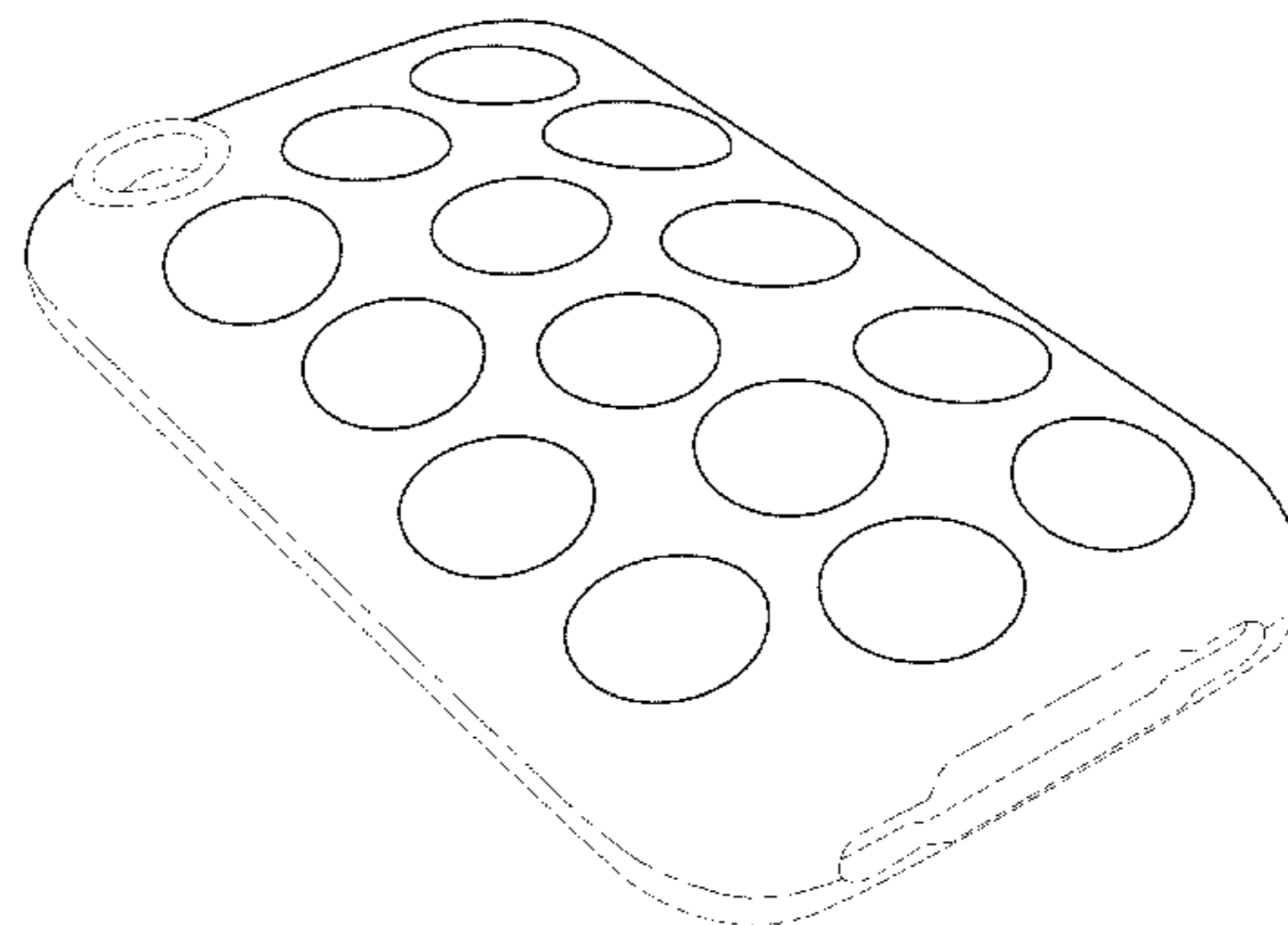
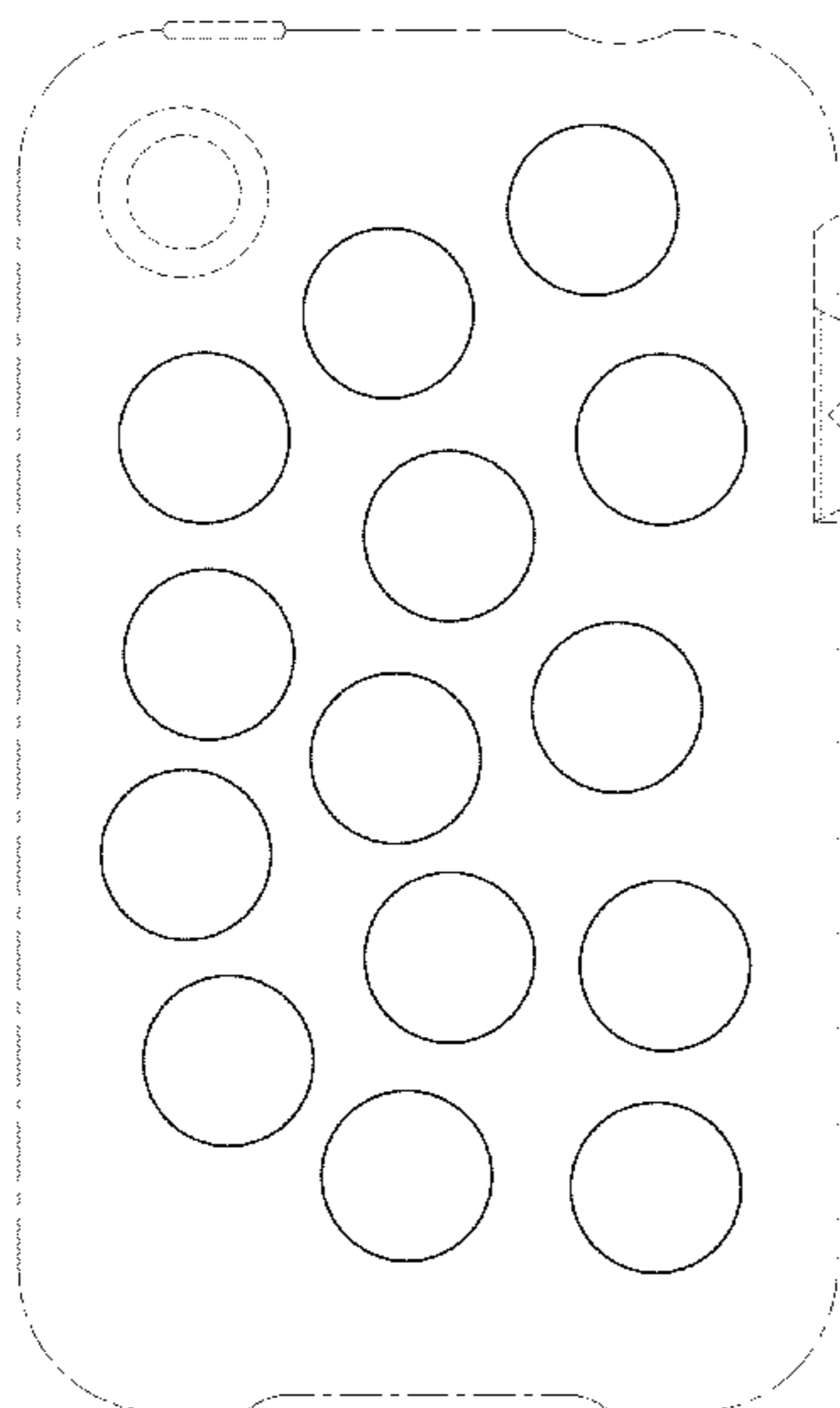
(57) **CLAIM**

I claim the ornamental design for a case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a case showing our new design; FIG. 2 is a bottom view of the case of FIG. 1; FIG. 3 is a left side view of the case of FIG. 1; FIG. 4 is a right side view of the case of FIG. 1; FIG. 5 is a front view of the case of FIG. 1; FIG. 6 is a rear view of the case of FIG. 1; and, FIG. 7 is a rear perspective view of the case of FIG. 1. The dot-dash broken lines represent boundaries of the claimed design. The dash-dash broken lines depict unclaimed environment. The broken lines form no part of the claimed design.

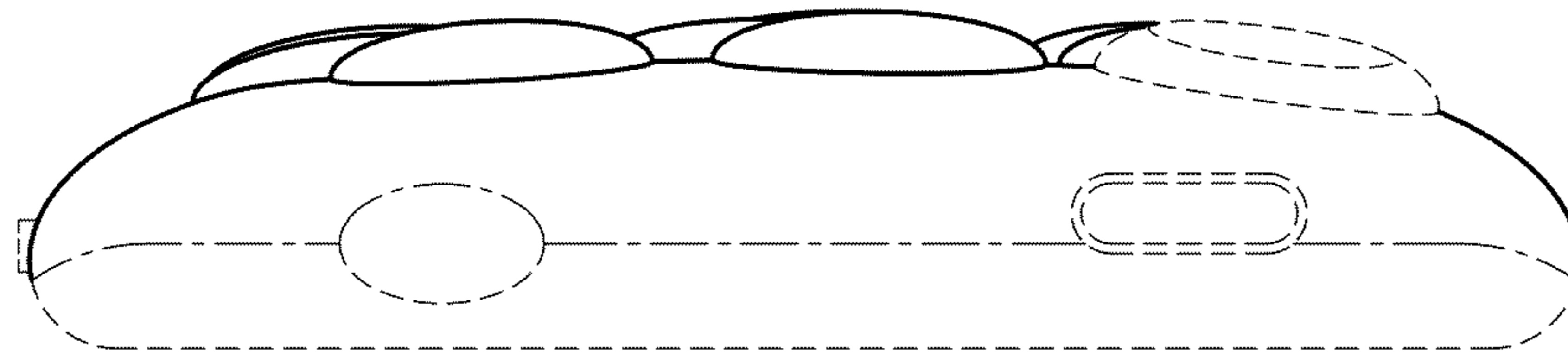

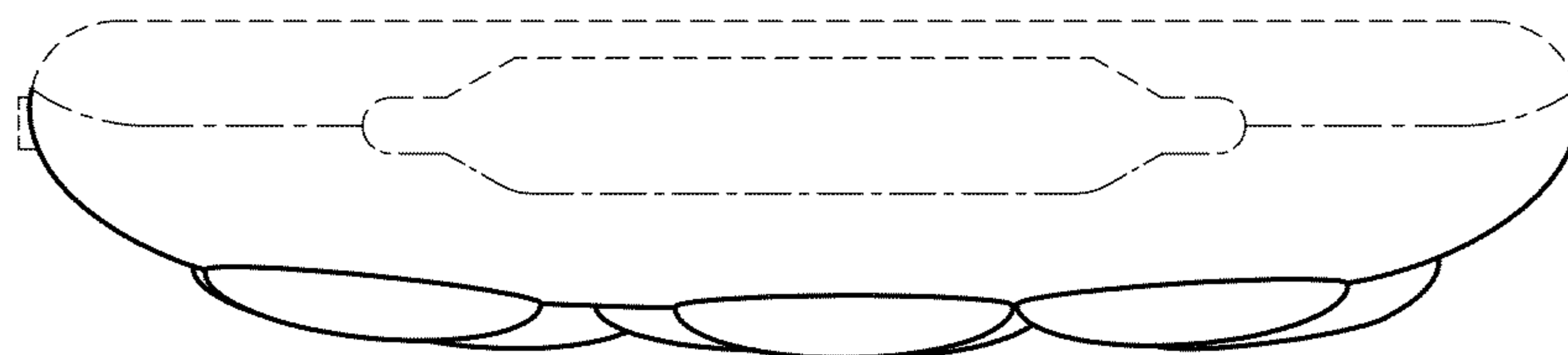

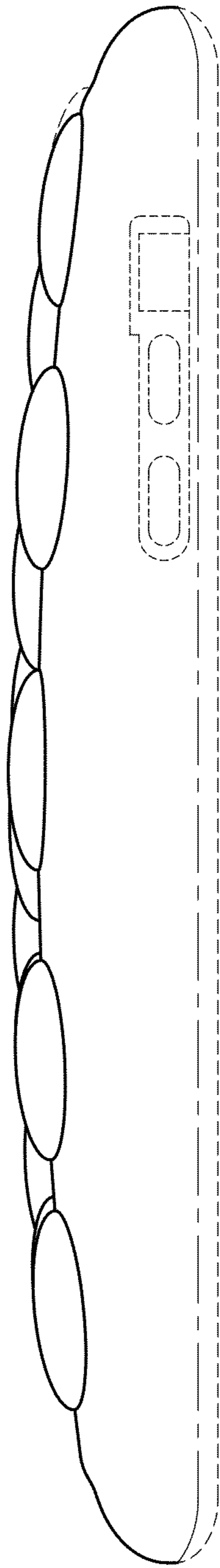

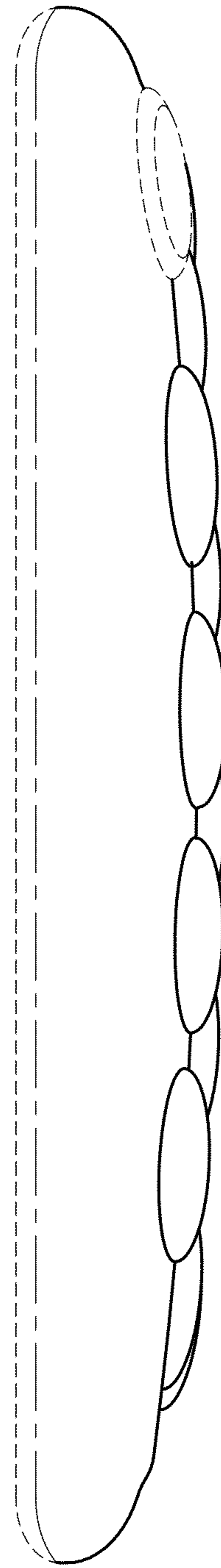

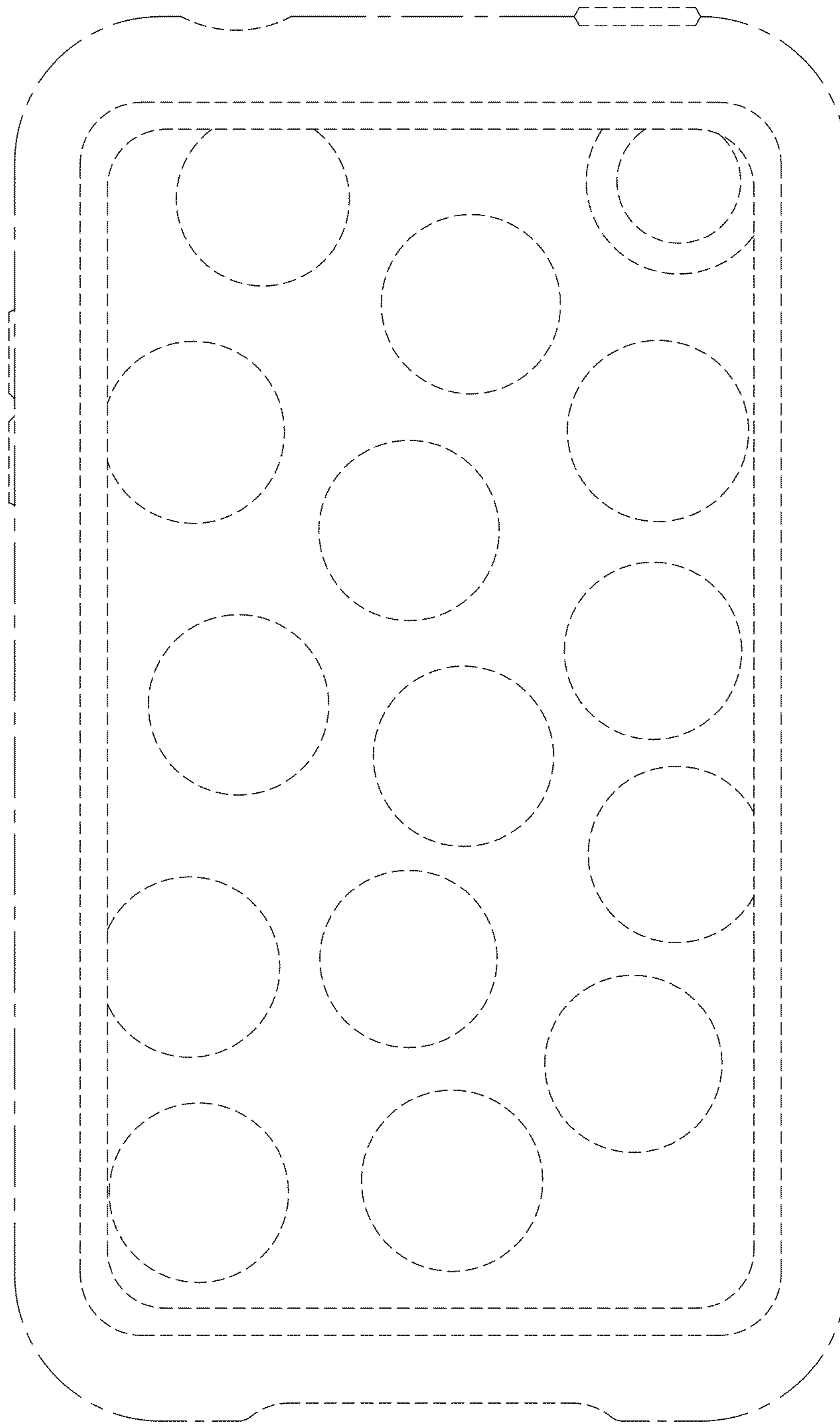

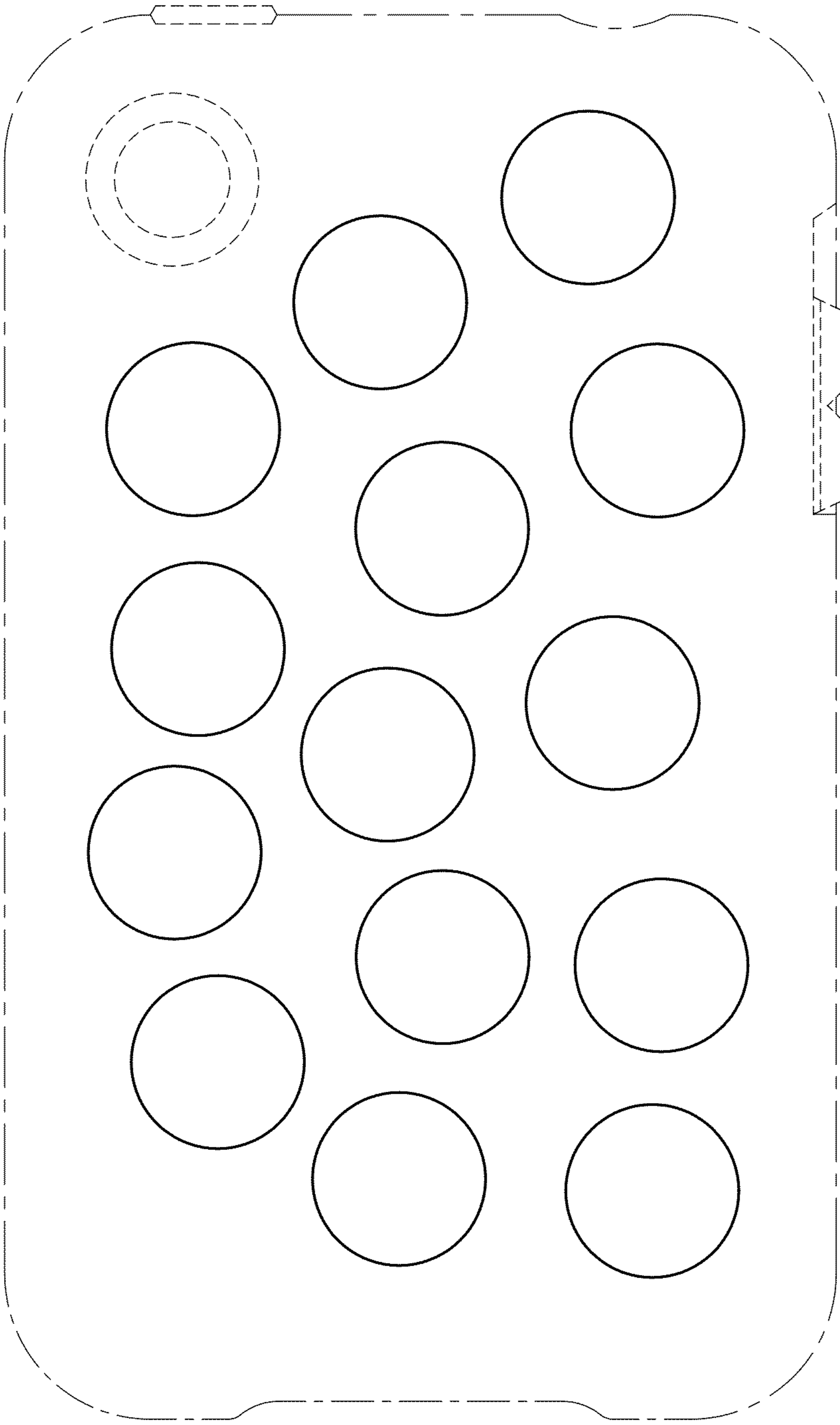

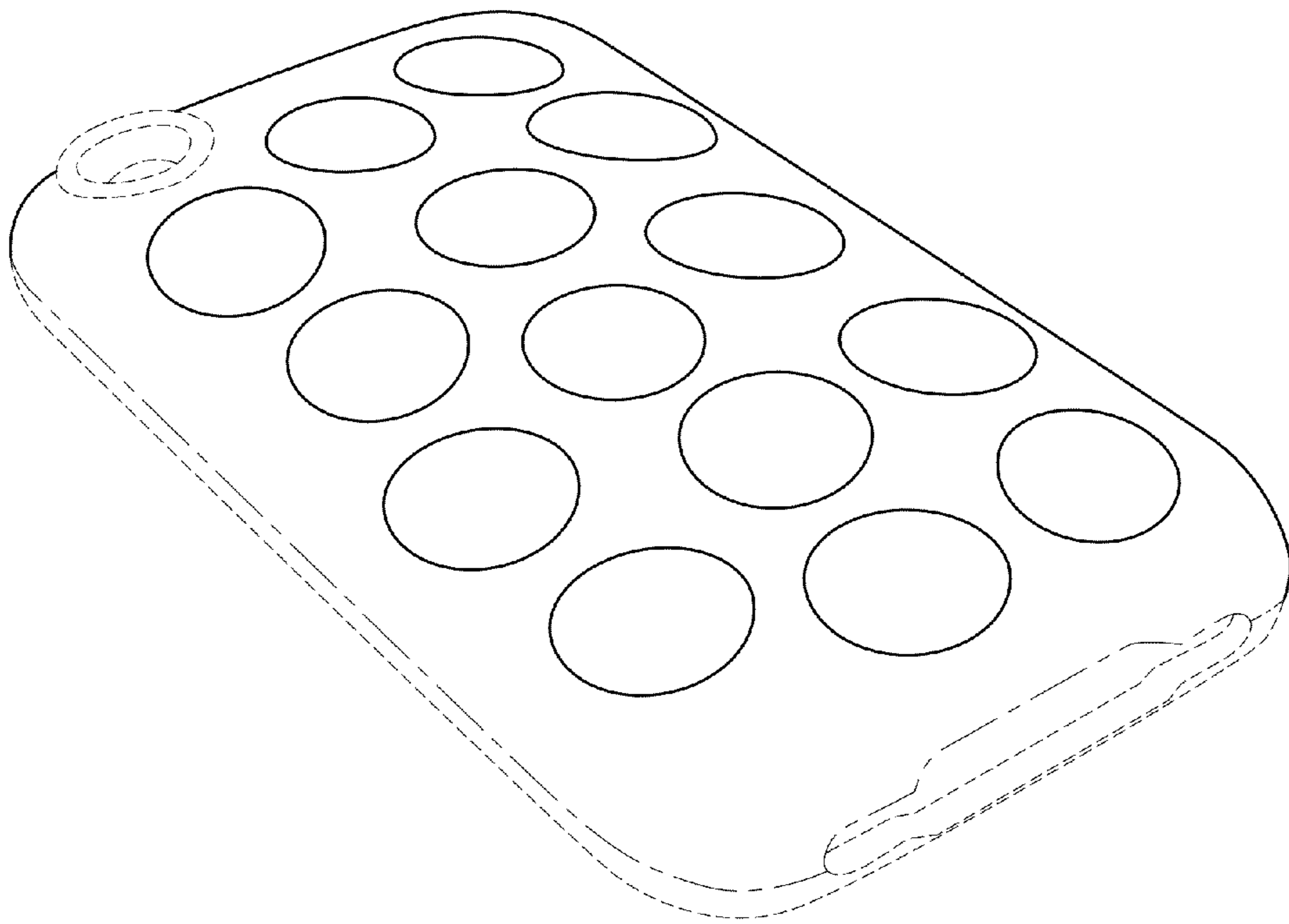
