DESCRIPTION

 FIG. 16 is a right side elevational view thereof; and

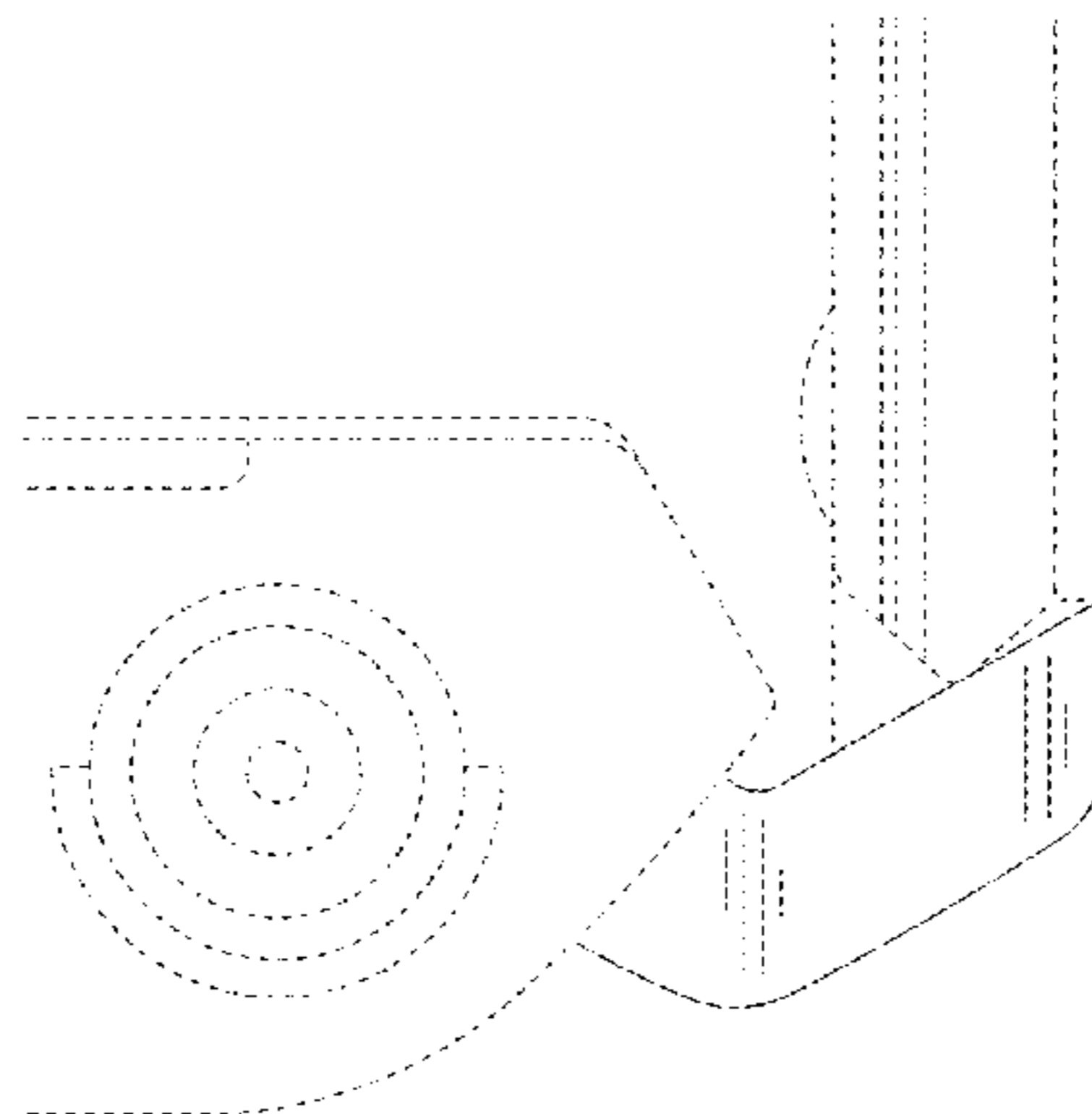


FIG. 17 is a bottom plan view thereof.

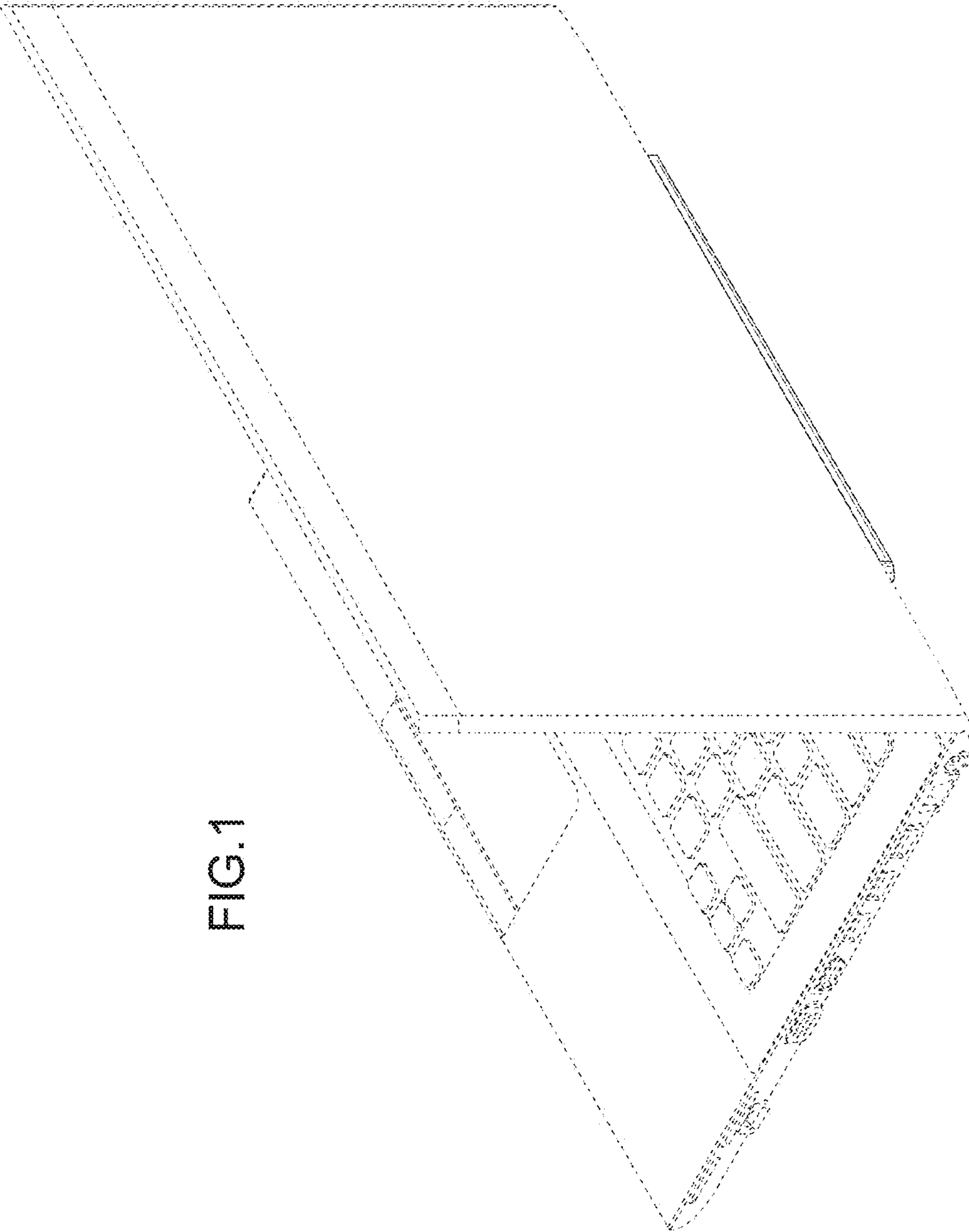

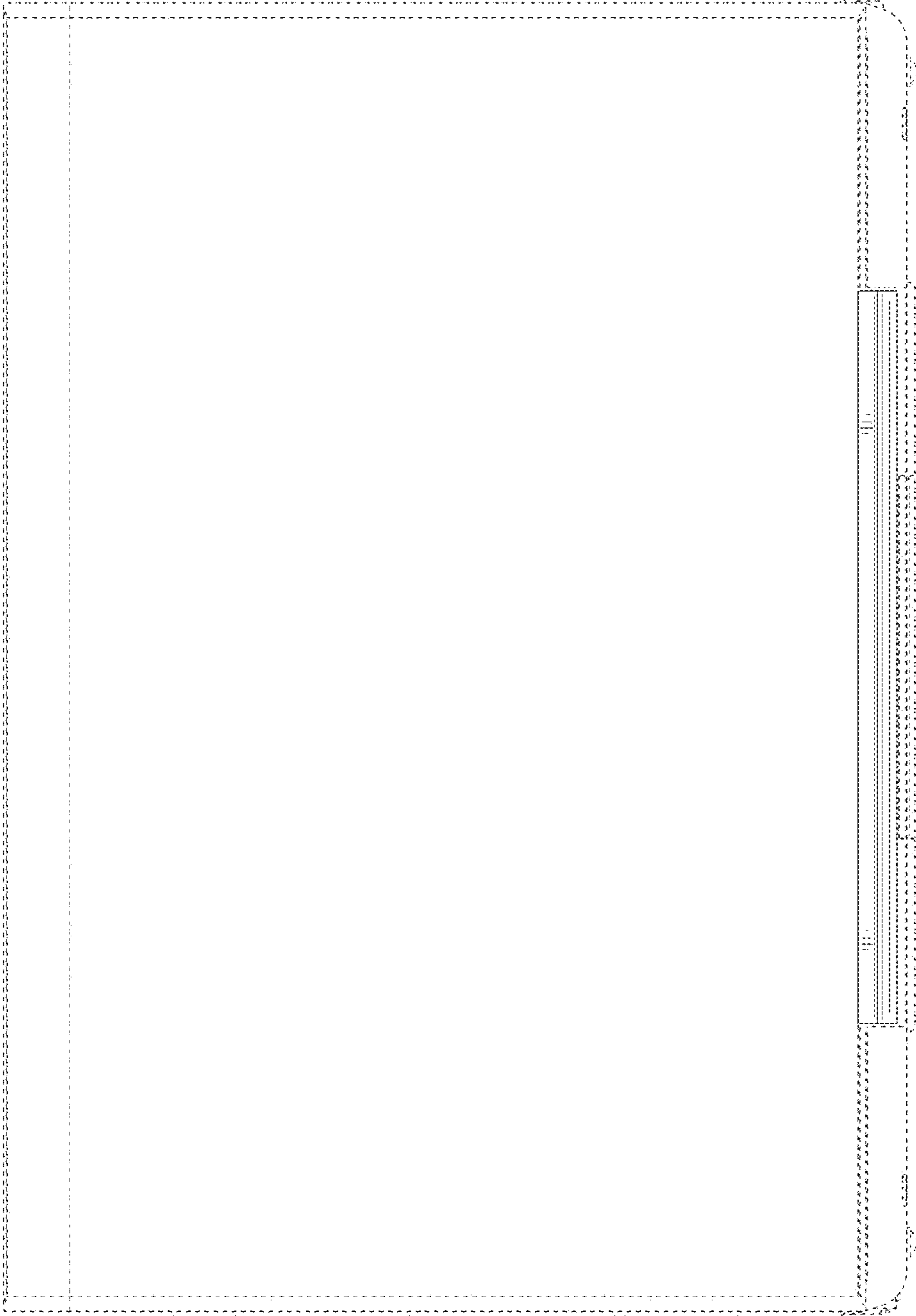

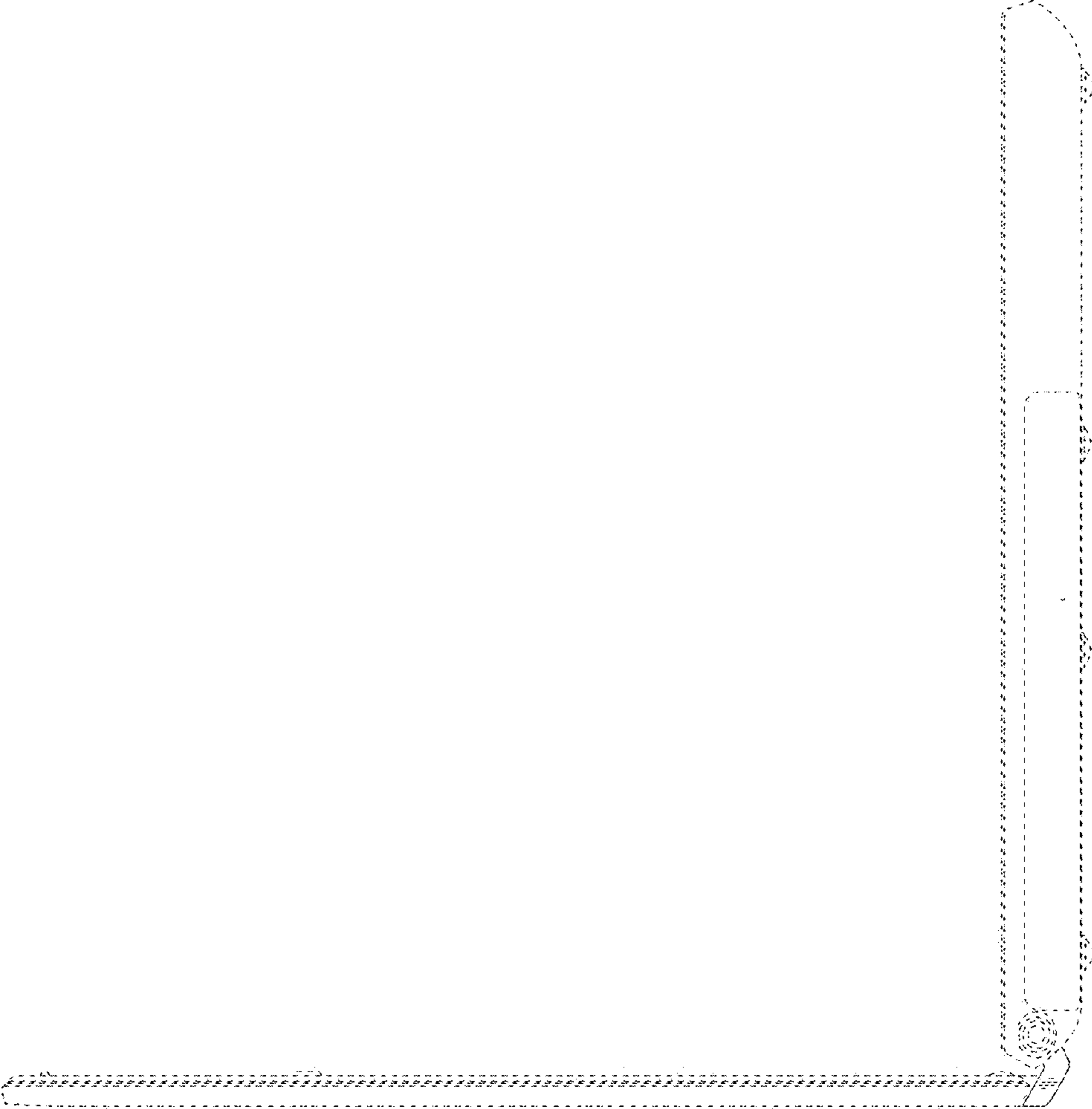

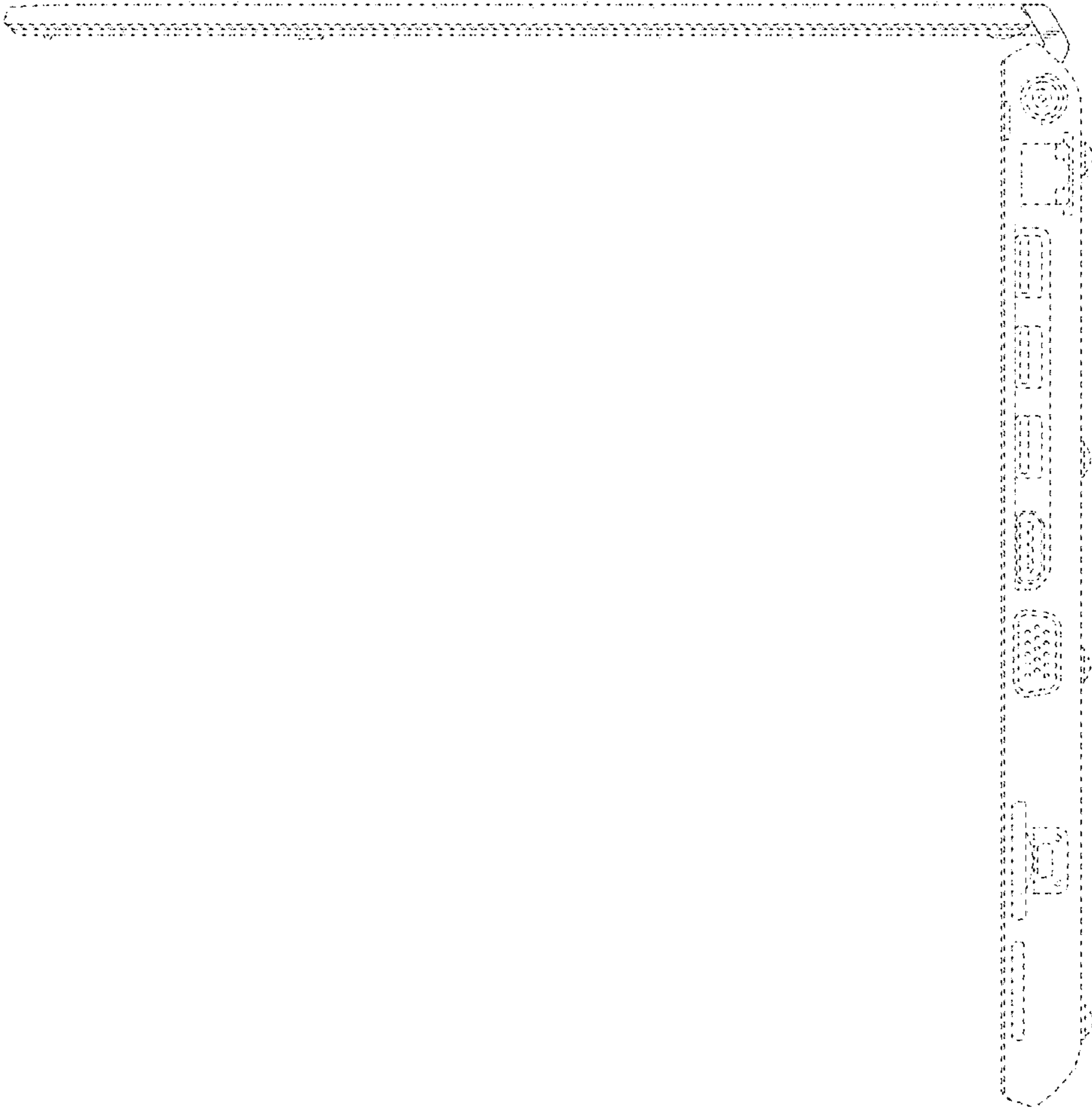

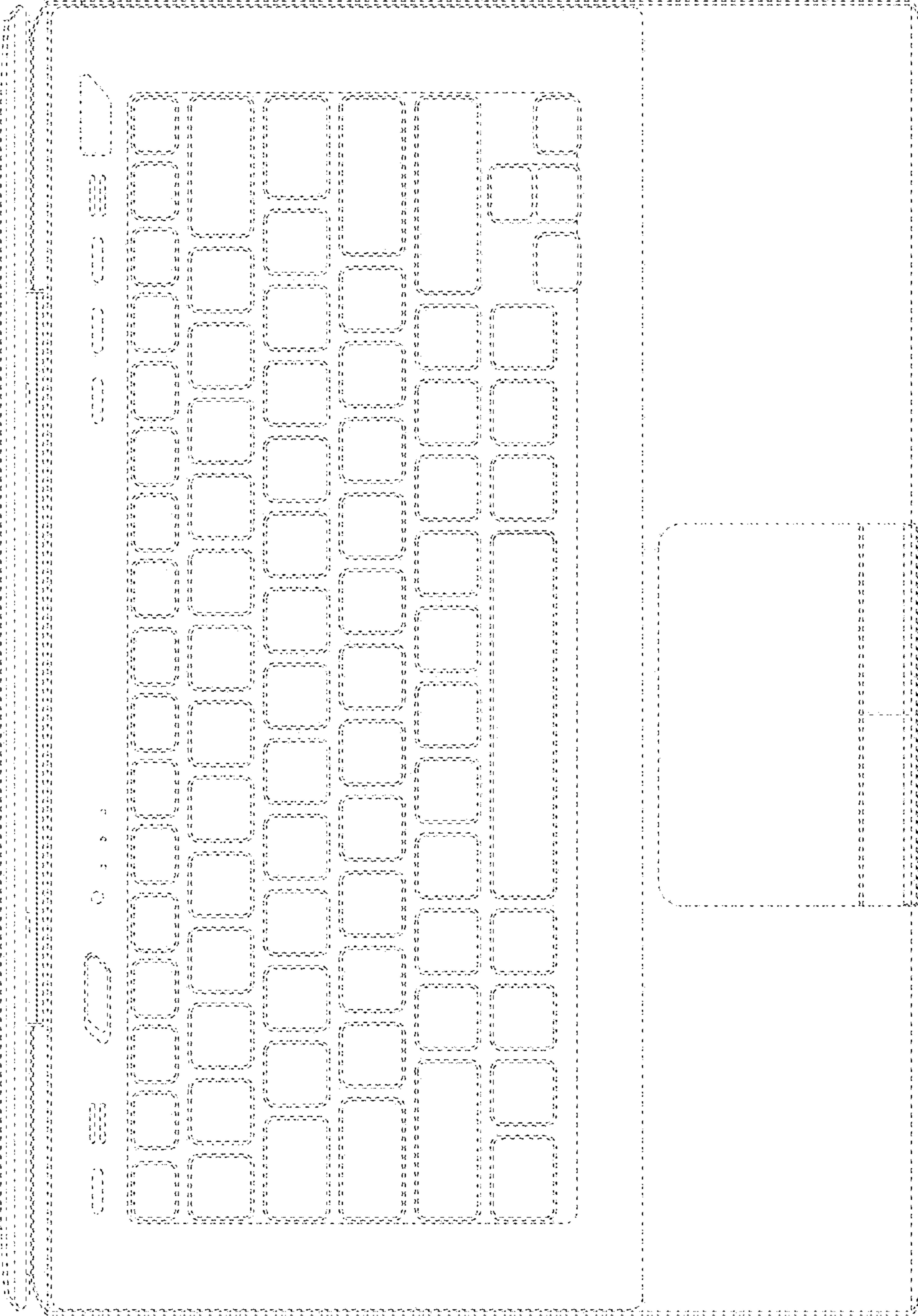
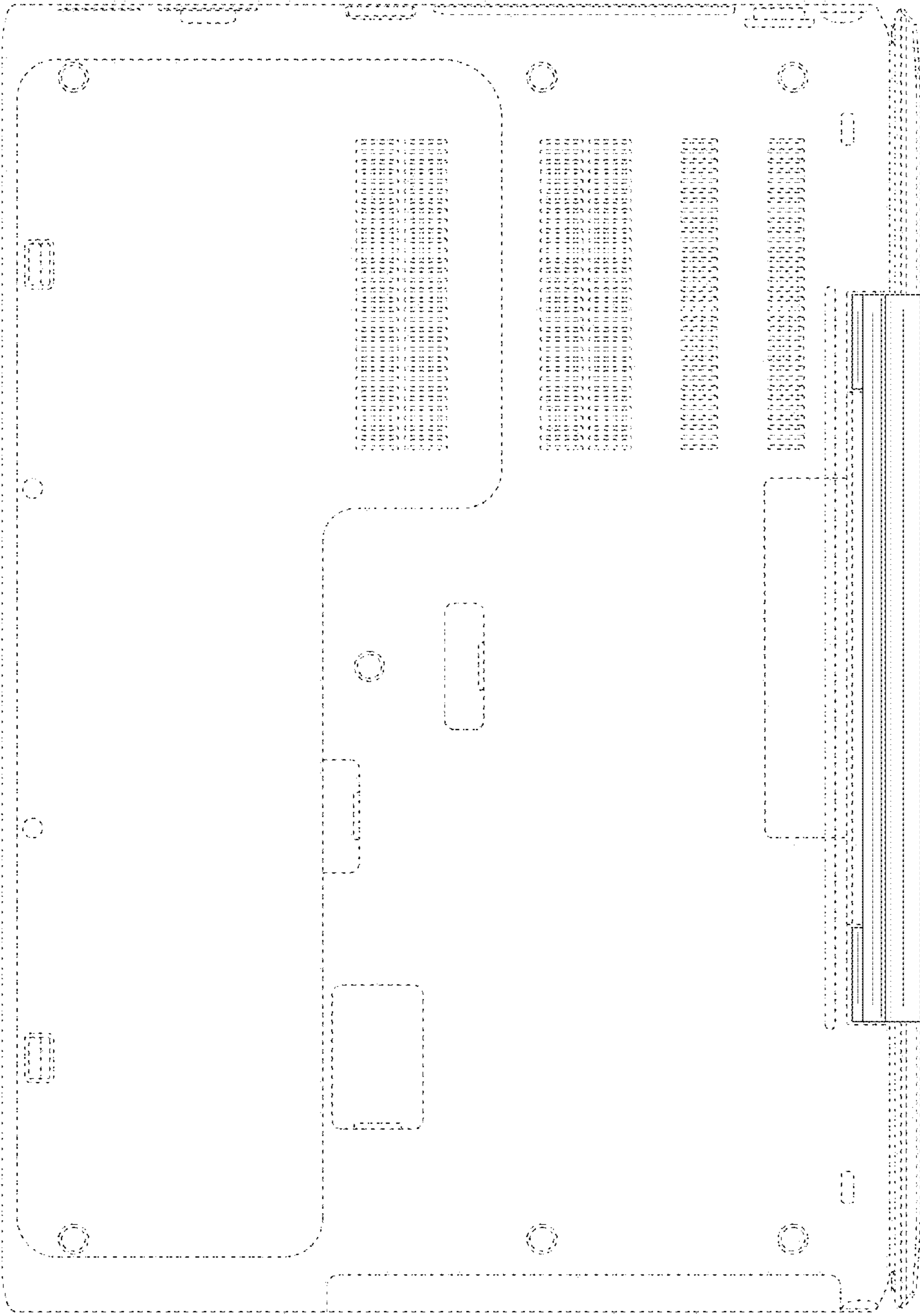

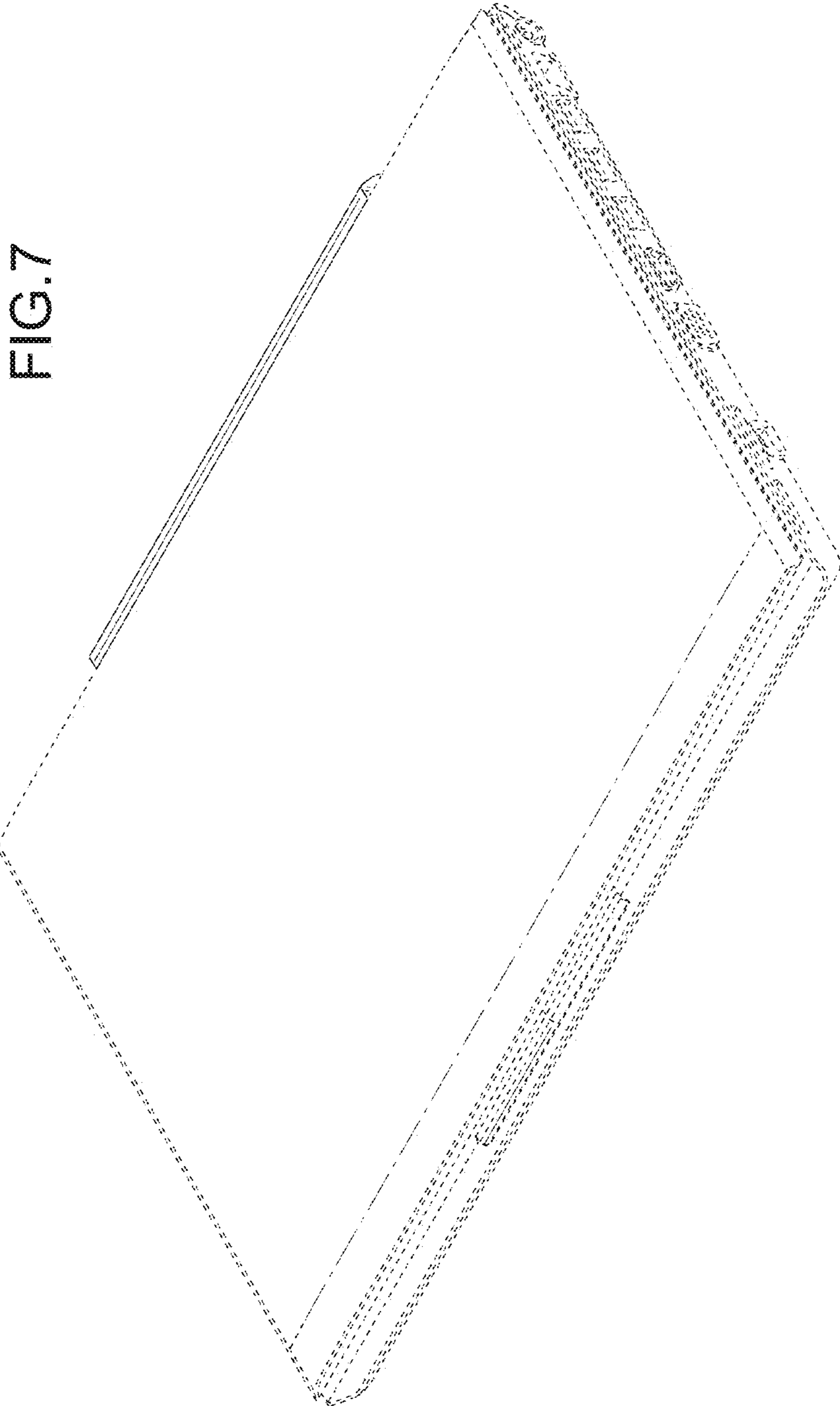

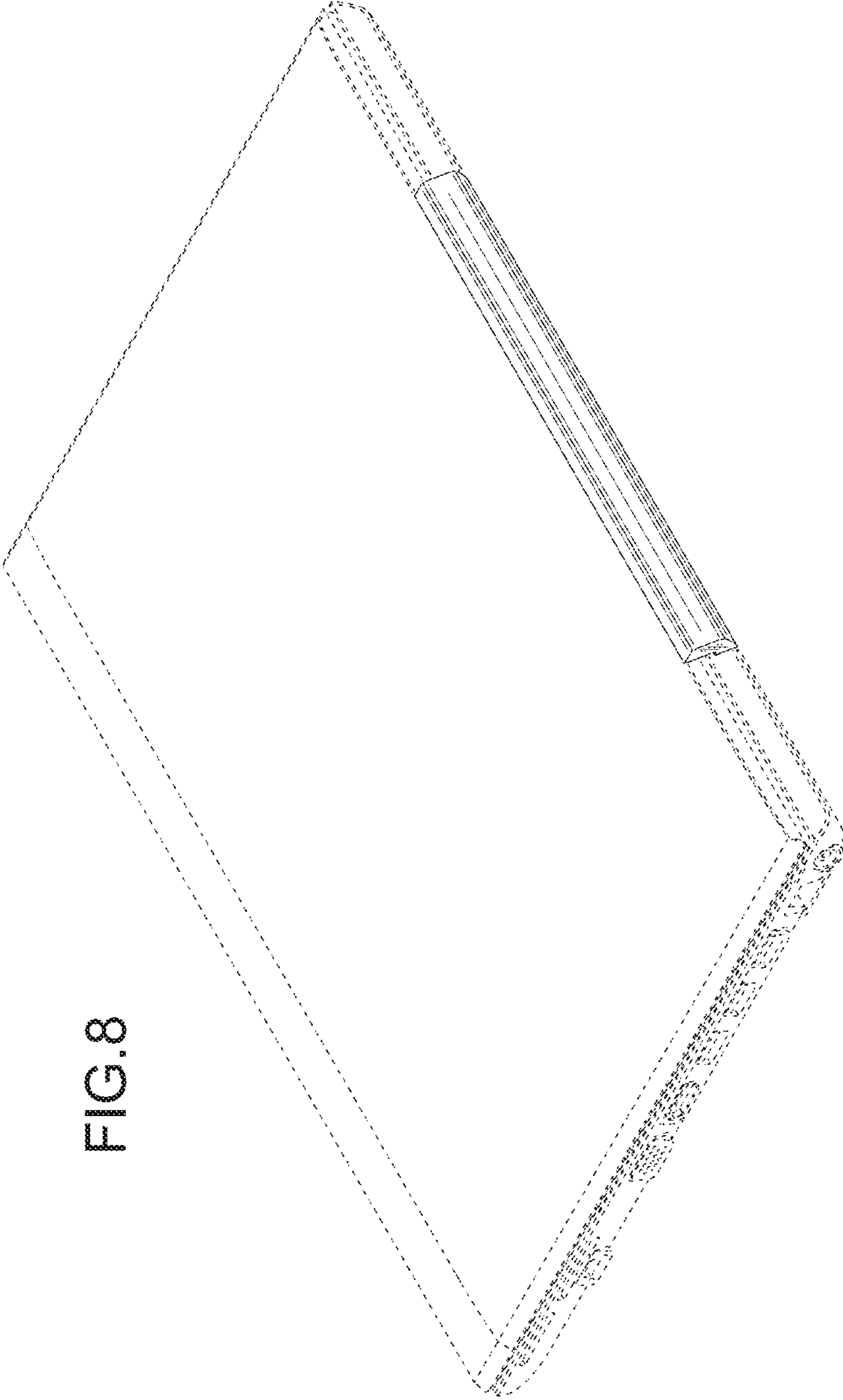

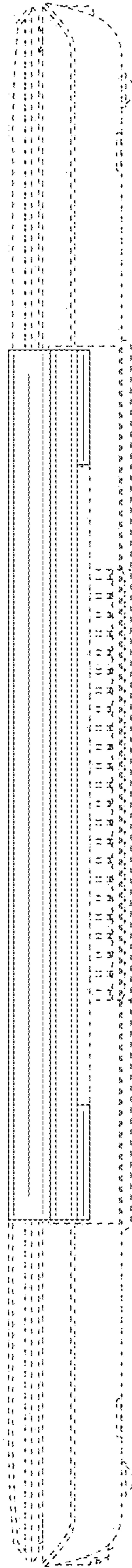

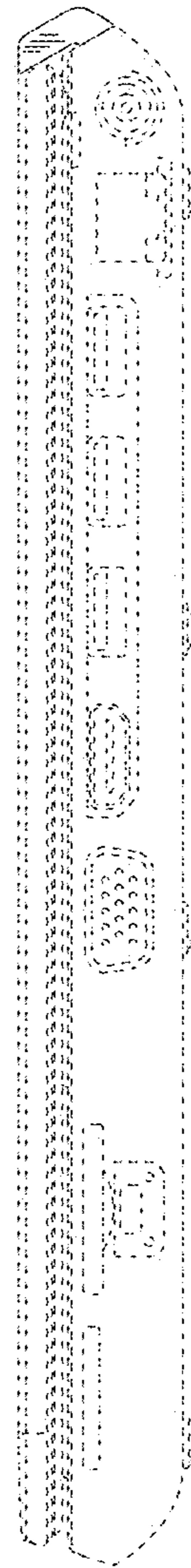

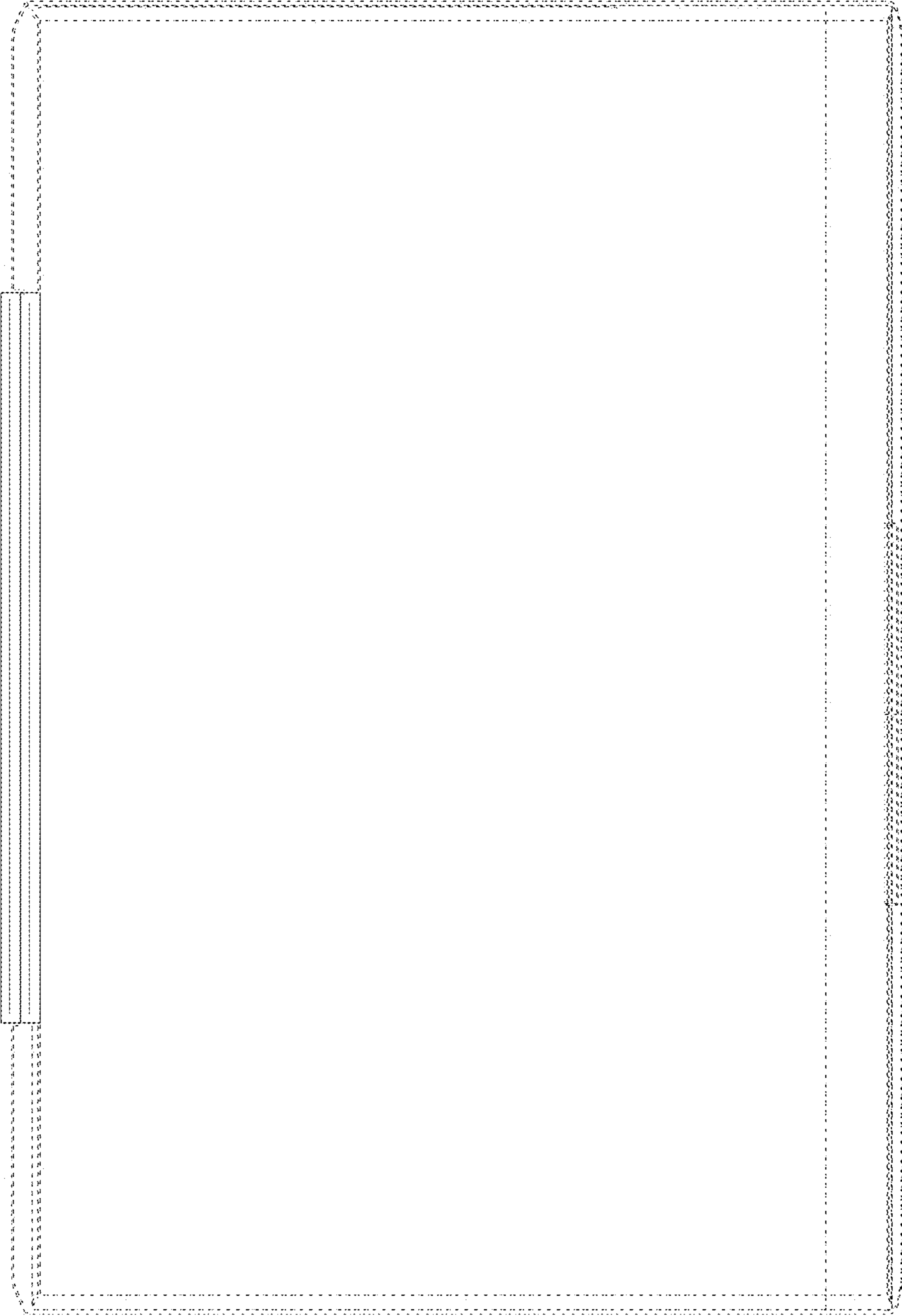

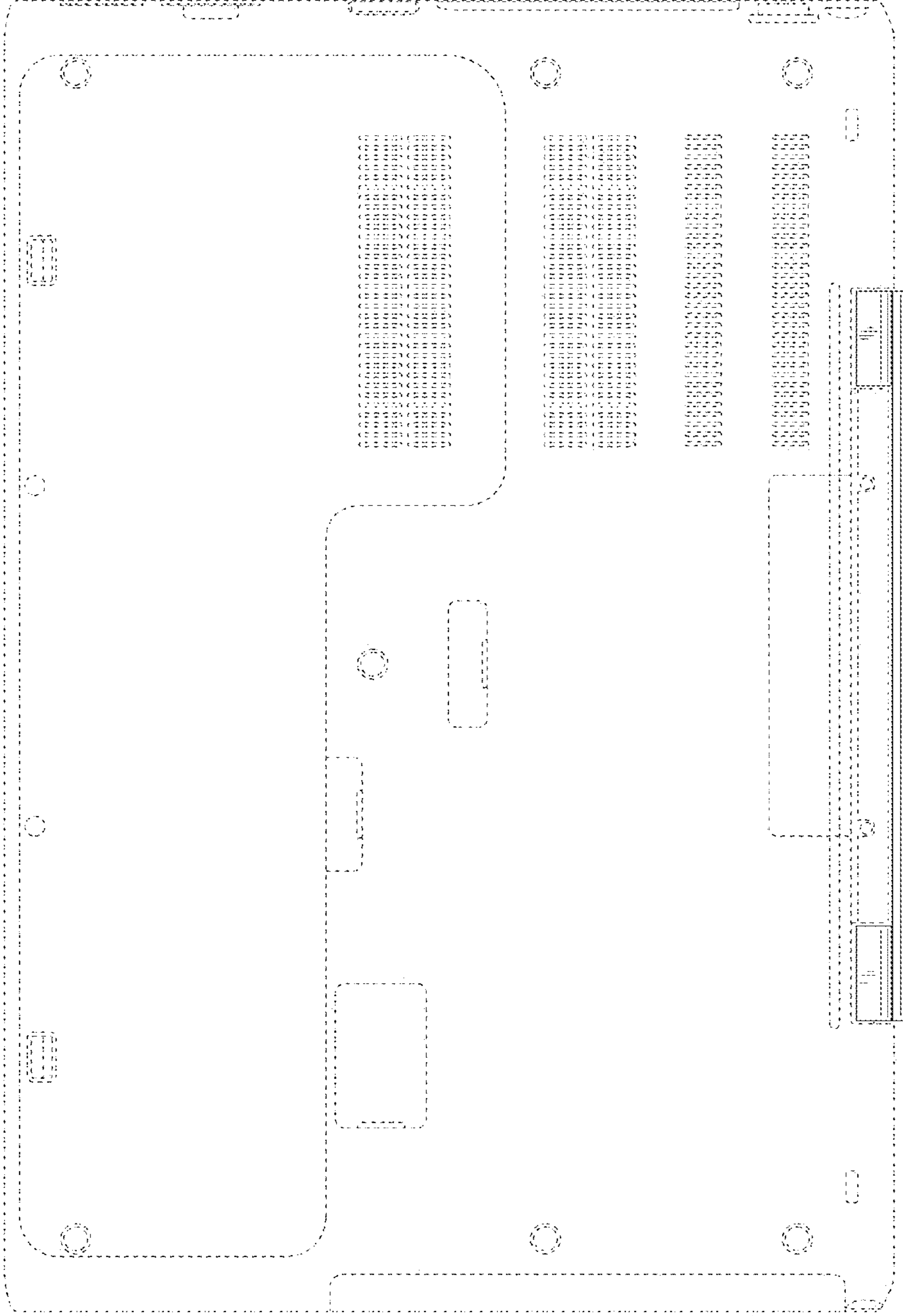

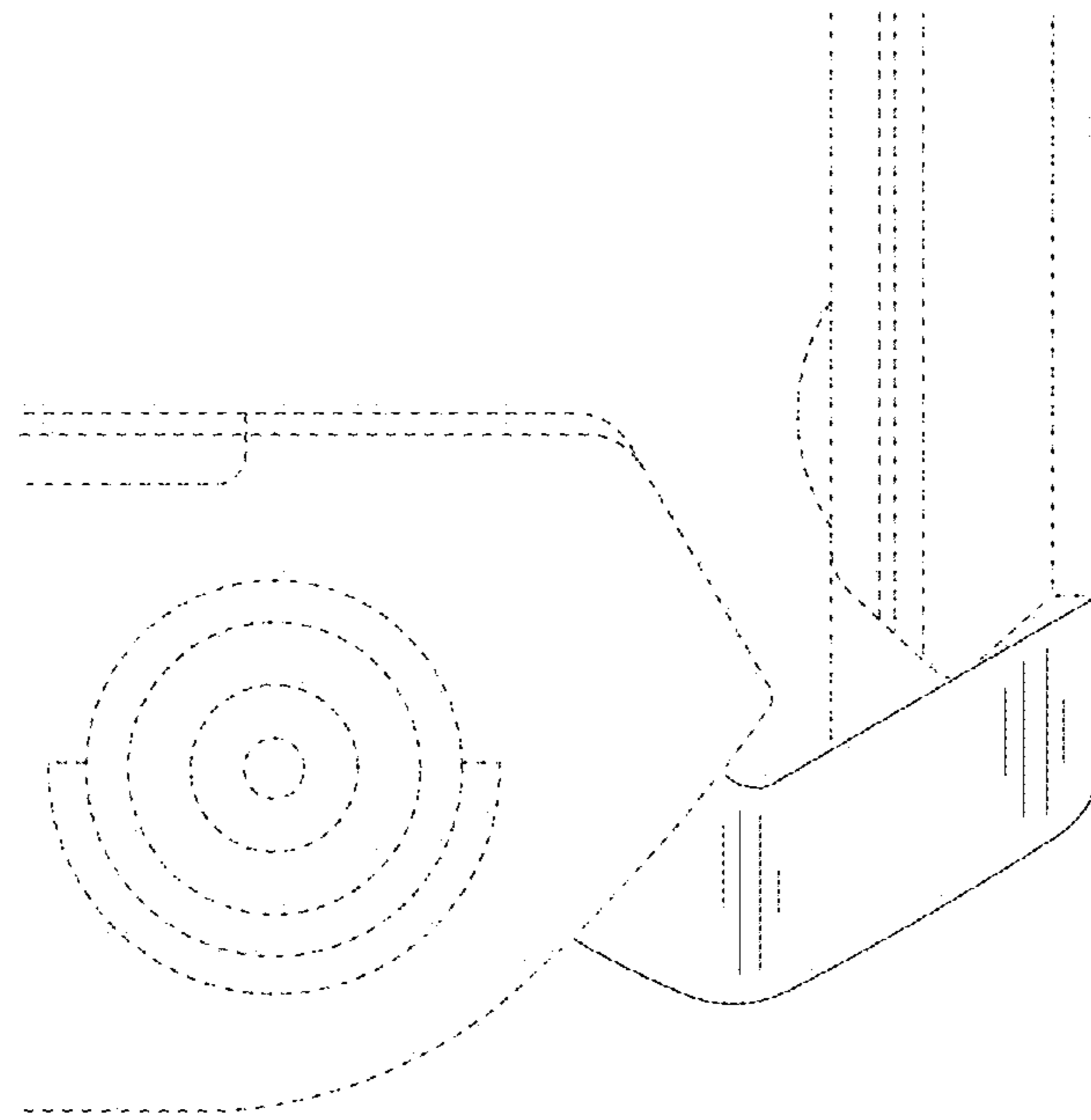

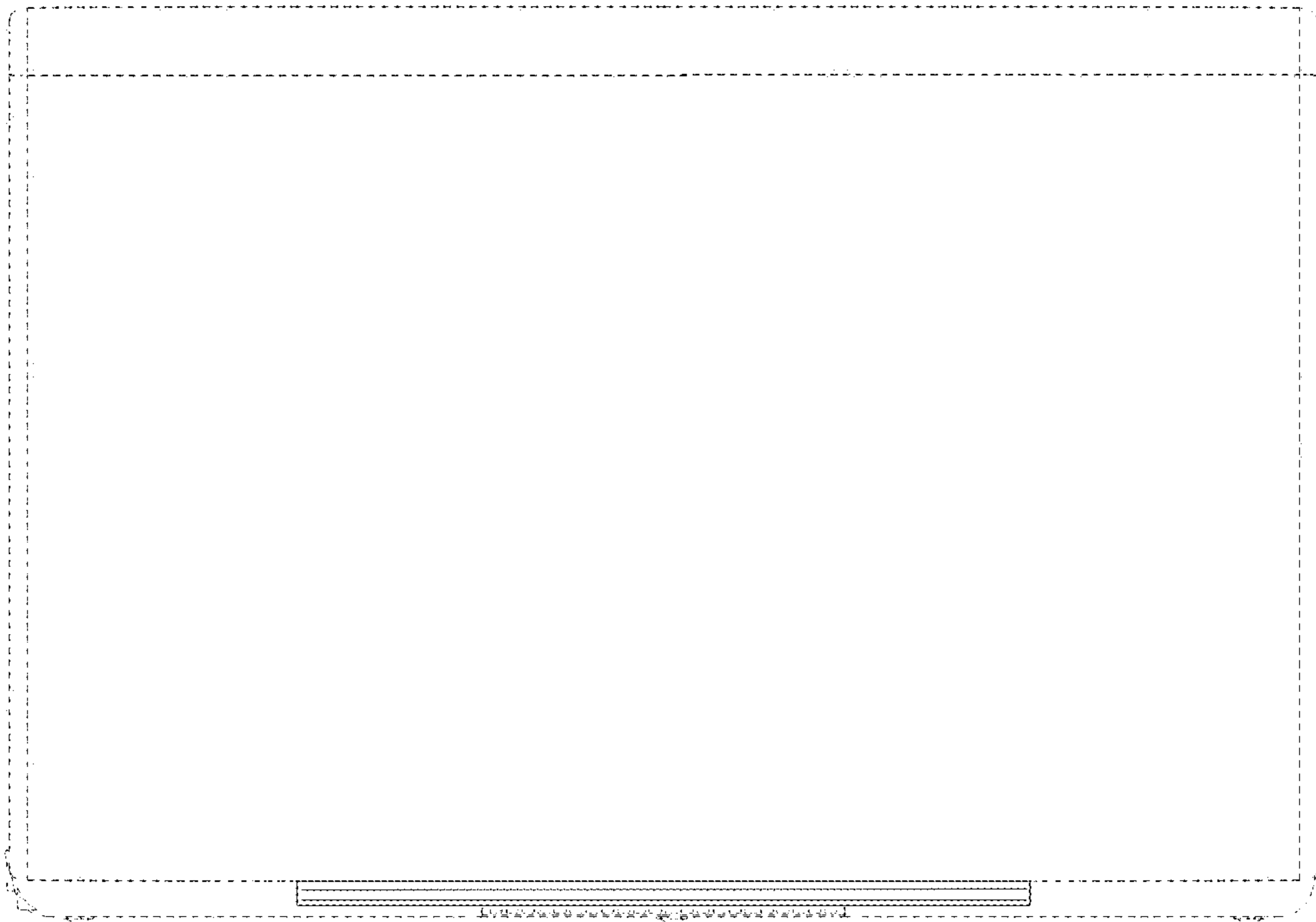

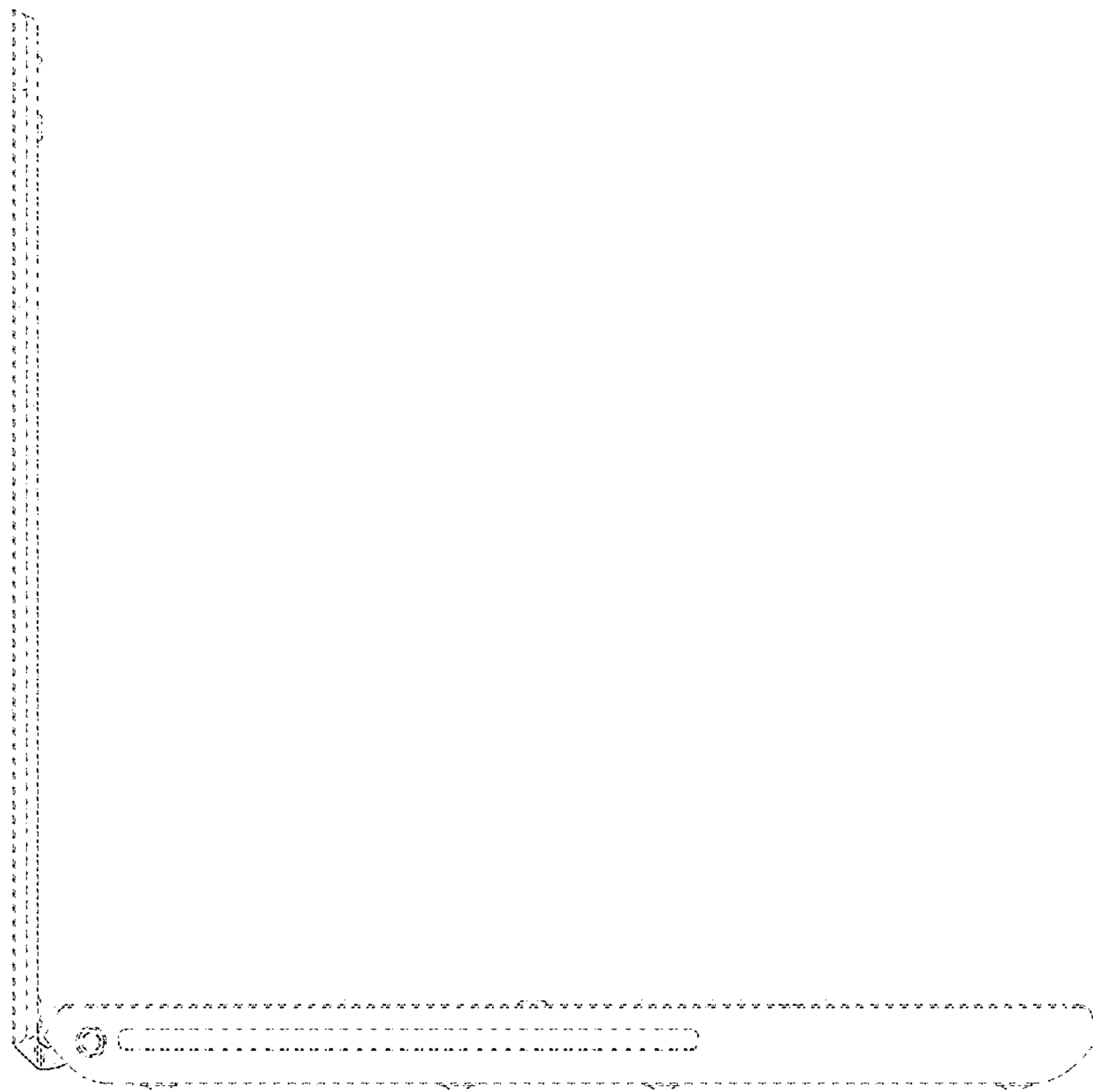

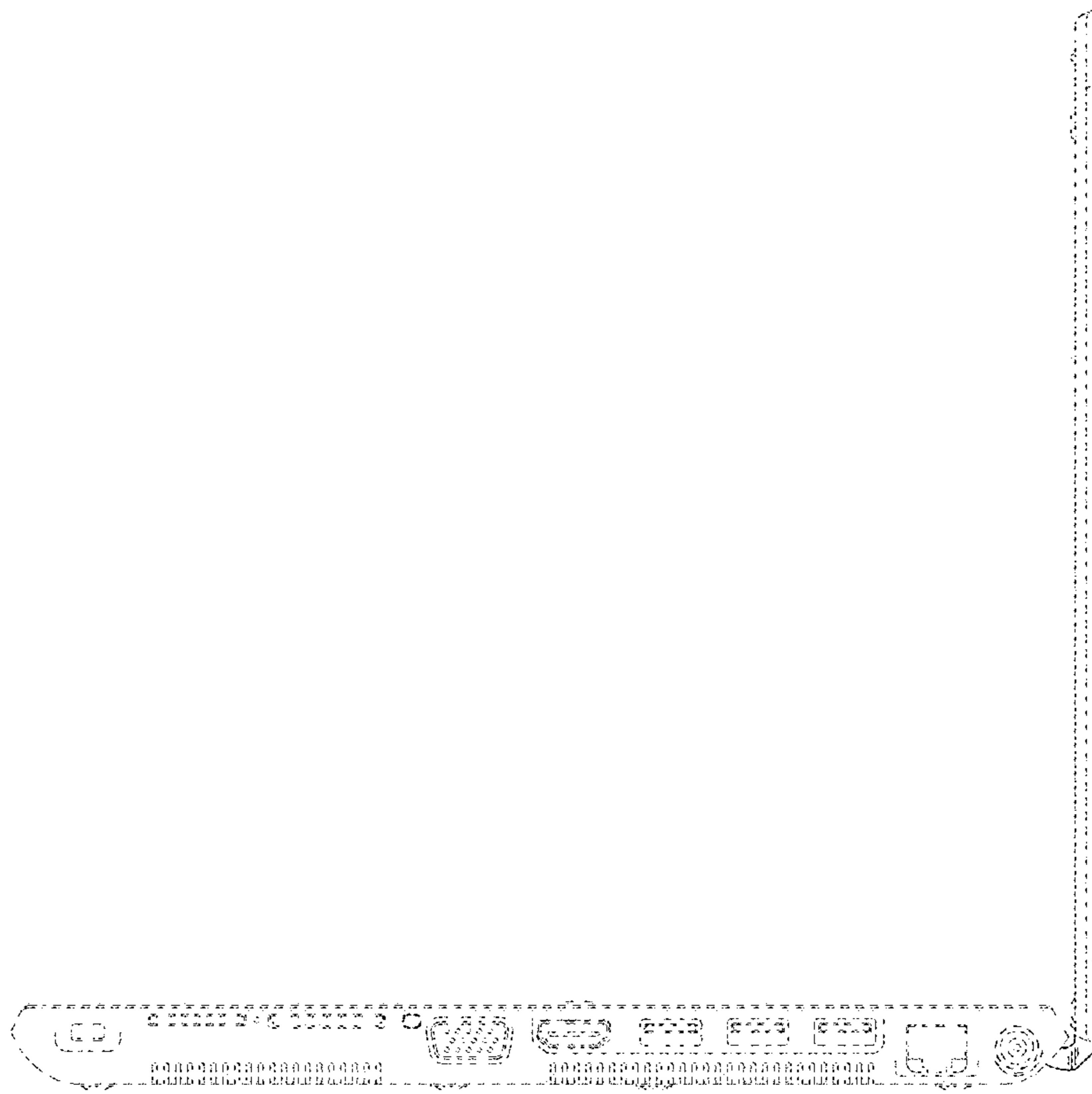
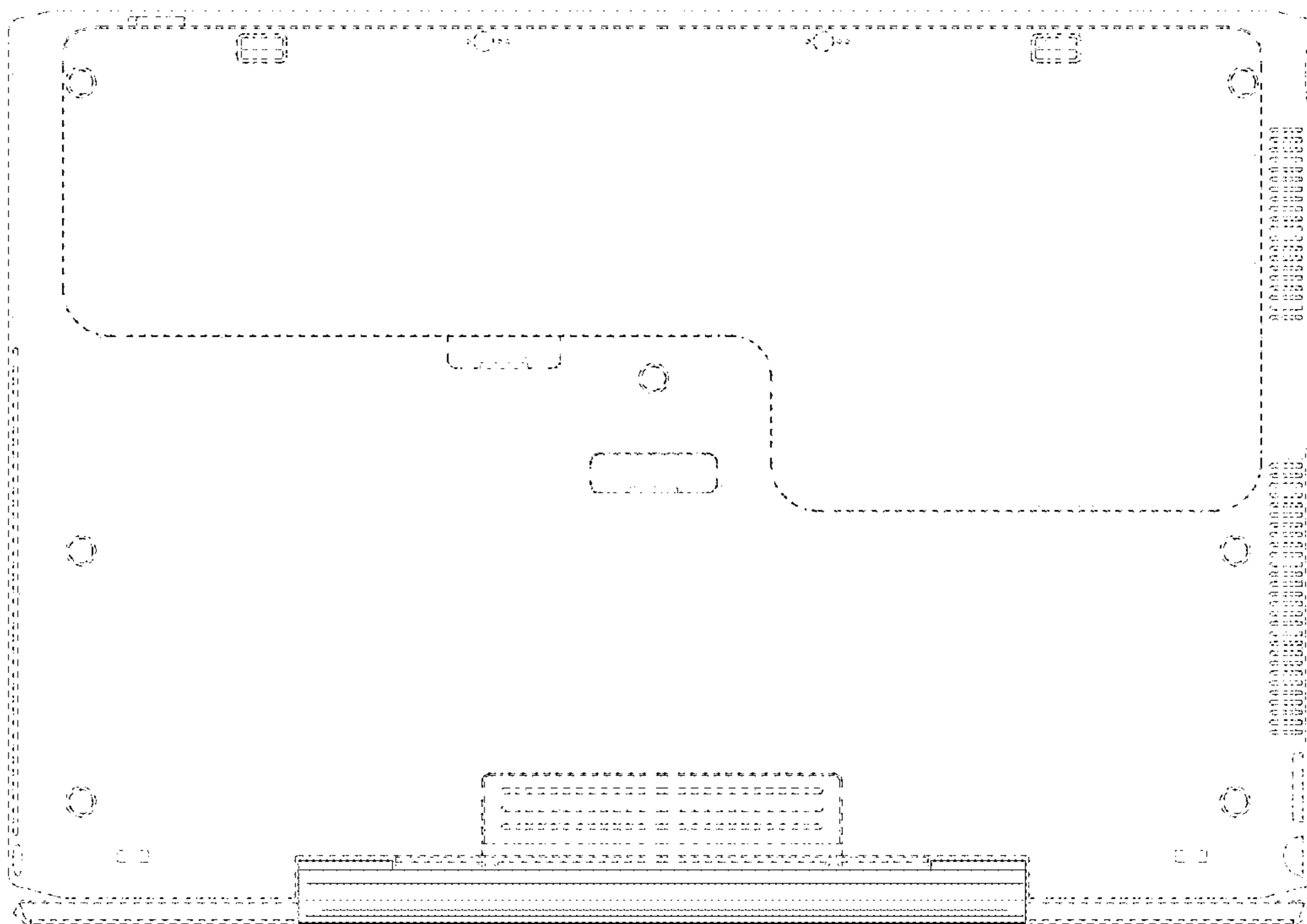

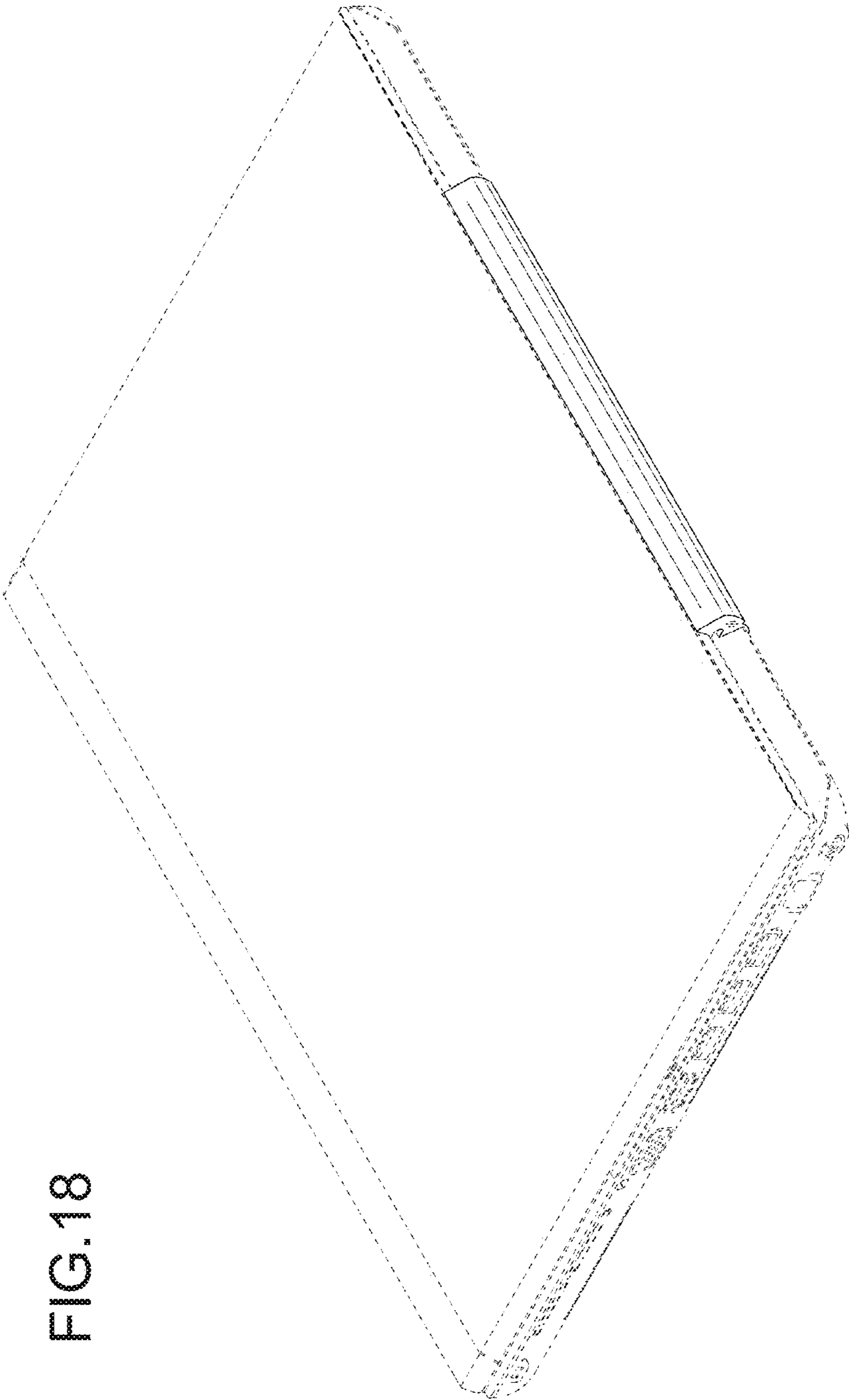

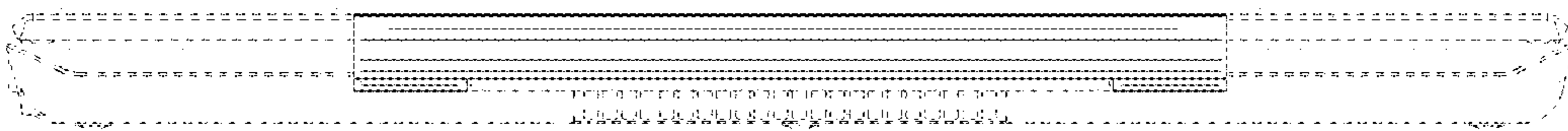

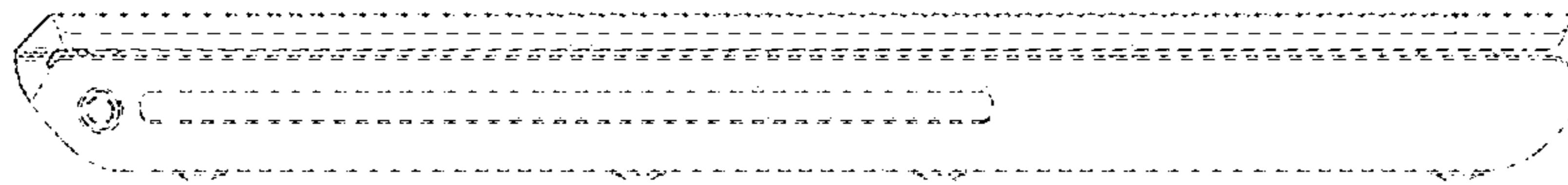

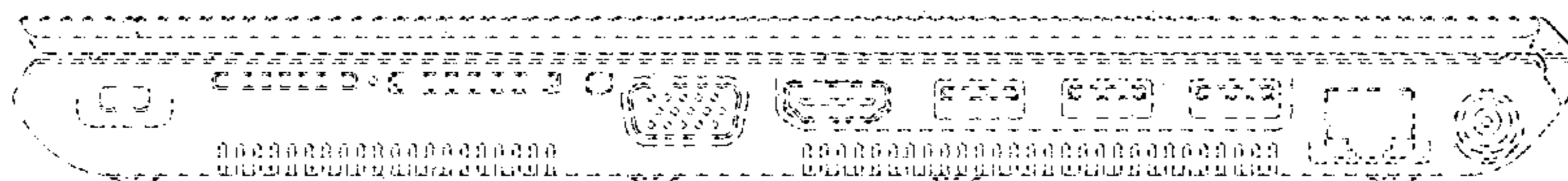

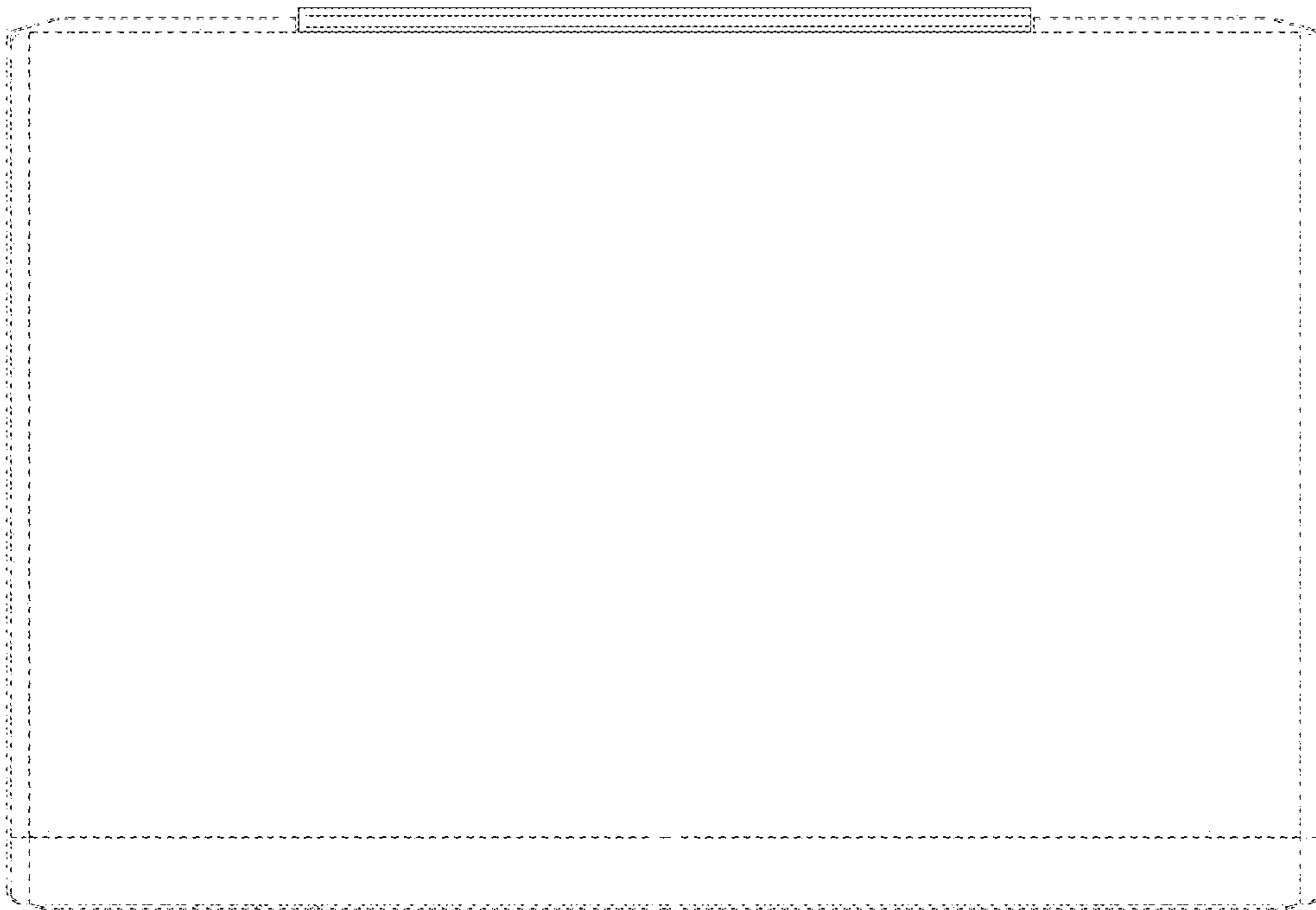

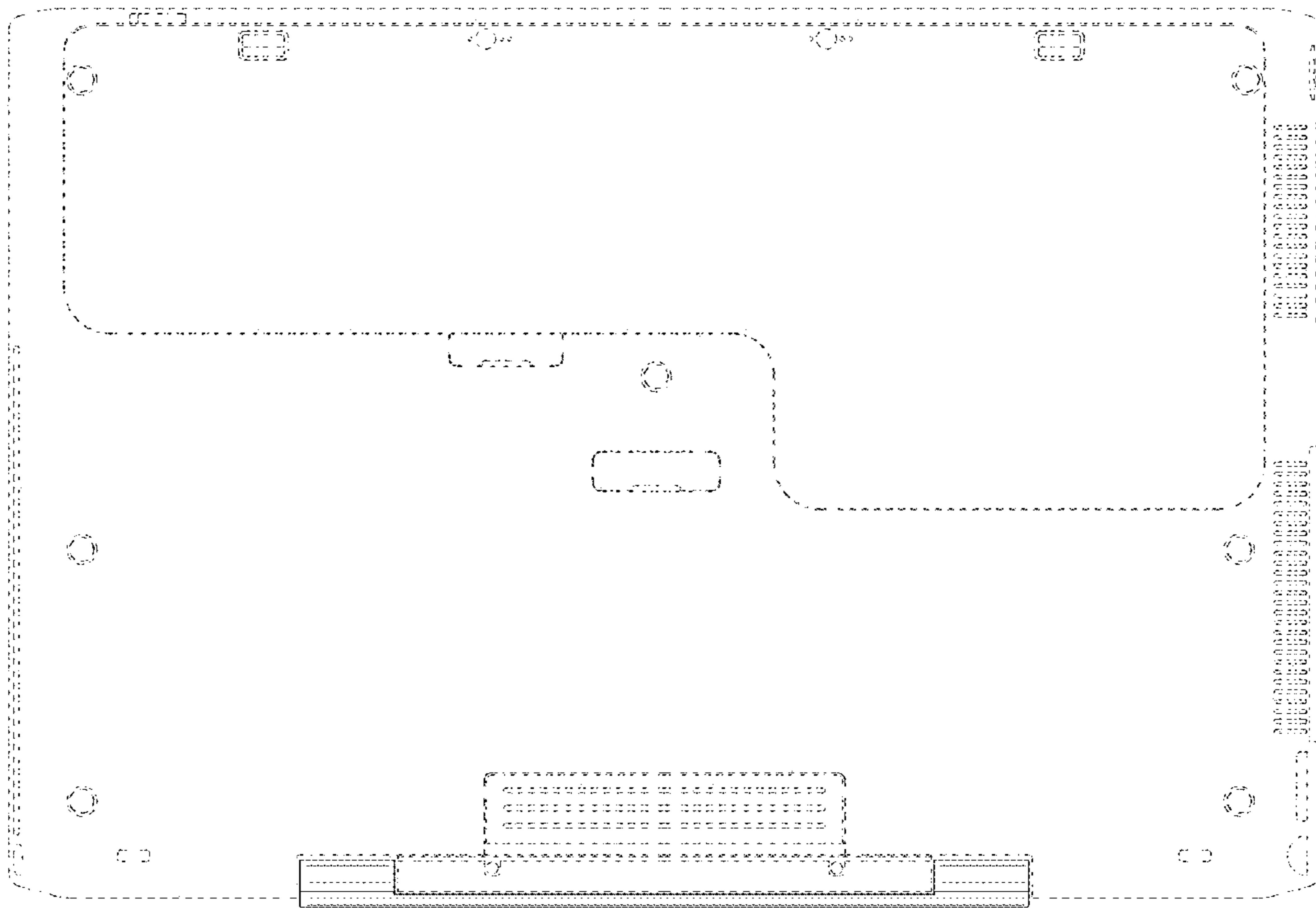

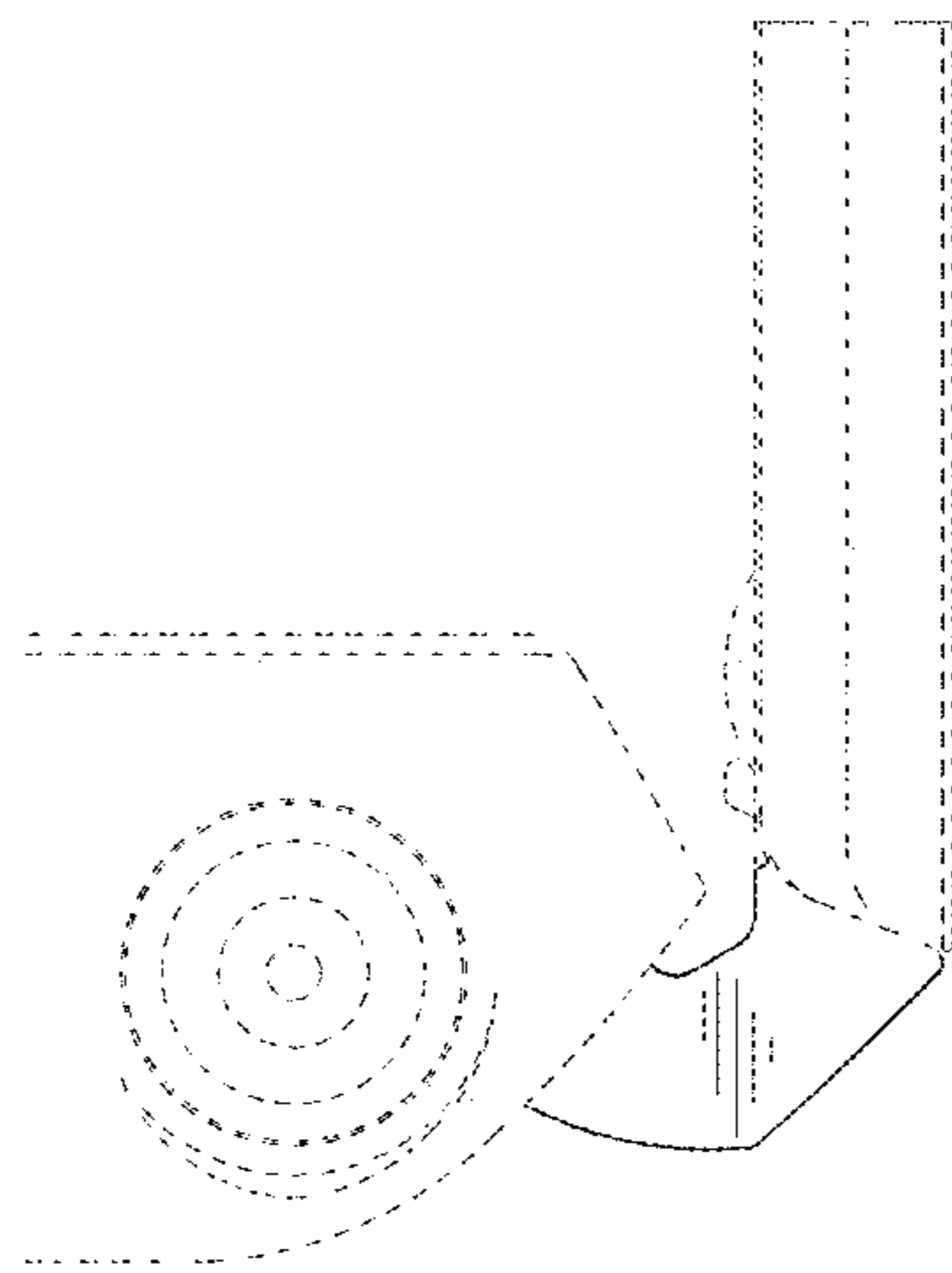

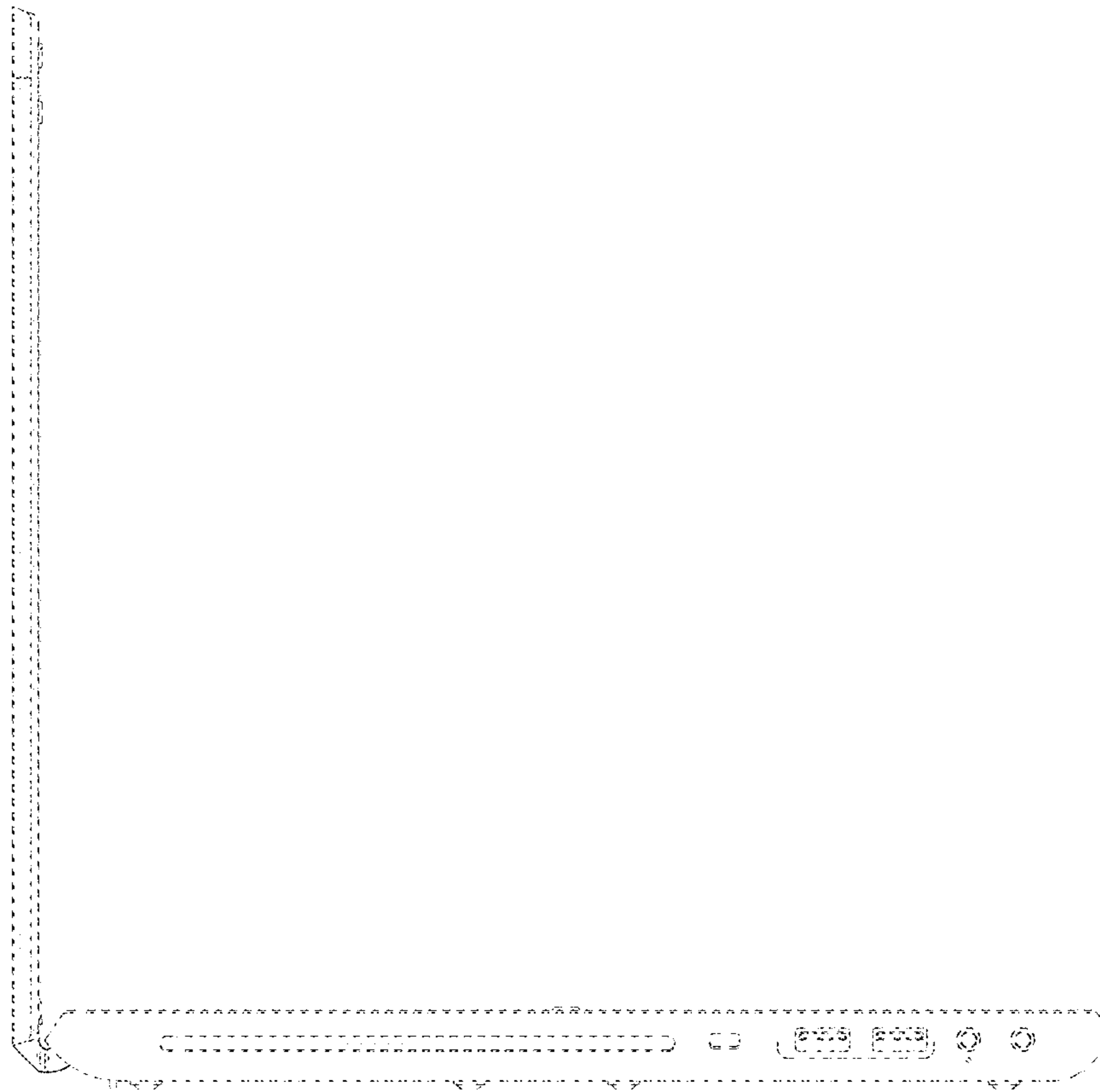

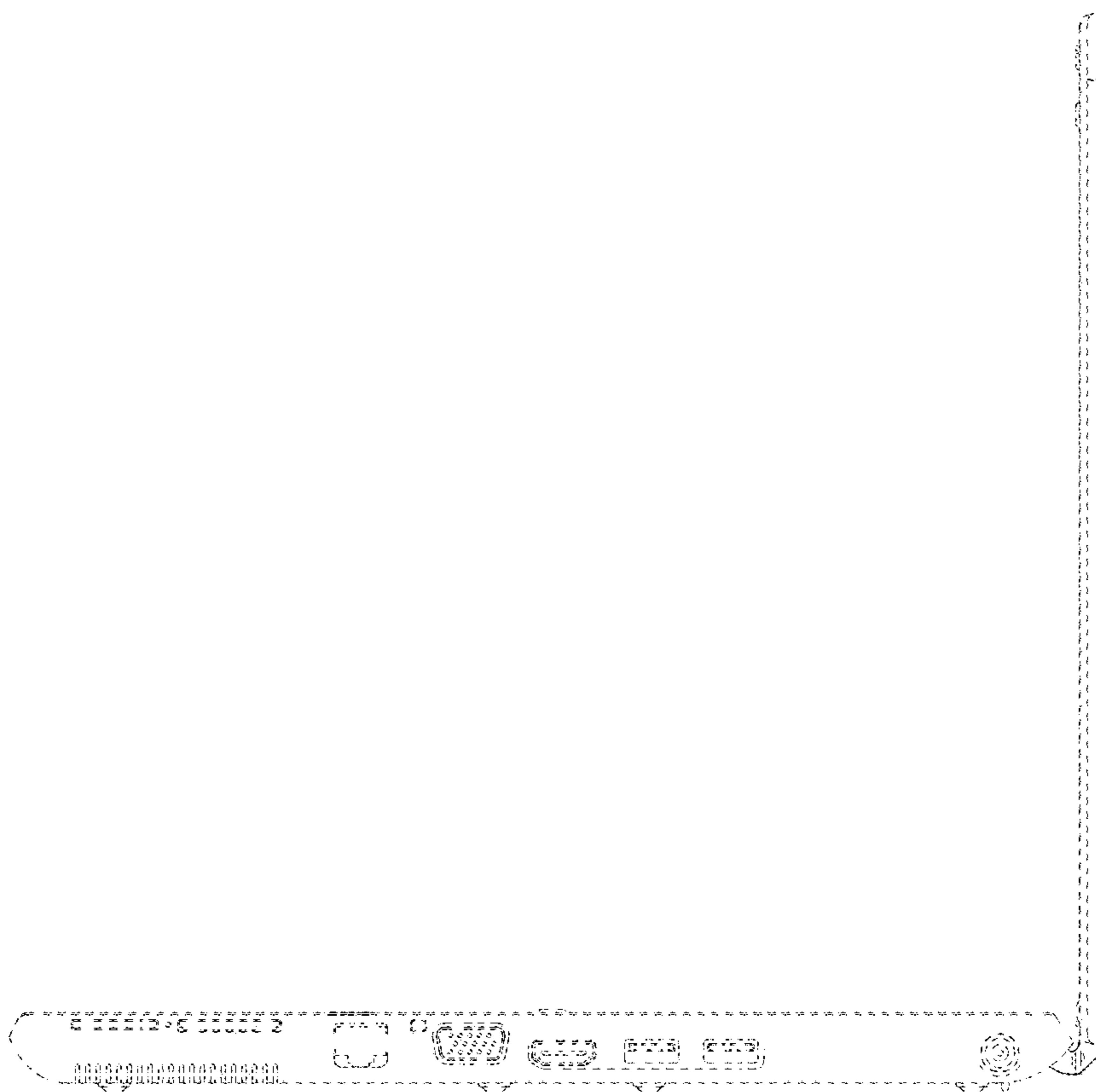
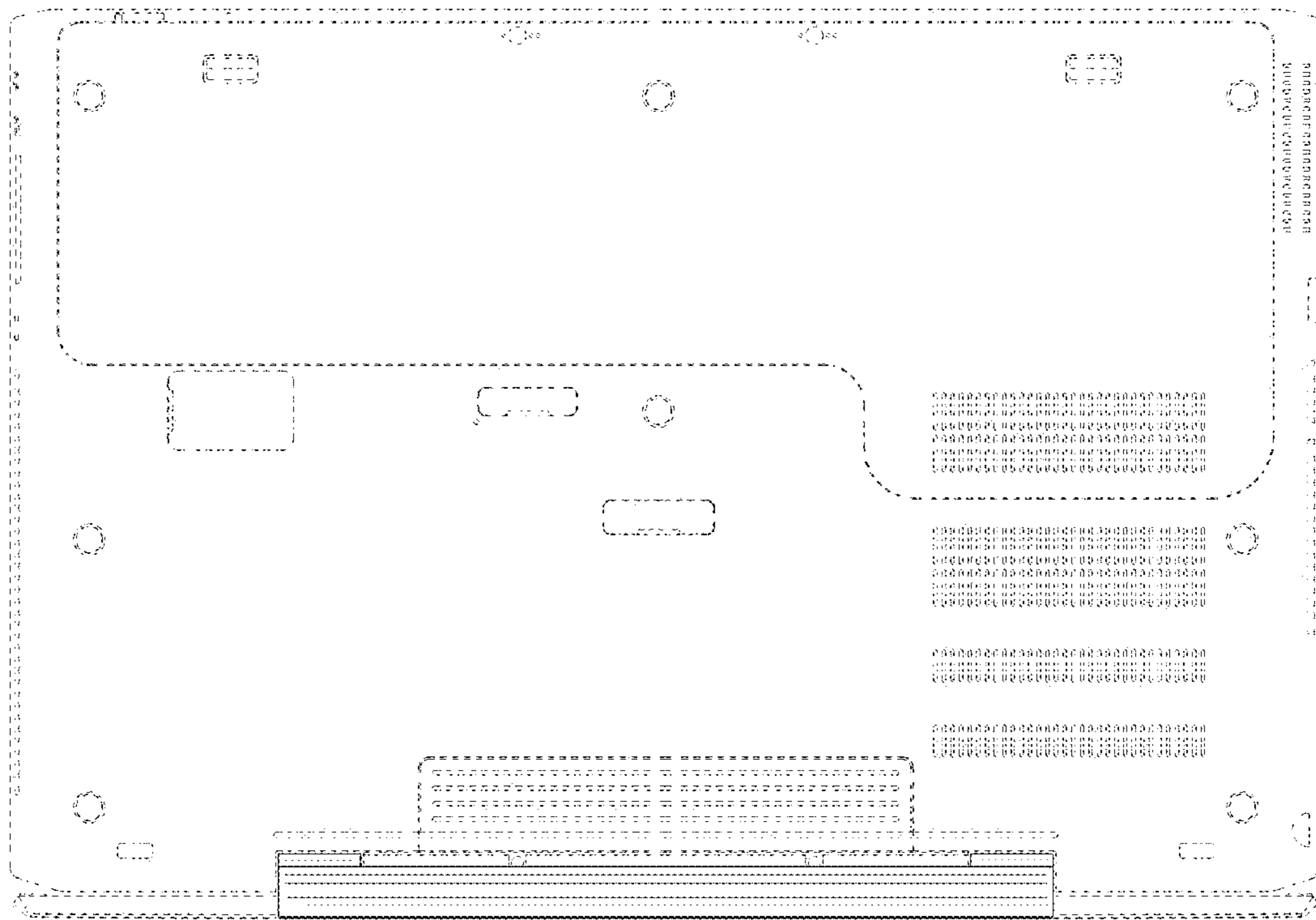

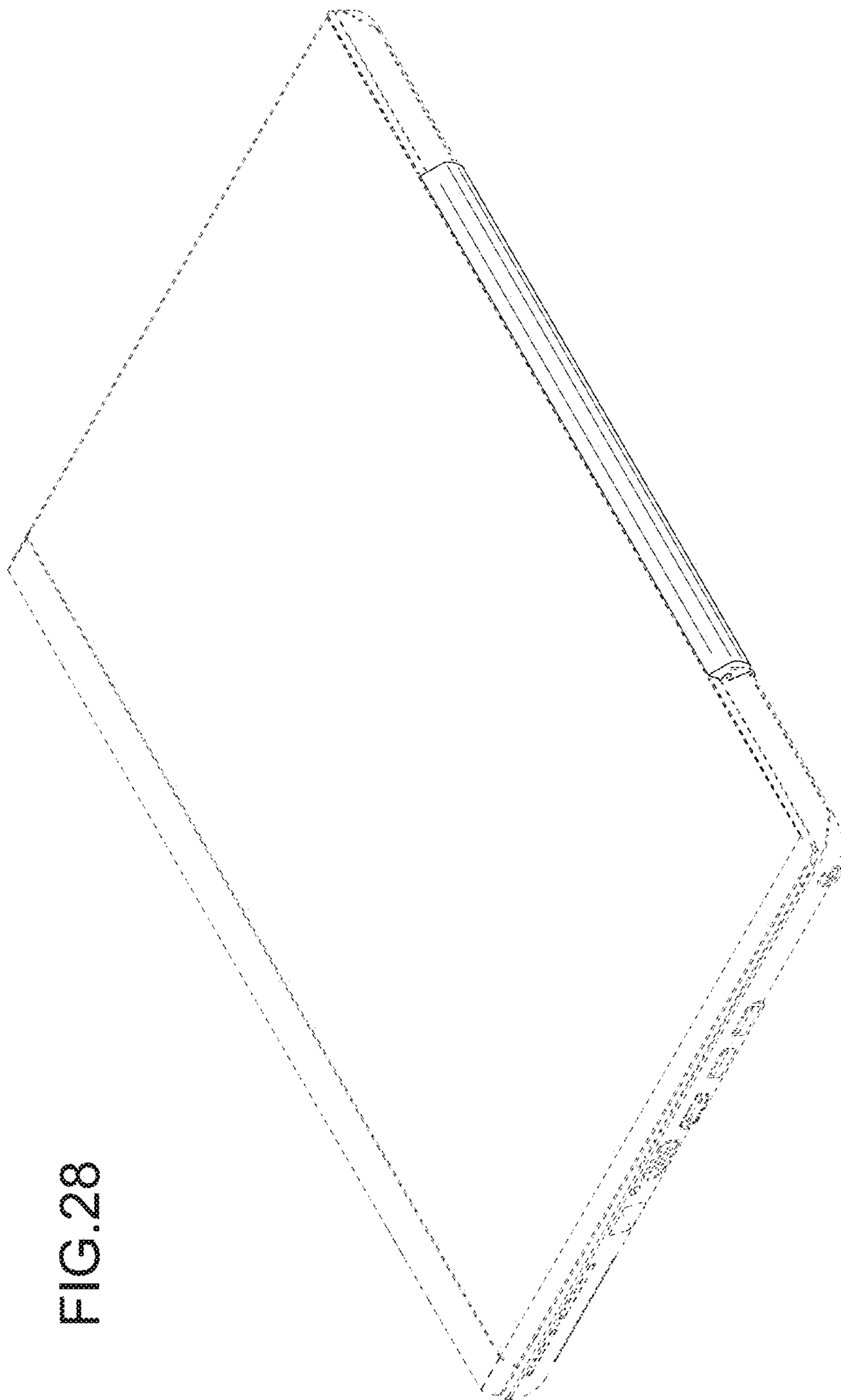

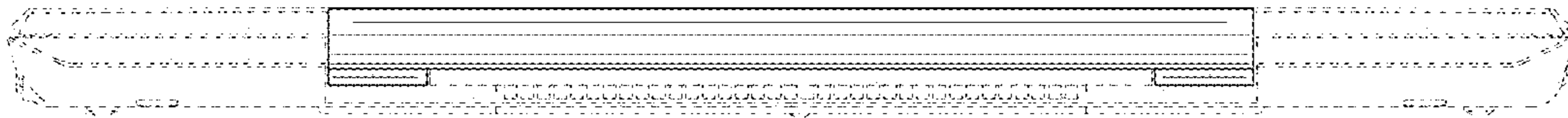

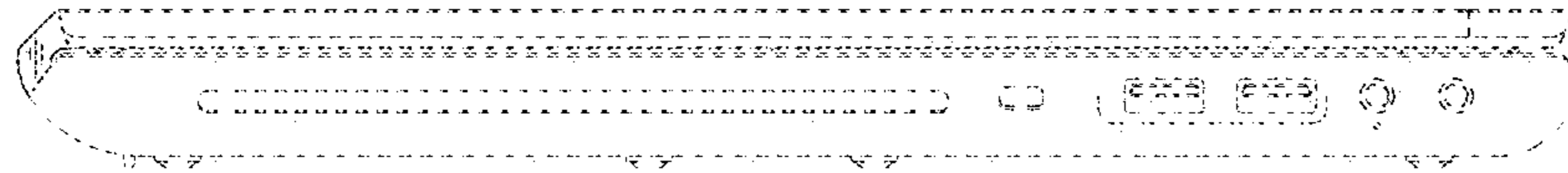

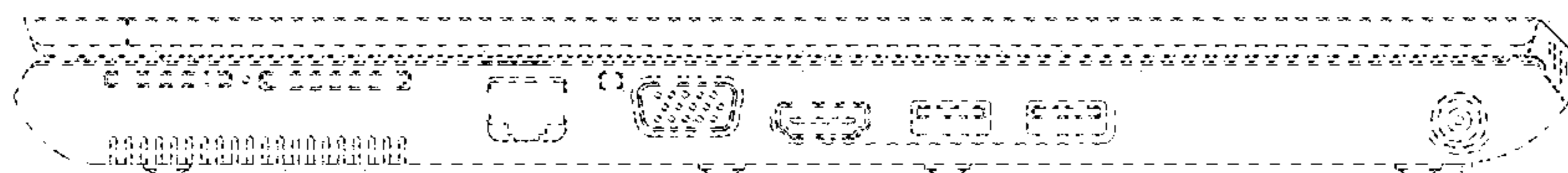

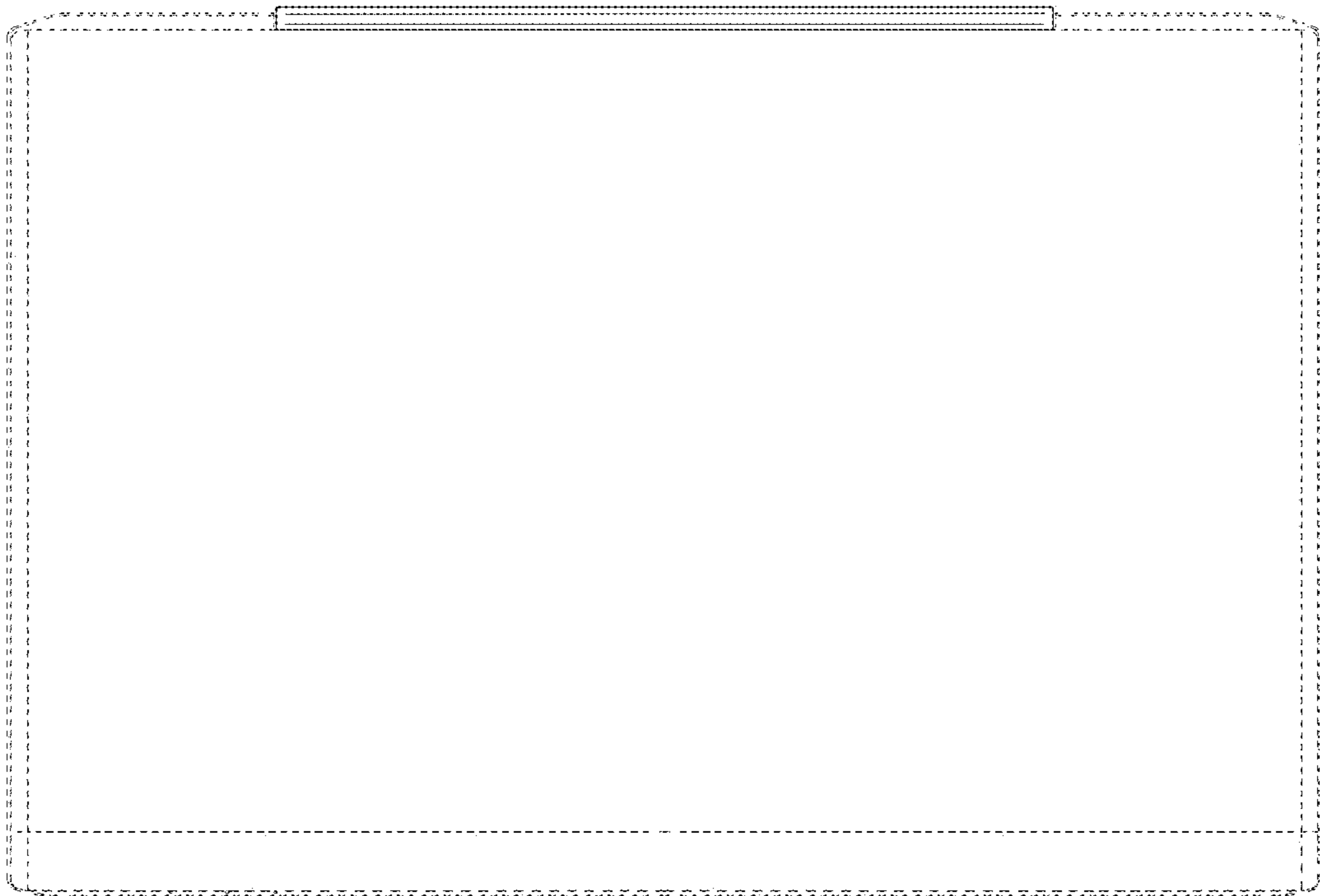

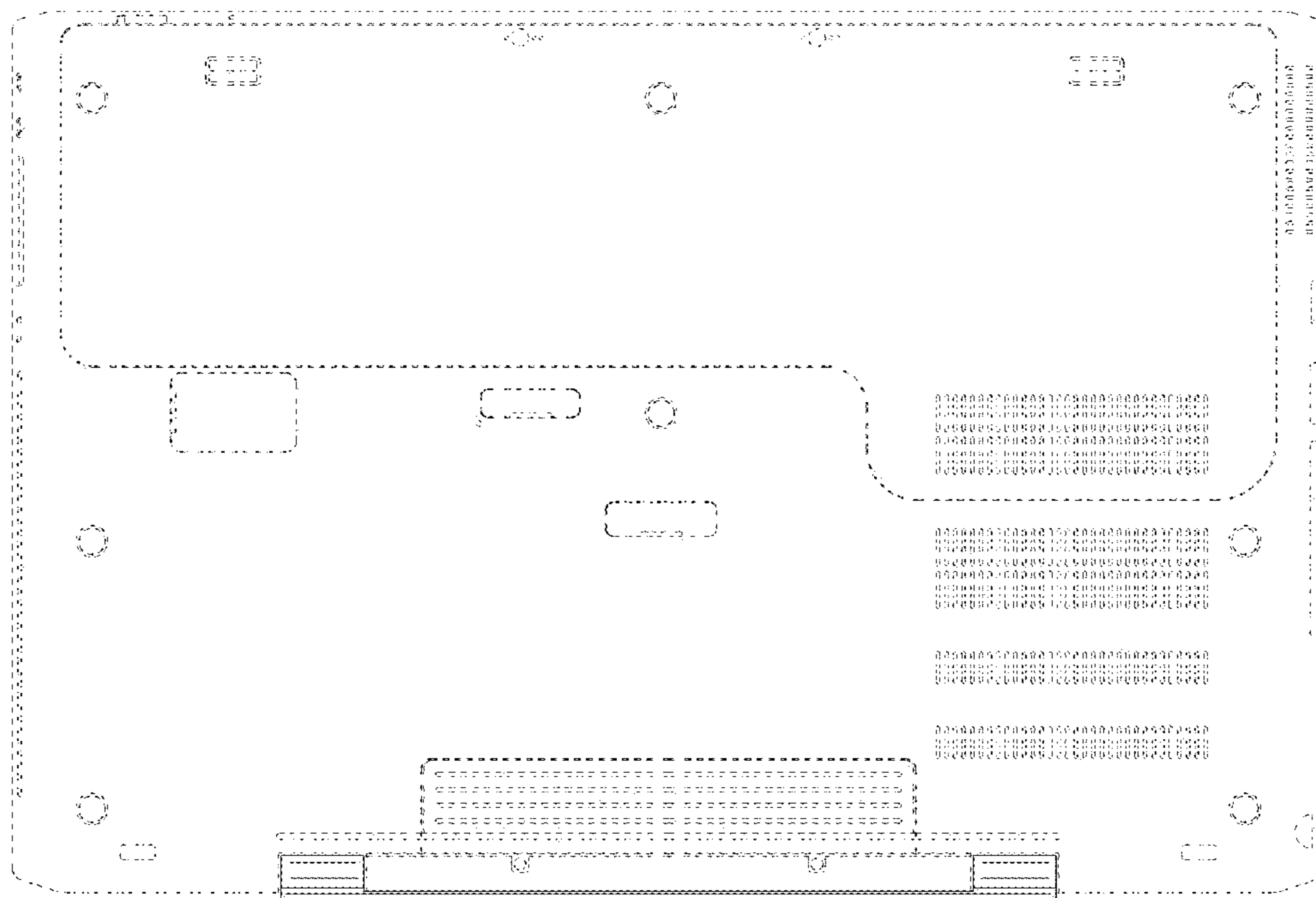
