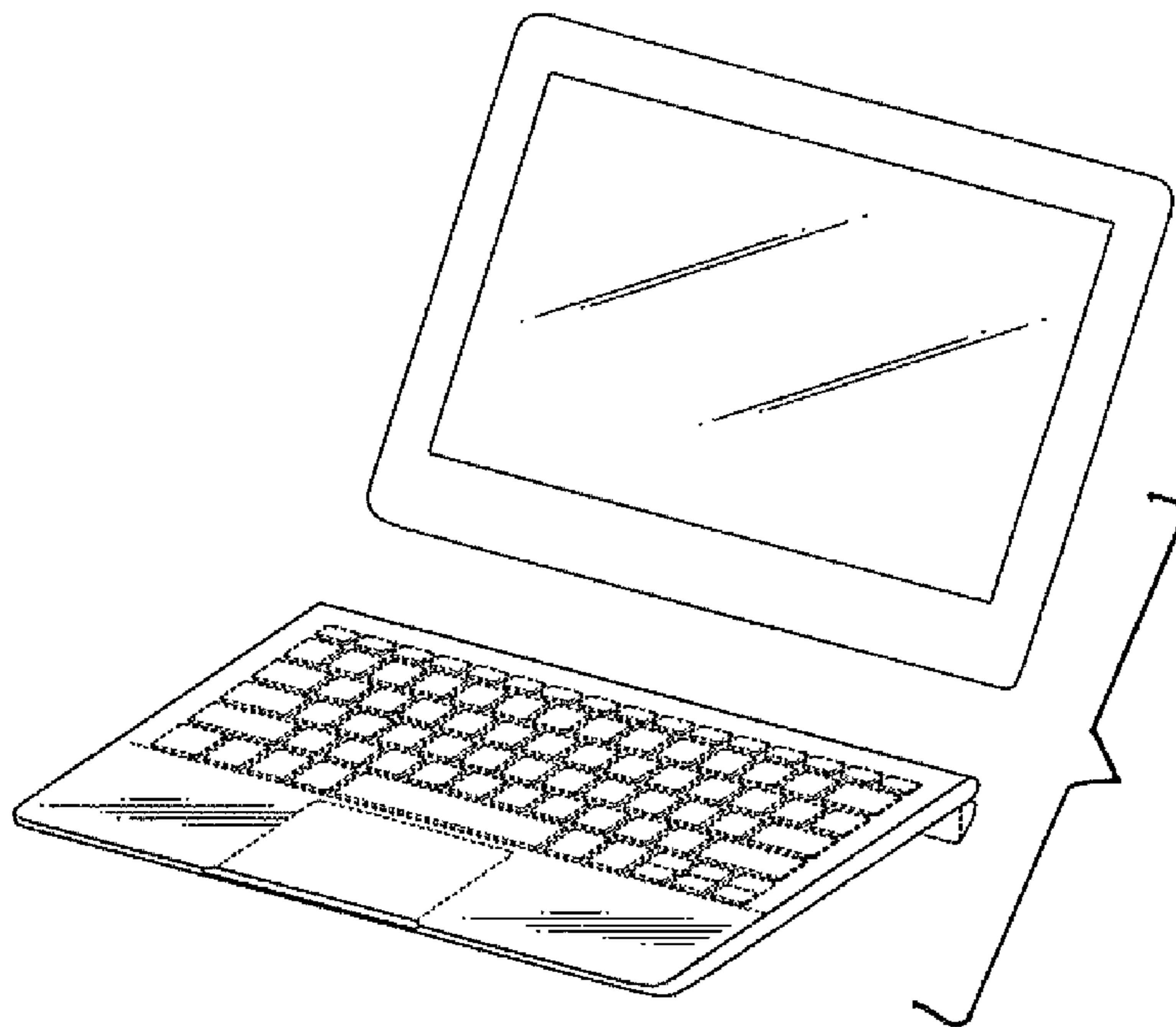
(57) **CLAIM**

The ornamental design for the detachable electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a detachable electronic device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a front perspective view of a detachable electronic device of FIG. 1 in open state and the screen facing inward;
FIG. 9 is a front perspective view of a detachable electronic device of FIG. 1 in separate state; and,
FIG. 10 is a front perspective view of a detachable electronic device of FIG. 1 in open state and the screen facing outward.
Broken lines shown in the drawings illustrate portions of the detachable electronic device, and form no part of the claimed design.

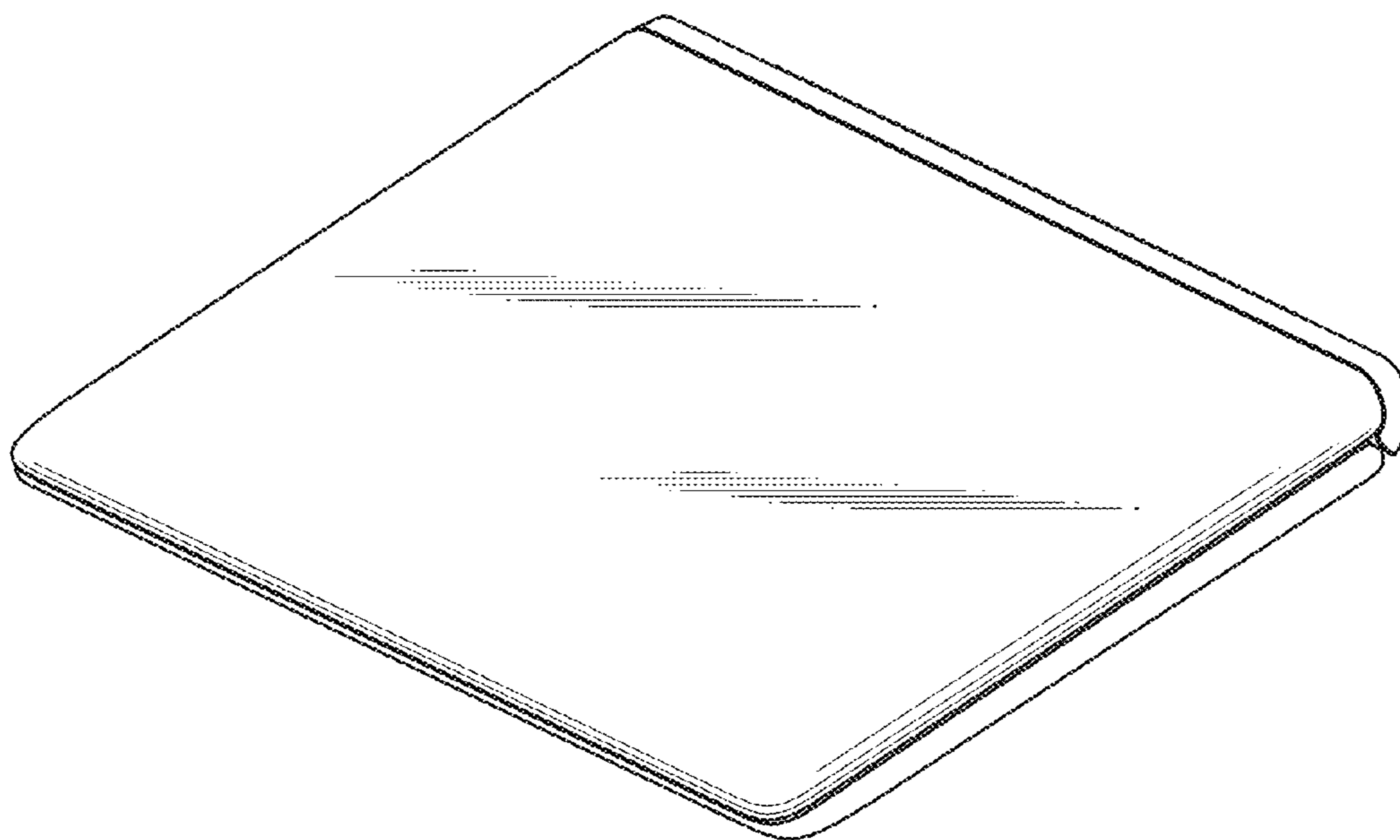

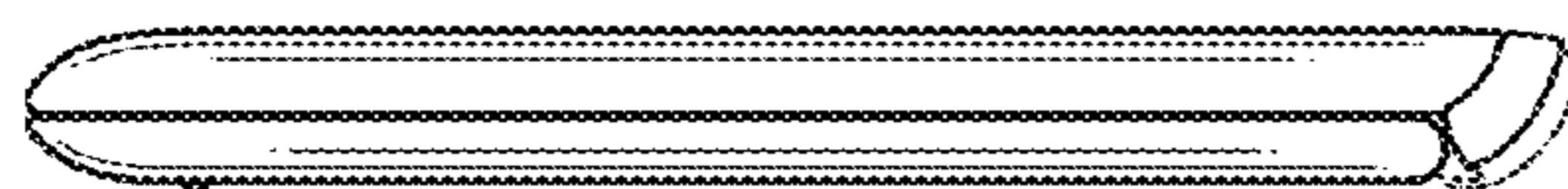

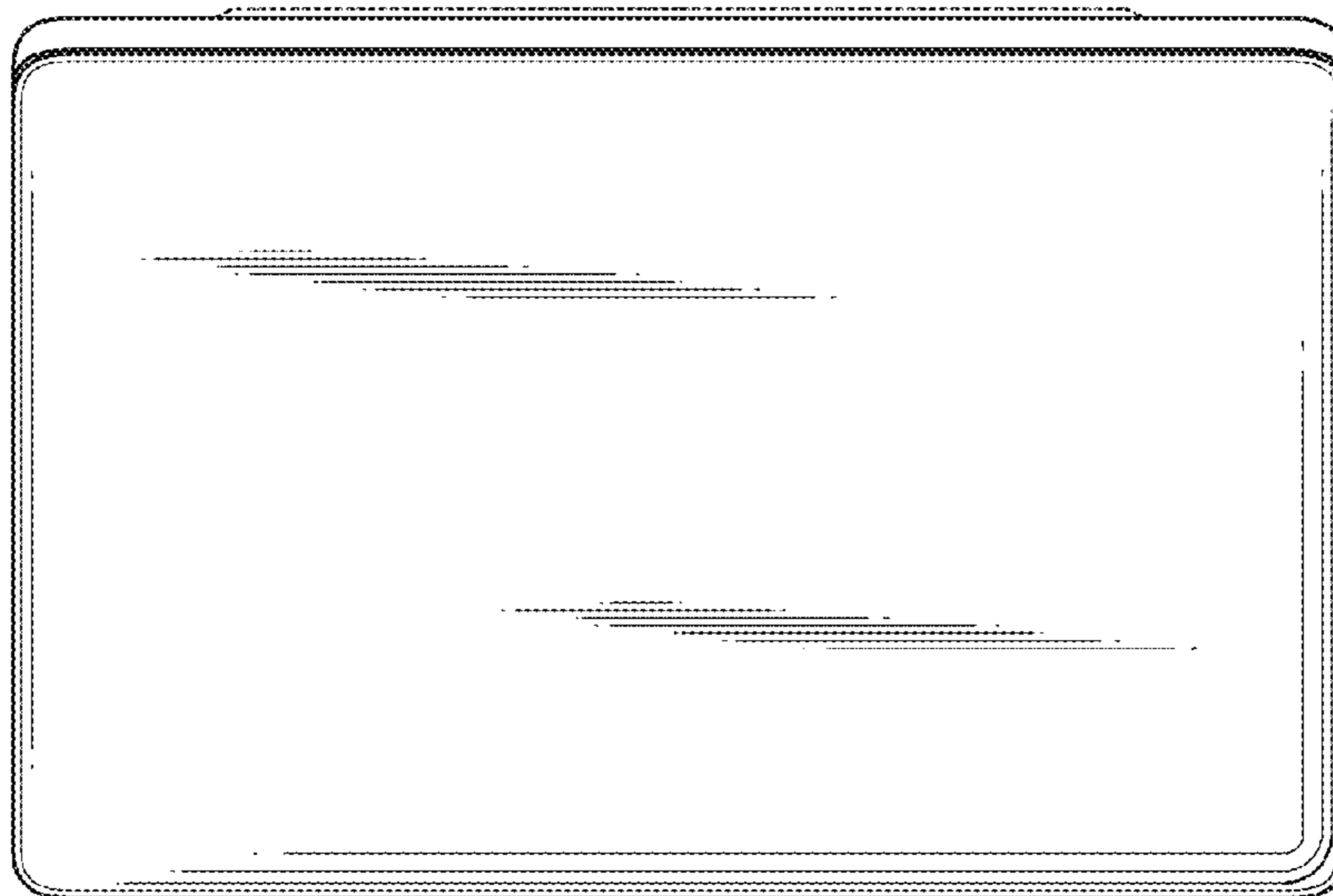

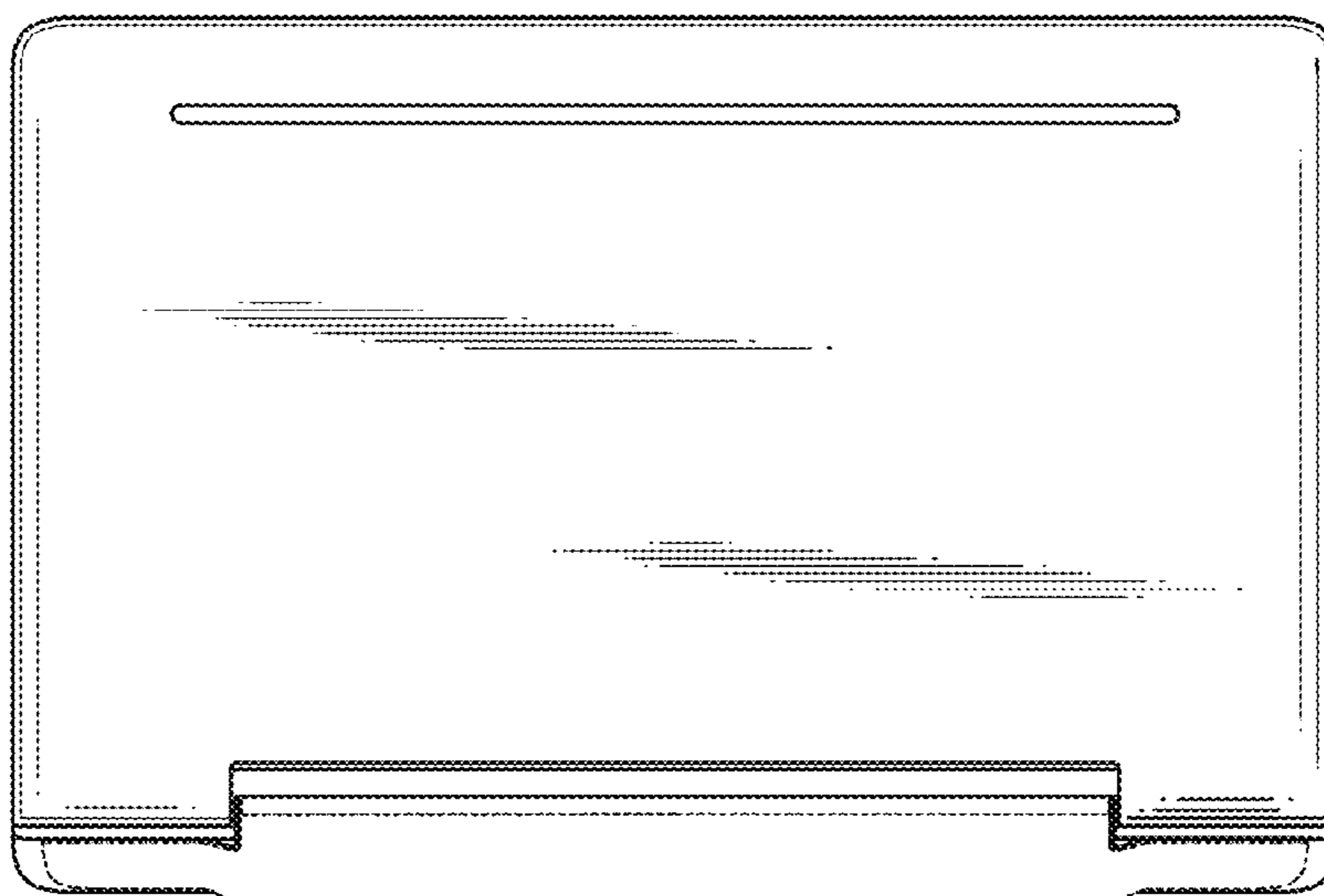

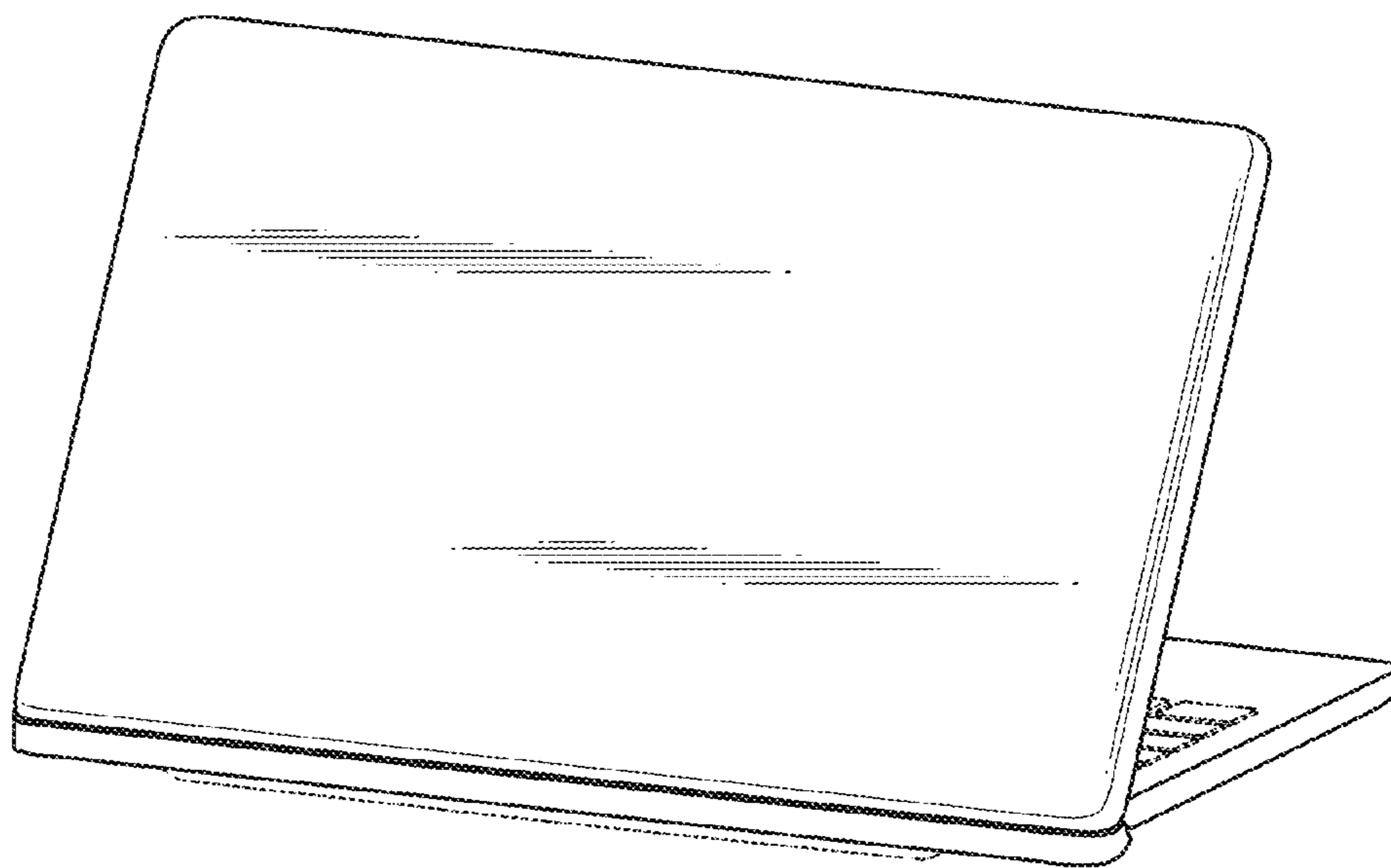

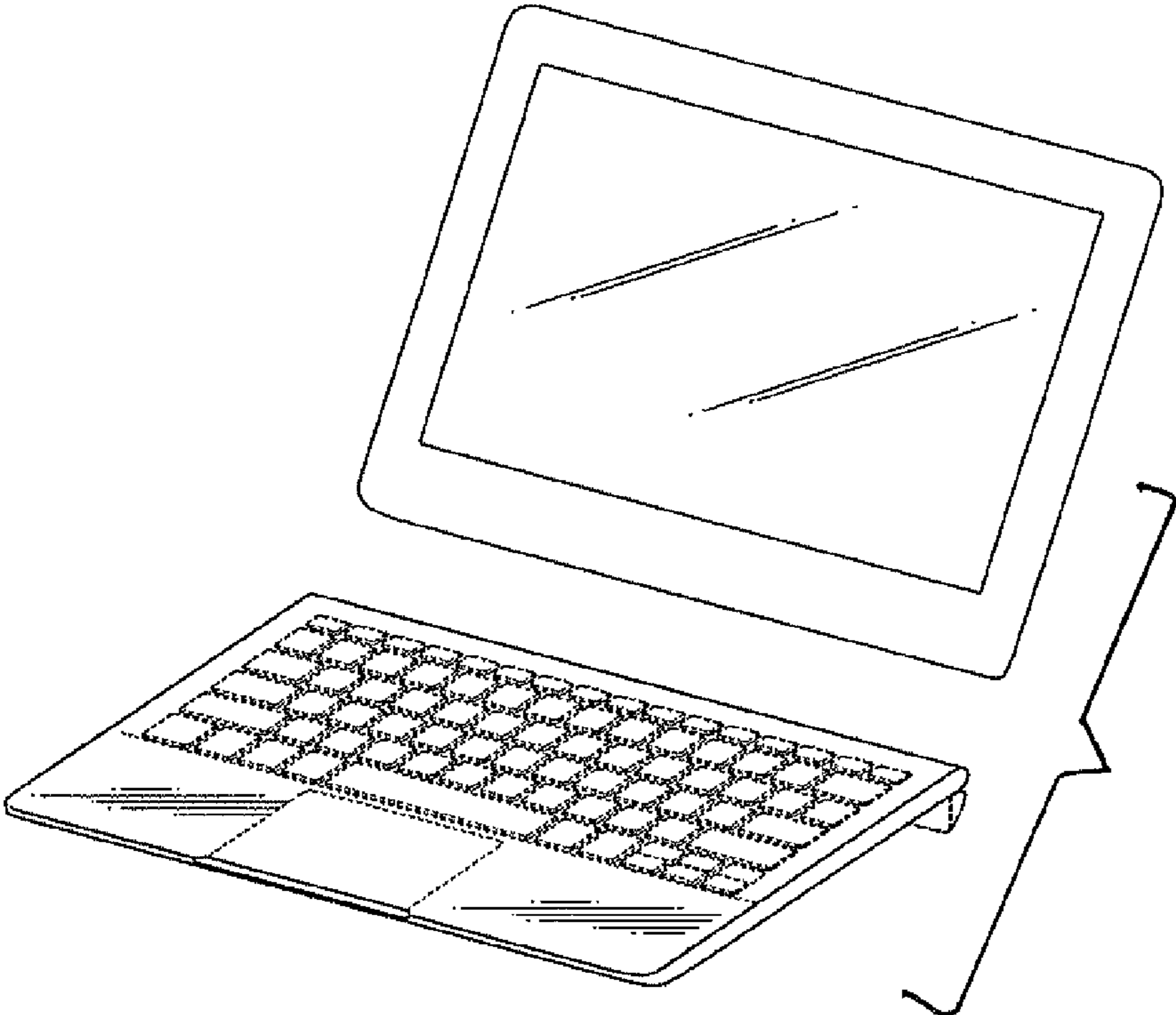

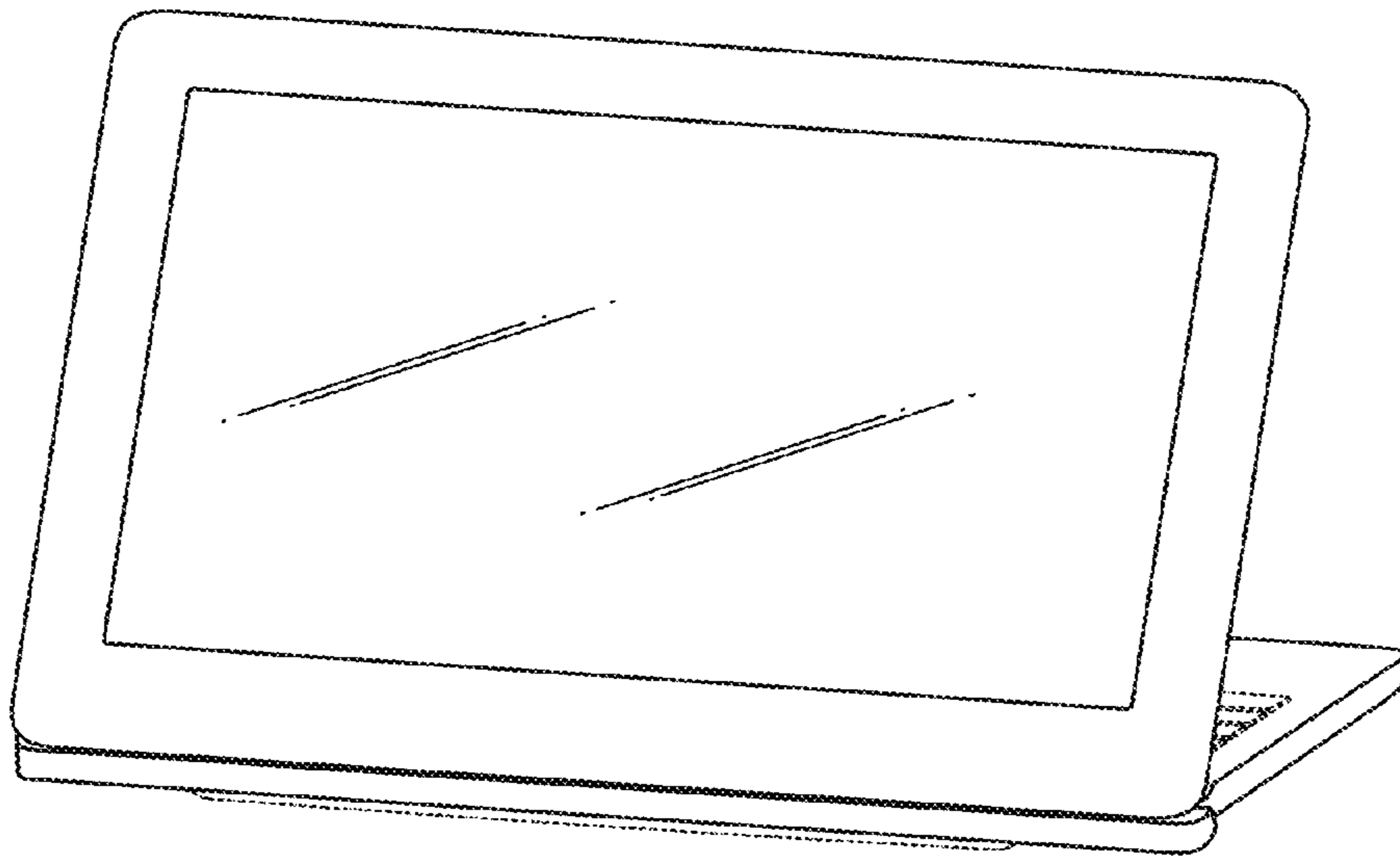
