(57) **CLAIM**

I claim the ornamental design for a display of mobile phone with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 7 is a front view of a sixth image thereof;

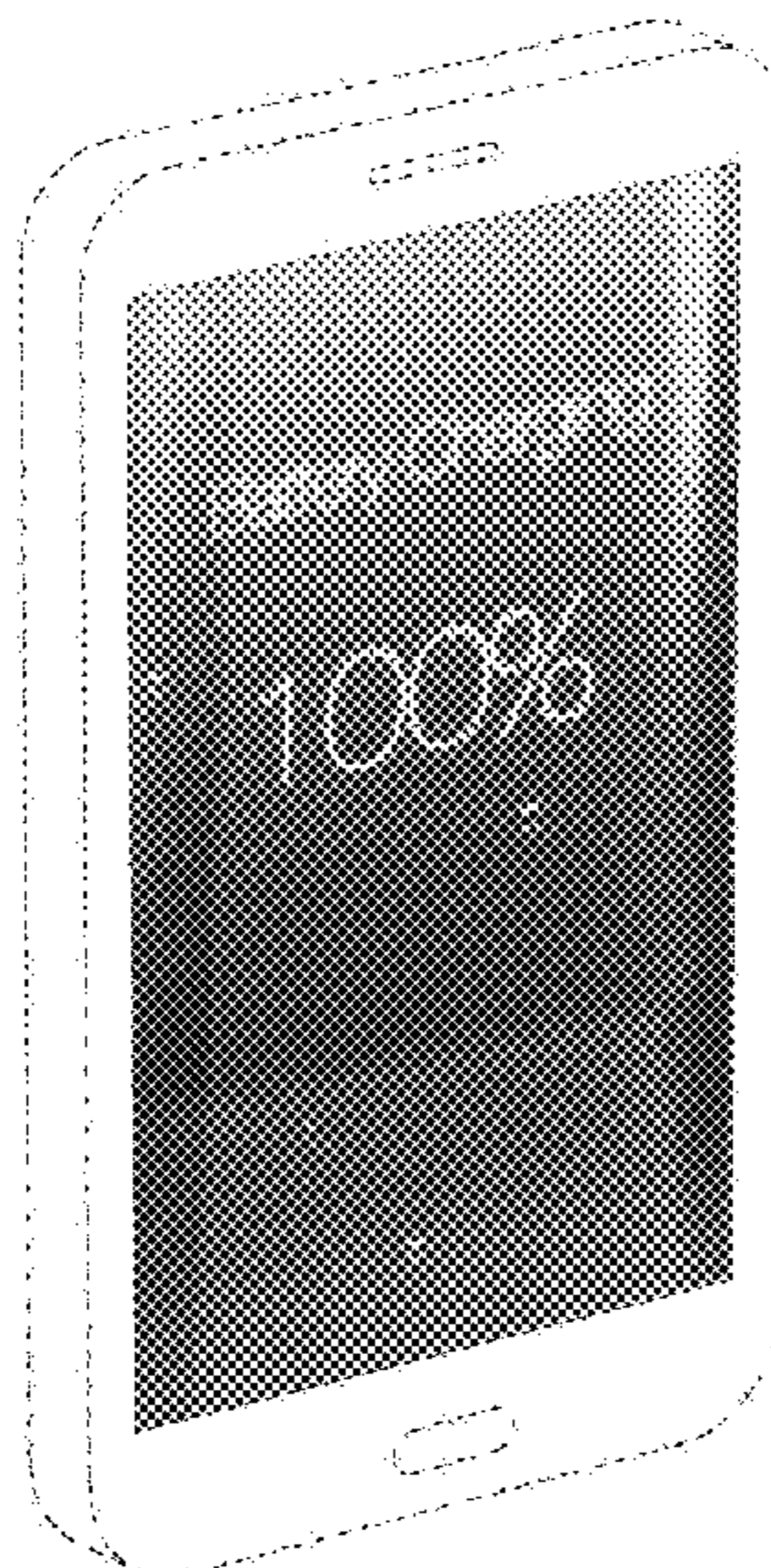
FIG. 8 is a front view of a seventh image thereof; and,

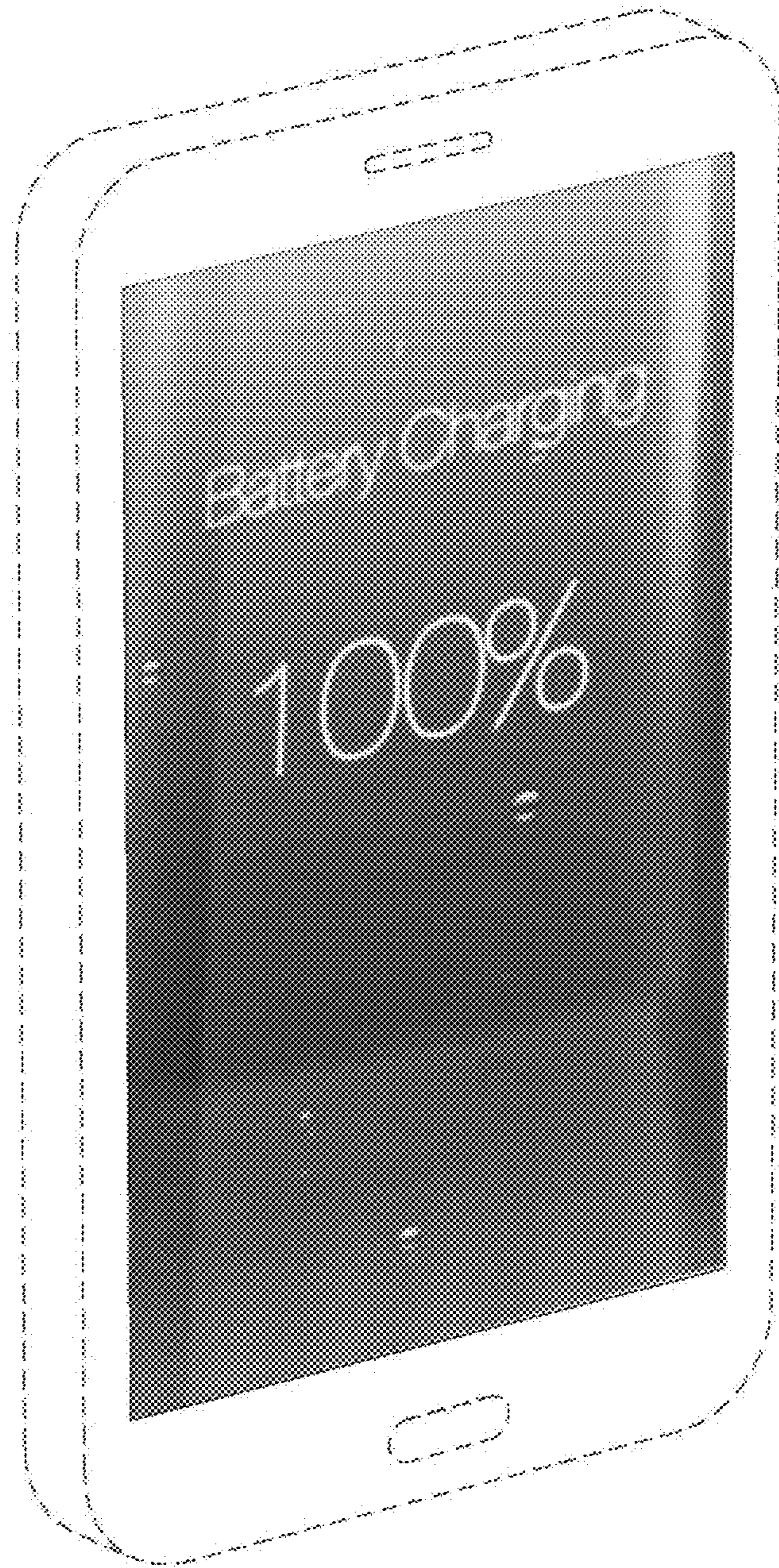

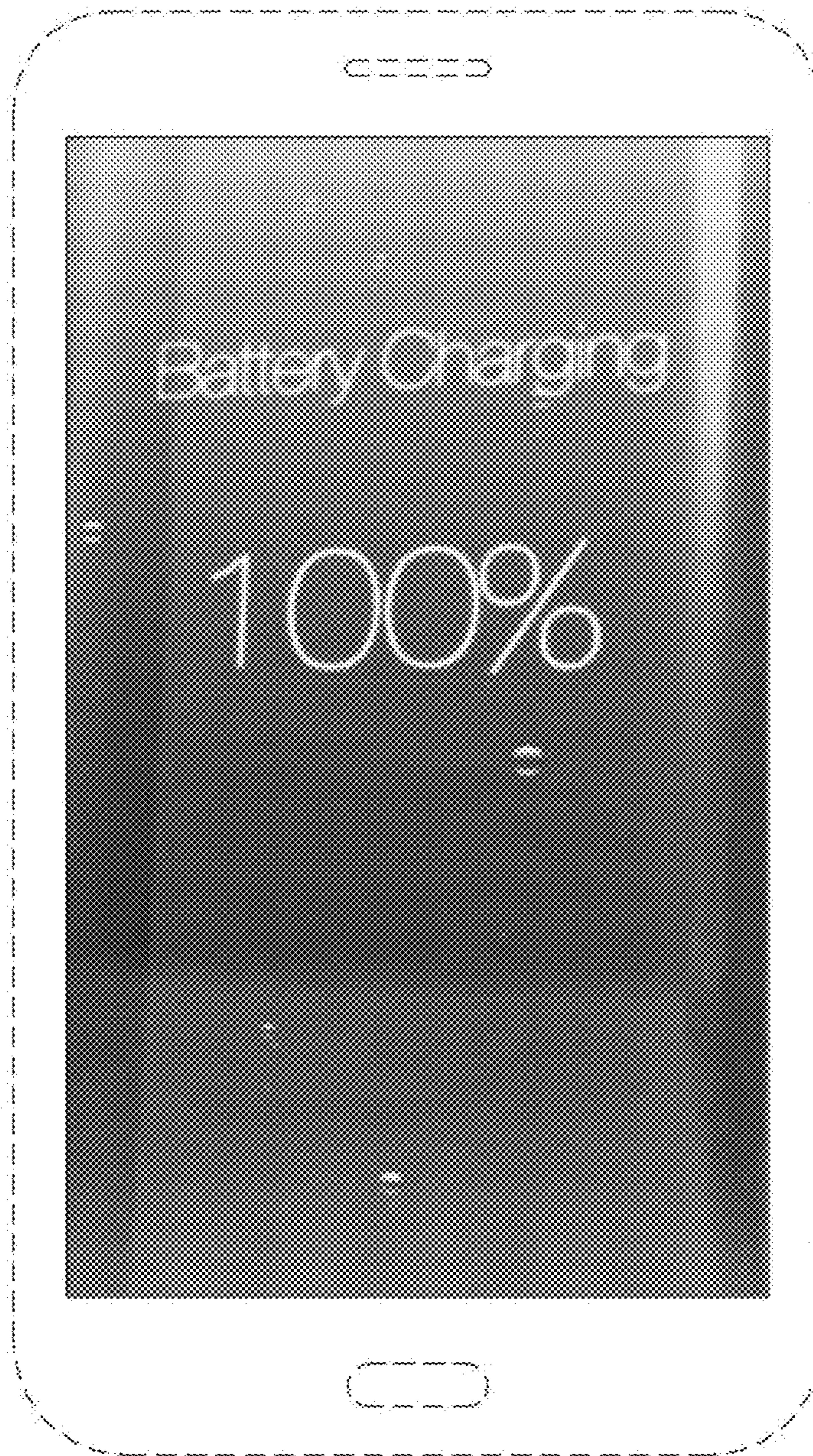

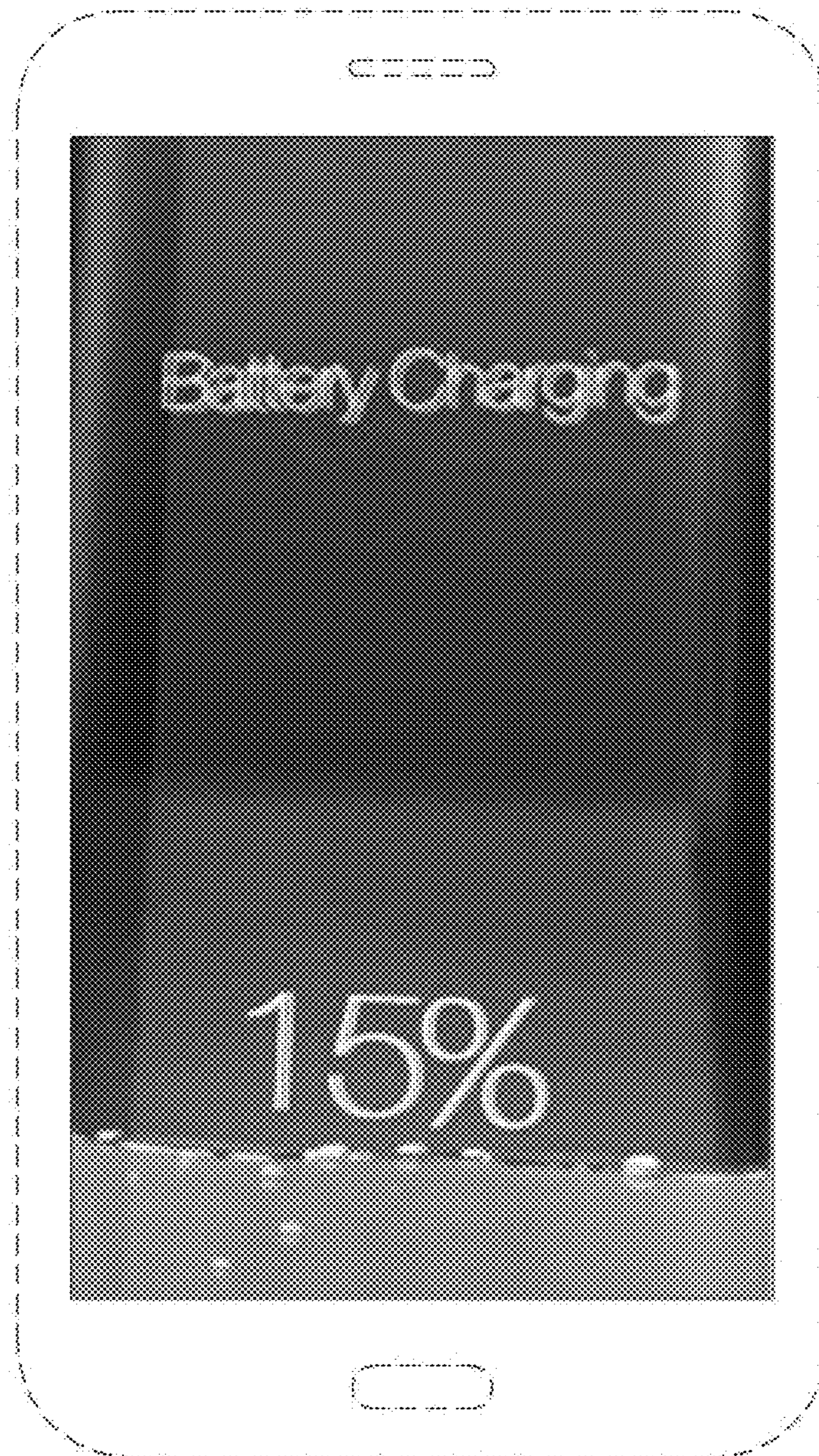

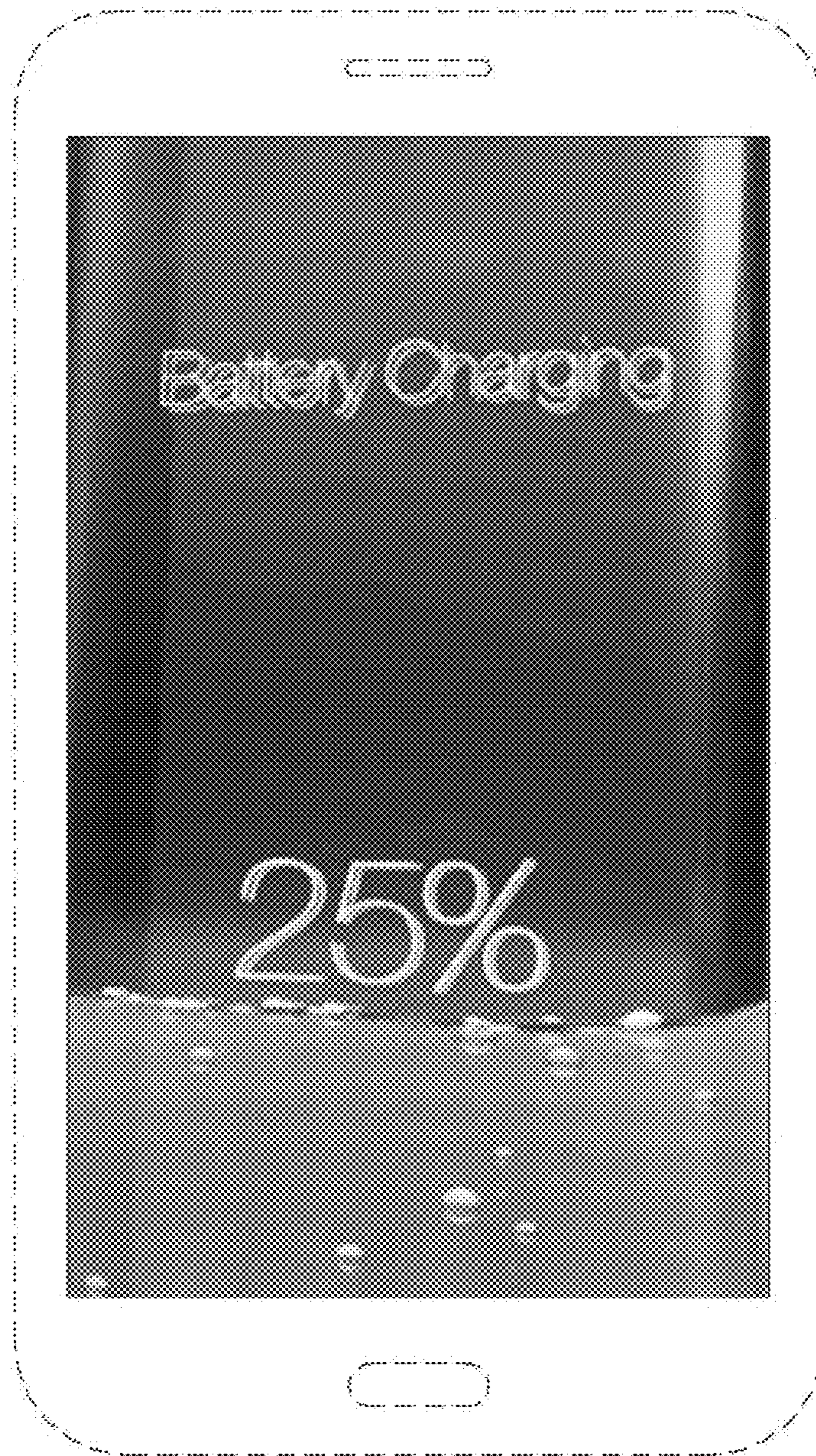

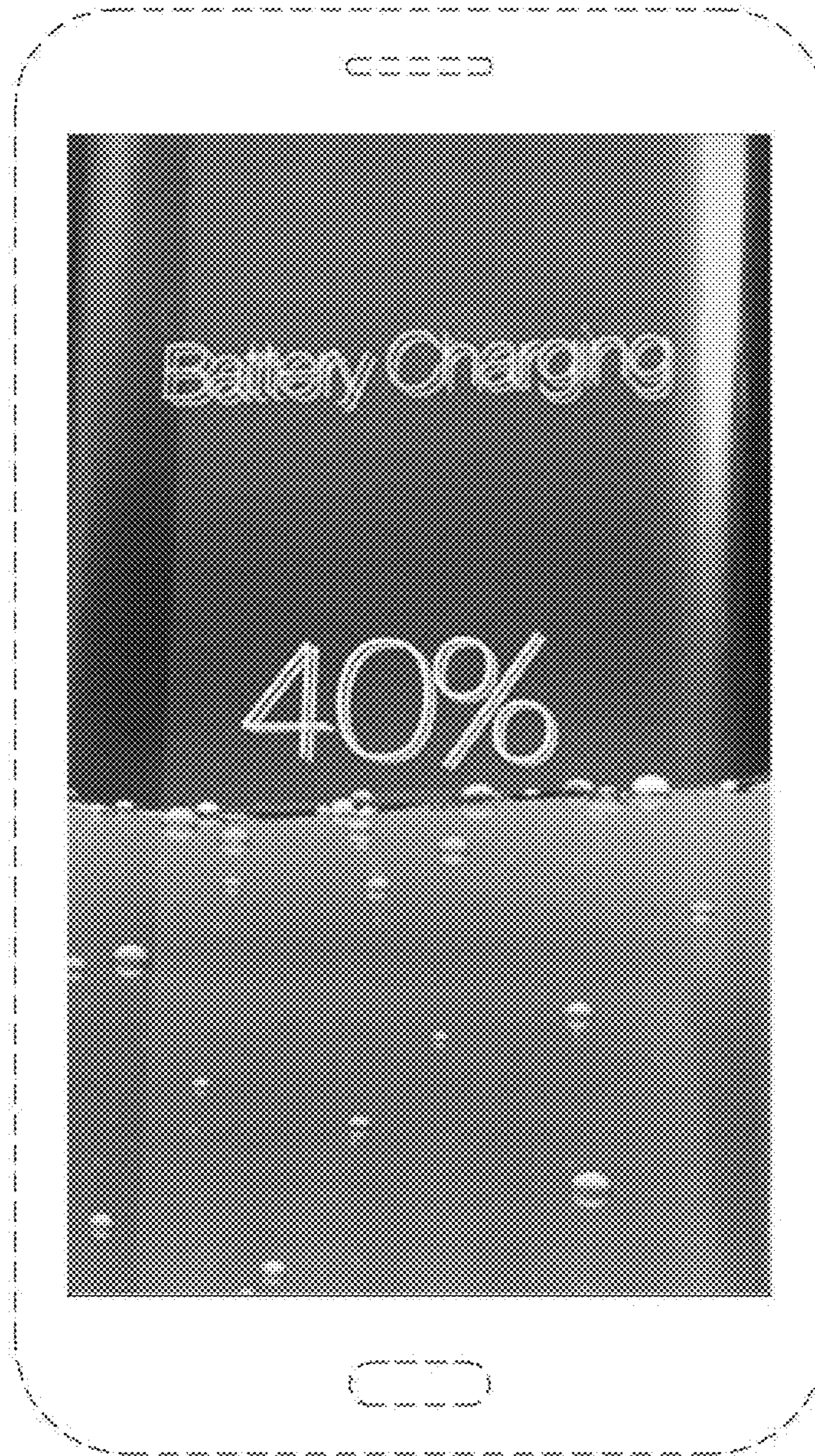

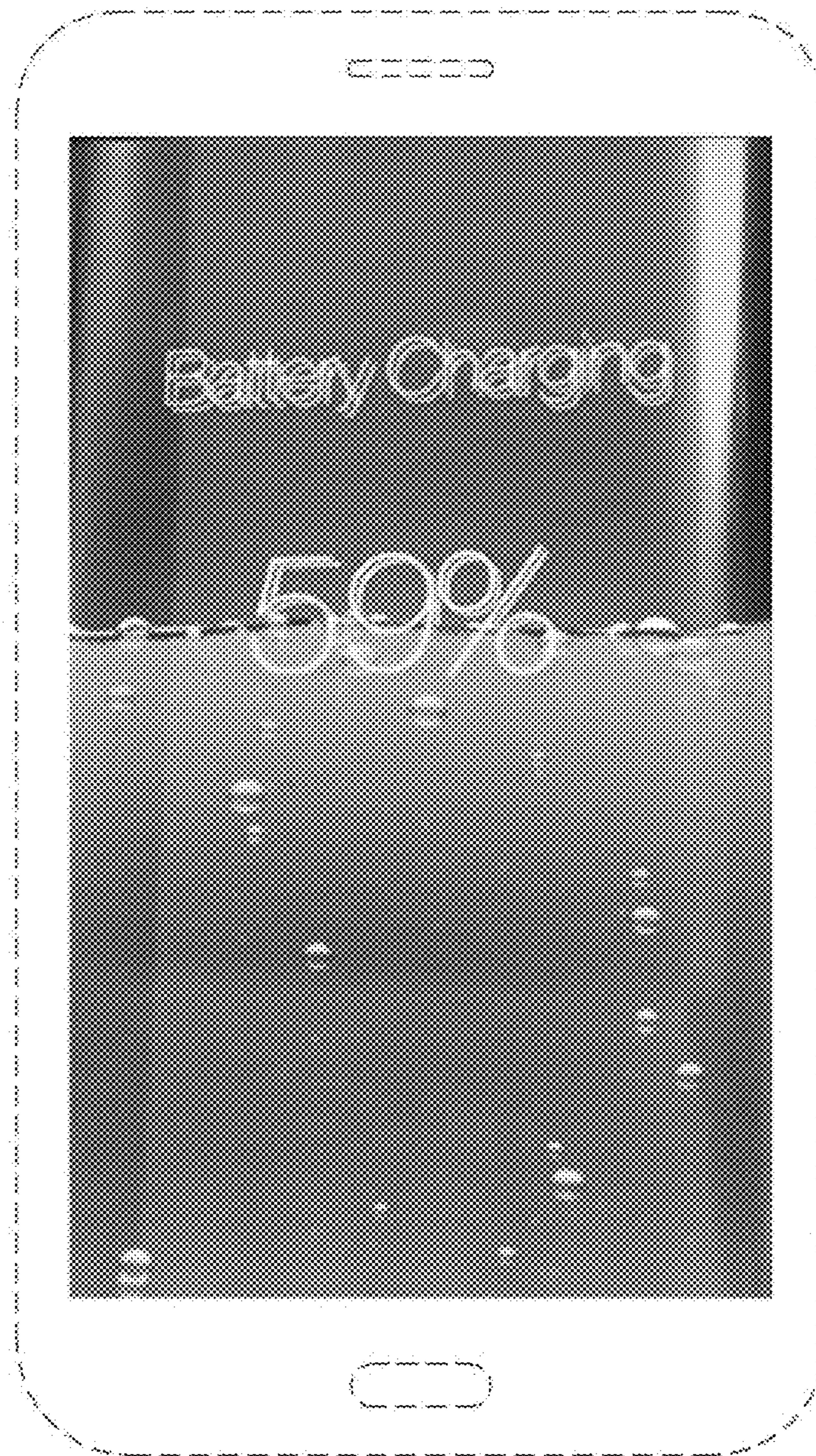

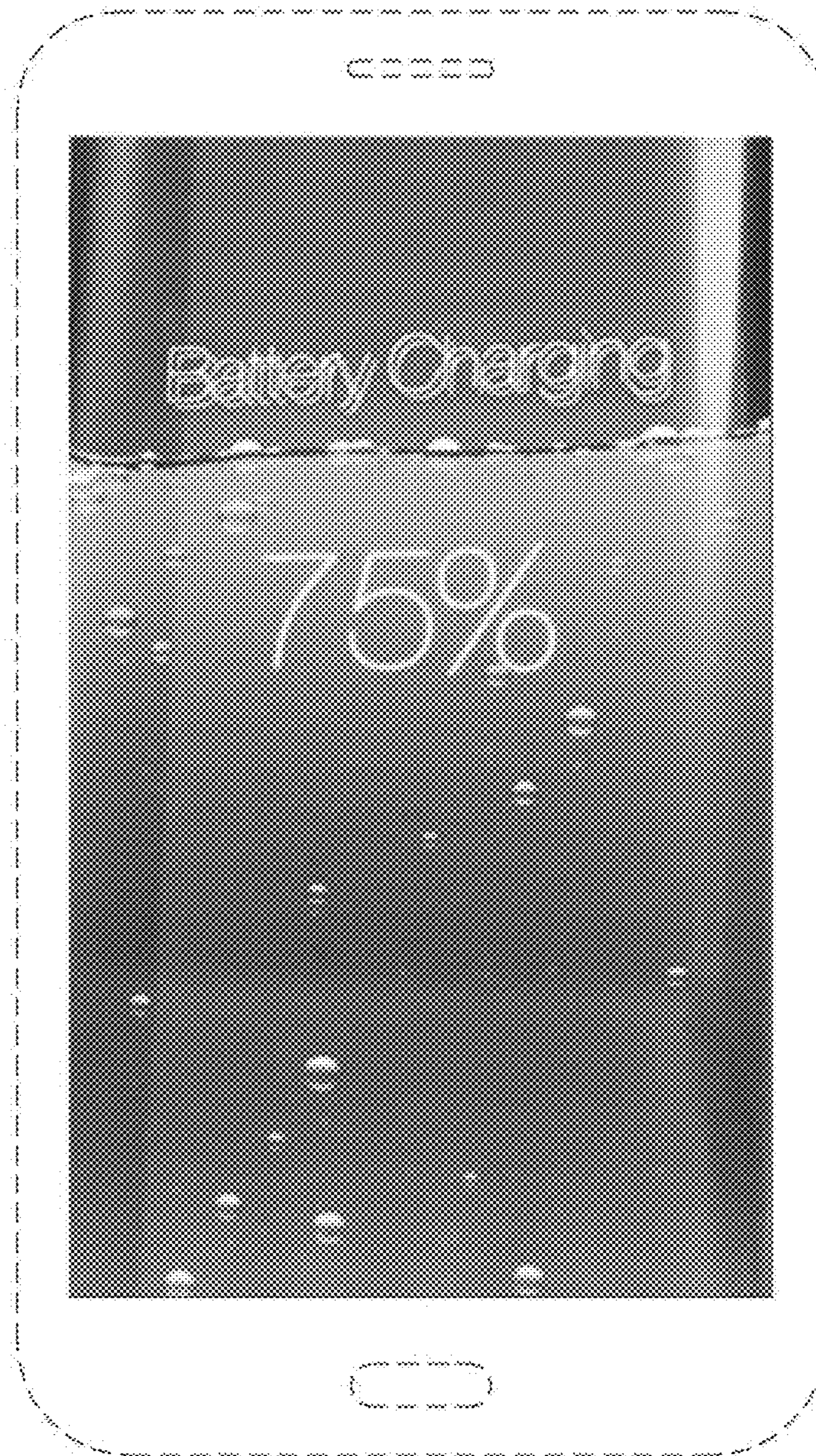

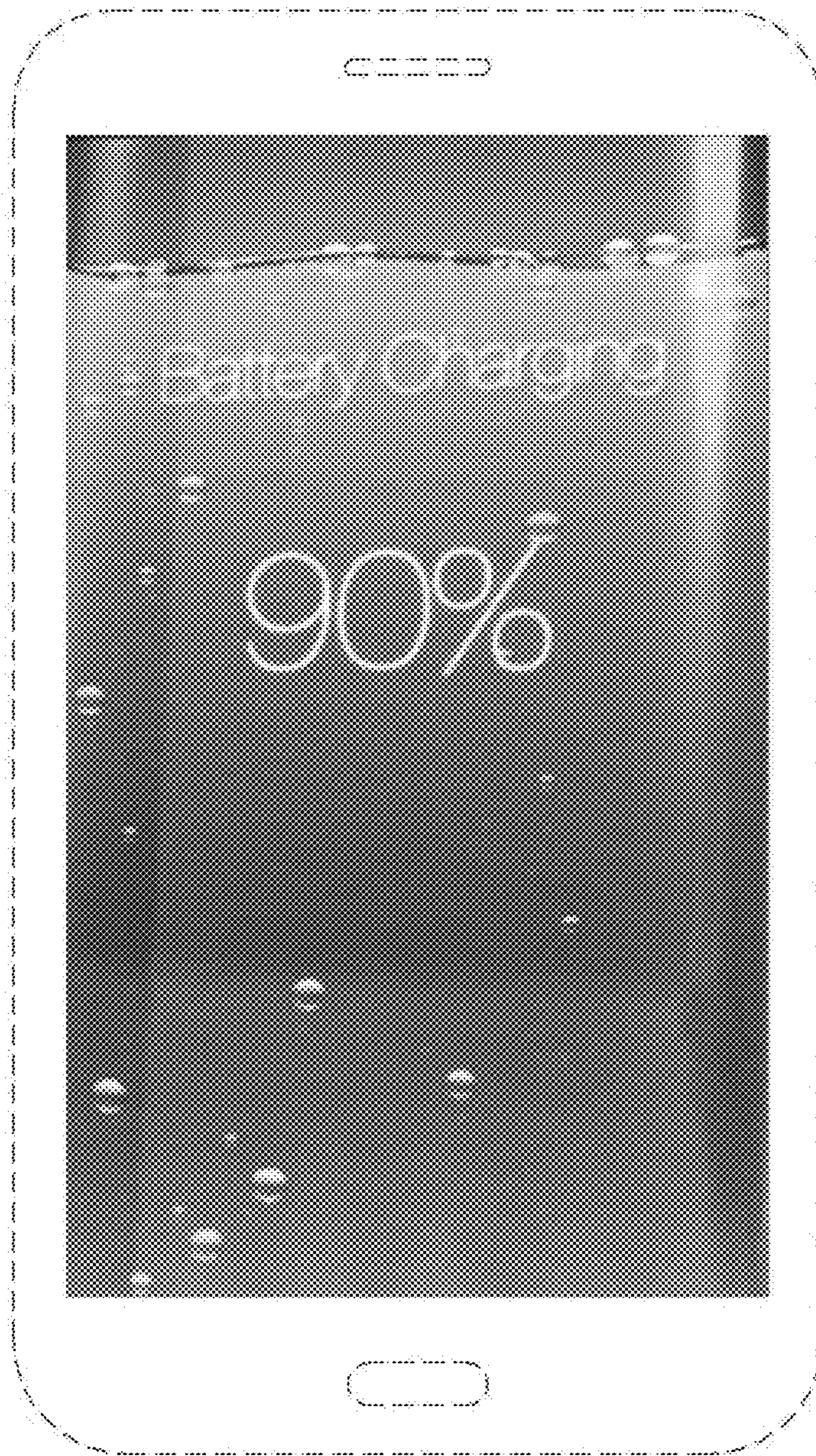
