The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence of a display screen with animated graphical user interface showing the new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; FIG. 4 is the fourth image thereof; FIG. 5 is the fifth image thereof; FIG. 6 is the sixth image thereof; FIG. 7 is the seventh image thereof; FIG. 8 is the eighth image thereof; FIG. 9 is the ninth image thereof; FIG. 10 is the tenth image thereof; FIG. 11 is the eleventh image thereof; FIG. 12 is the twelfth image thereof; FIG. 13 is the thirteenth image thereof; FIG. 14 is the fourteenth image thereof; FIG. 15 is the fifteenth image thereof; and, FIGS. 16-30 show the display screen with animated graphical user interface of FIGS. 1-15 on an unclaimed device. The appearance of the display screen with animated graphical user interface sequentially transitions between the images shown in FIGS. 1-15 and in FIGS. 16-30. The process or period in which one image transitions to another forms no part of the claimed design. The broken line showing of the text, remainder of the graphical user interface and the remainder of the display screen in FIGS. 1-15 and the unclaimed device having the display screen with animated graphical user interface in FIGS. 16-30 represents unclaimed environmental subject matter and forms no part of the claimed design.

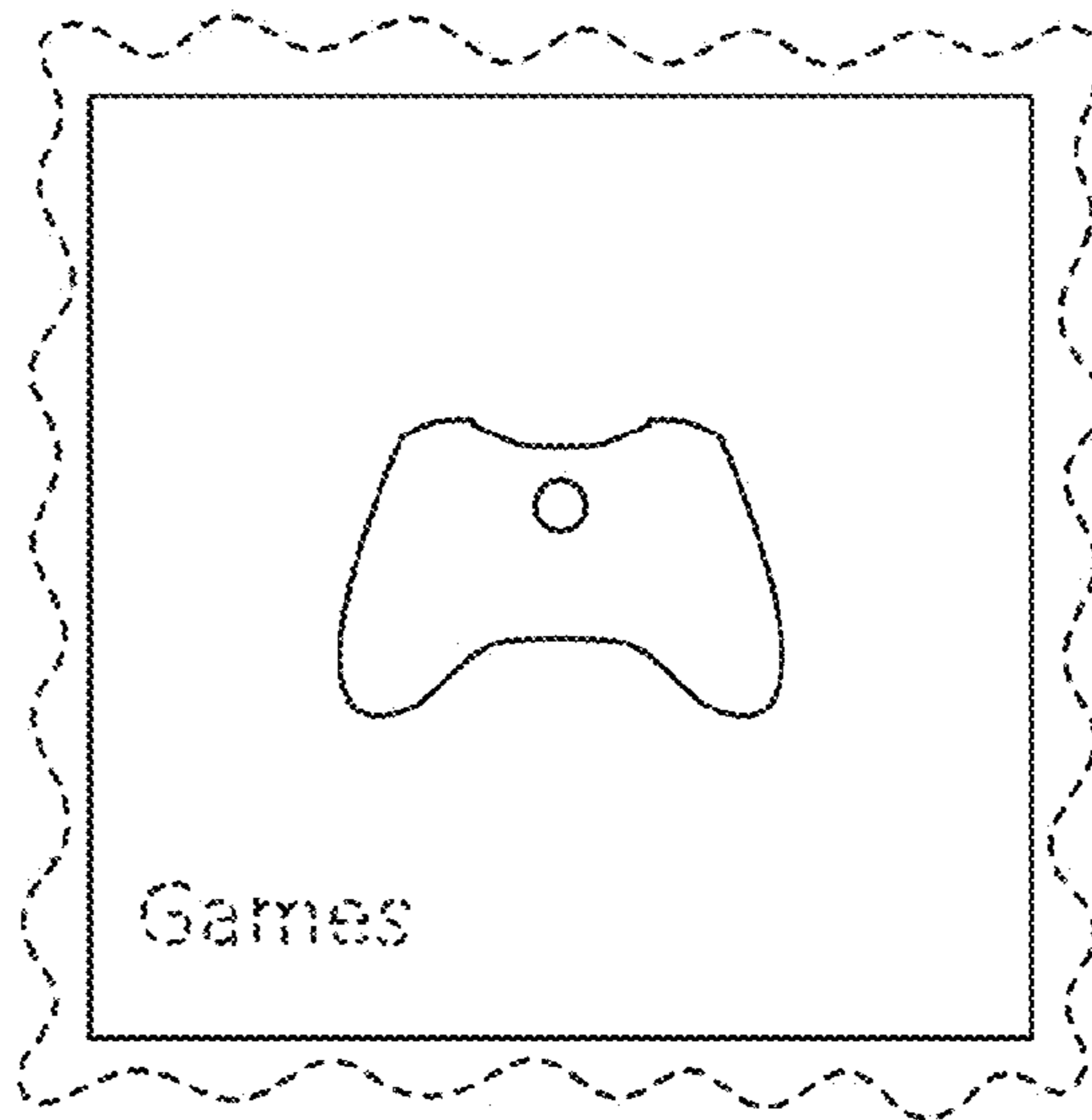

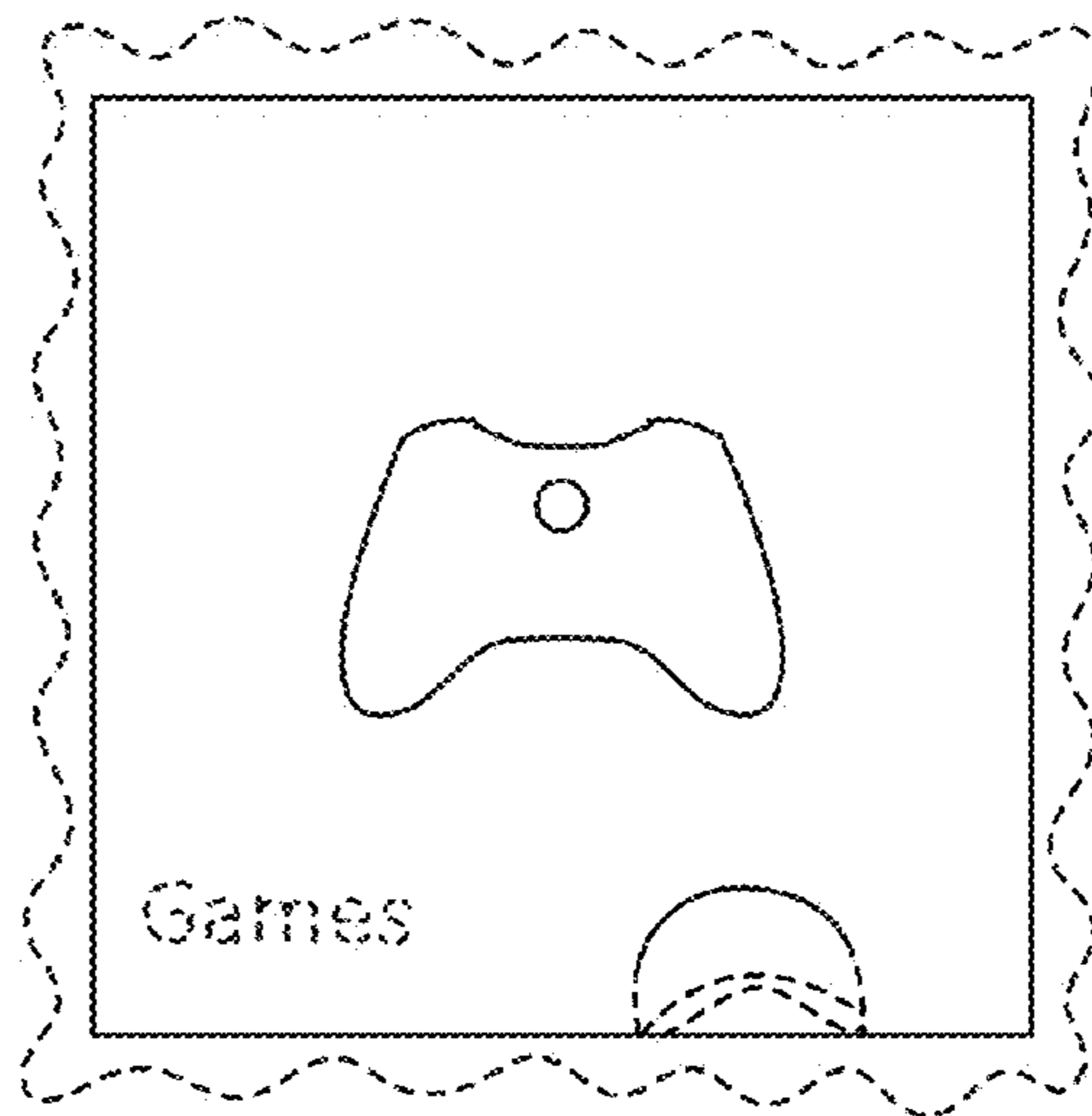

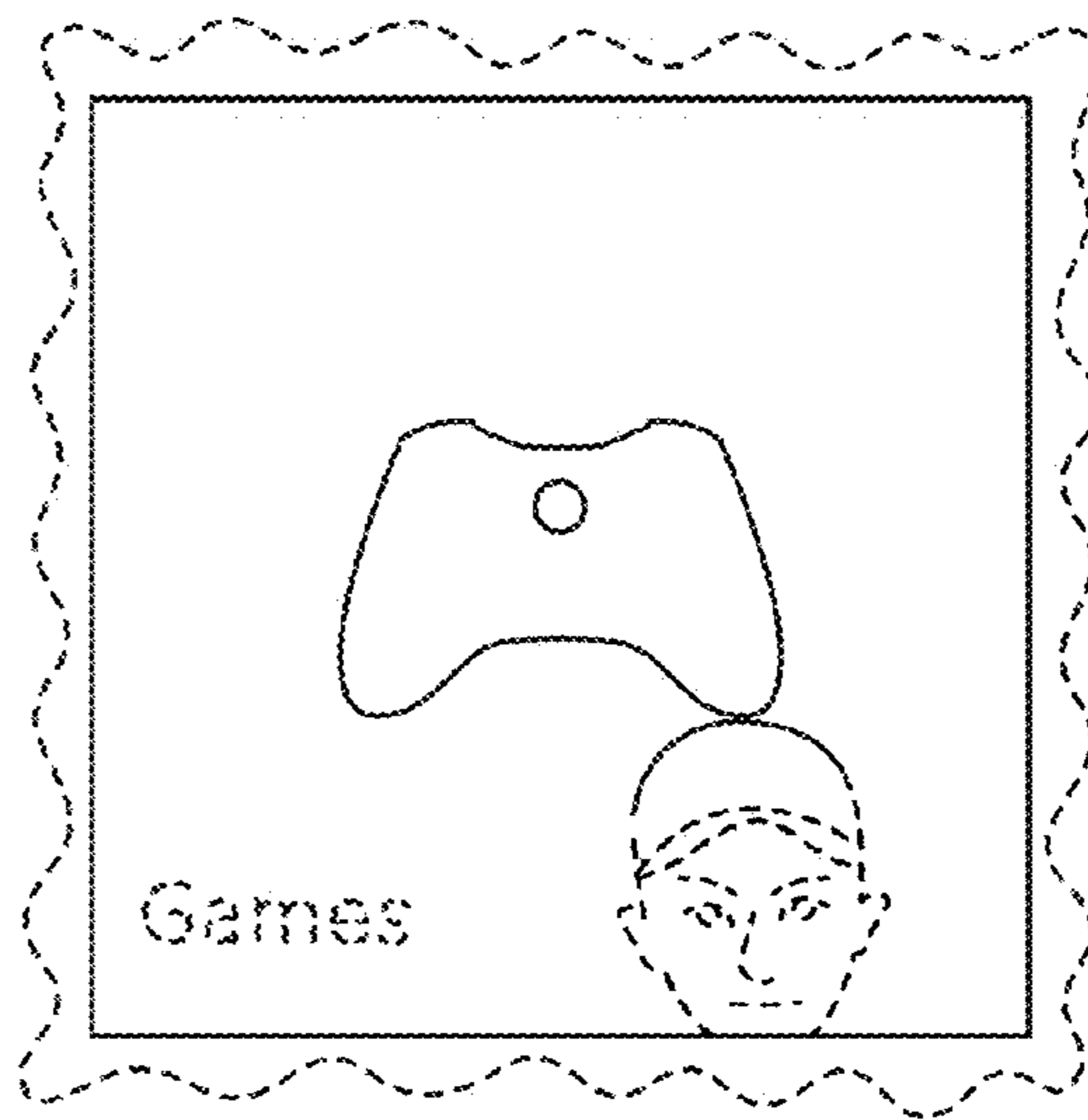

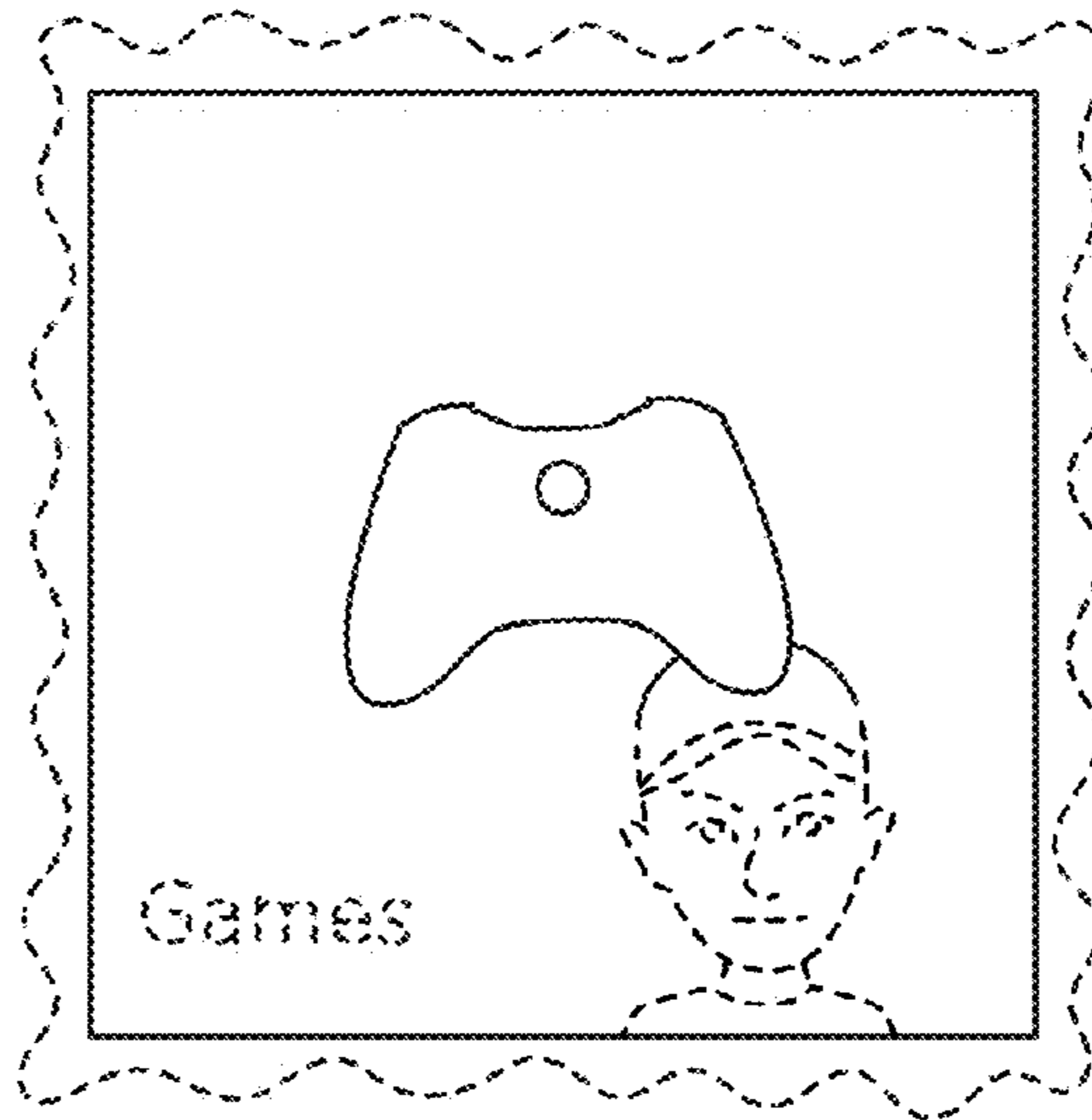

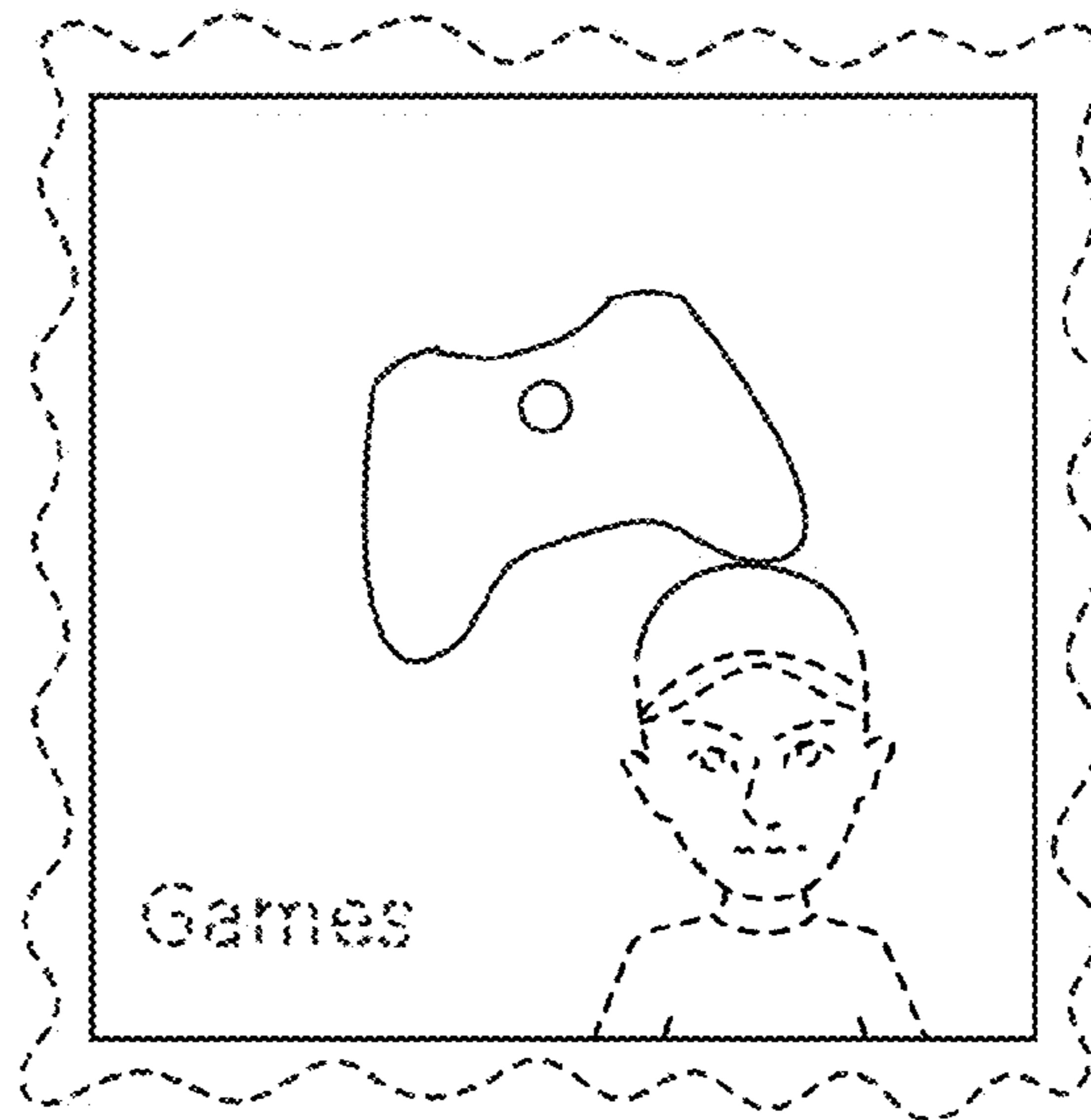

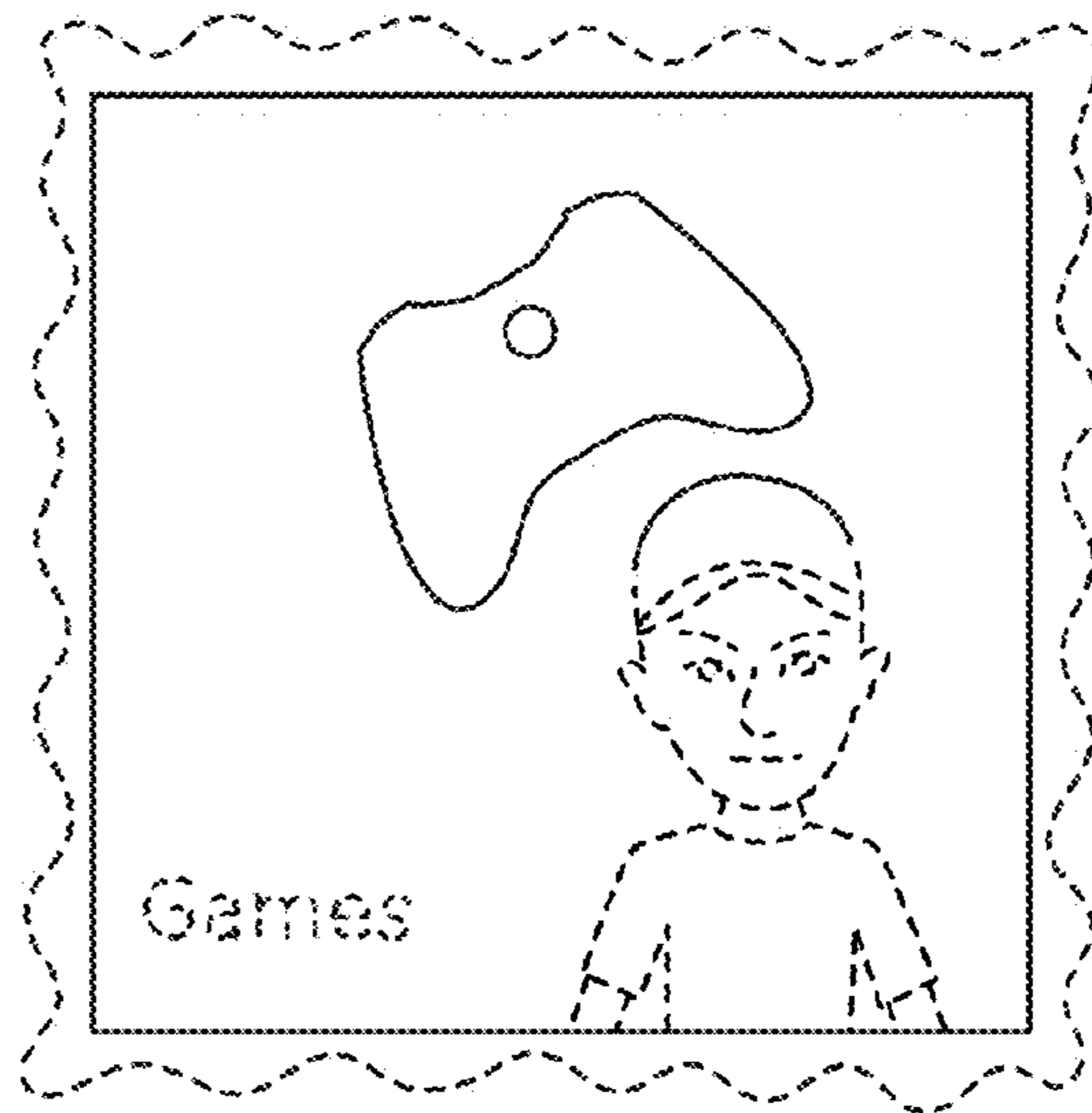

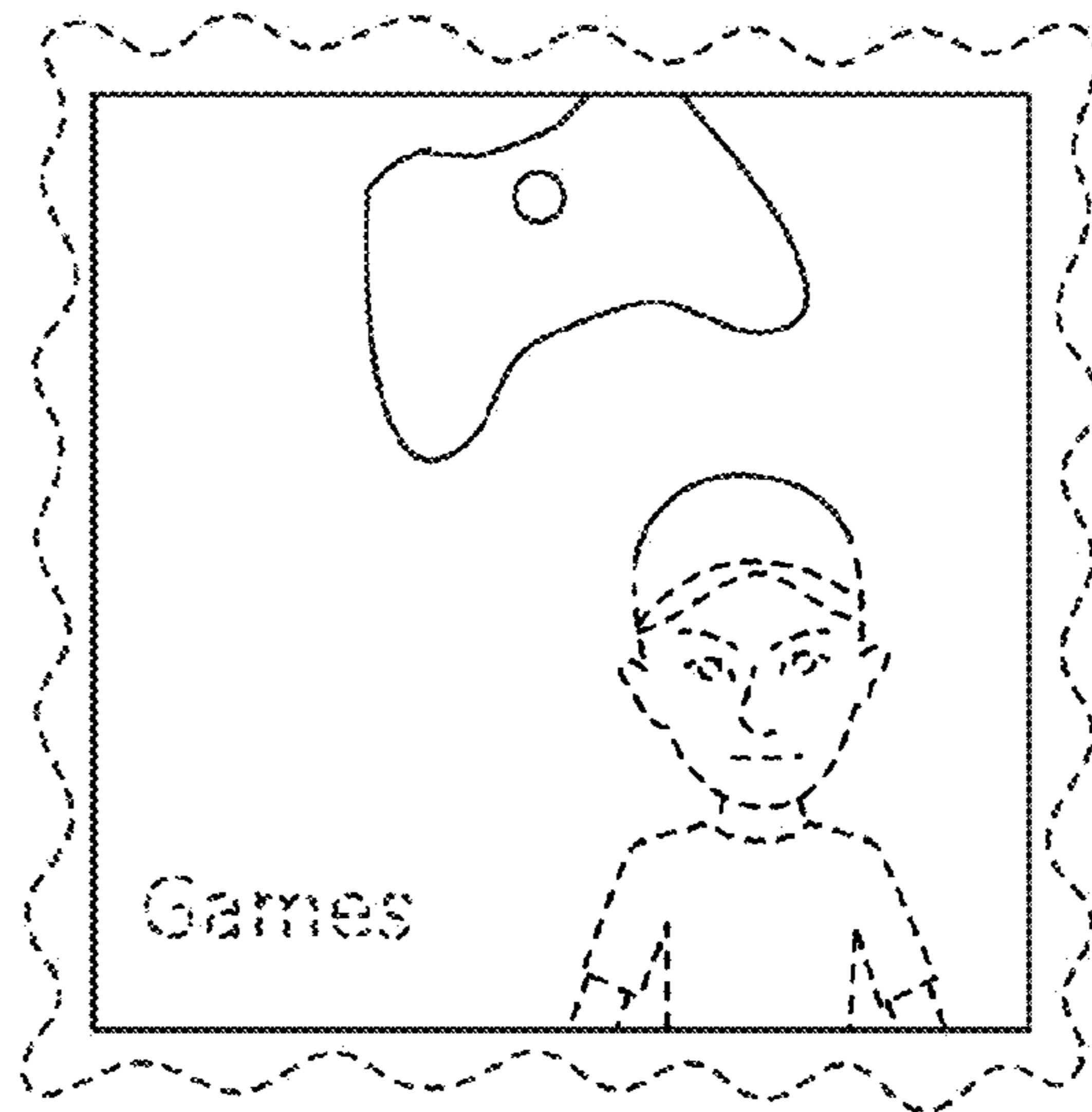

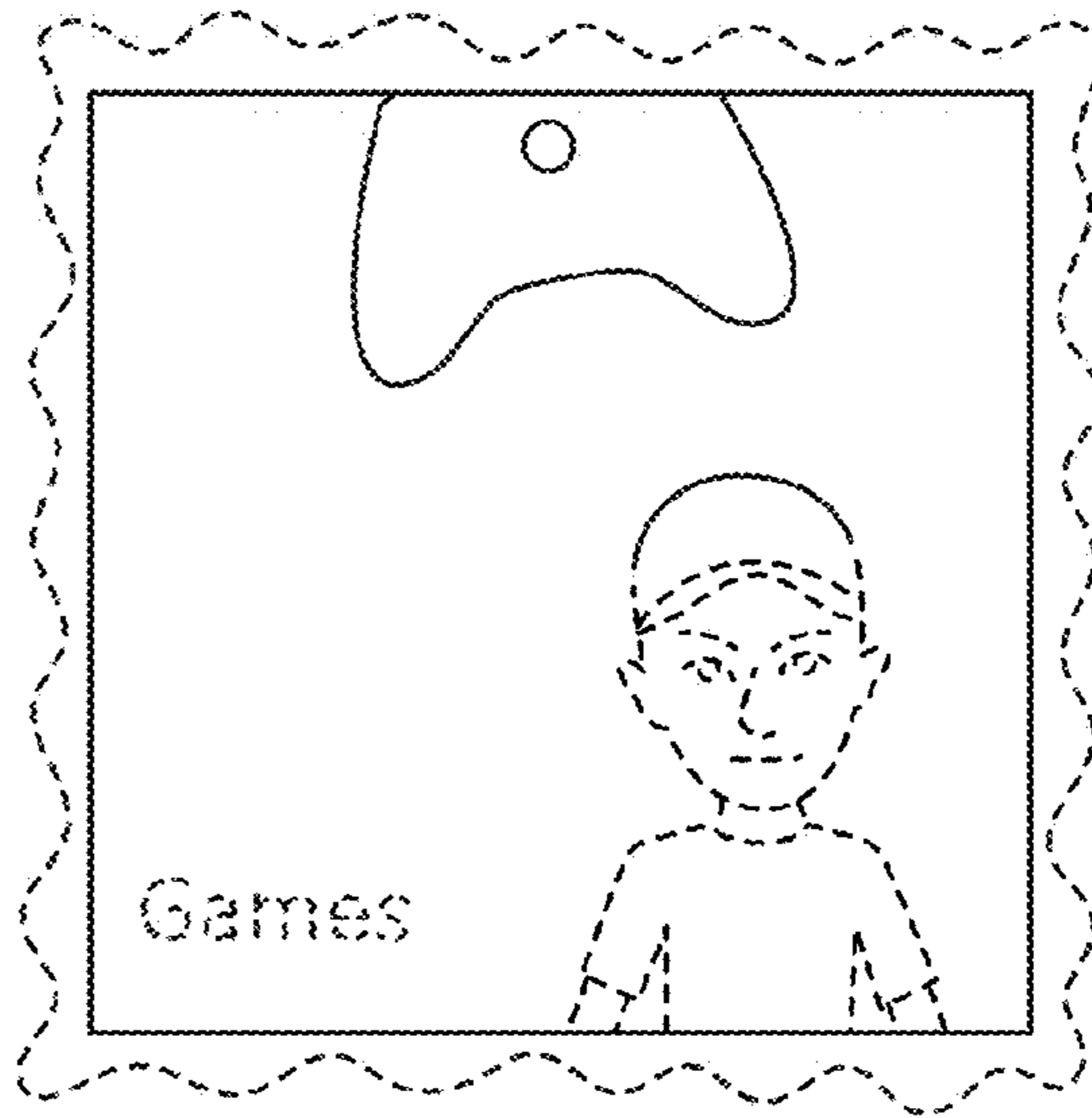

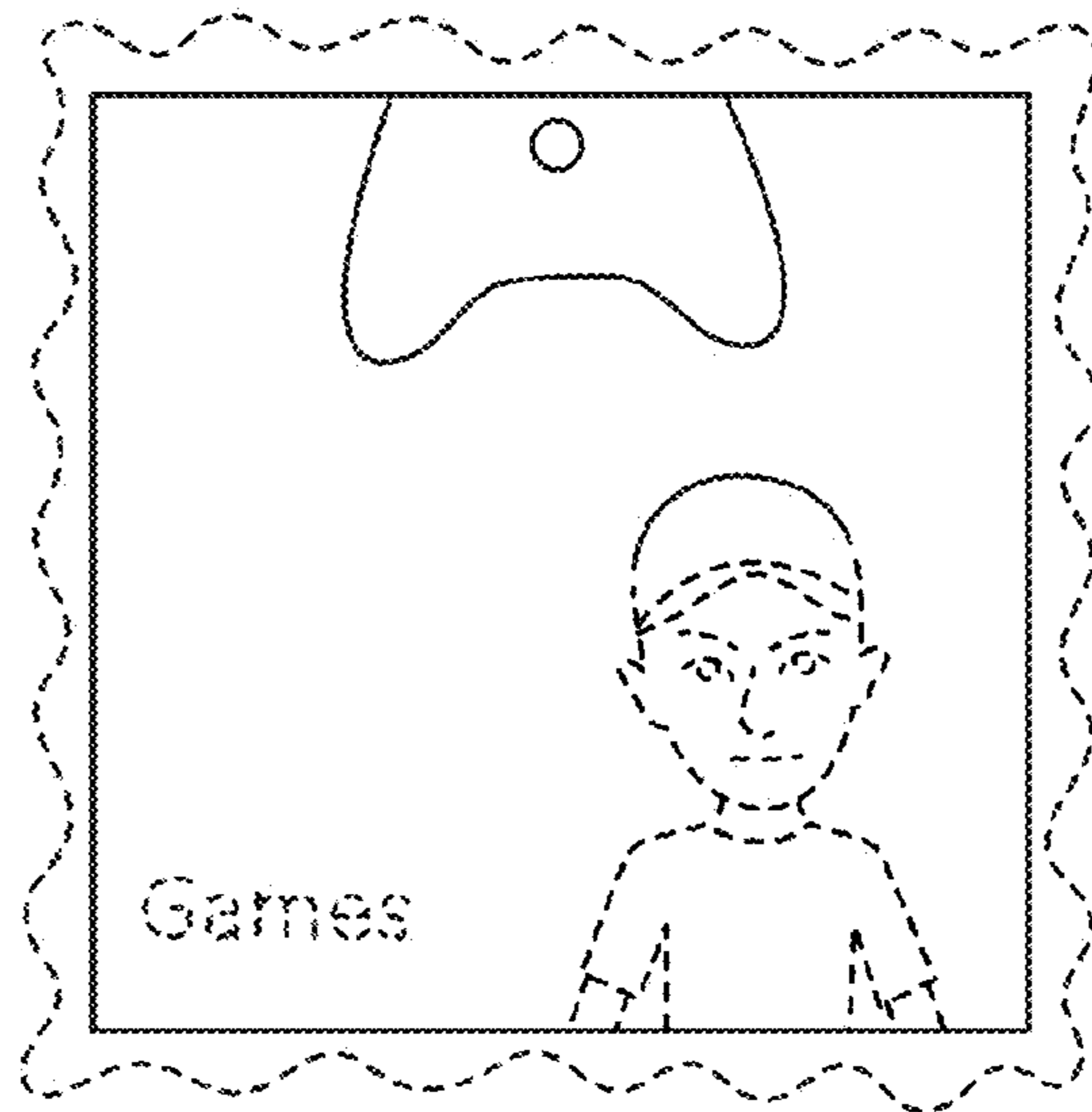

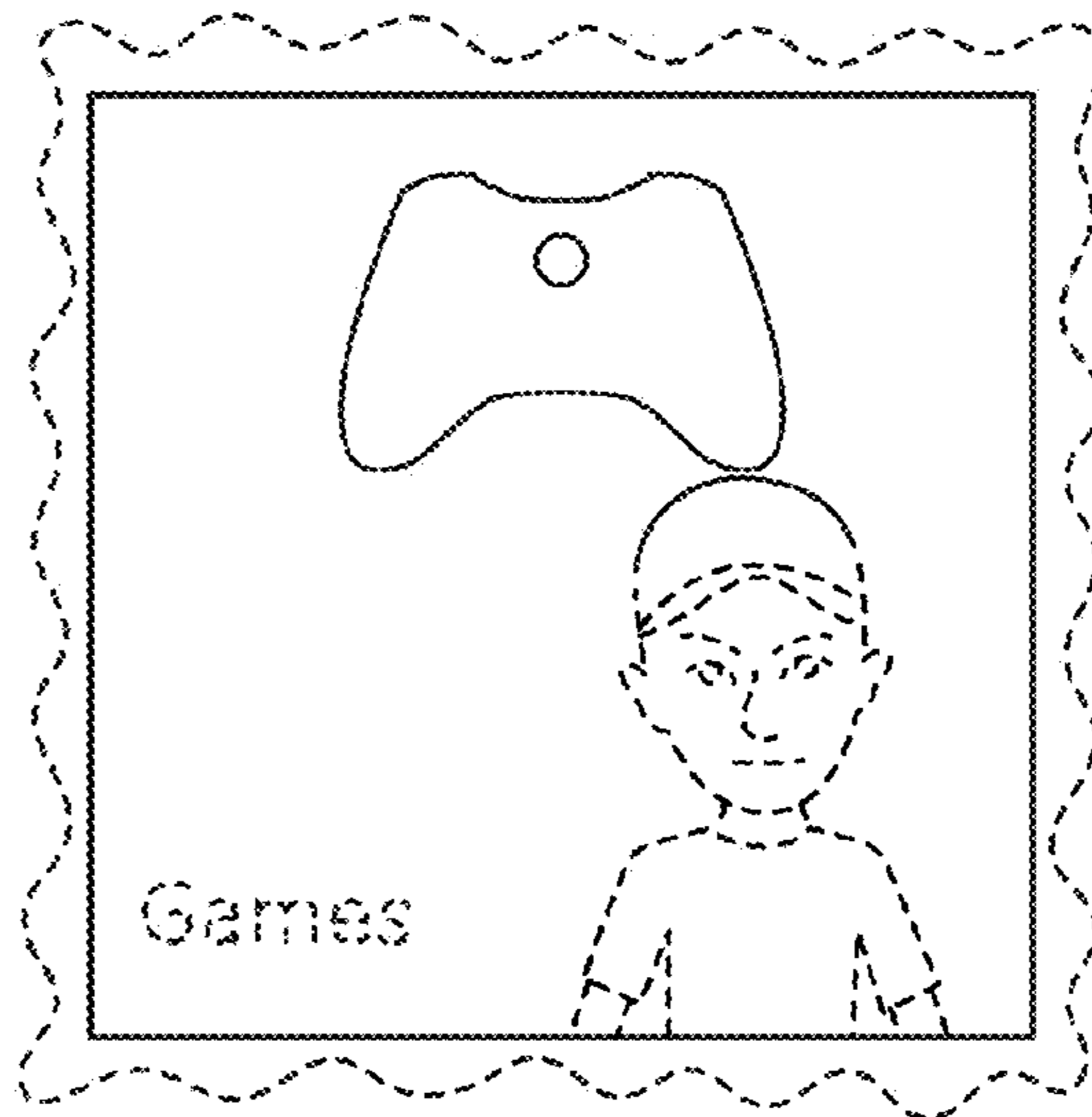

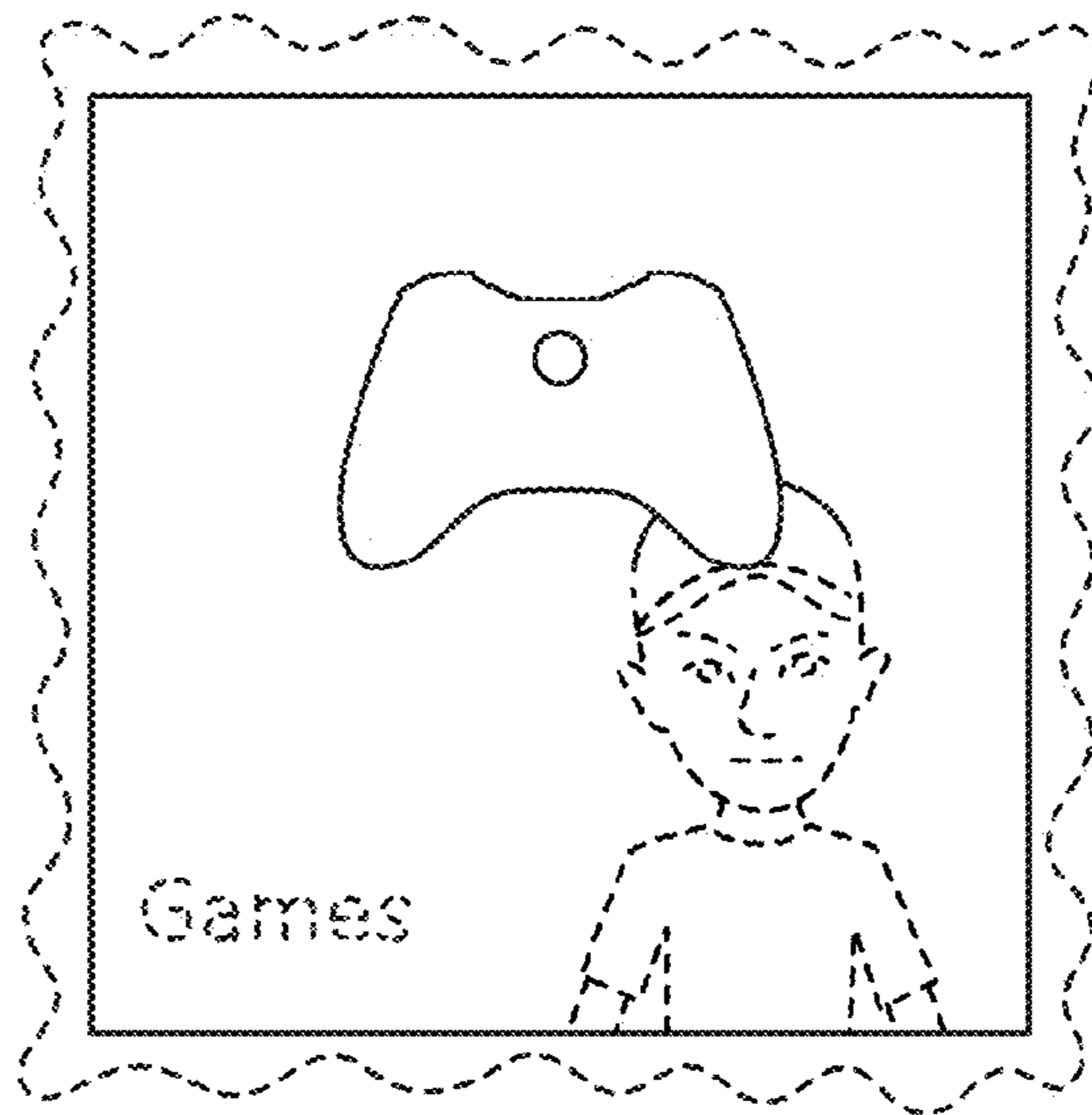

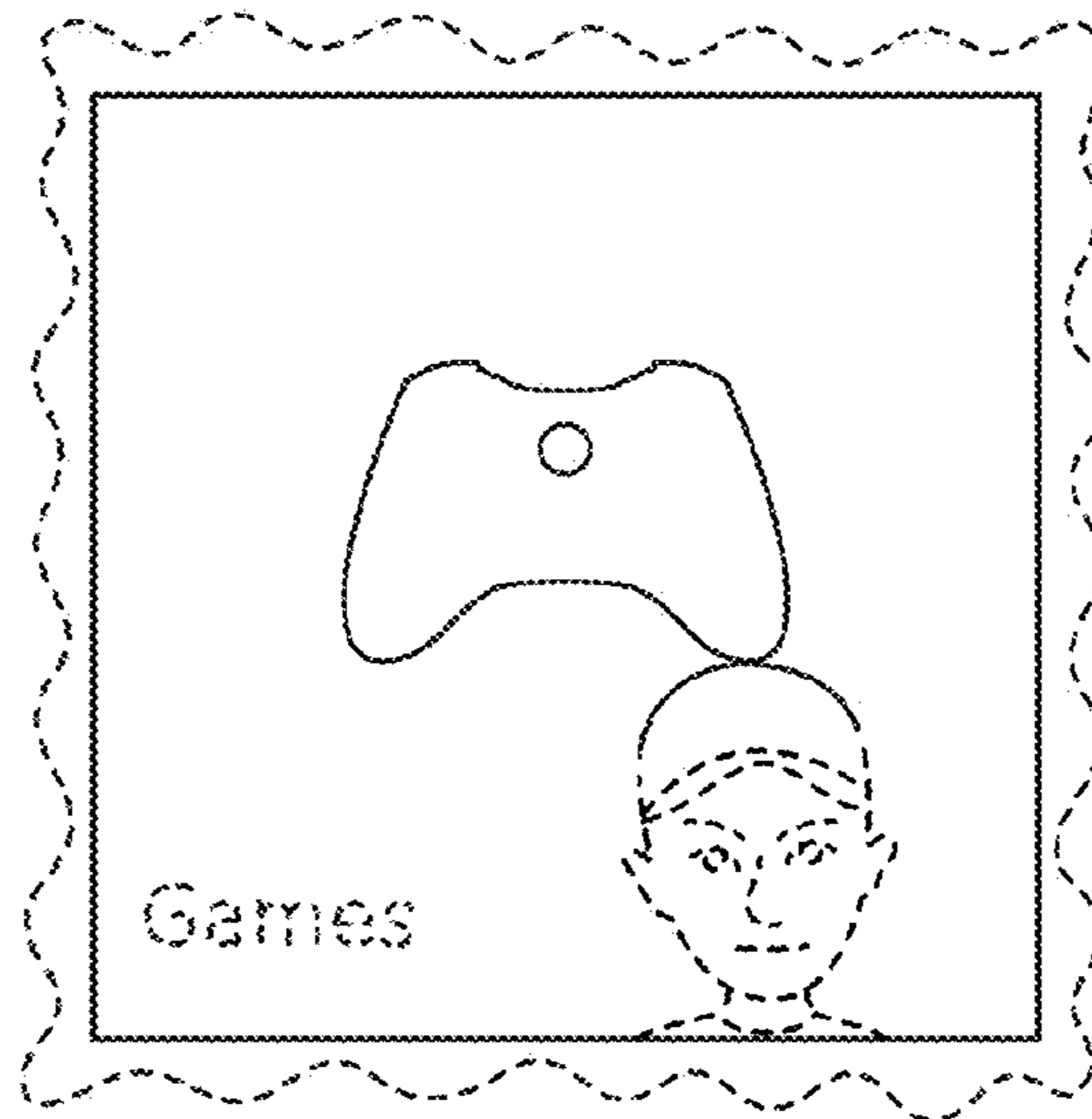

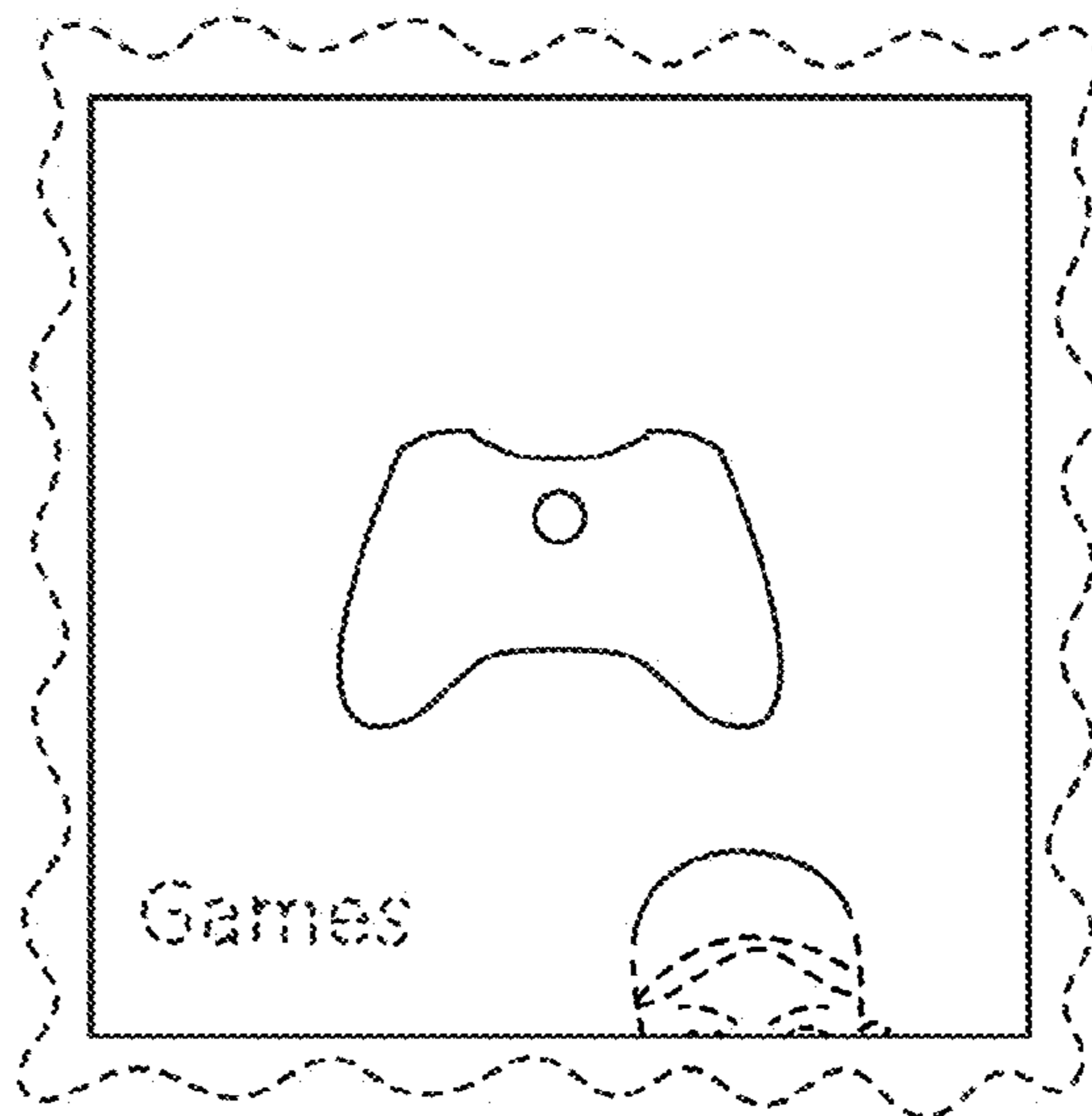

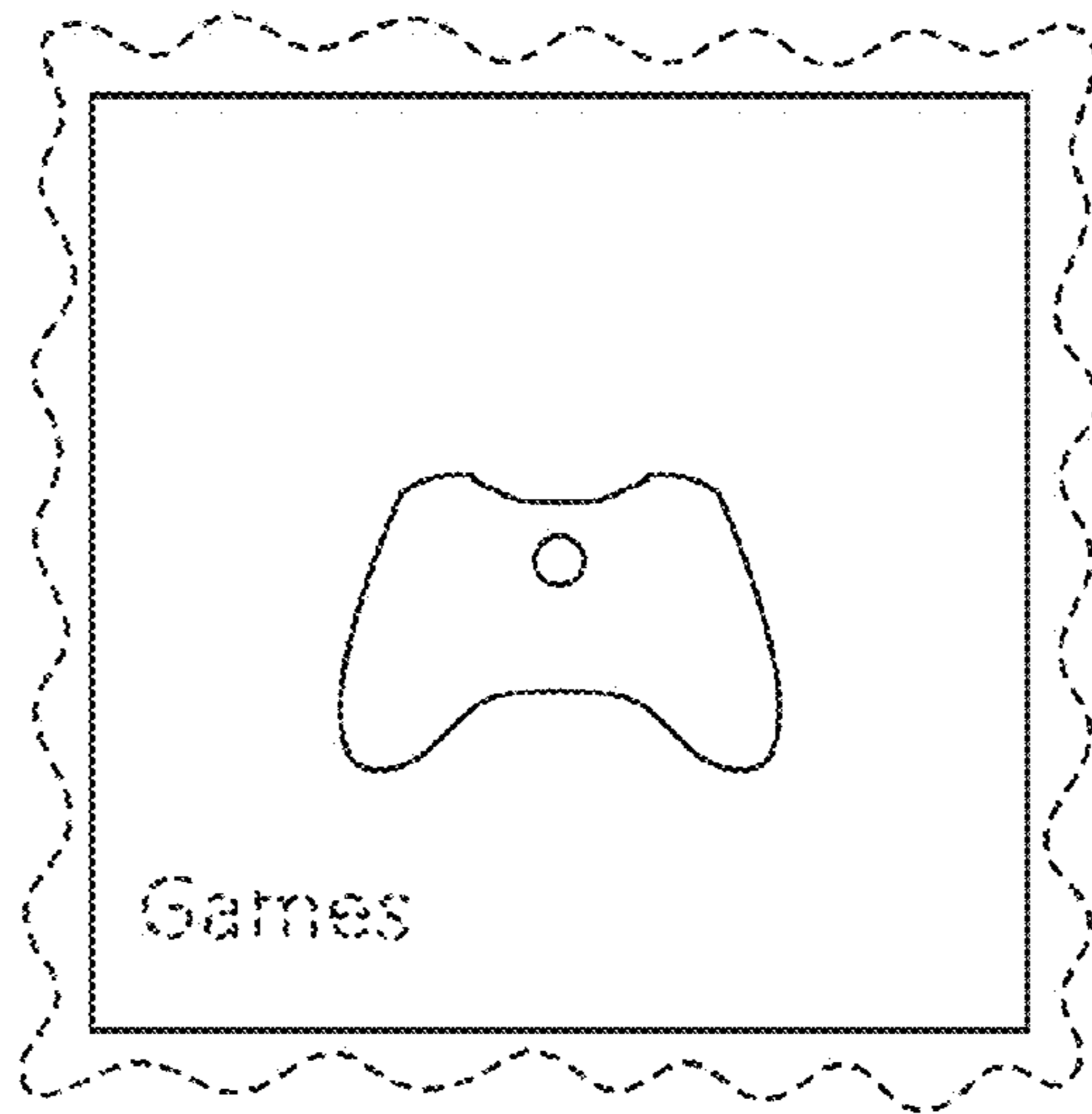

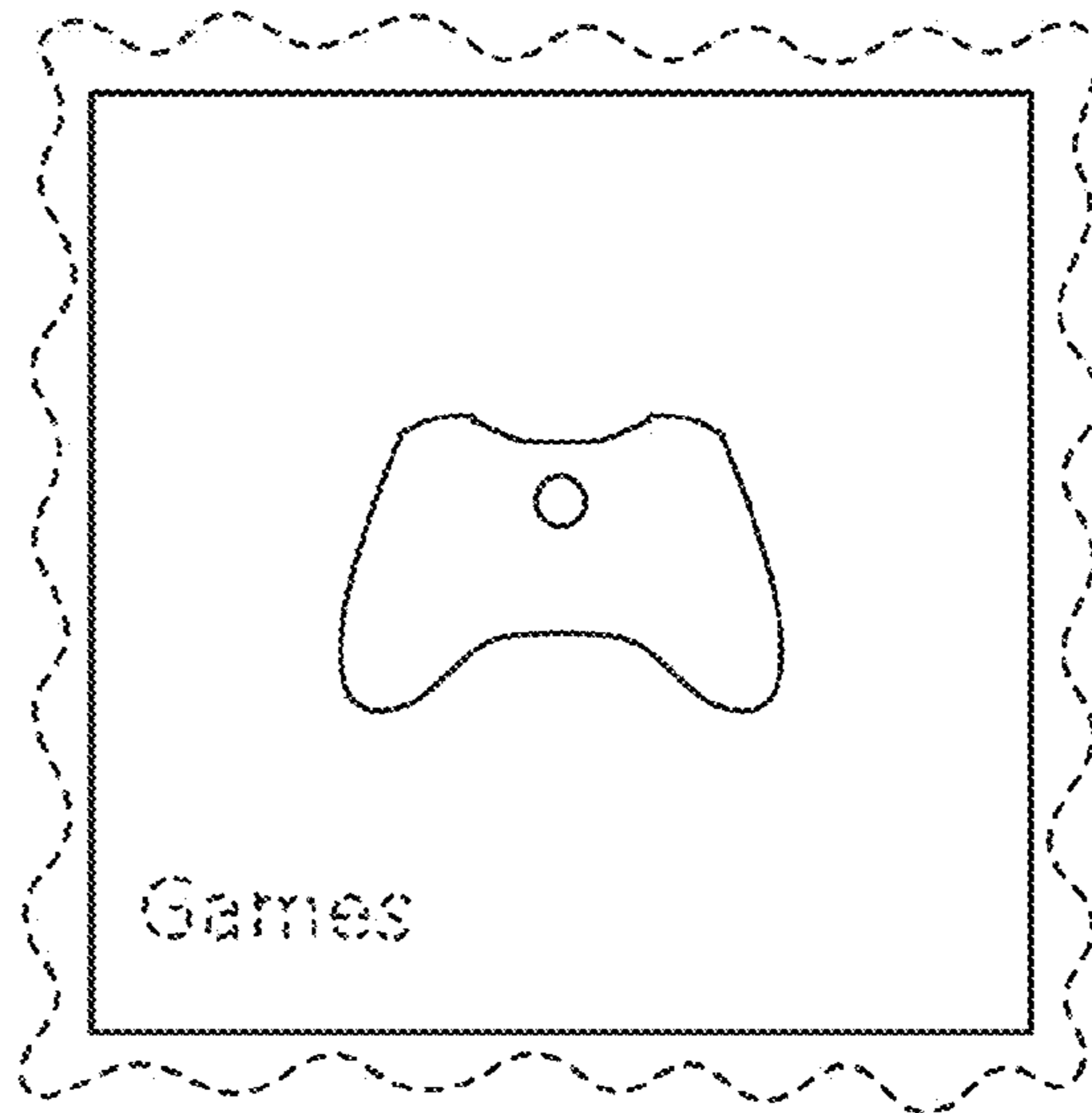

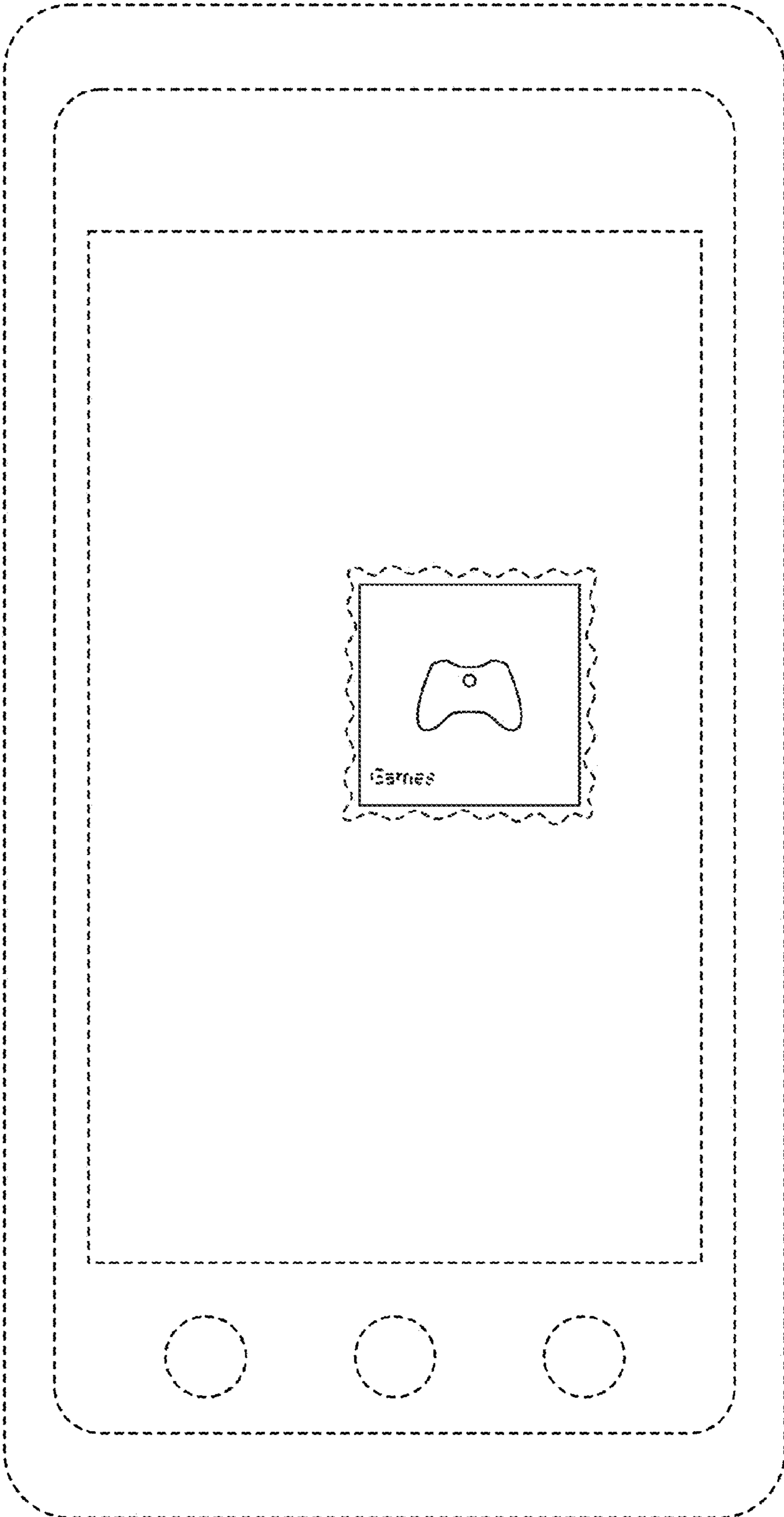

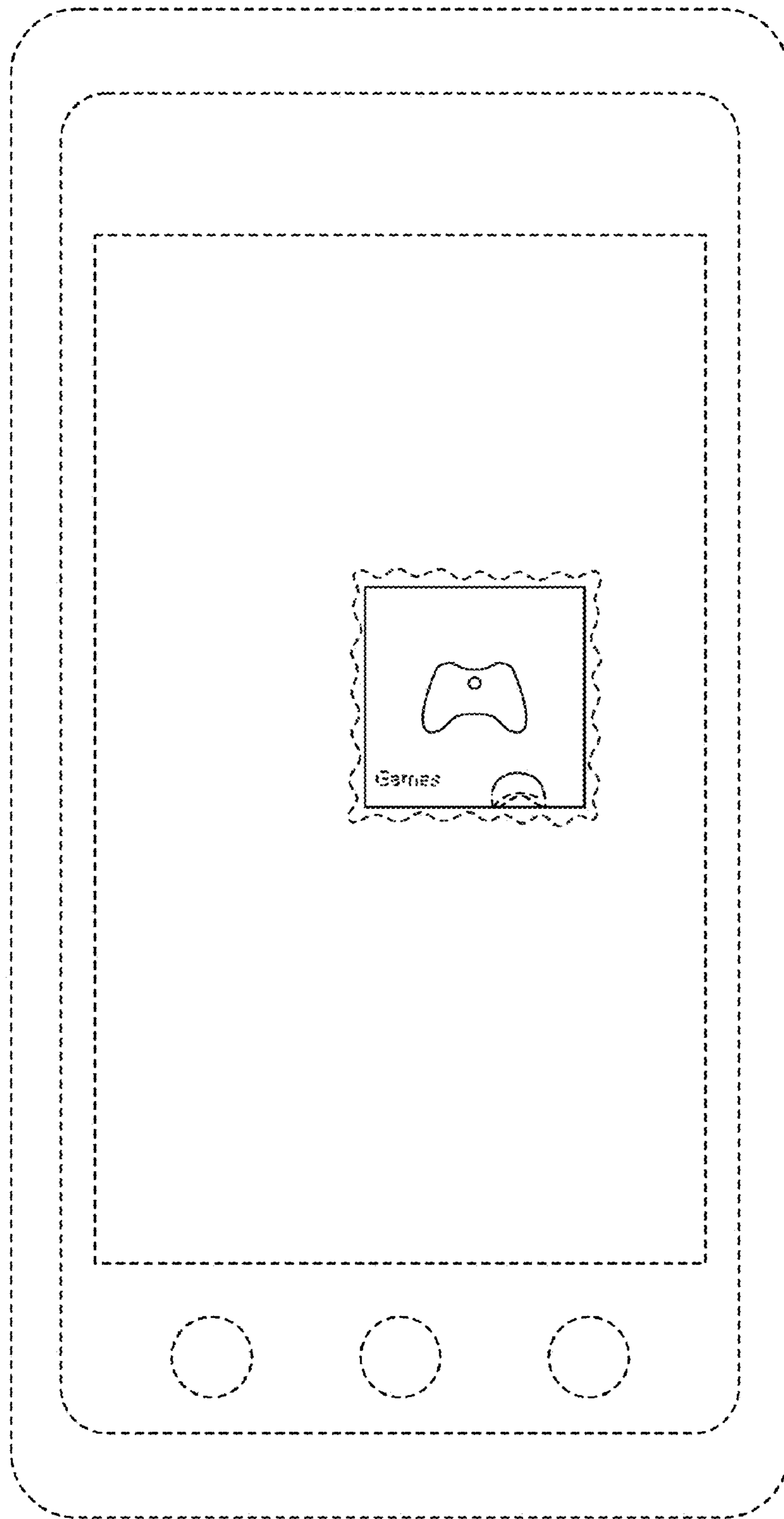

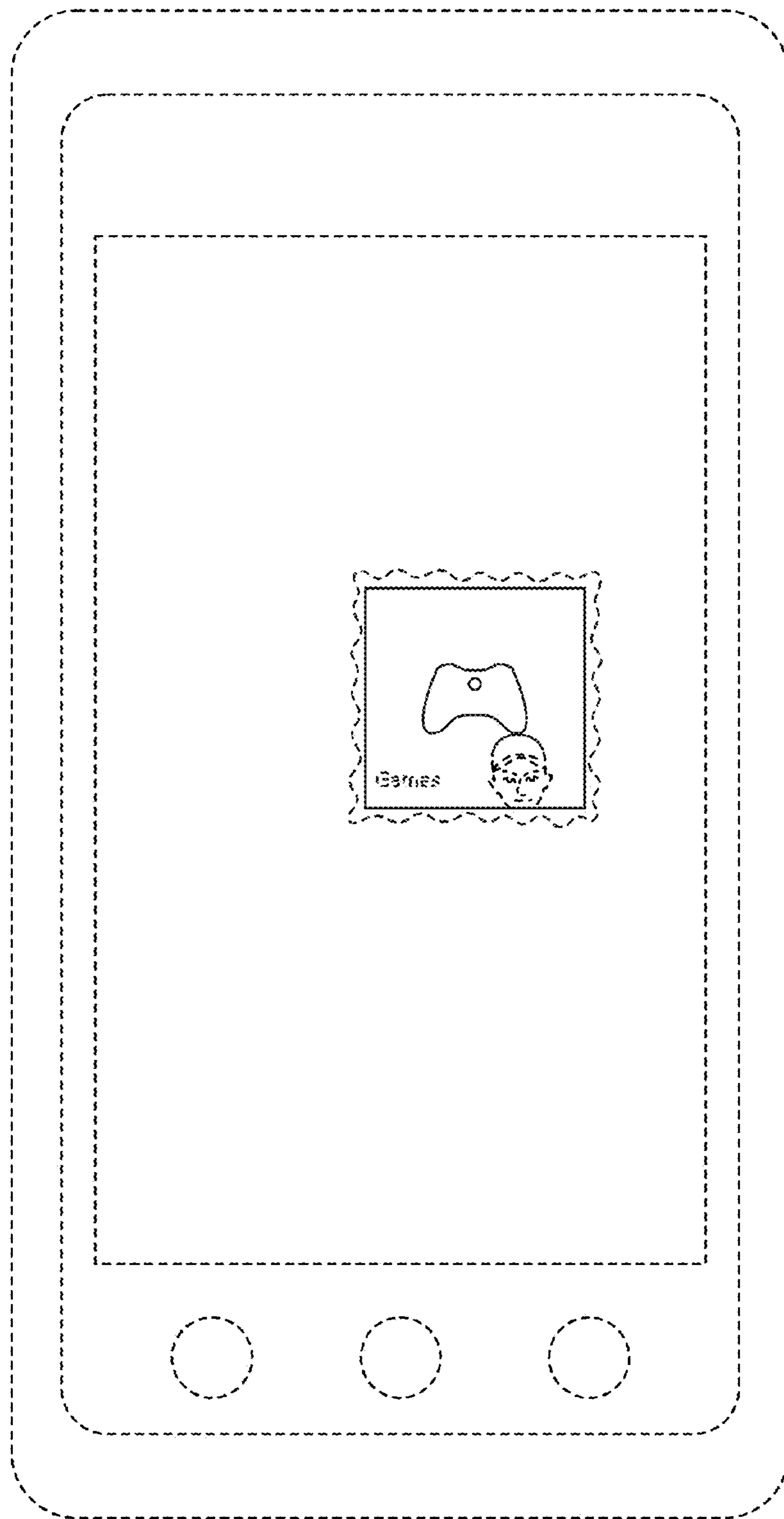

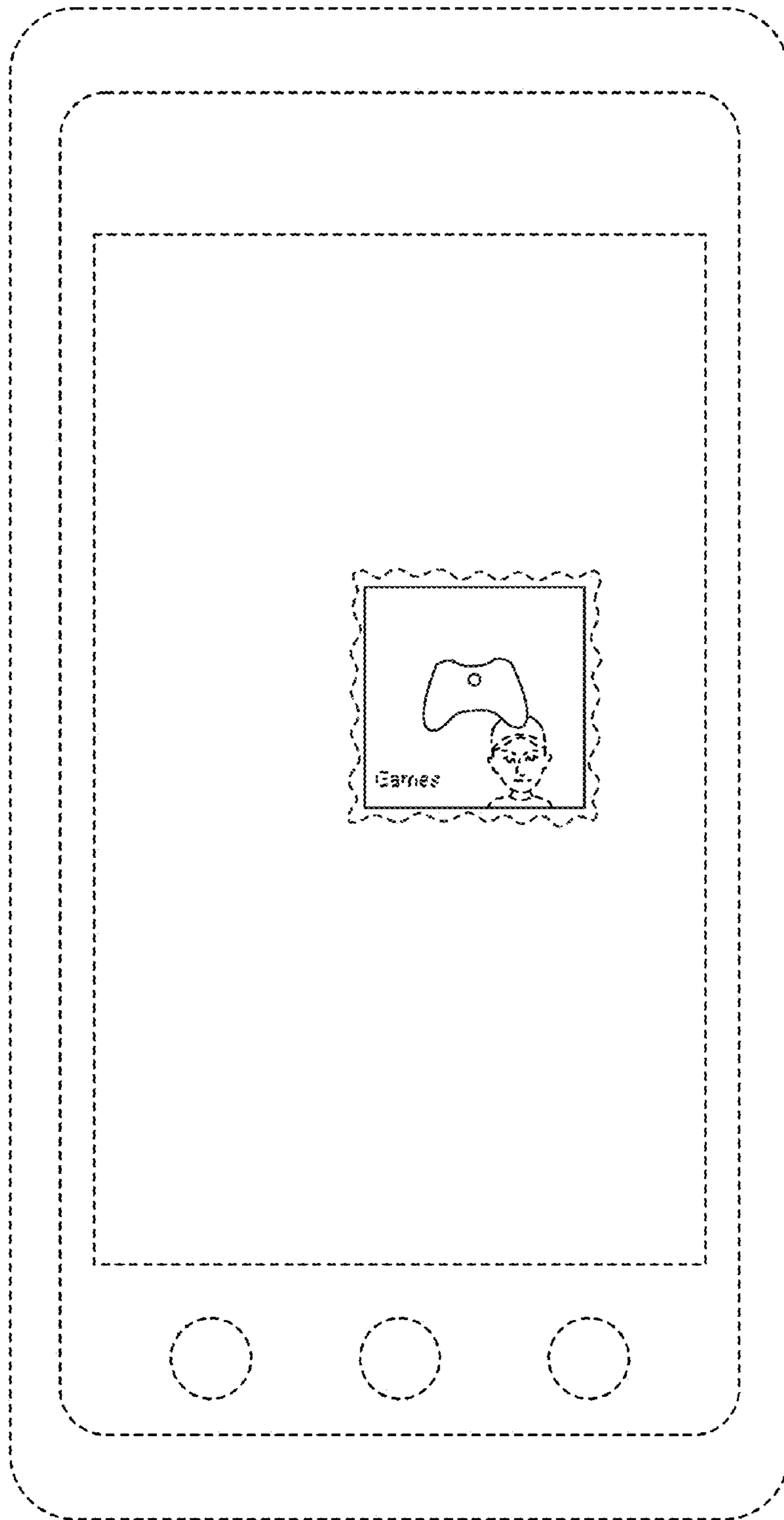

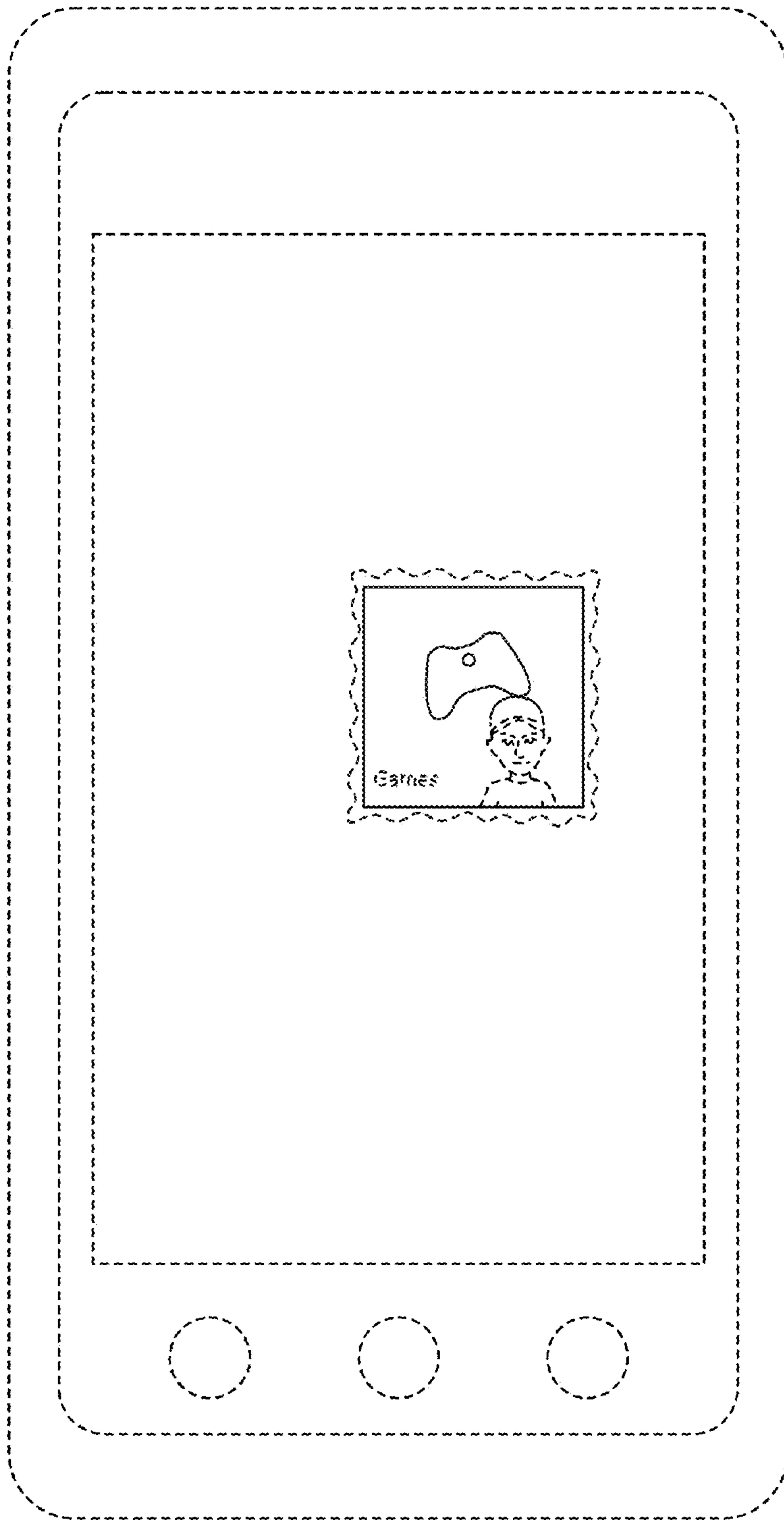

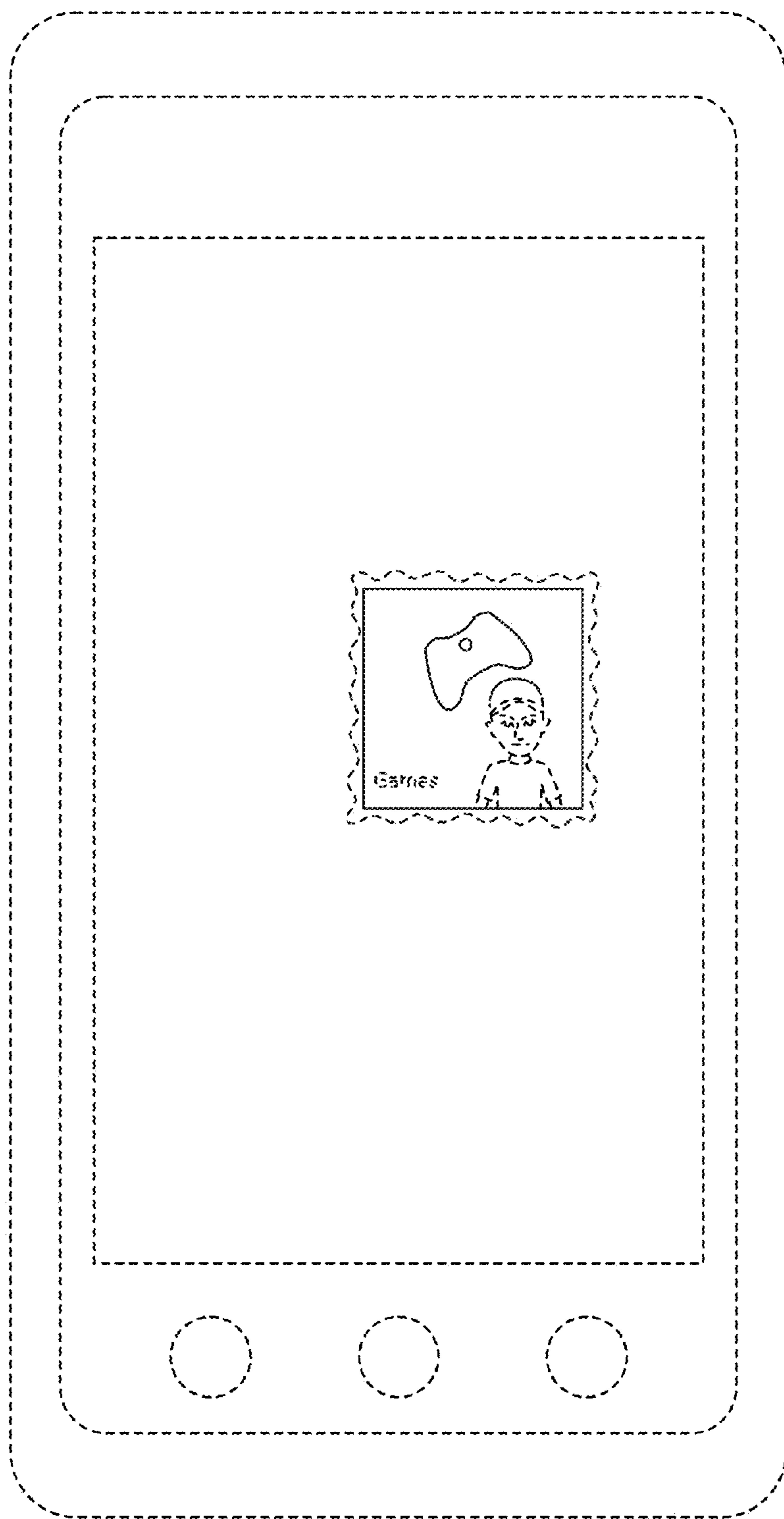

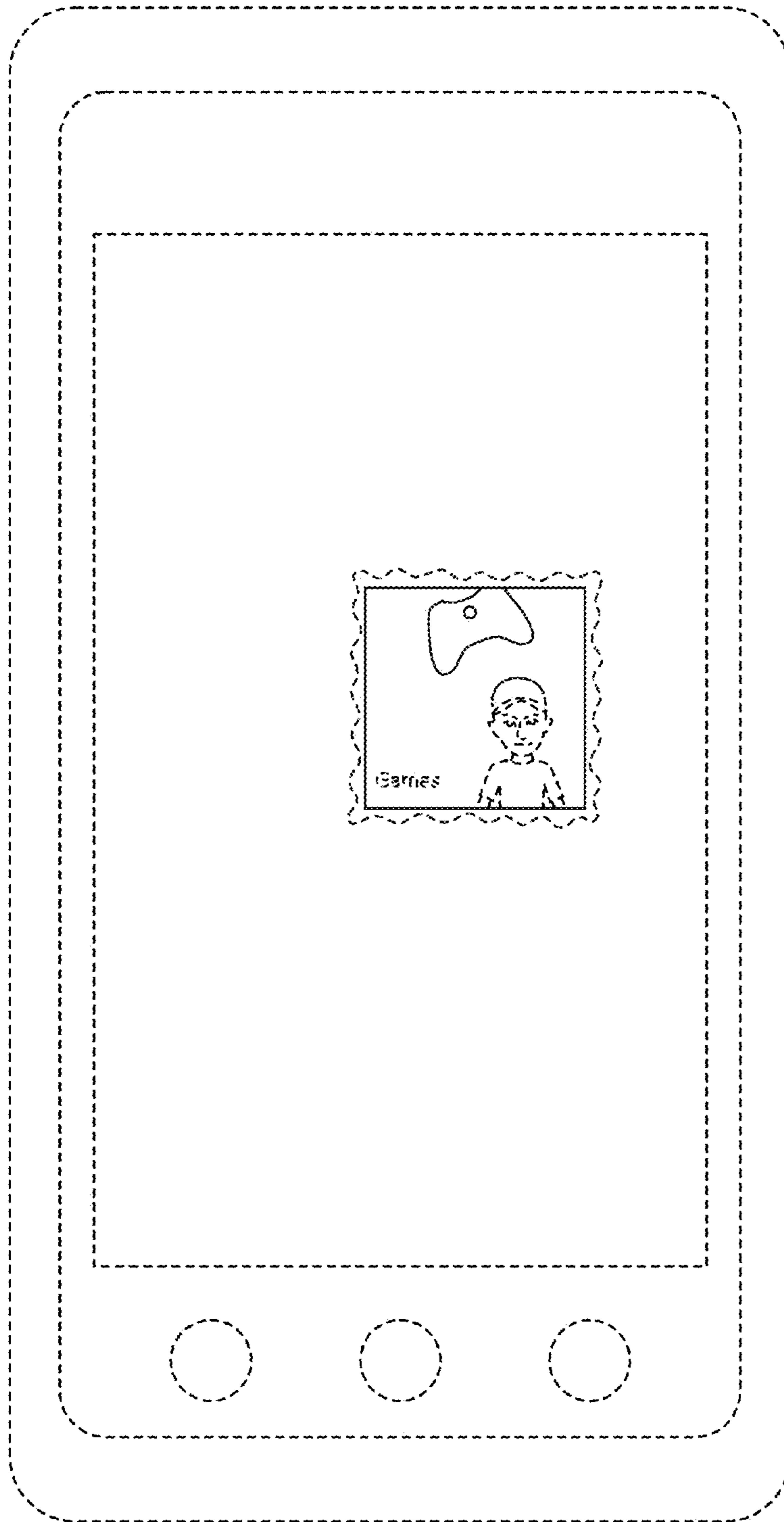

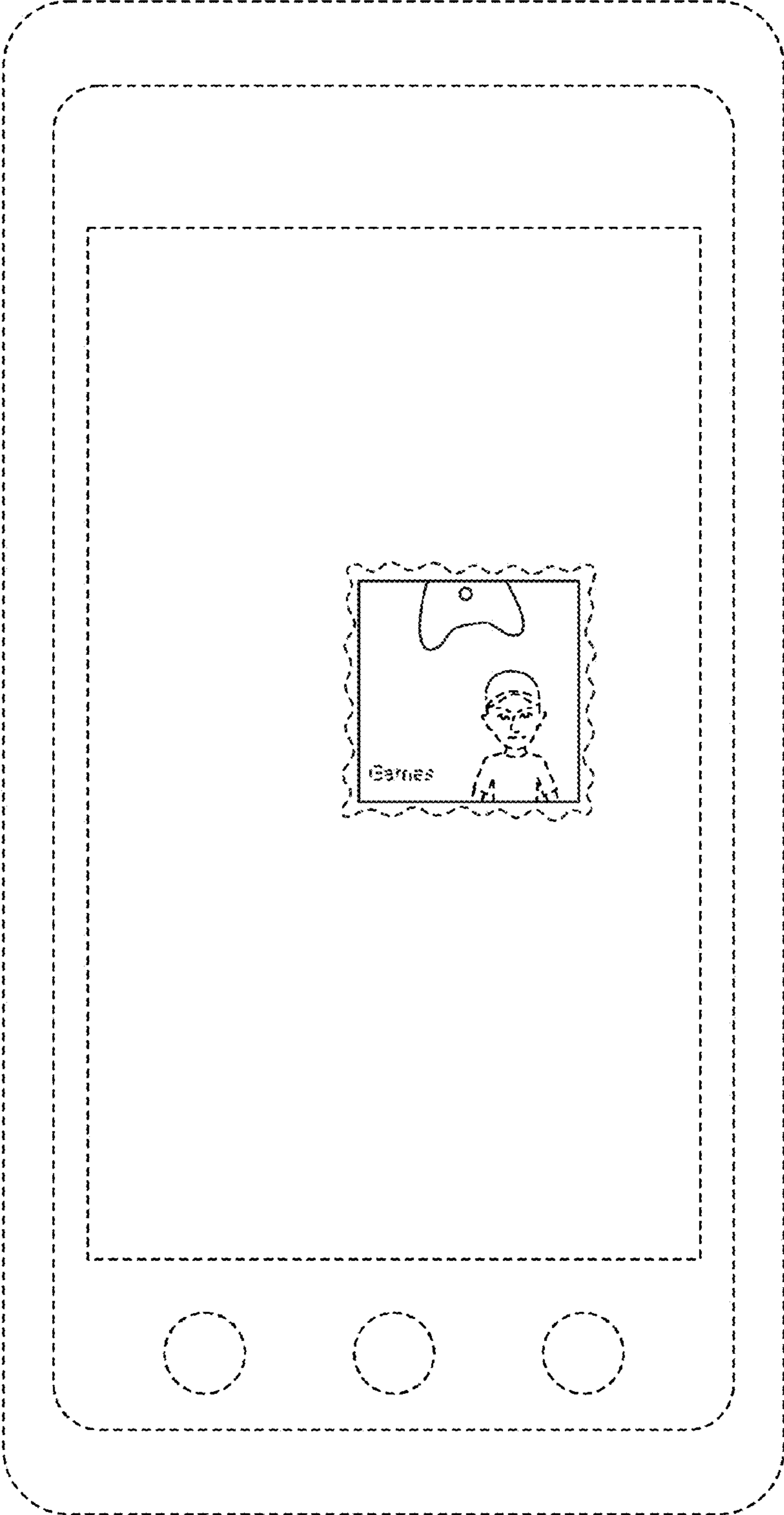

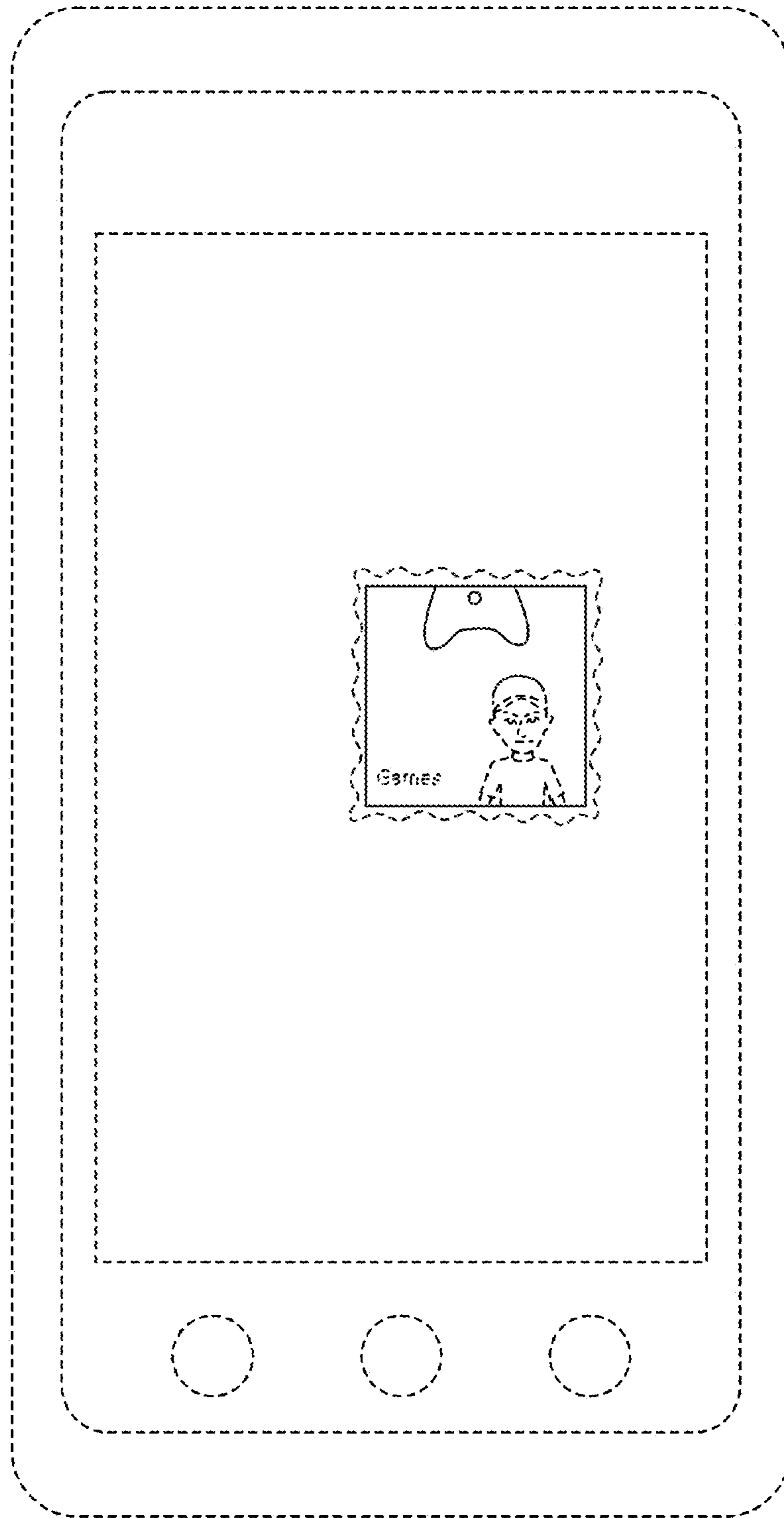

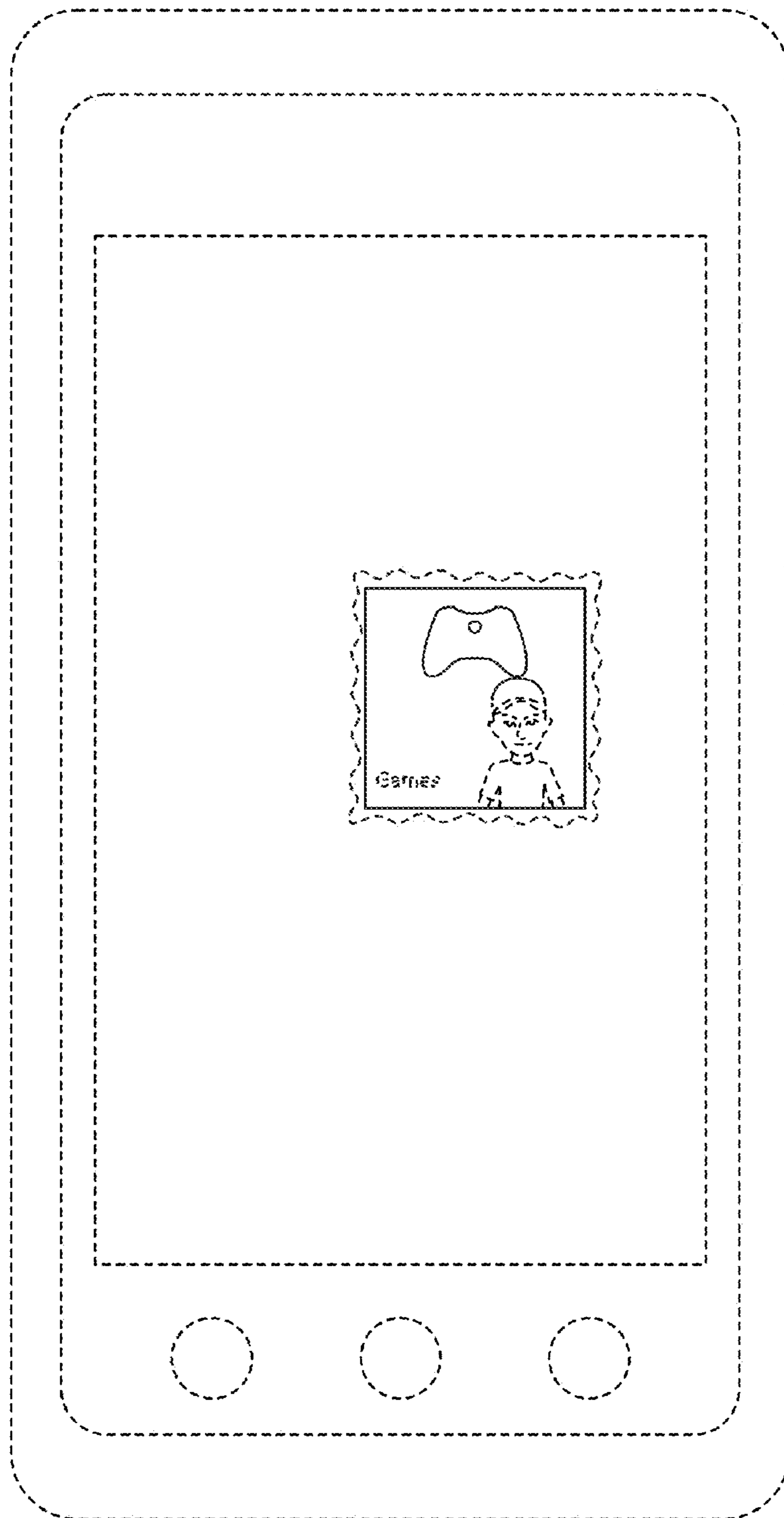

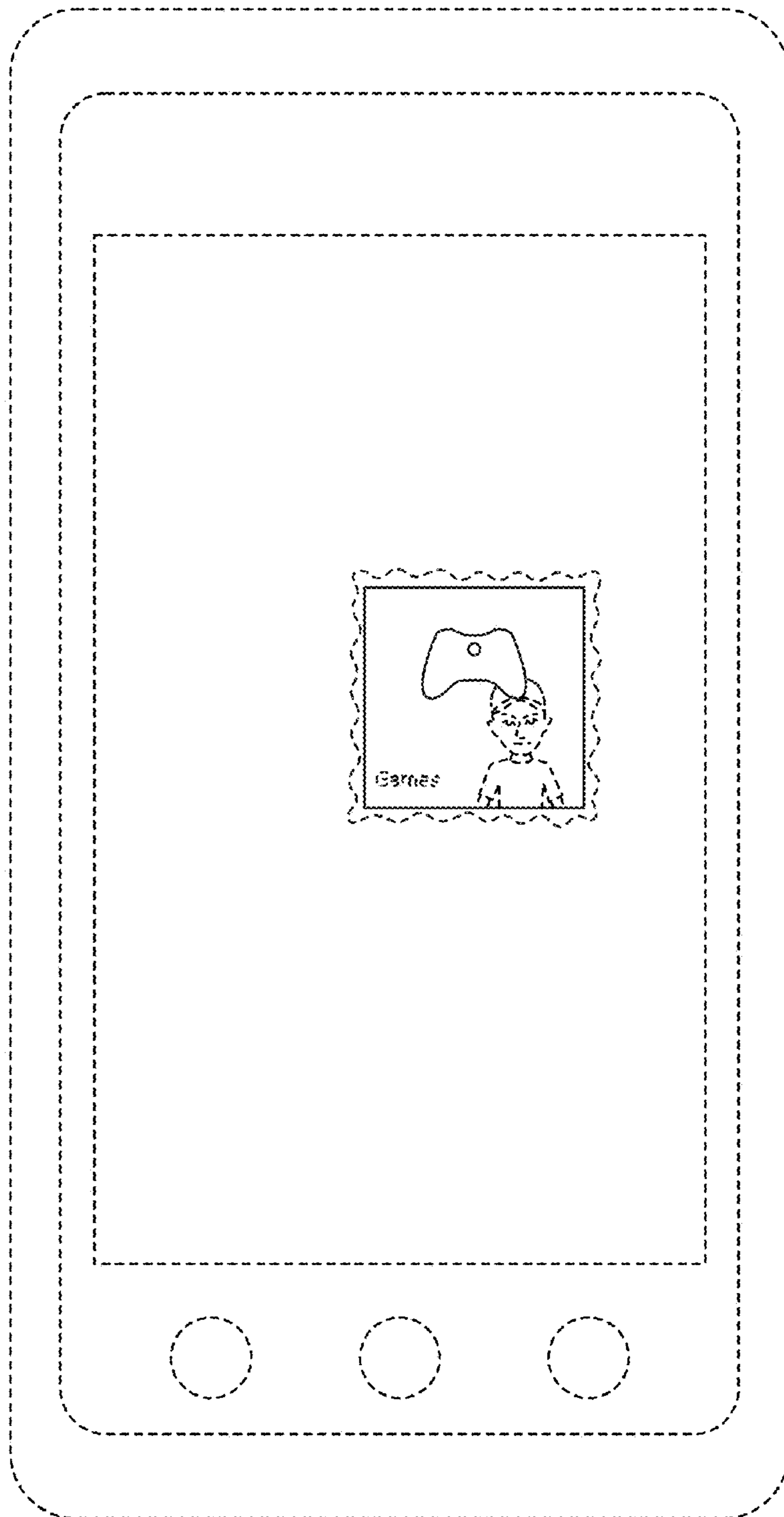

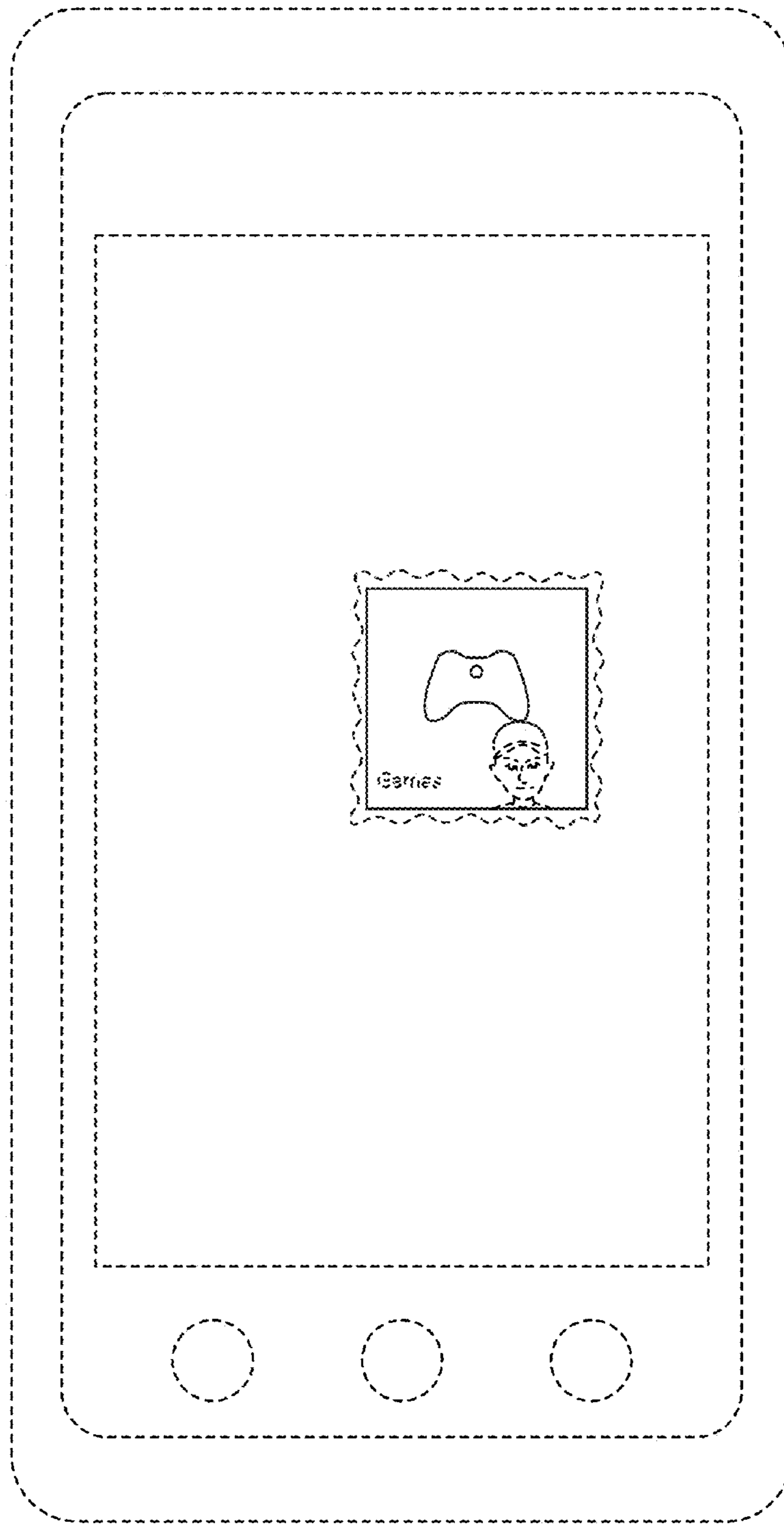

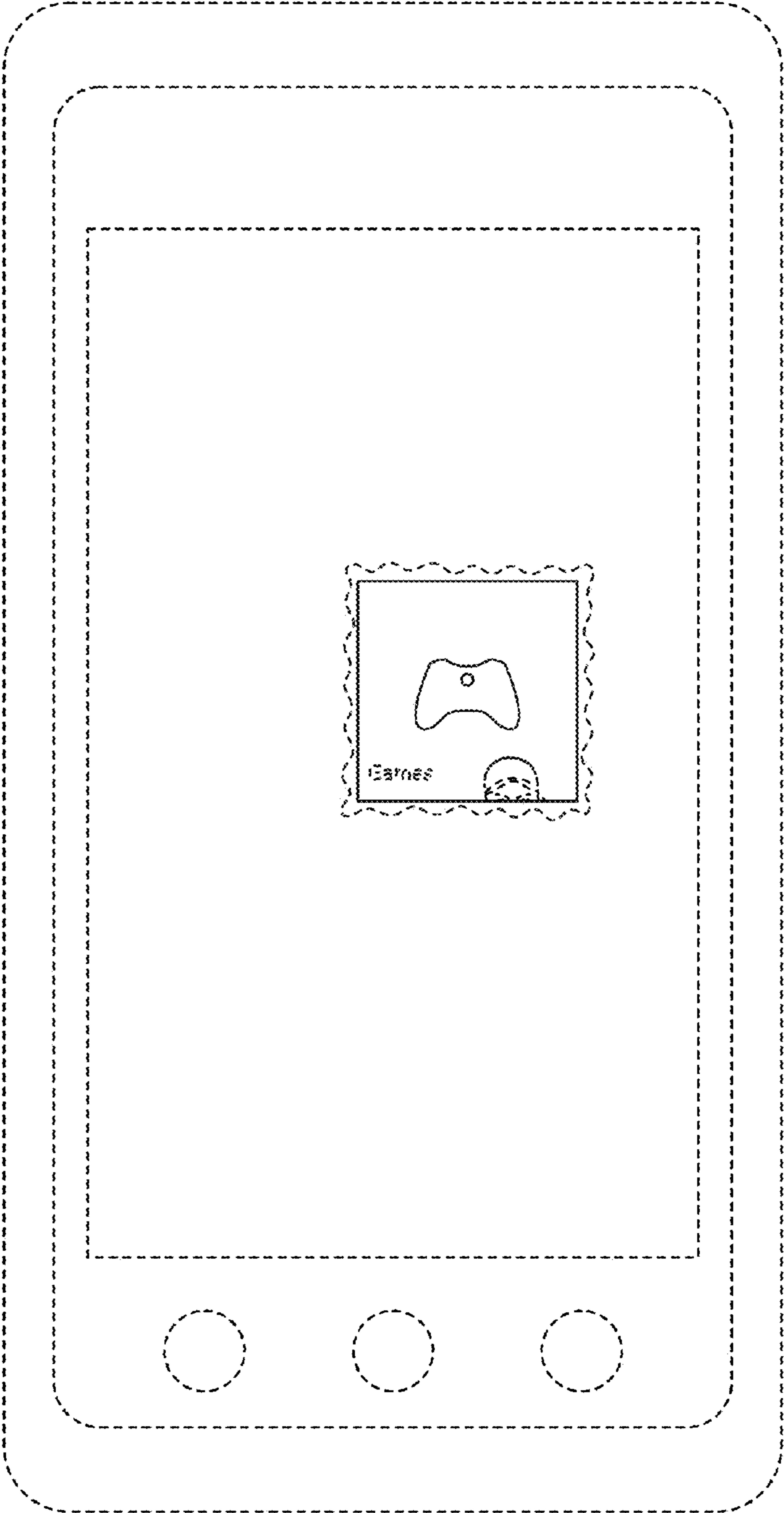

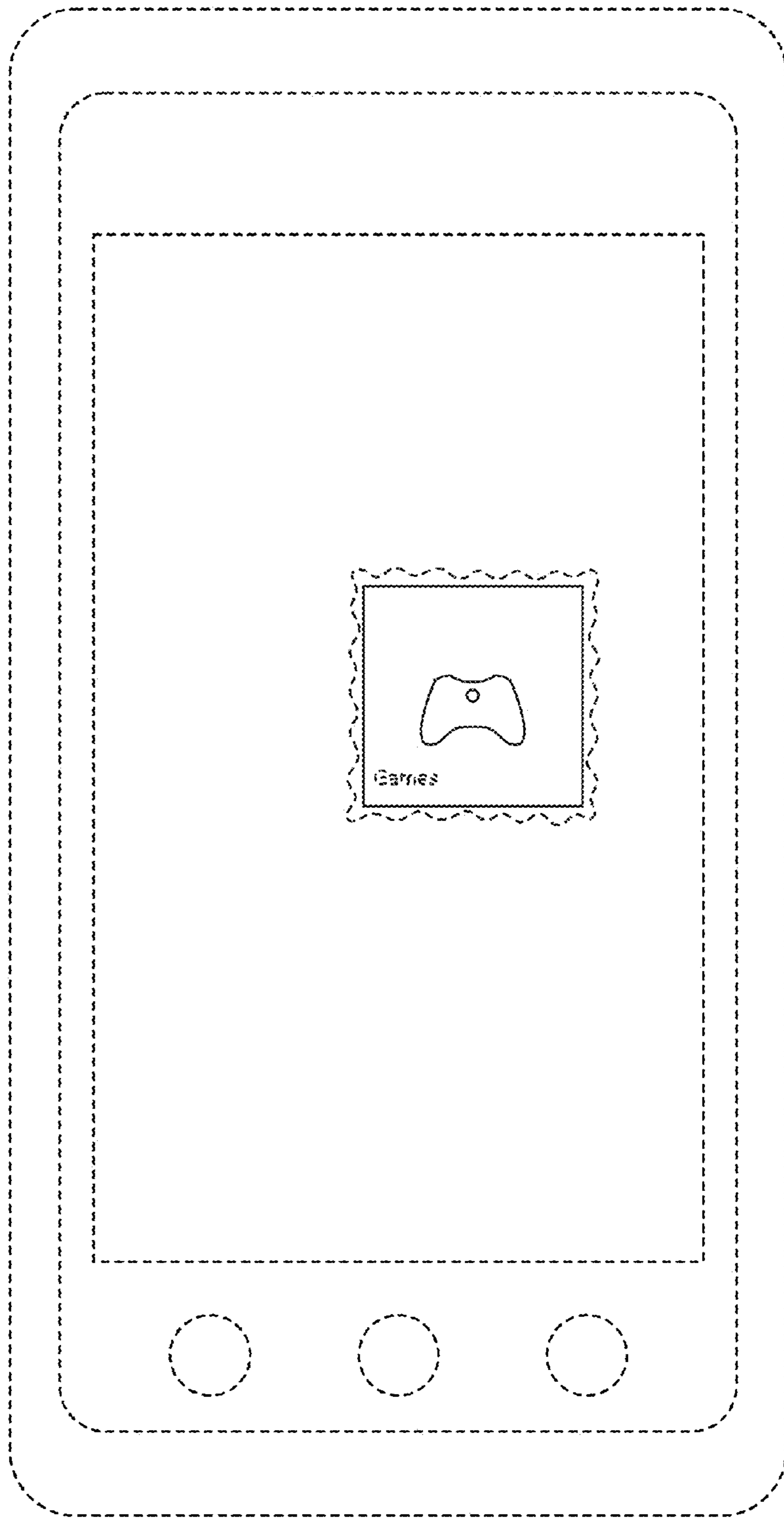

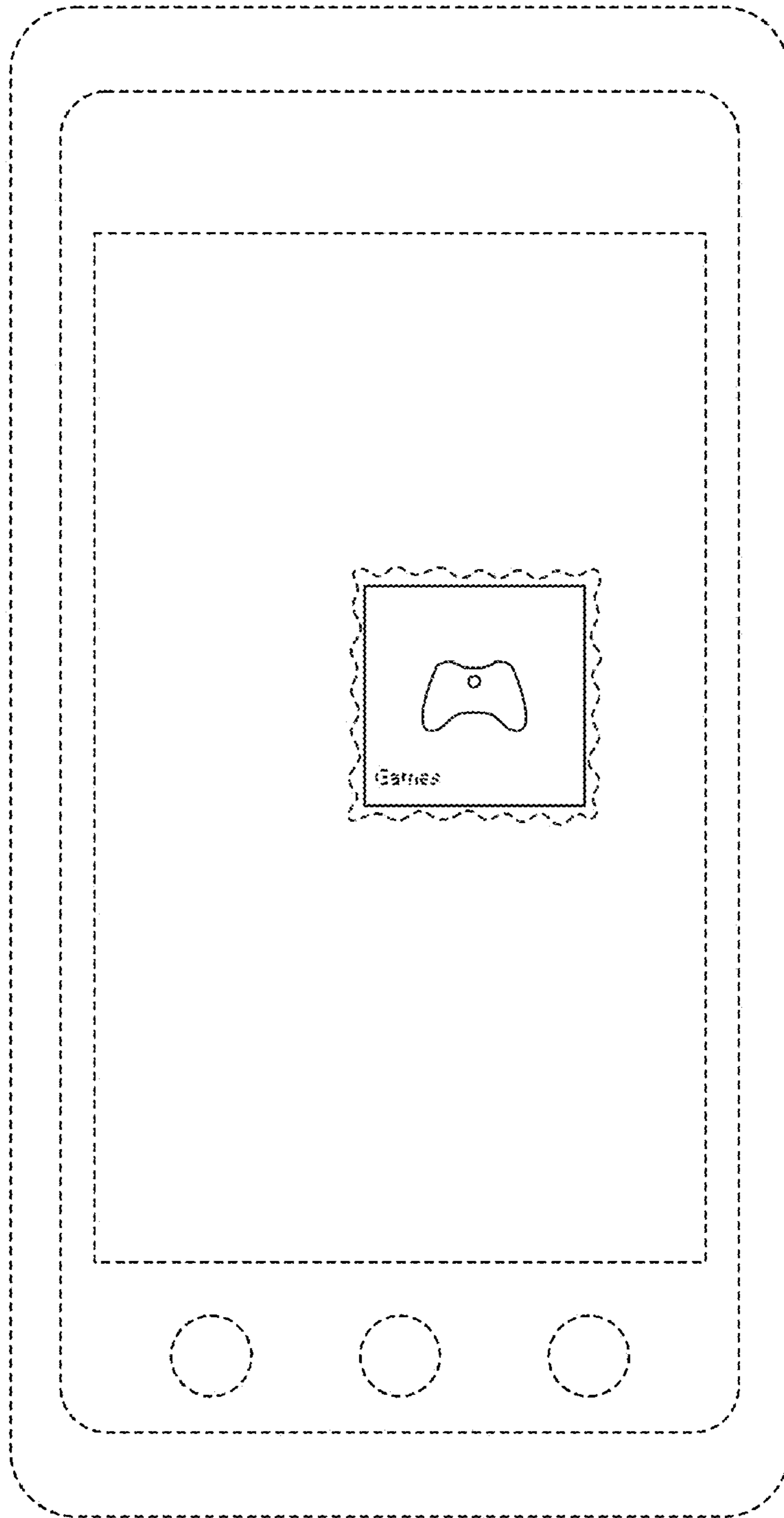
