(57) **CLAIM**

The ornamental design for a vertical semi-ovular eyeglass lens with shallow horizontal semi-ovular aperture, as shown and described.

DESCRIPTION

FIG. 1 is a front environmental view of the vertical semi-ovular eyeglass lens with shallow horizontal semi-ovular aperture showing my new design;

FIG. 2 is a front perspective view of the vertical semi-ovular eyeglass lens with shallow horizontal semi-ovular aperture;

FIG. 4 is a rear view thereof;

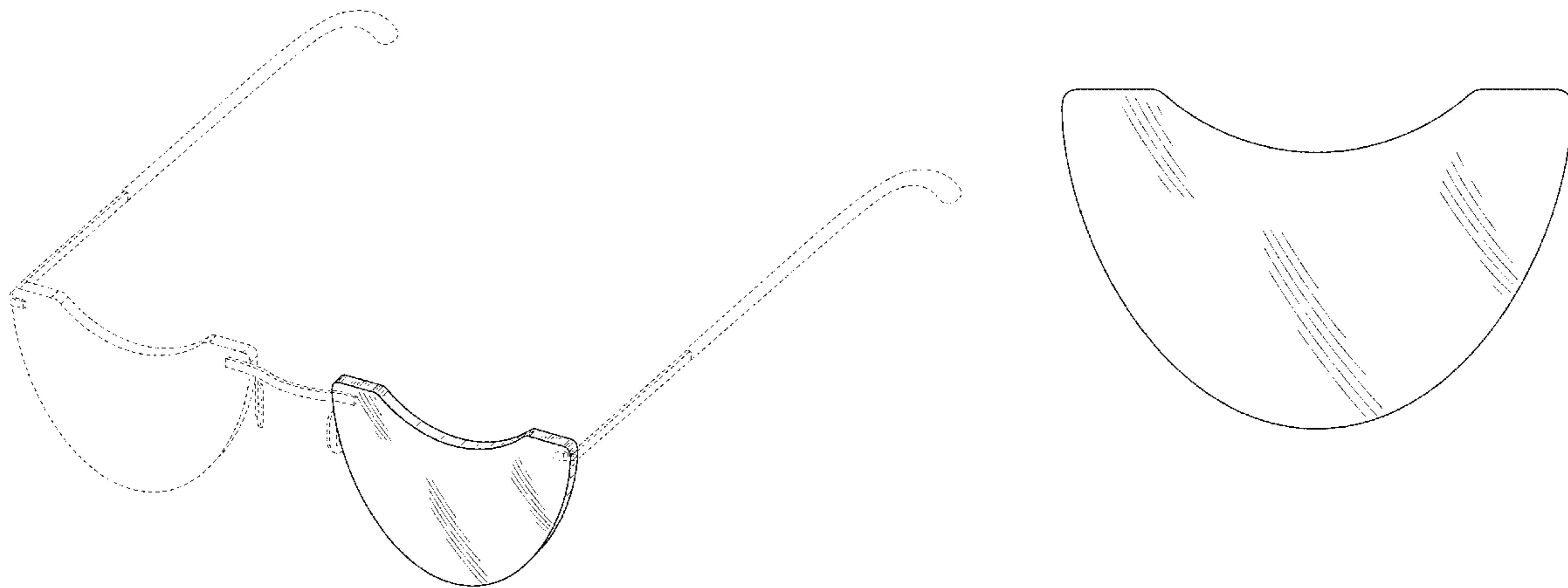
FIG. 5 is a right side view thereof with a left side being a mirror image;

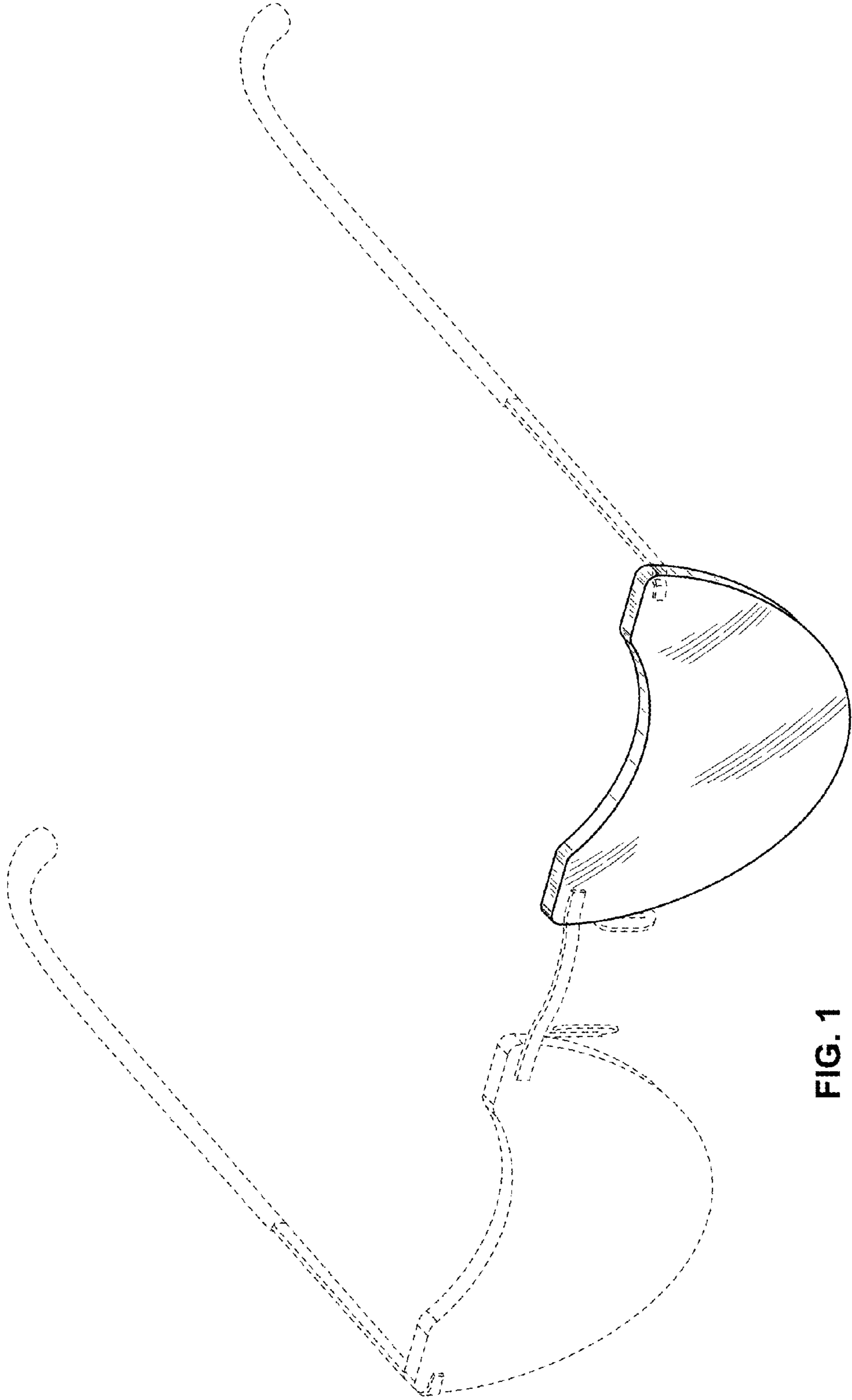

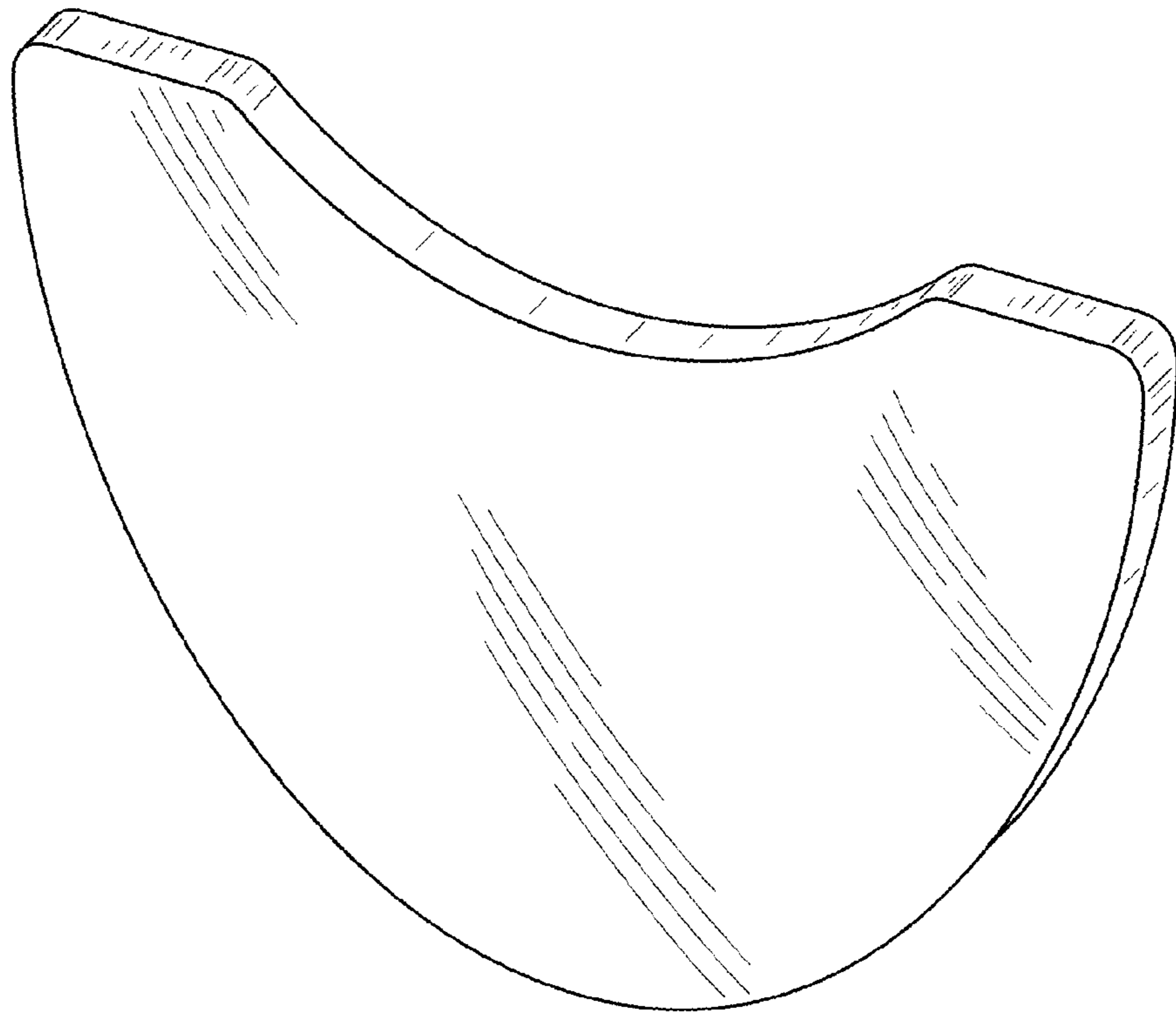

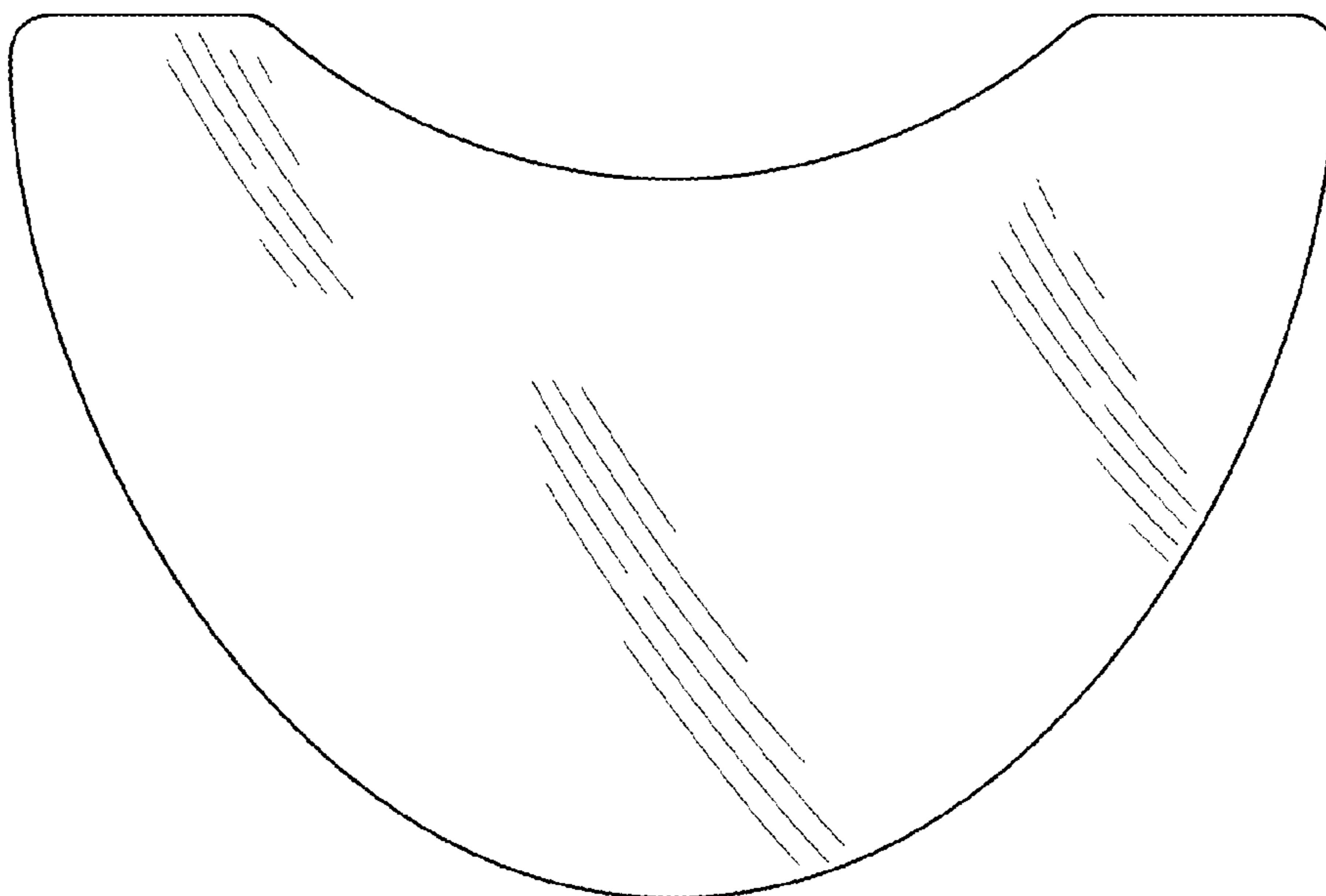

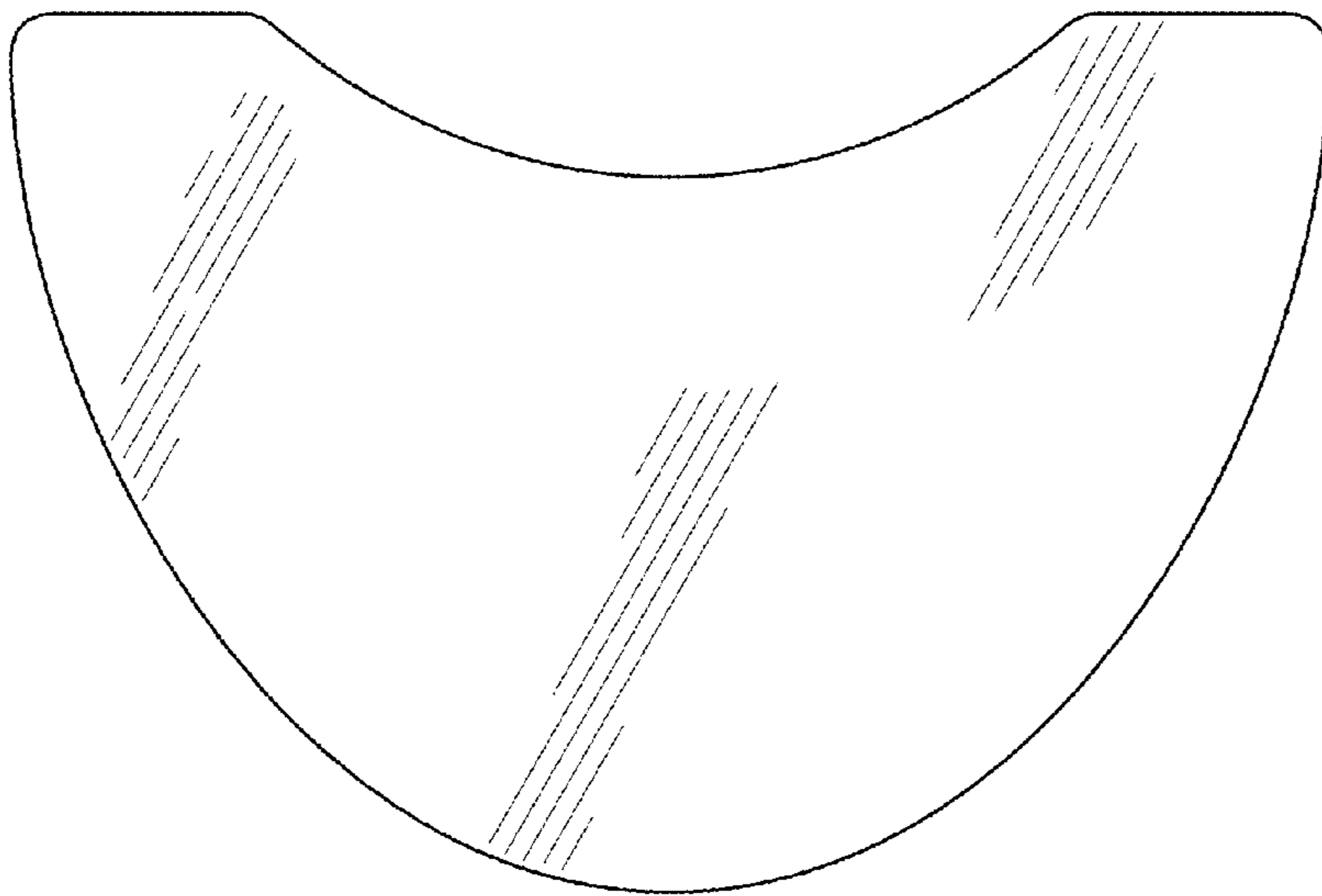

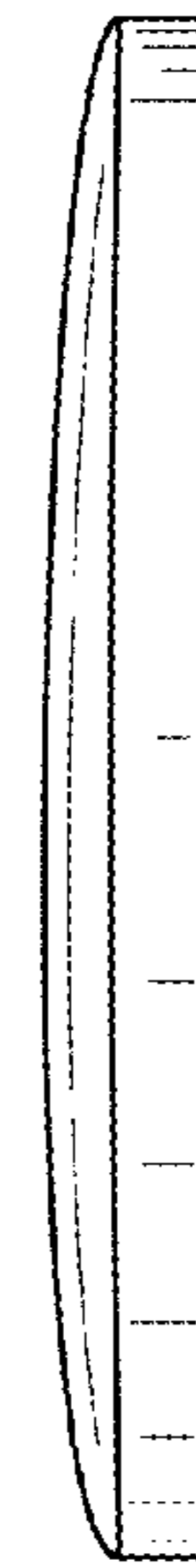

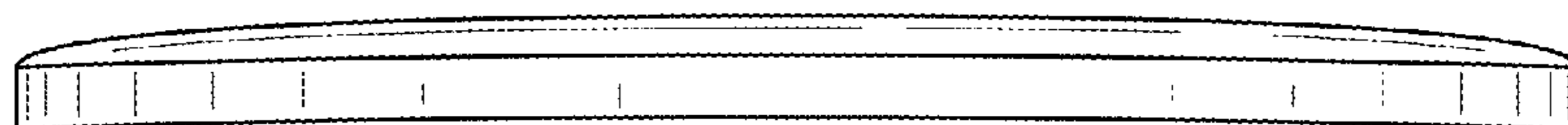
