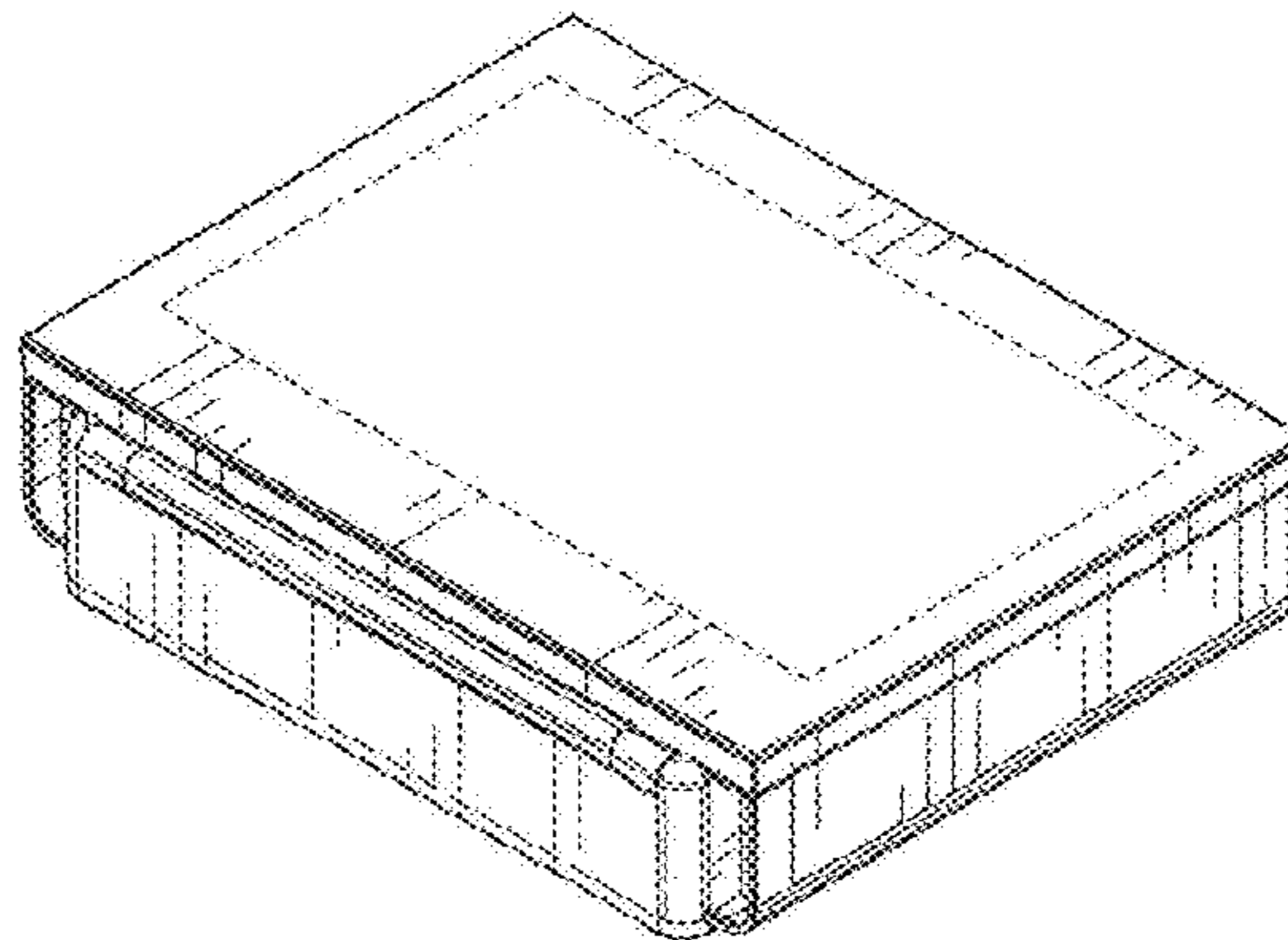
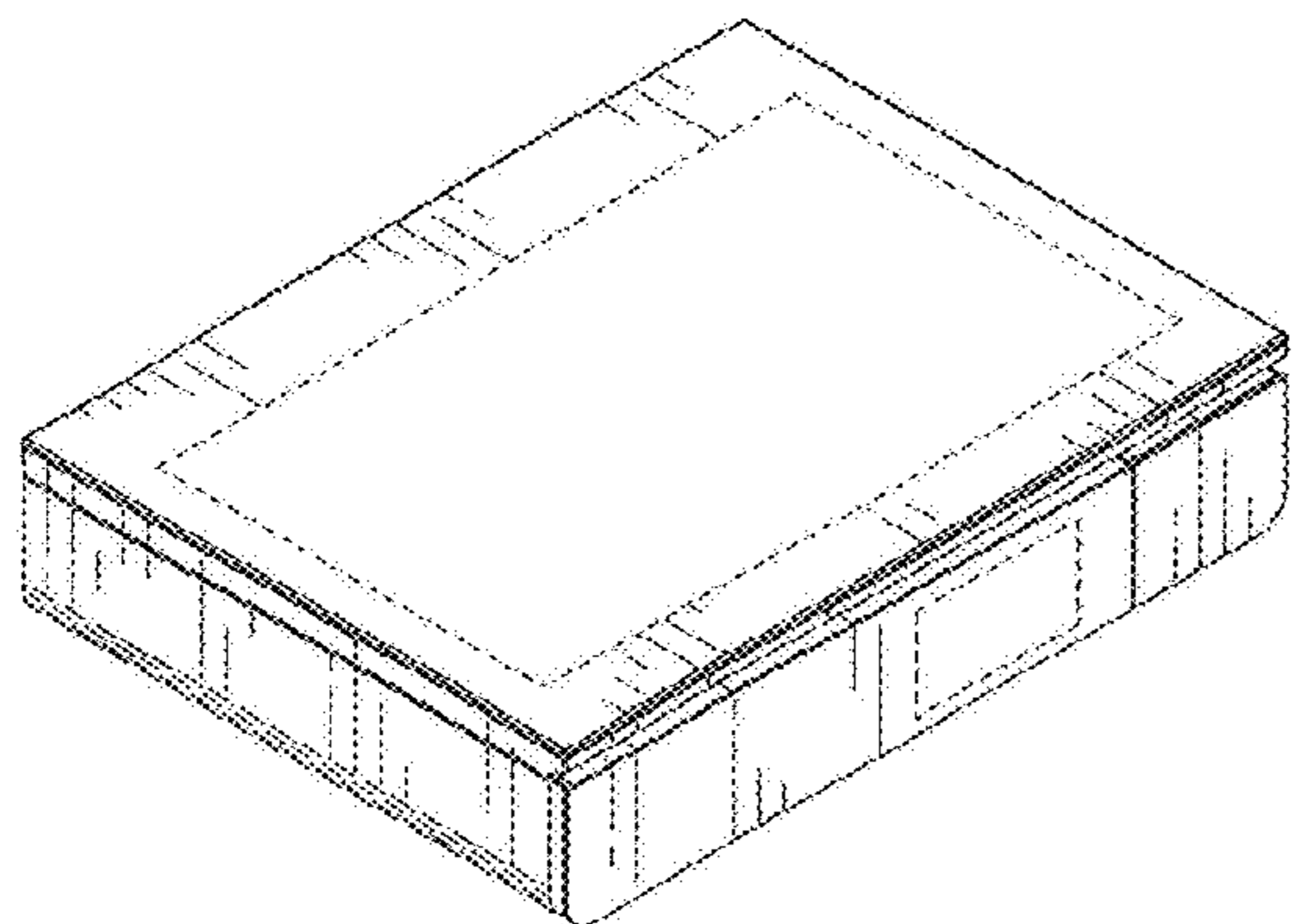
The ornamental design for an imaging device, as shown and described.

DESCRIPTION

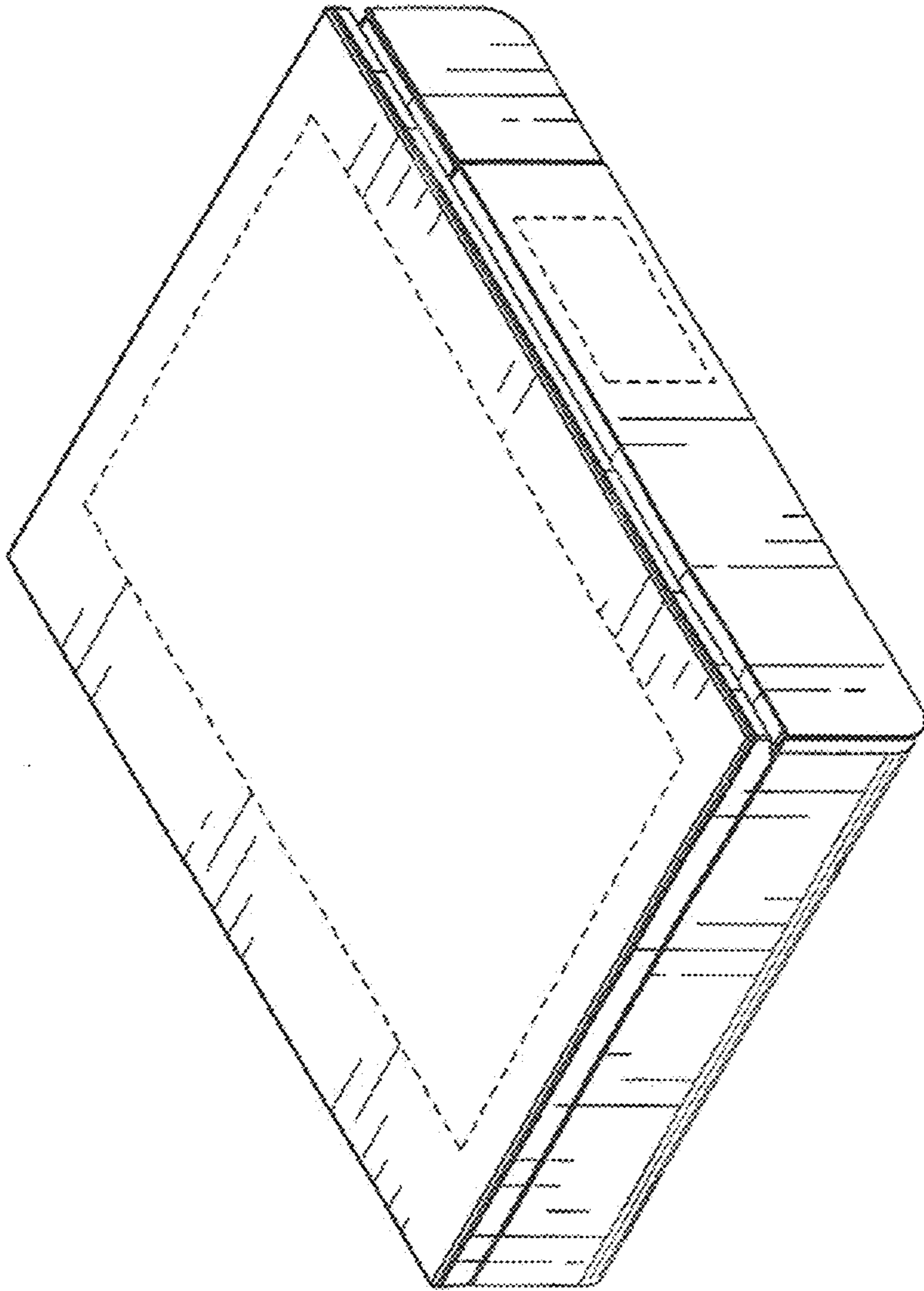

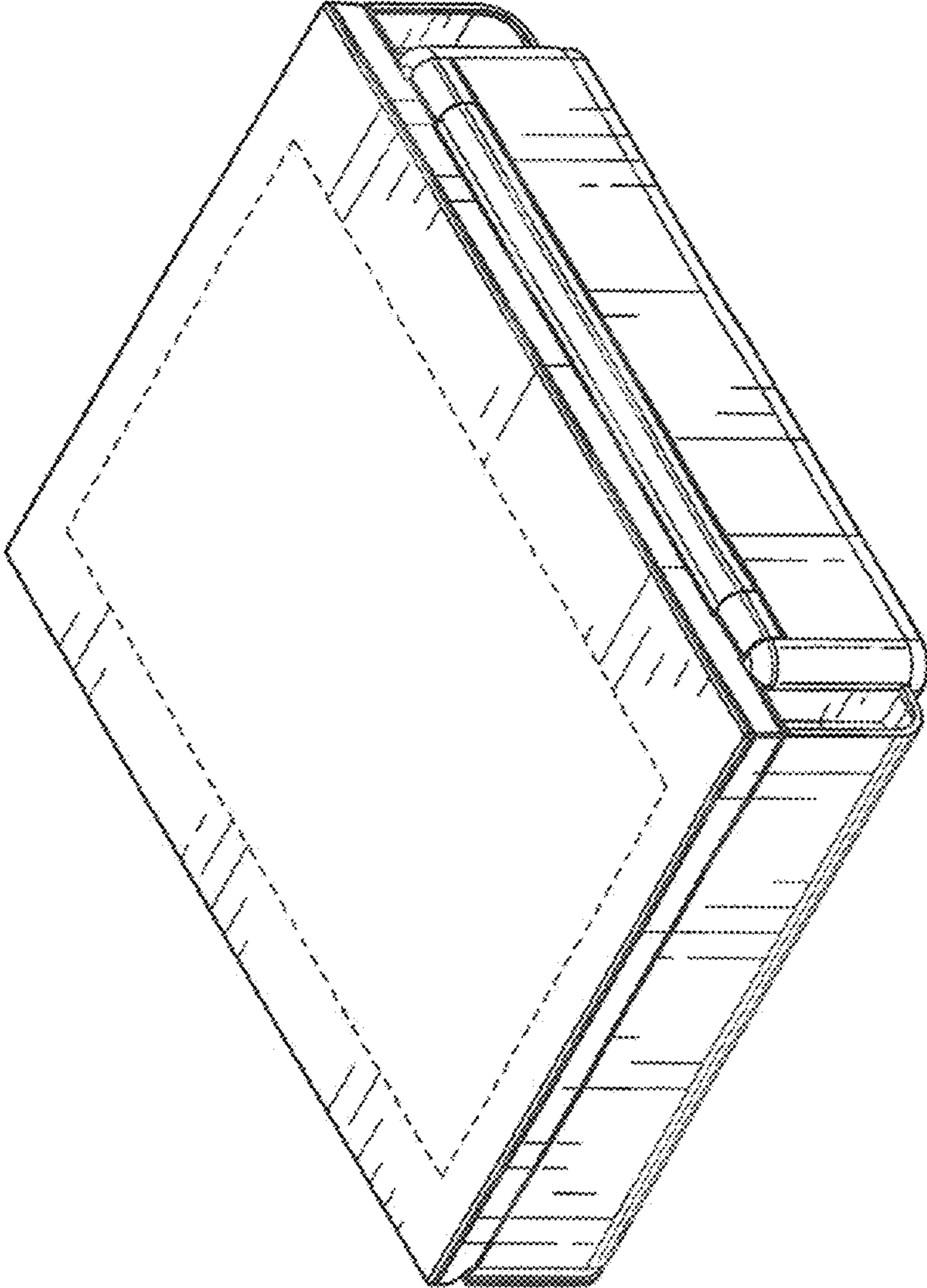

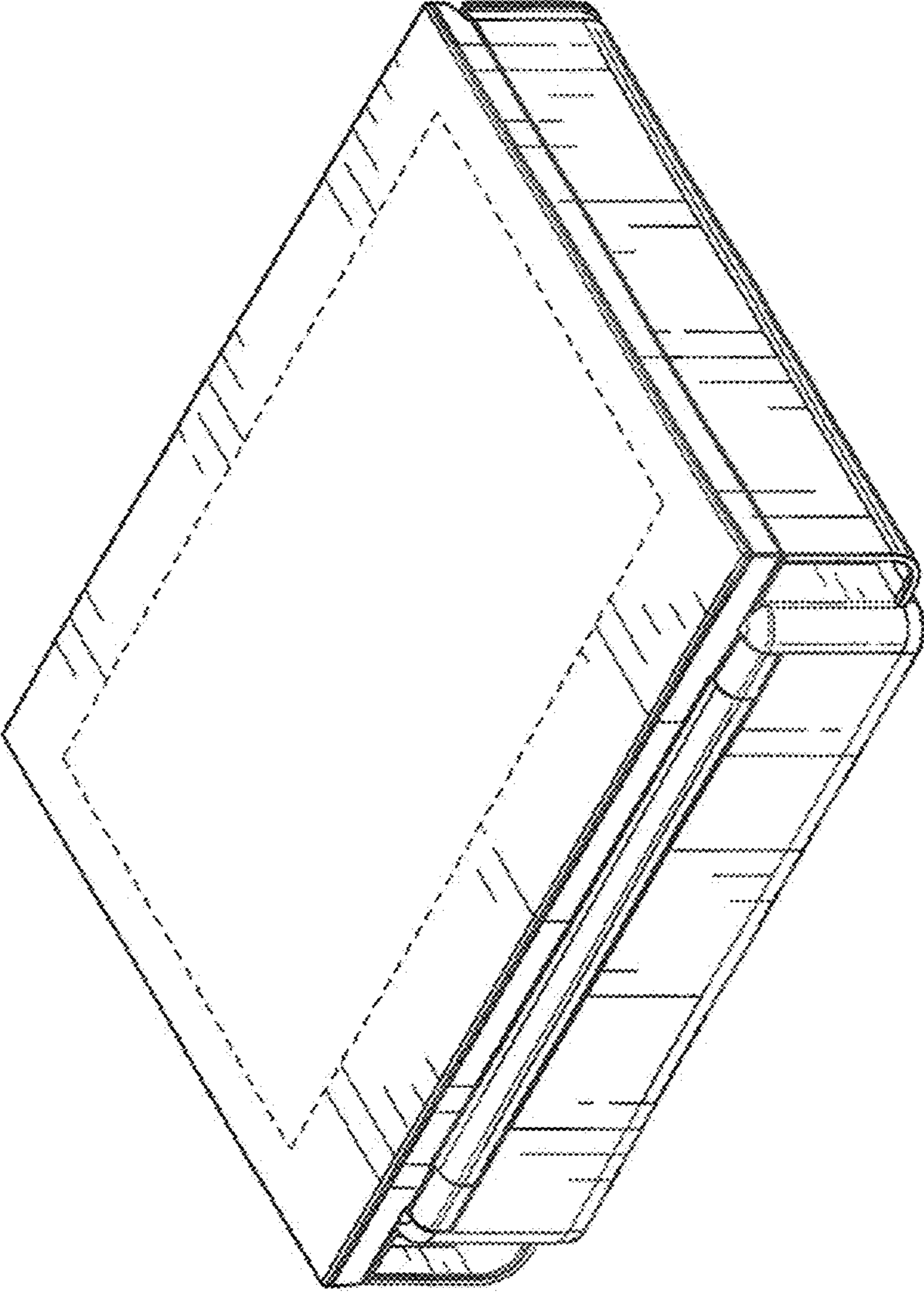

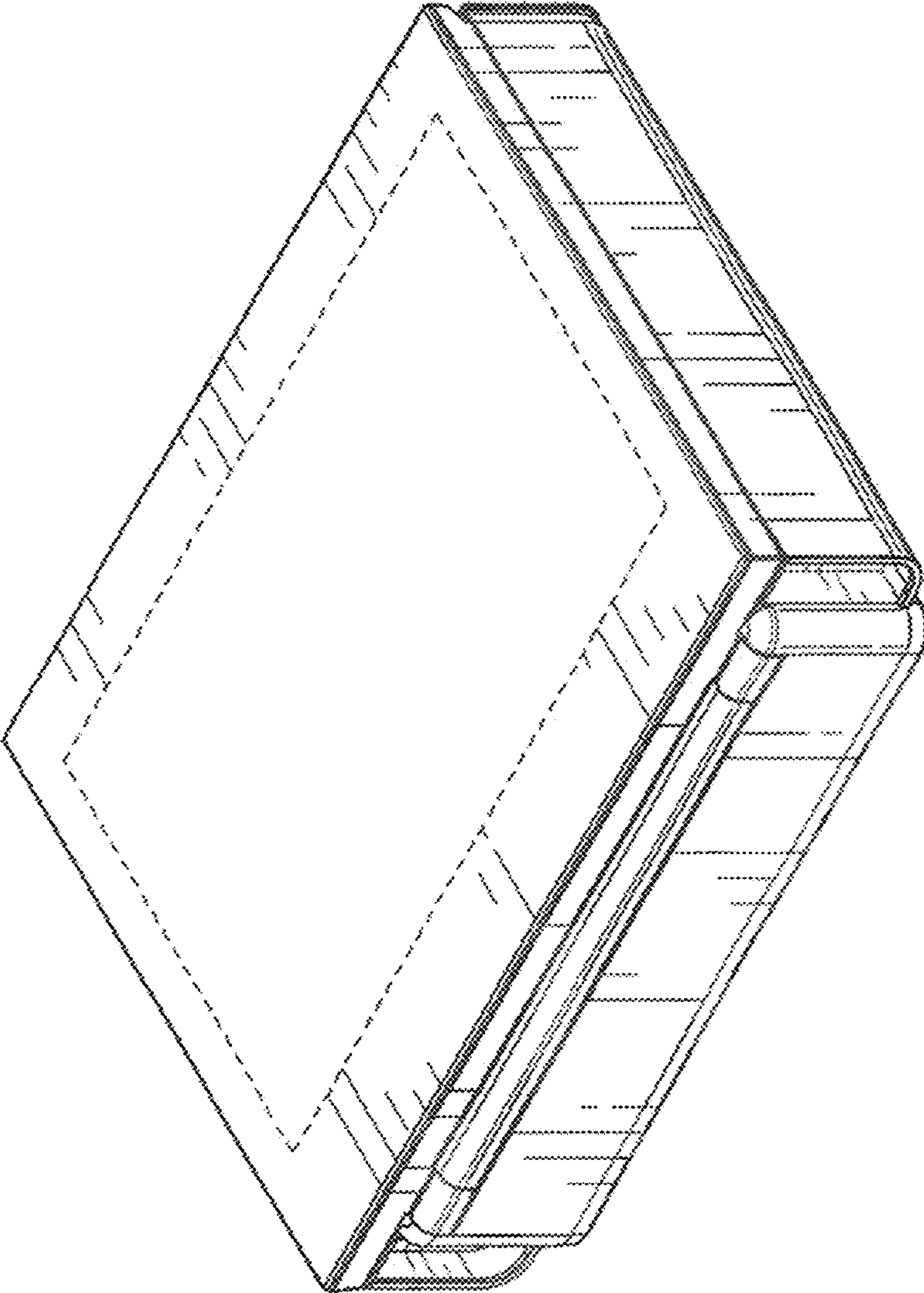

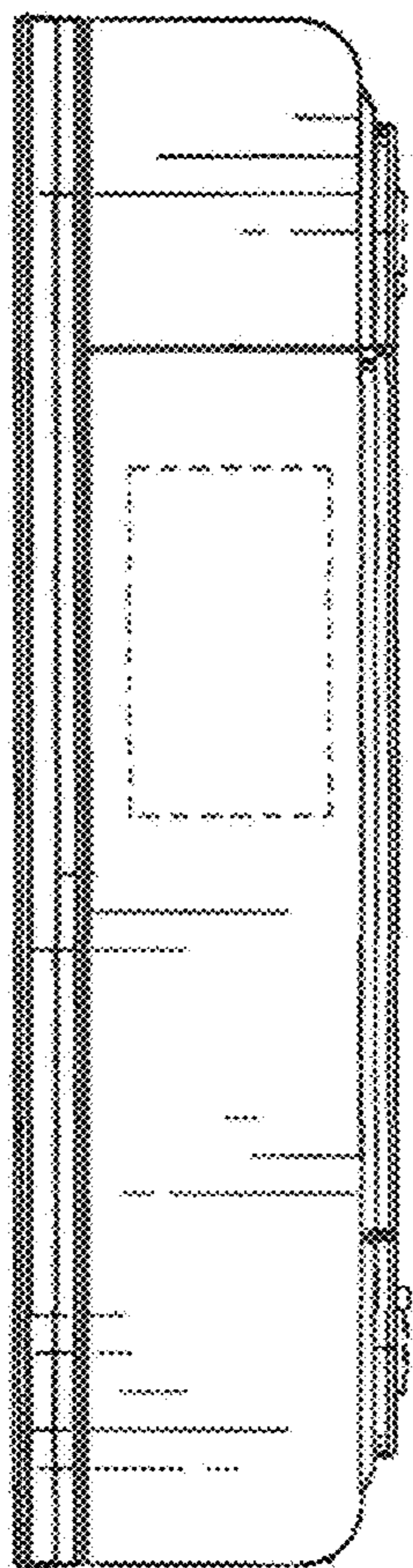

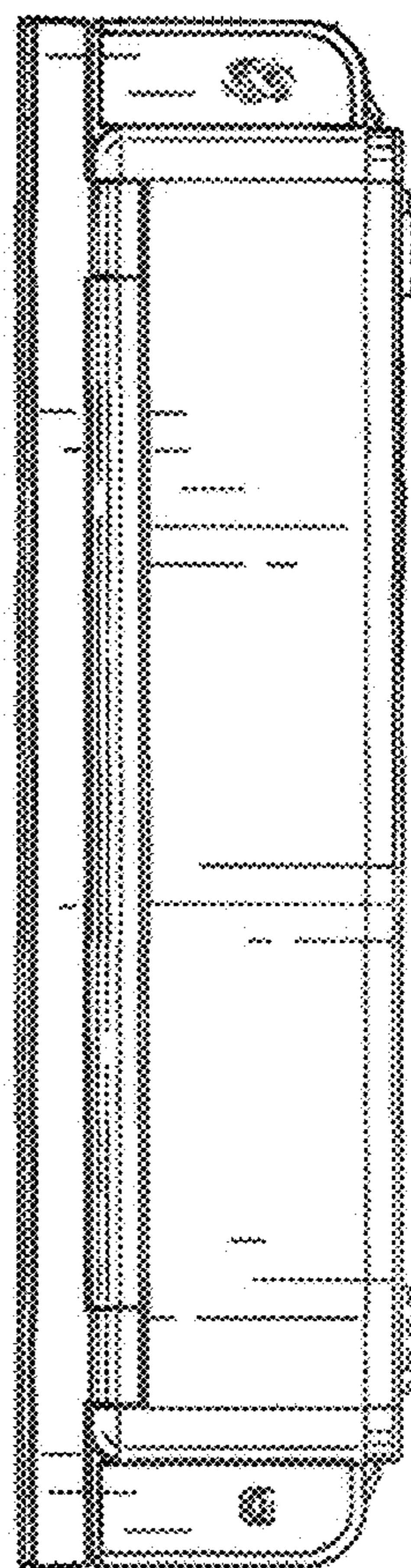

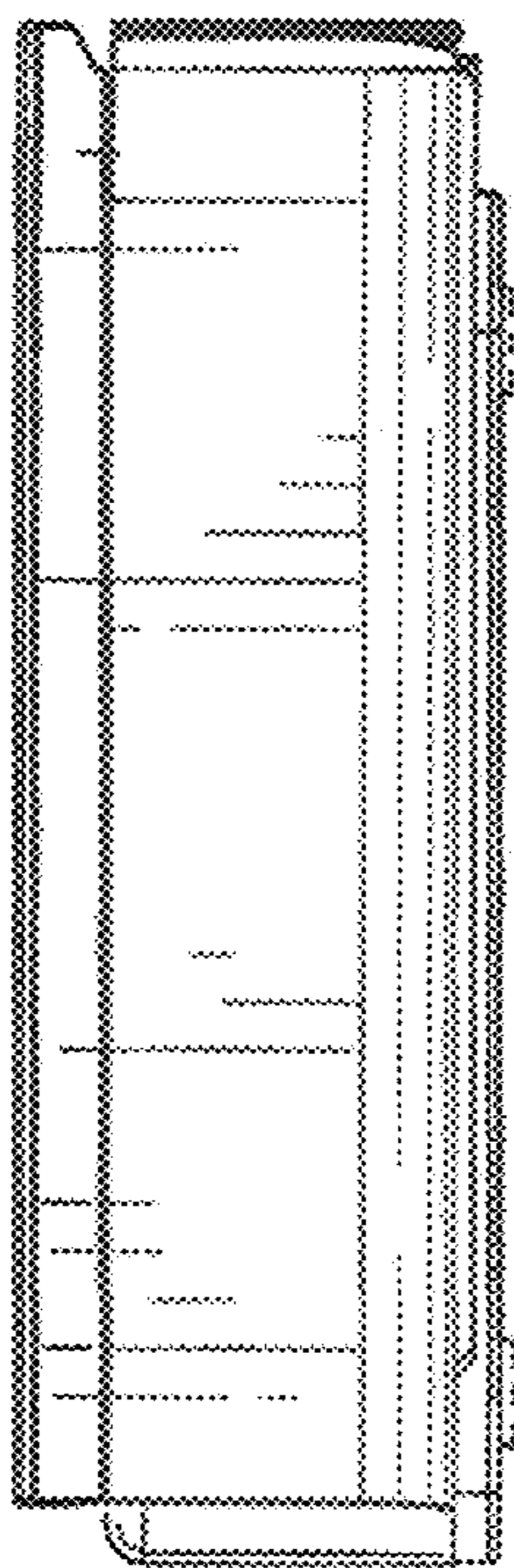

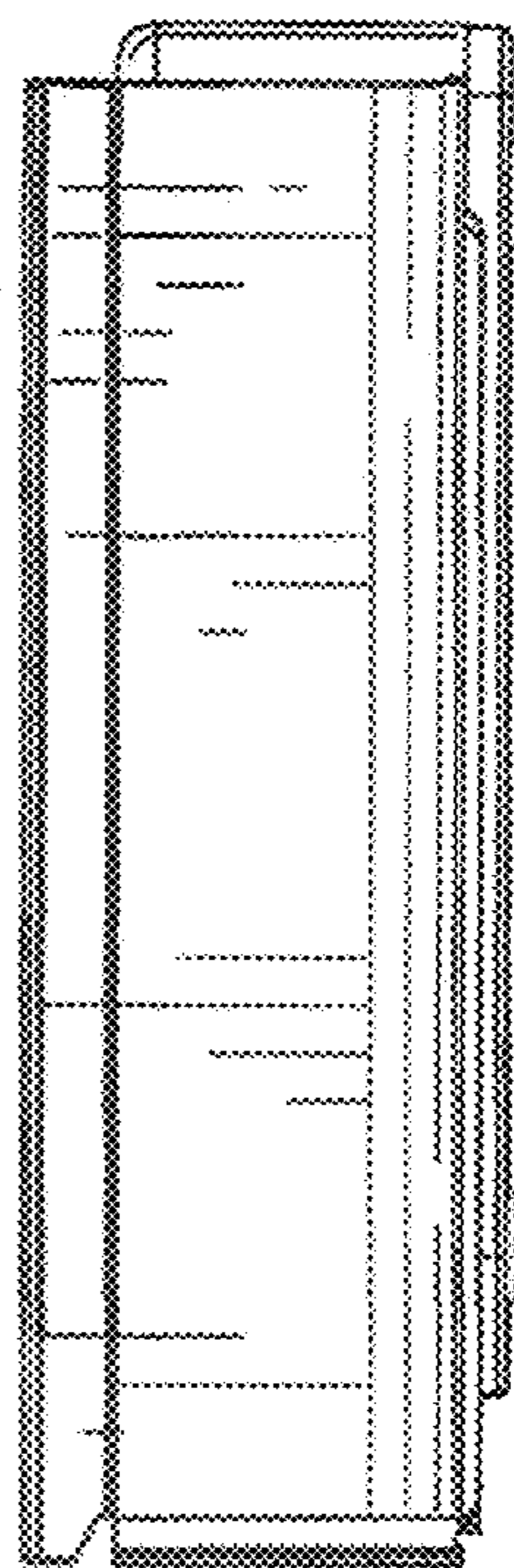

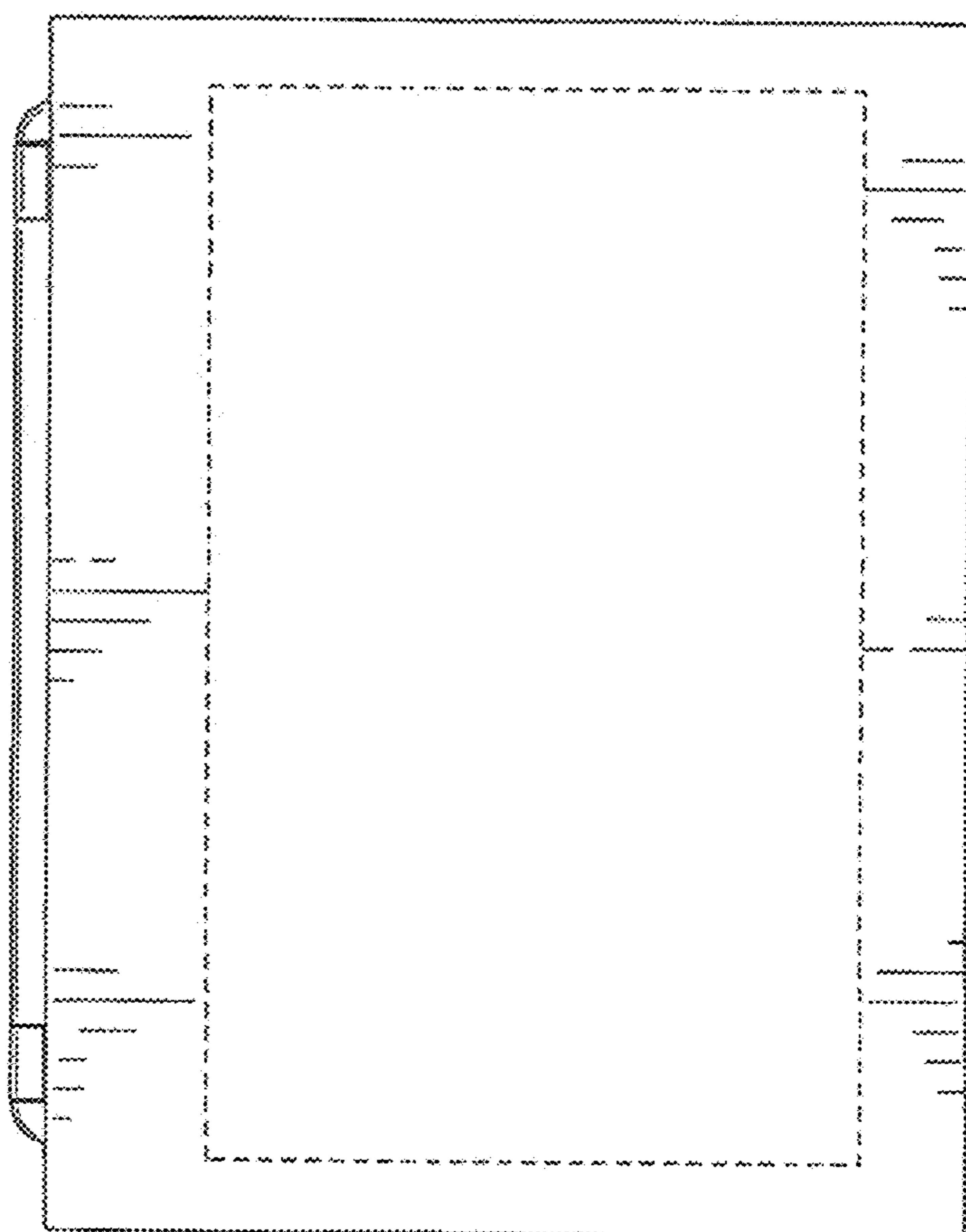

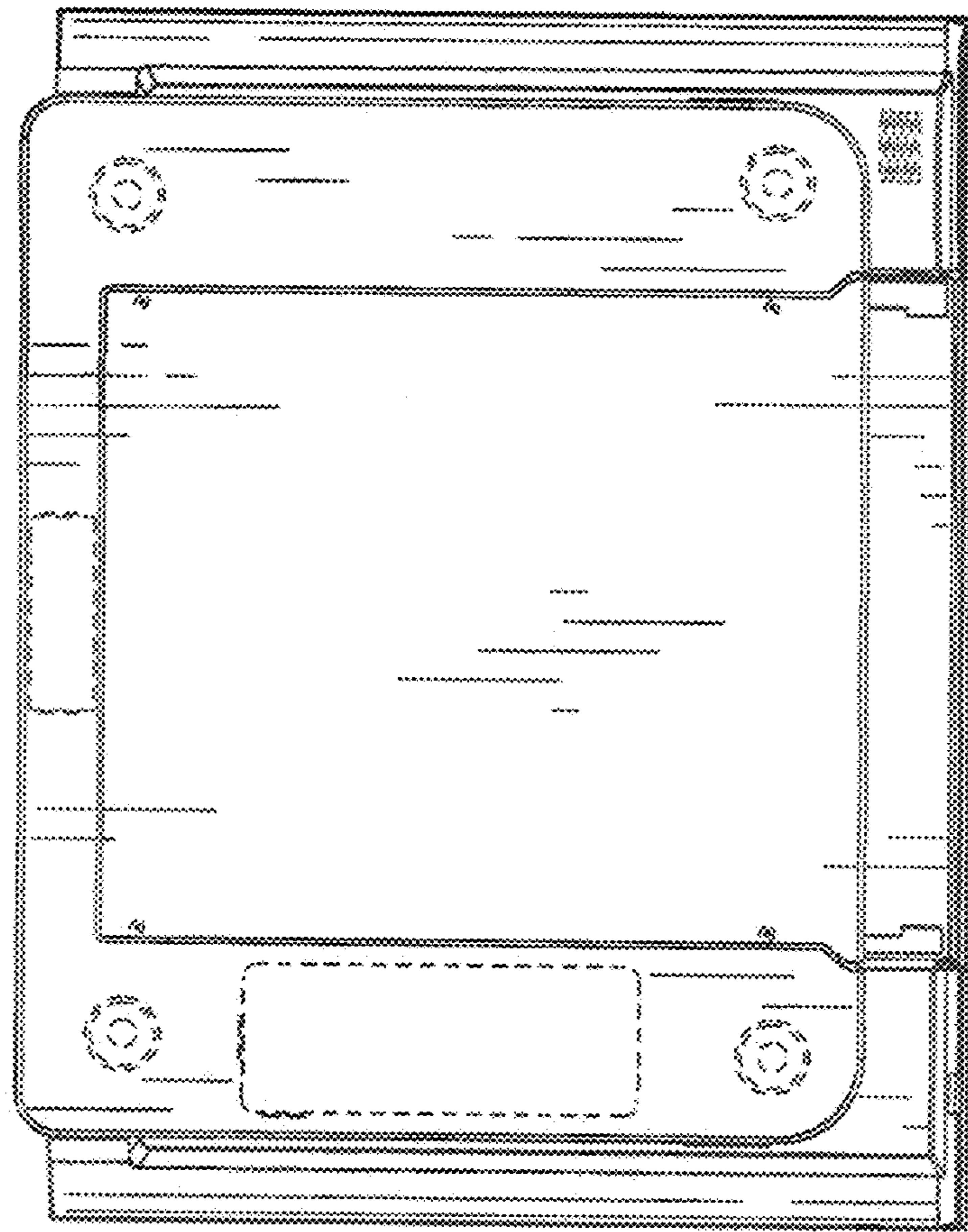
