DESCRIPTION

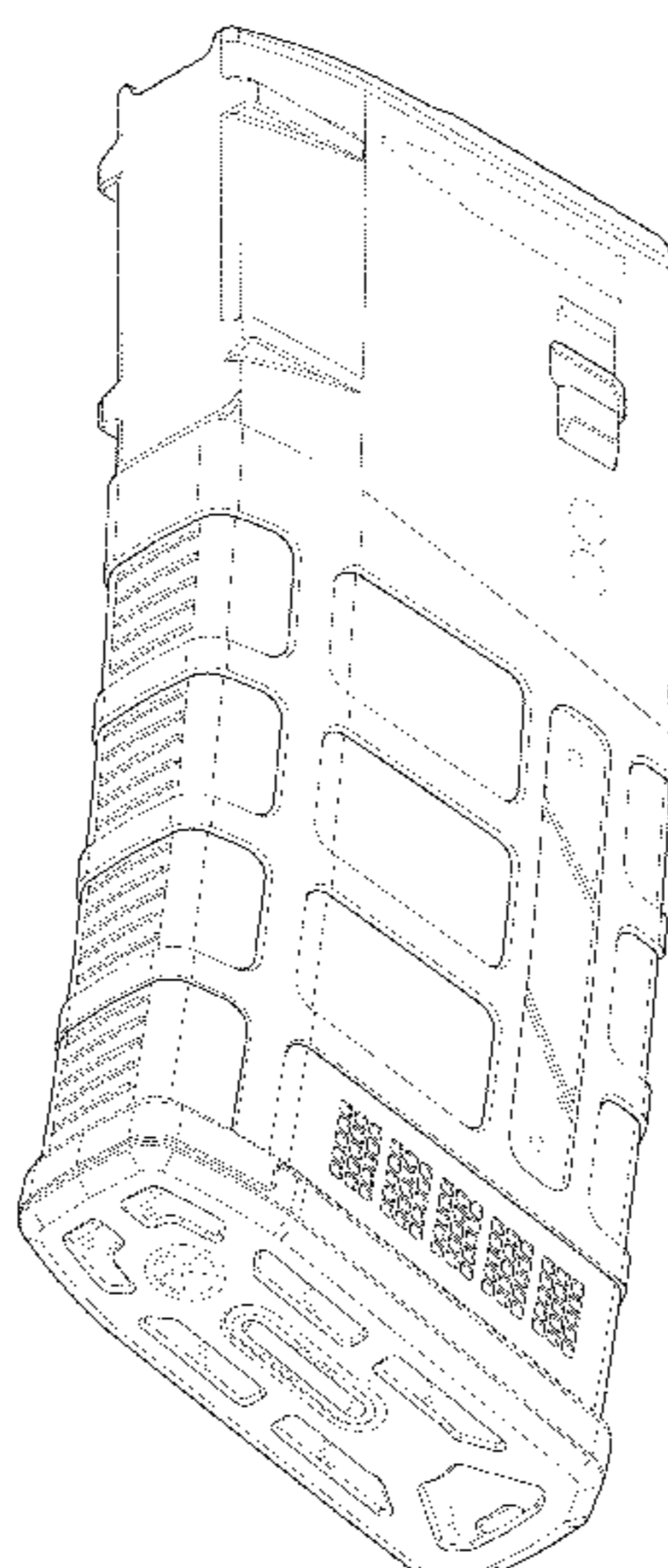
FIG. 1 is a left, bottom, front perspective view of a firearm magazine with window showing our new design;

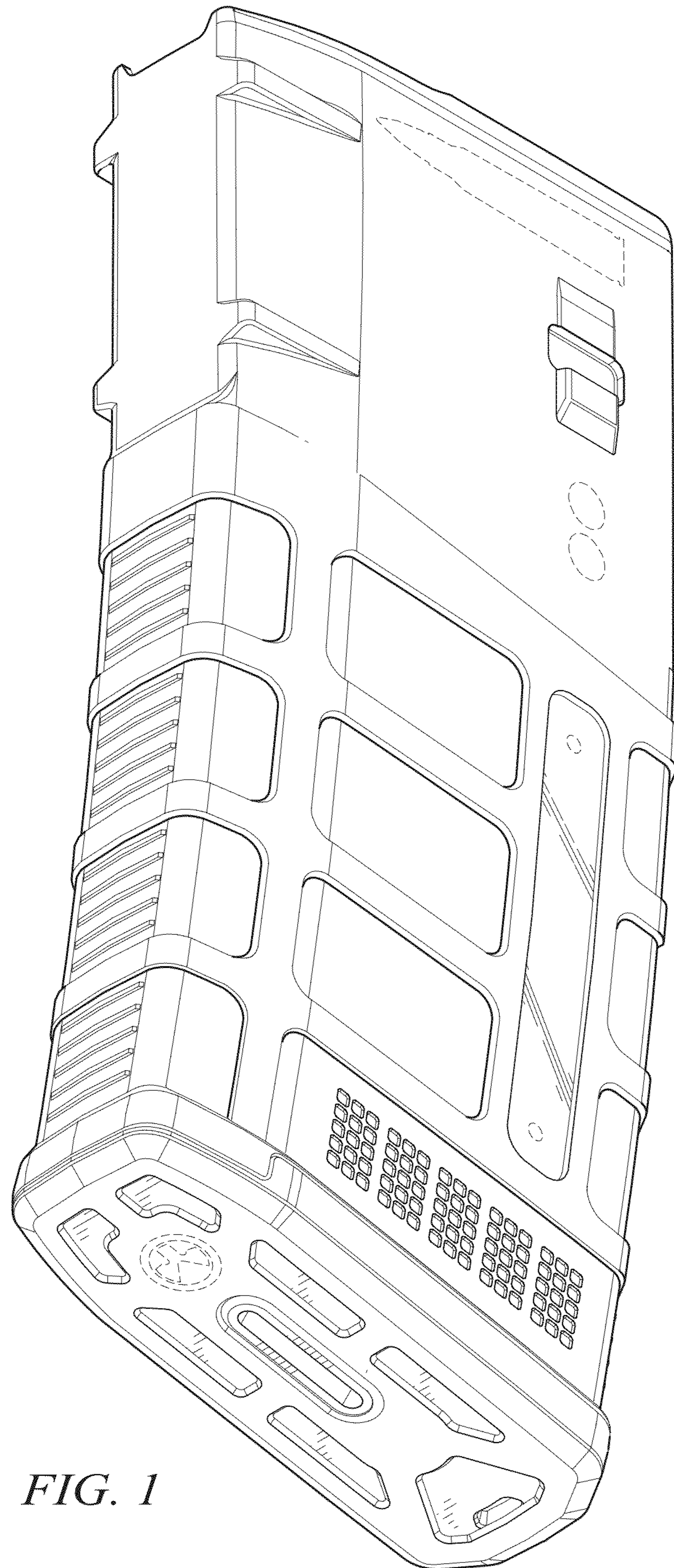

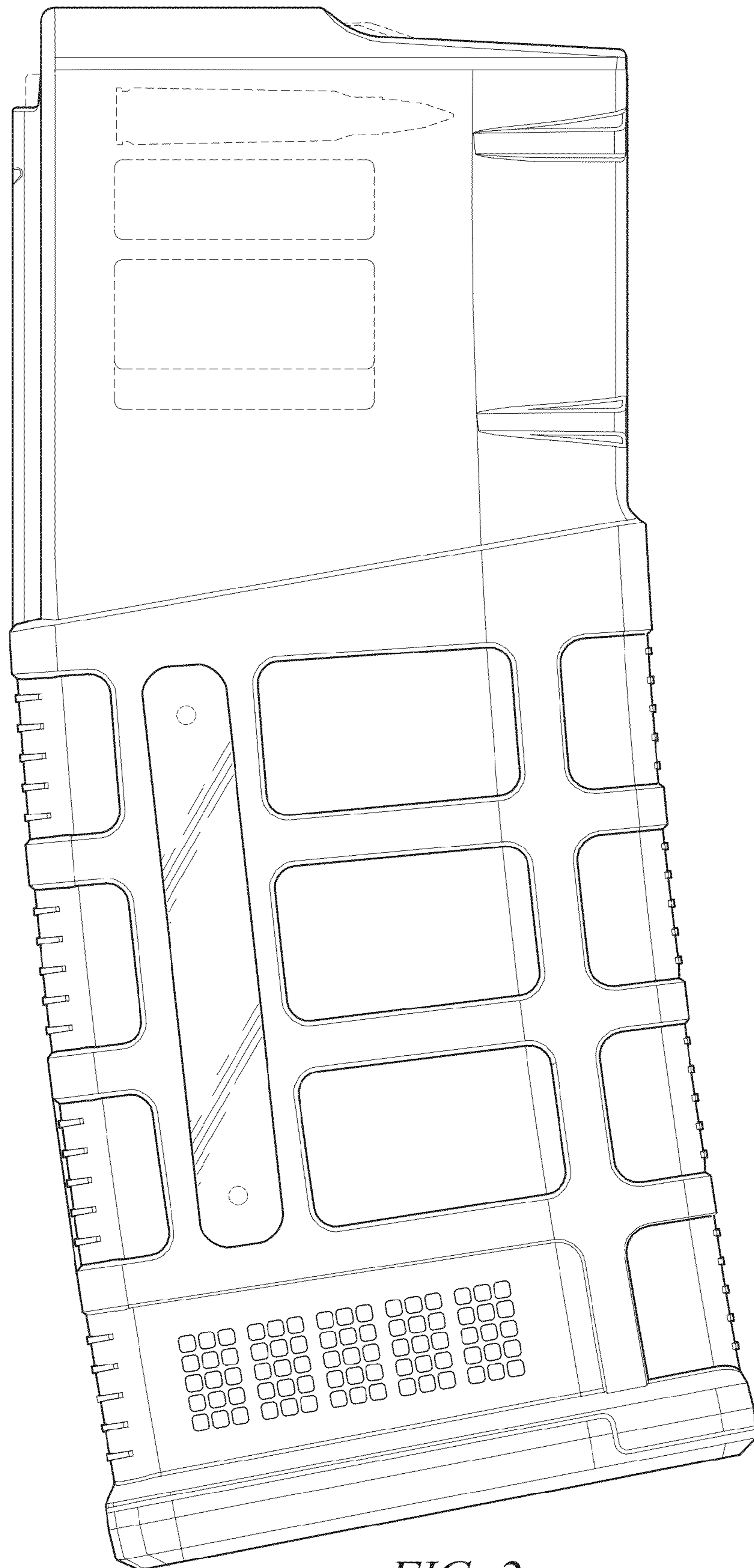

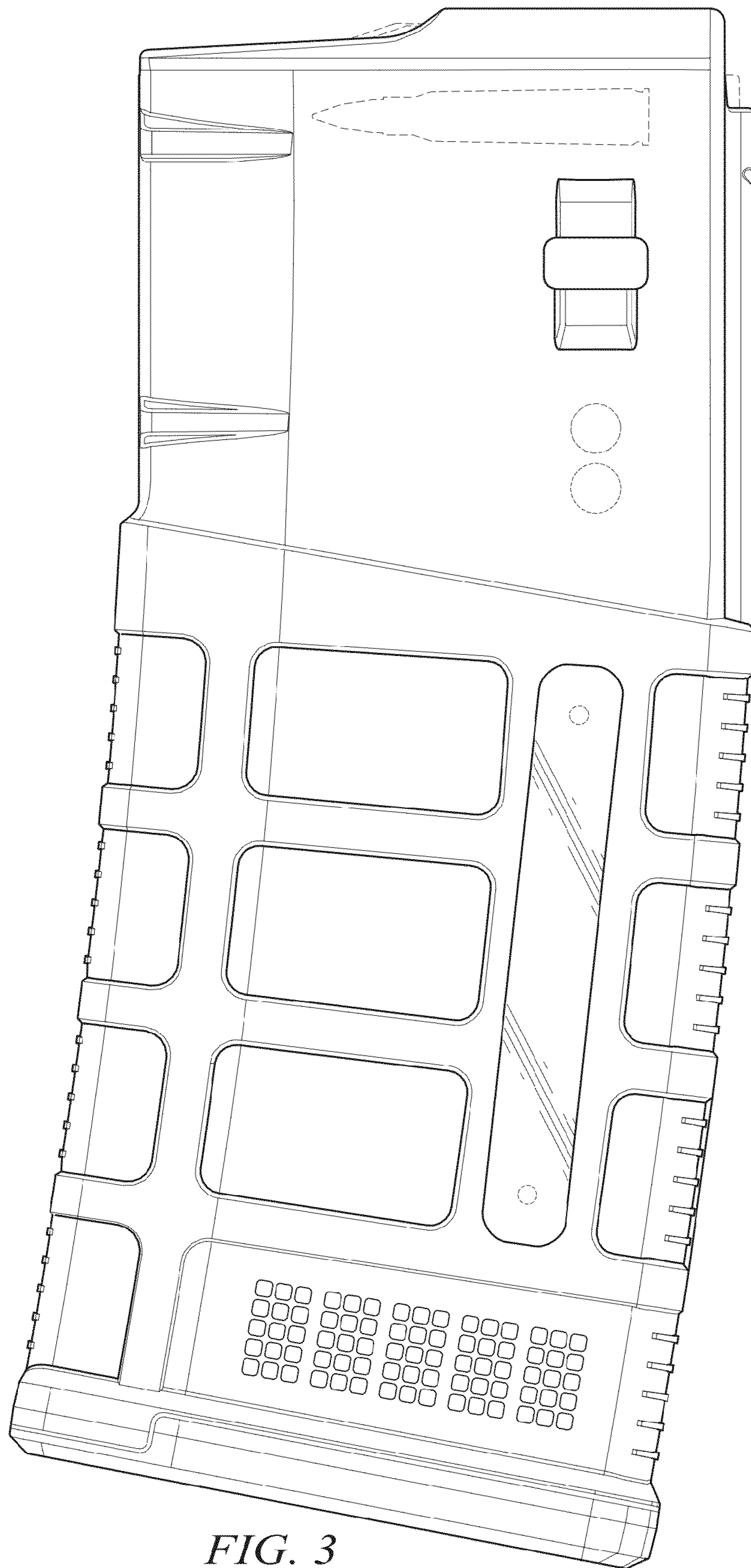

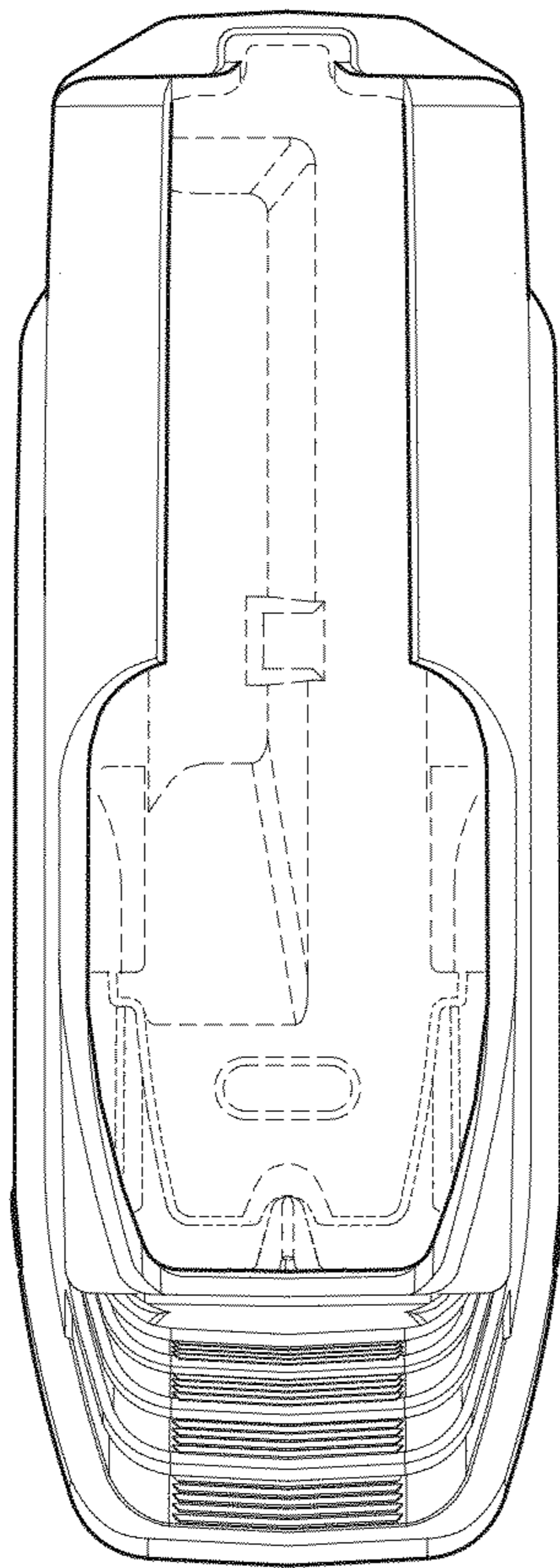

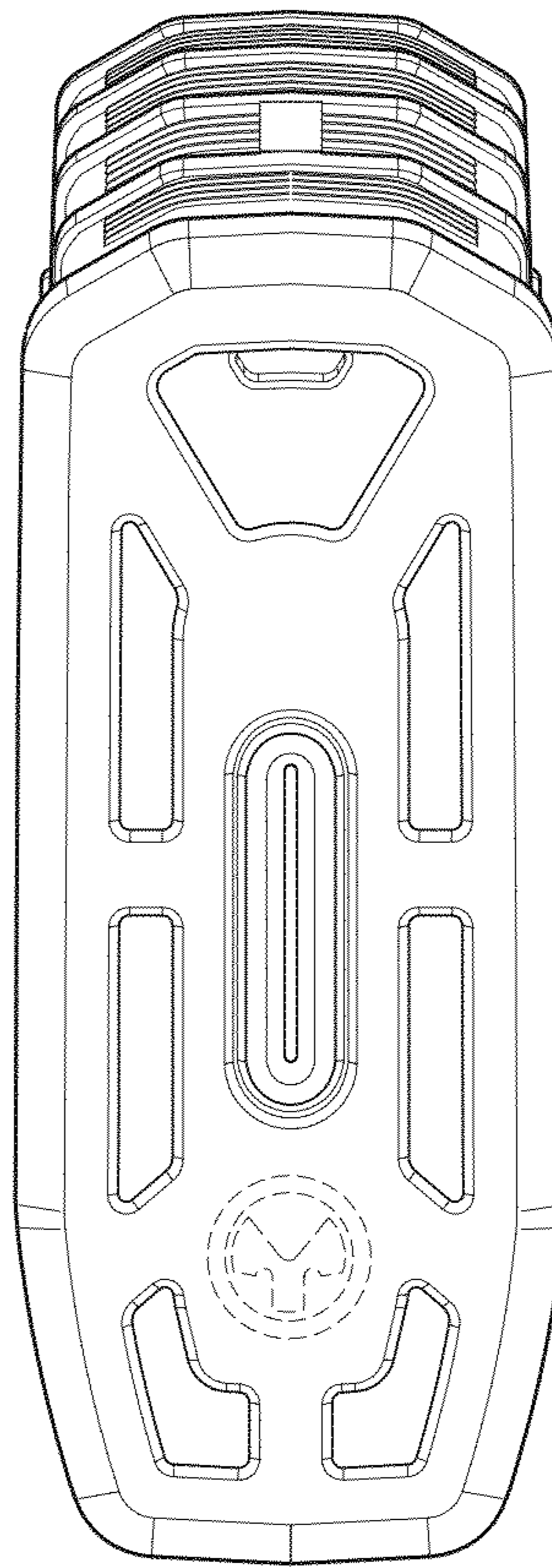

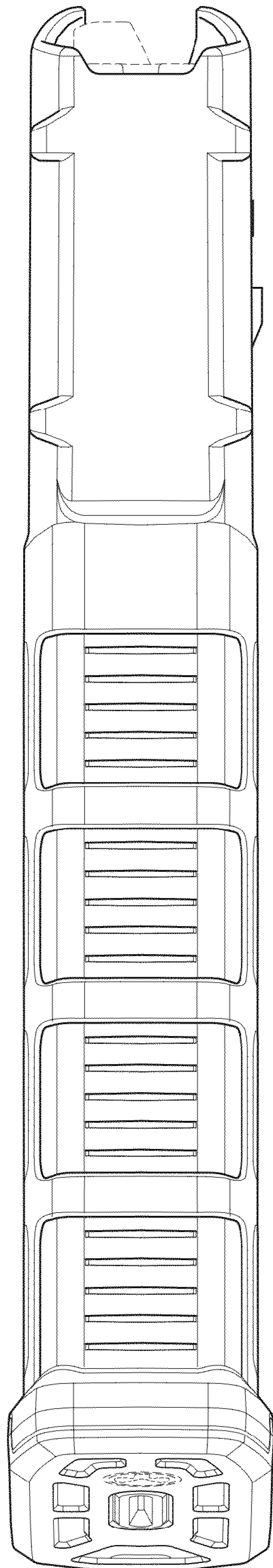

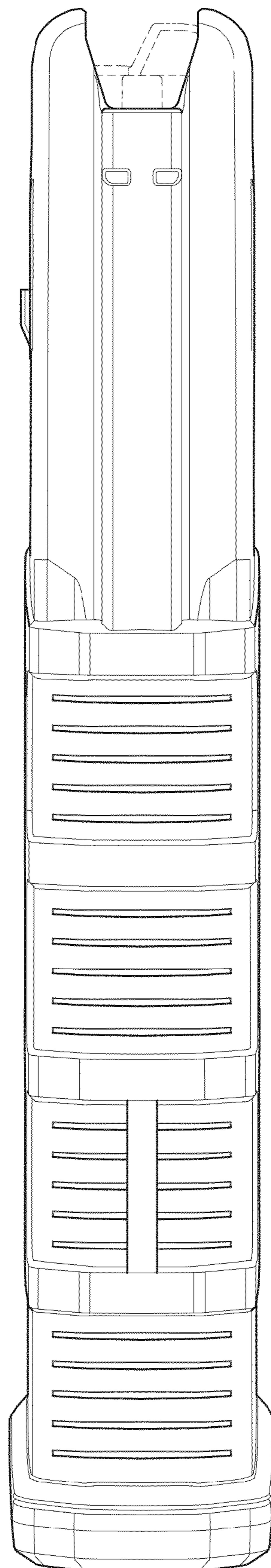

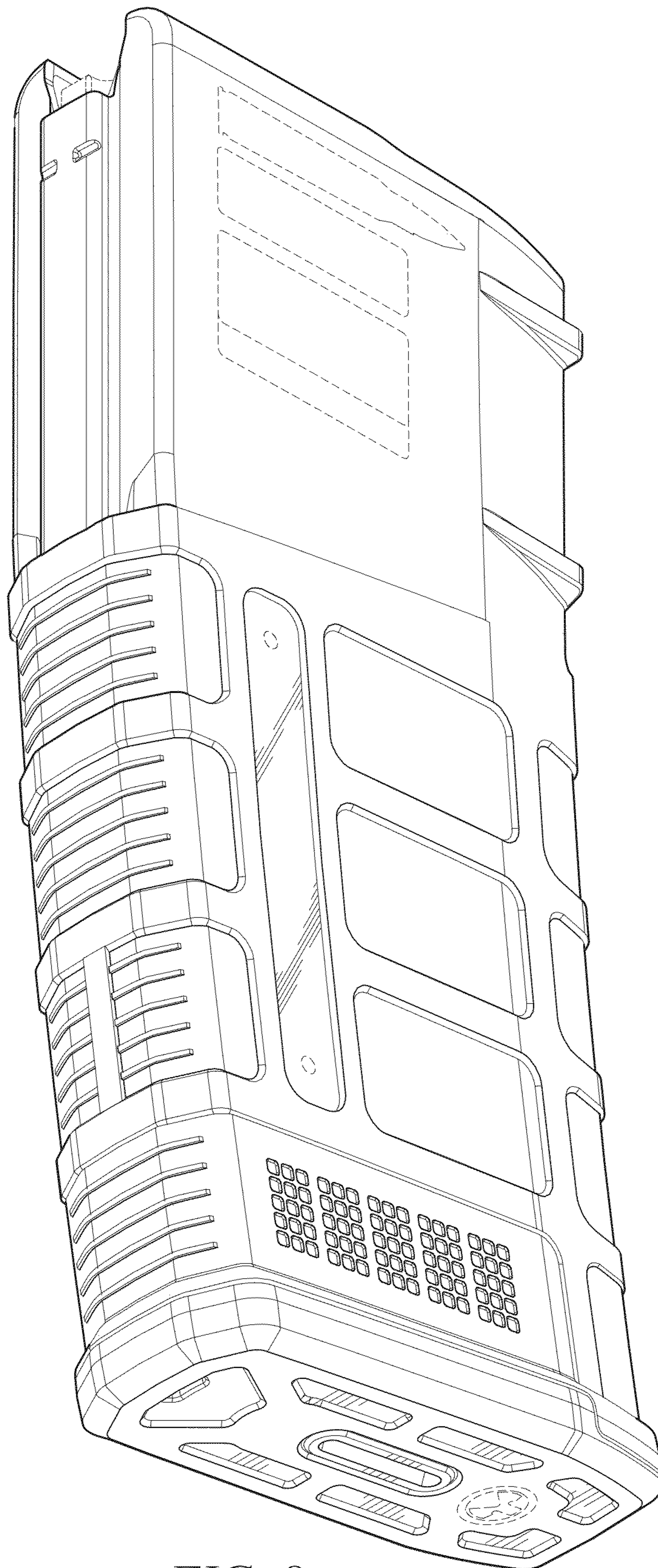
