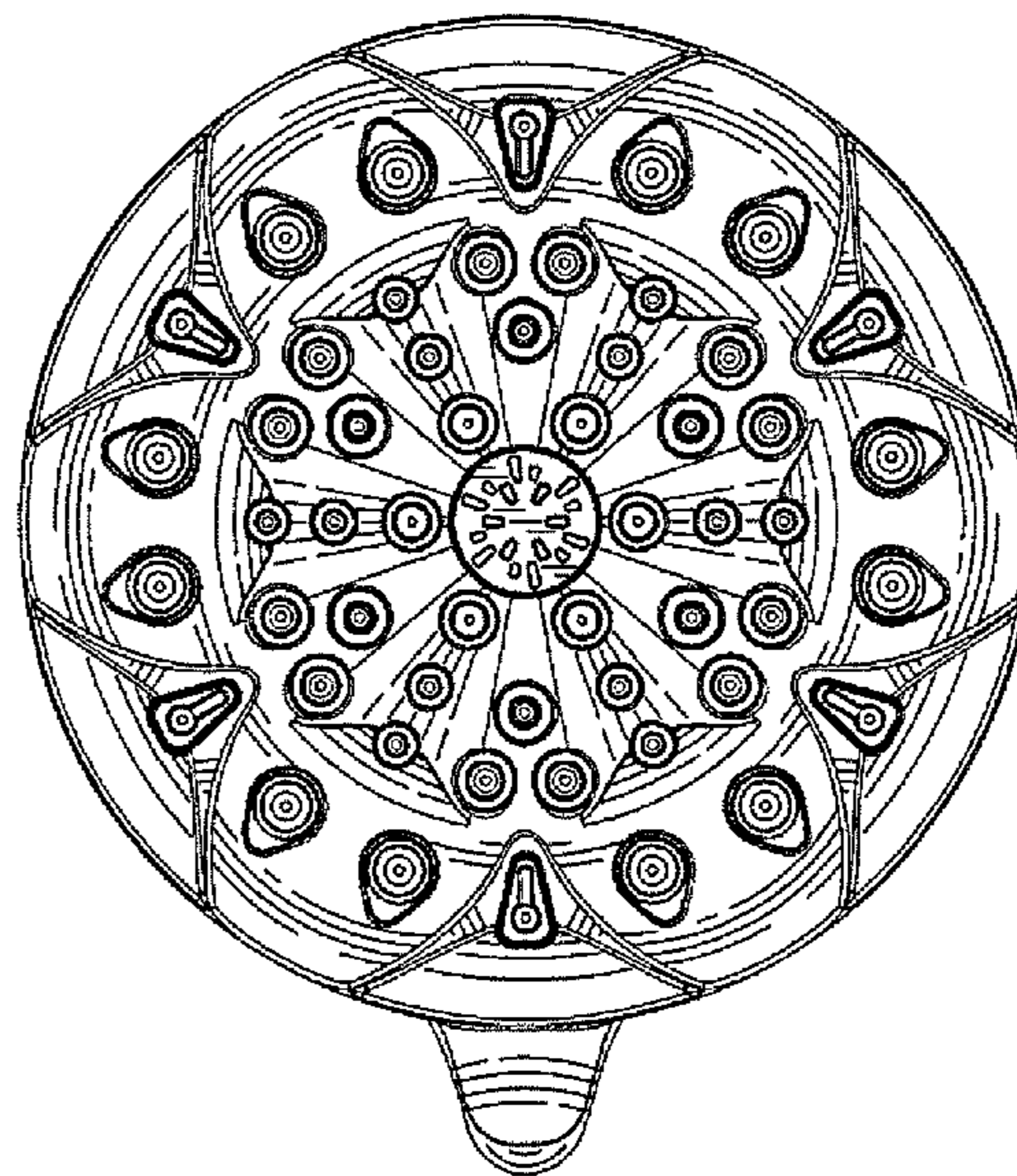
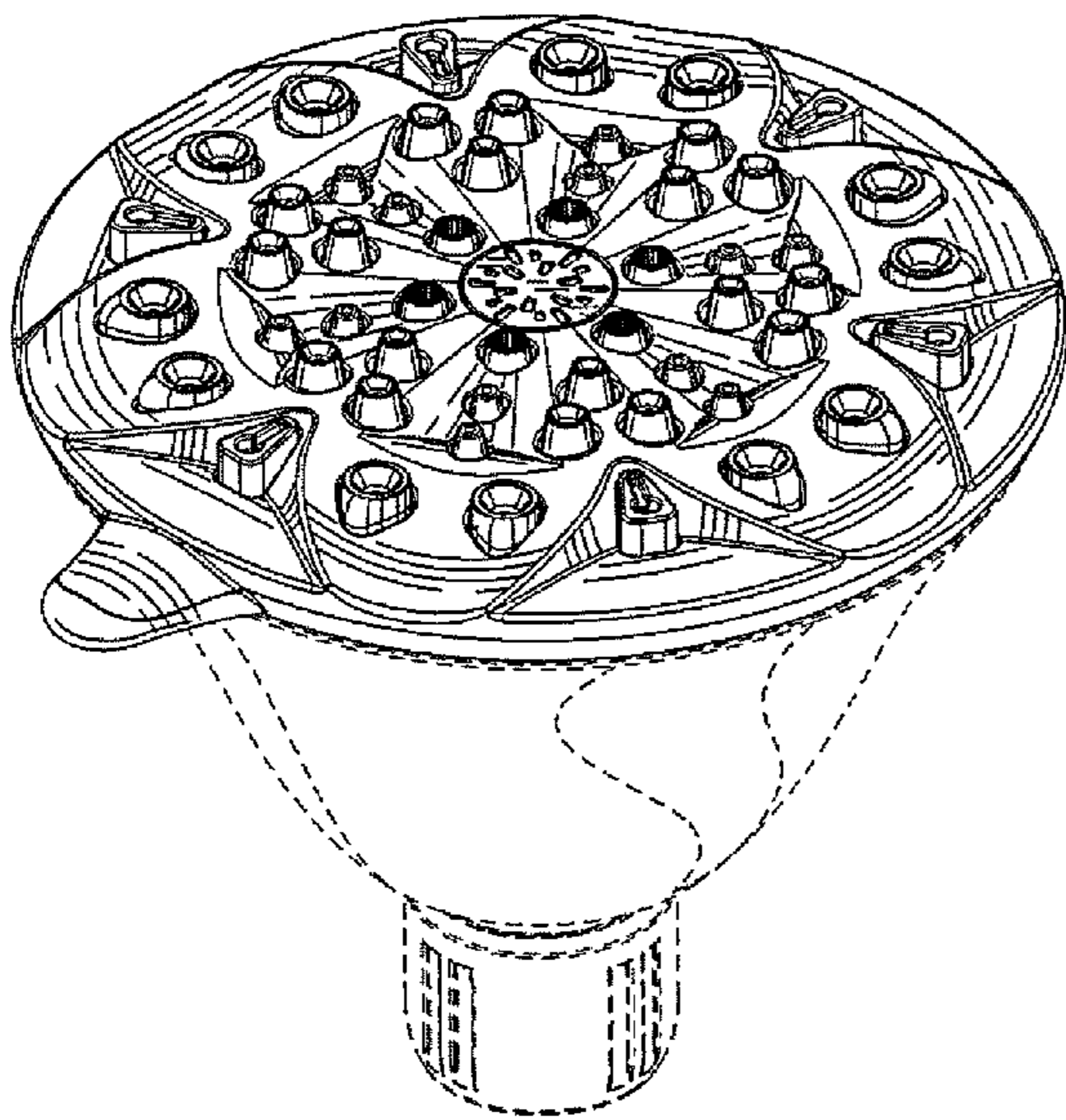
The ornamental design for a showerhead, as shown and described.

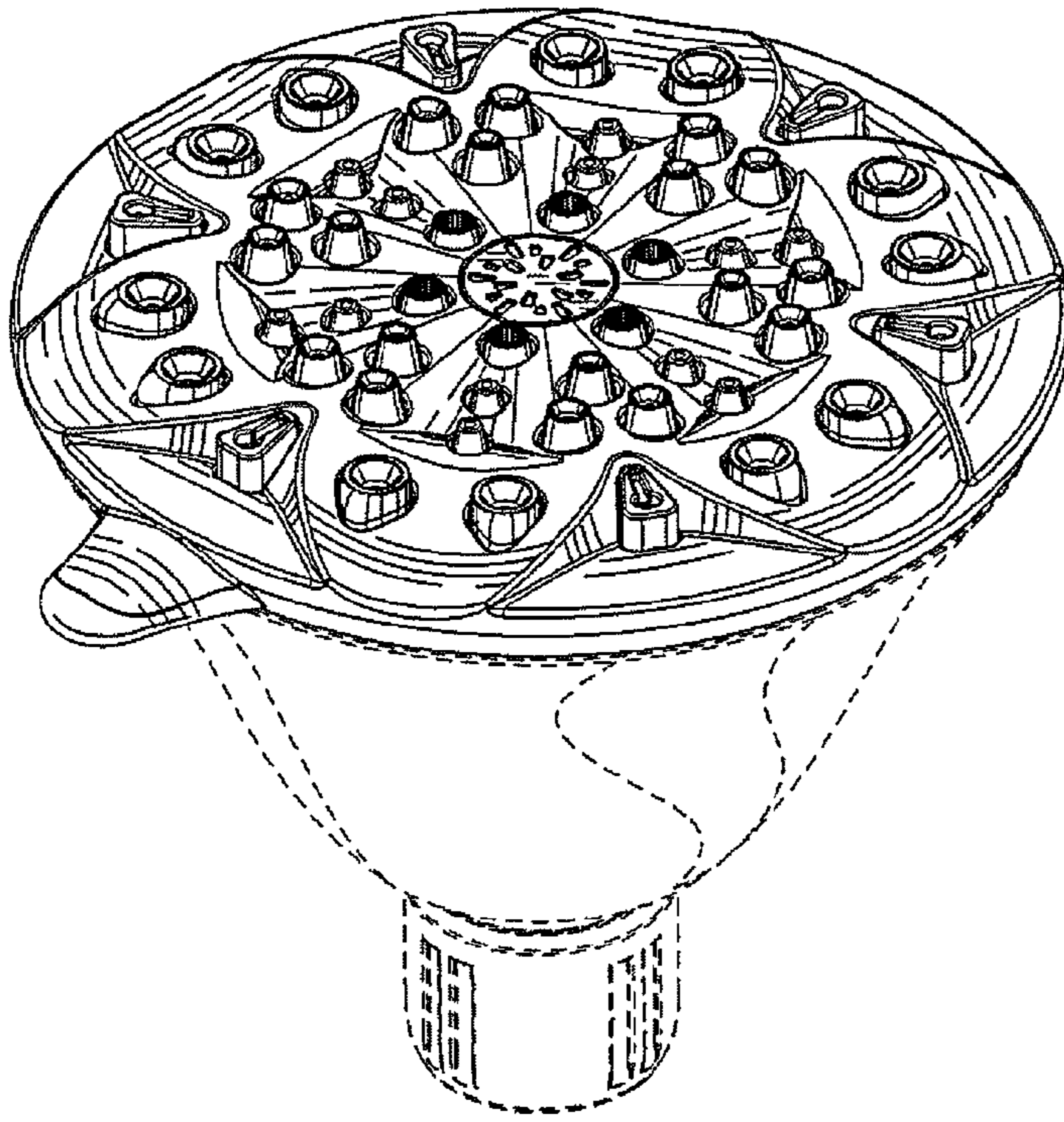

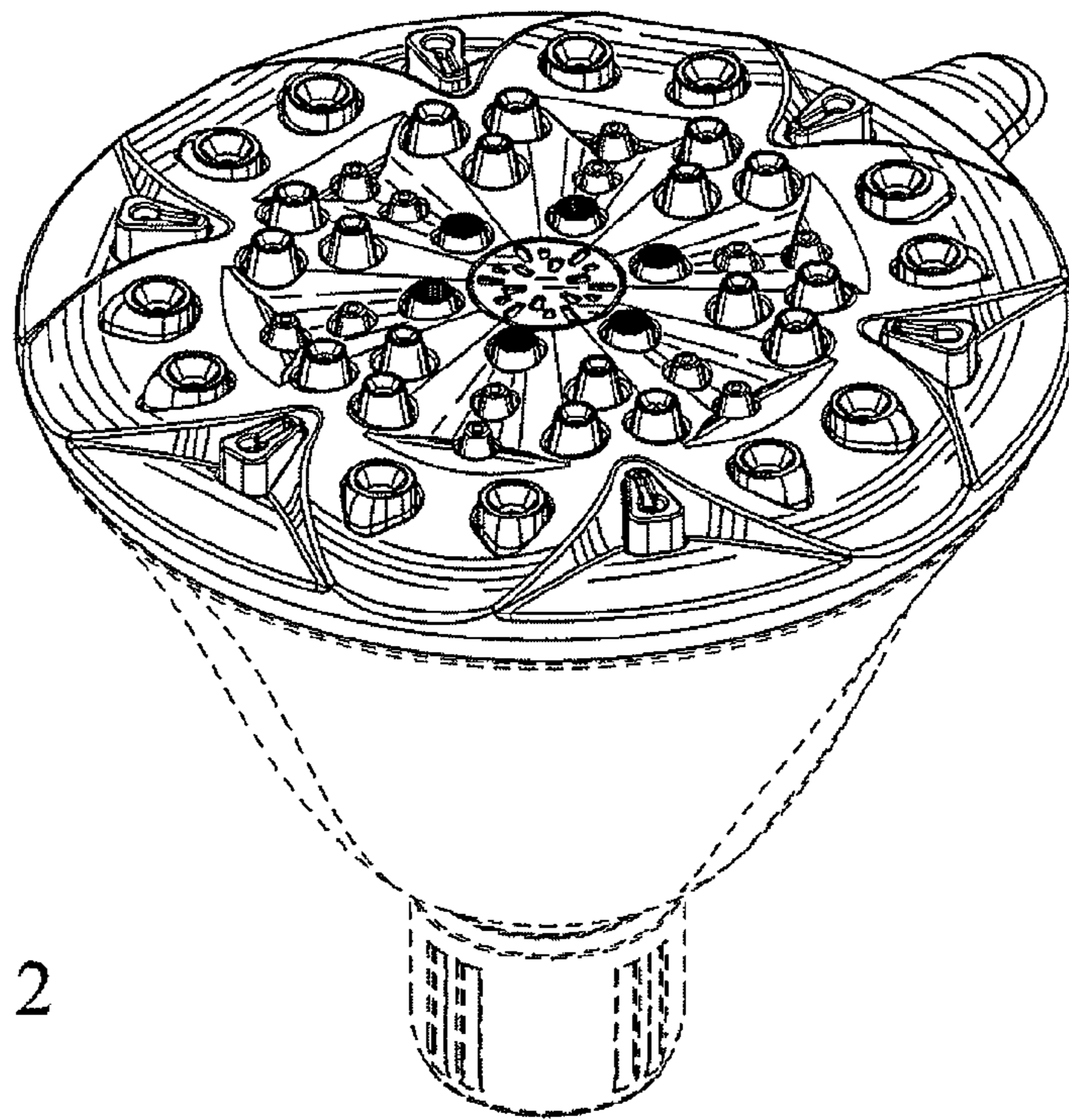

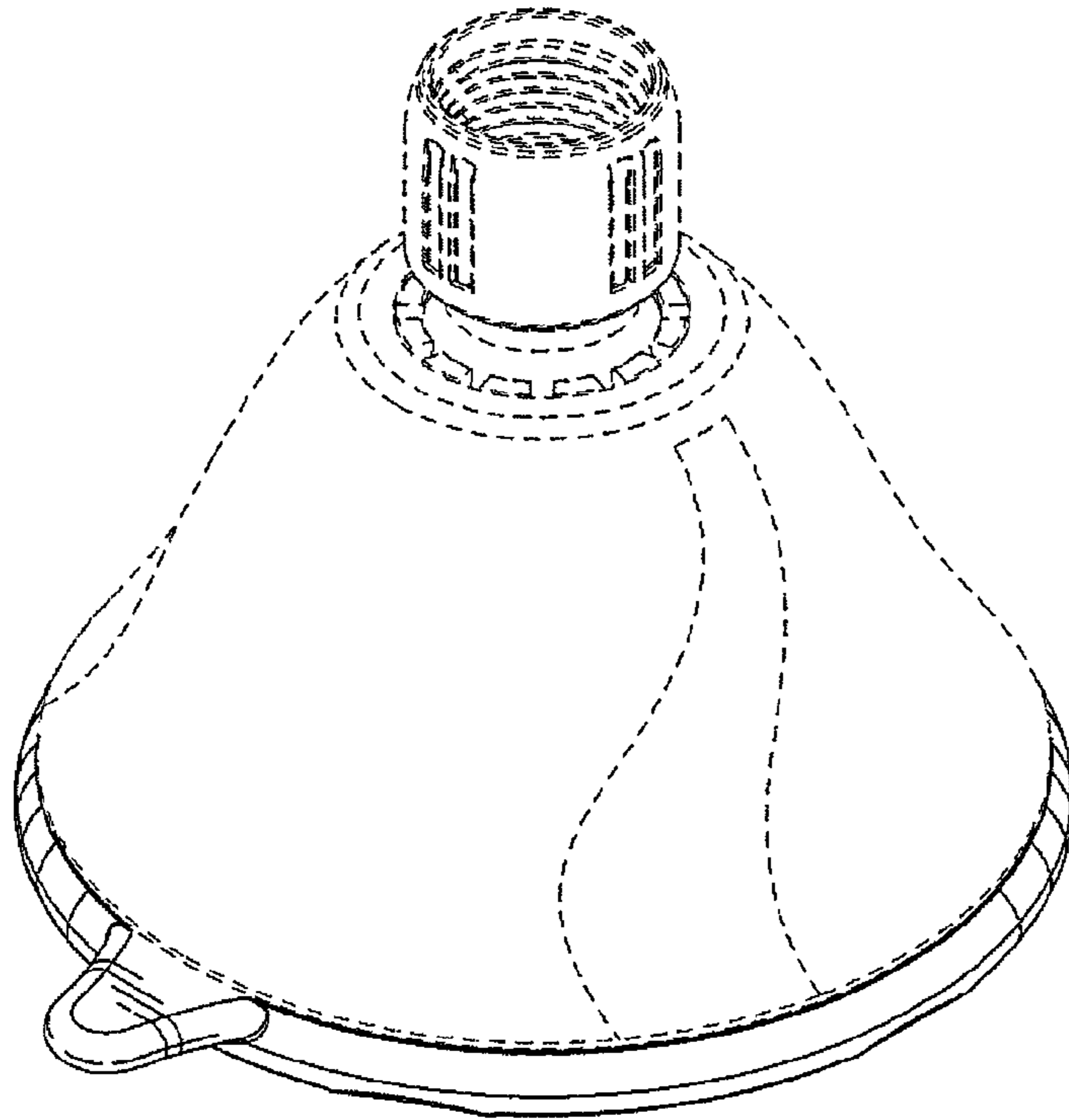
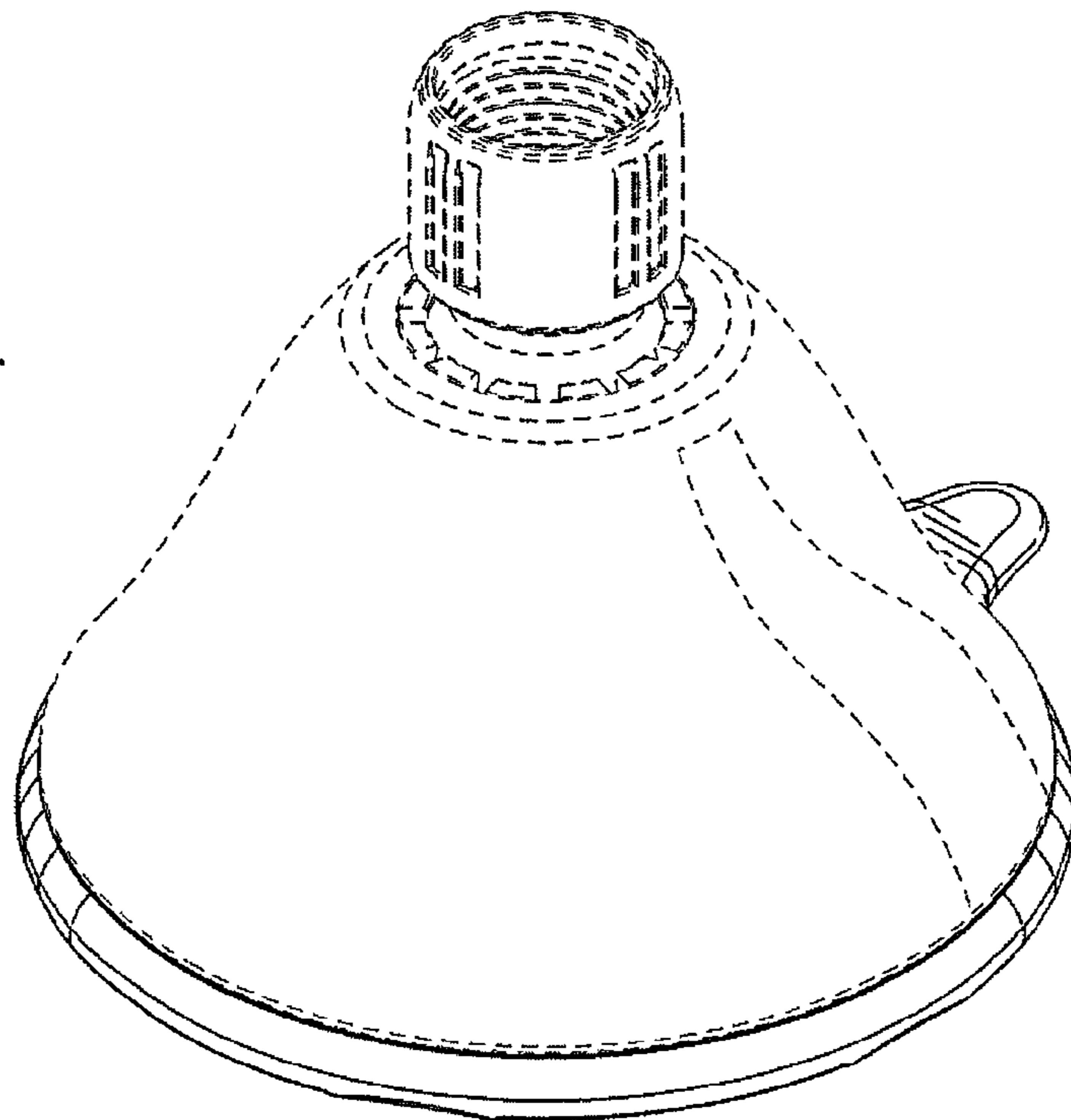

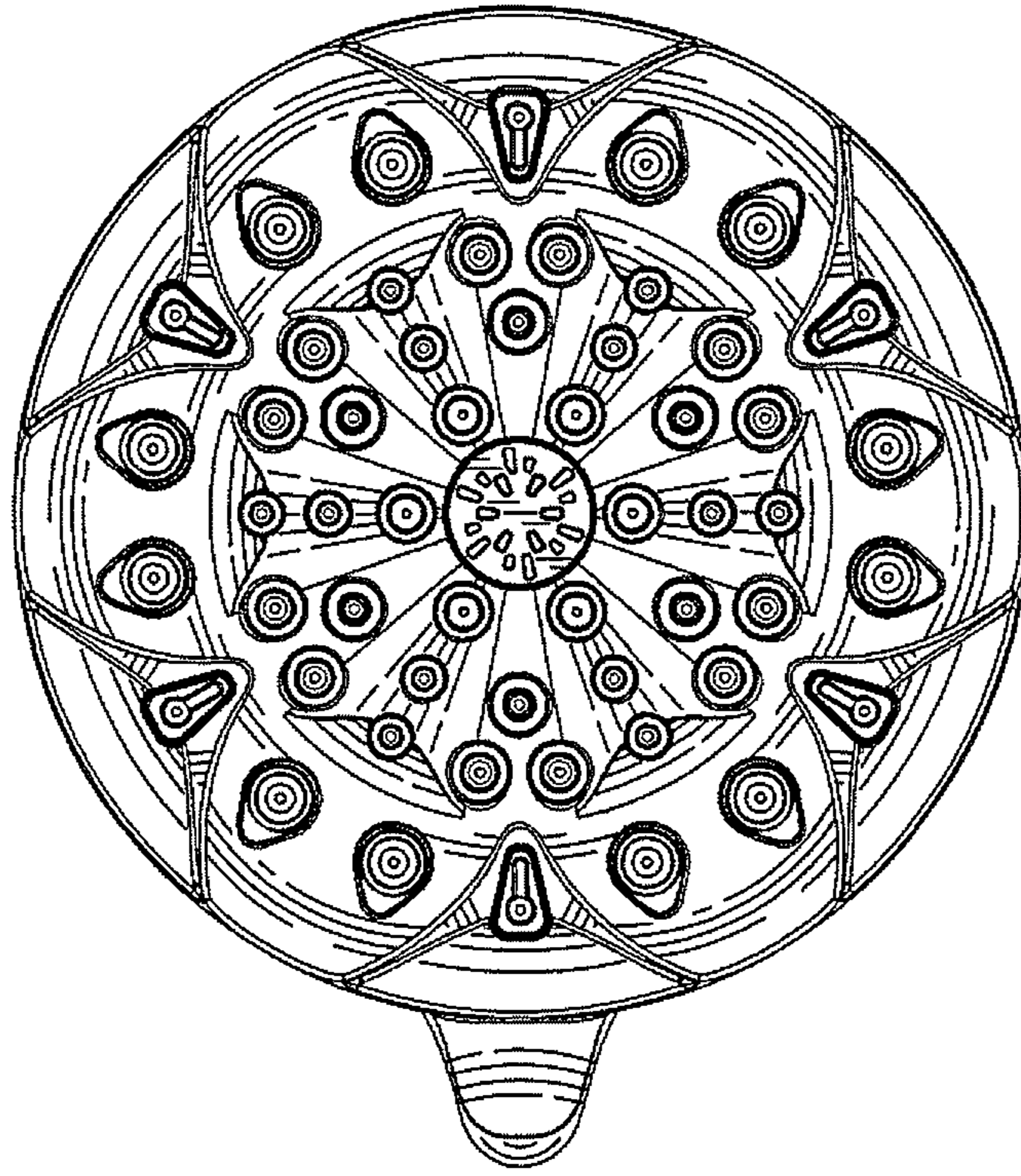

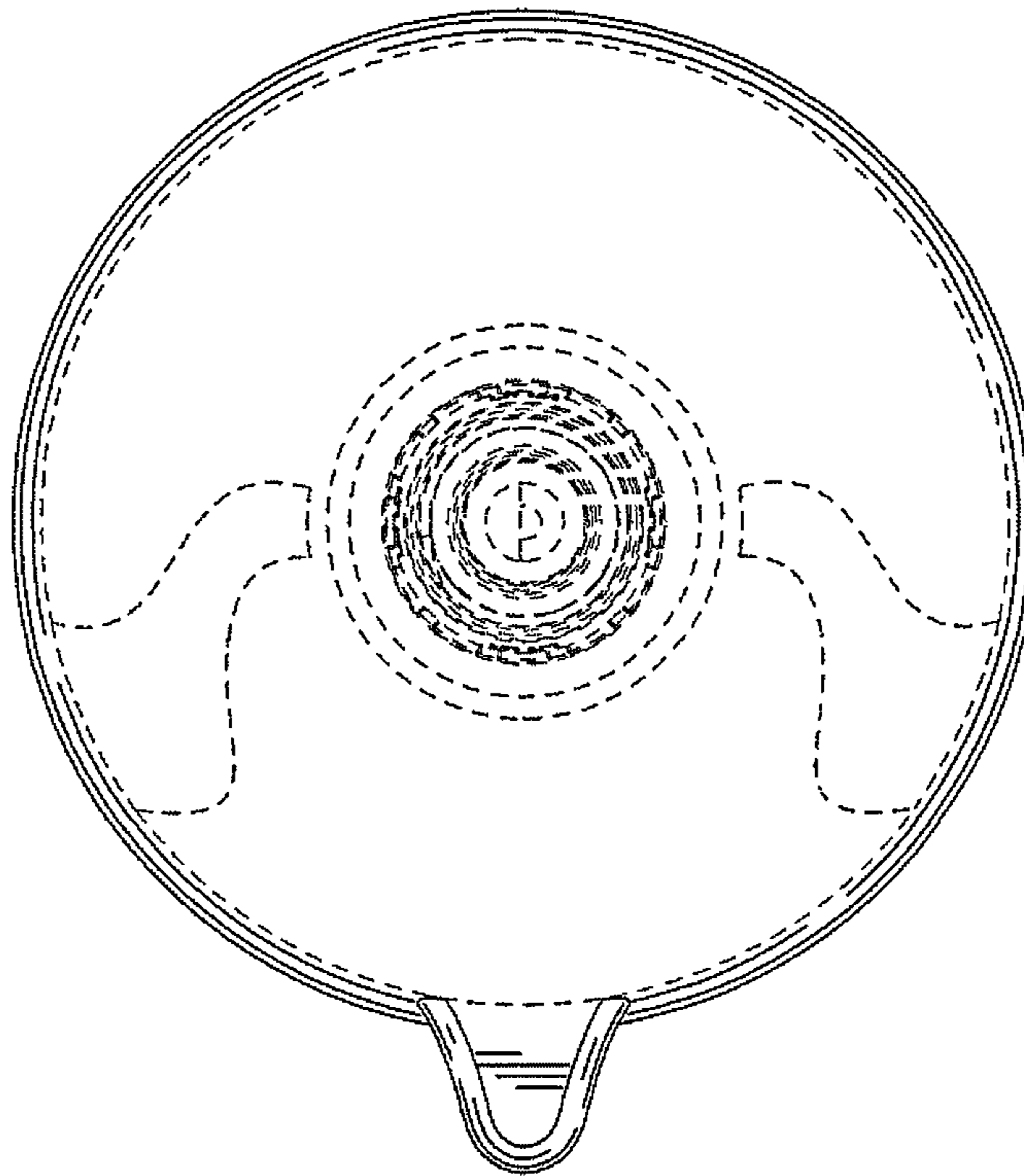

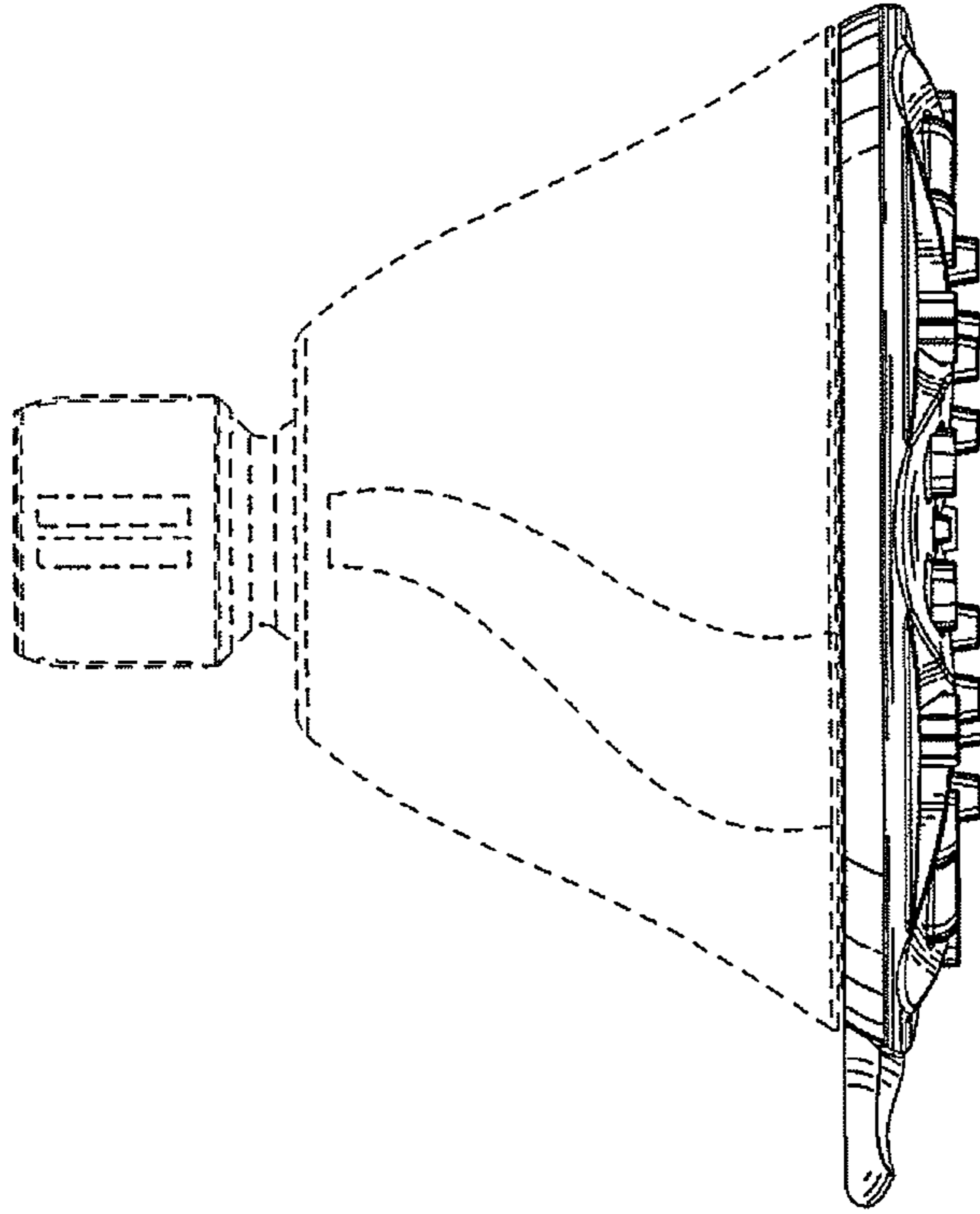

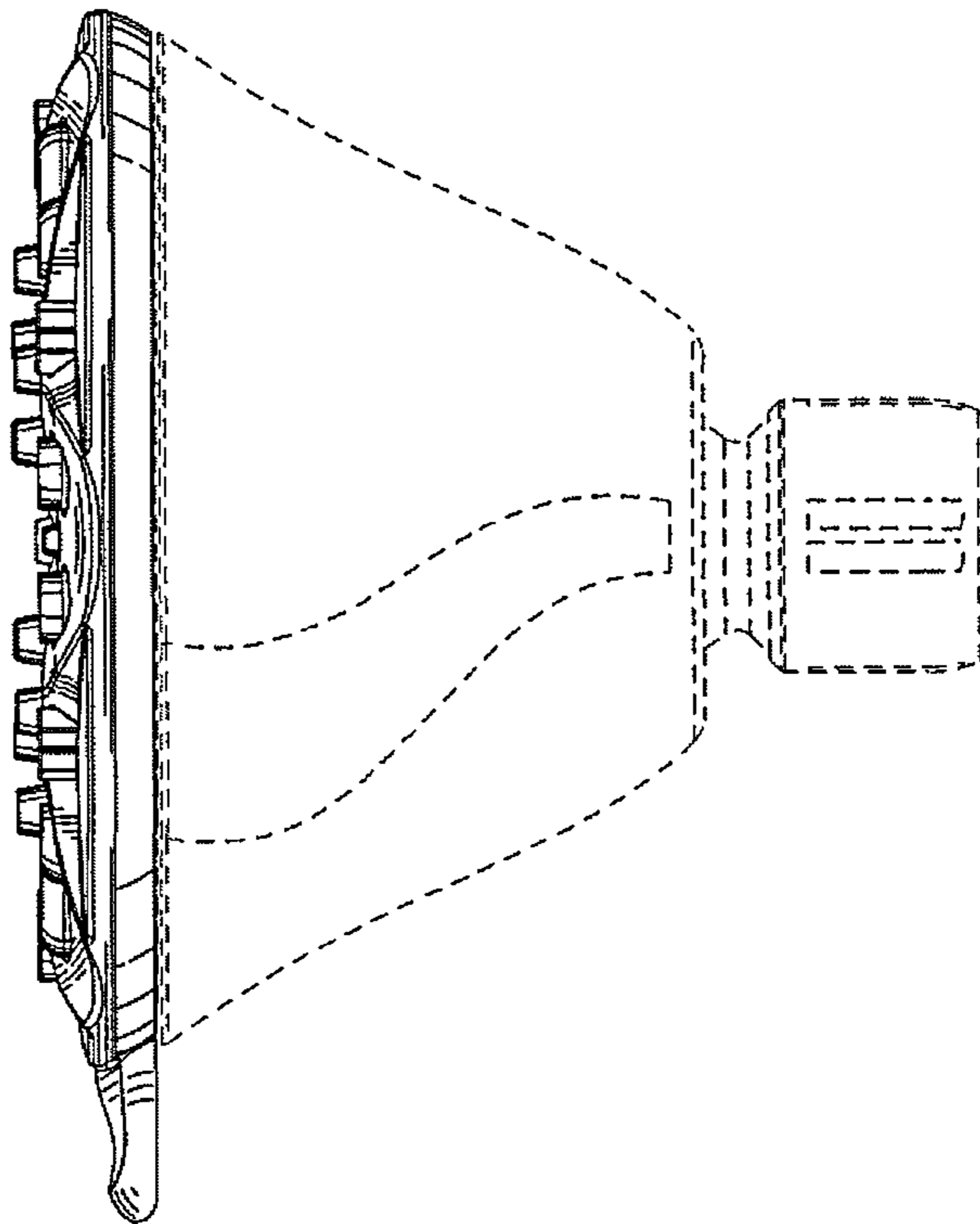

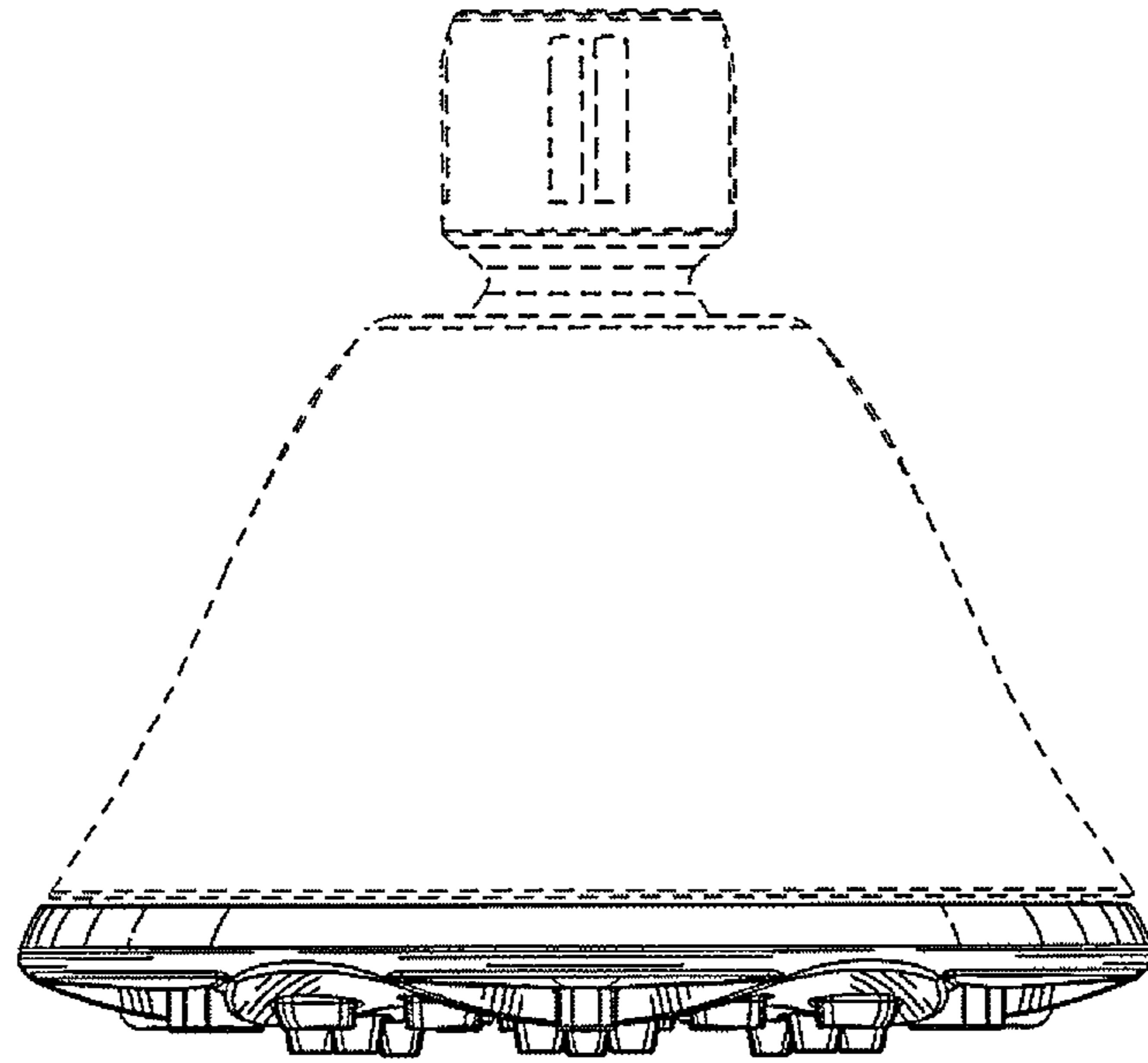

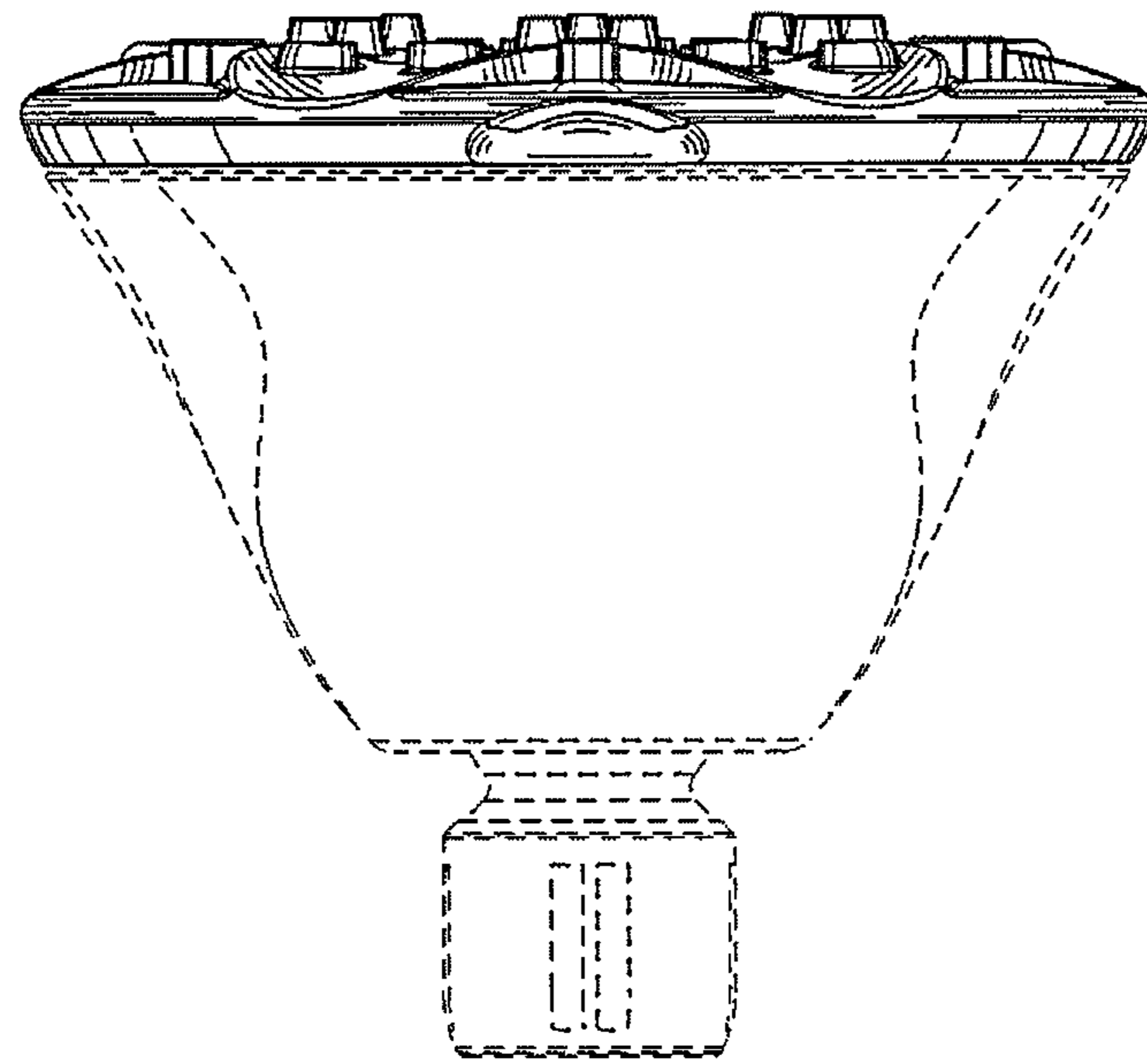

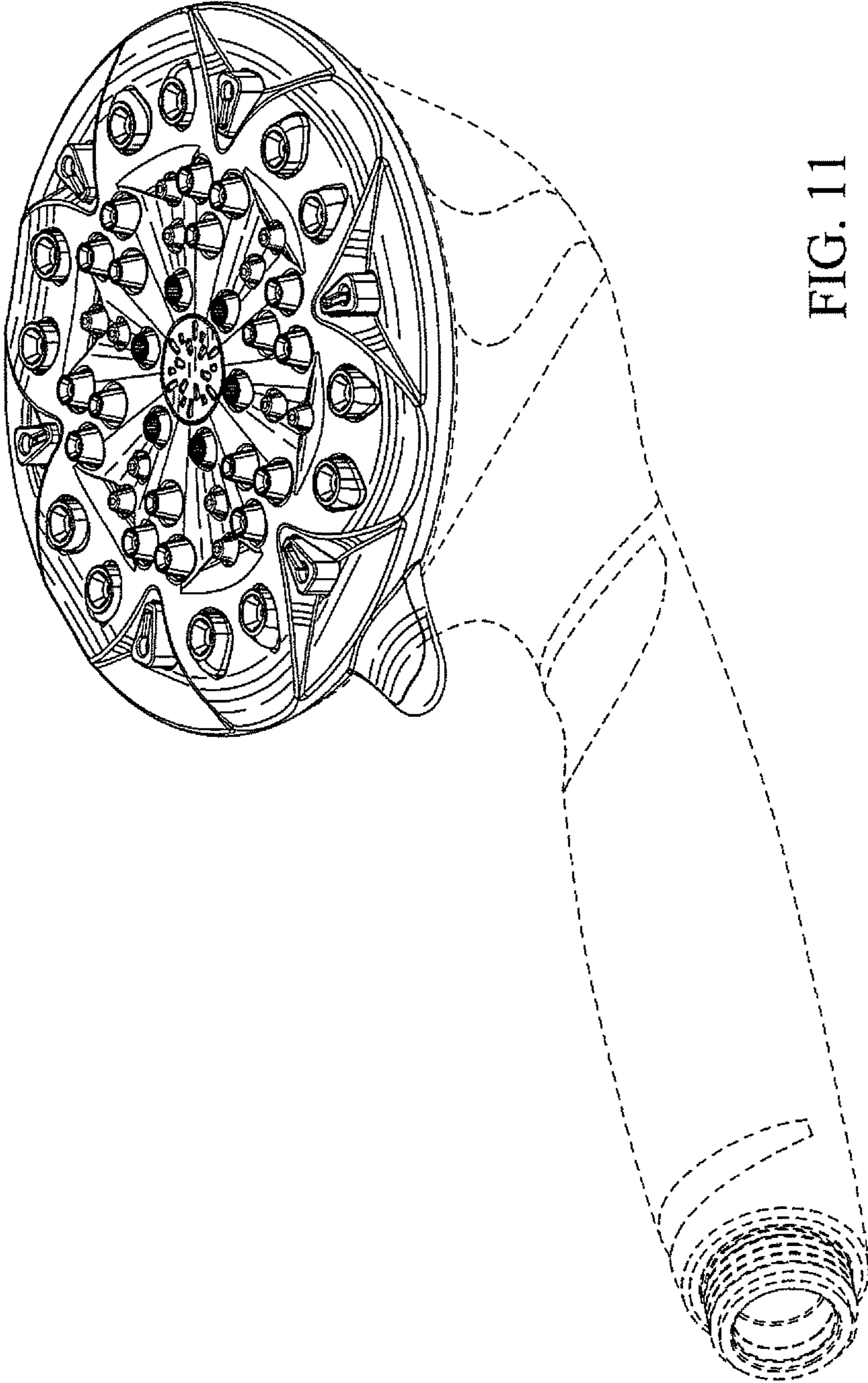

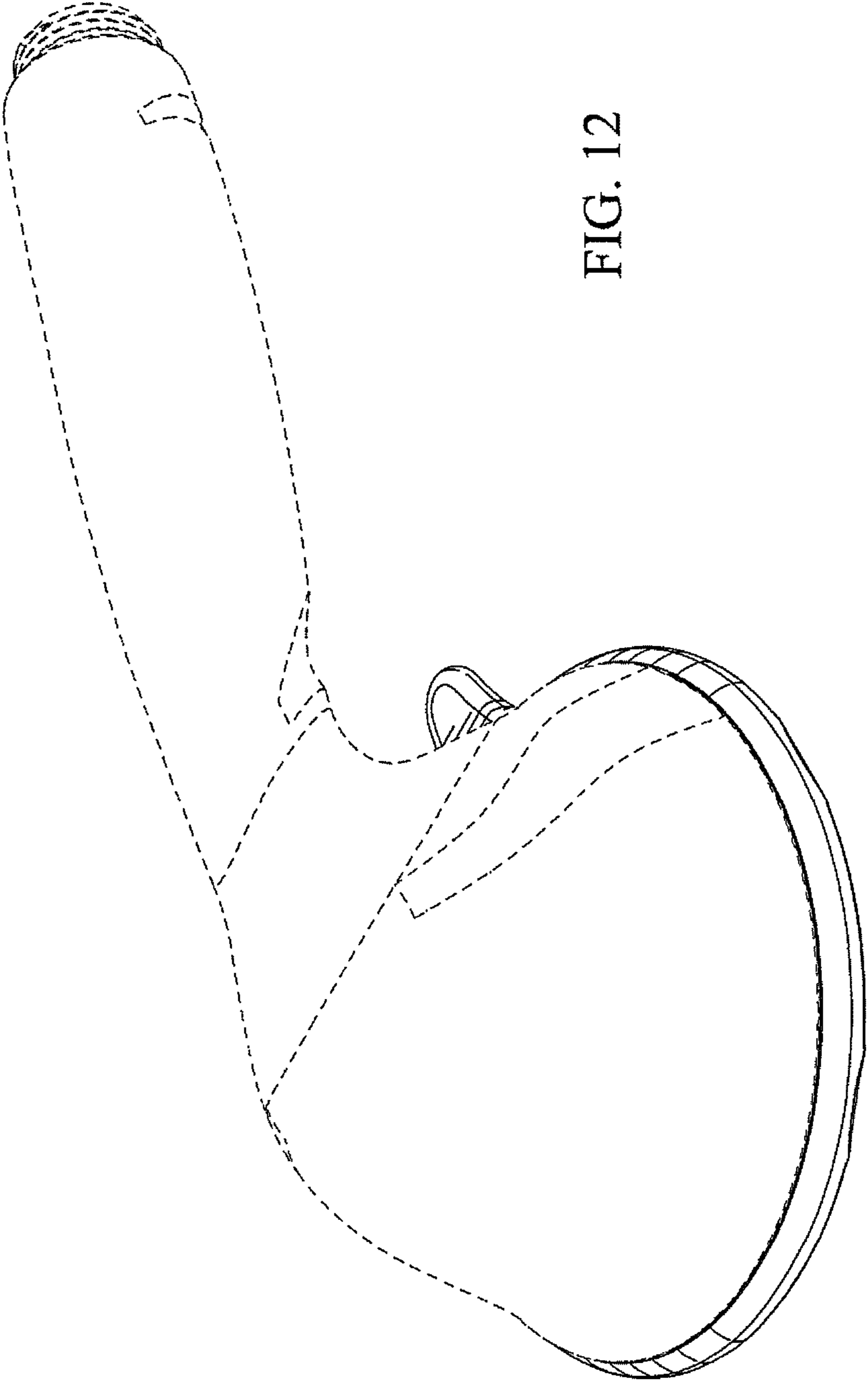

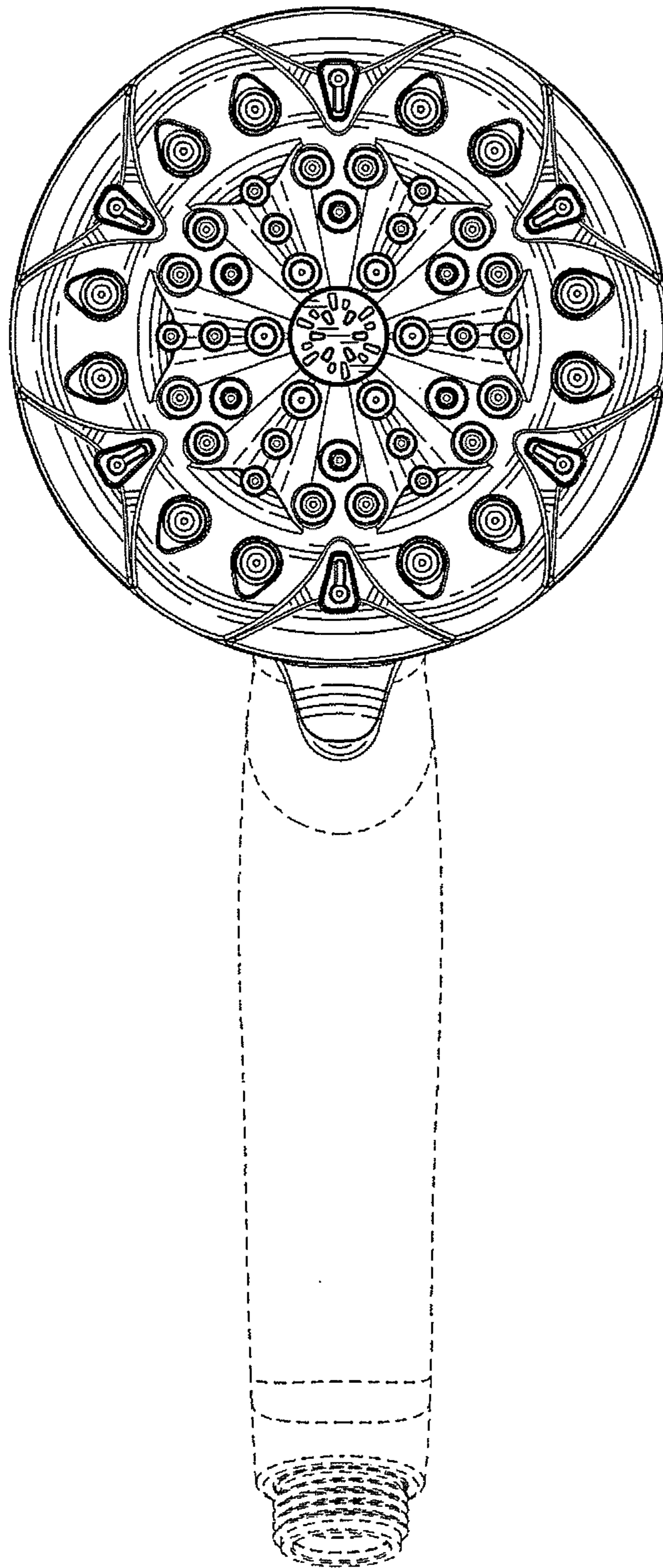

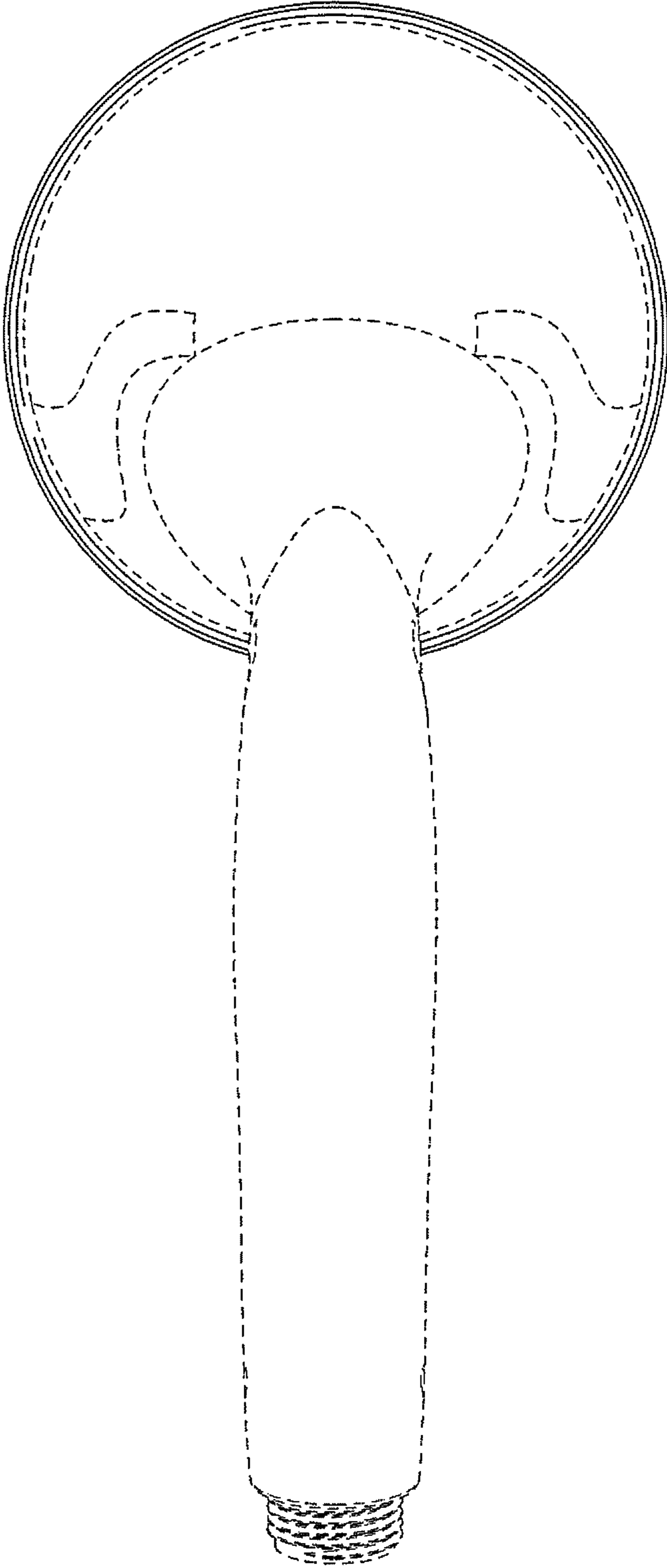

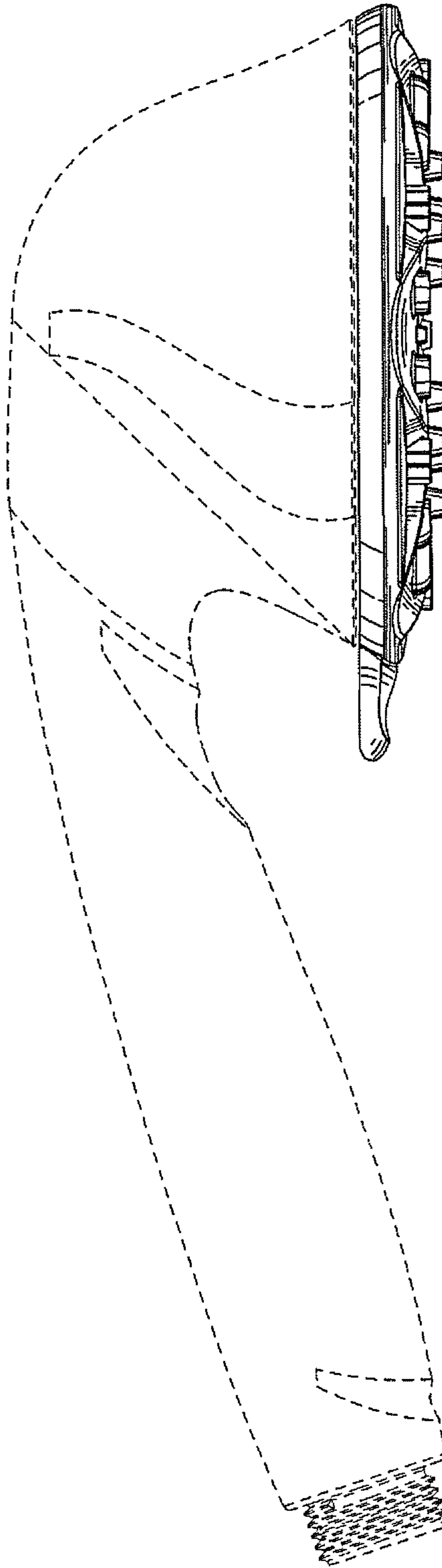

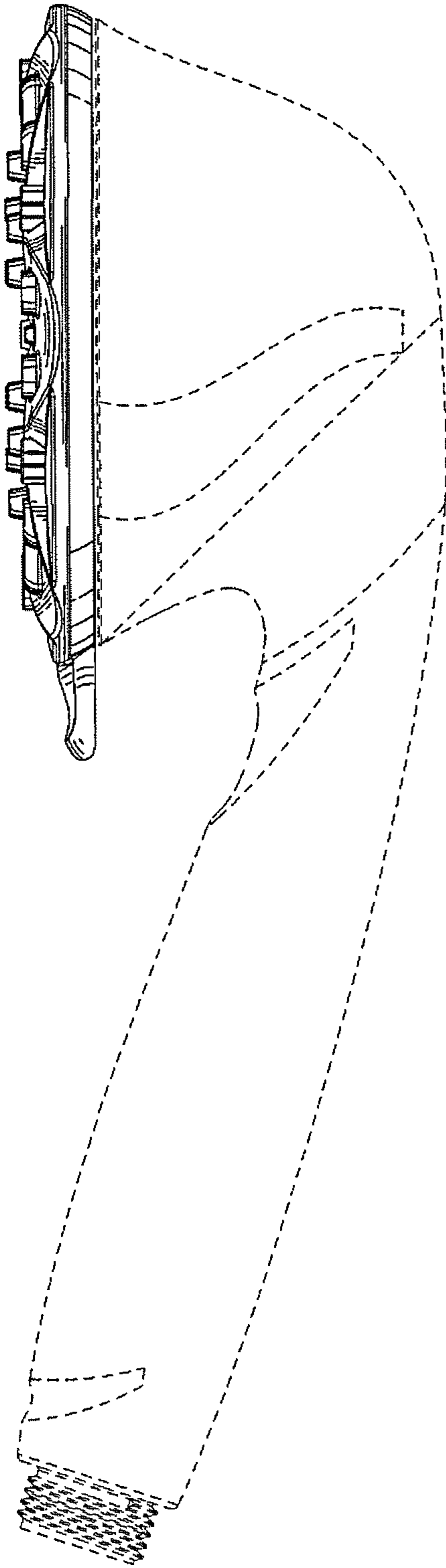

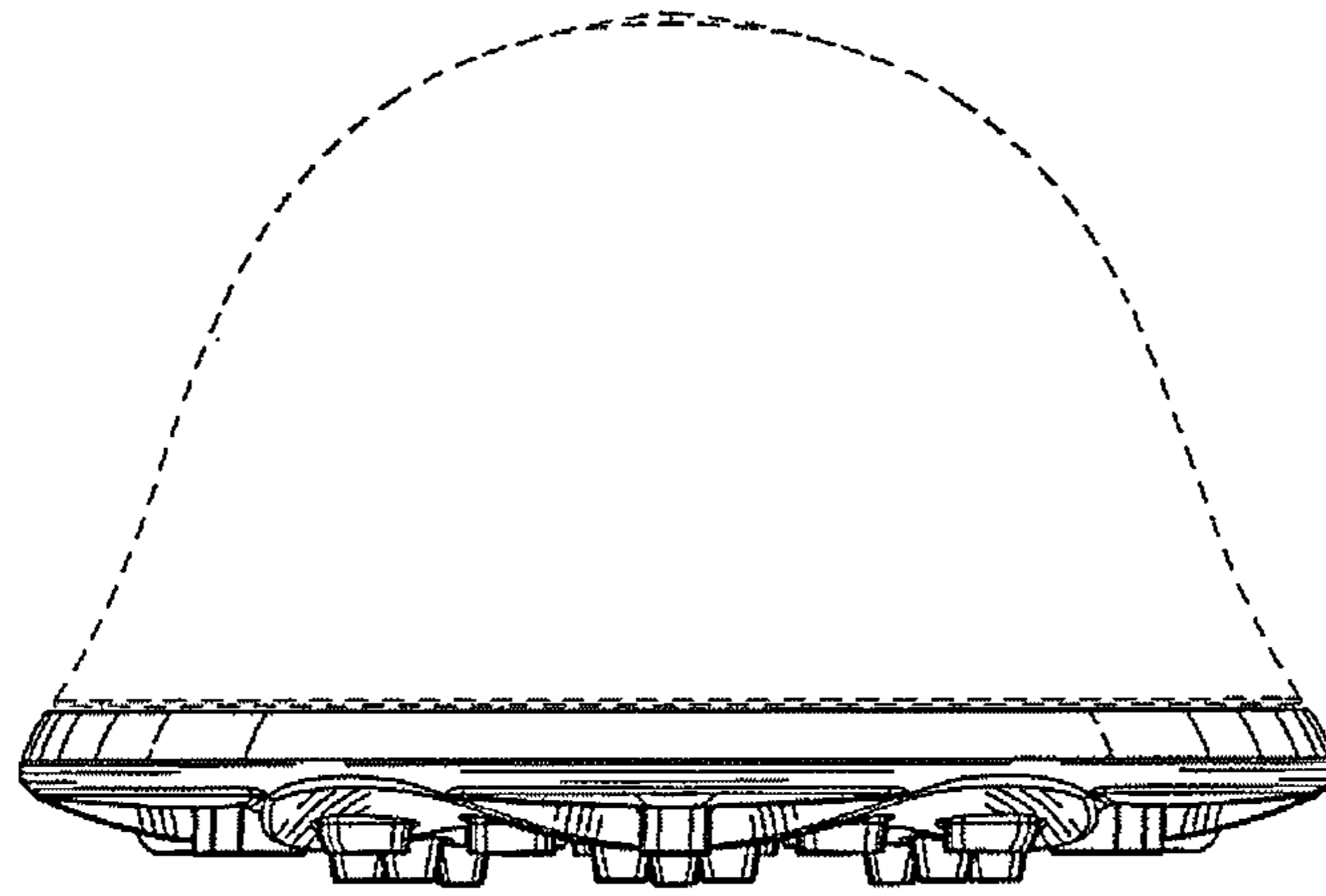

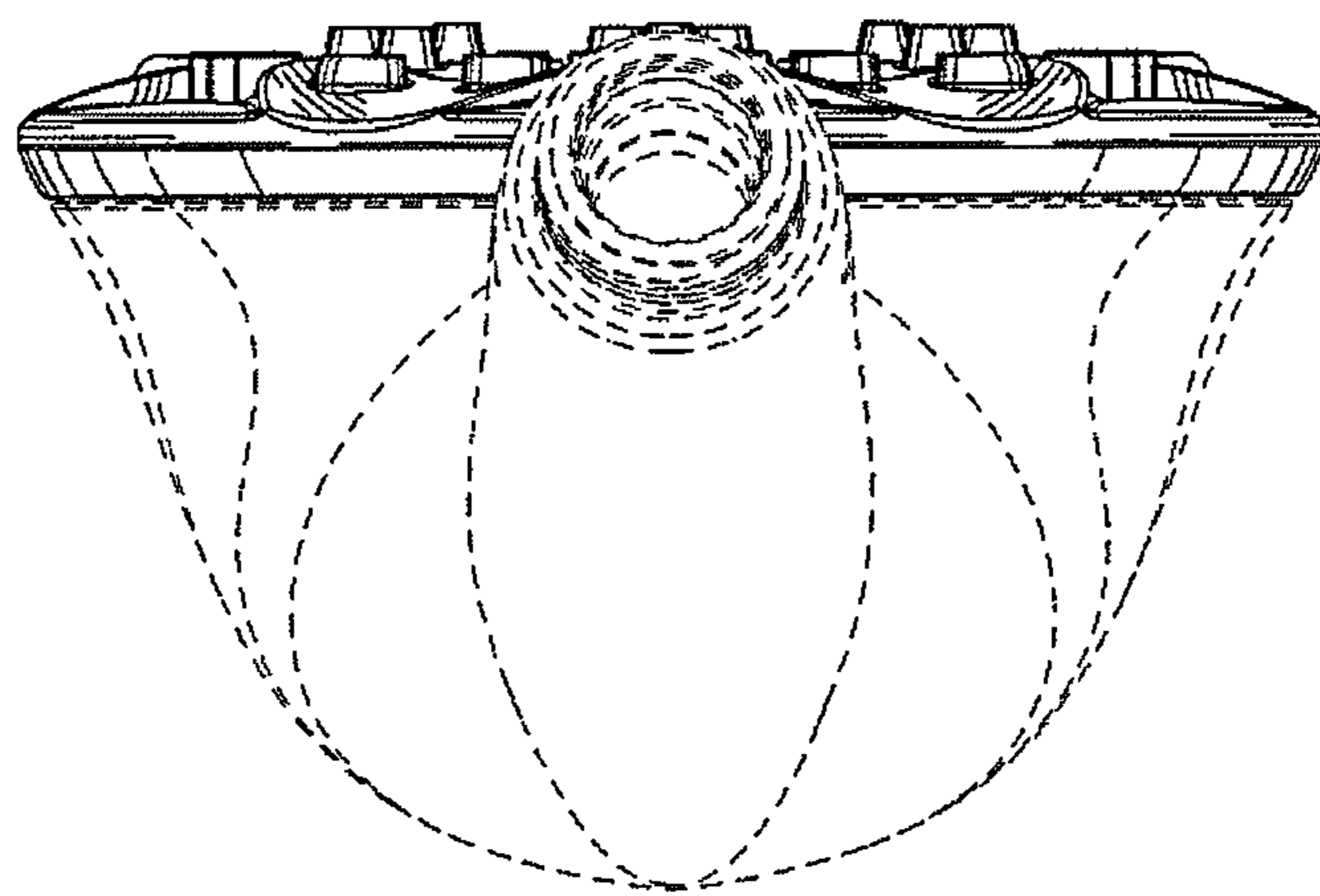
