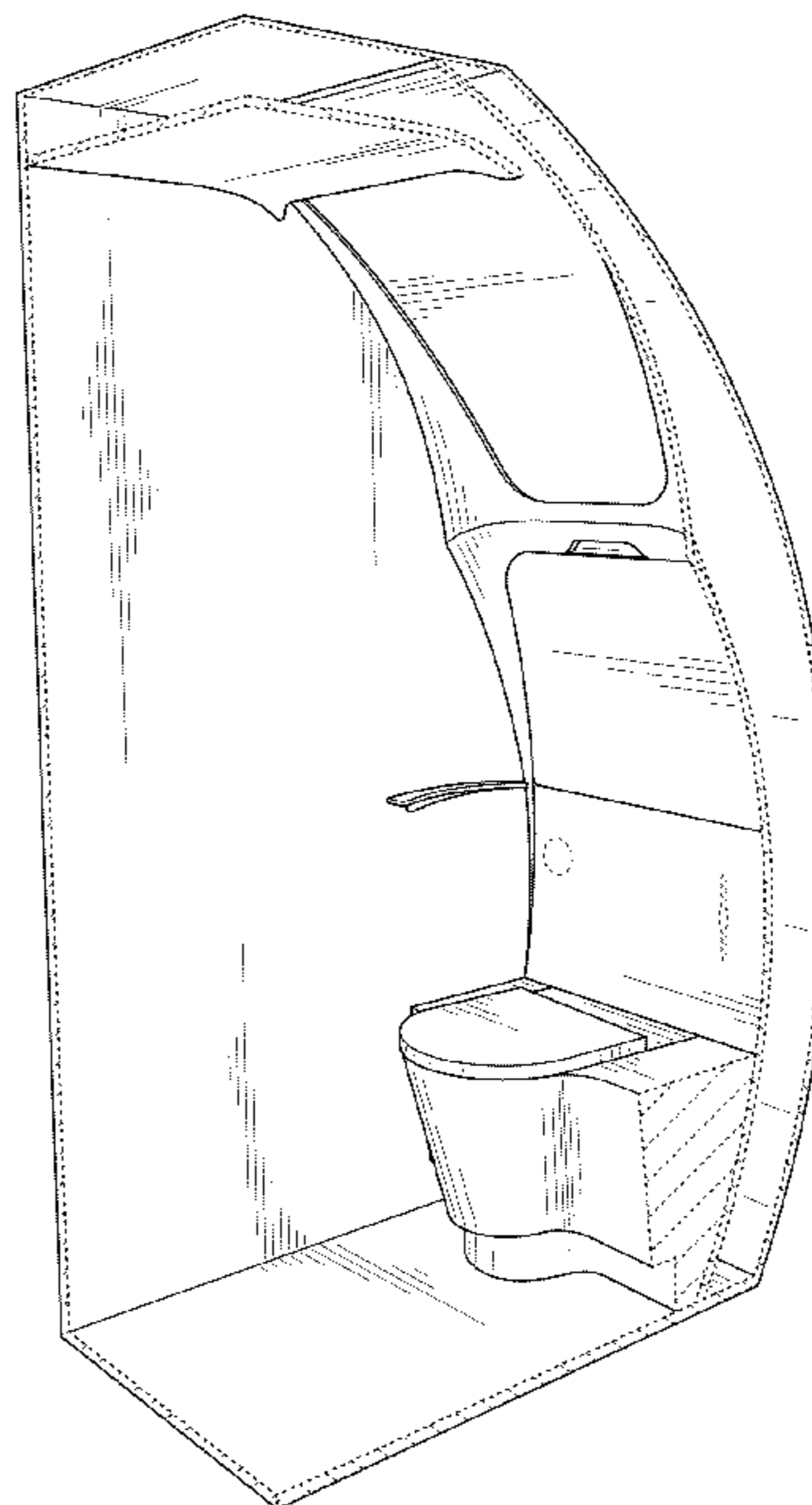
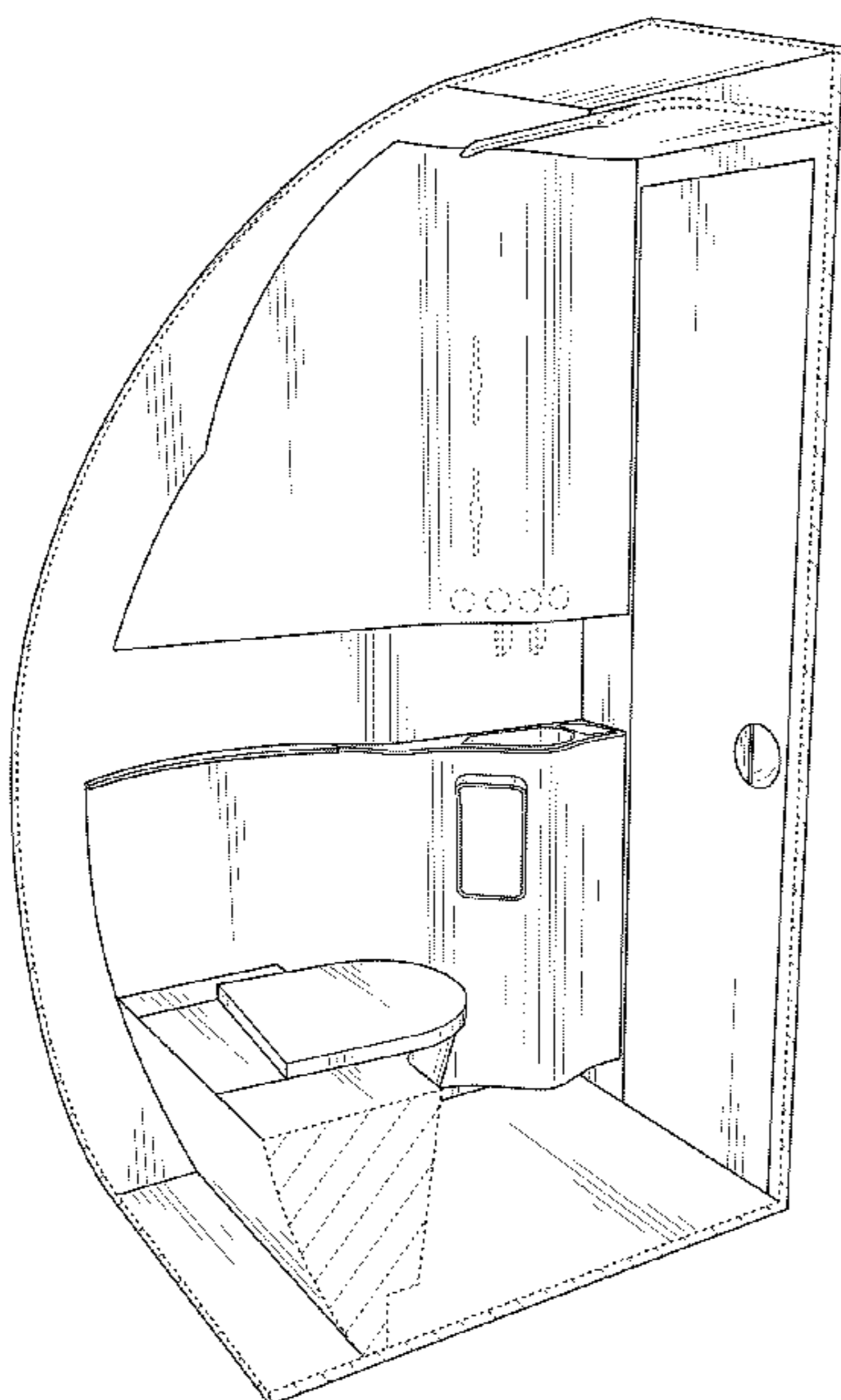
The ornamental design for a toilet unit, as shown and described.

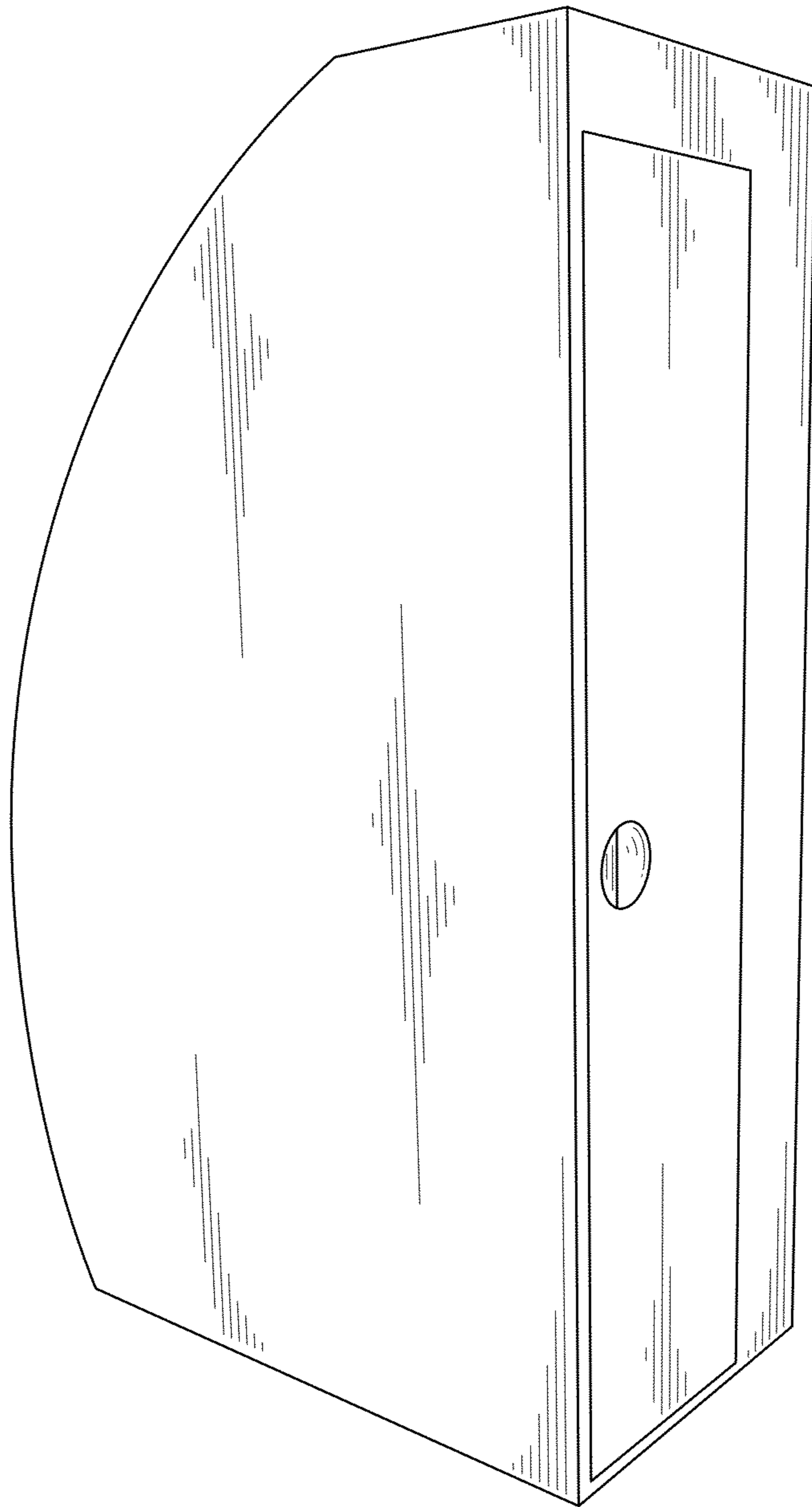

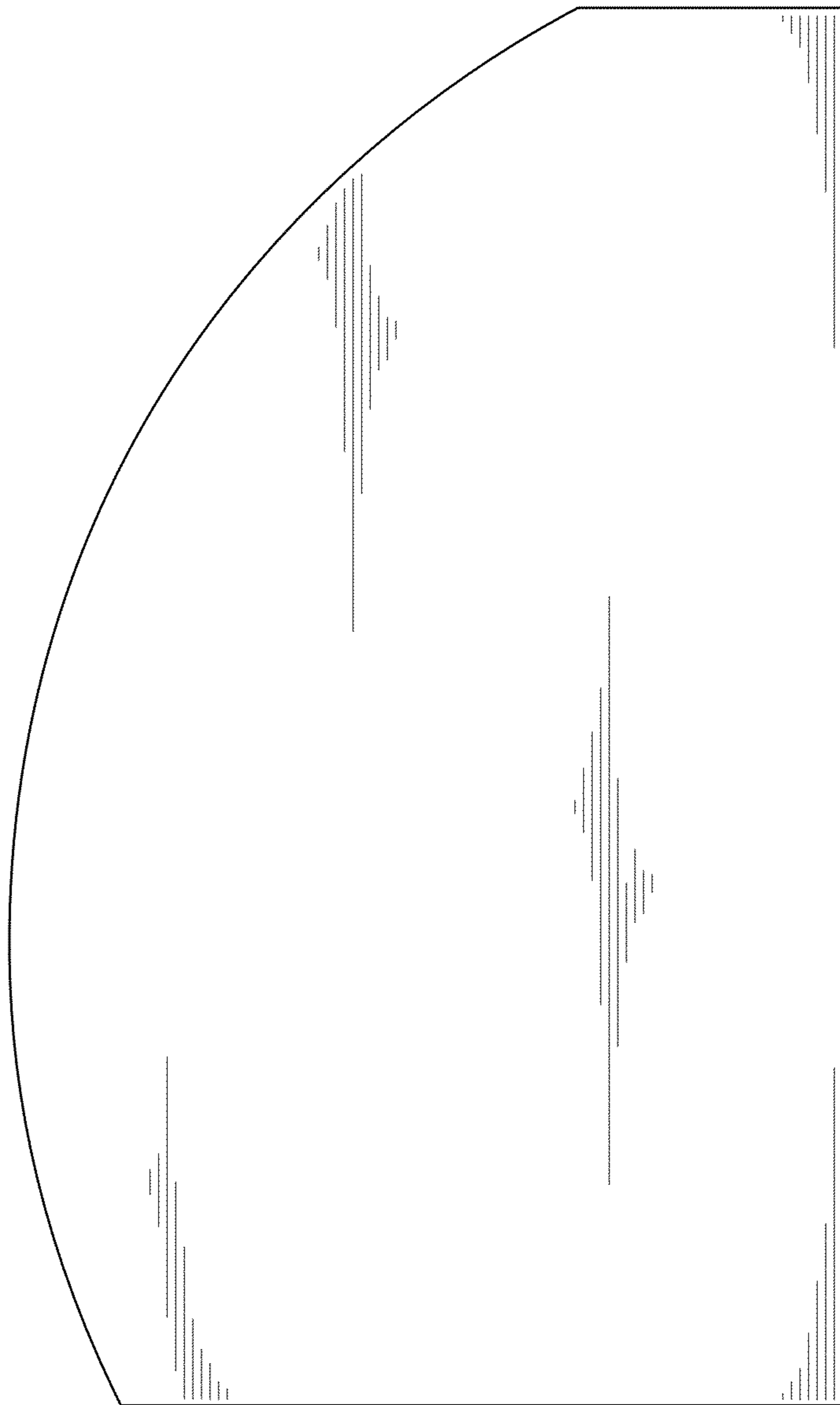

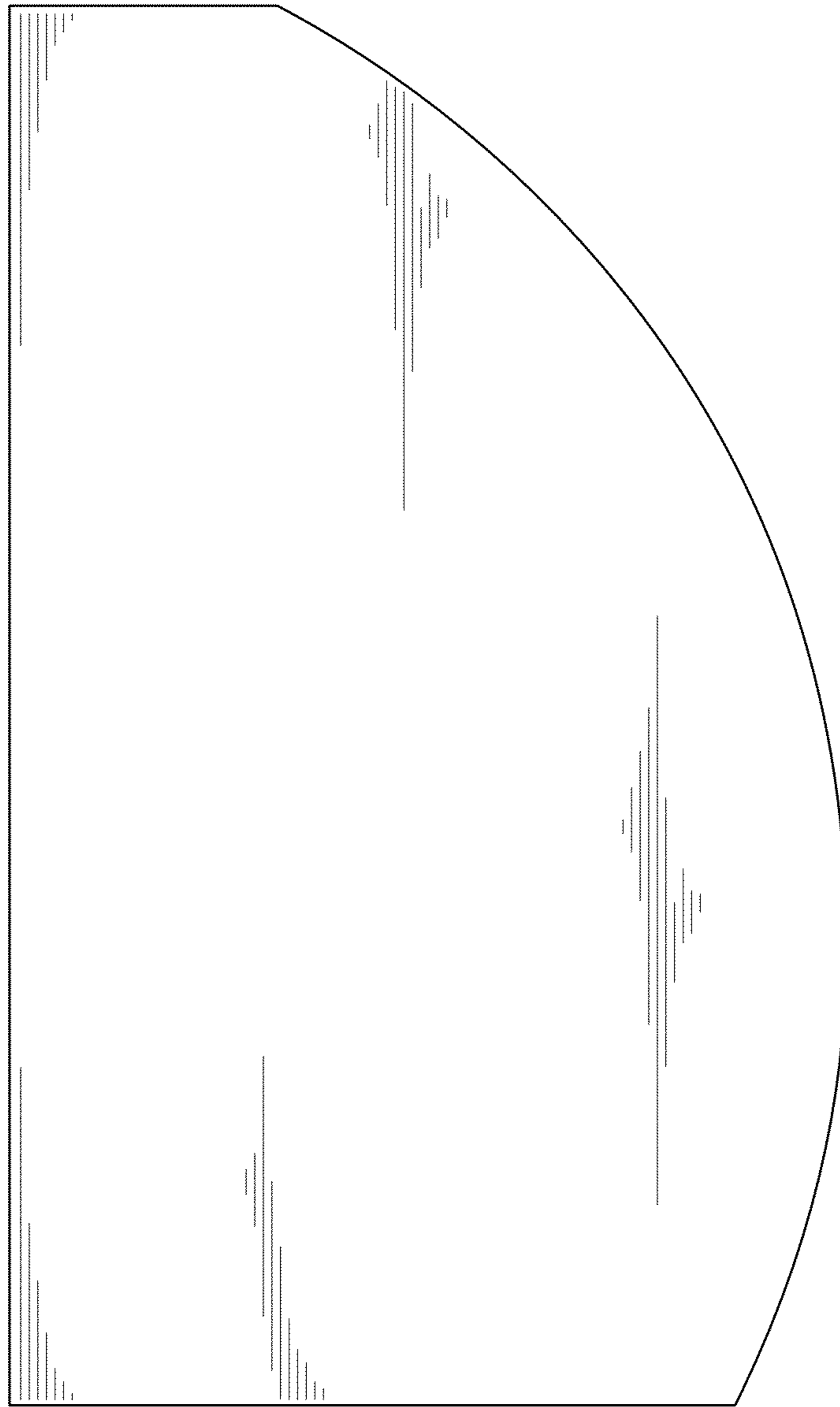

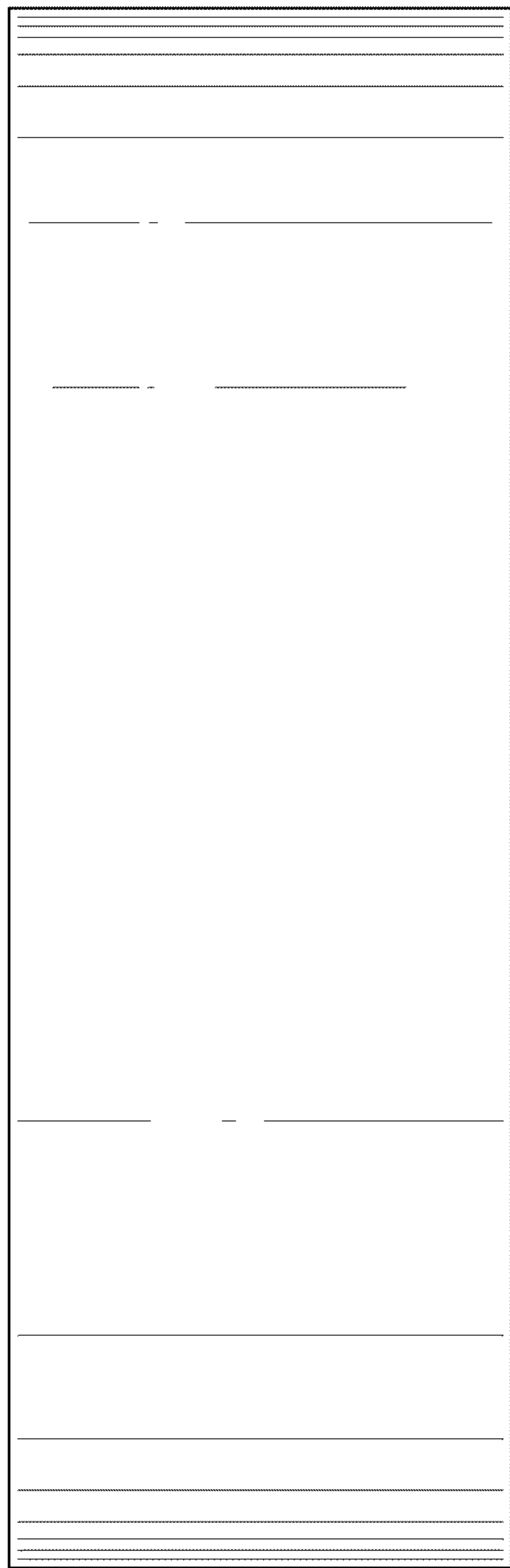

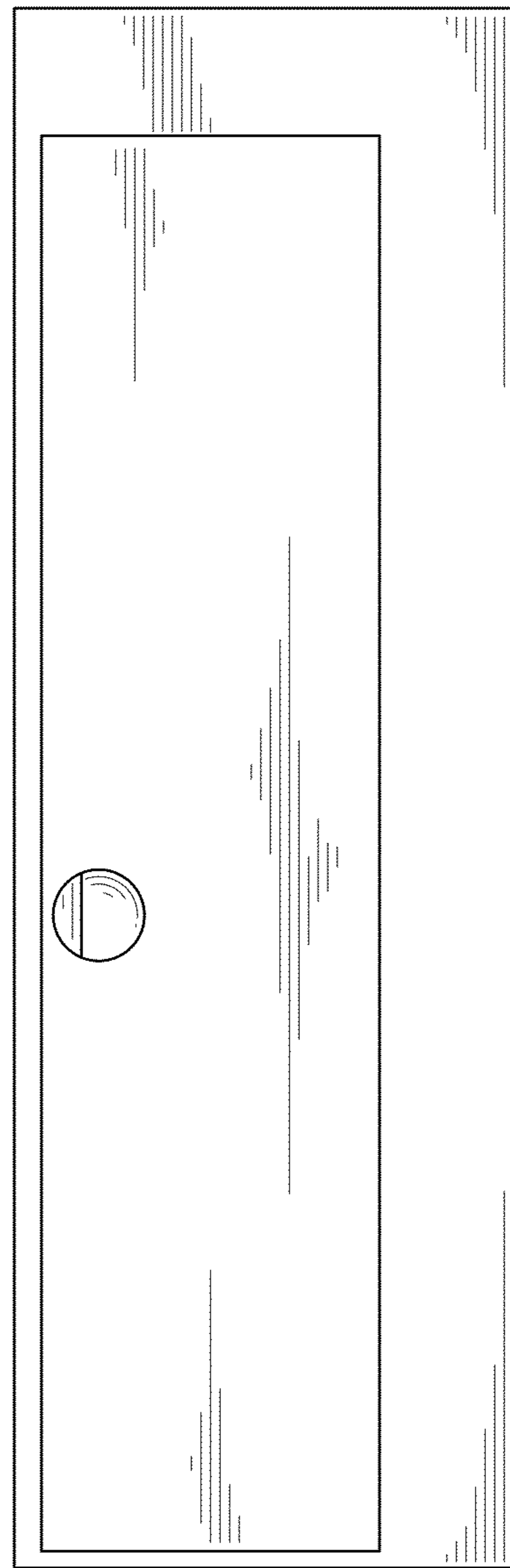

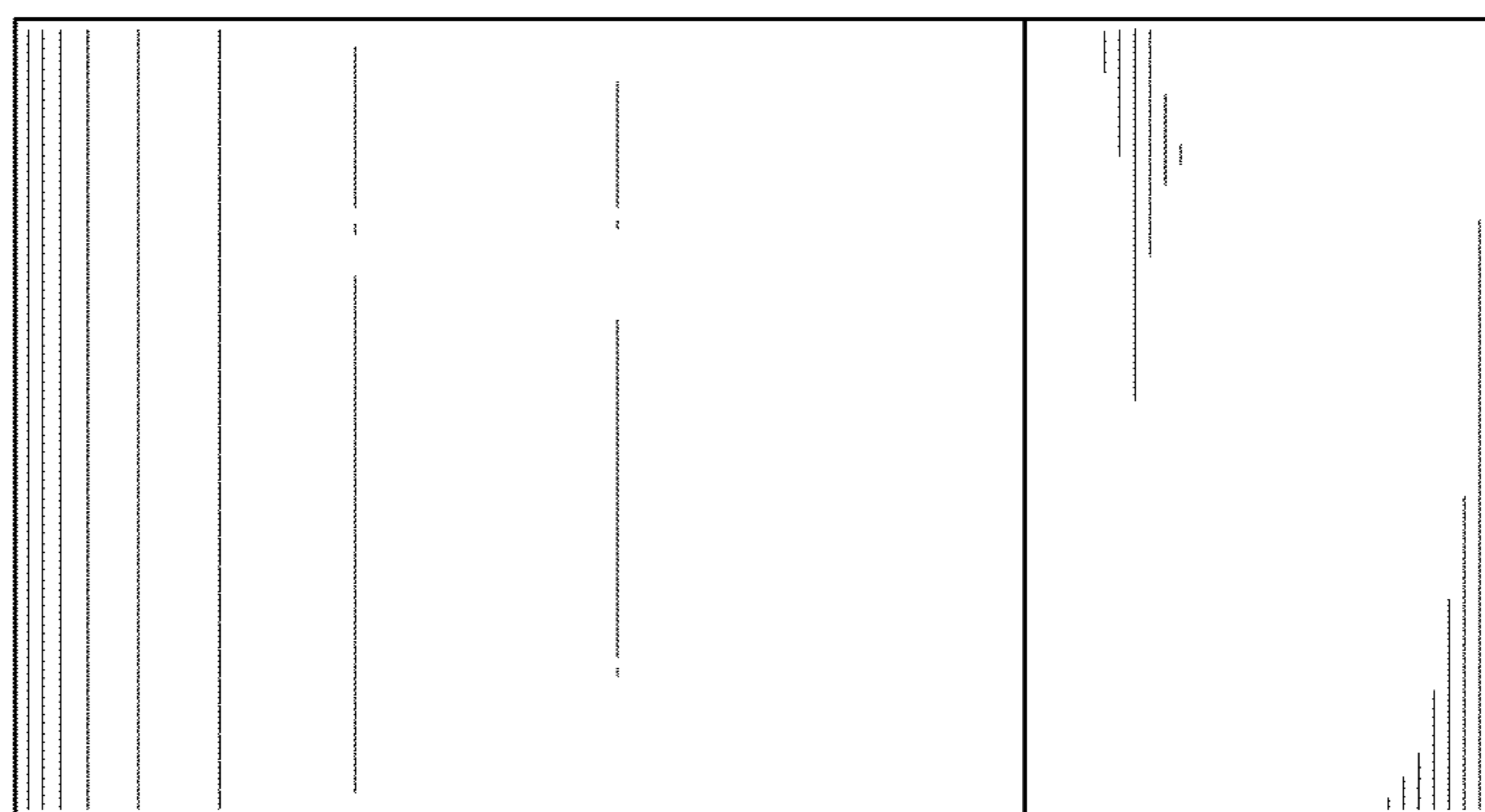

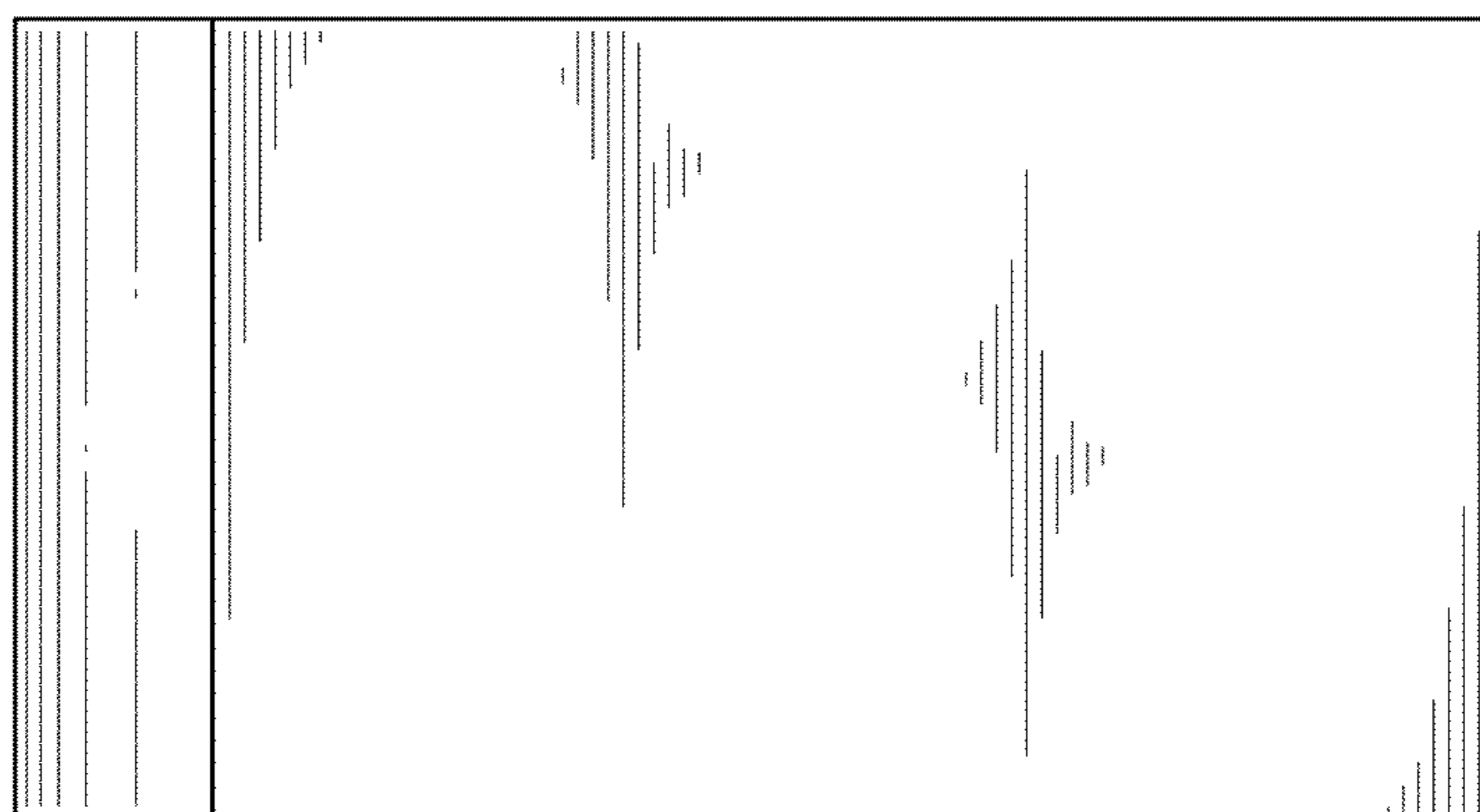

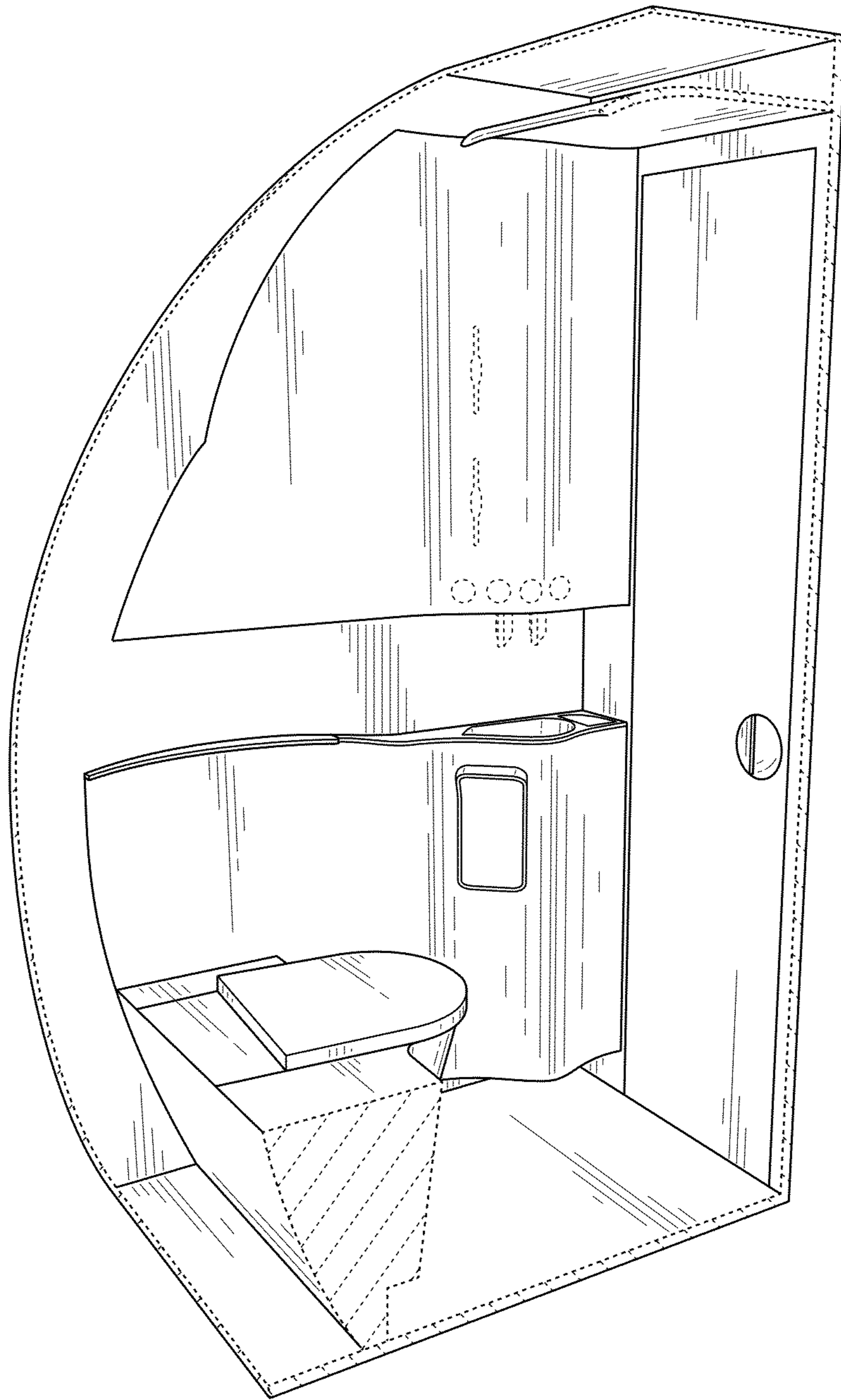

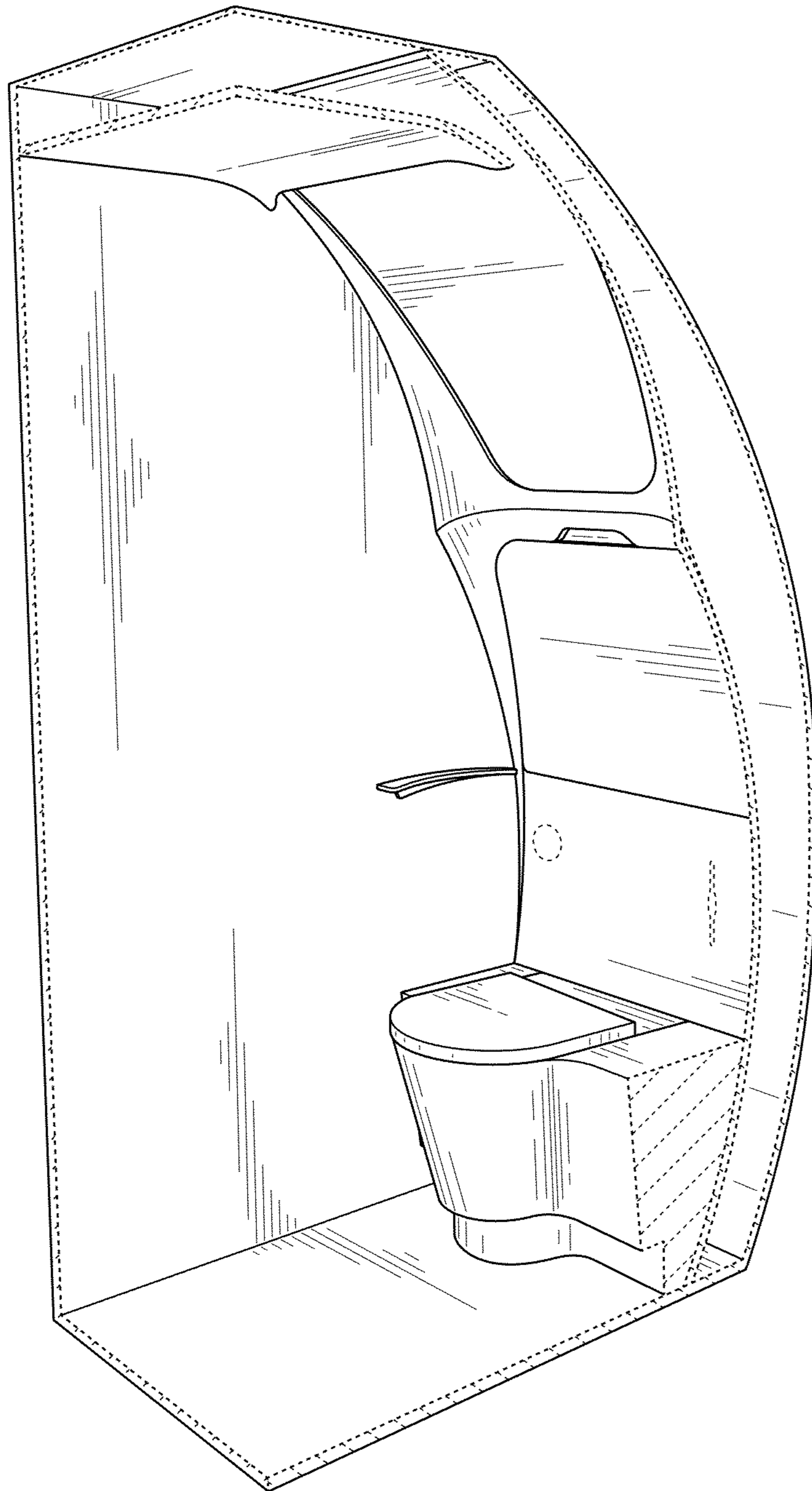
