DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of an air cleaner showing our new design;

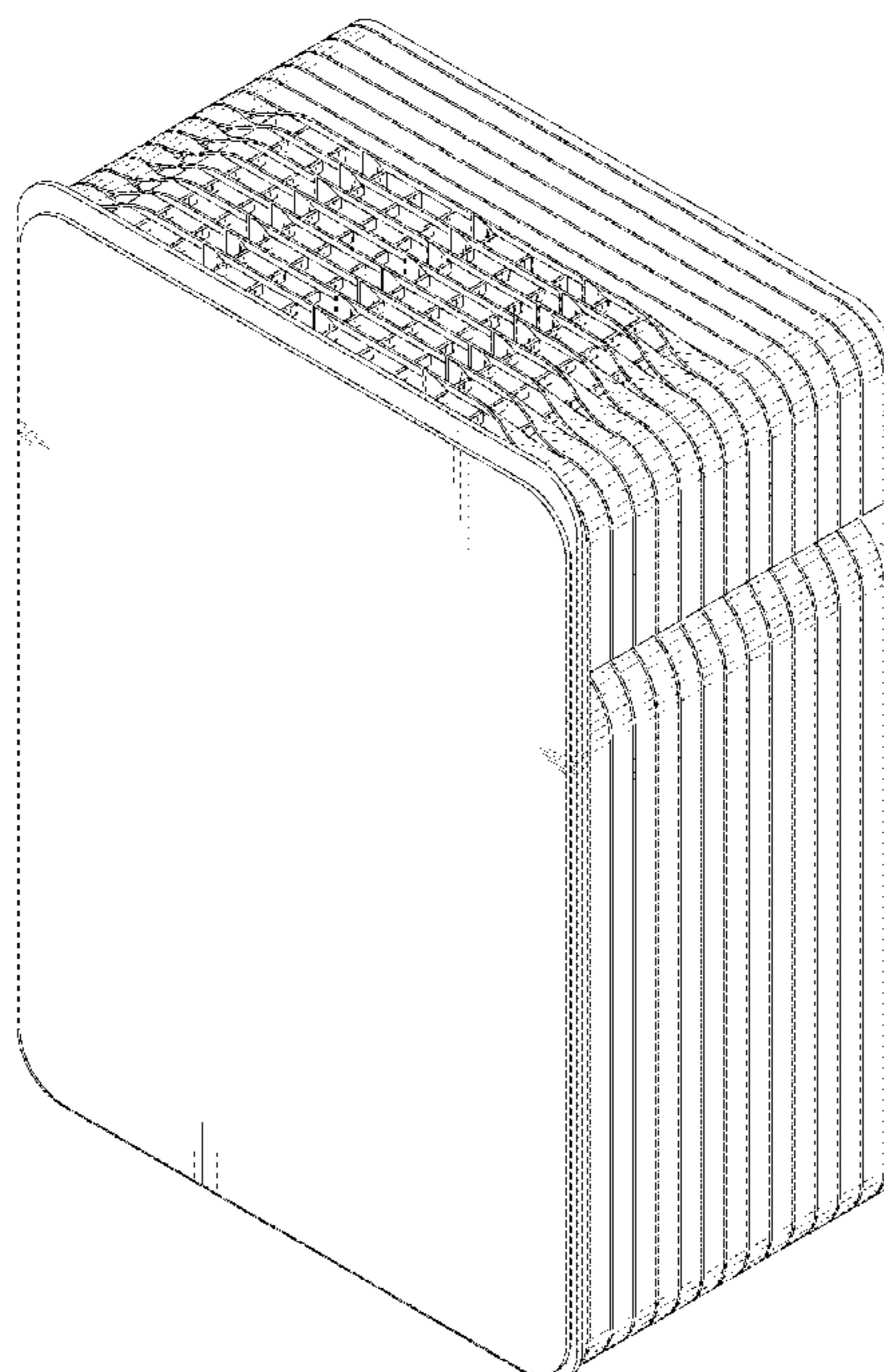

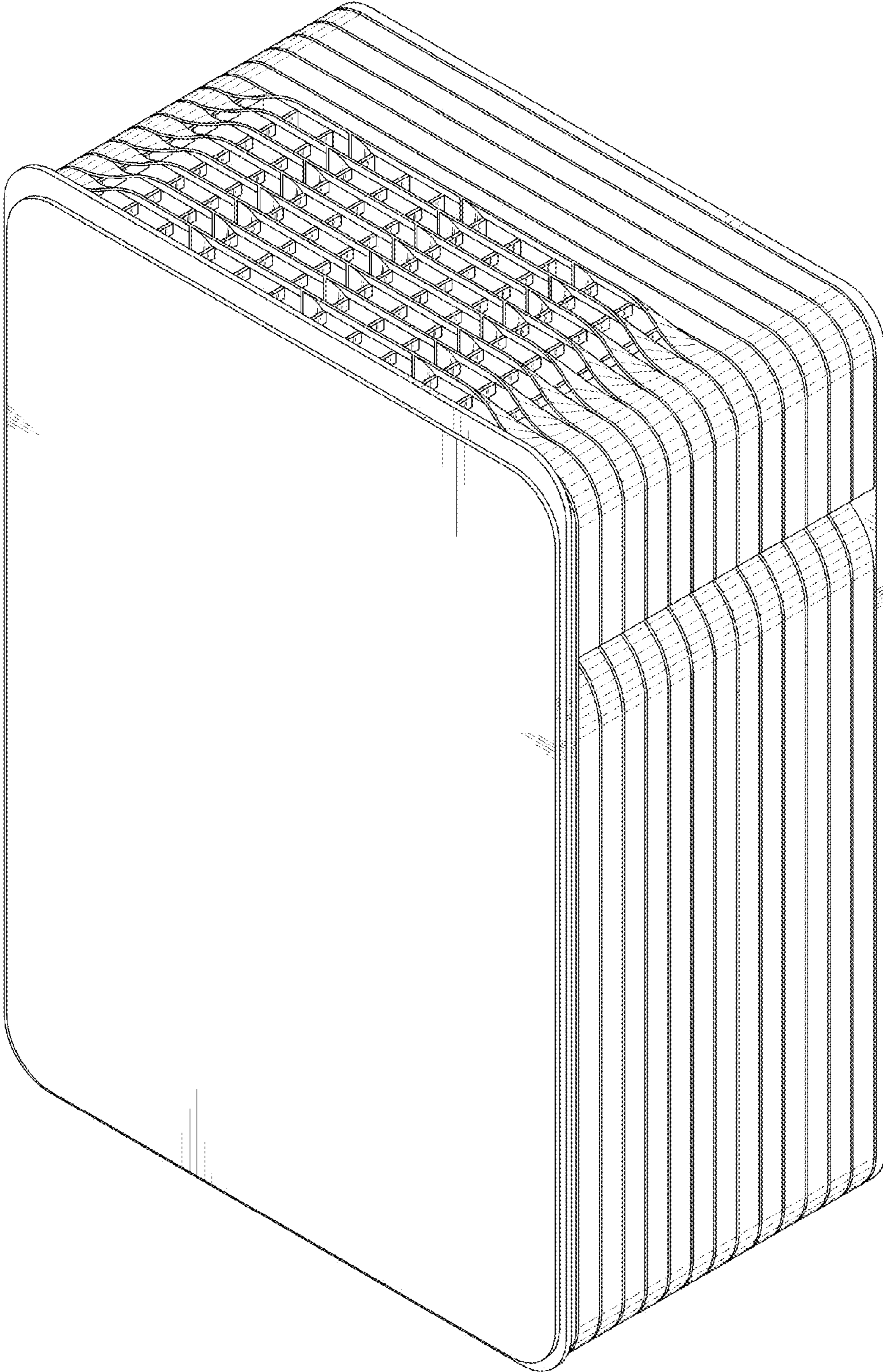

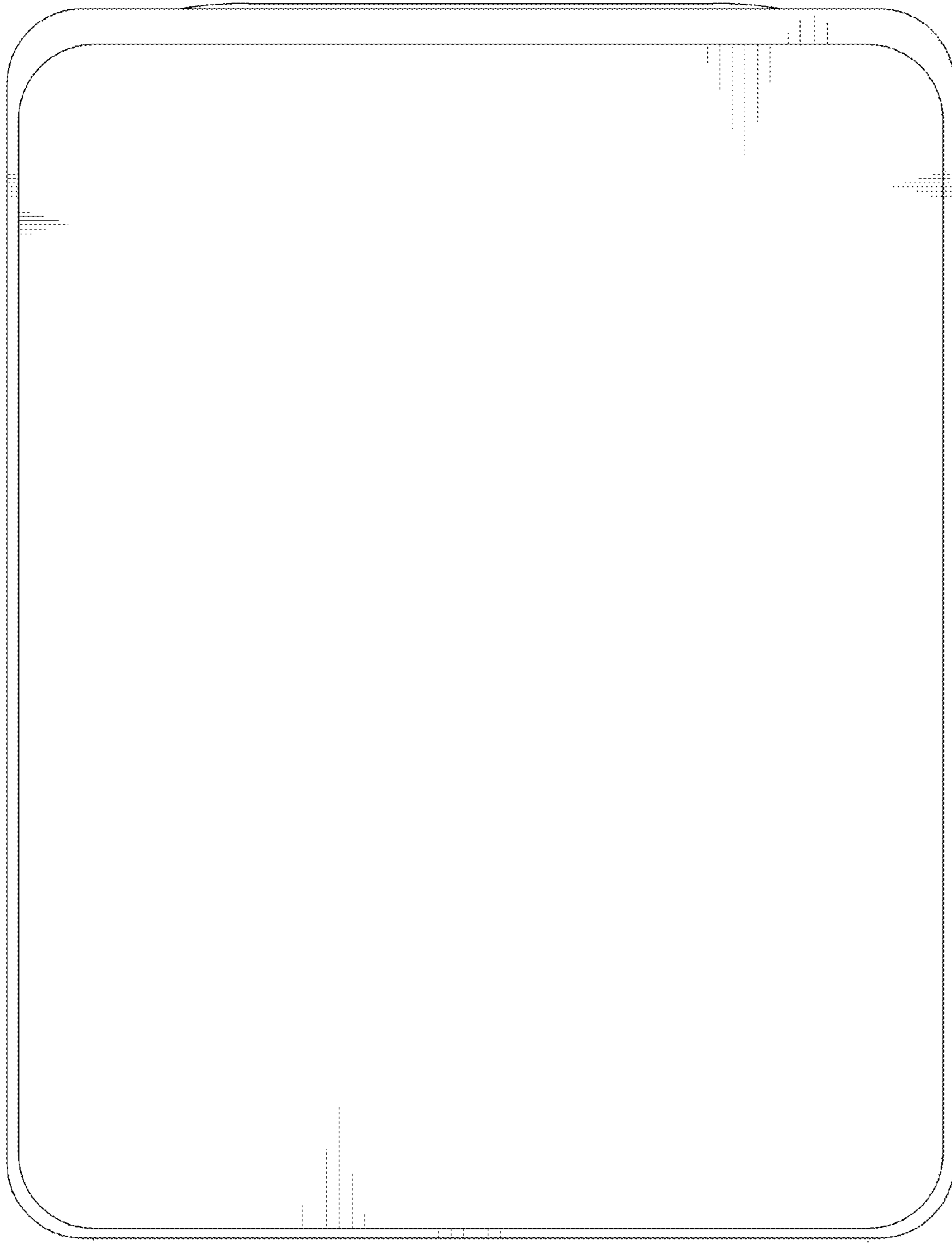

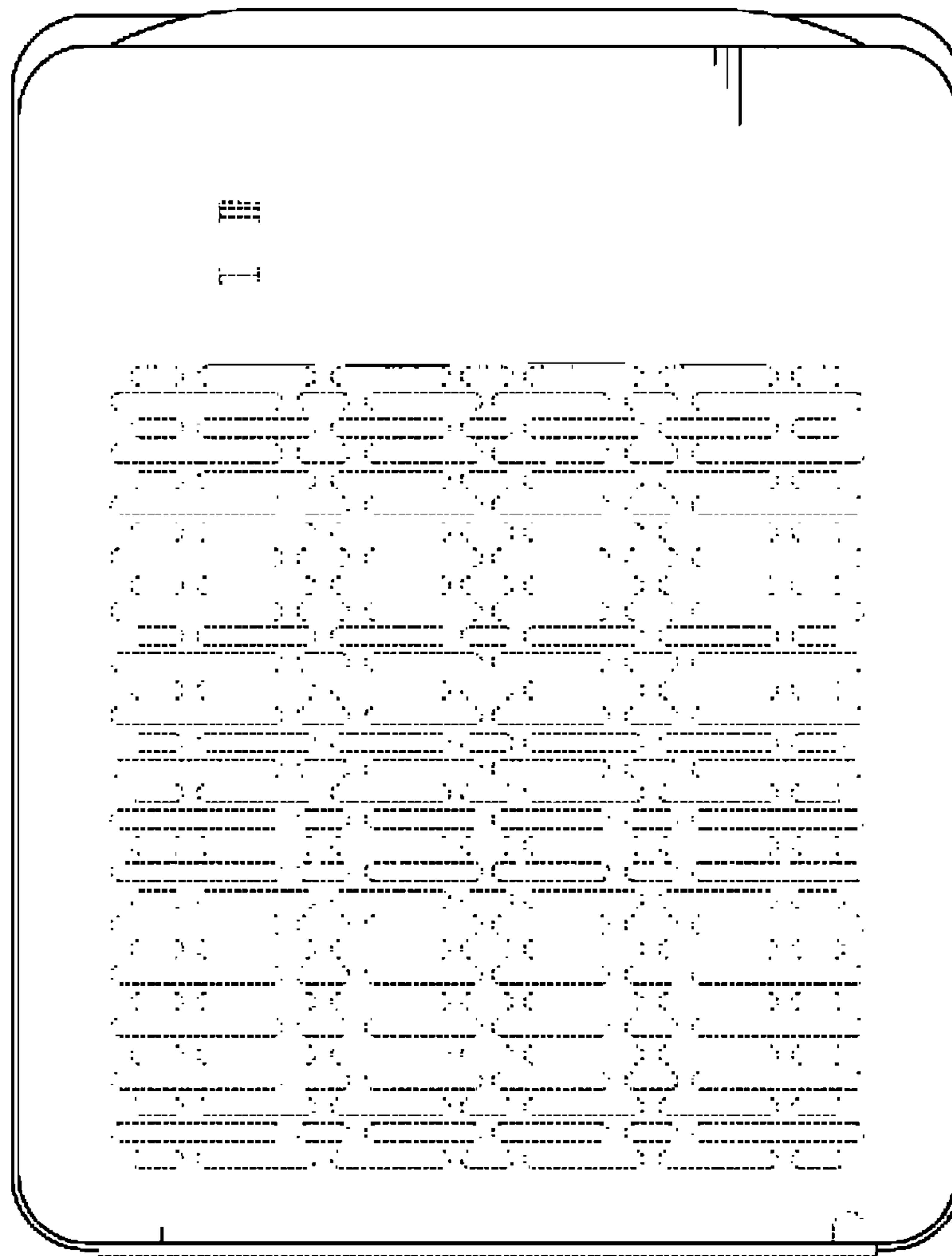

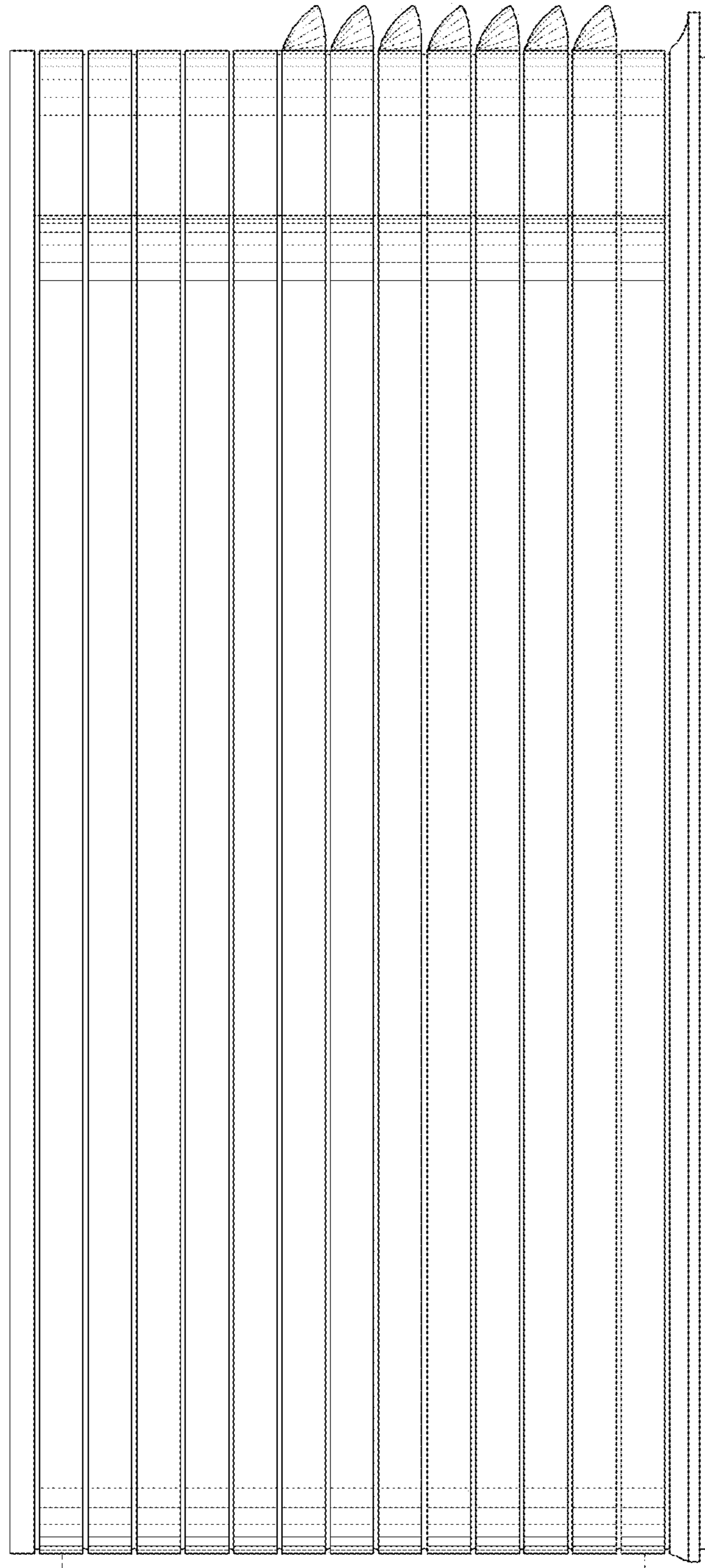

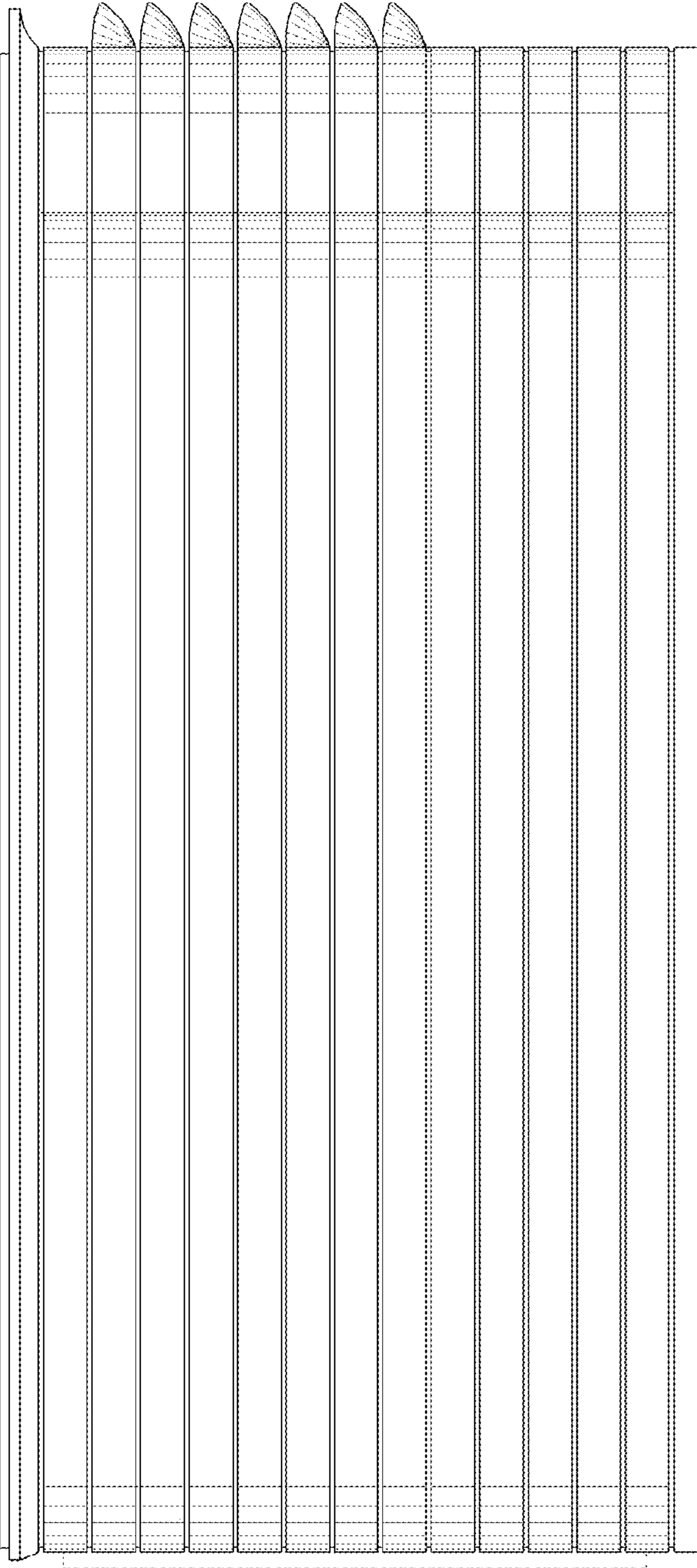

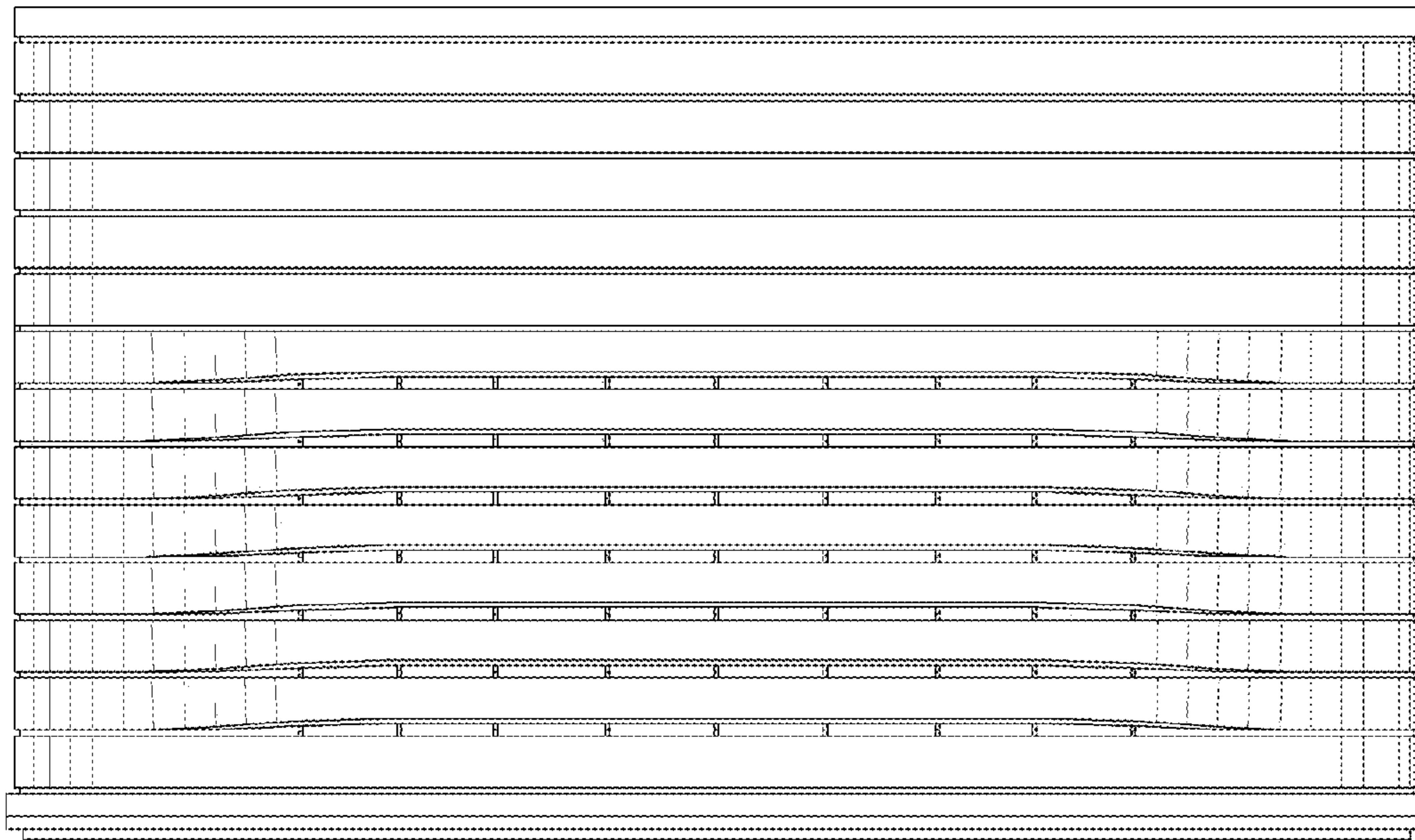
