(57) **CLAIM**

The ornamental design for an x-ray scanner, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawing views are included for the purpose of illustrating unclaimed portions of the x-ray scanner and form no part of the claimed design.

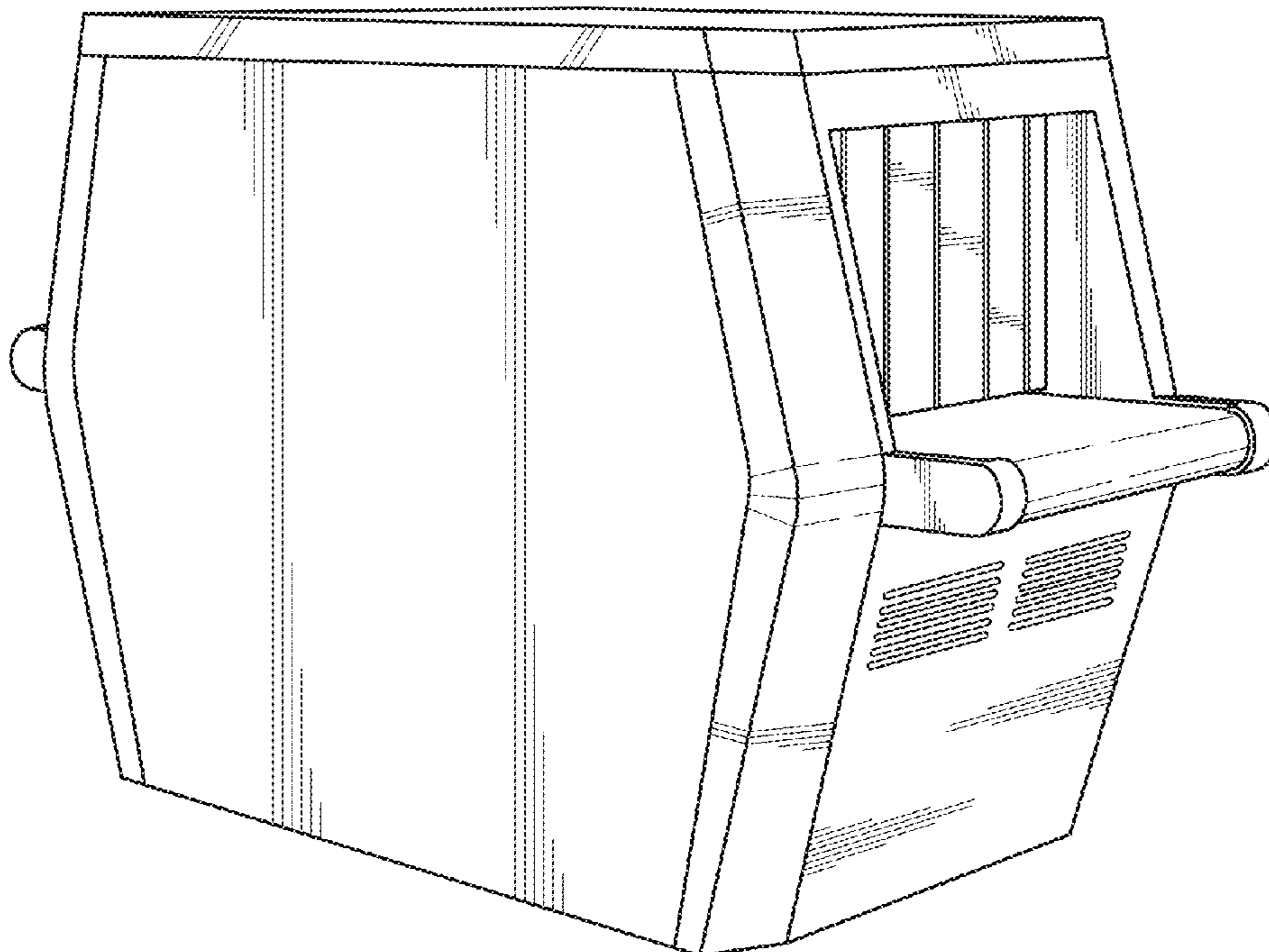

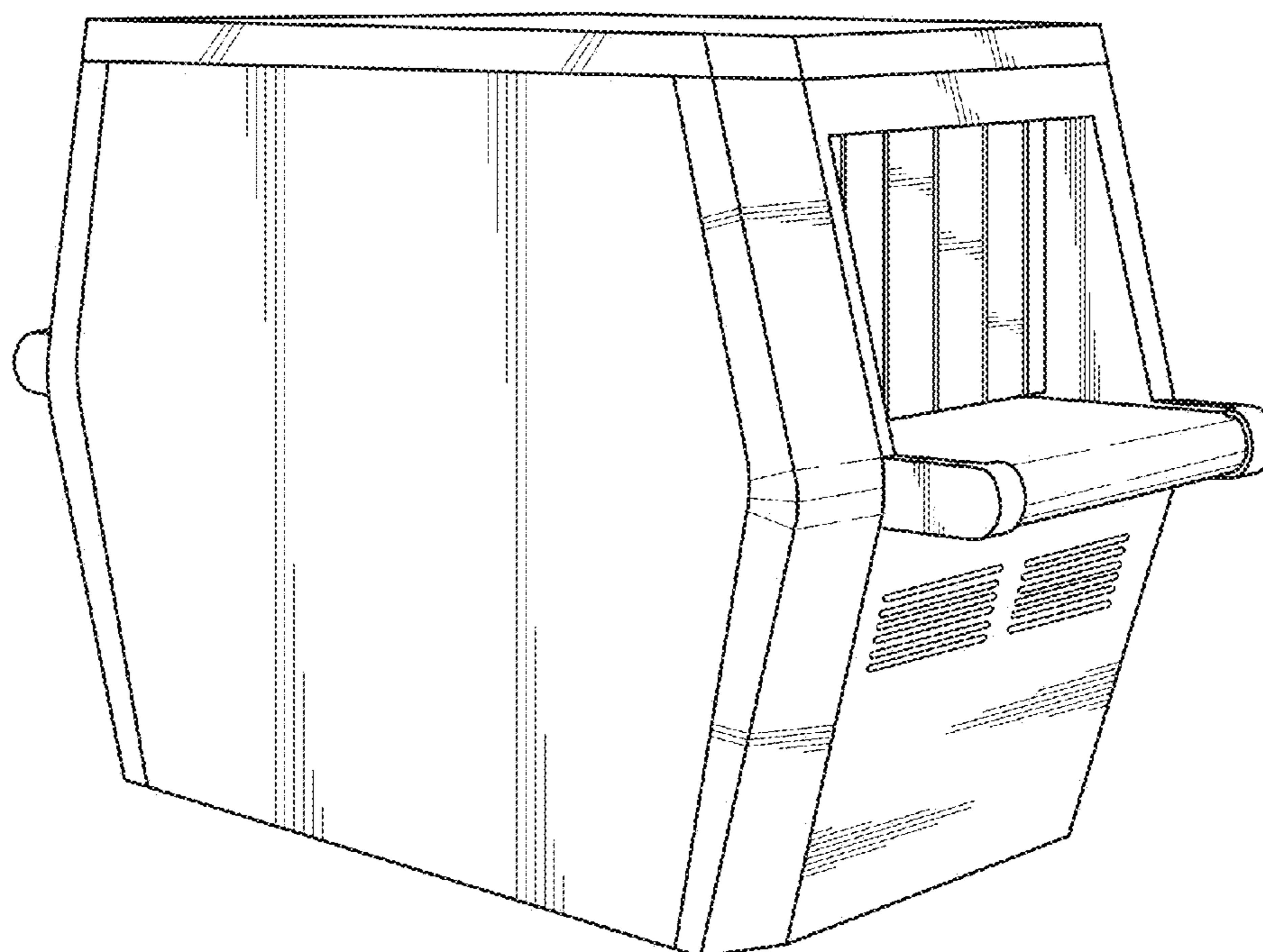

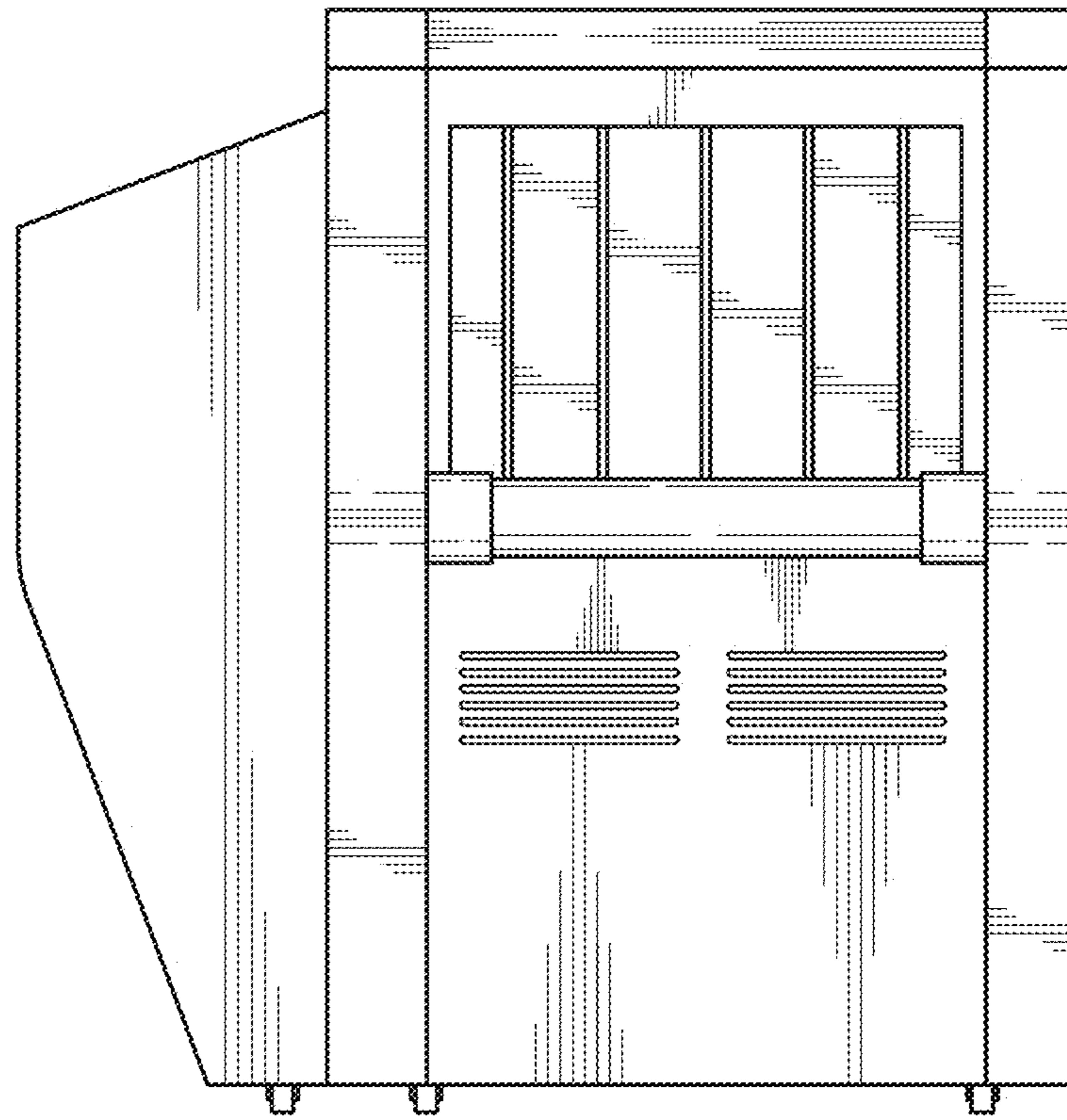

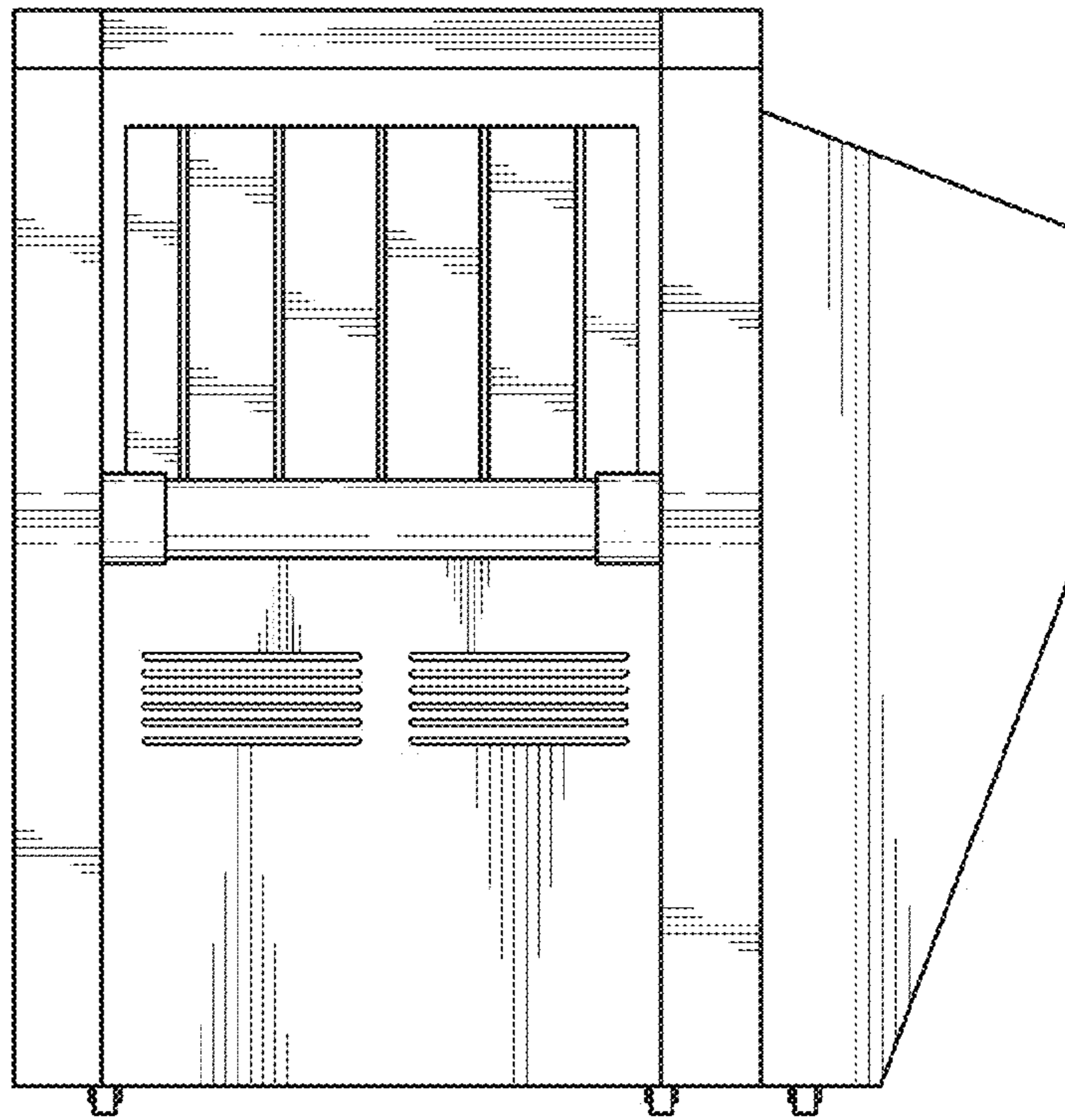

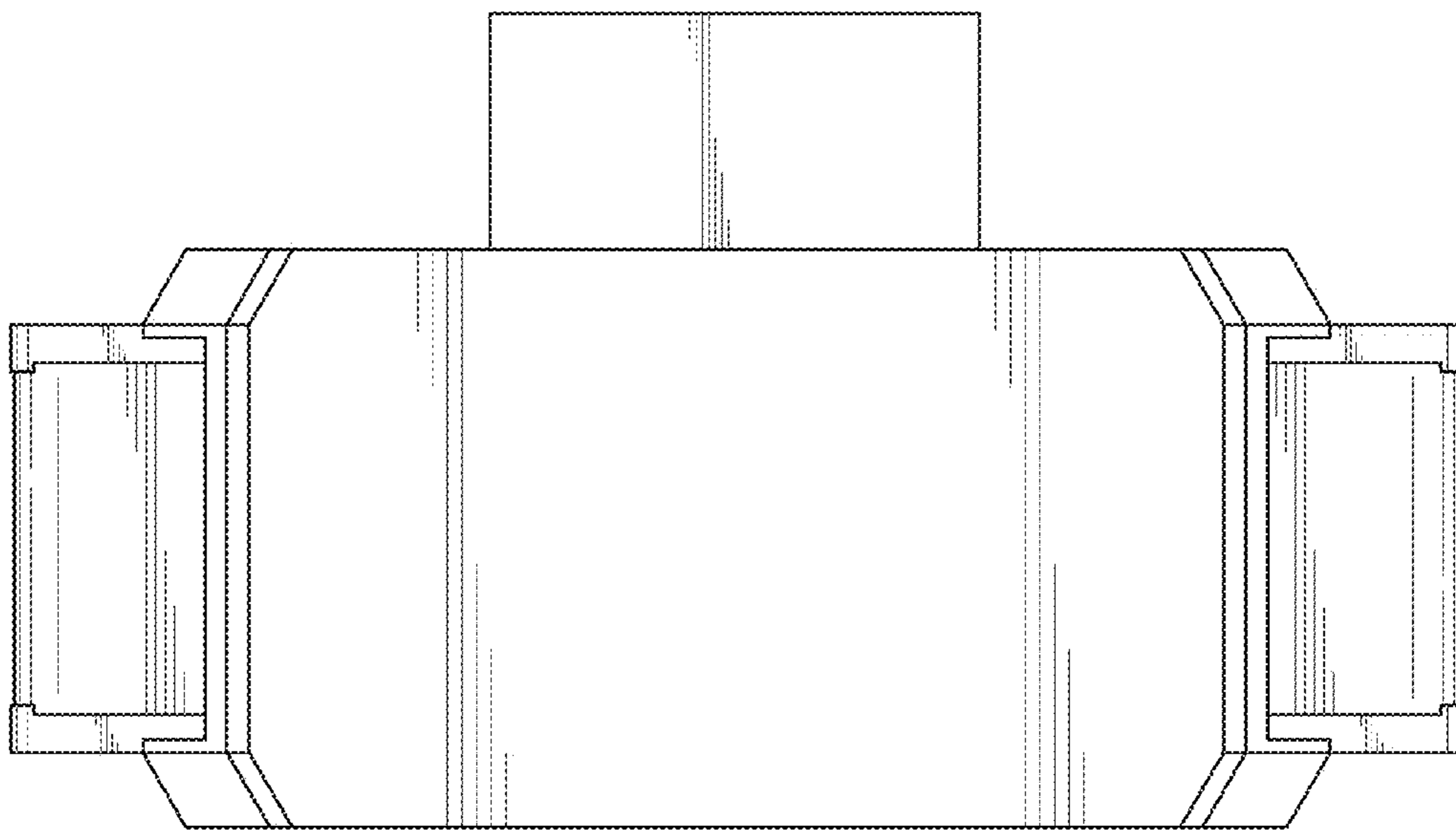

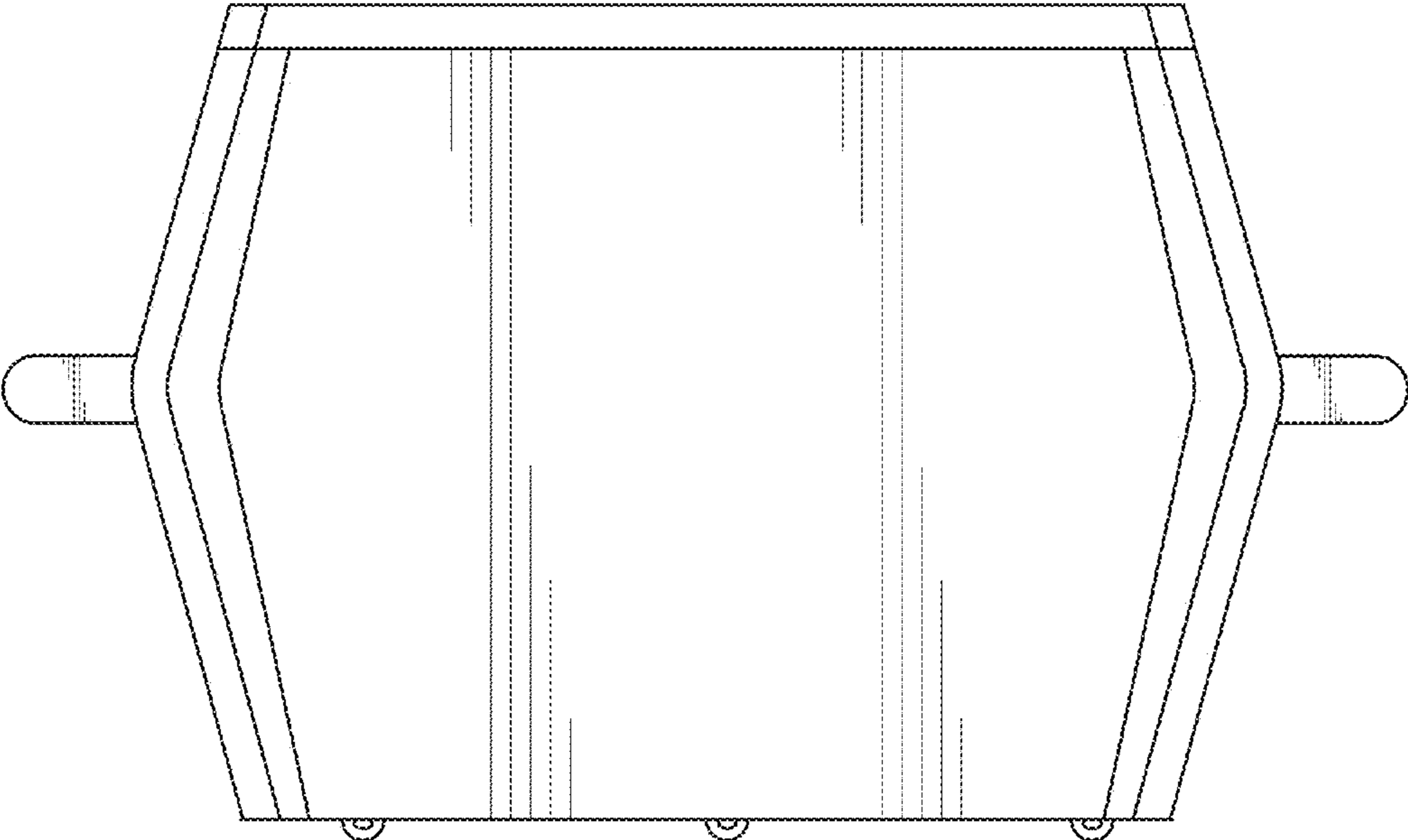

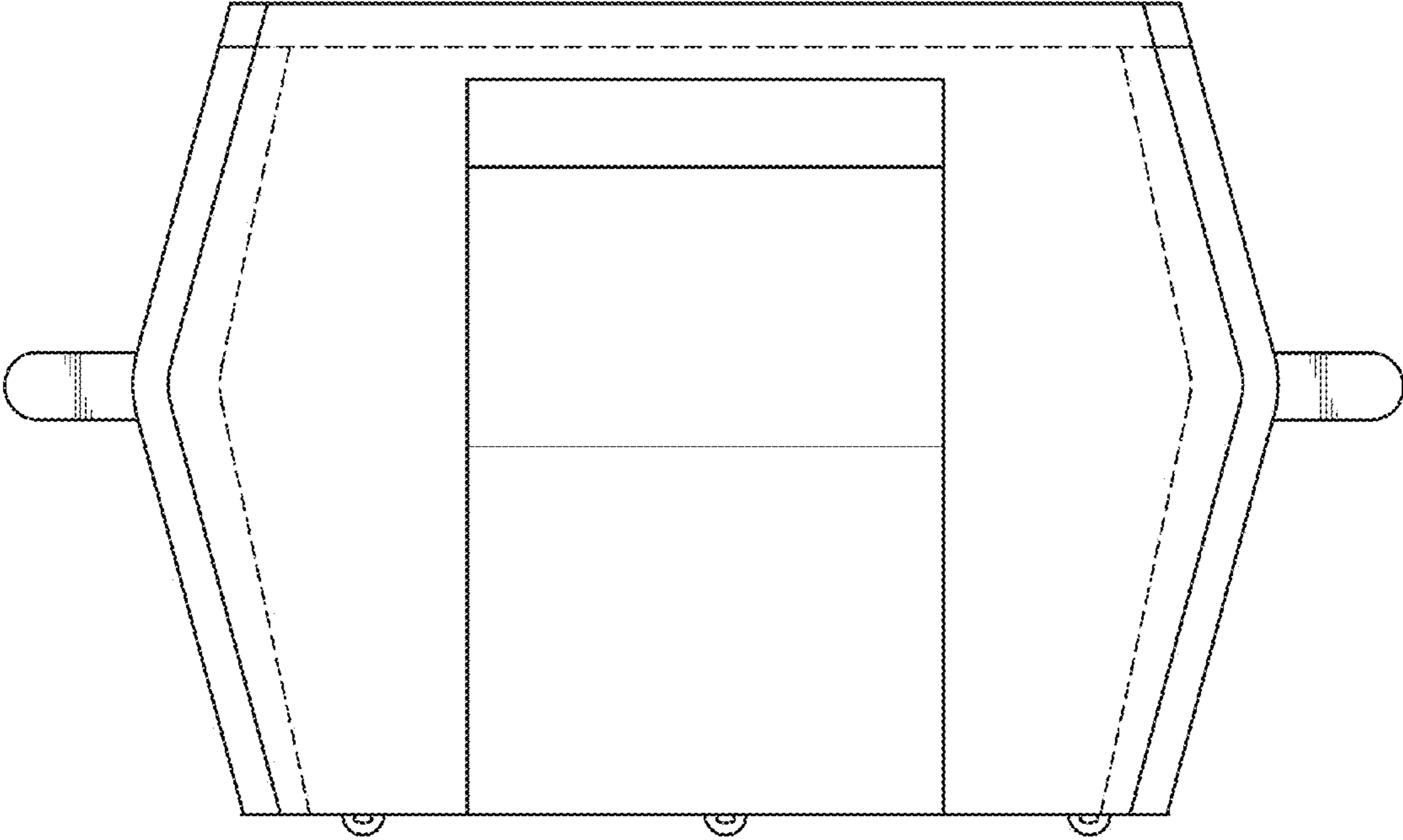
