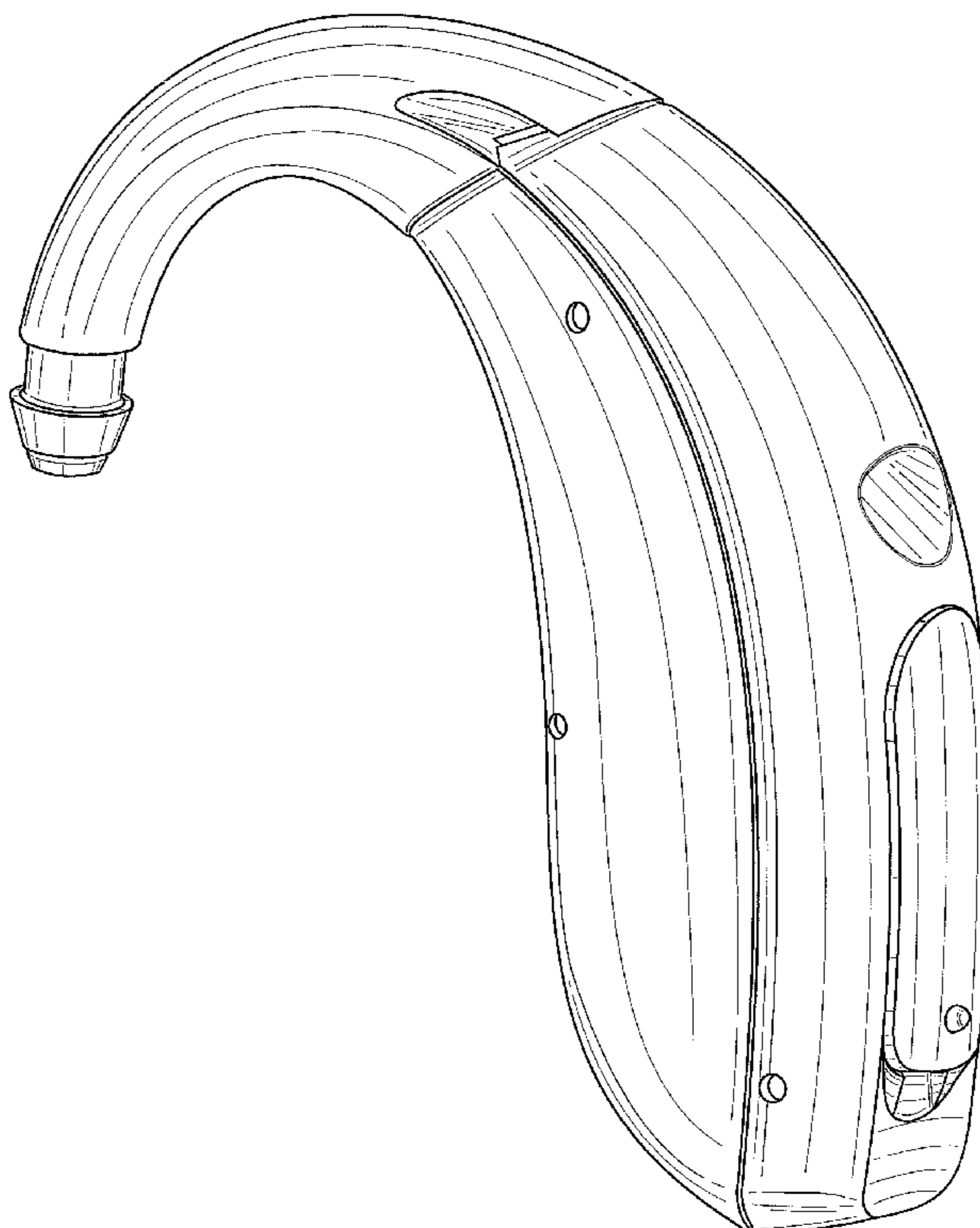
(57) **CLAIM**

The ornamental design for a behind-the-ear (BTE) hearing aid, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of the behind-the-ear (BTE) hearing aid;
FIG. 2 is a top view of the behind-the-ear (BTE) hearing aid;
FIG. 3 is a front view of the behind-the-ear (BTE) hearing aid;

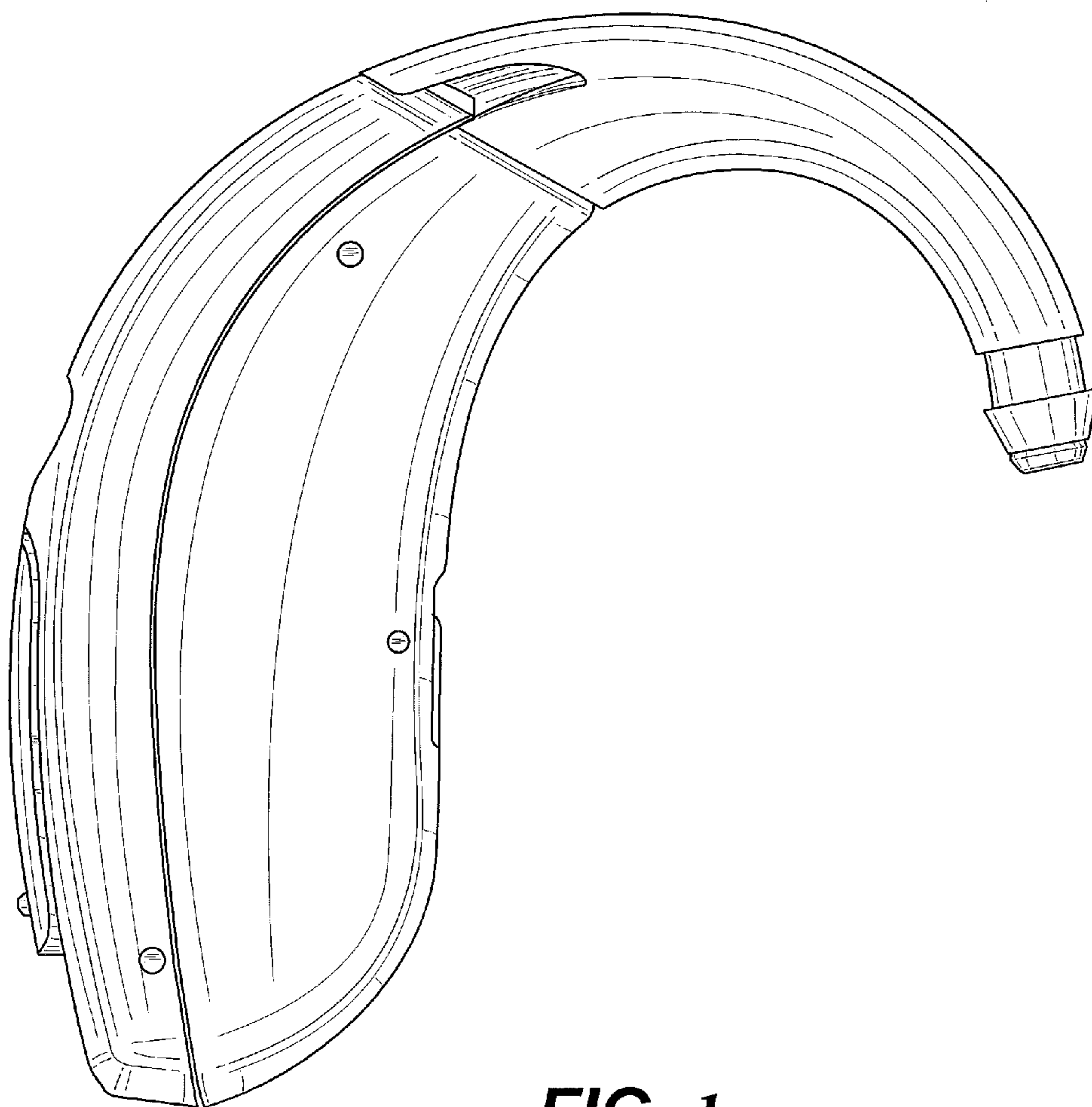

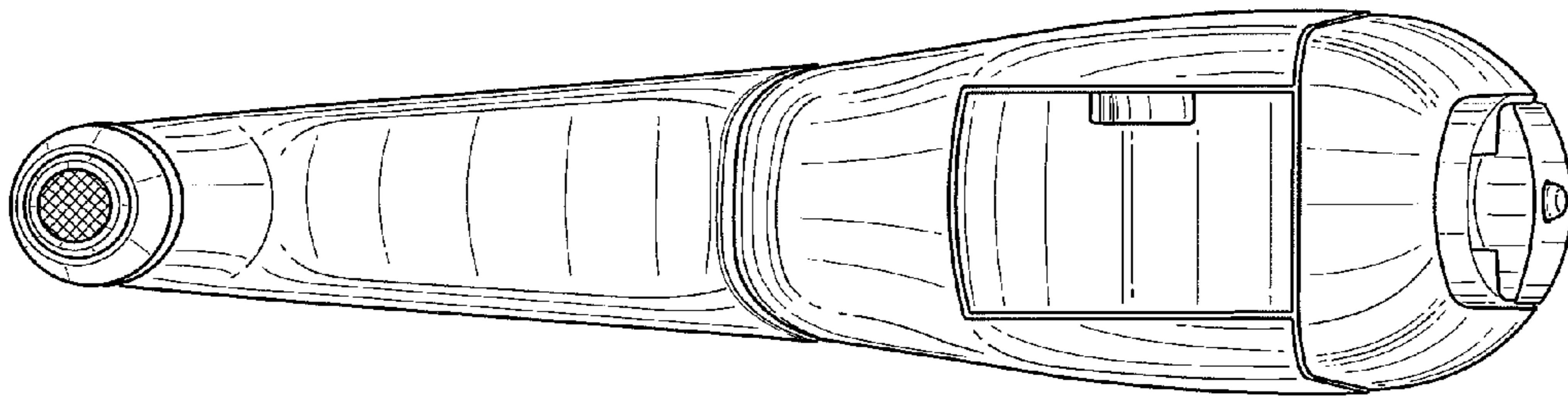

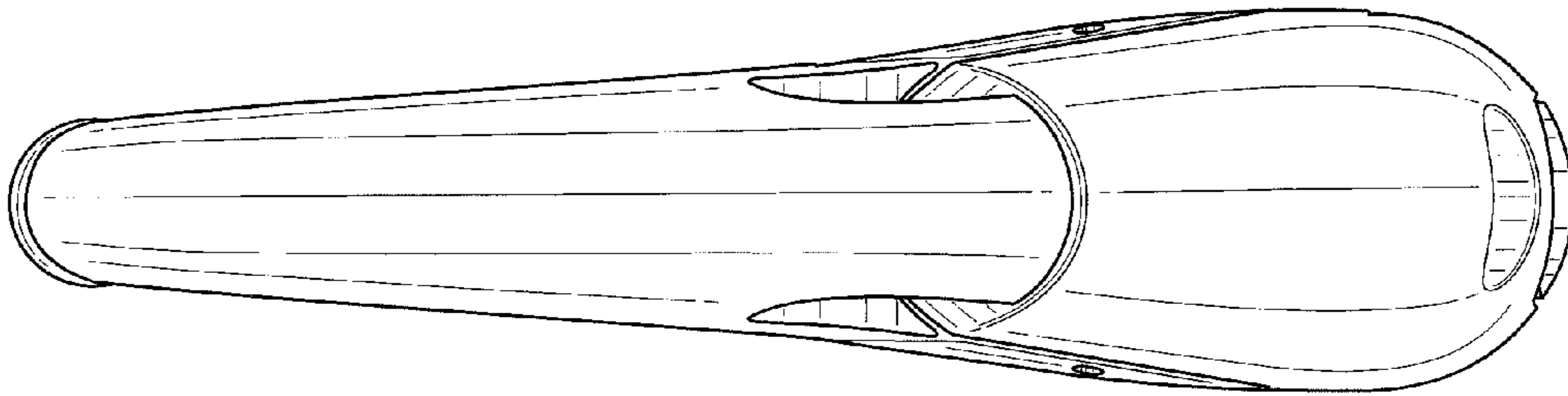

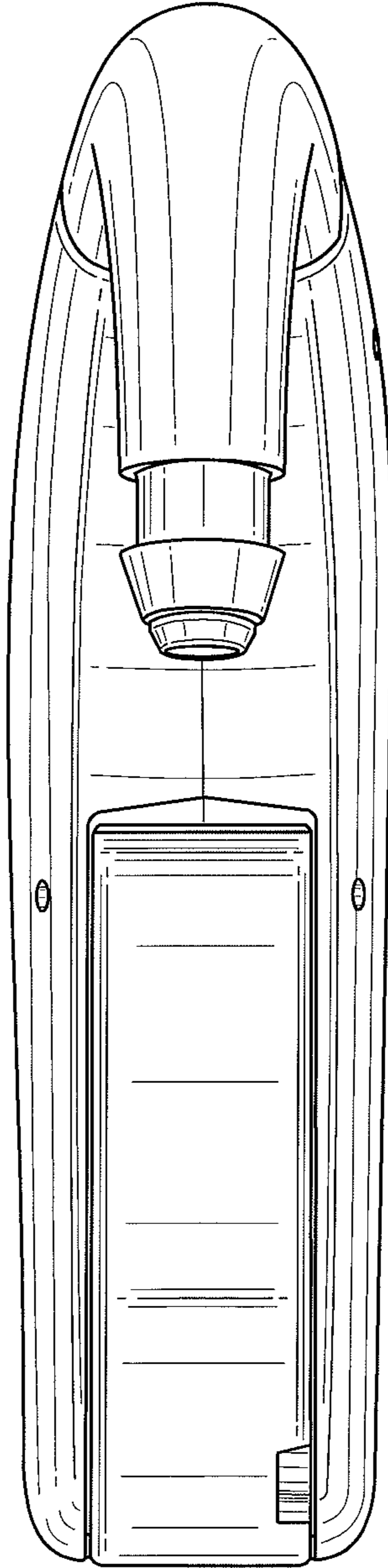

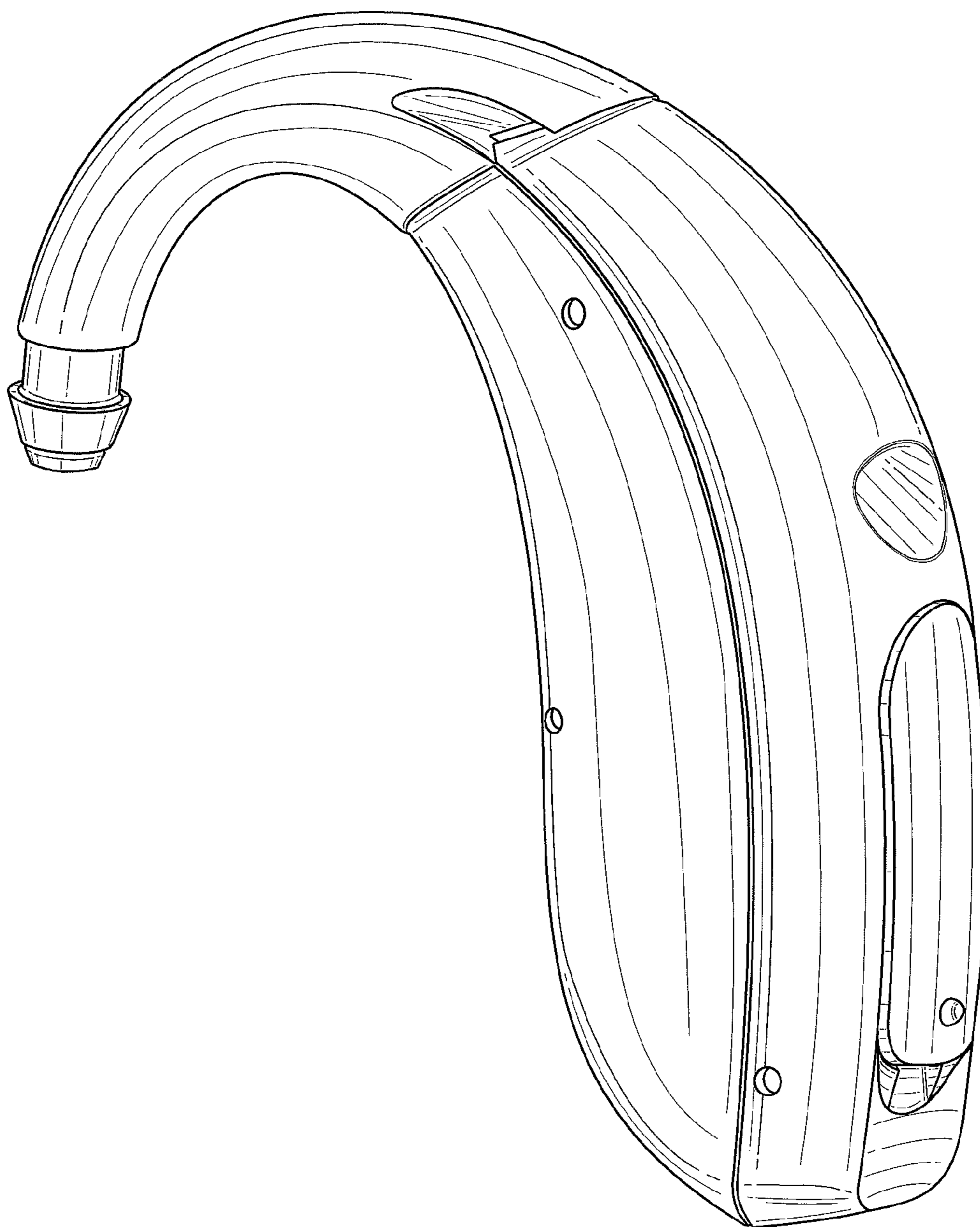

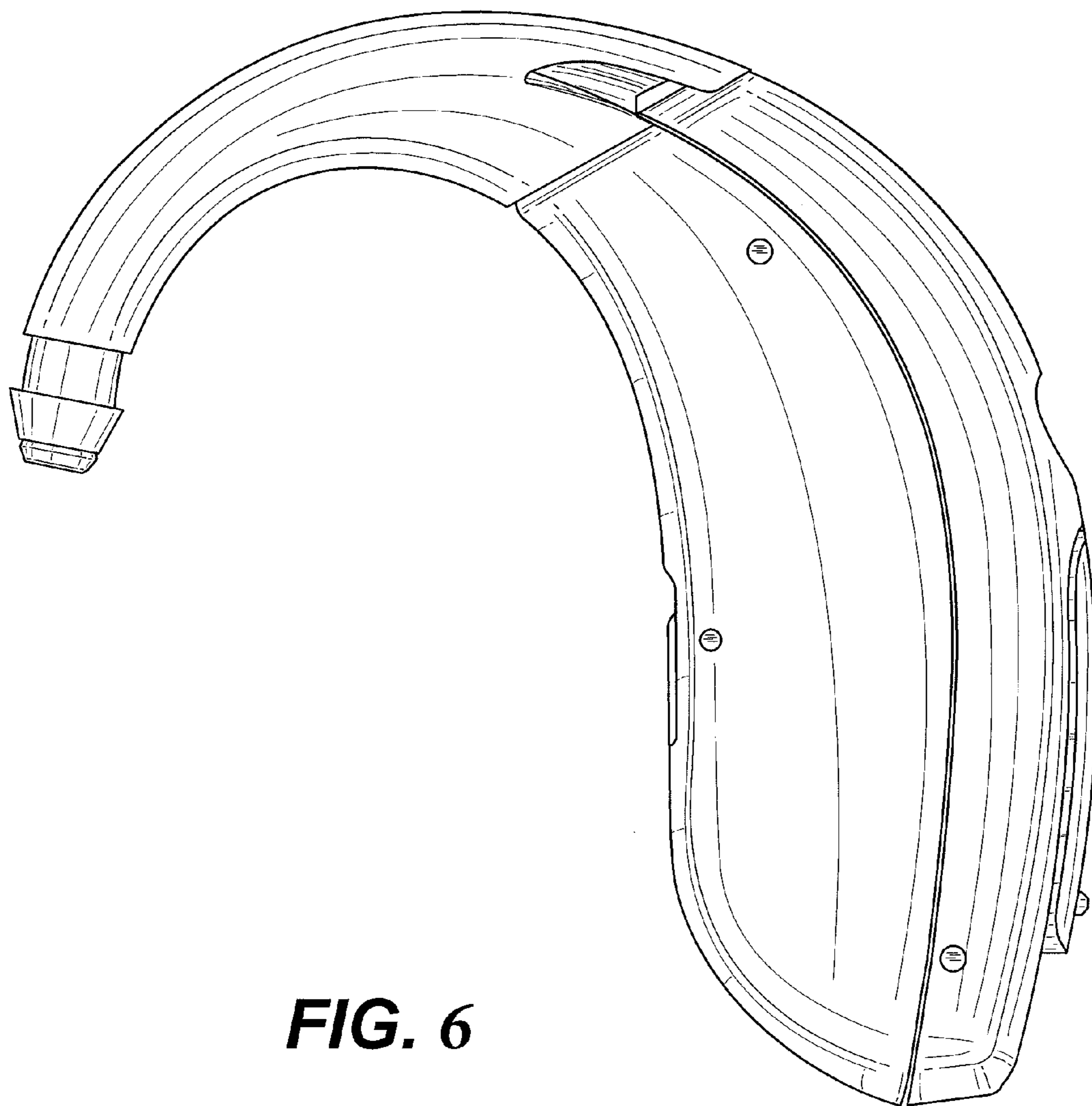

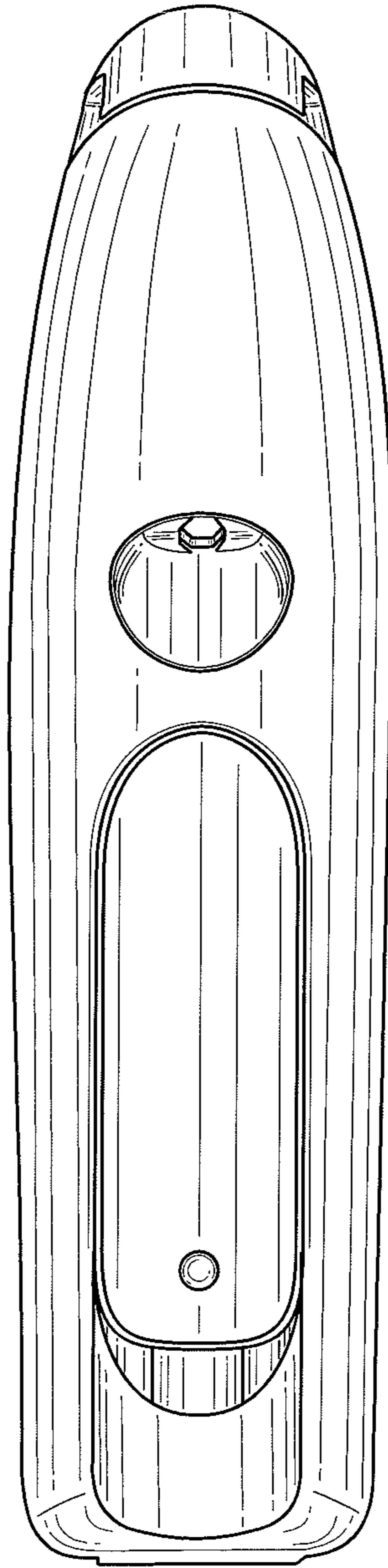
