FIG. 3 illustrates a side elevational view of a laser hair removal device according to a specific example embodiment of the disclosure;

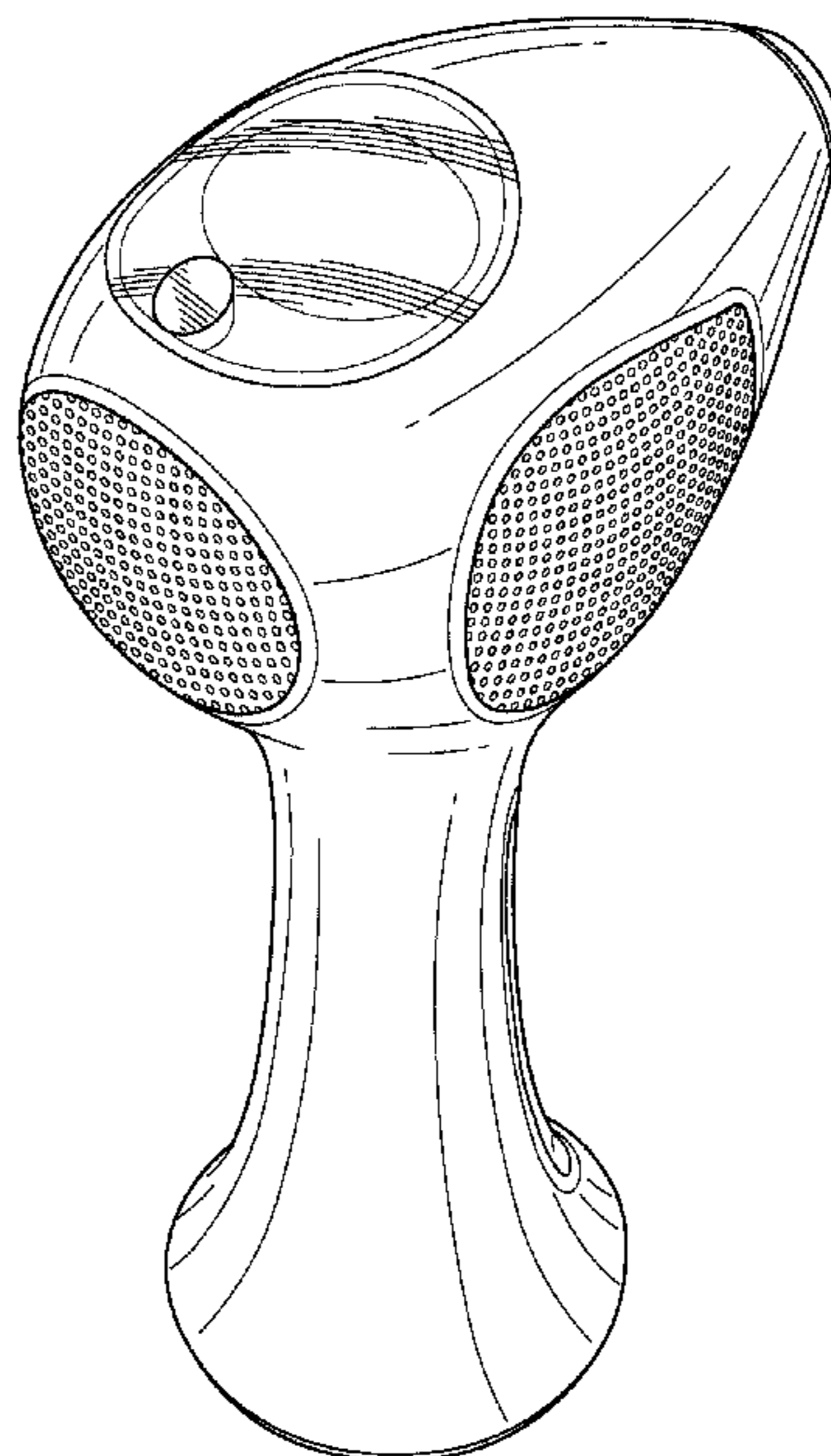
FIG. 4 illustrates a rear elevational view of a laser hair removal device according to a specific example embodiment of the disclosure;

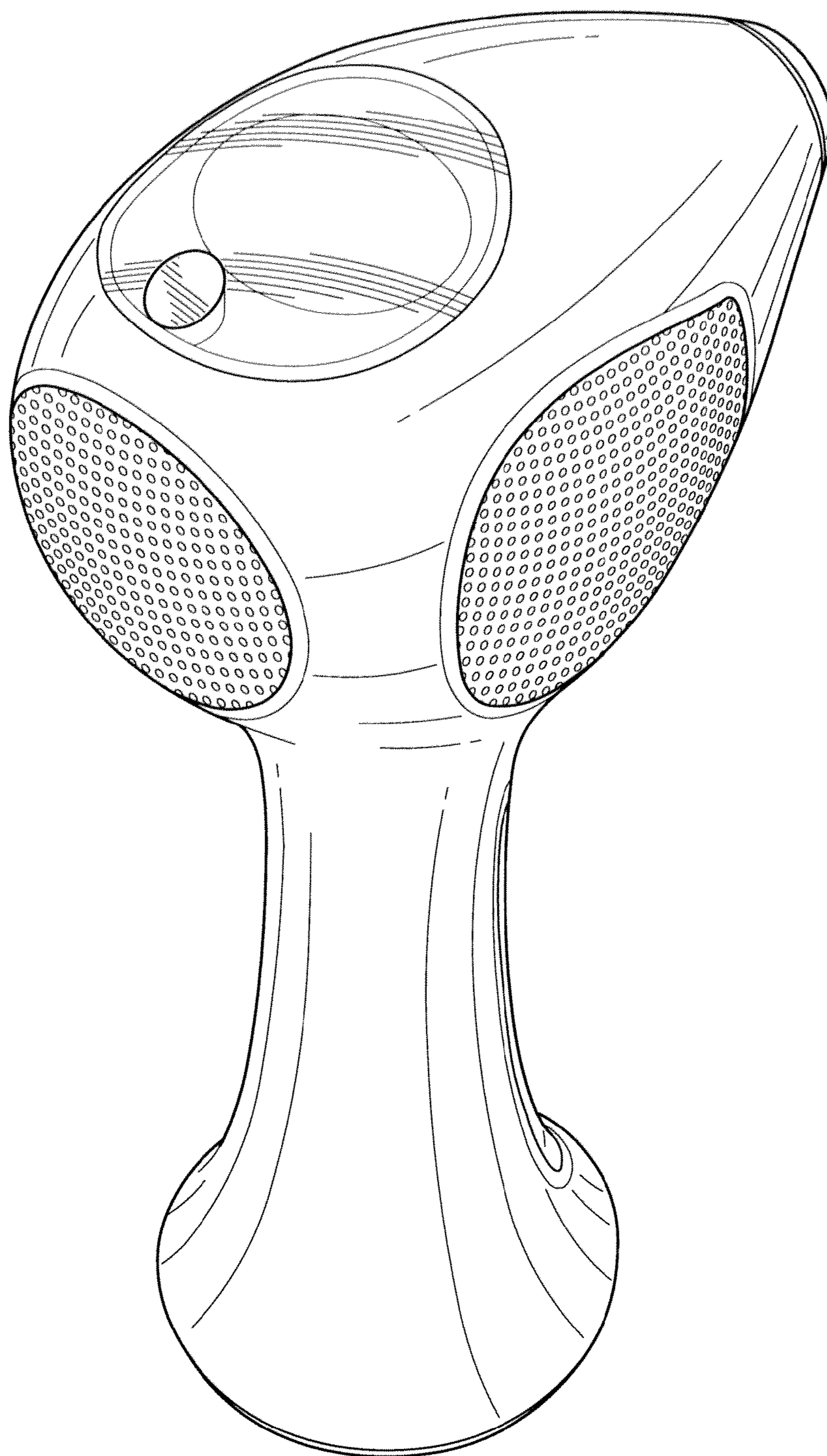

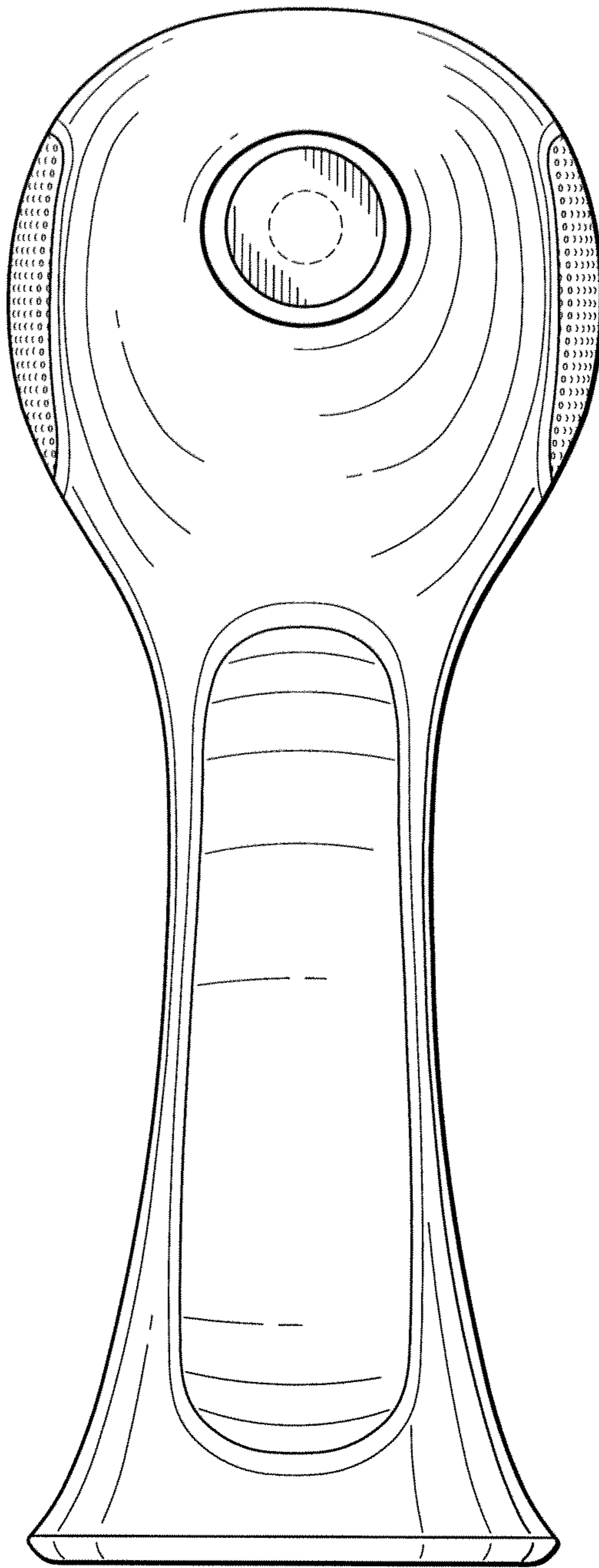

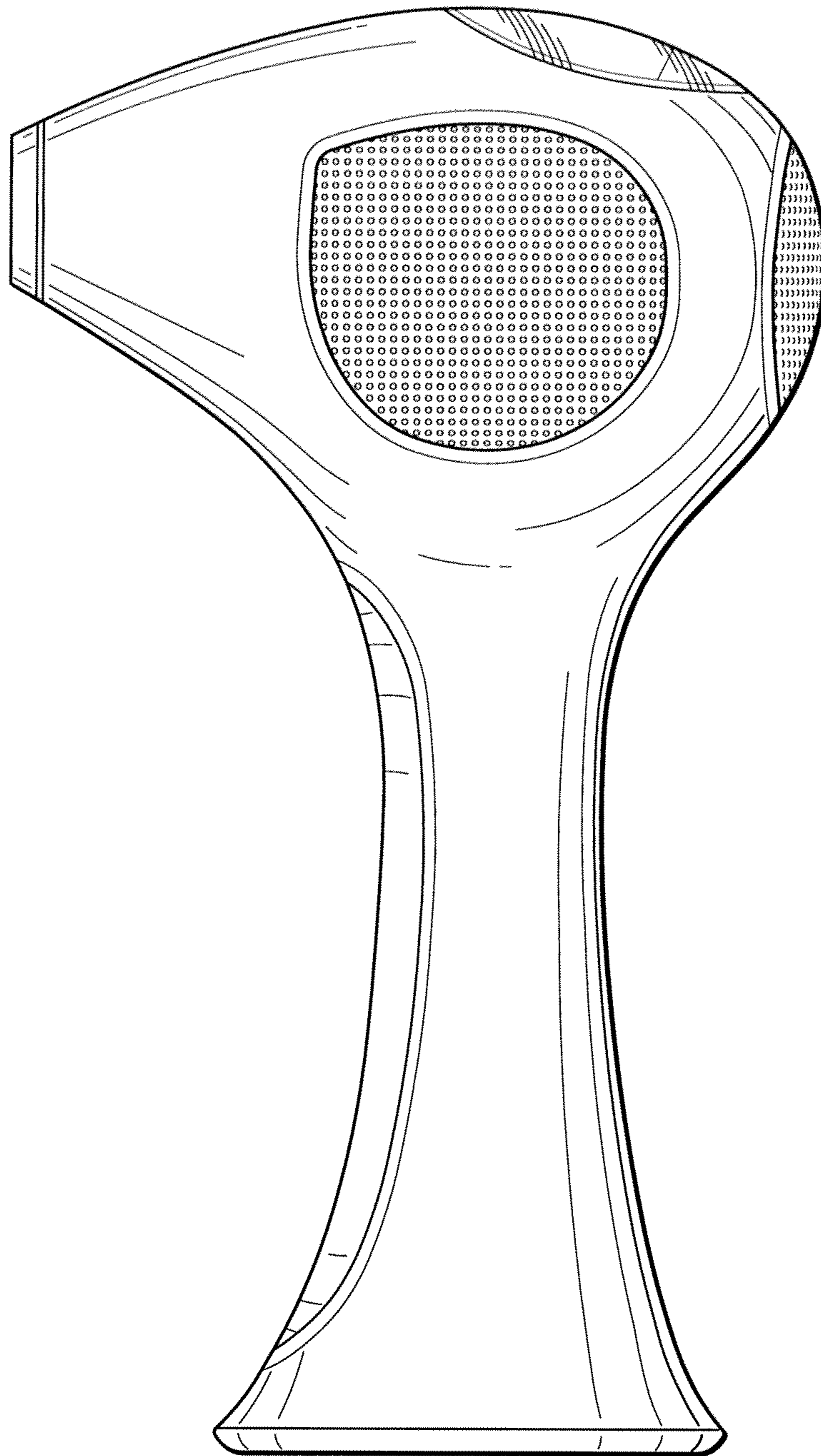

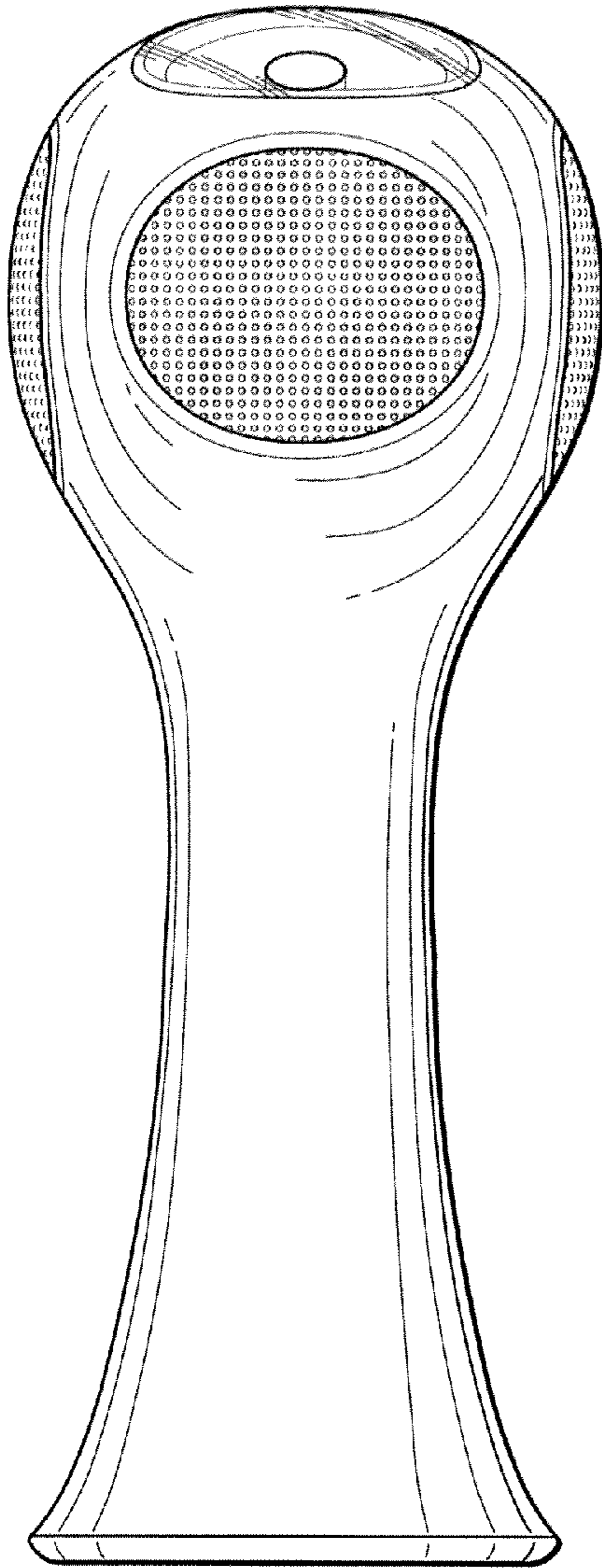

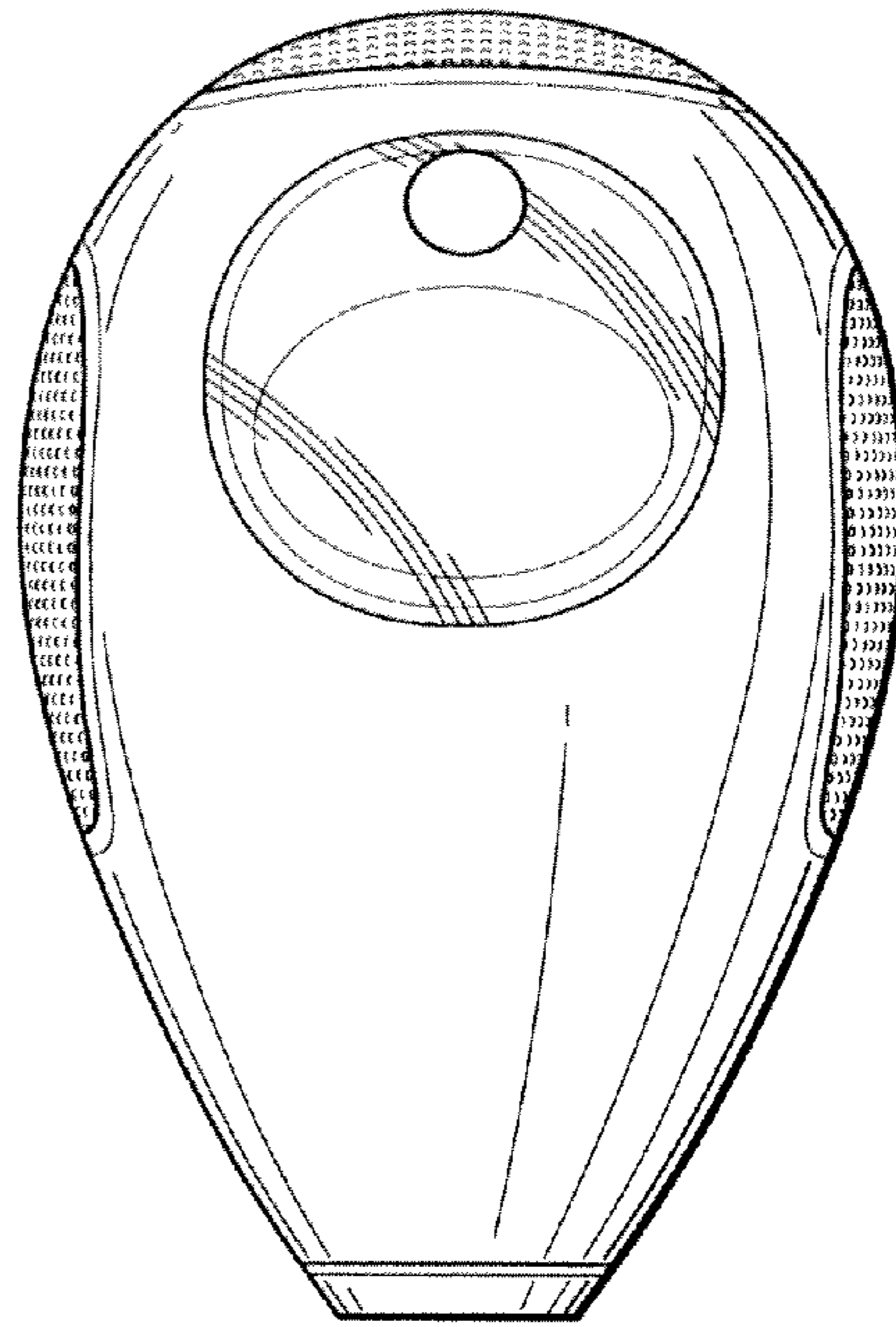

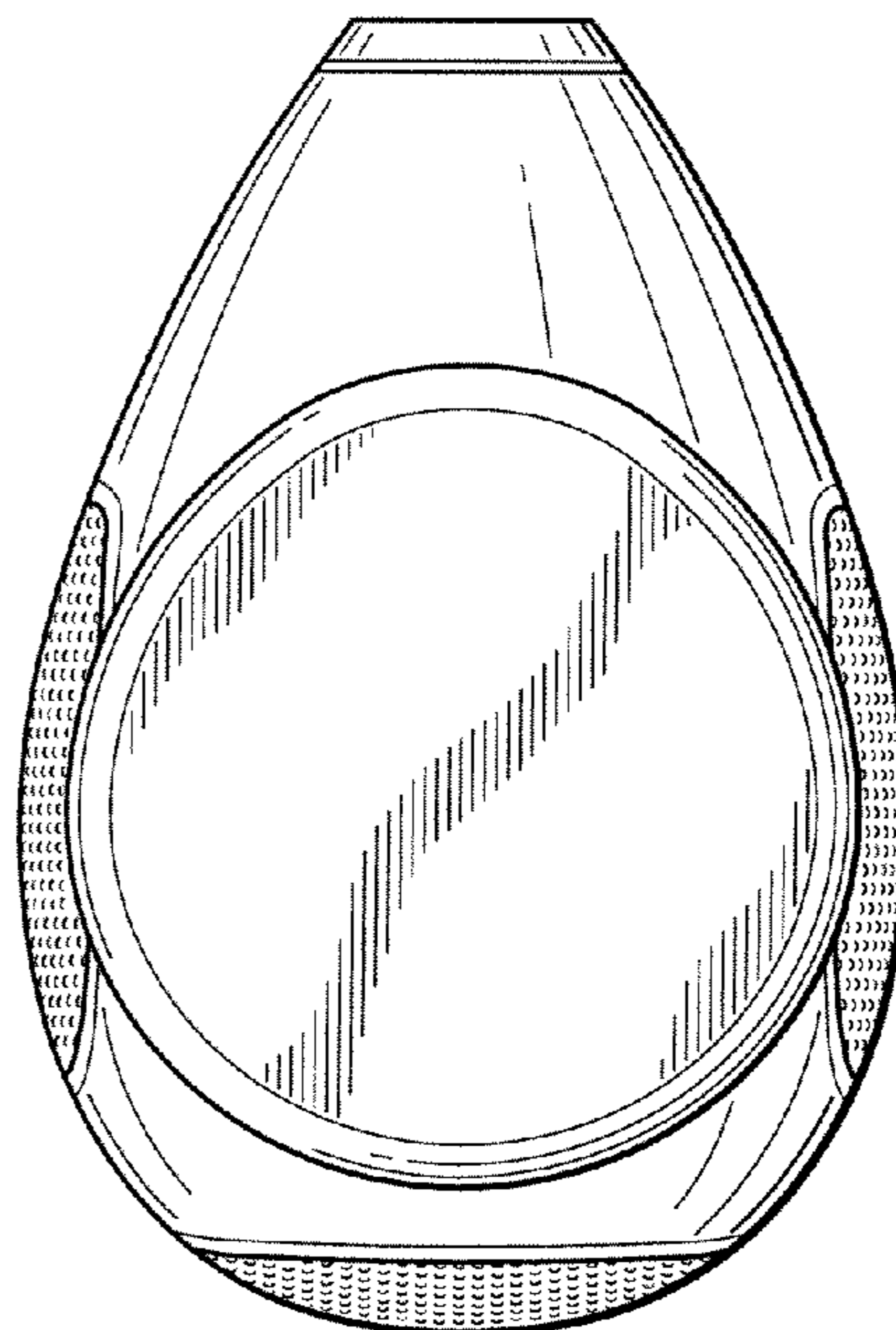
