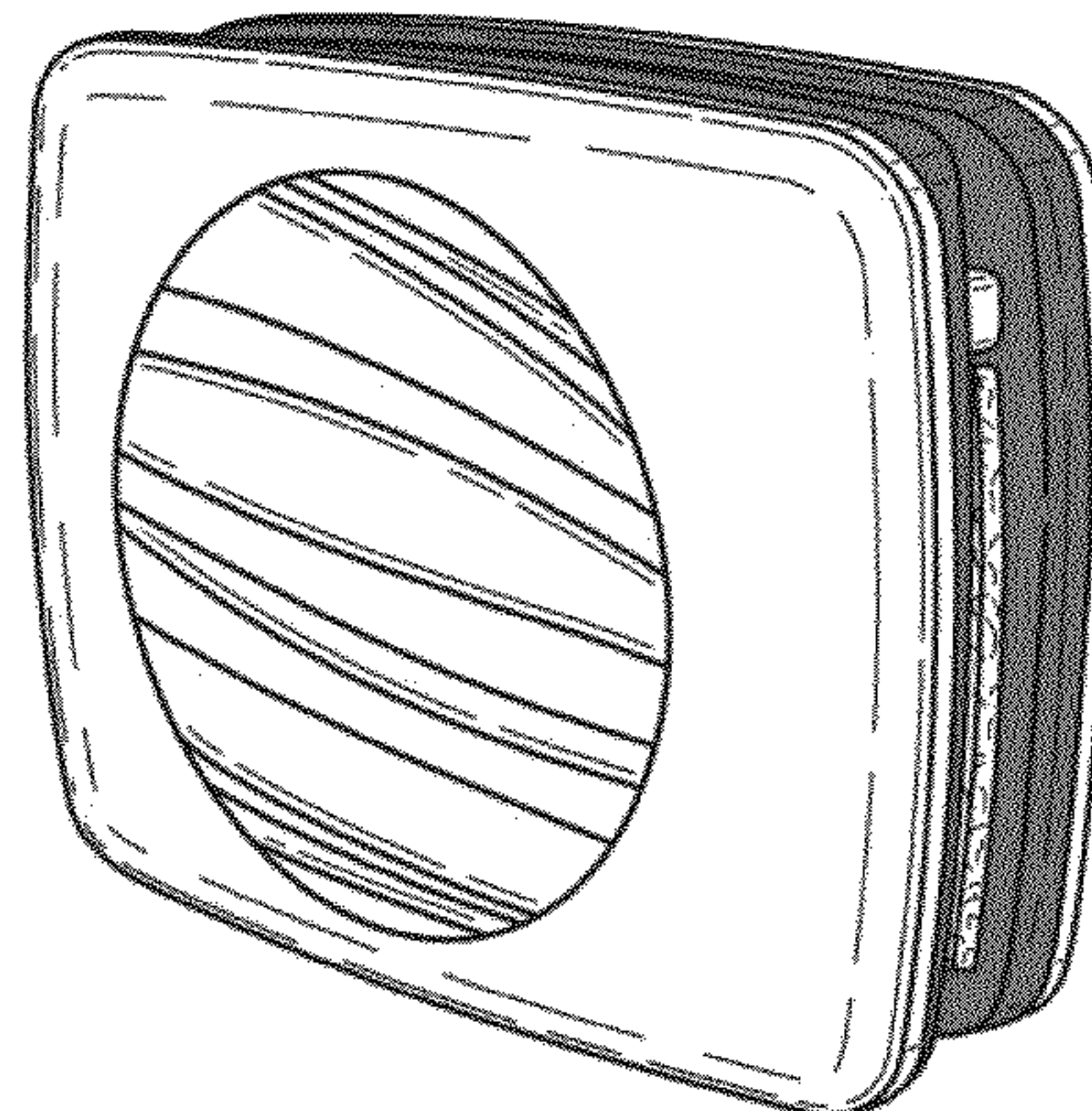
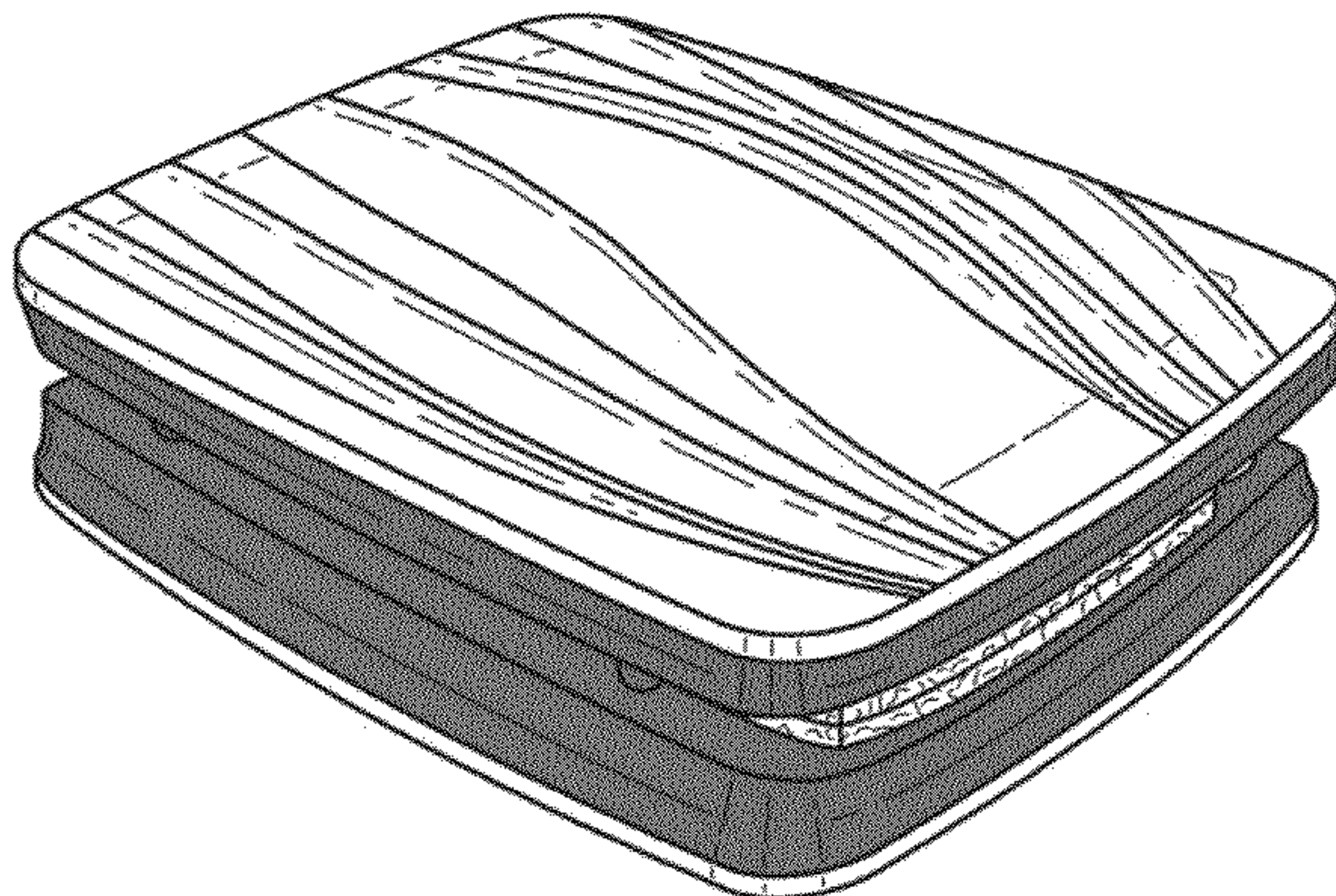
(57) **CLAIM**

The ornamental design for an applicator clip for applying a hair treatment composition to a bundle of hair strands, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our new design shown in a closed position, the design being capable of being in an open or closed position;
FIG. 2 is a front view;
FIG. 3 is a rear view;
FIG. 4 is a left side;
FIG. 5 is a bottom view; and,
FIG. 6 is a bottom perspective view.
Wherein the shaded portions of FIG. 1-6 represent a contrasting color to the non-shaded portions of FIG. 1-6, and wherein the broken lines represent disclaimed portions of the design.

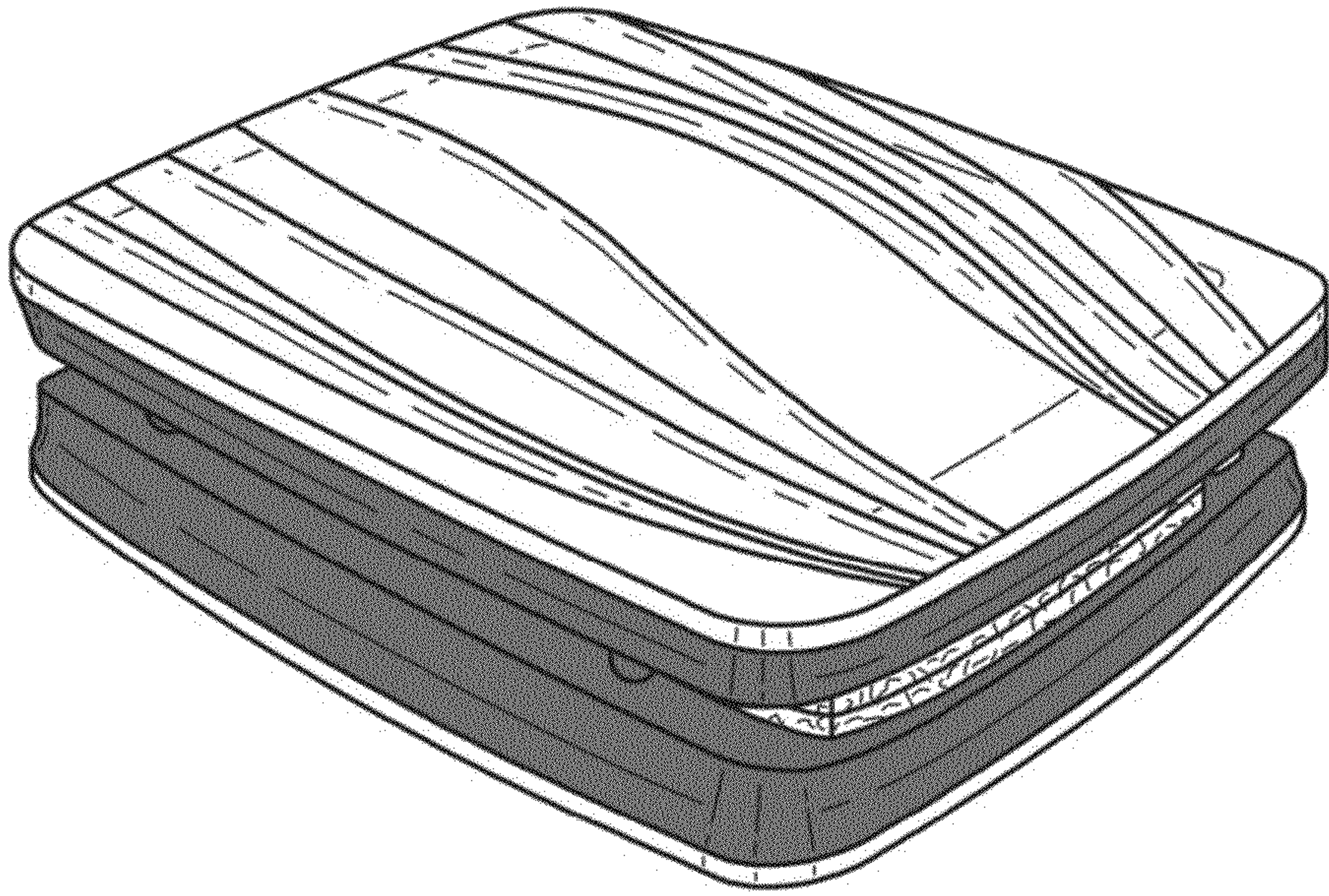

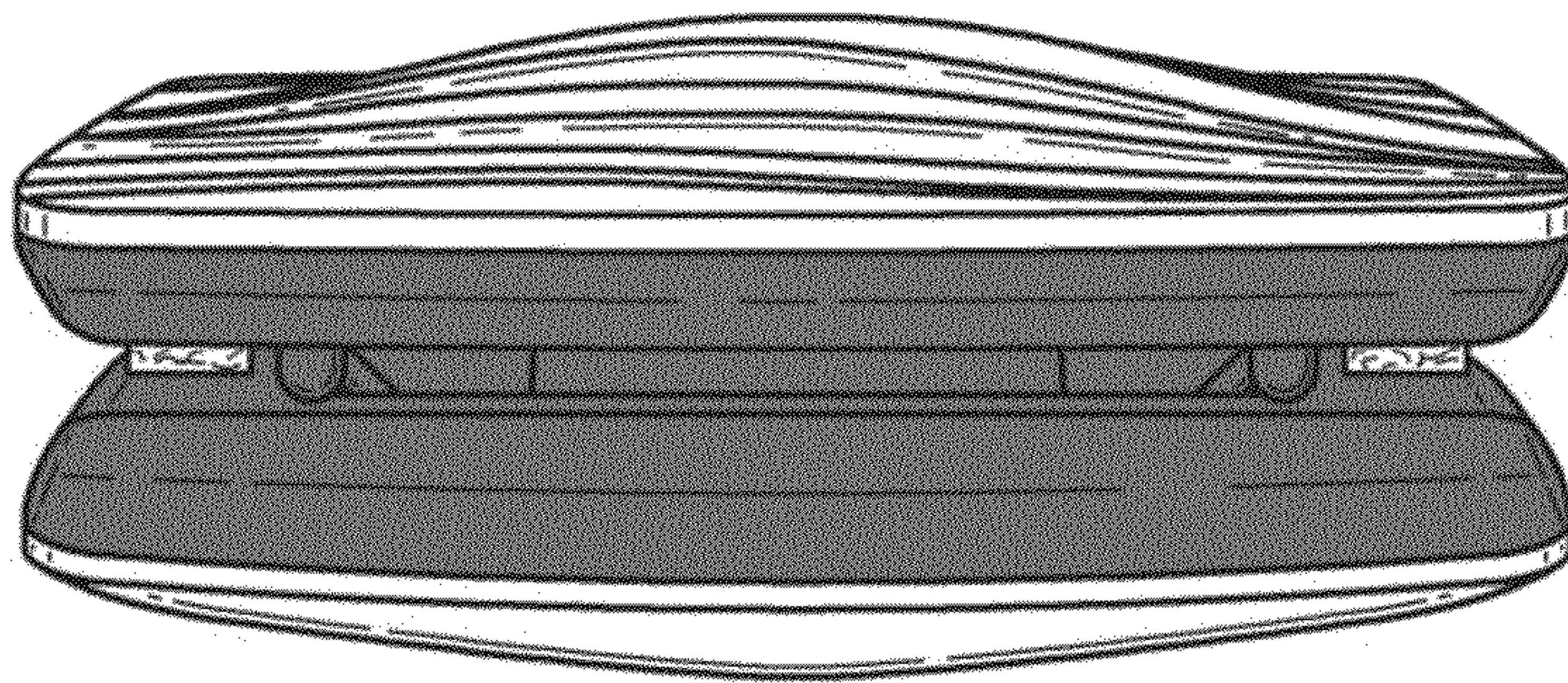

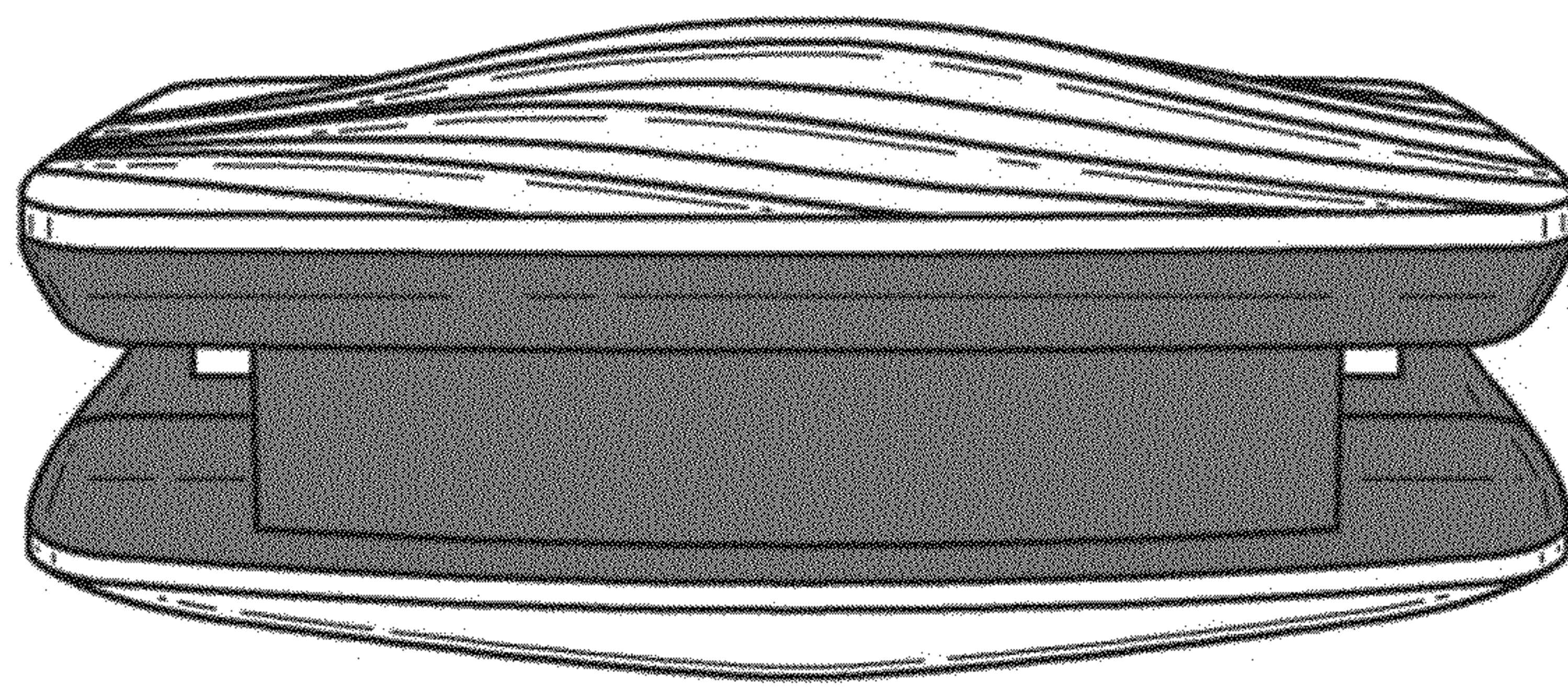

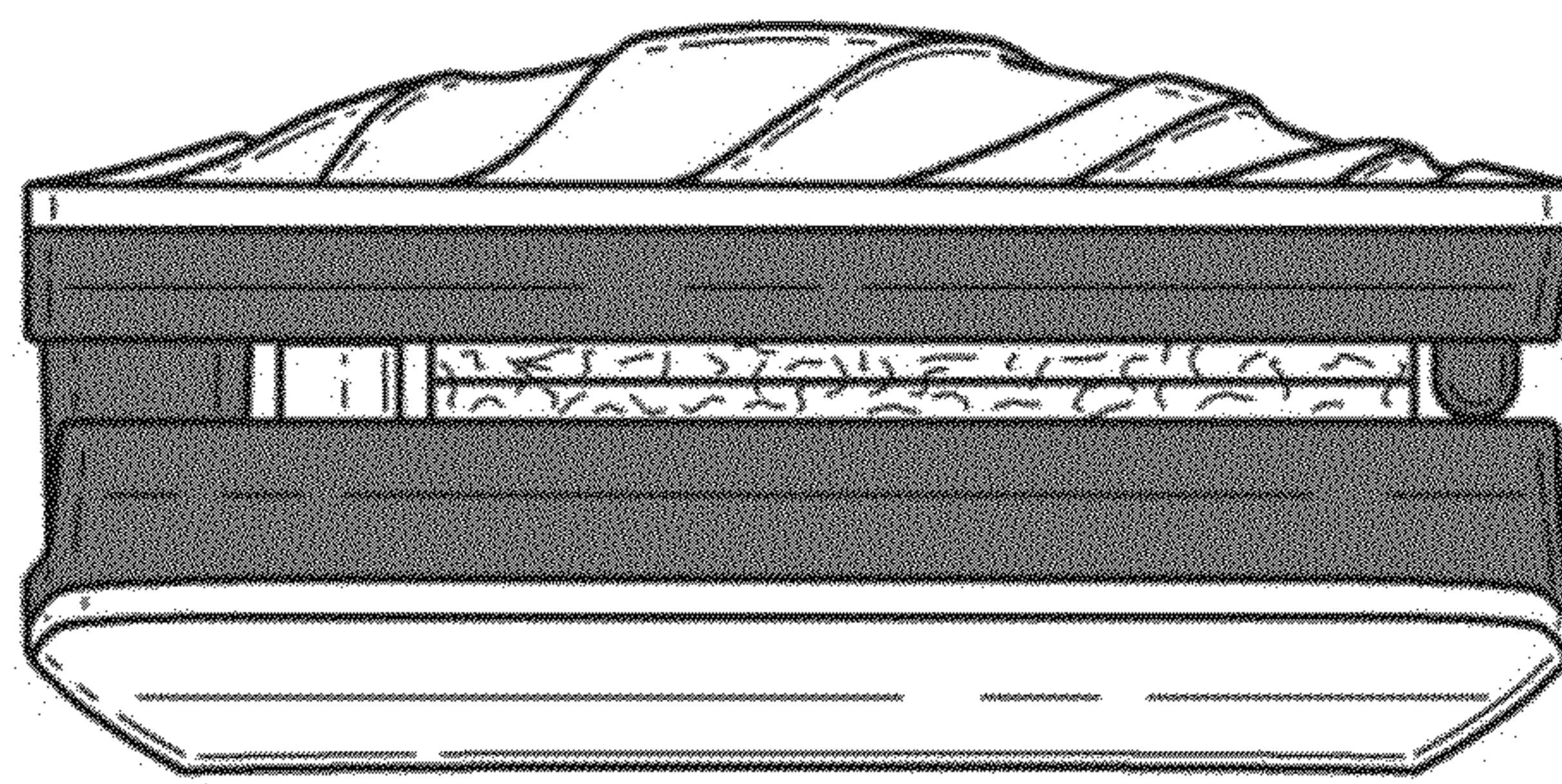

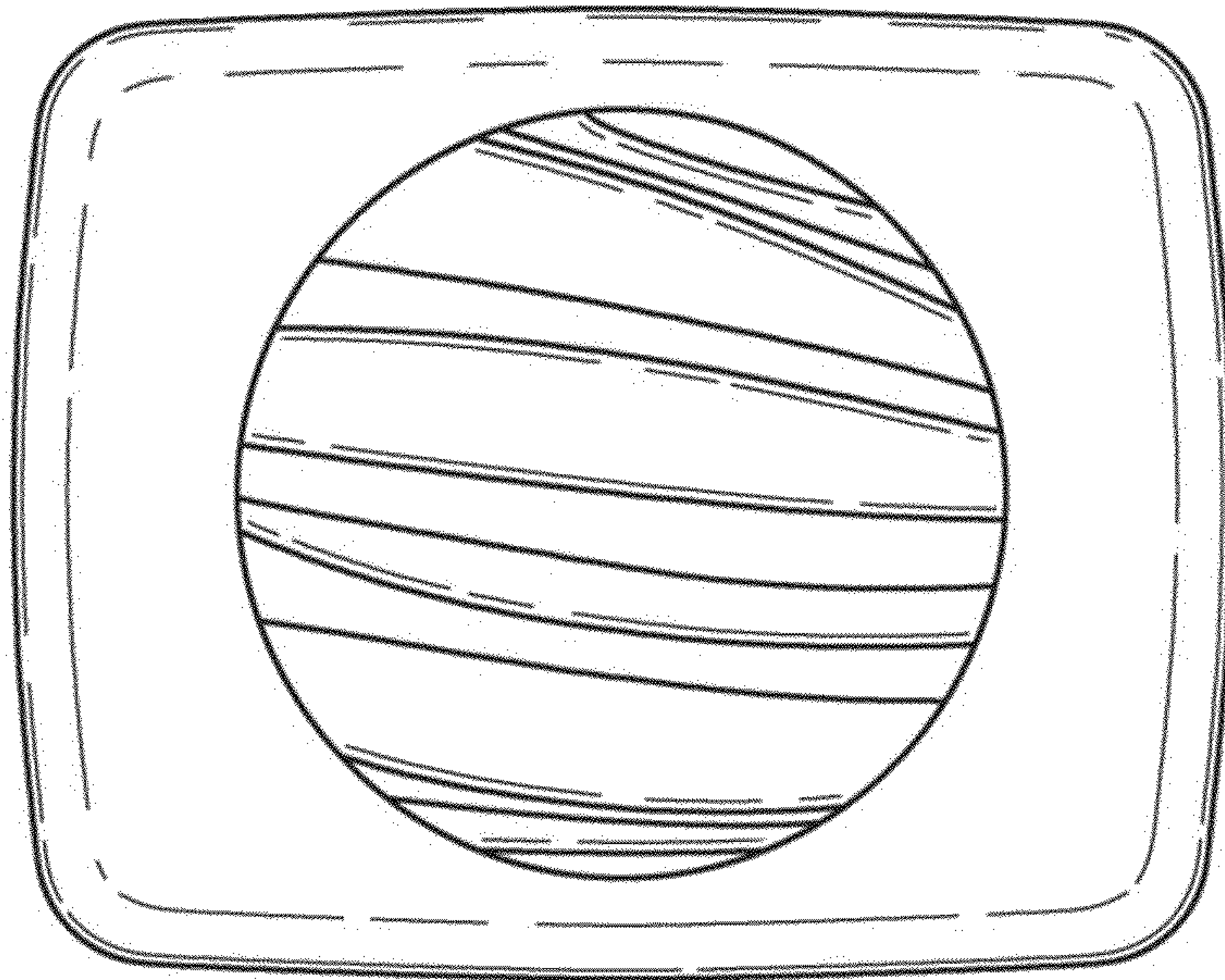

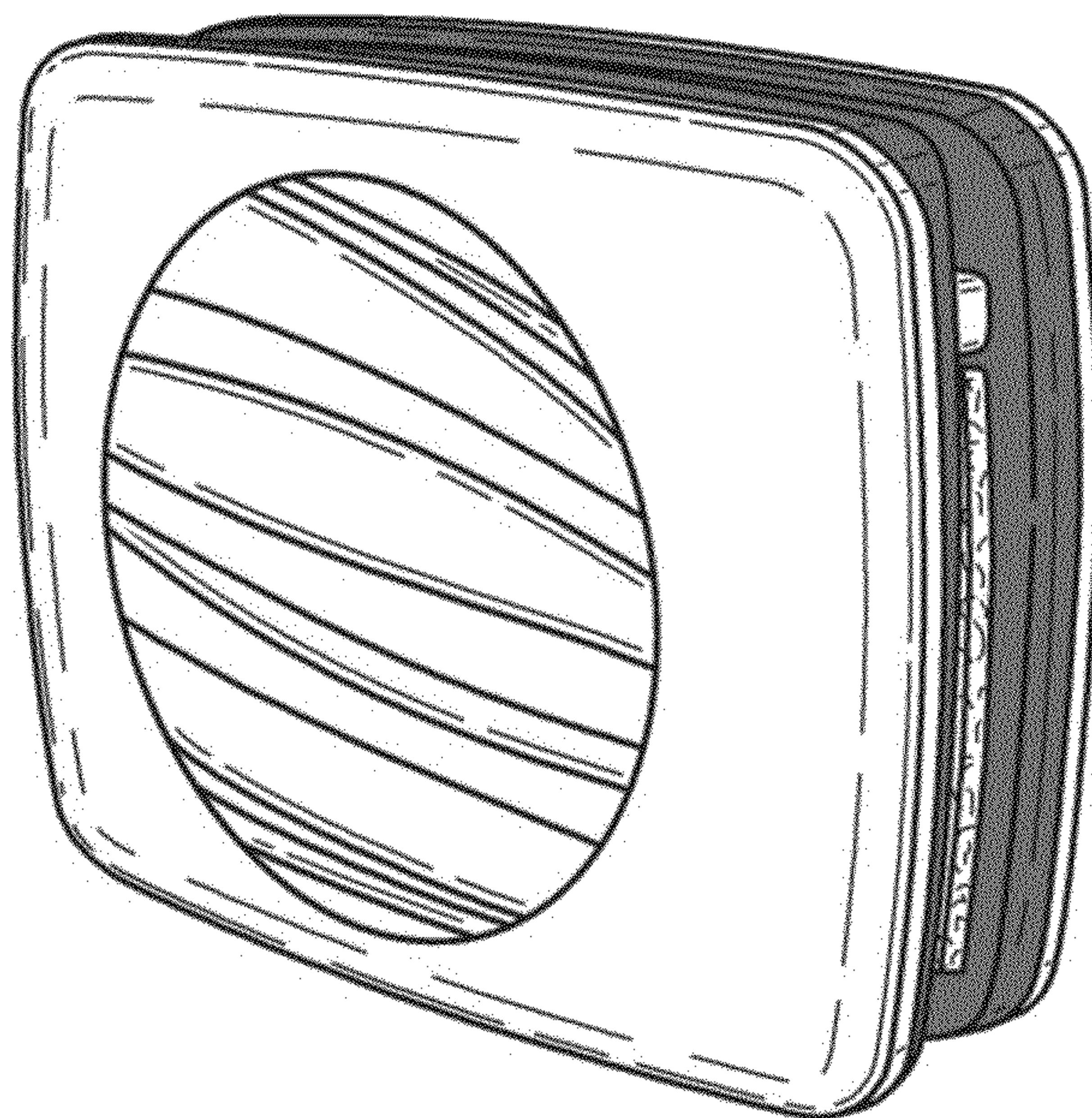
