(57) **CLAIM**

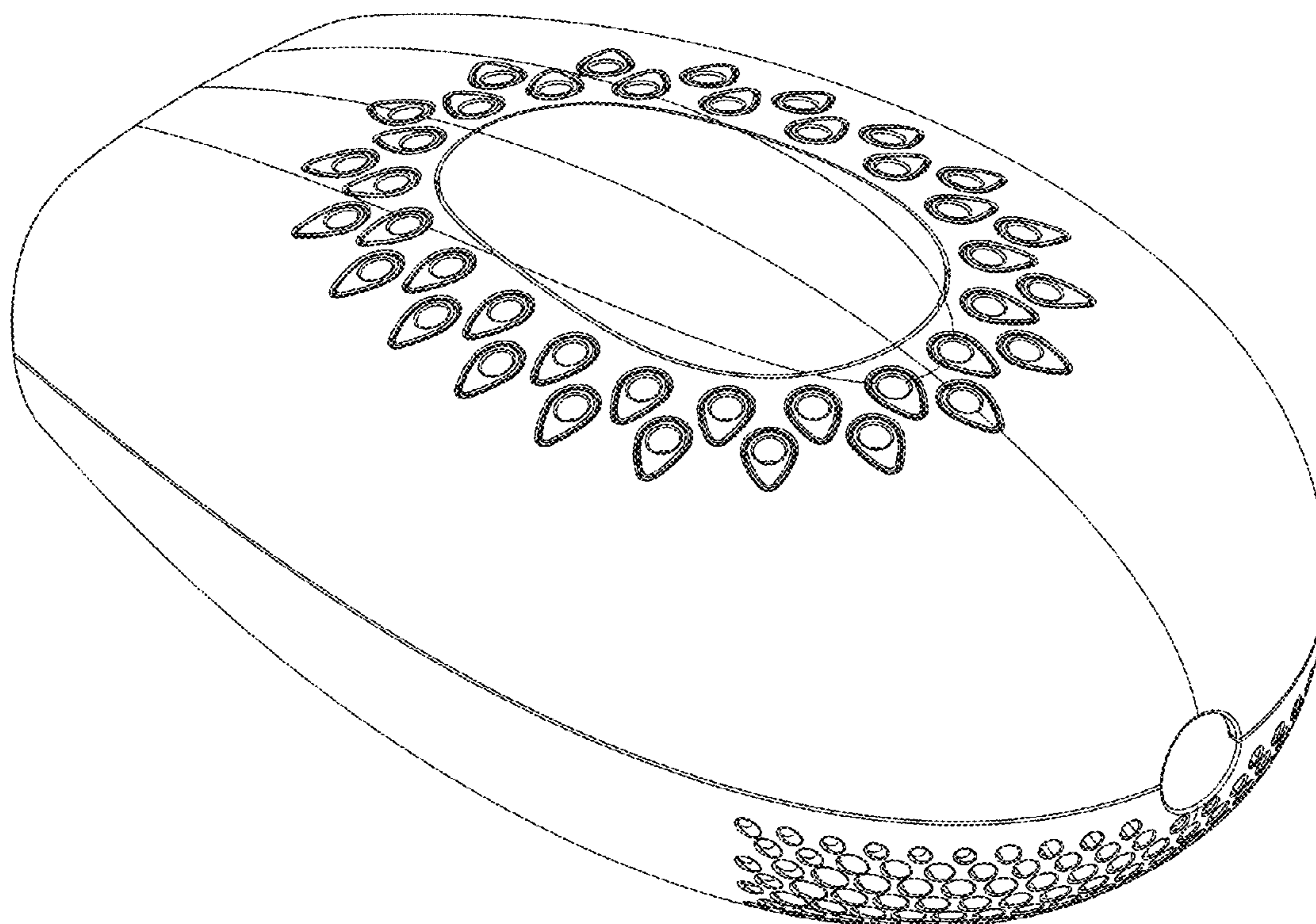
The ornamental design for a hair removal device, as shown and described.

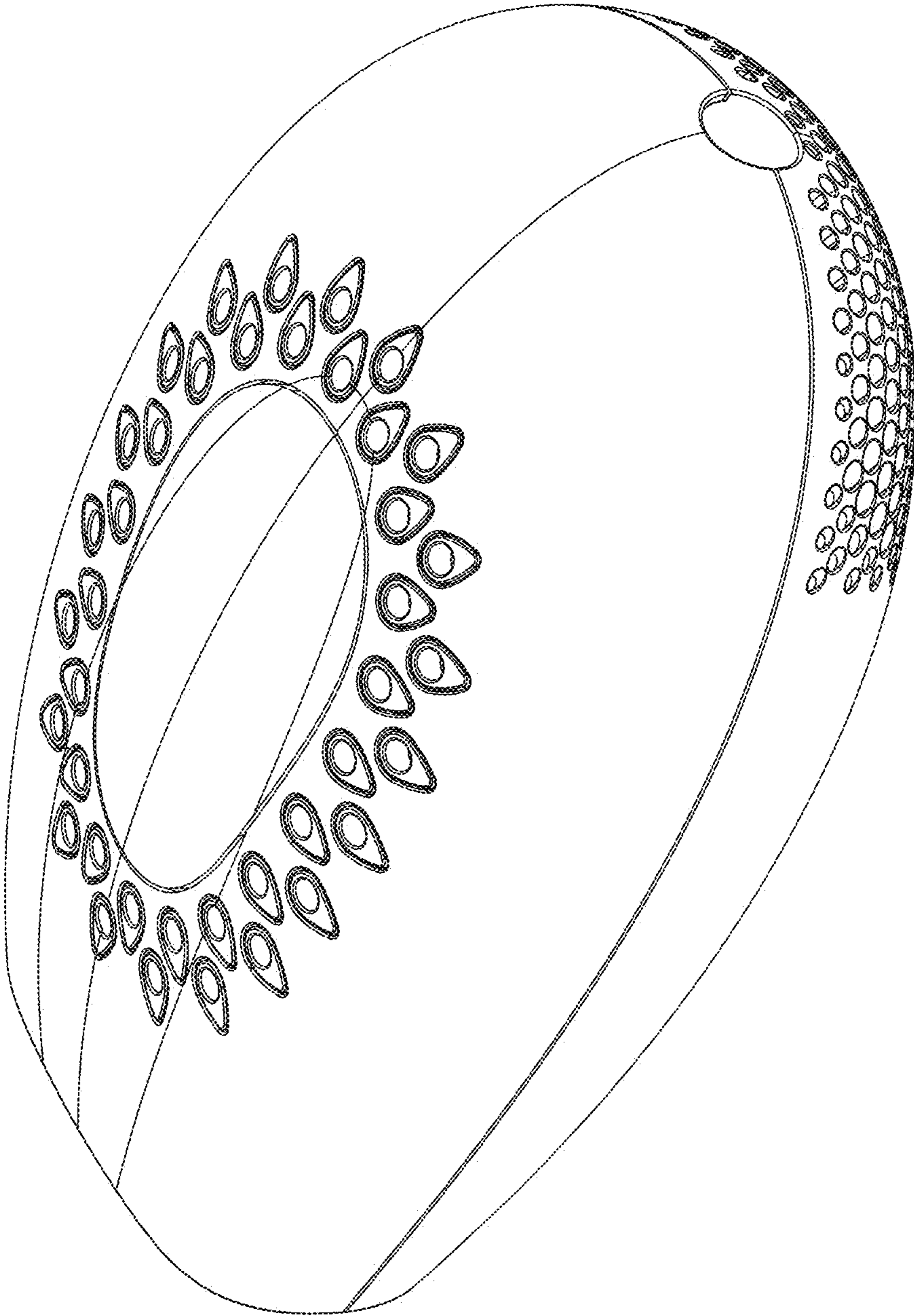

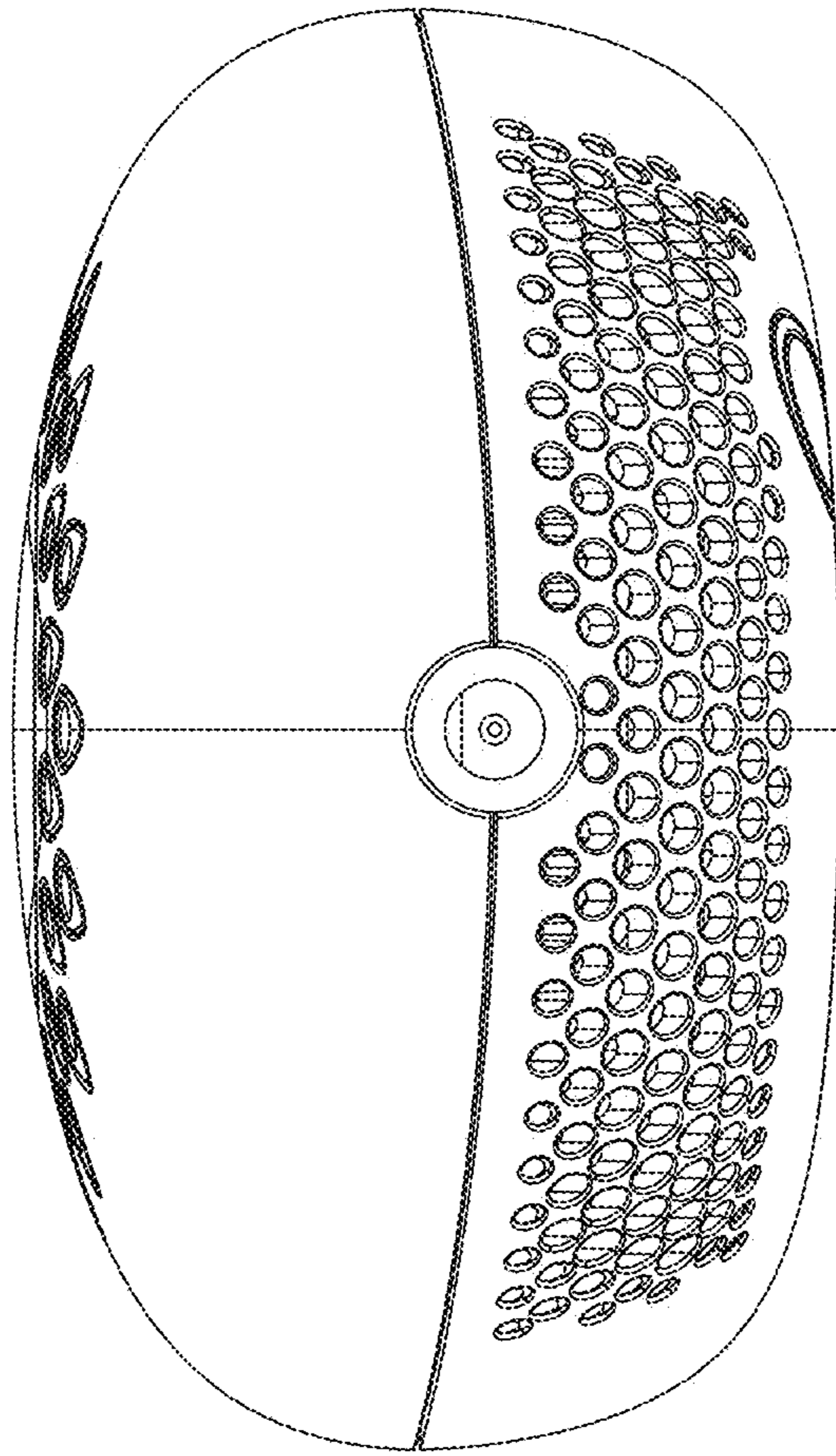

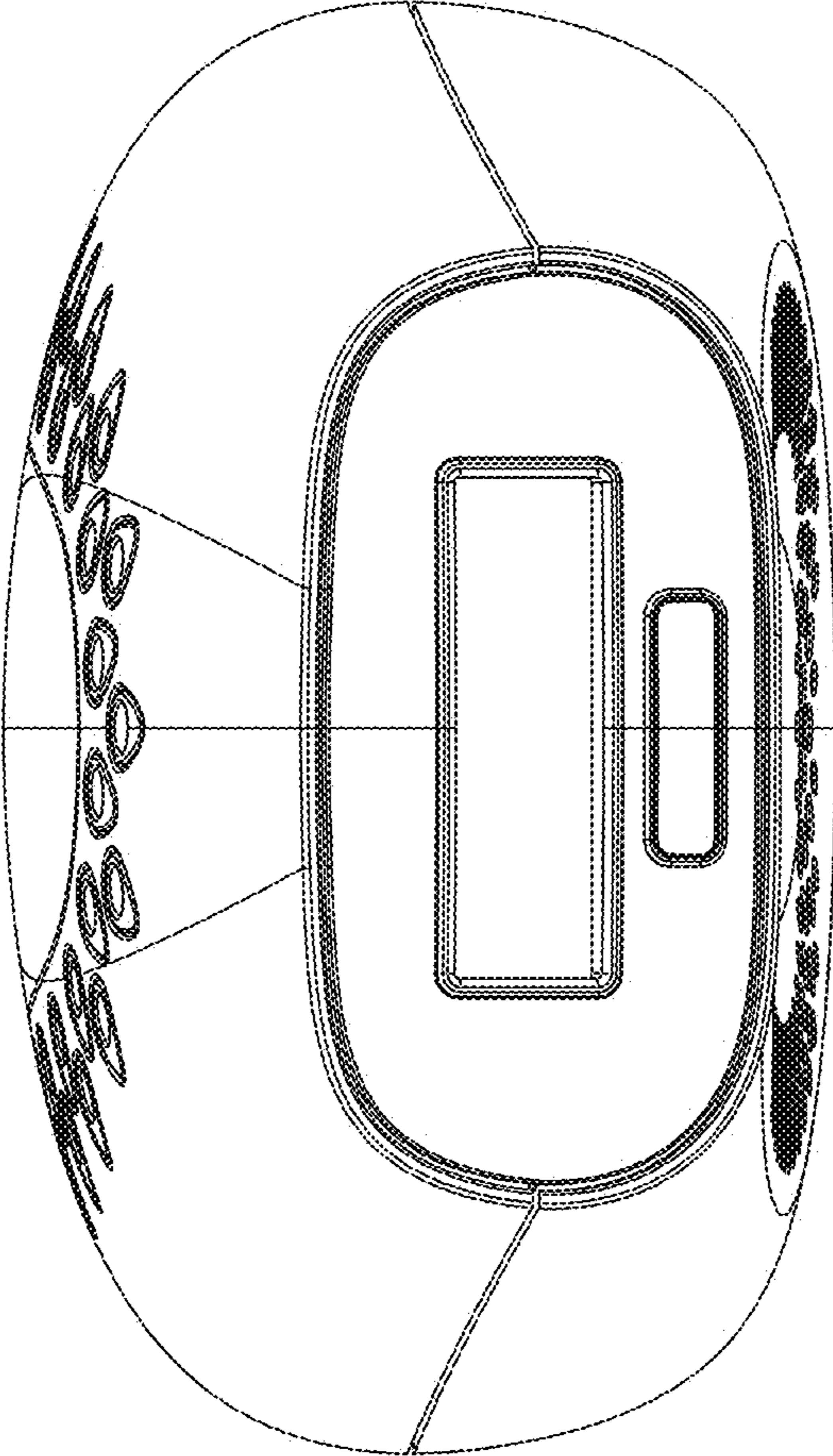

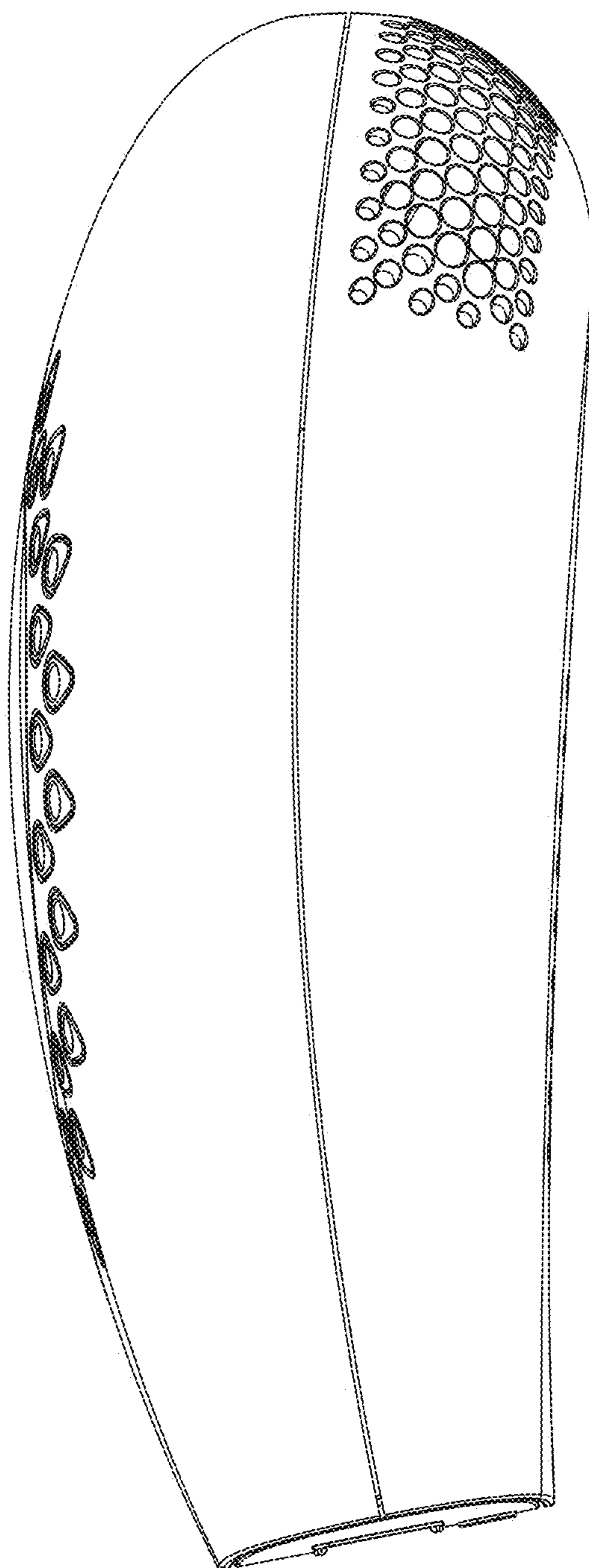

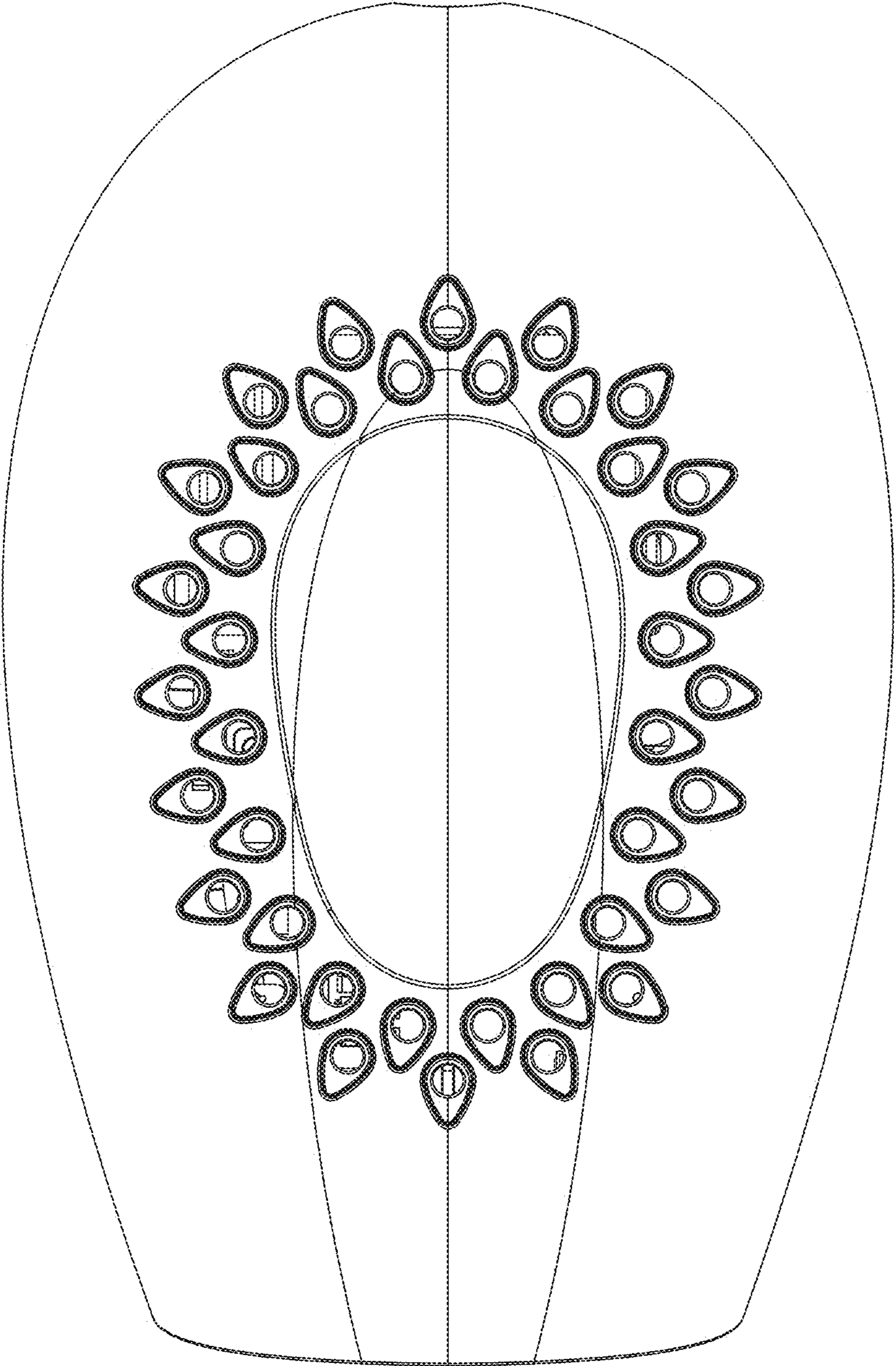

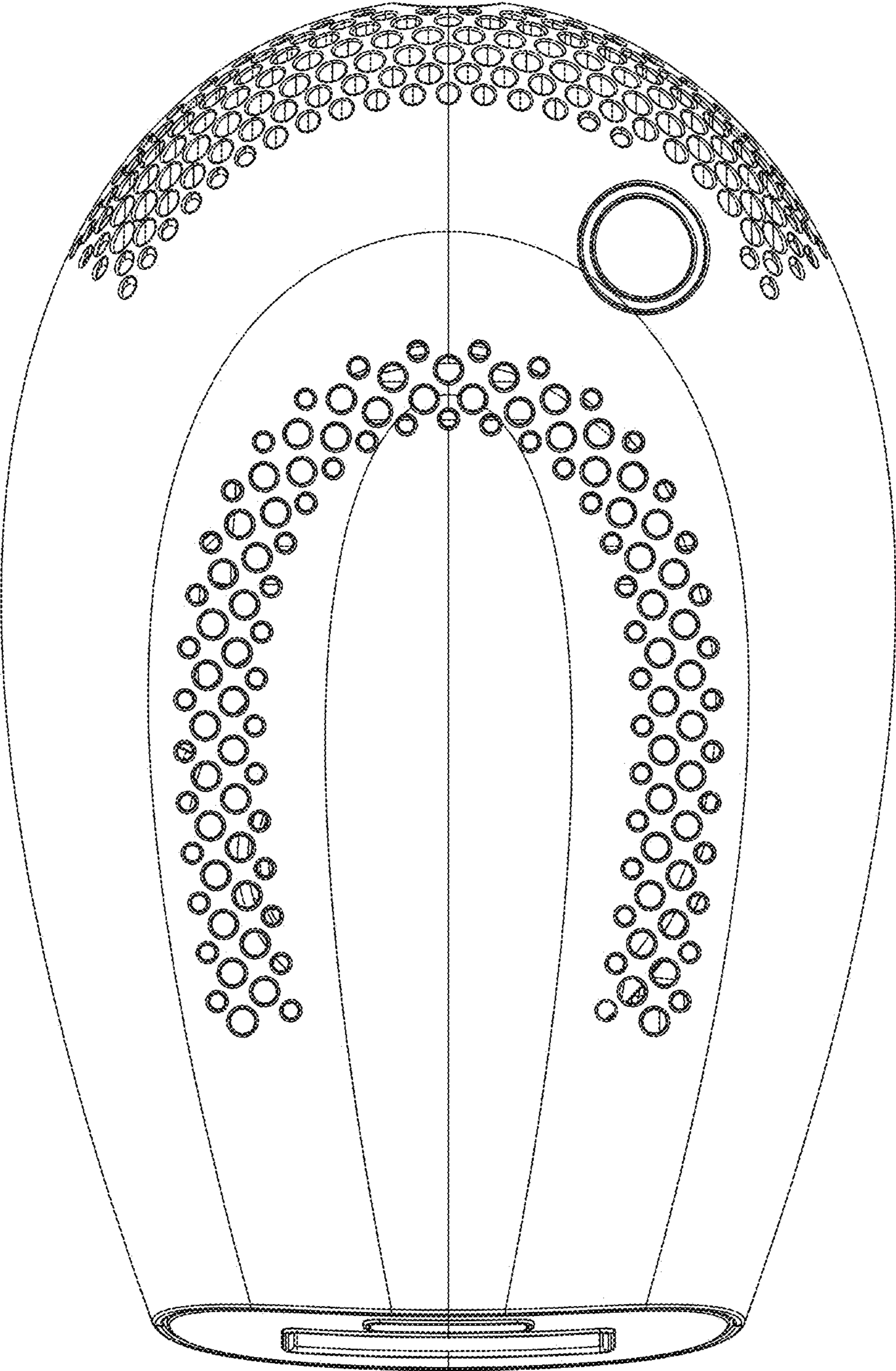
