(57) **CLAIM**

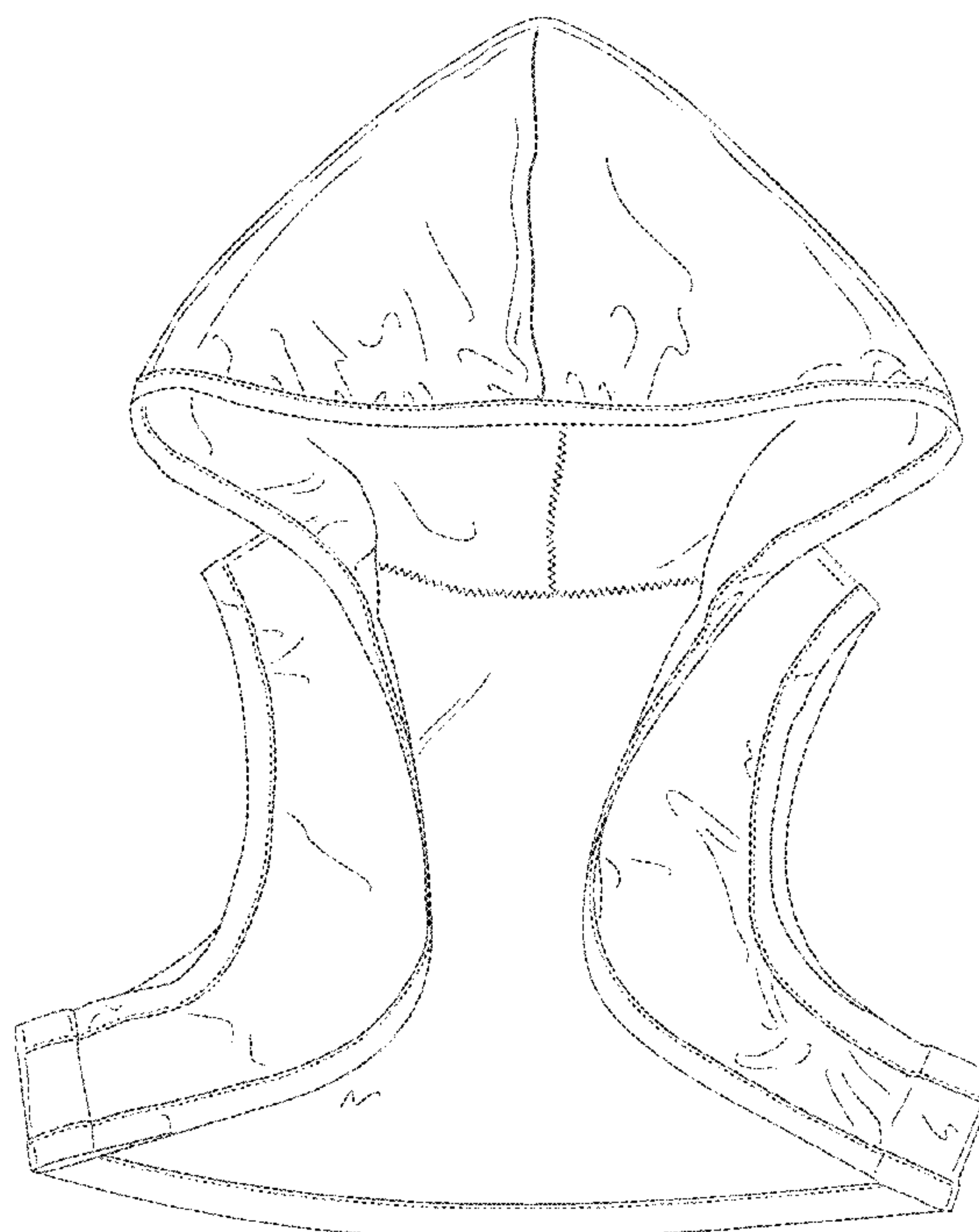
The ornamental design for a hood garment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a hood garment shown with the vest portion in a closed position,;
FIG. 2 is a back elevational view thereof;
FIG. 3 is a side view of a the hood garment; and,
FIG. 4 is a front elevational view of the hood garment shown with the vest portion in an open position, with a flattened hood.

The short dash dashed broken line appearing on the surface of the garment shown in the drawings indicate stitching and are part of the claim.

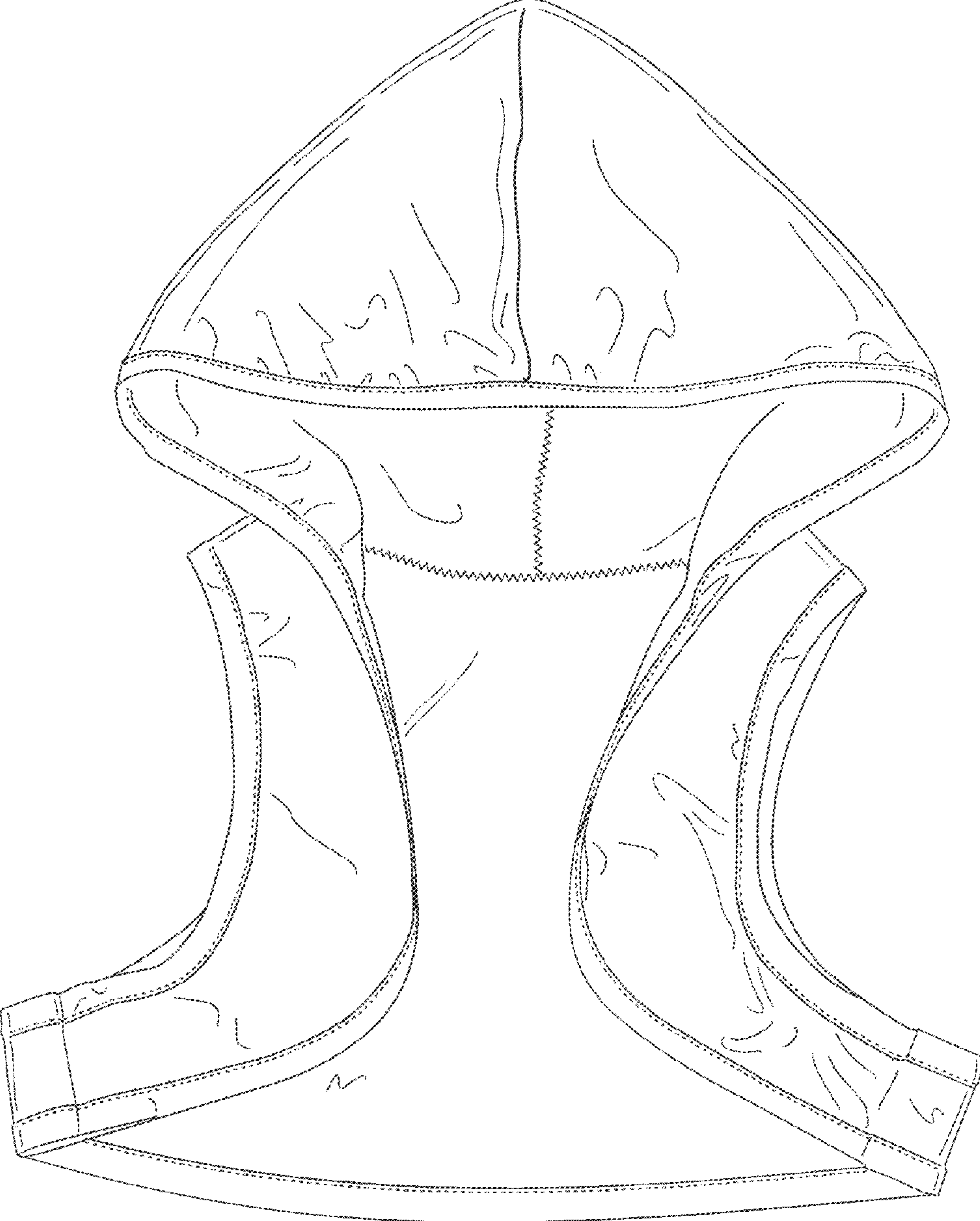

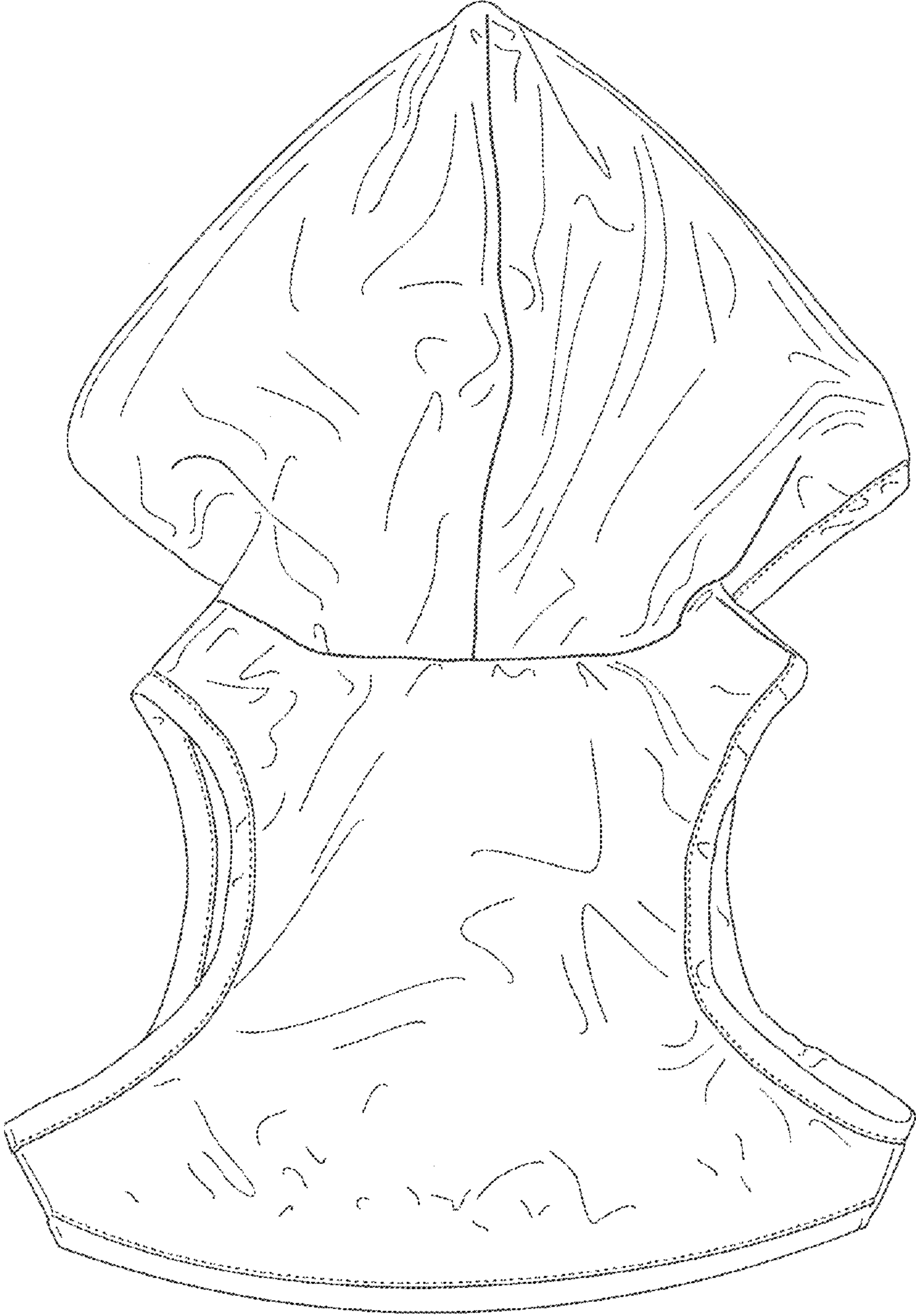

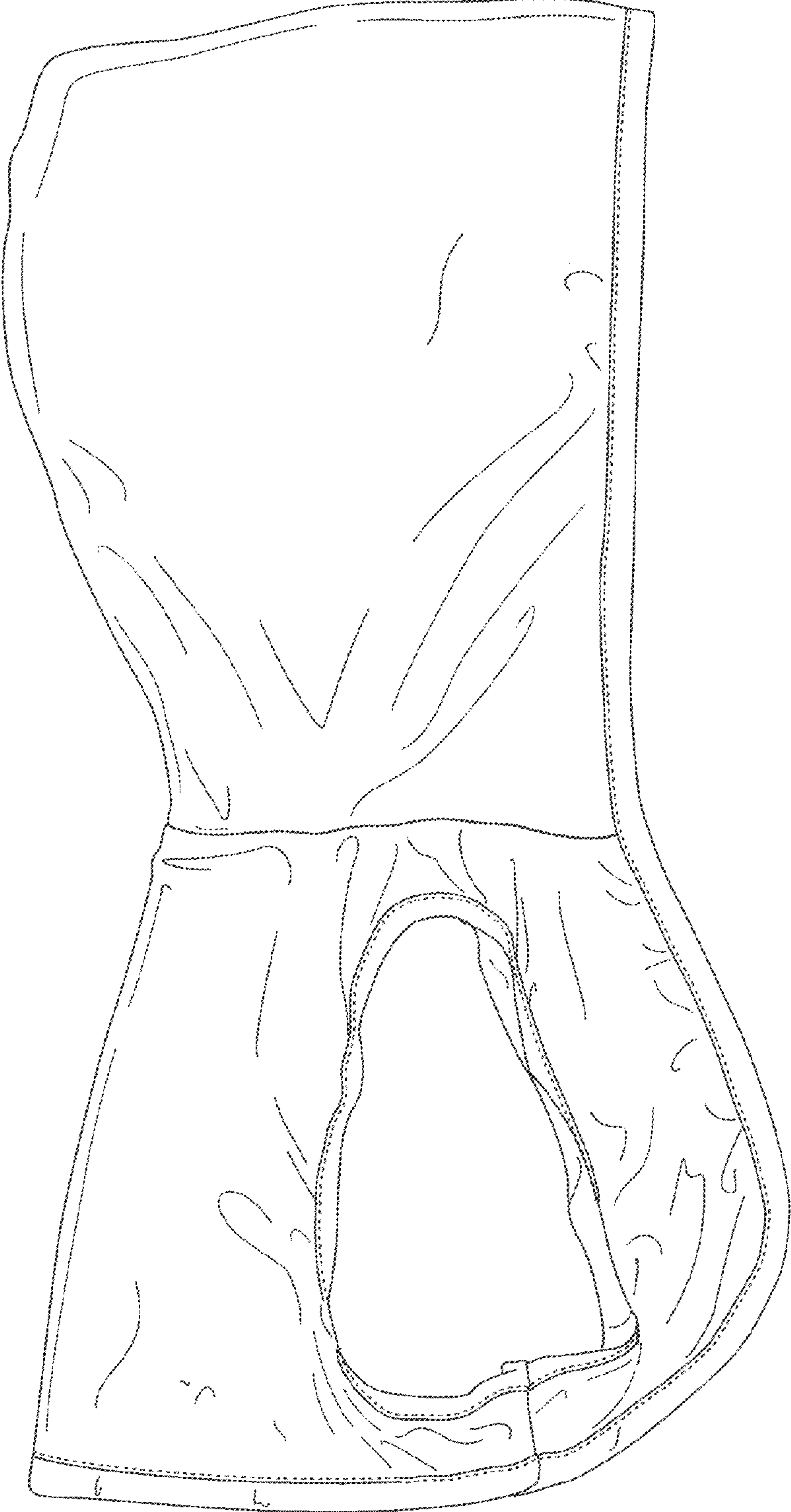

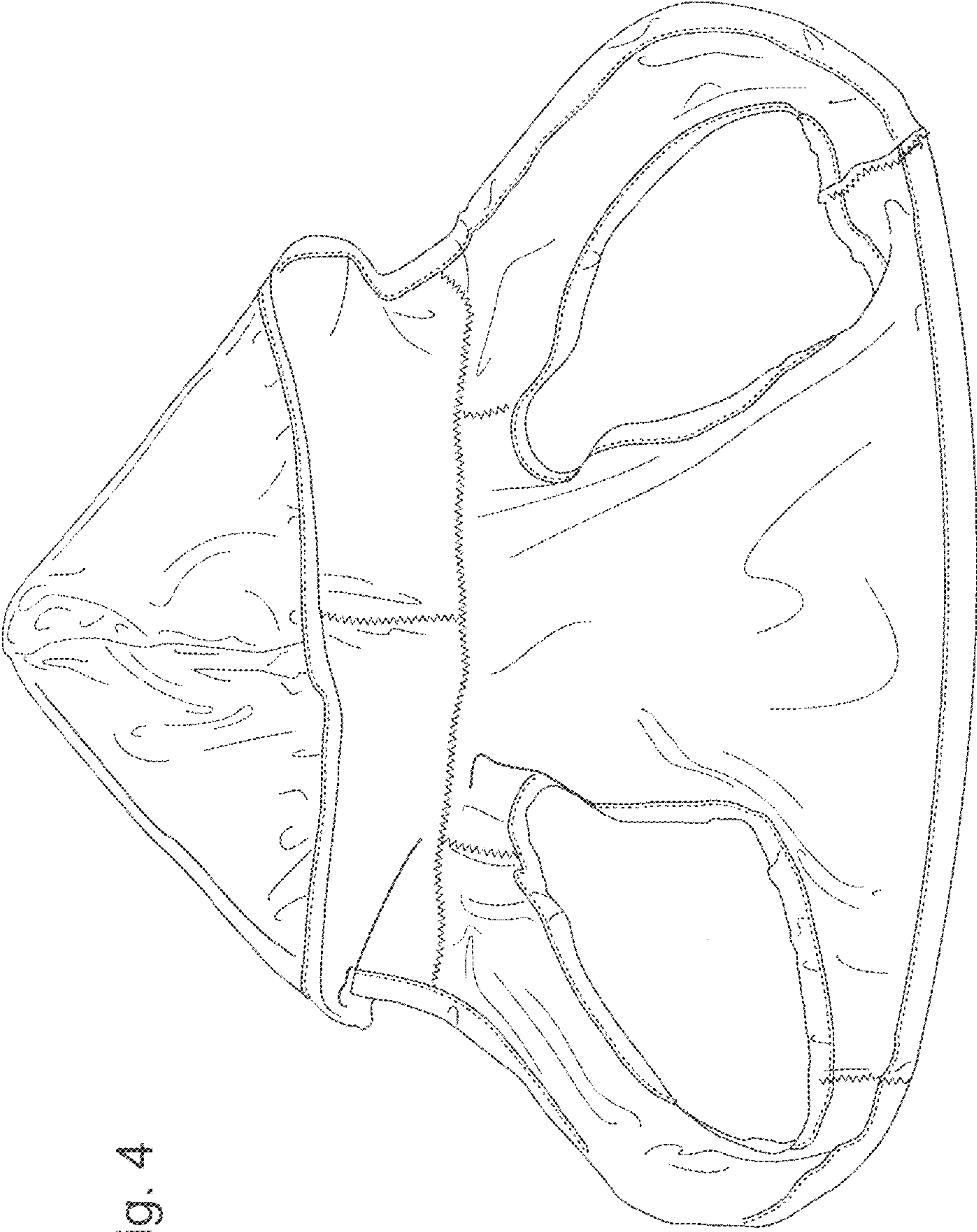
