DESCRIPTION

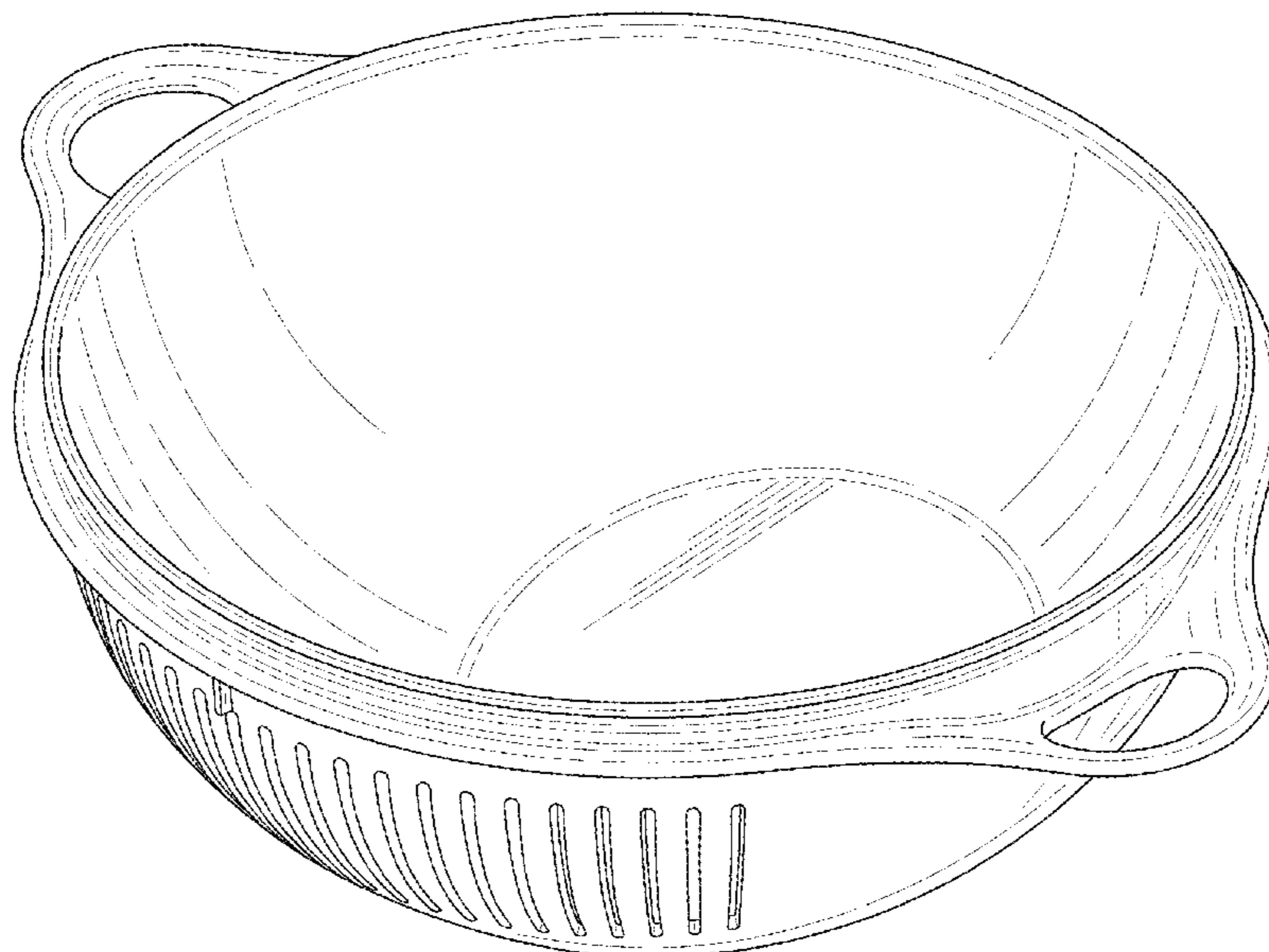
FIG. 1 is a top, side and front perspective view of a colander showing our new design;

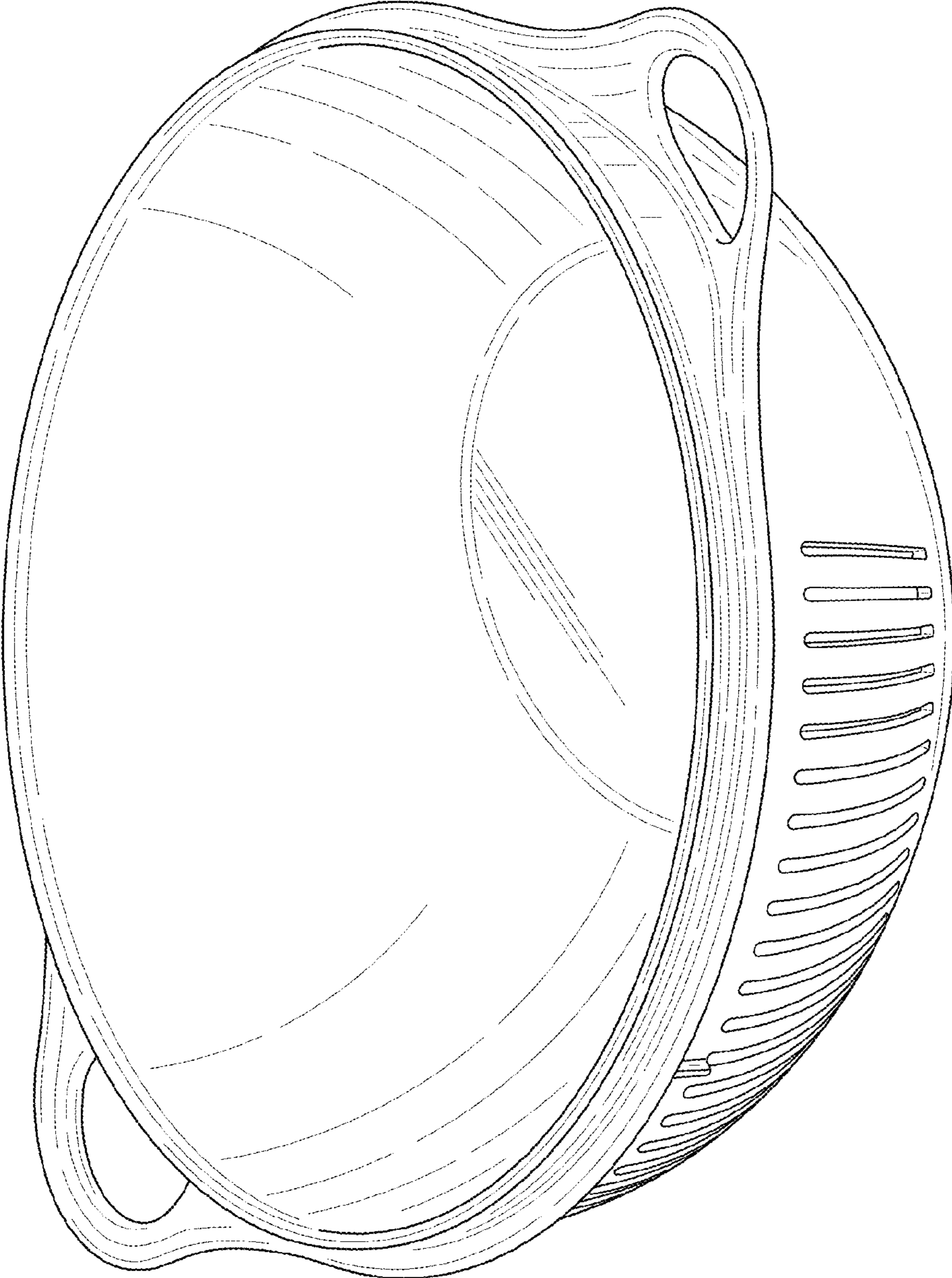

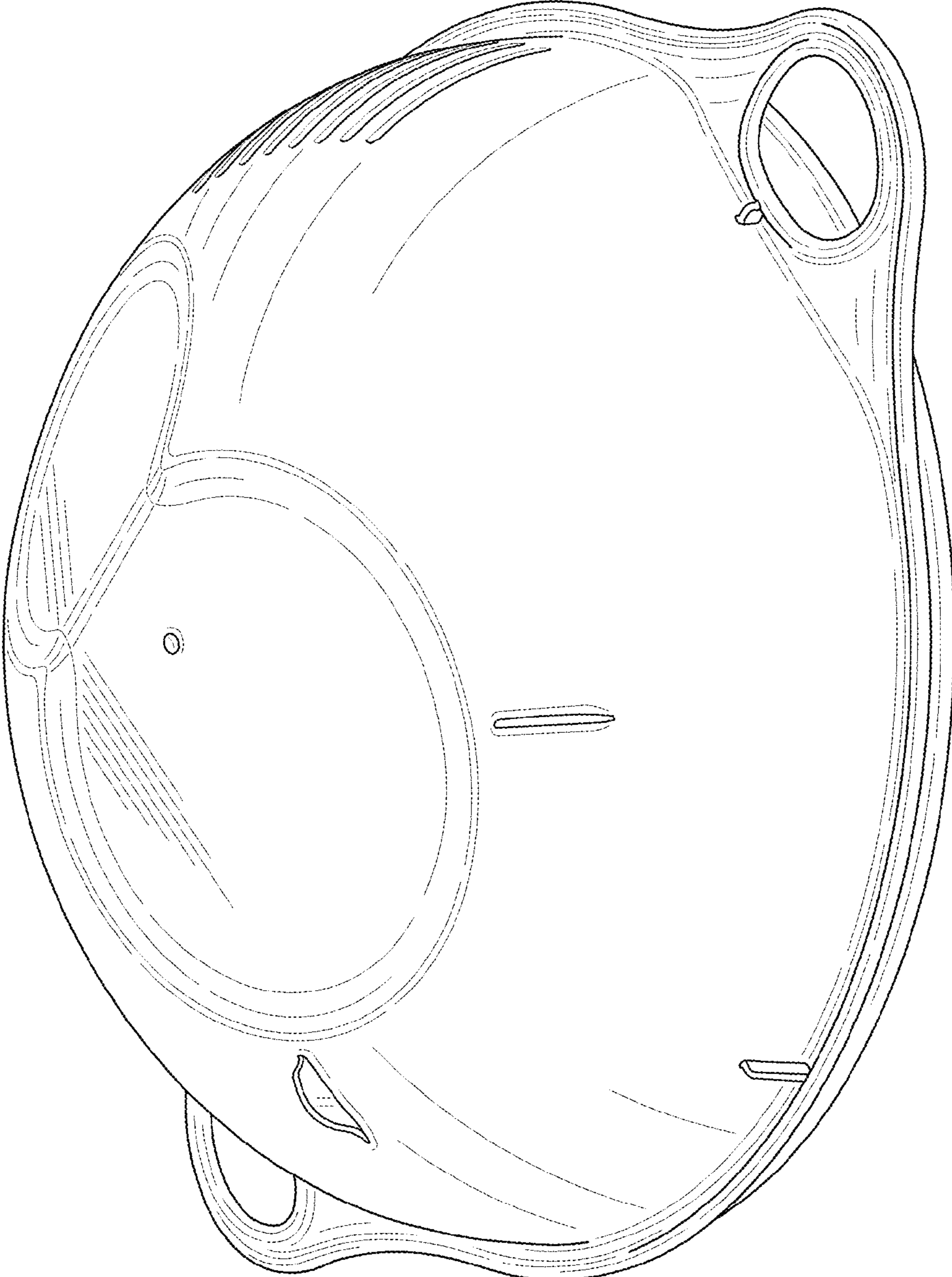

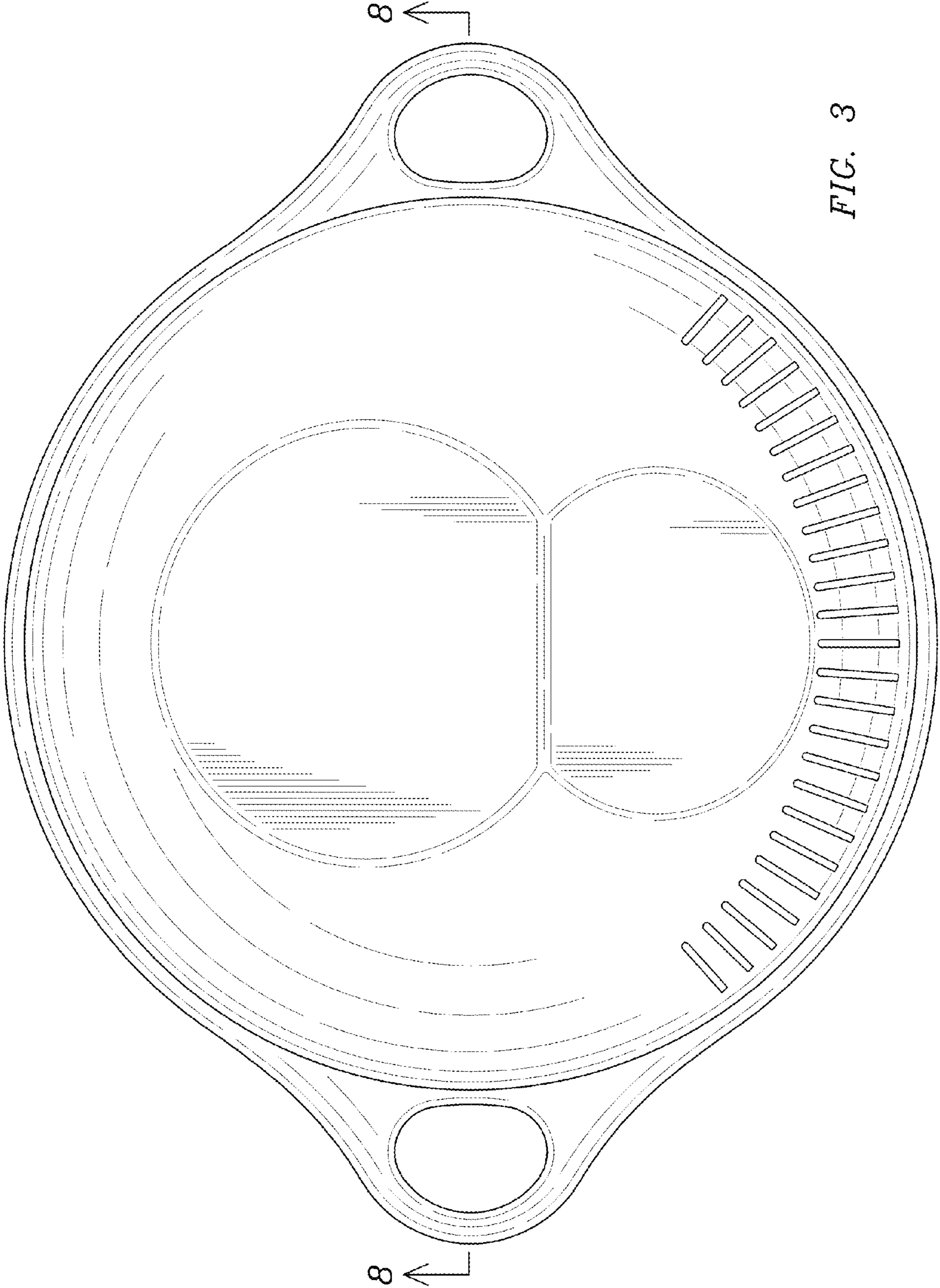

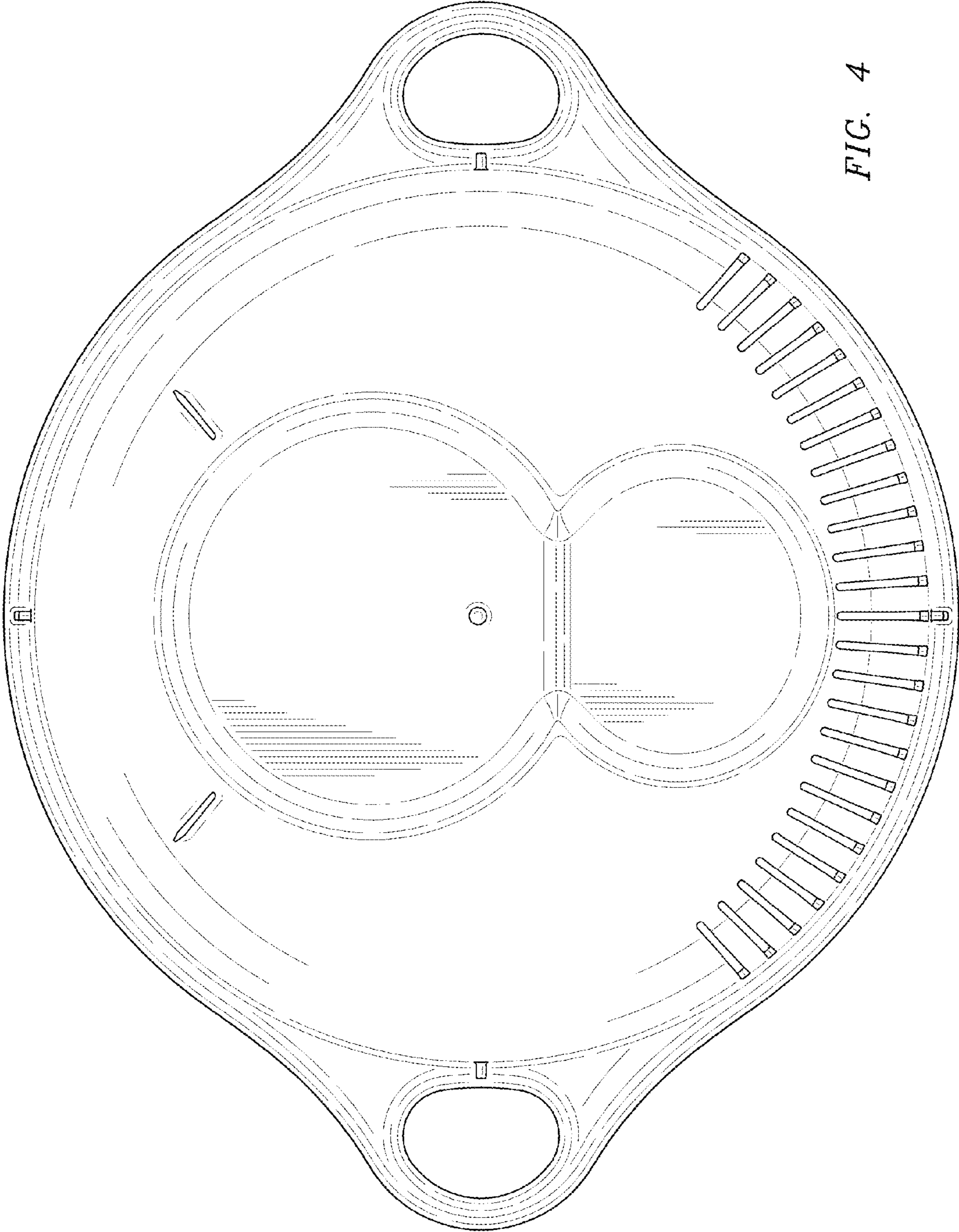

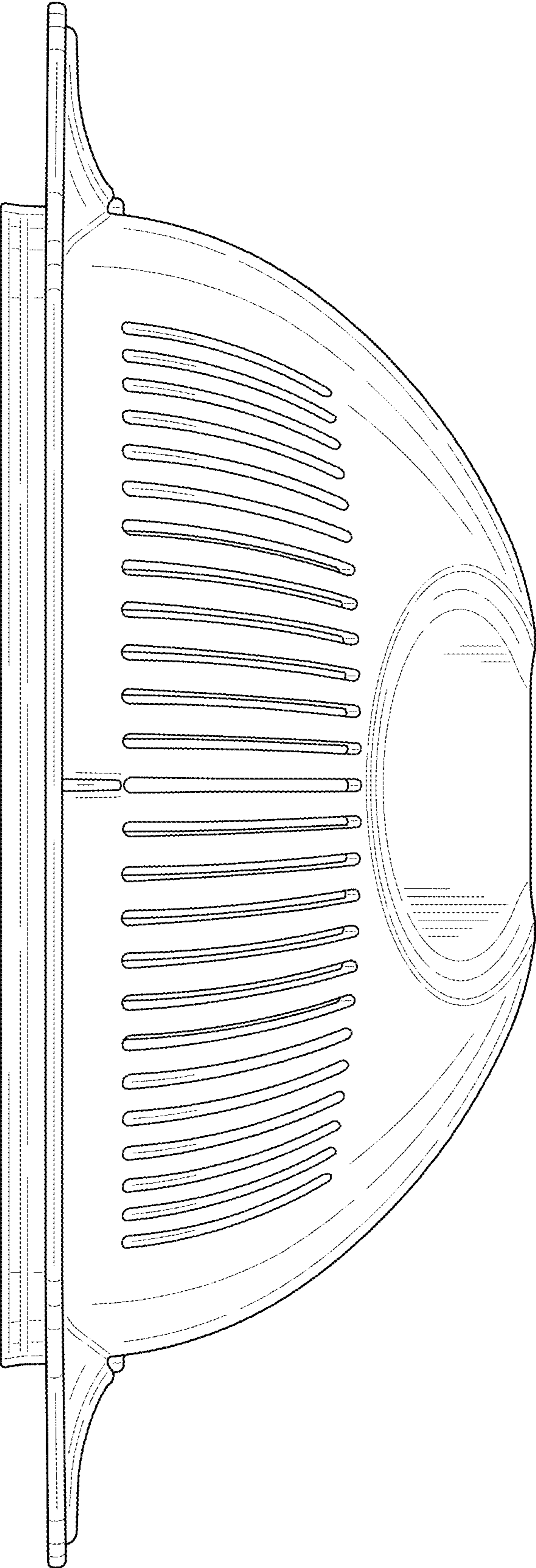

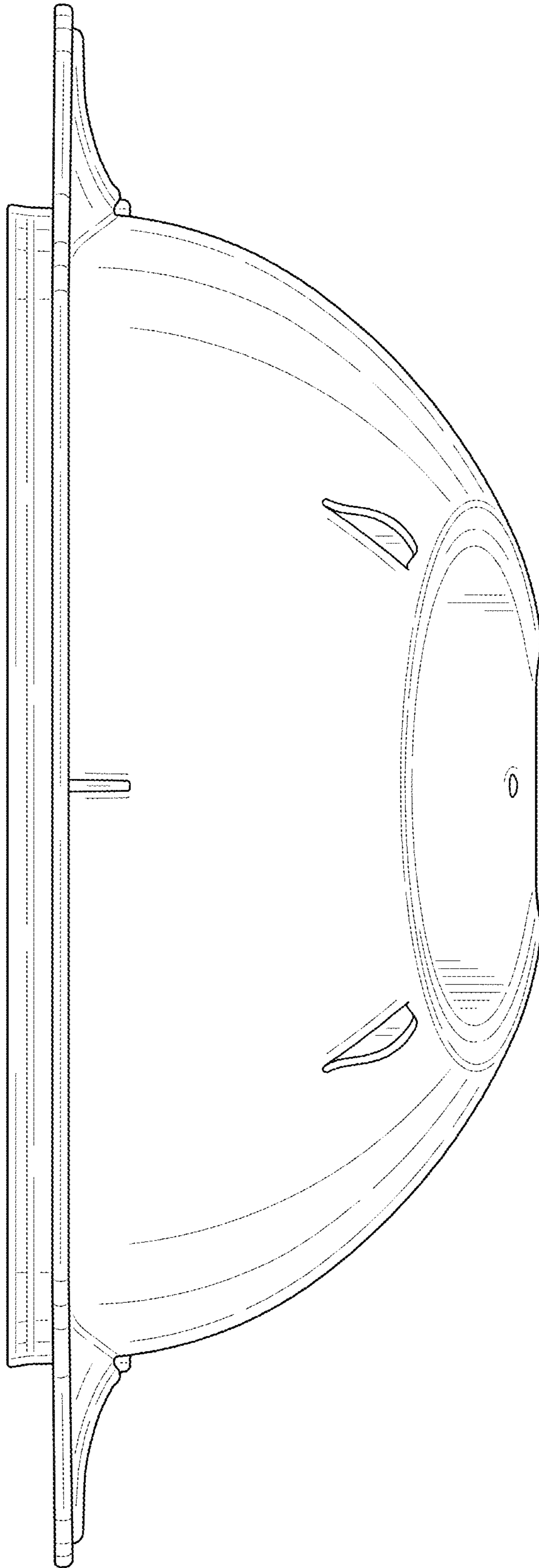

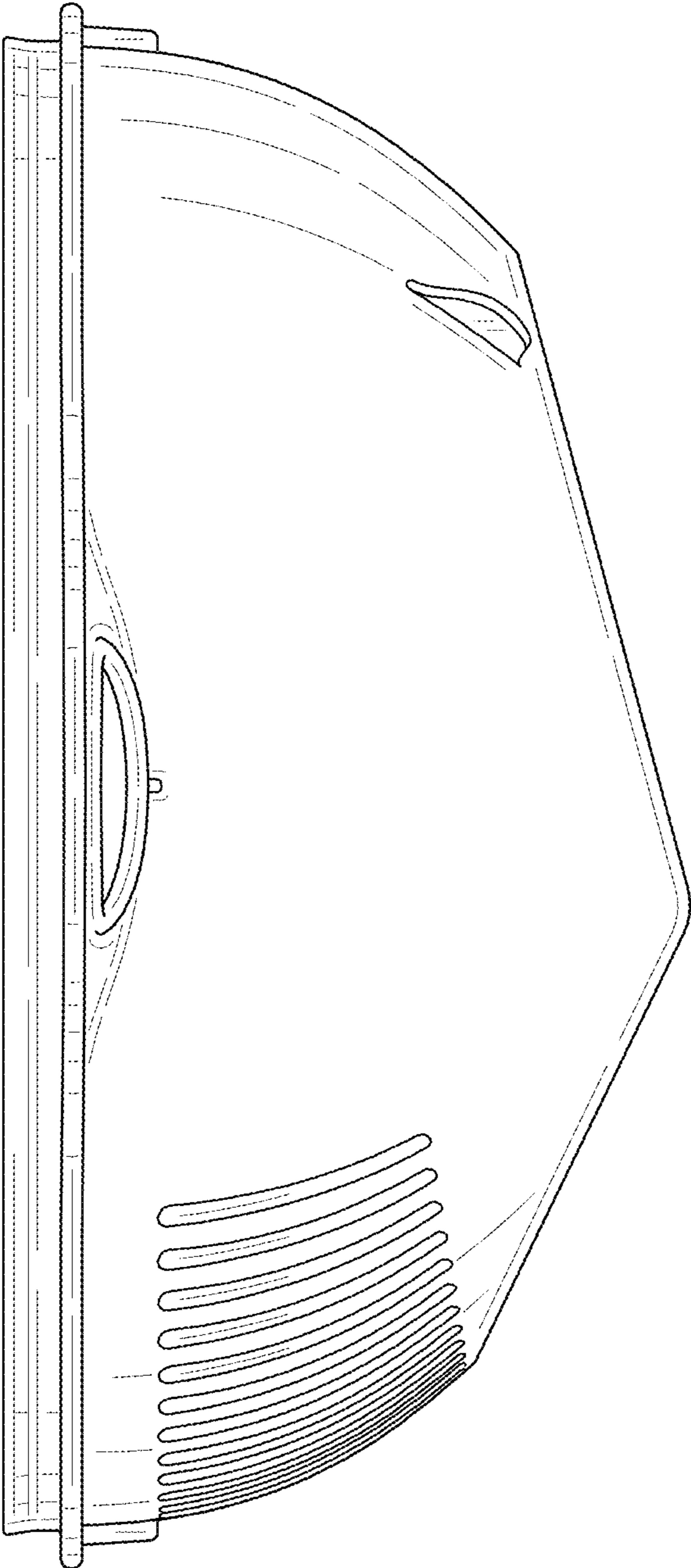

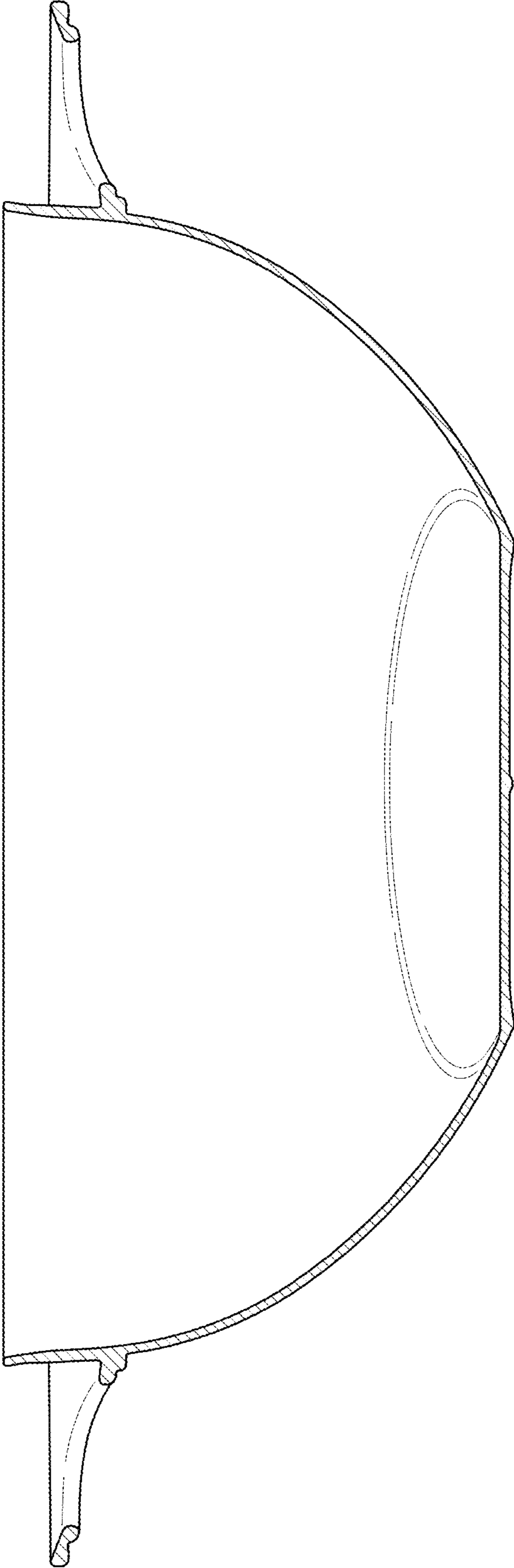
