The screw holes shown in broken lines in FIGS. 1 and 5 are for illustrative purposes only and do not form part of my claimed design.

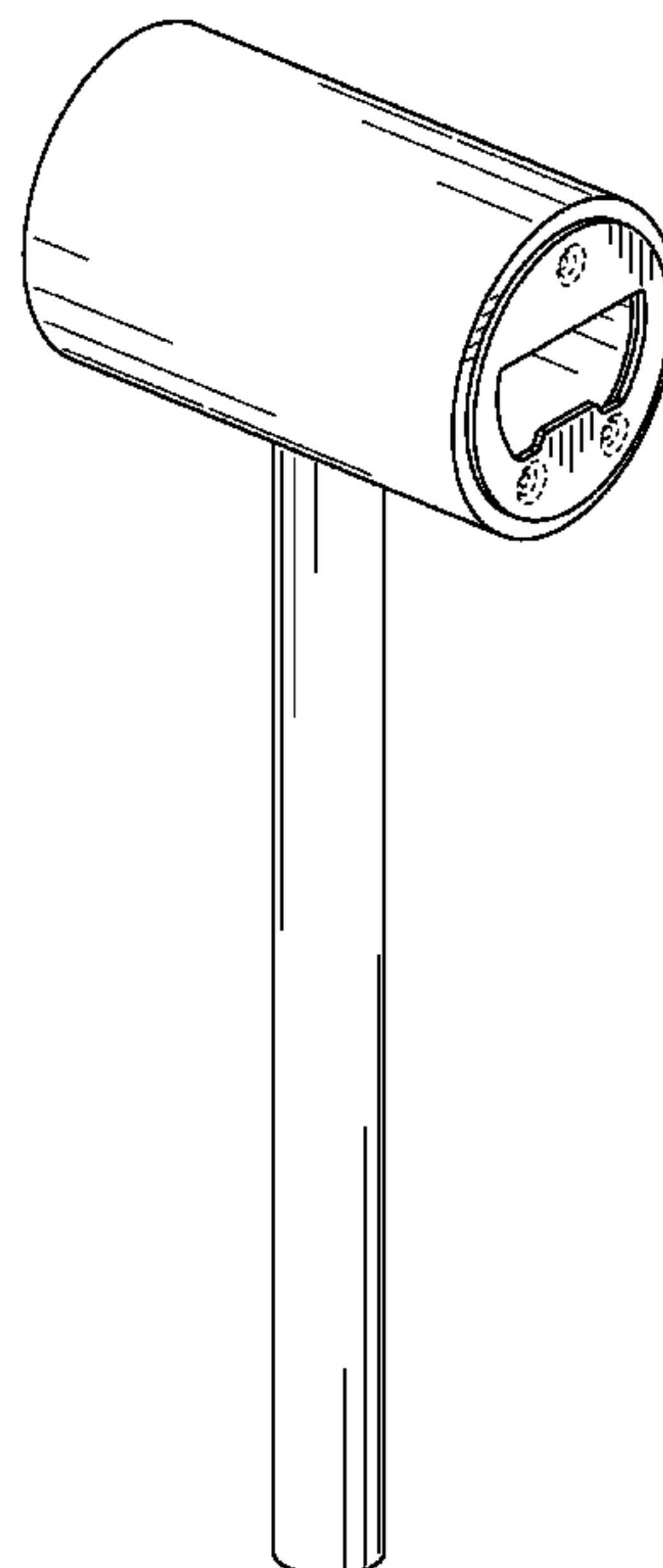

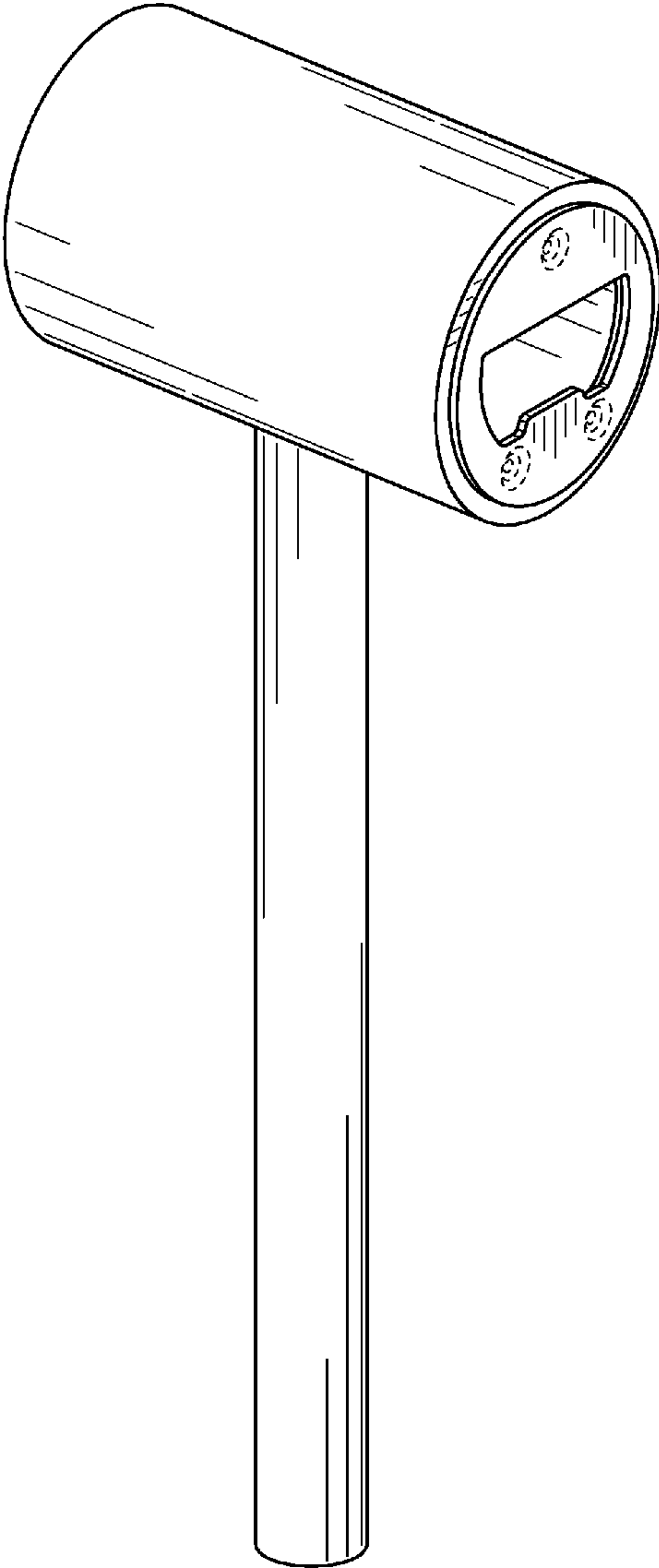

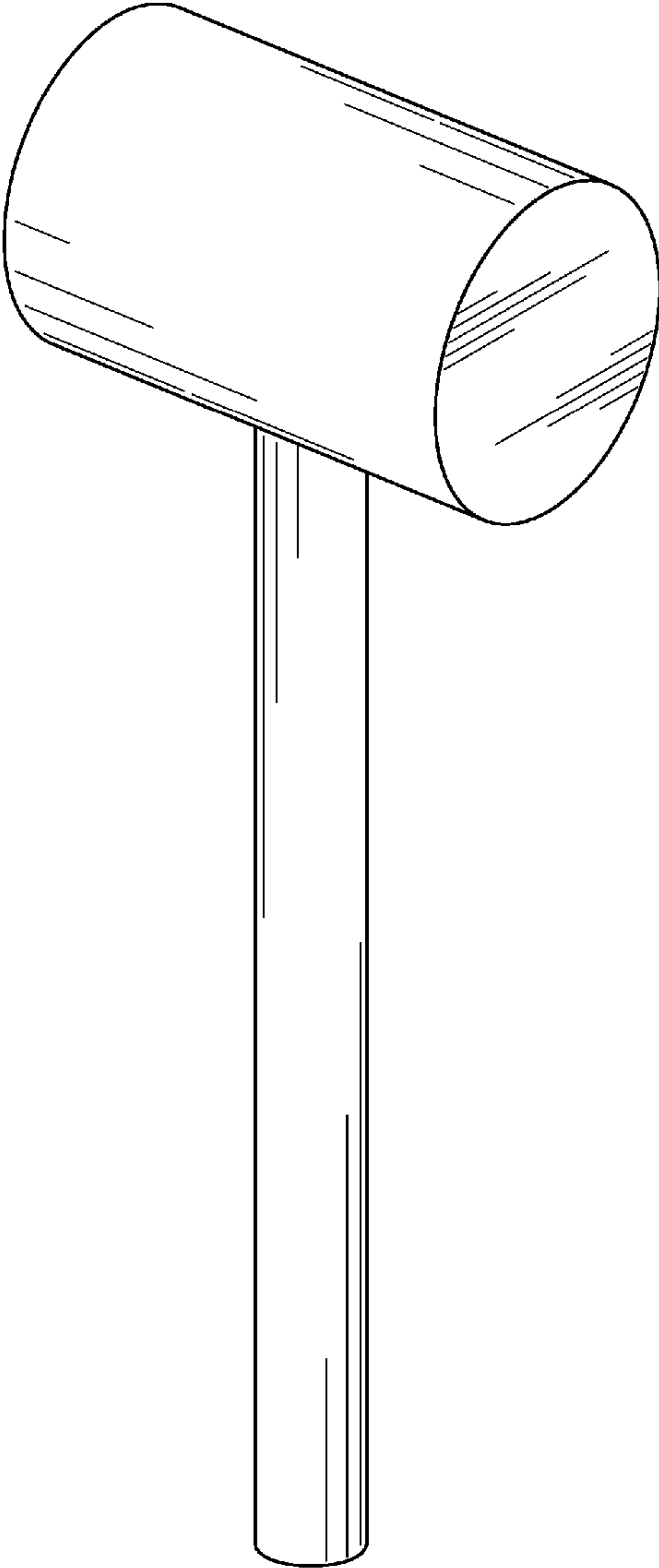

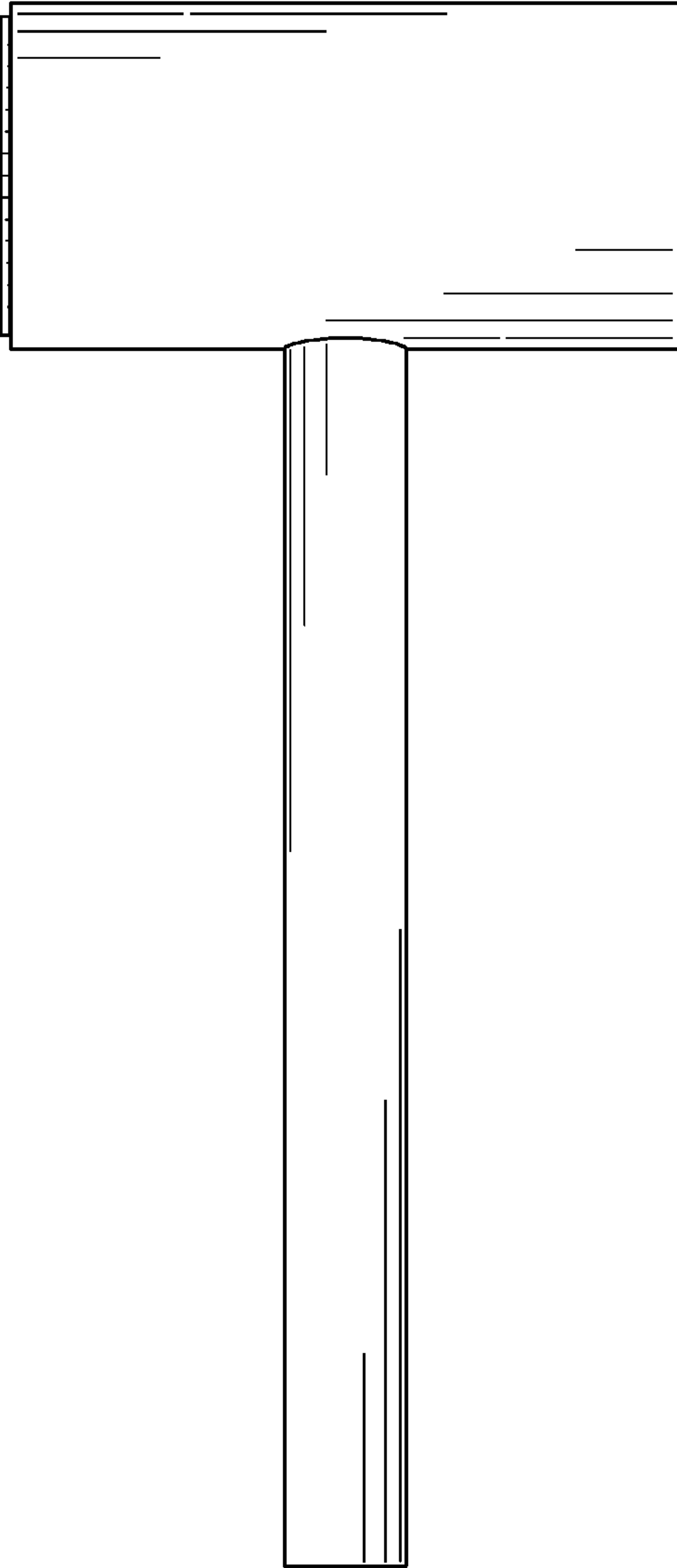

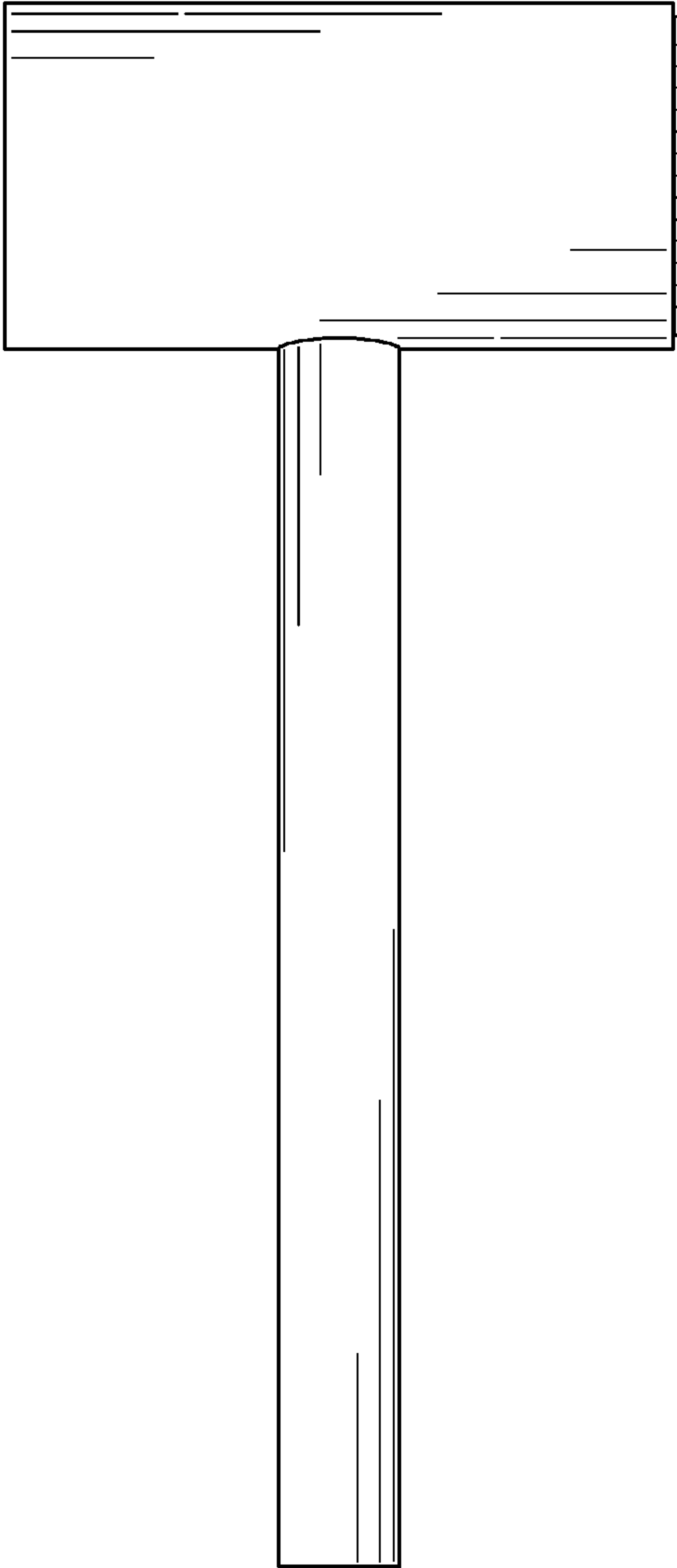

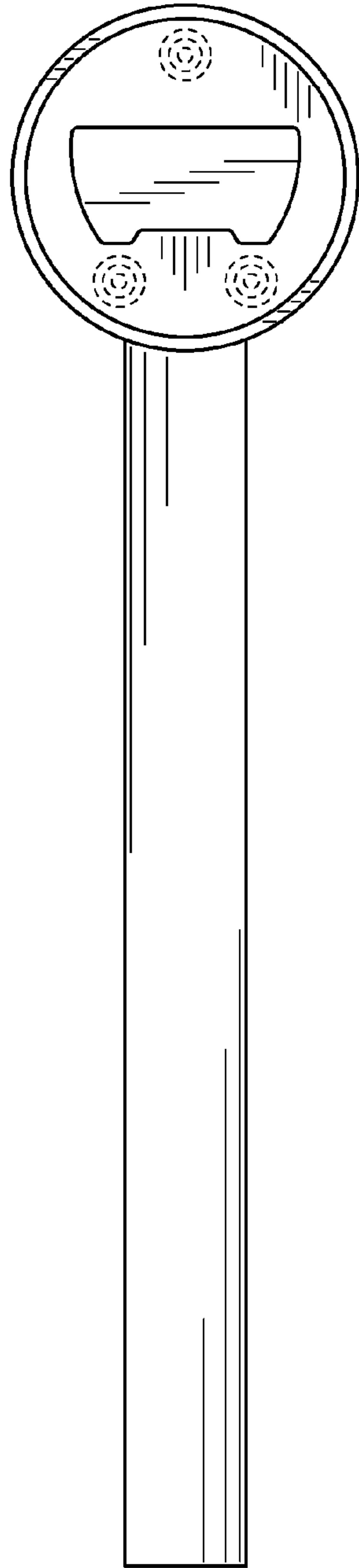

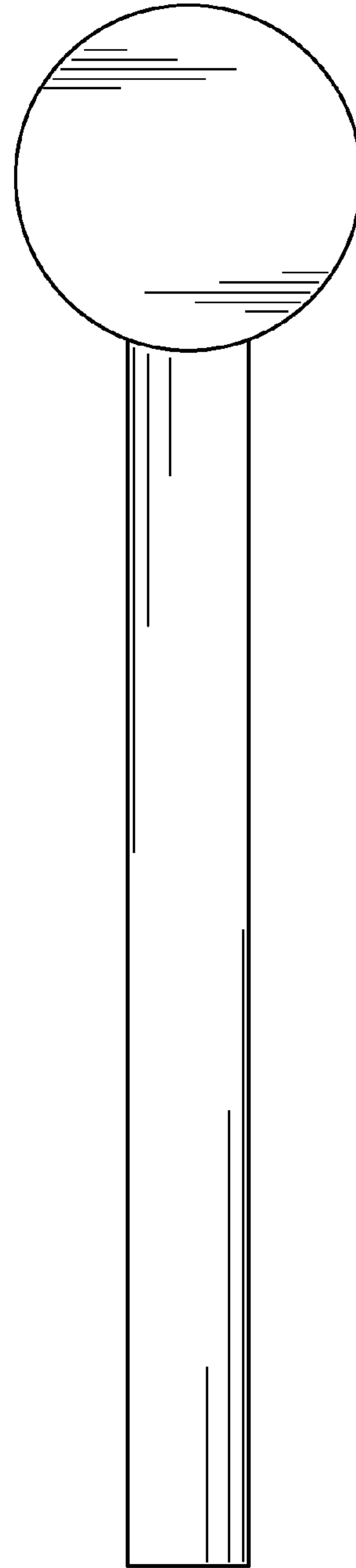

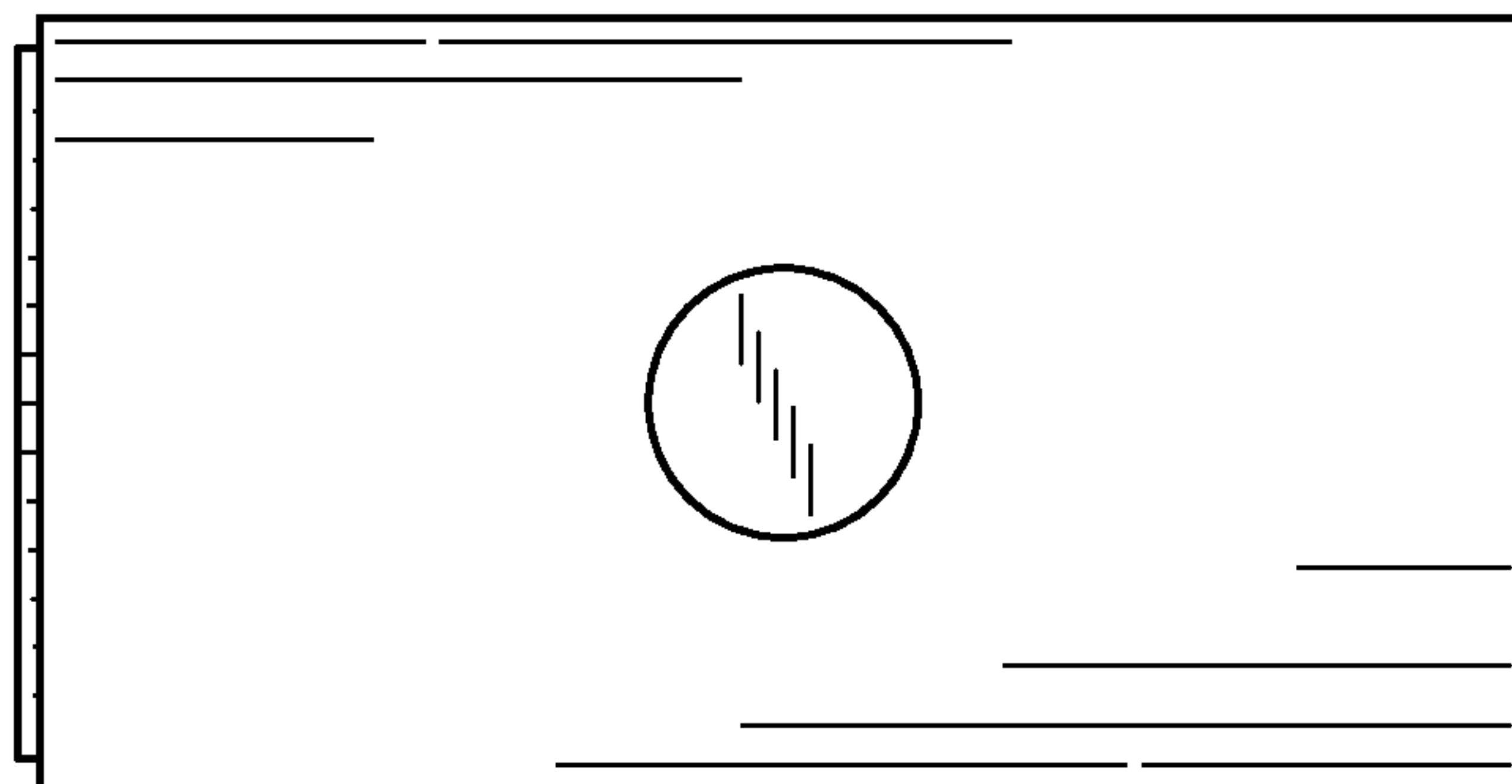
