FIG. 8 is a left side elevation view of the claimed design of FIG. 1.

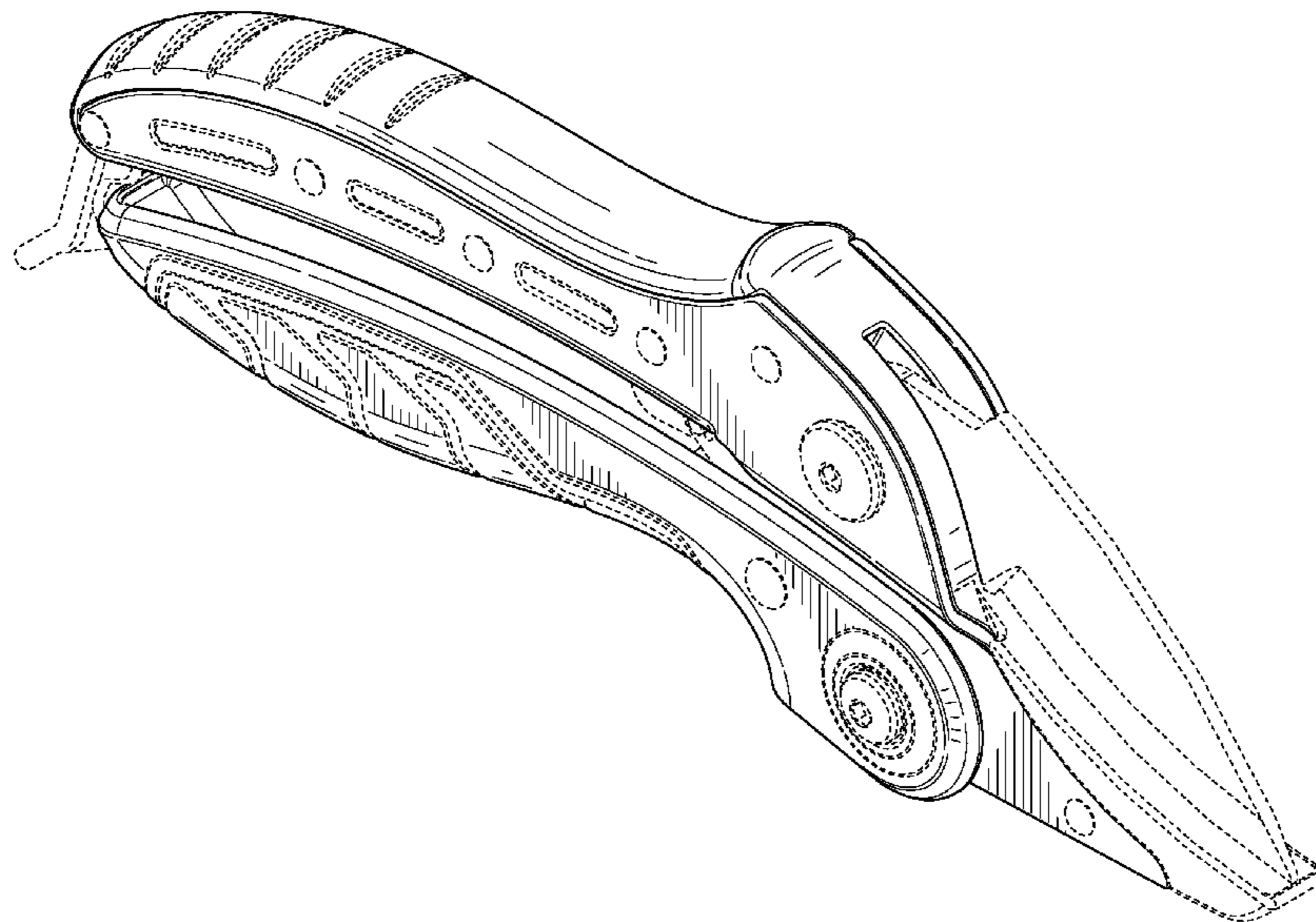
The broken lines represent portions of the pruner and form no part of the claimed design.

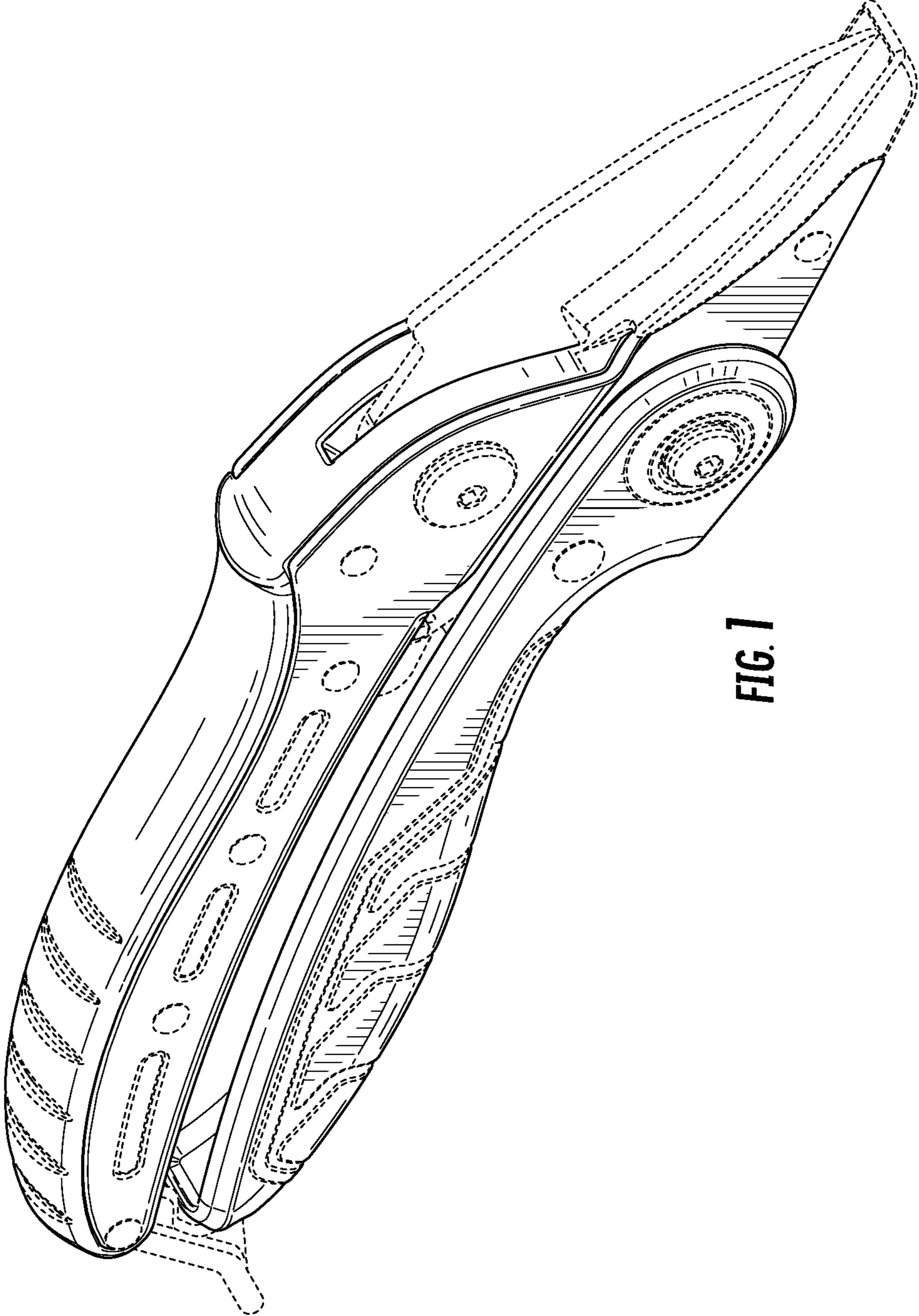

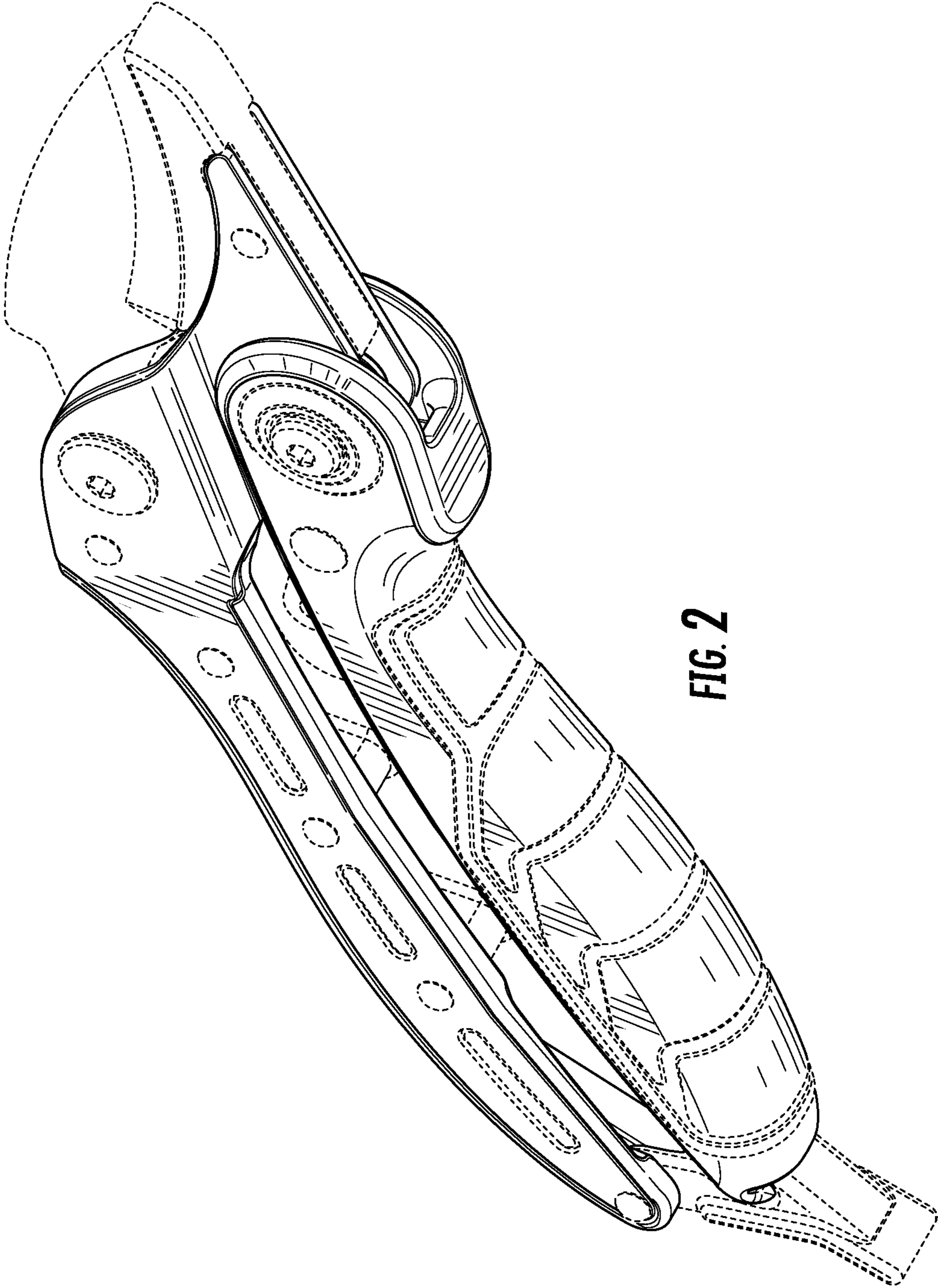

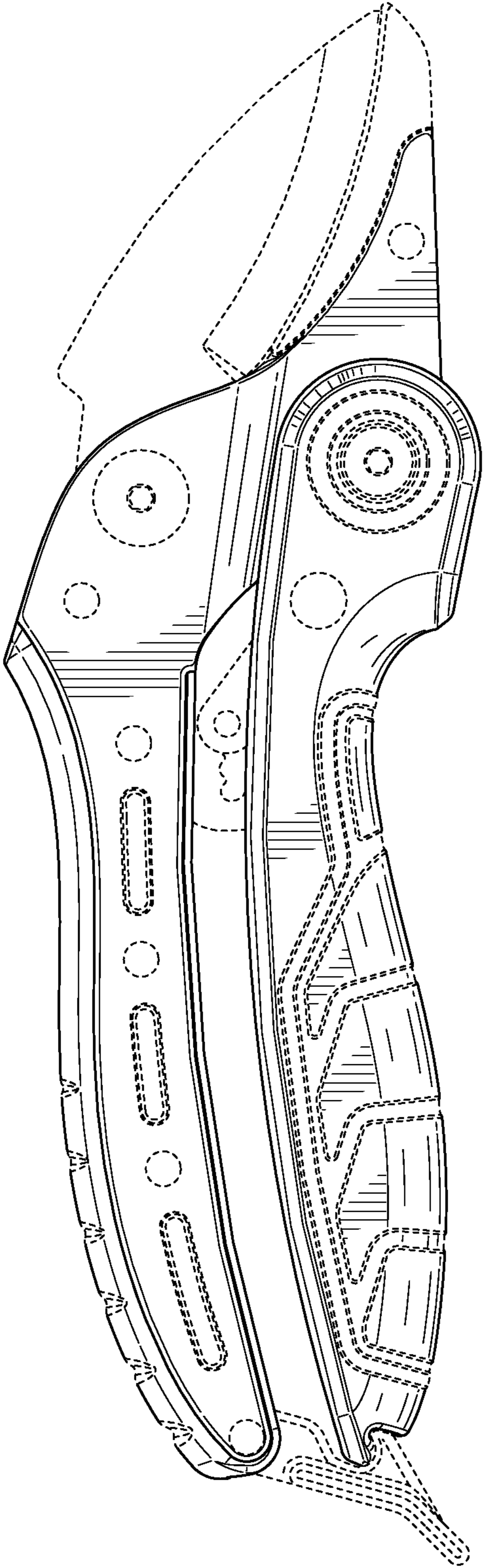

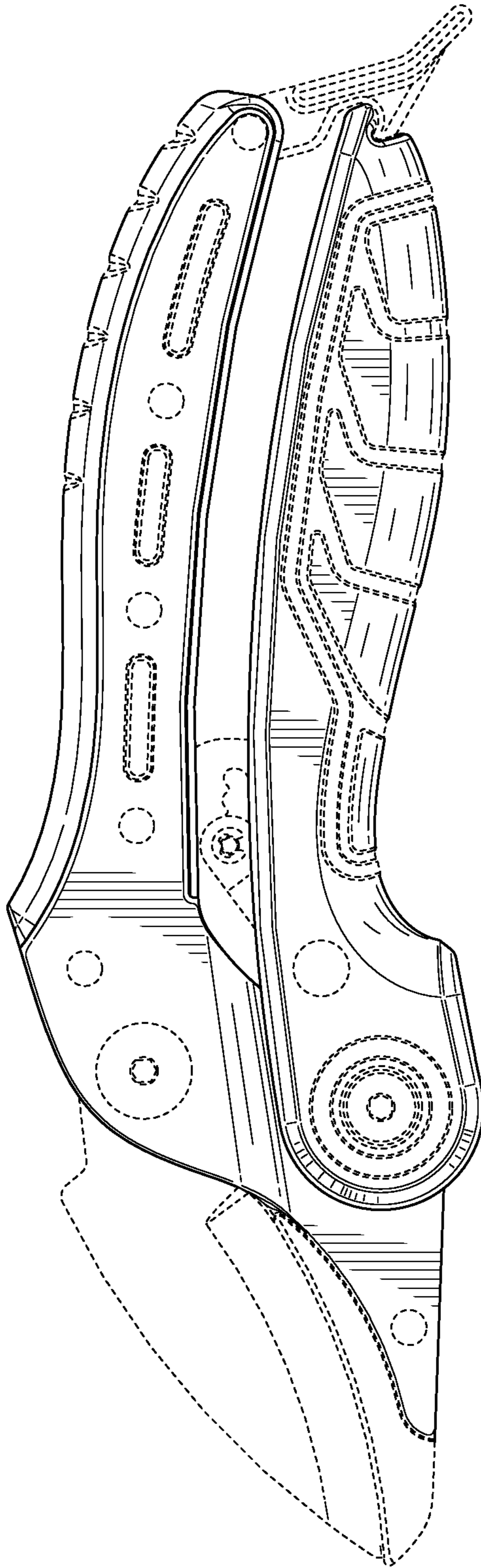

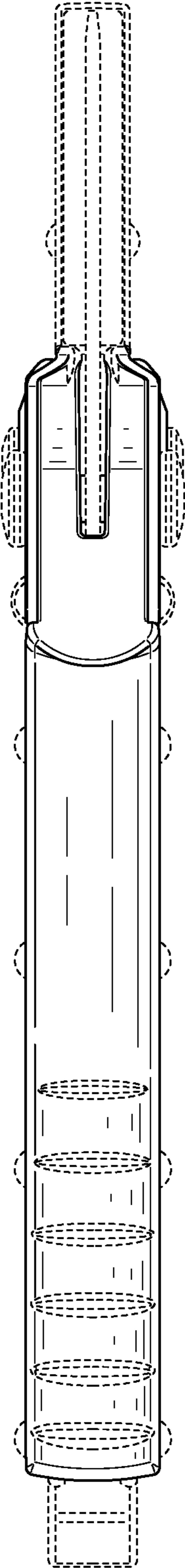

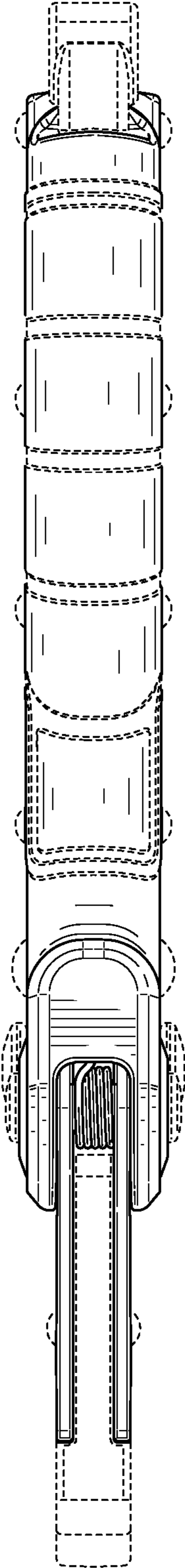

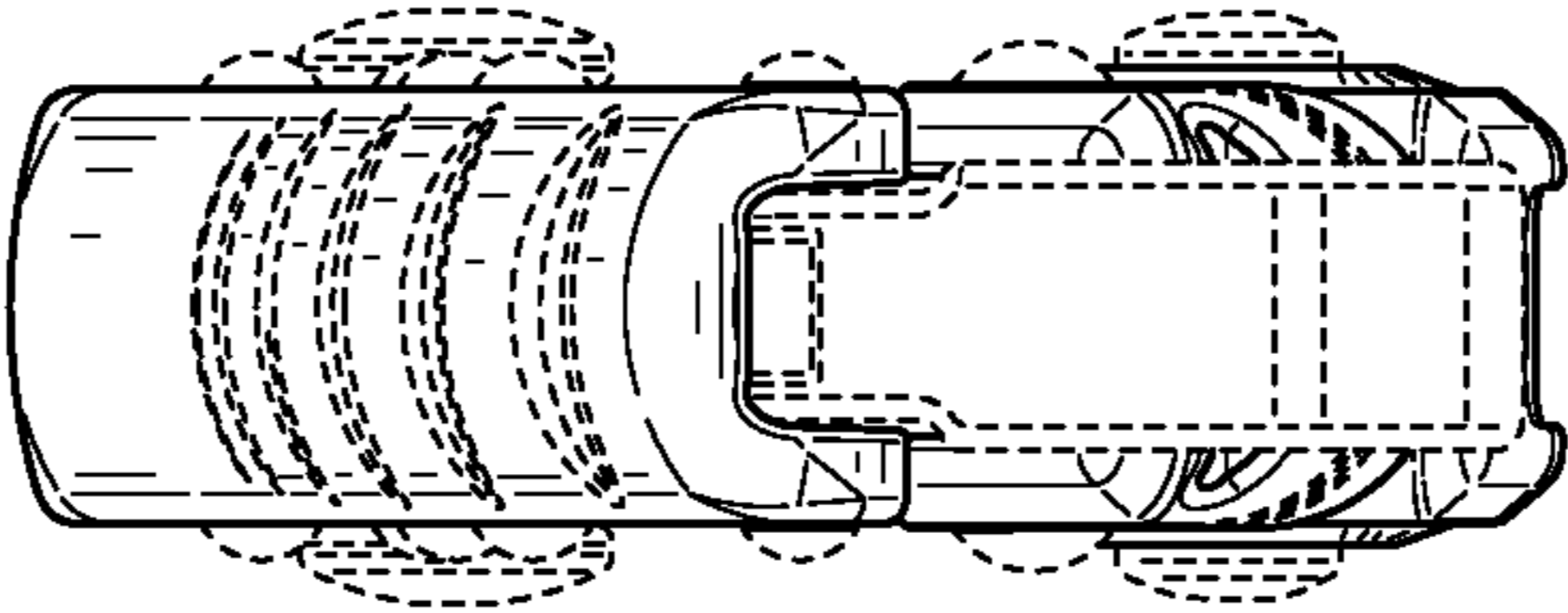

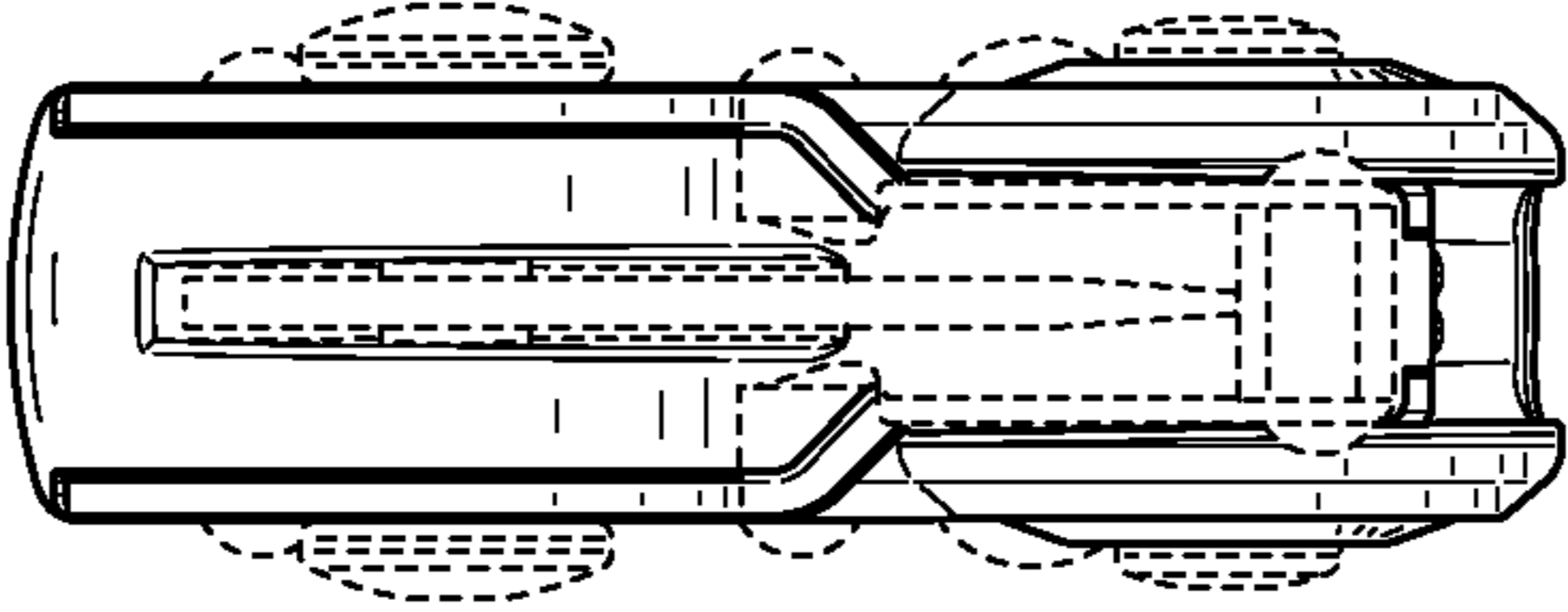
