(57) **CLAIM**

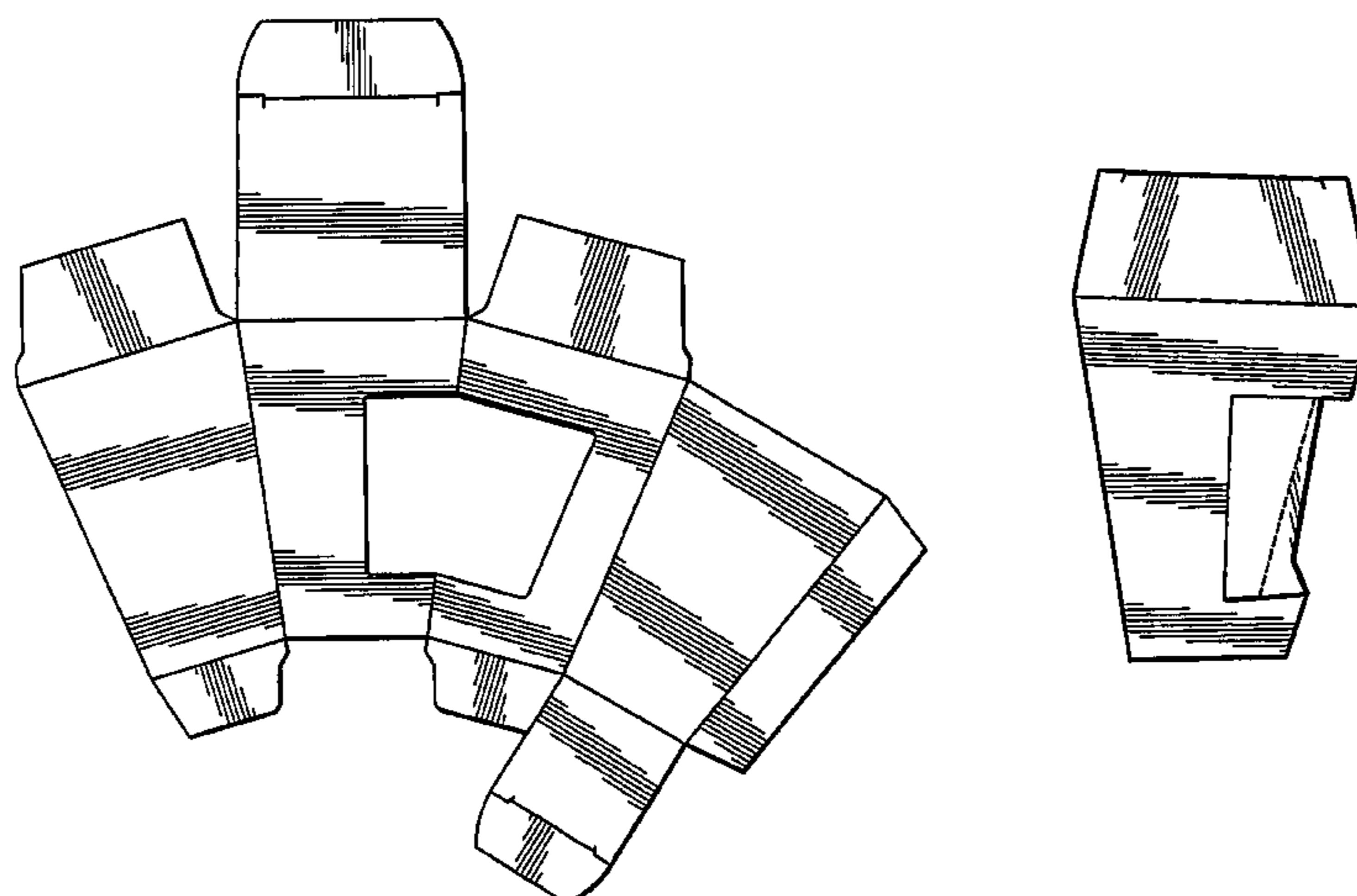
The ornamental design for a package for cup, as shown and described.

DESCRIPTION

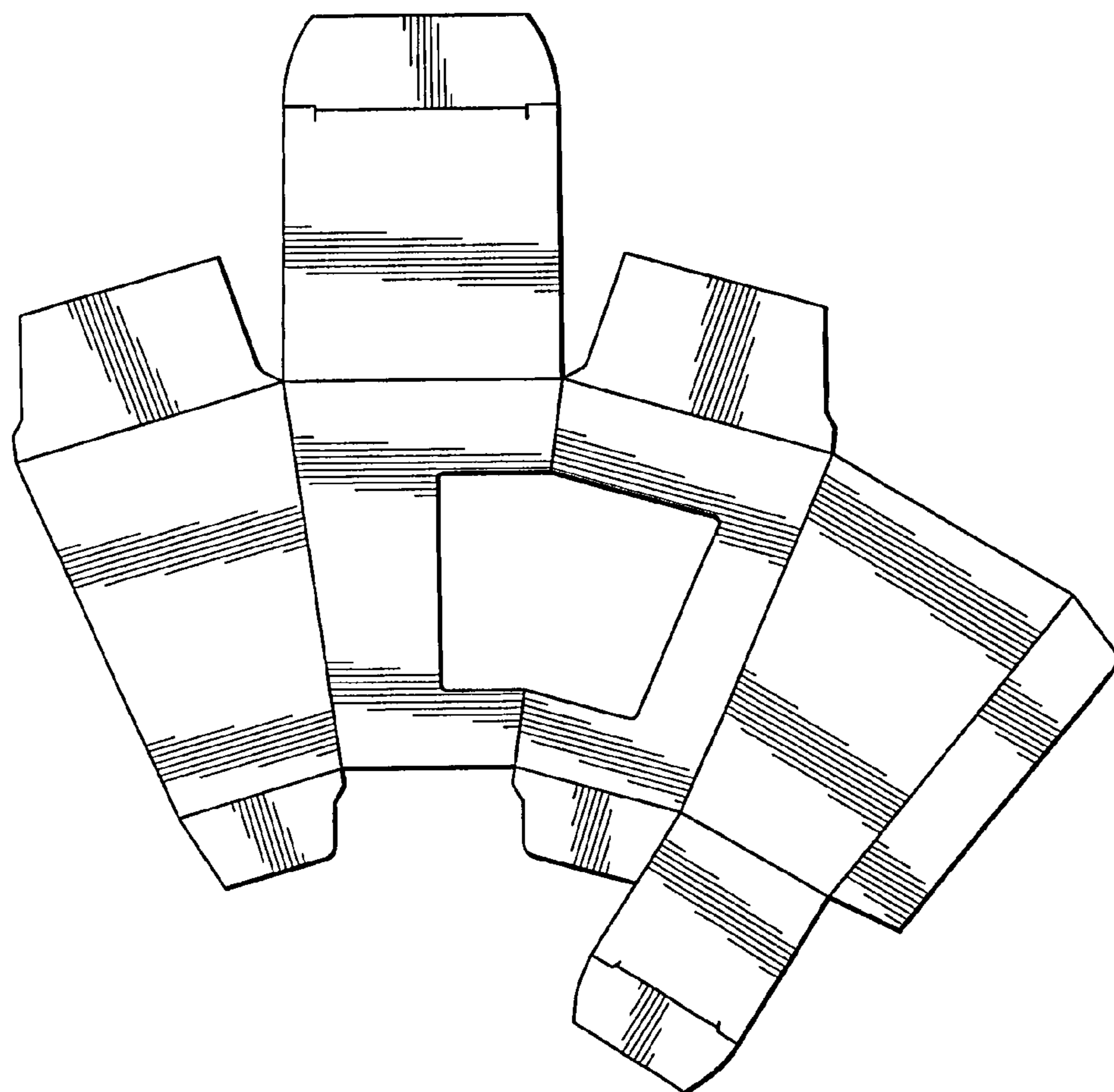

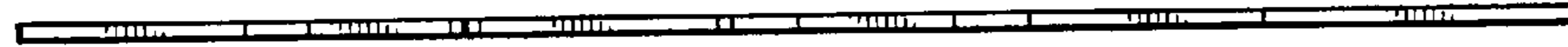

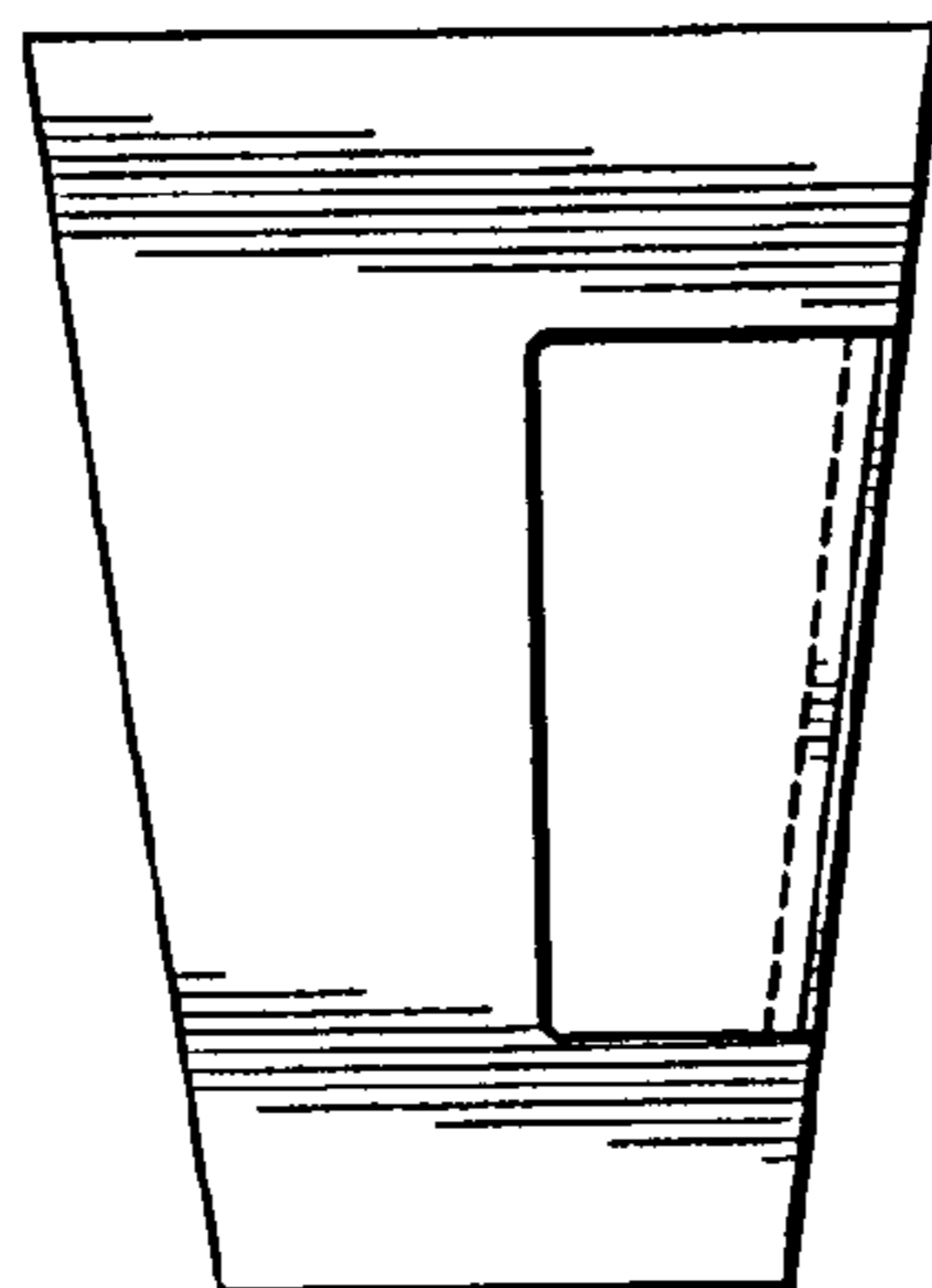

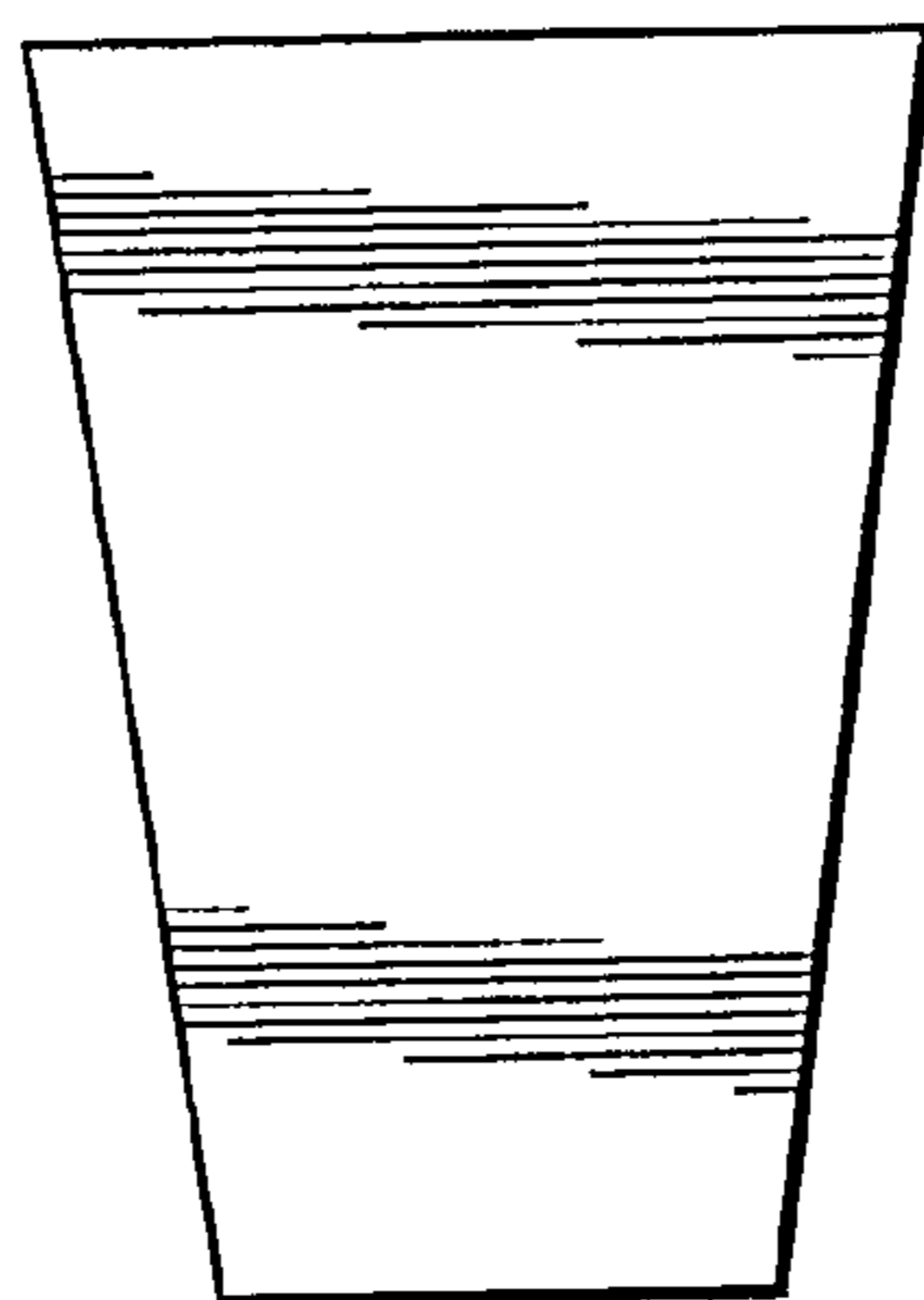

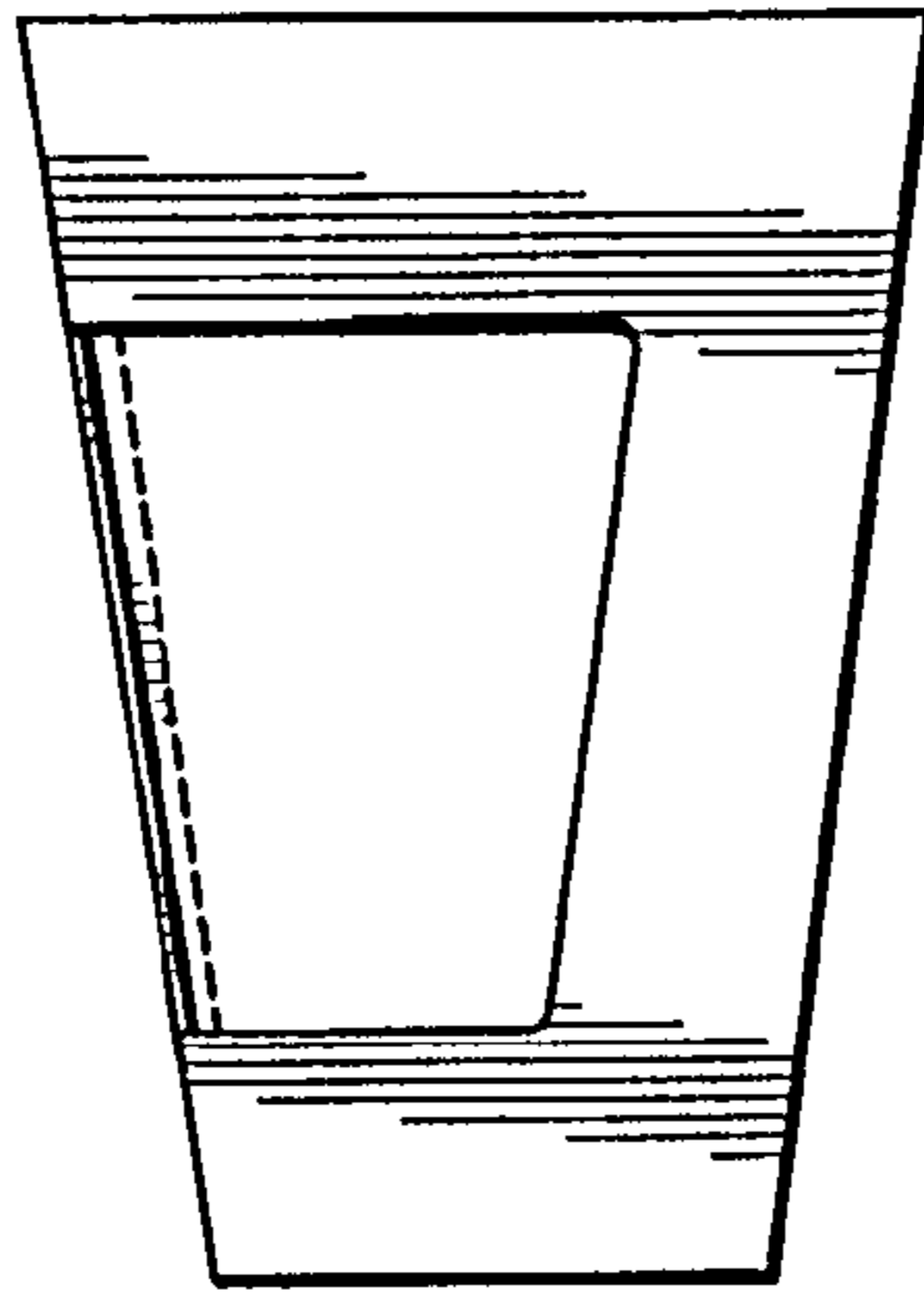

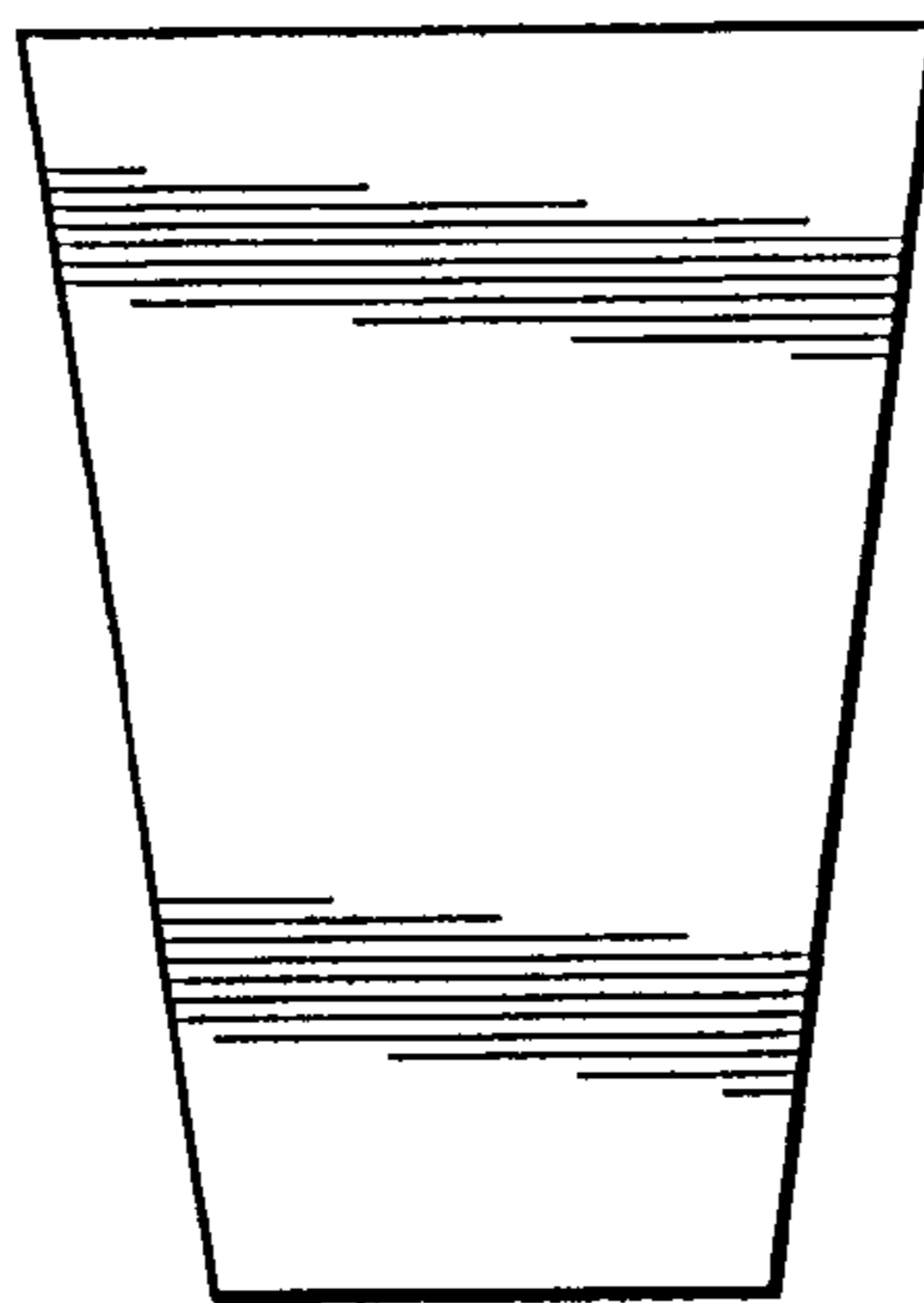

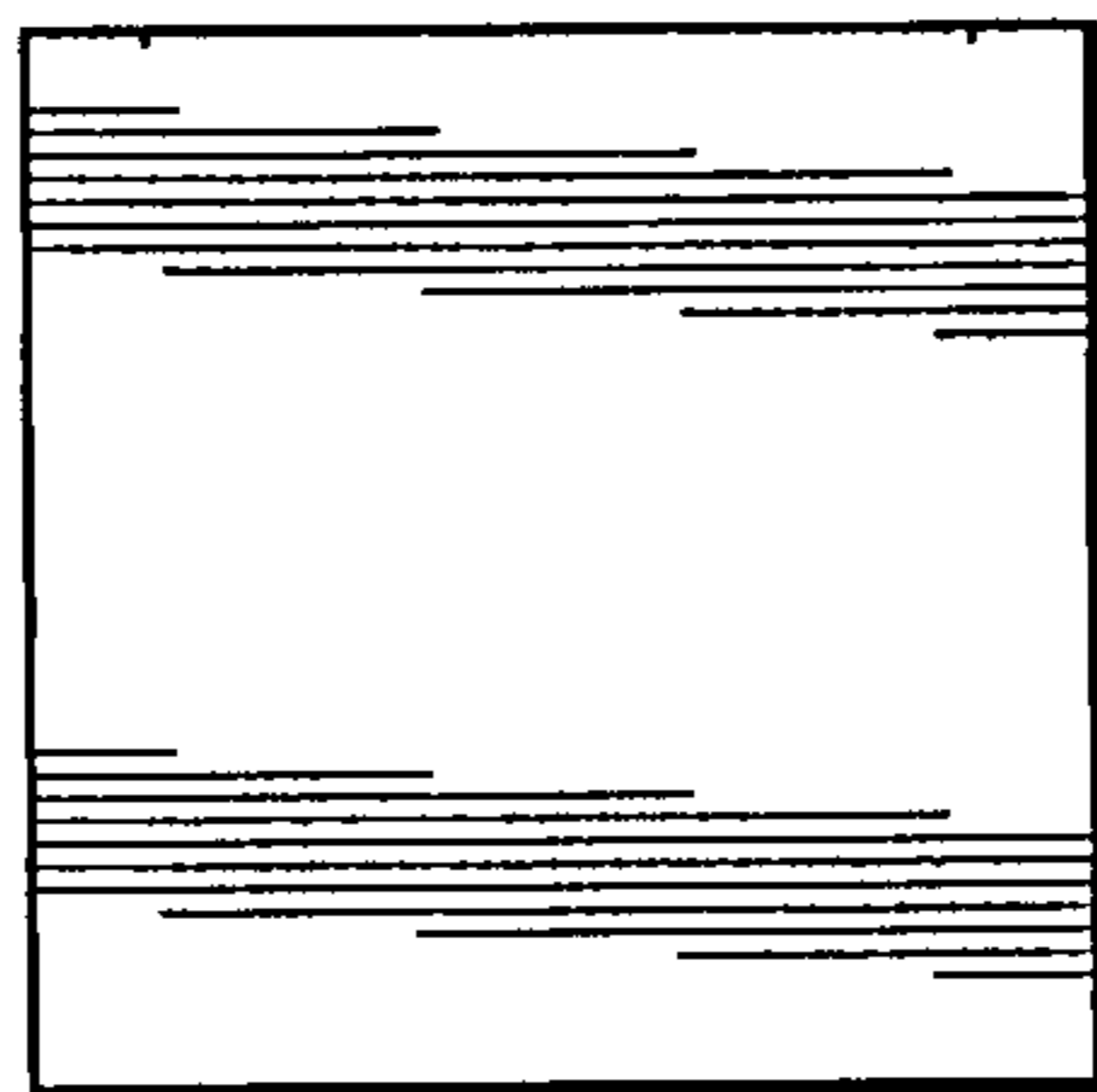

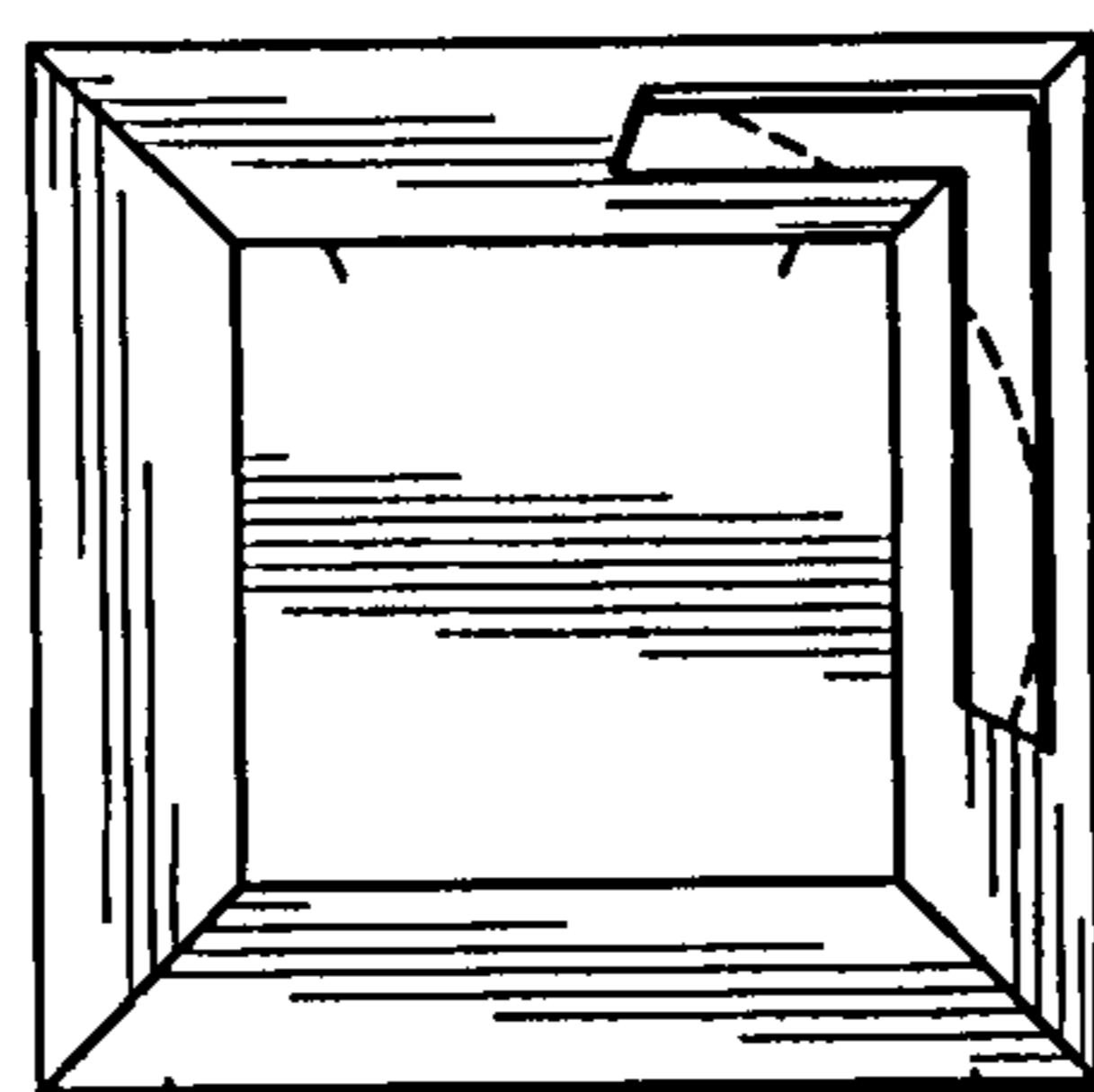

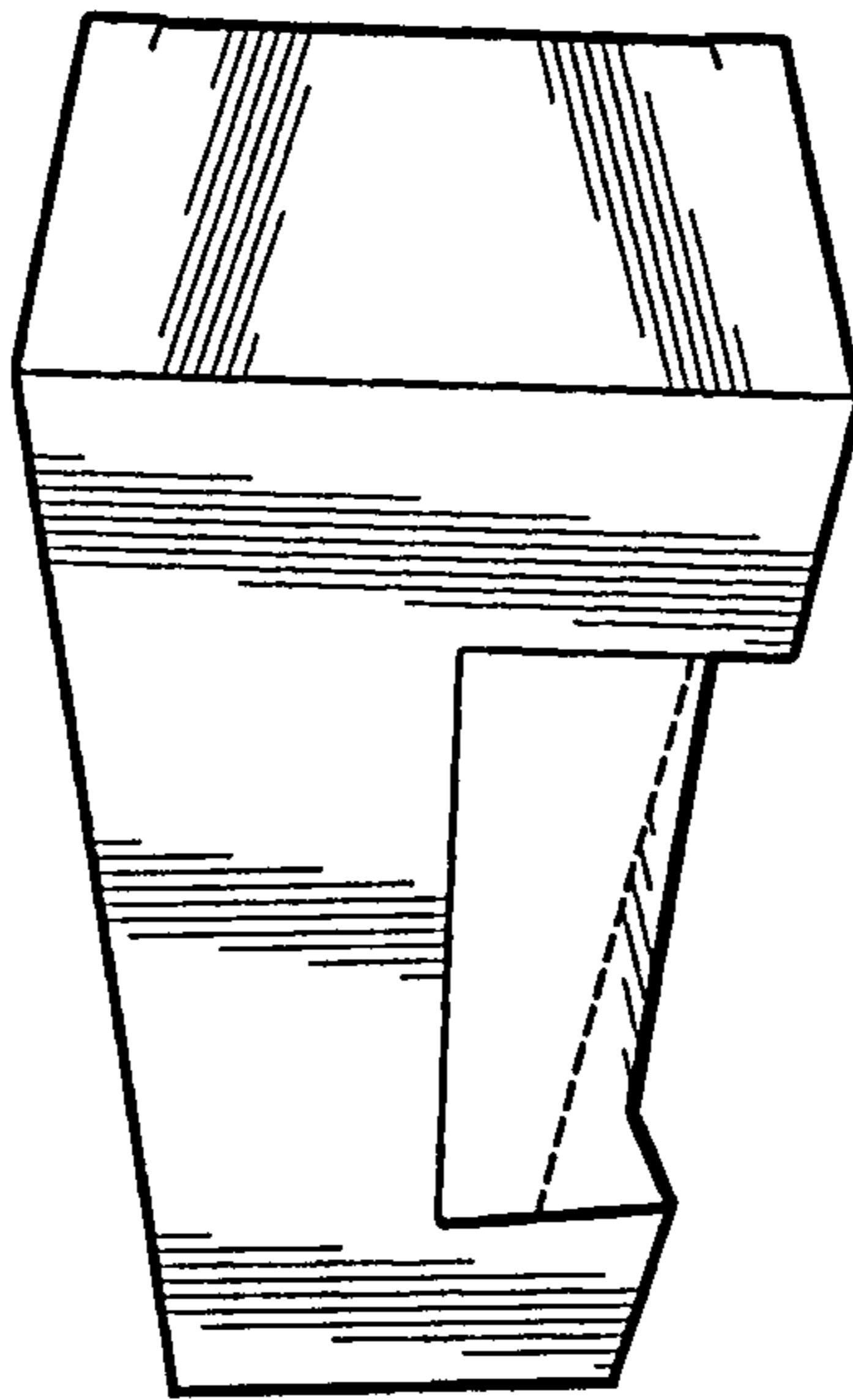
