The ornamental design for a front door for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a front door for an automobile showing our new design;

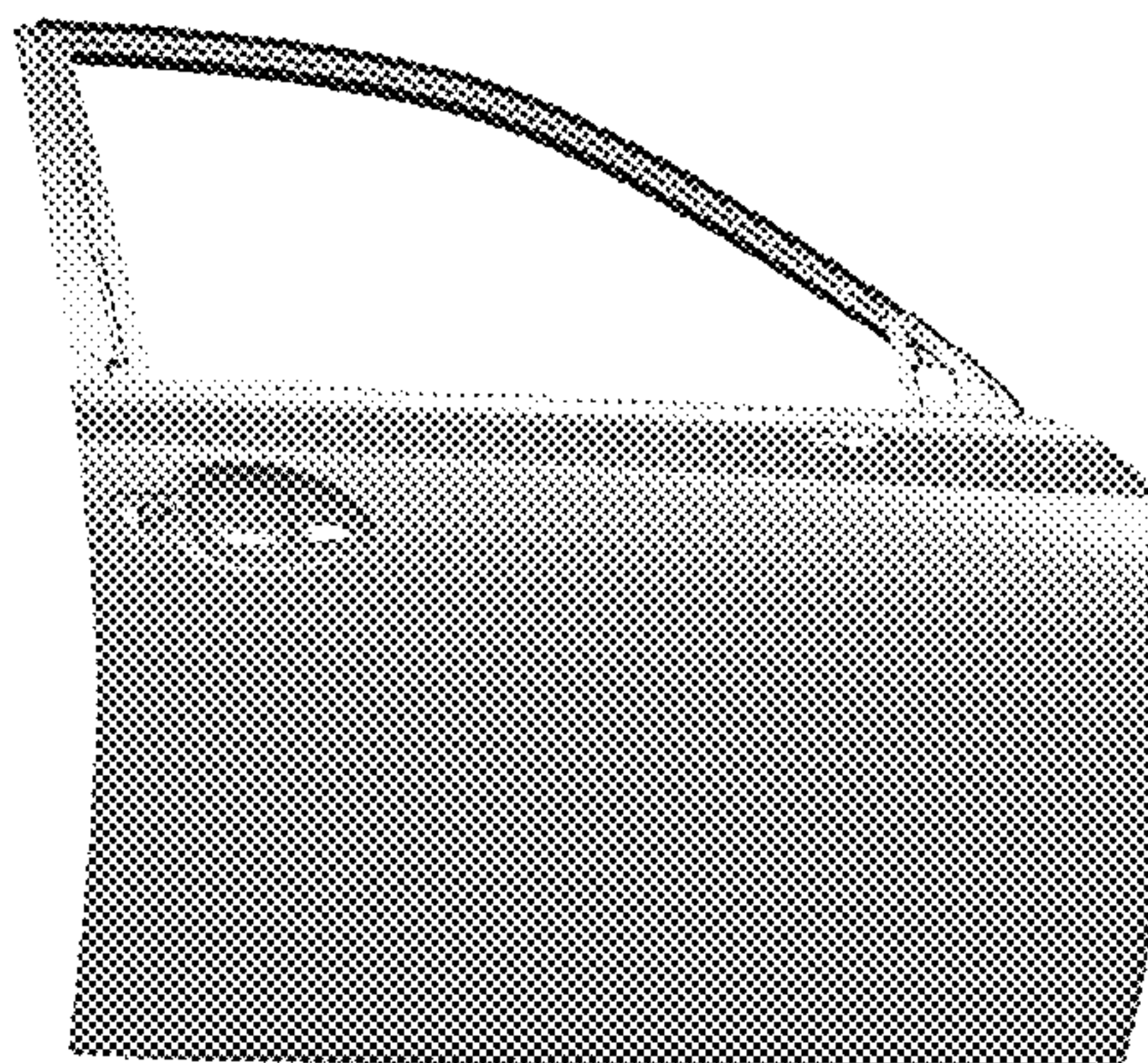

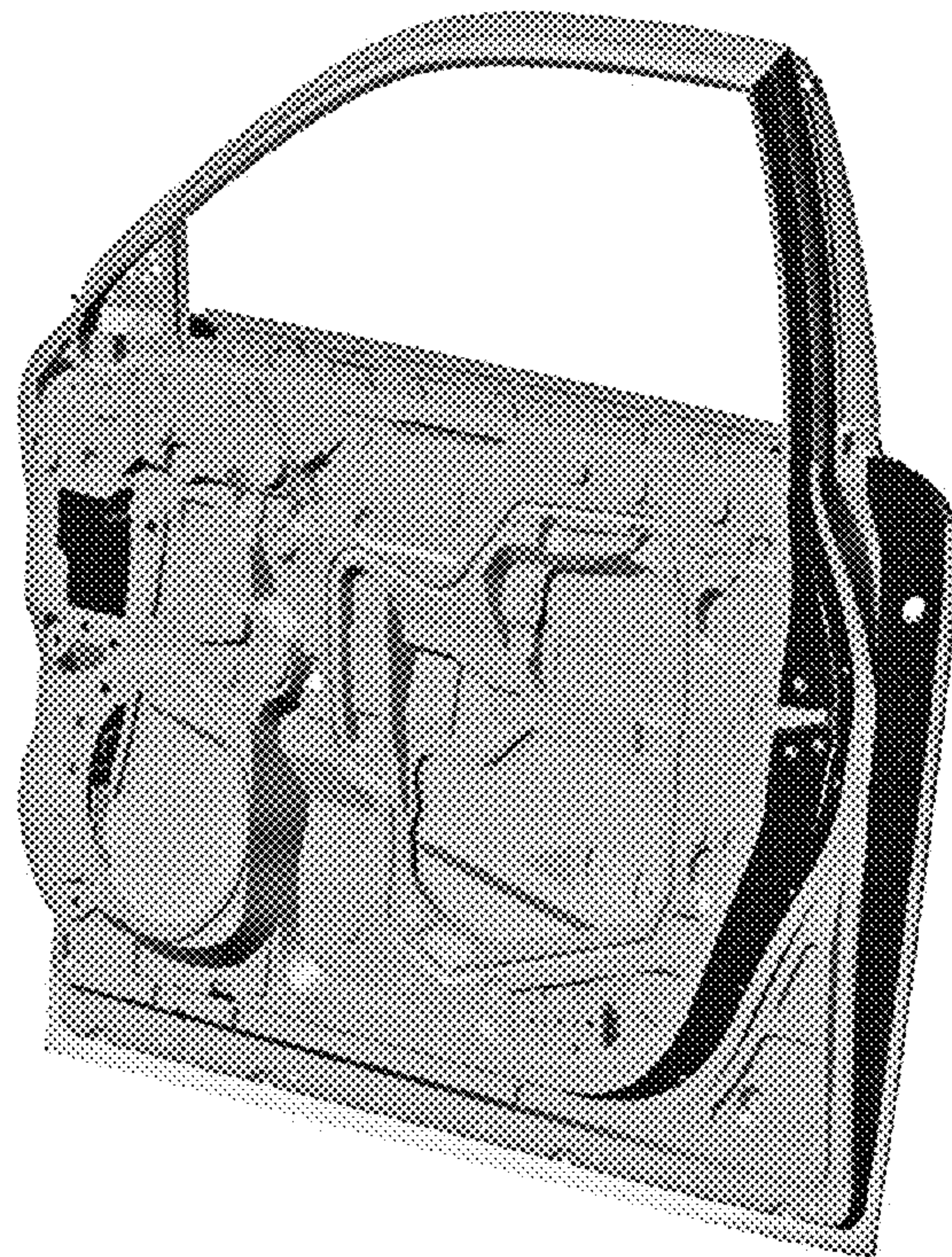

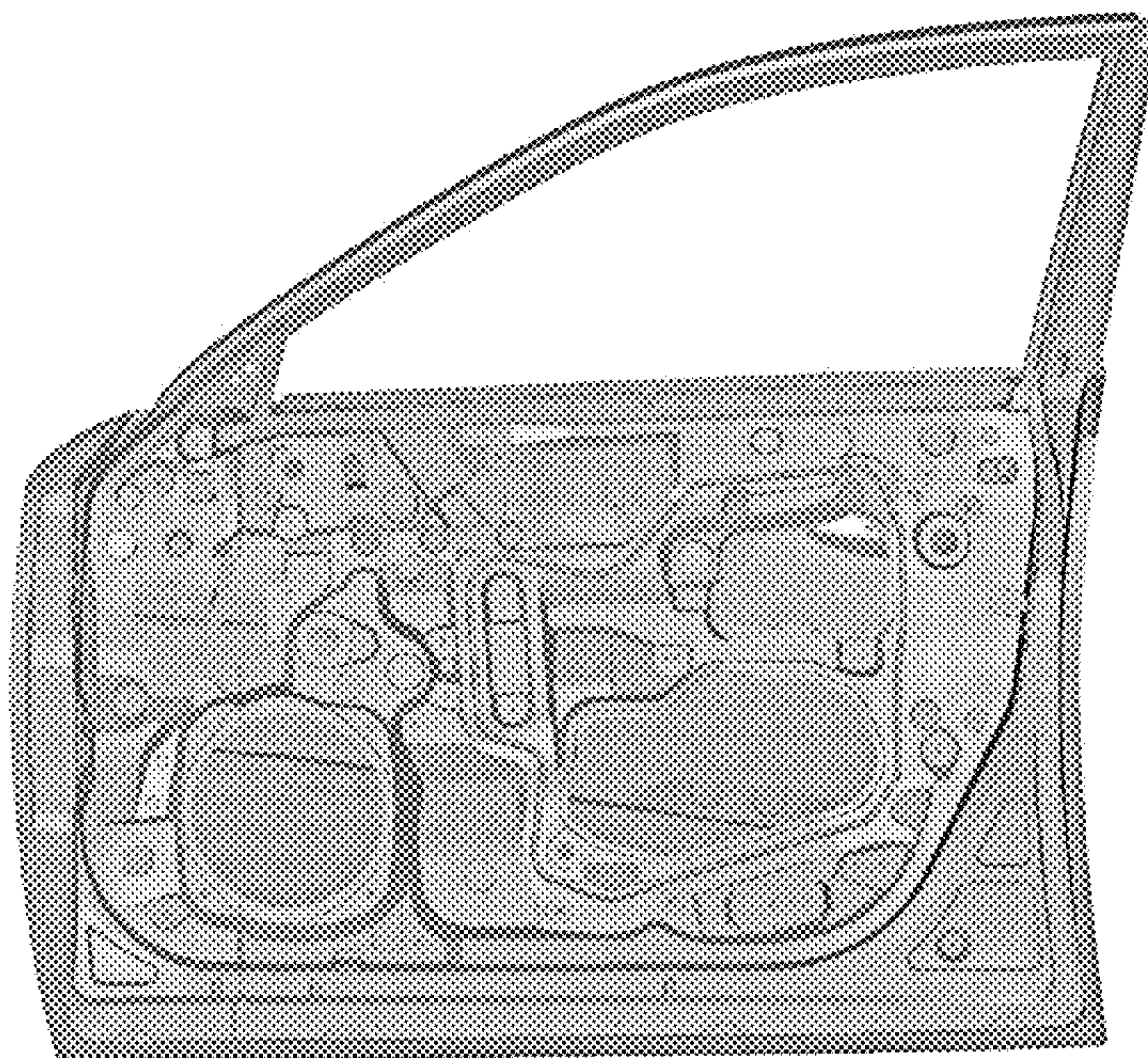

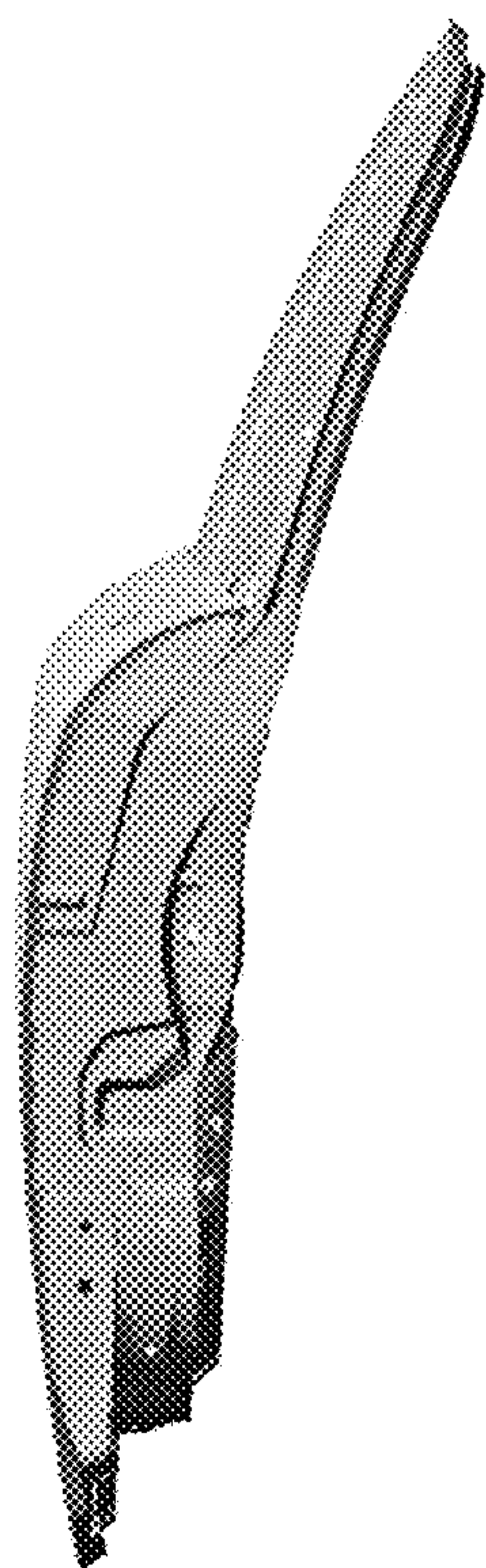

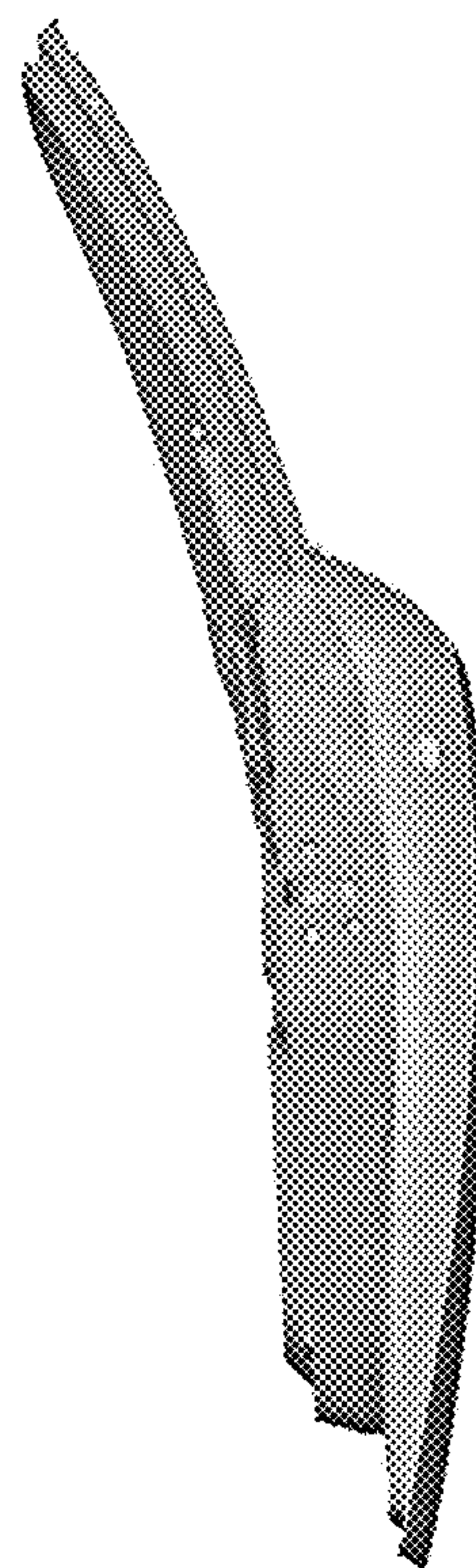

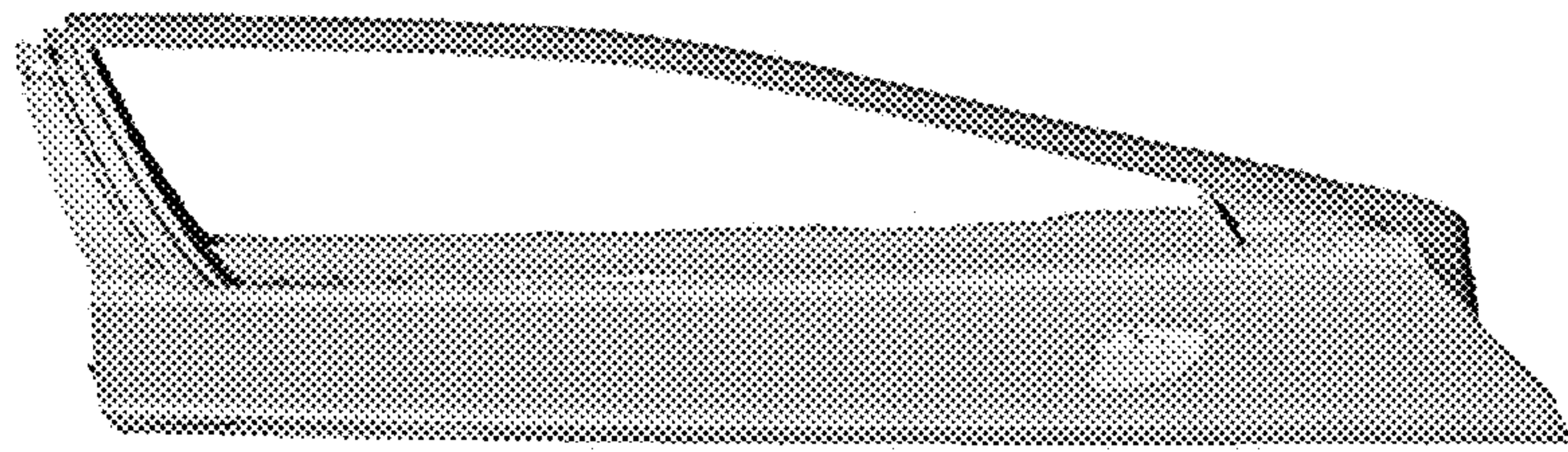

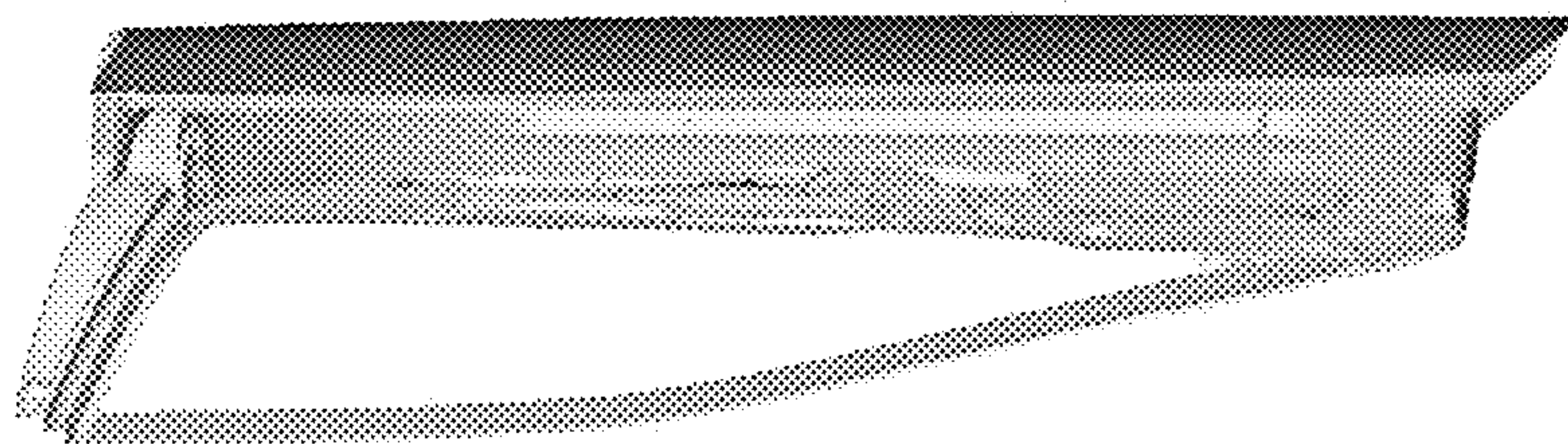
