FIG. 3 is a side elevation view of the antenna of FIG. 1 with a base in broken lines.

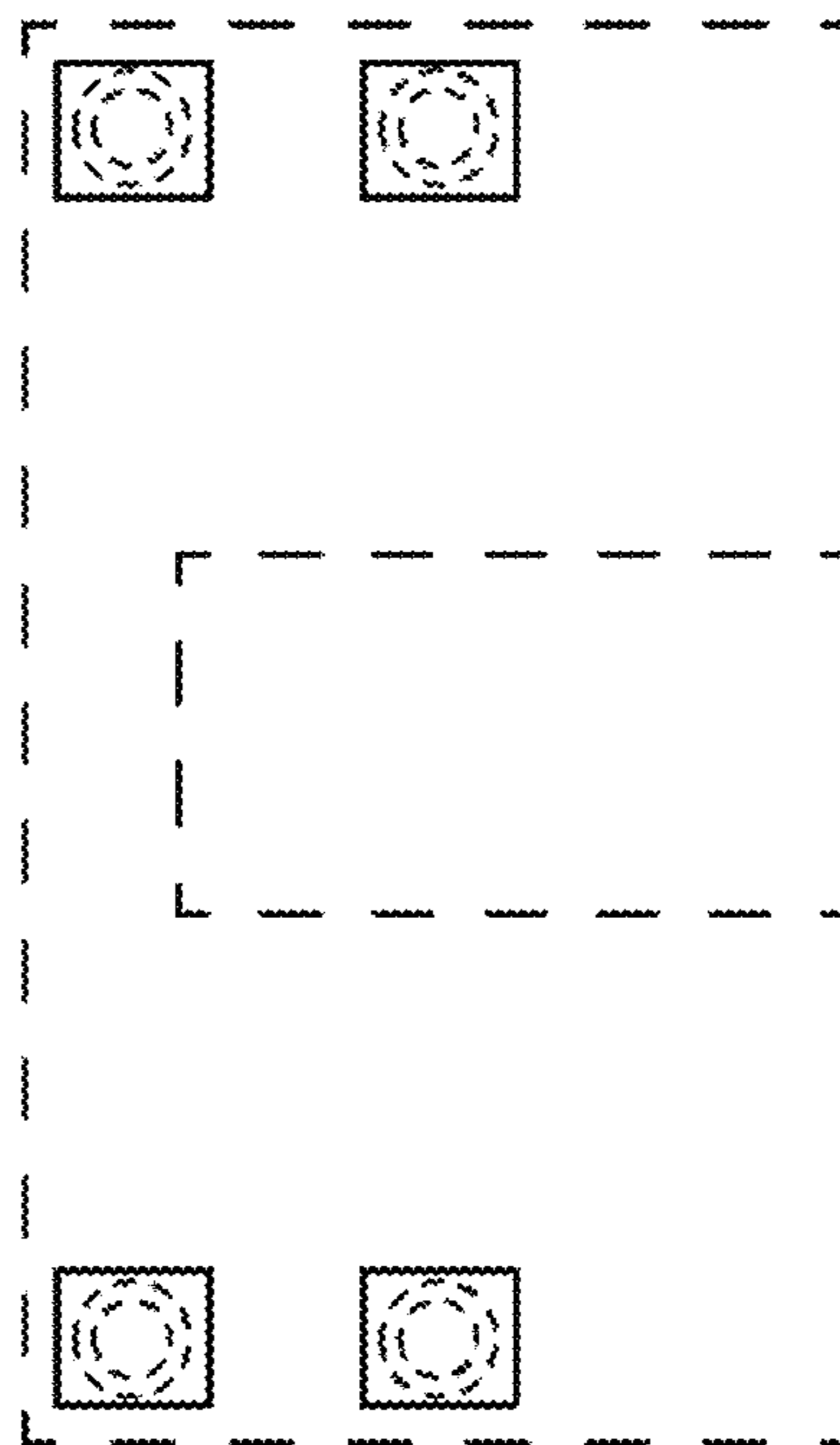
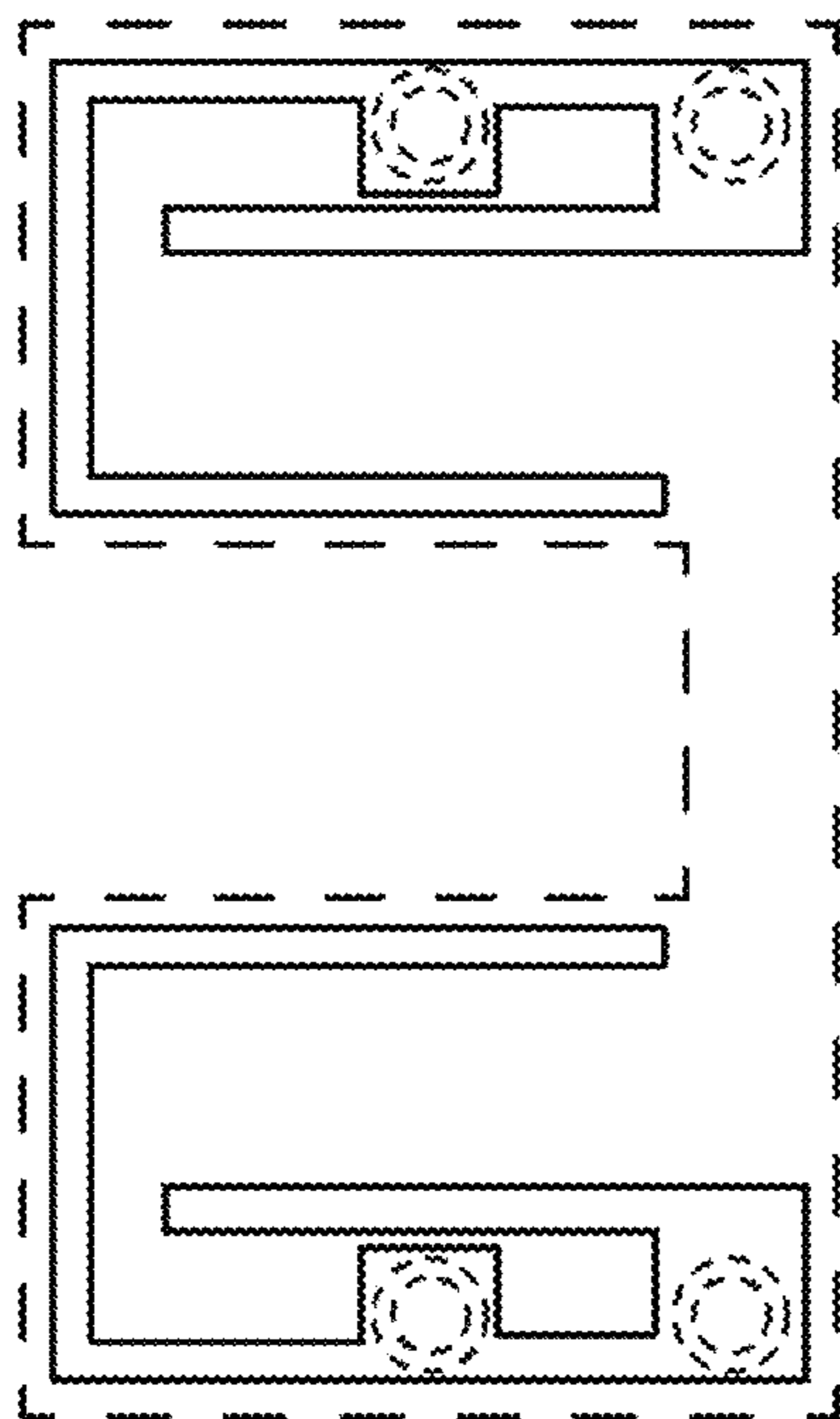
FIG. 4 is a front view of the antenna of FIG. 1 with a base in broken lines.

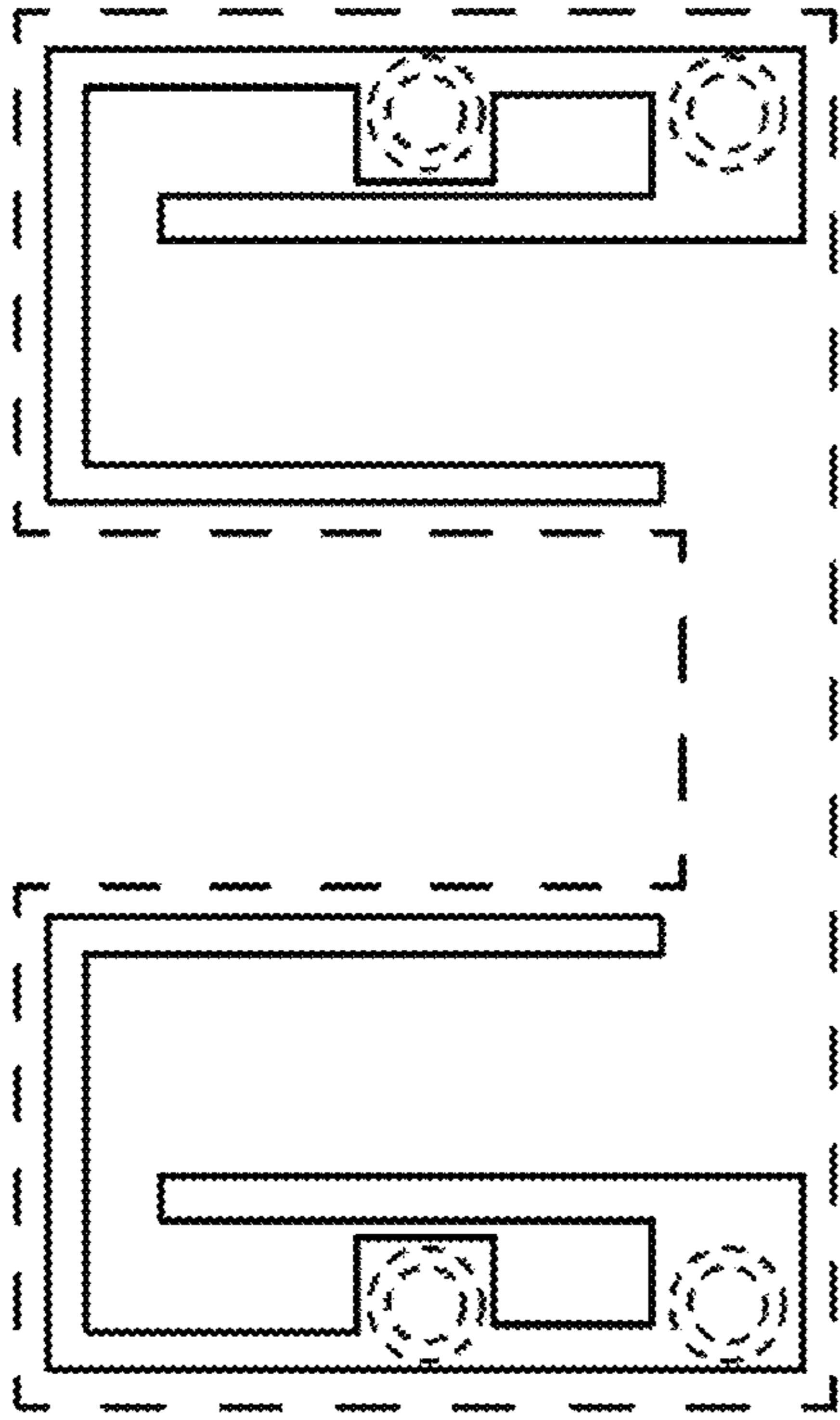

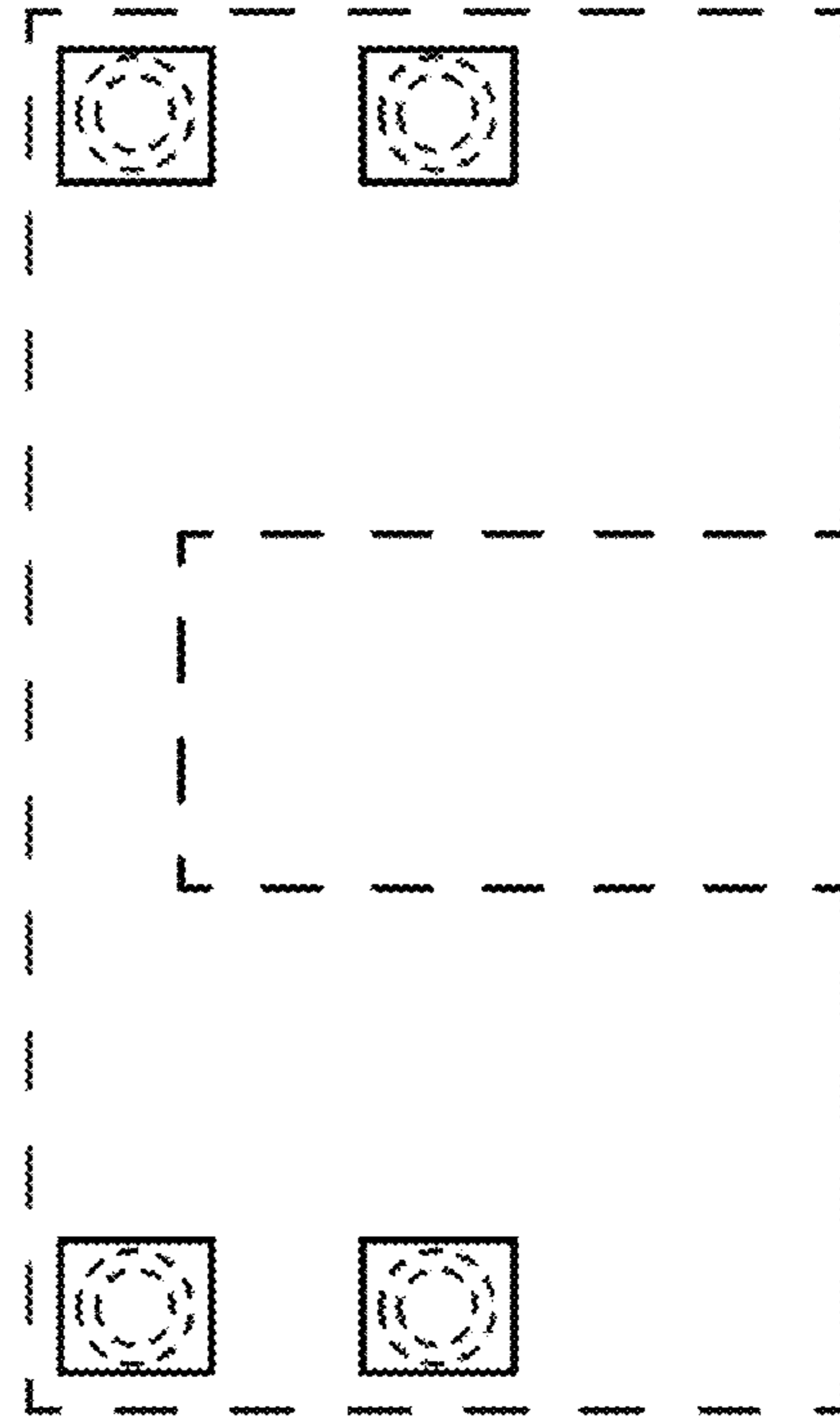

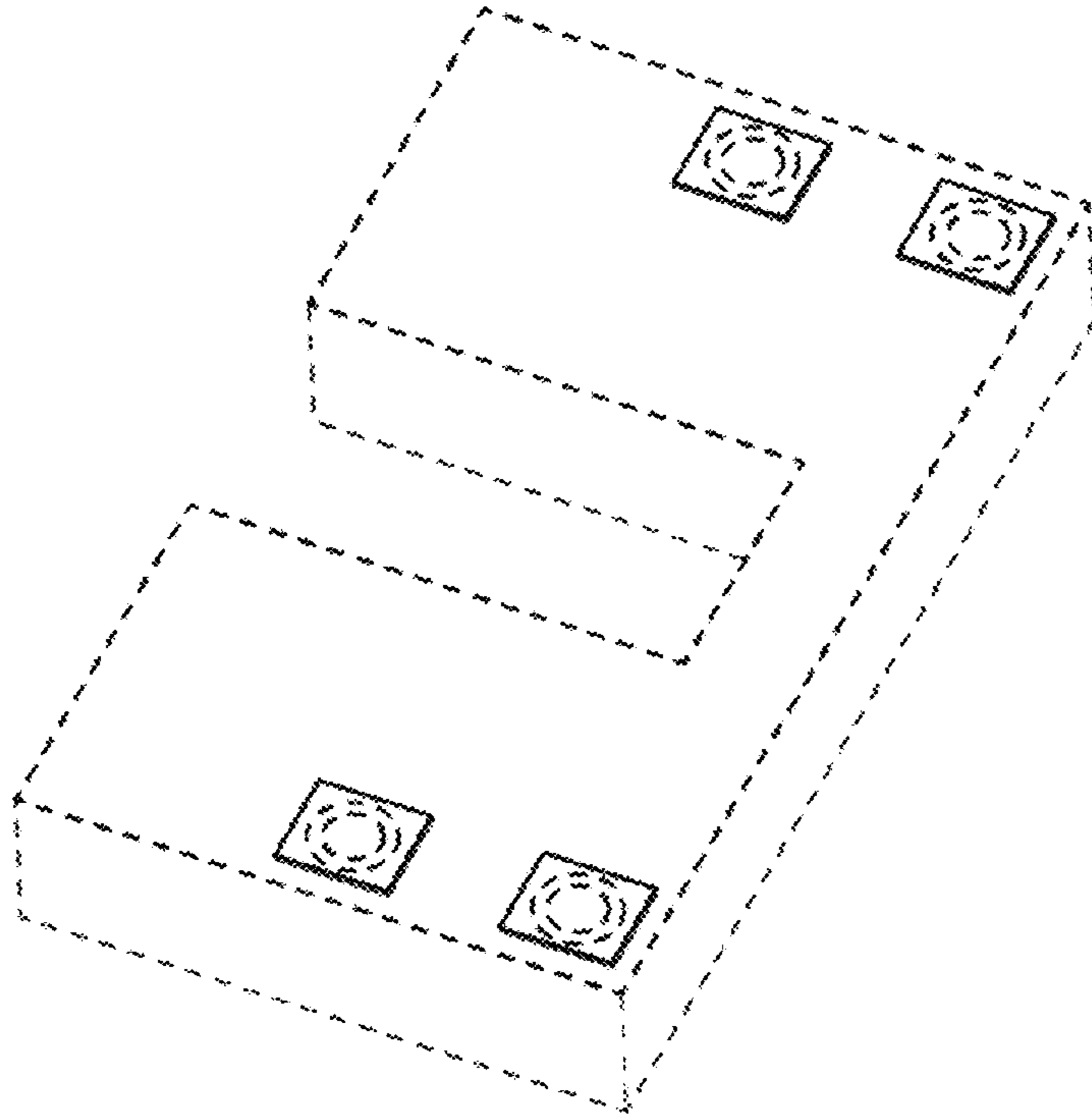

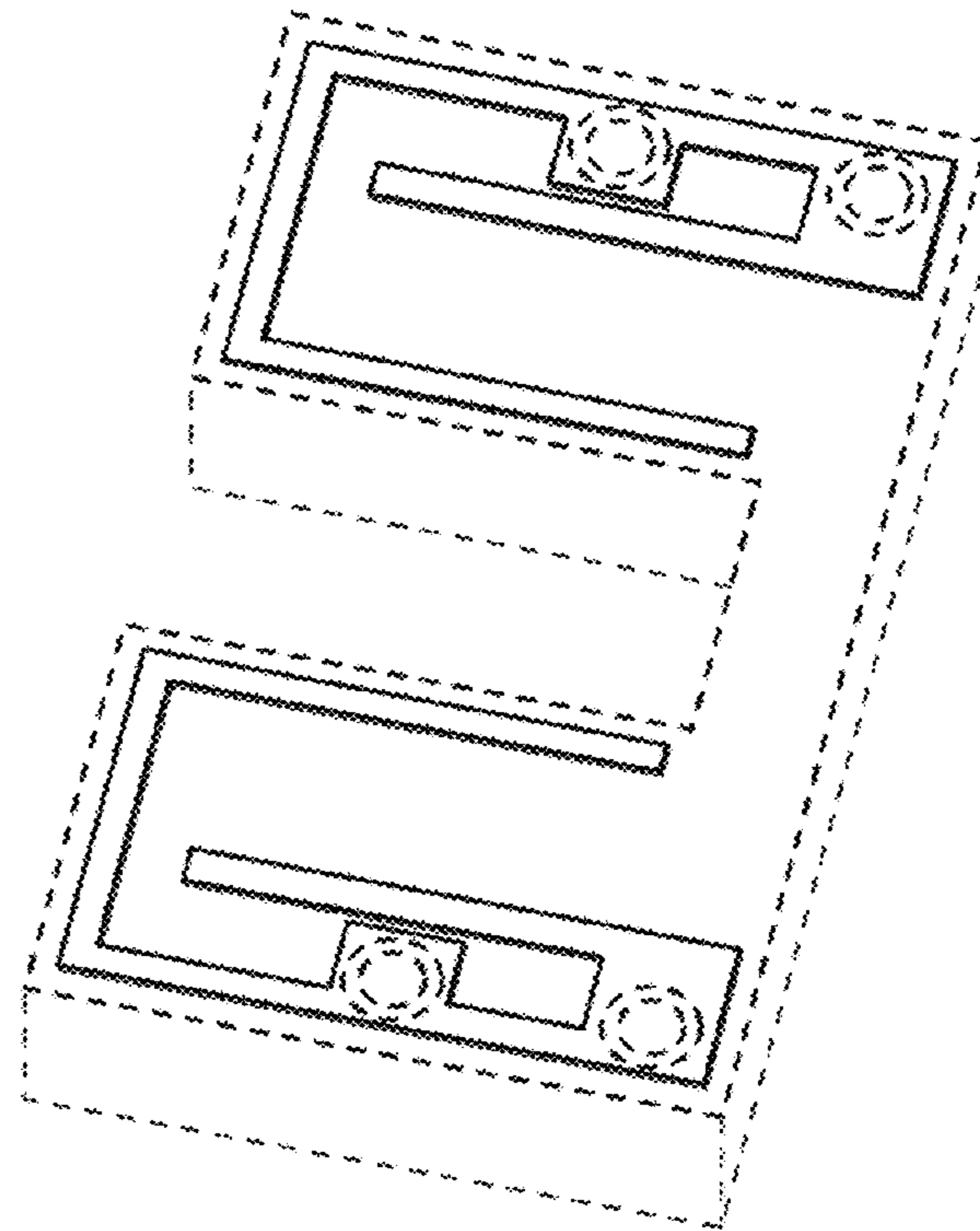
