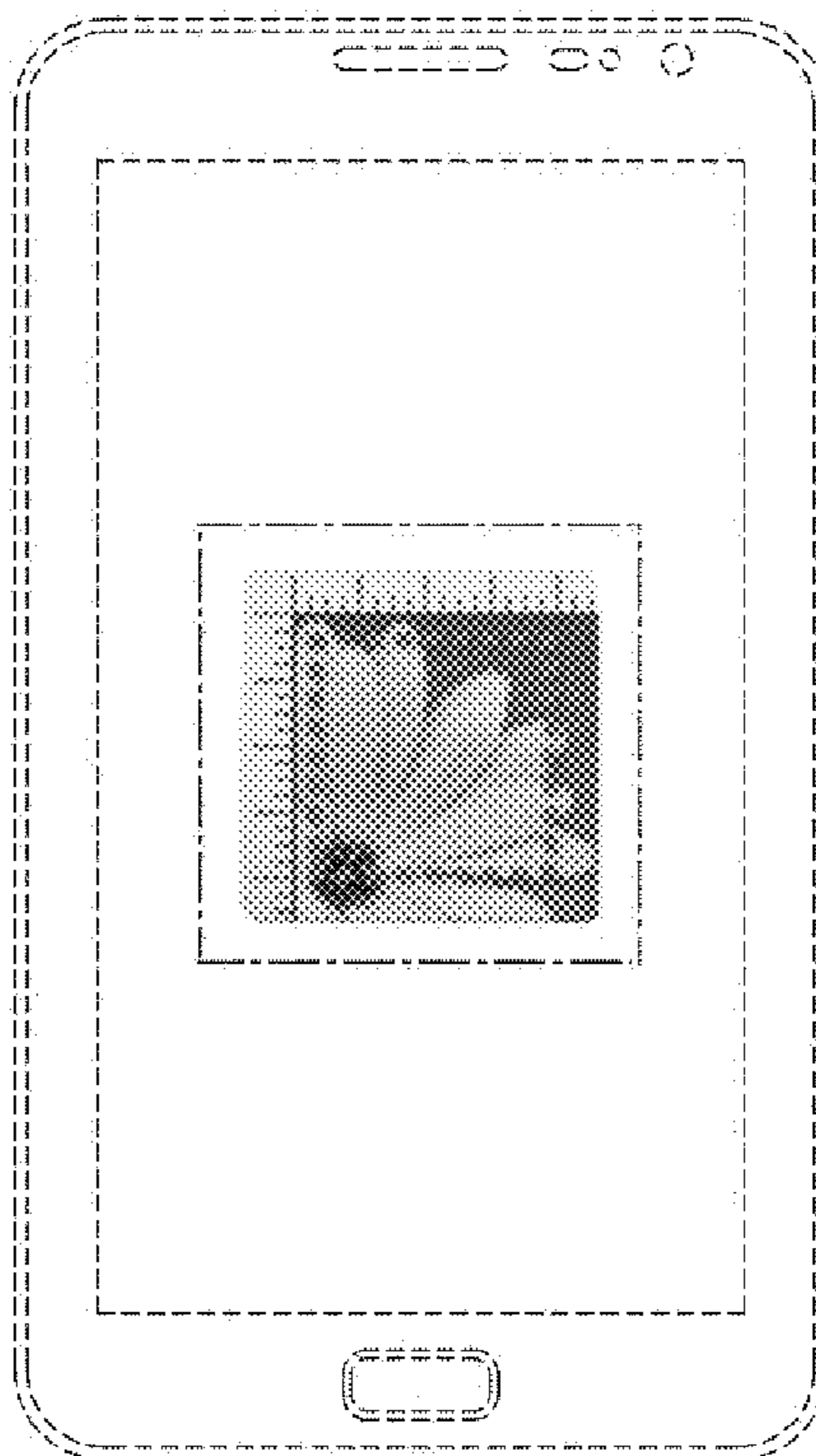

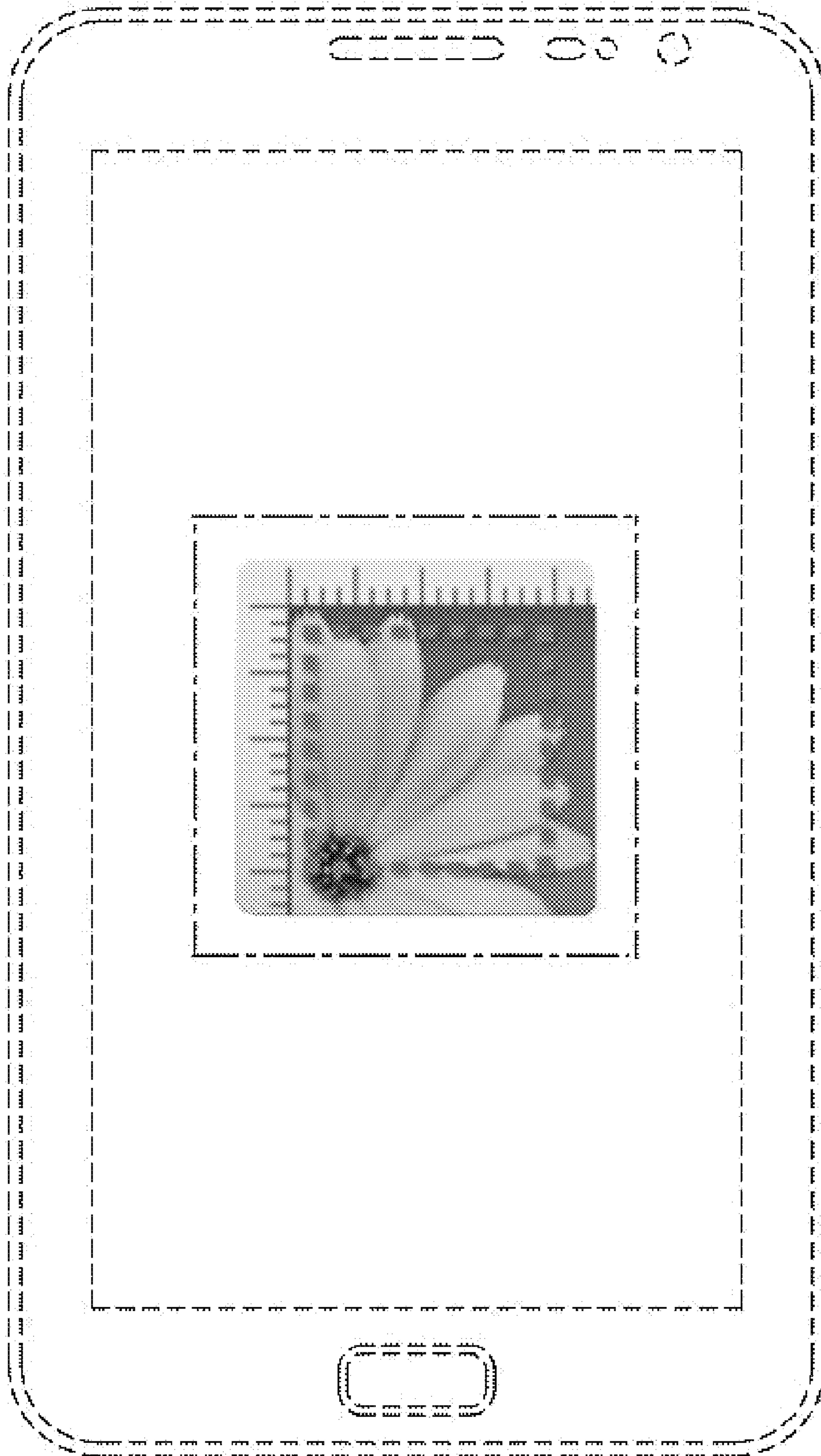
The ornamental design for a portable electronic device with a graphical user interface, as shown and described.
