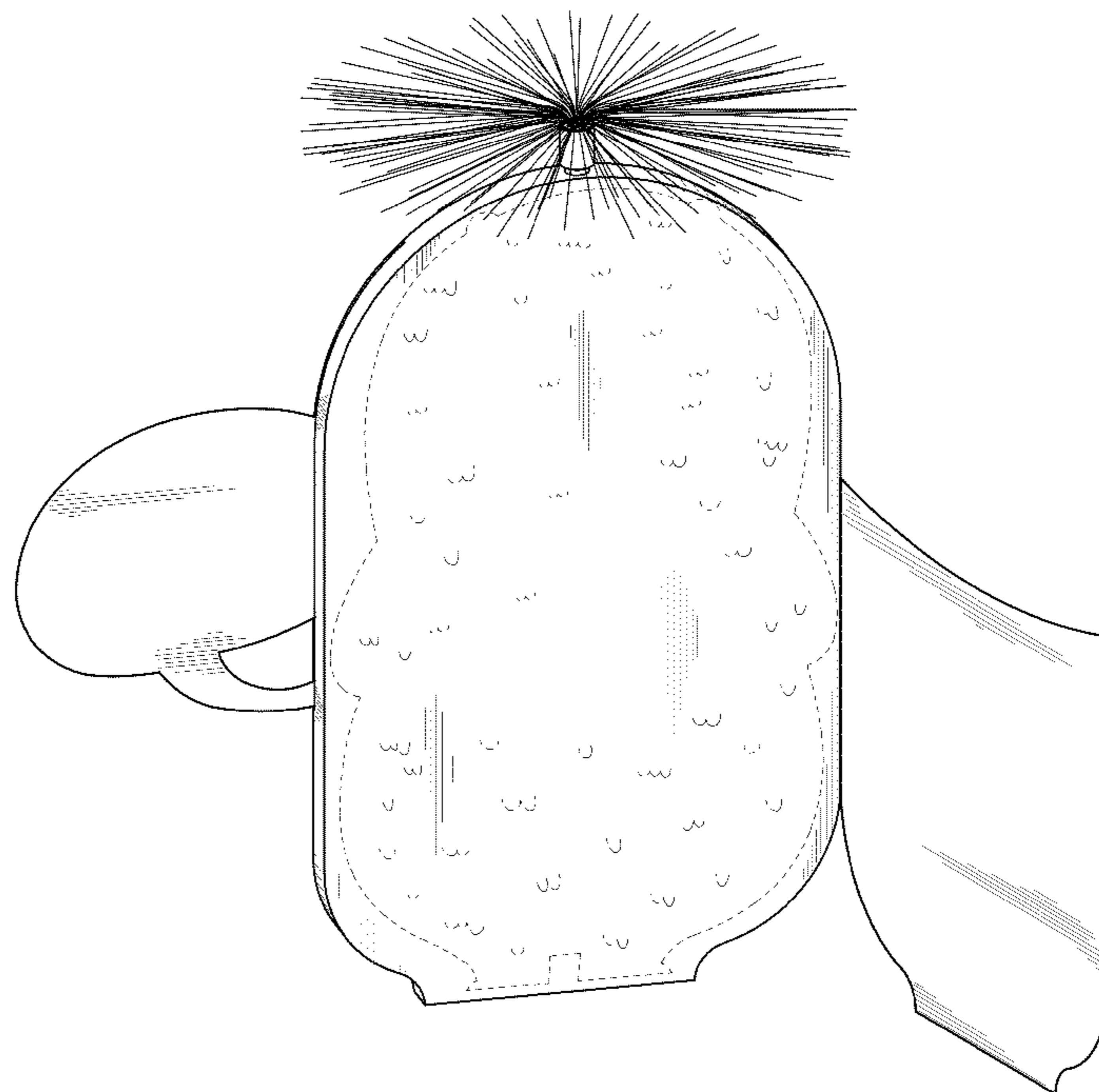
(57) **CLAIM**

The ornamental designs for a greeting card, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the greeting card of the present invention.
FIG. 2 is a front view of the greeting card of FIG. 1.
FIG. 3 is a rear view of the greeting card of FIG. 1.
FIG. 4 is a top view of the greeting card of FIG. 1.
FIG. 5 is a bottom view of the greeting card of FIG. 1.
FIG. 6 is a right side view of the greeting card of FIG. 1.
FIG. 7 is a left side view of the greeting card of FIG. 1.
FIG. 8 is a front perspective view of the greeting card of FIG. 1, in an open position; and,
FIG. 9 is a rear perspective view of greeting card of FIG. 1, in an open position.
The broken line showing of portions of the greeting card is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

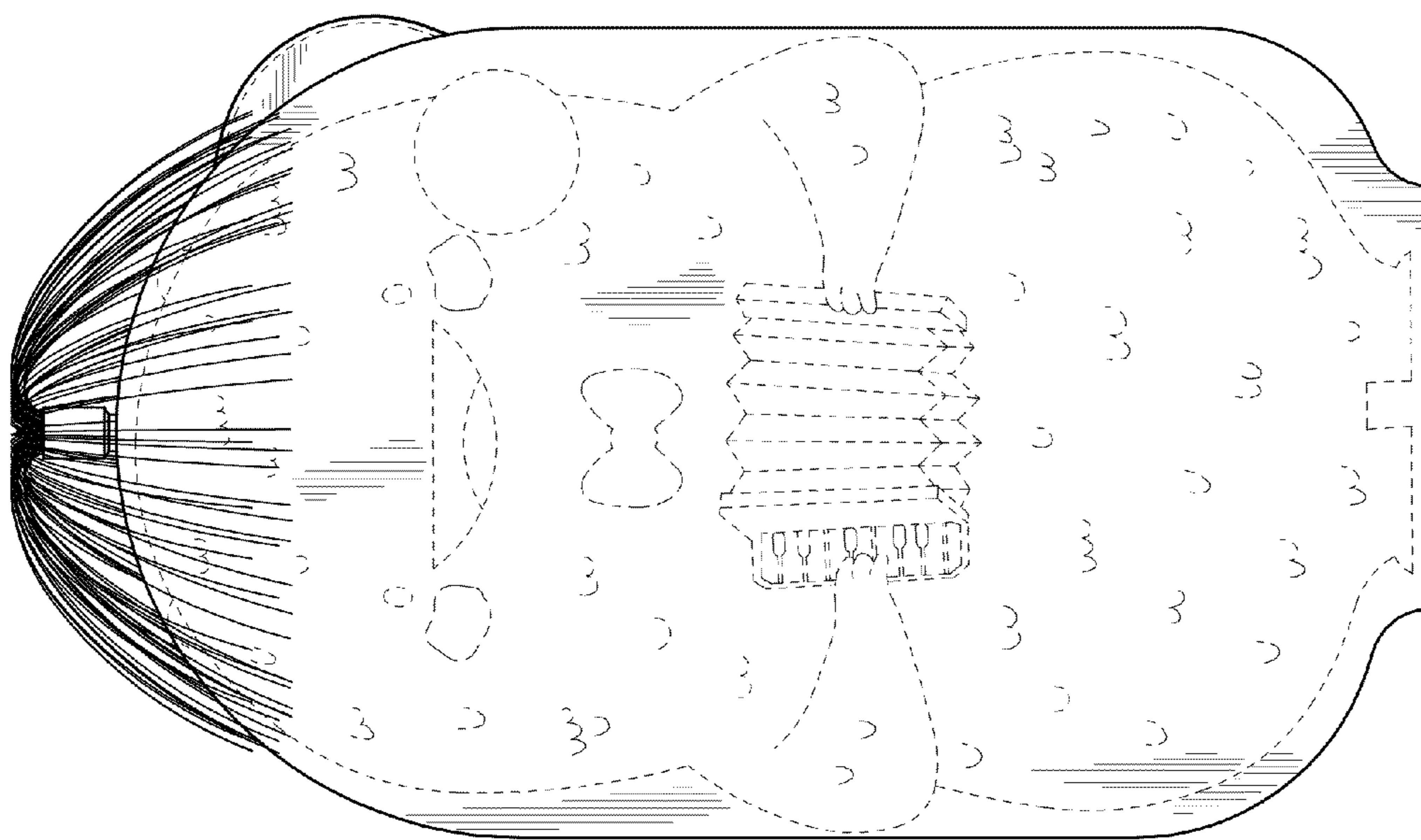

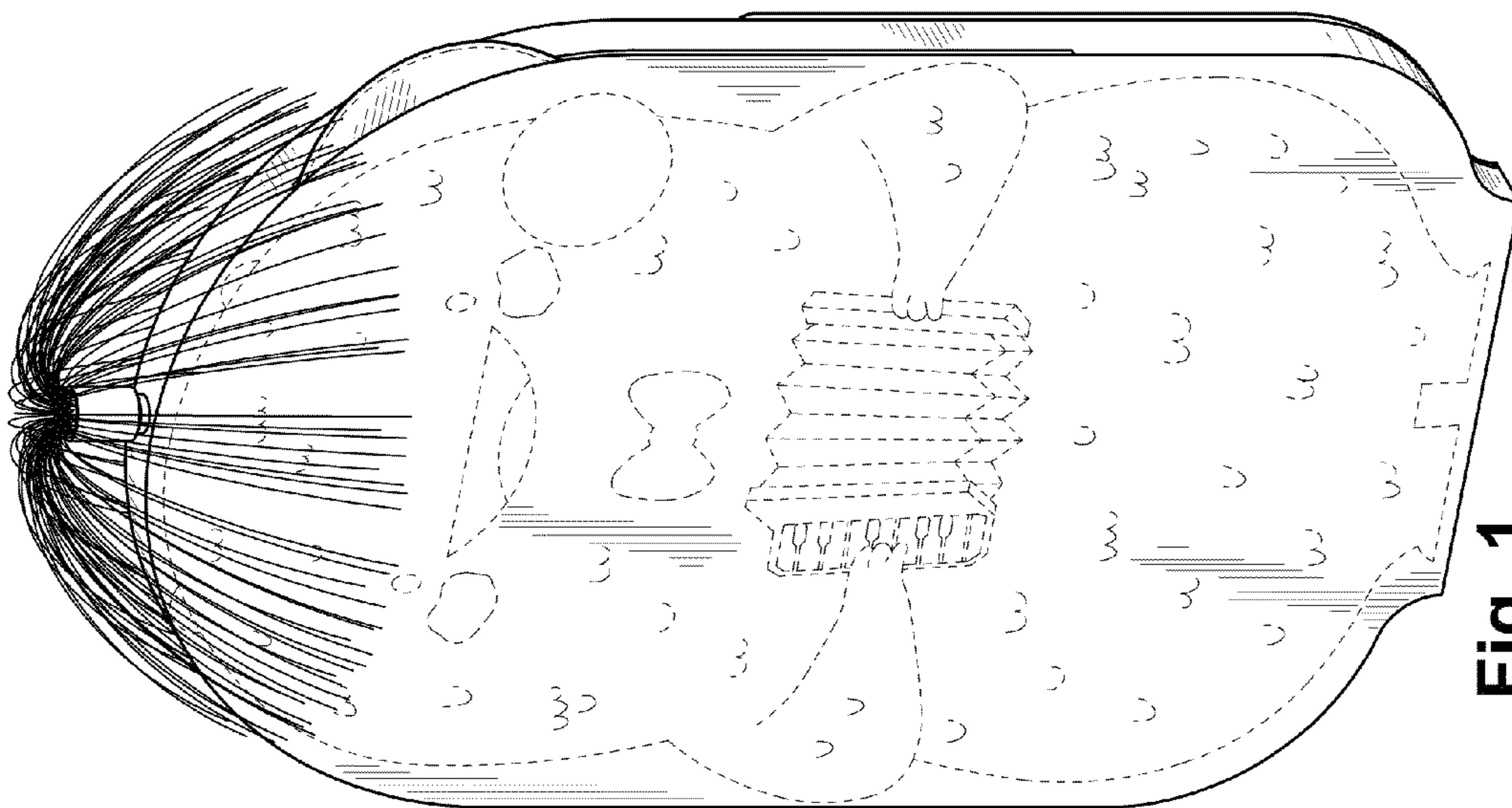

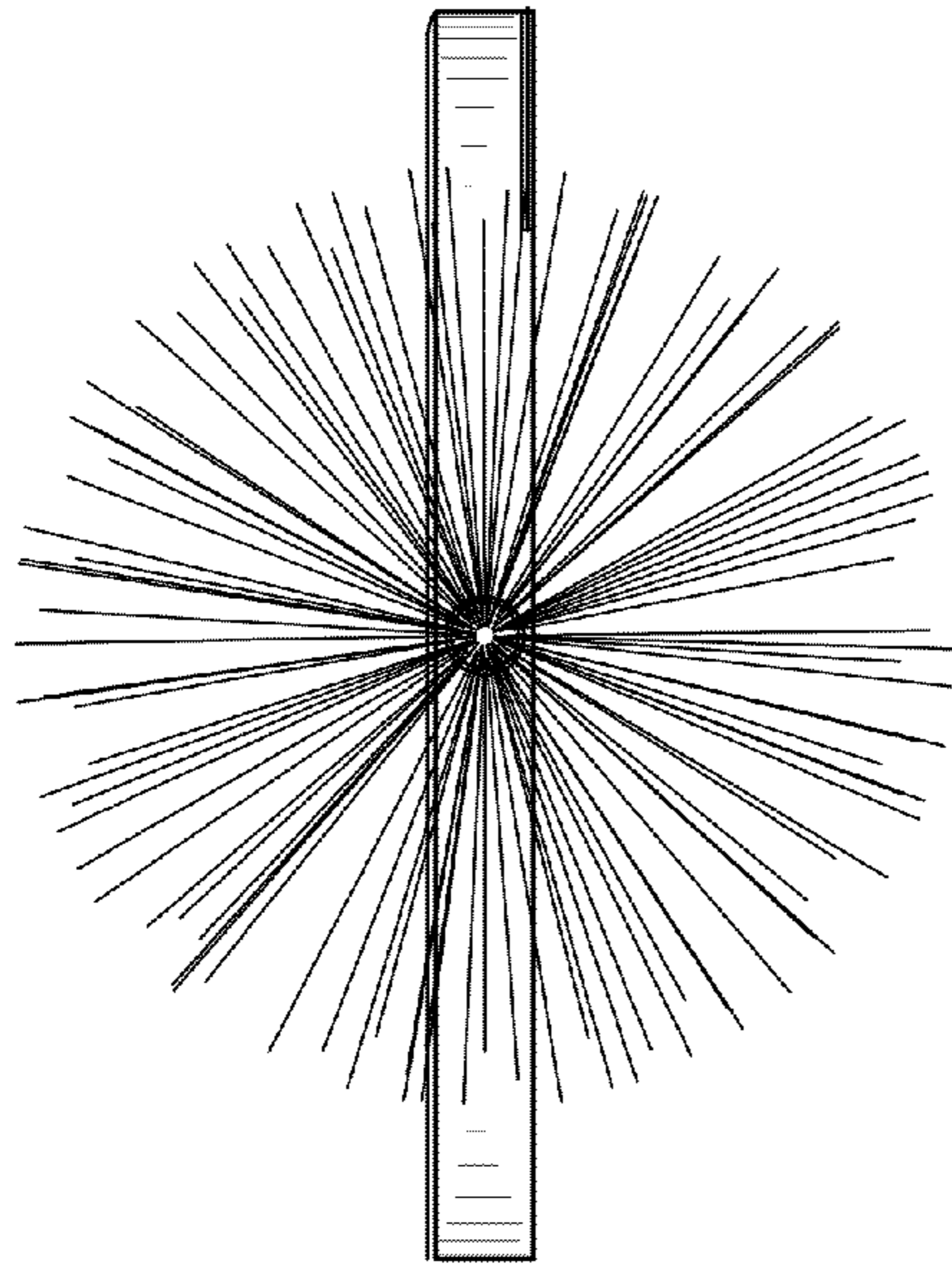

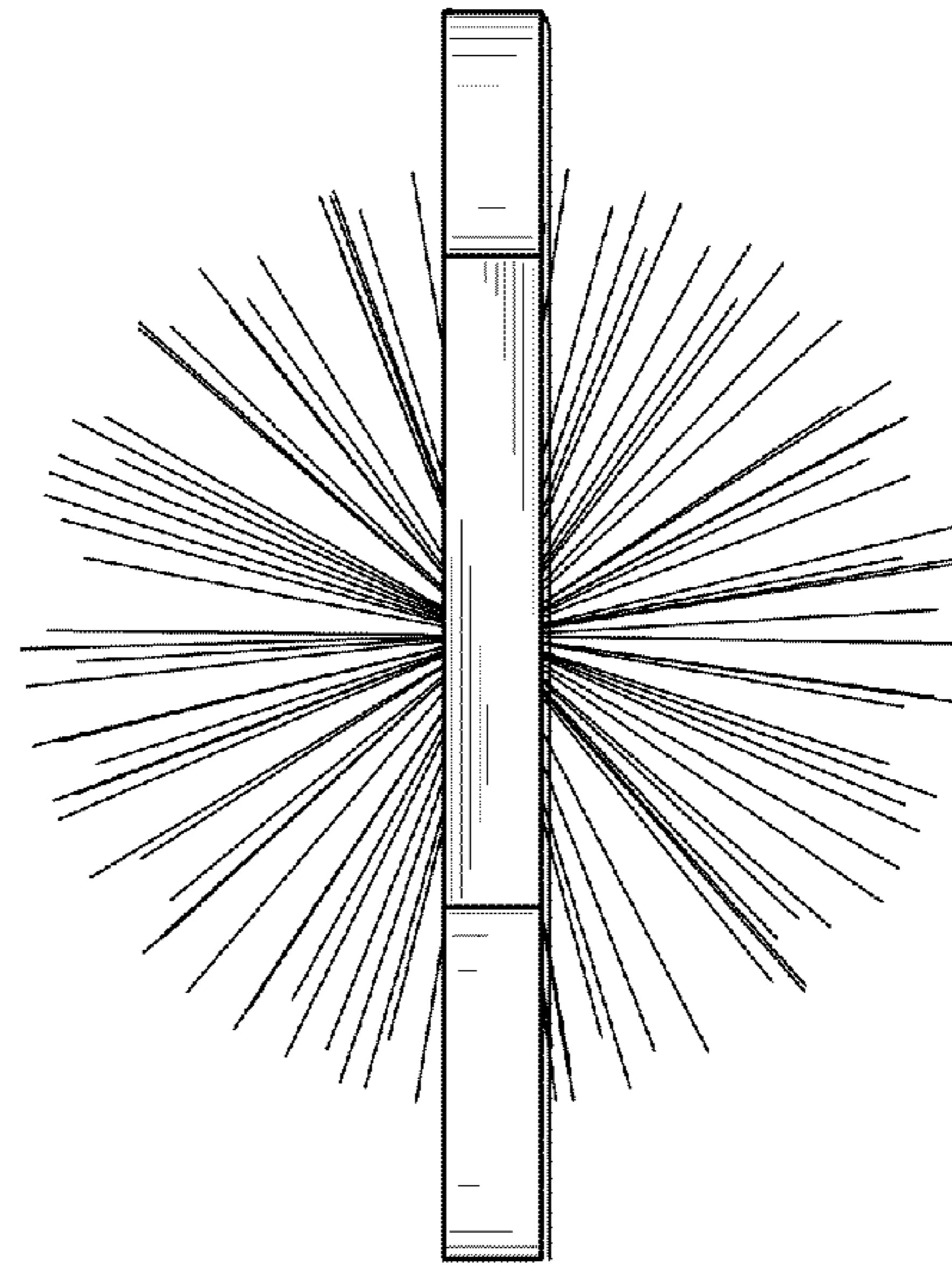

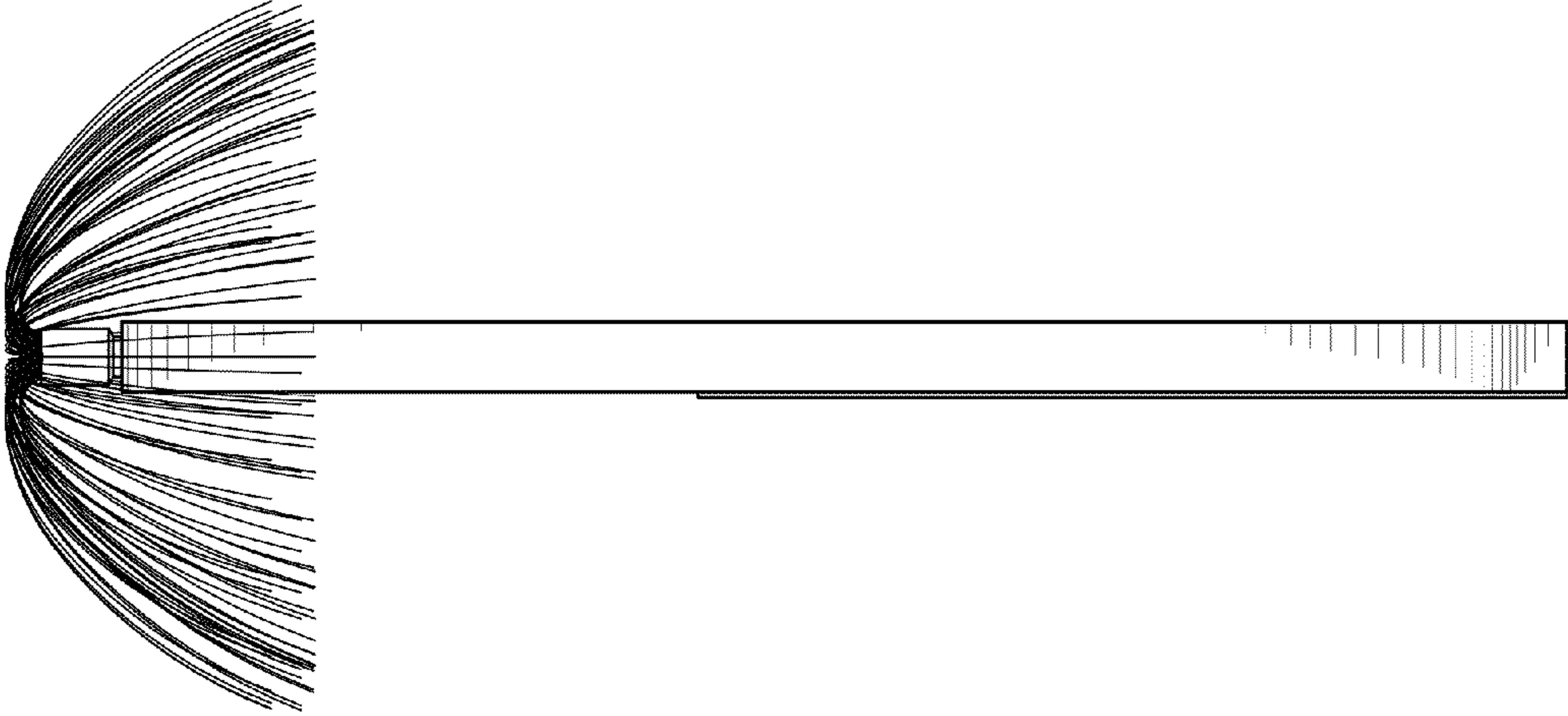

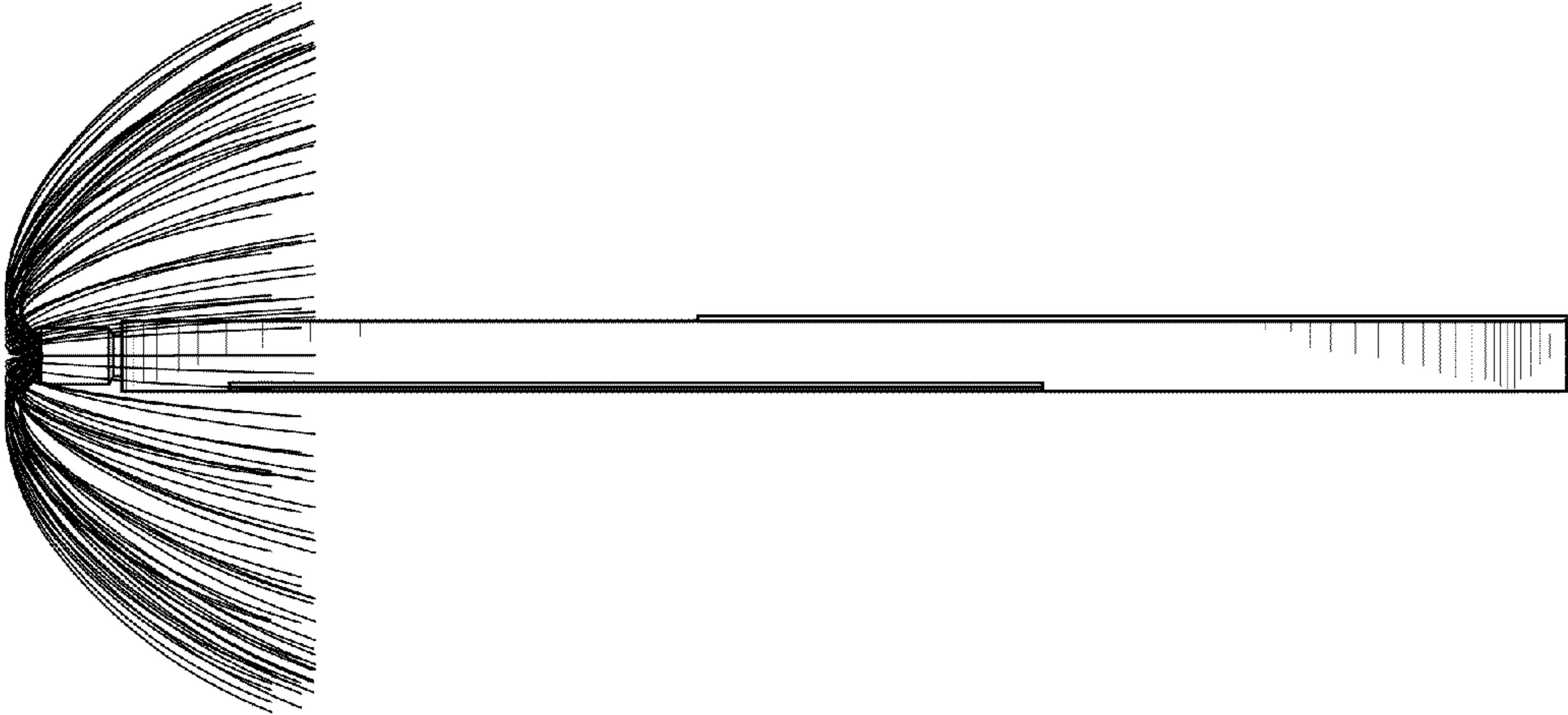

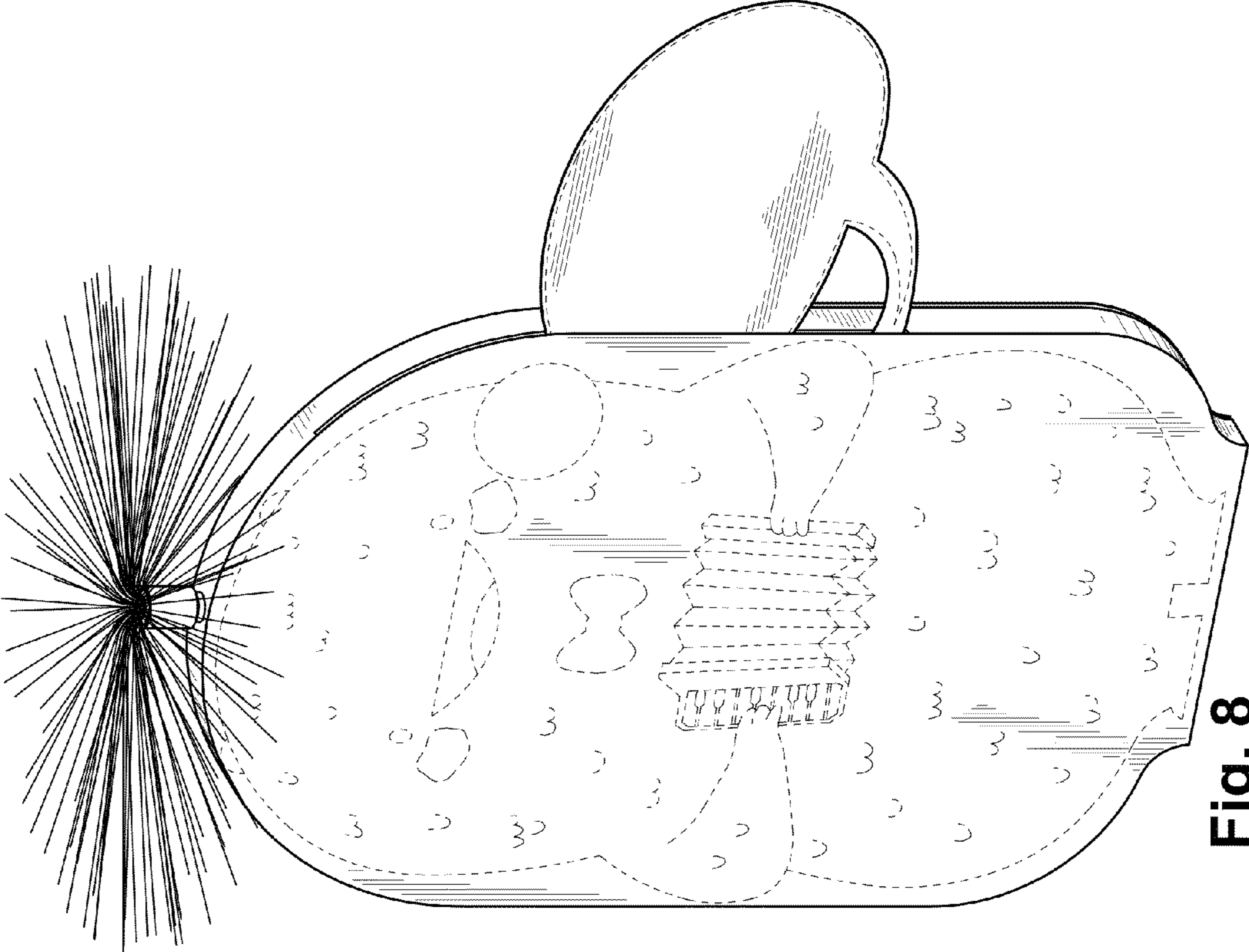

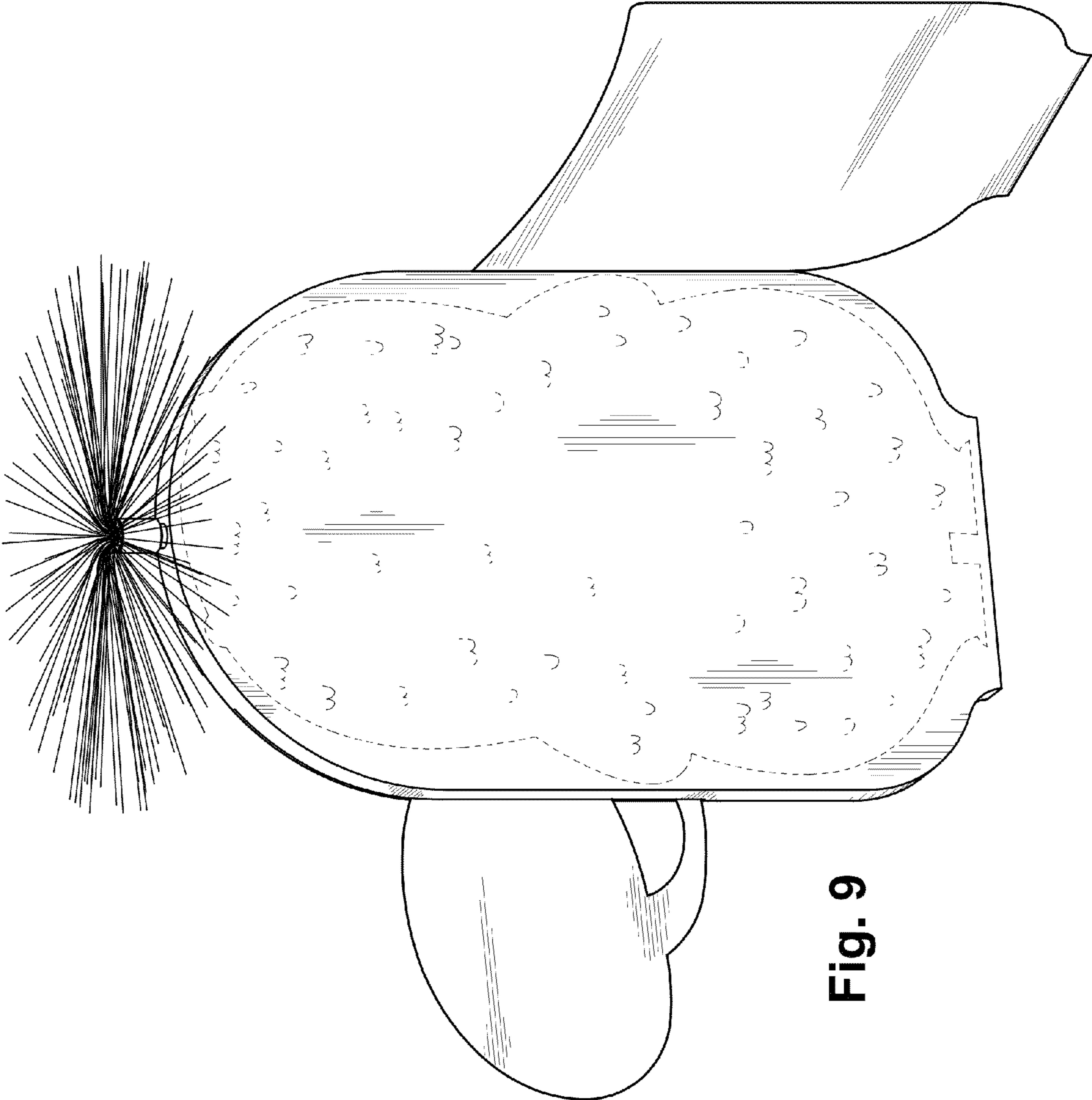
