**DESCRIPTION**

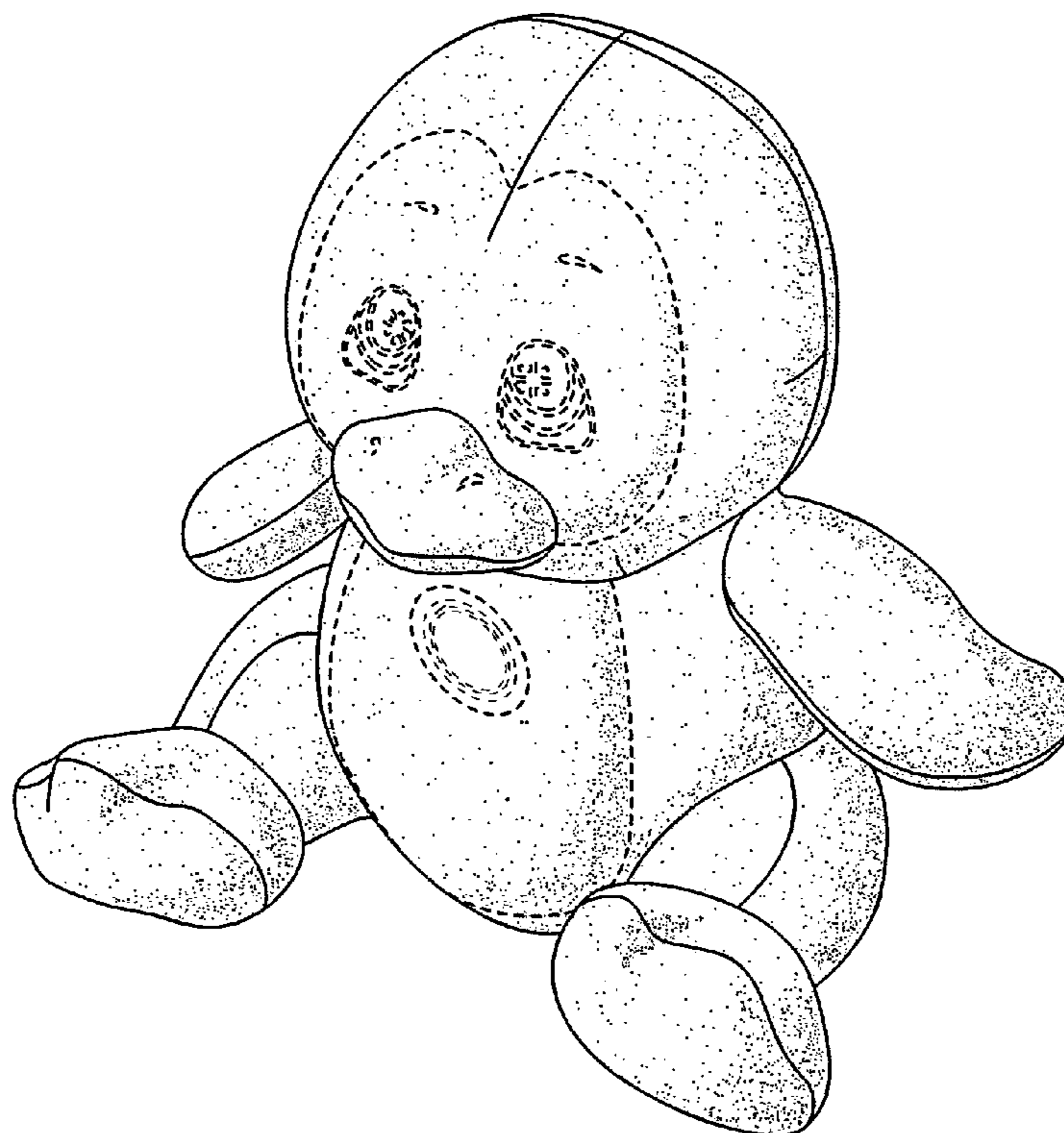
FIG. 1 is a front perspective view of the toy of the present invention showing my new design;

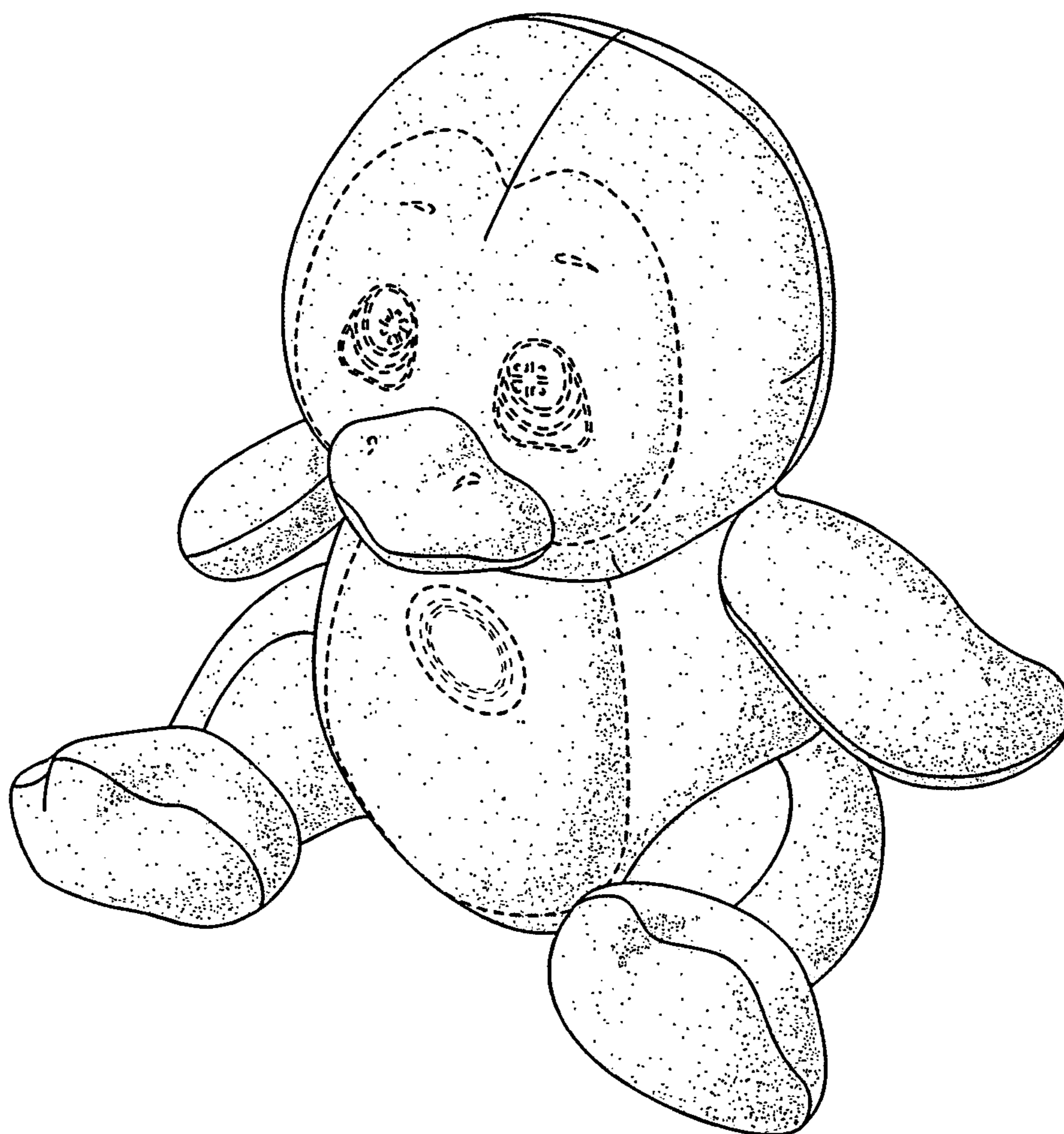

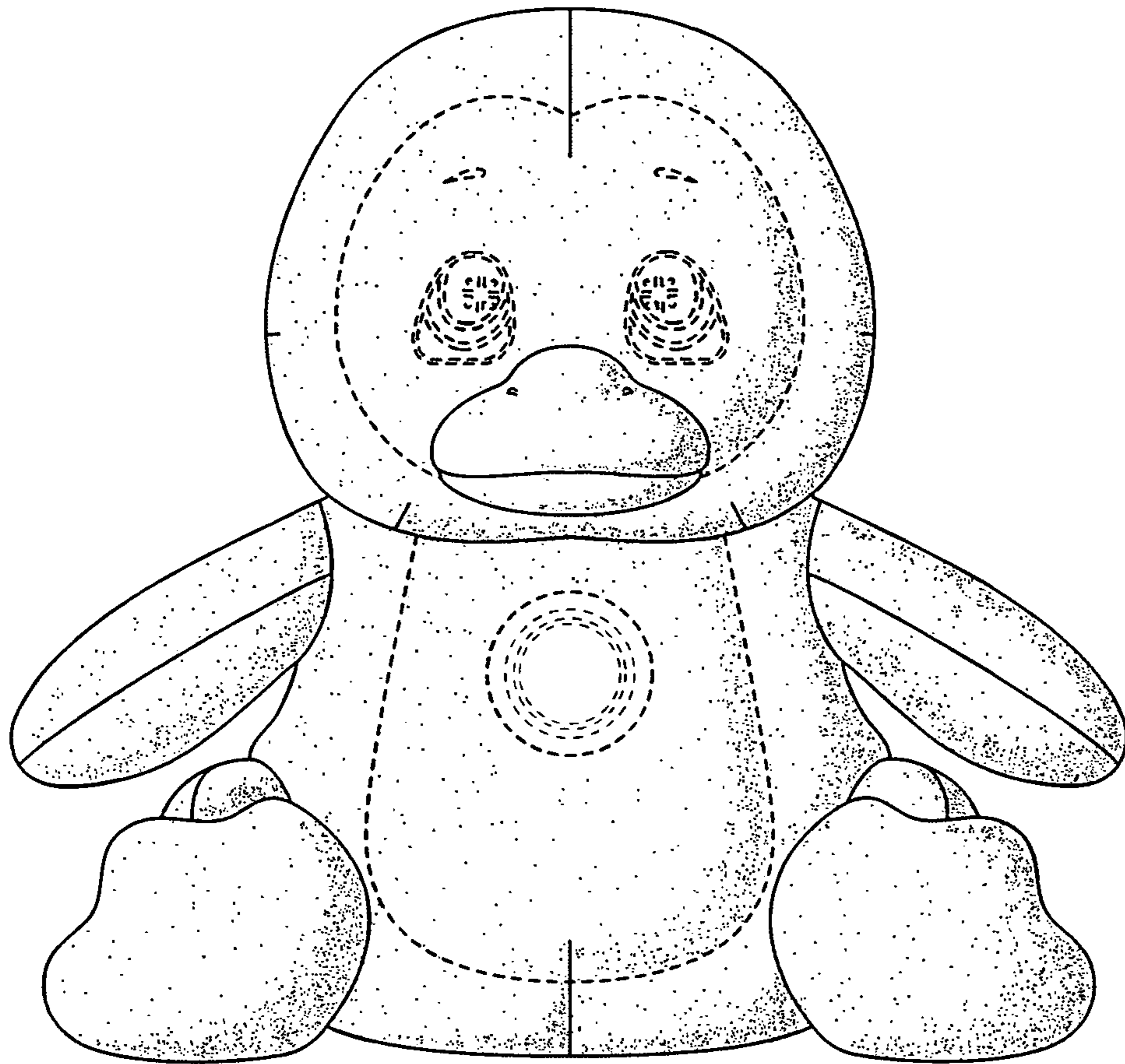

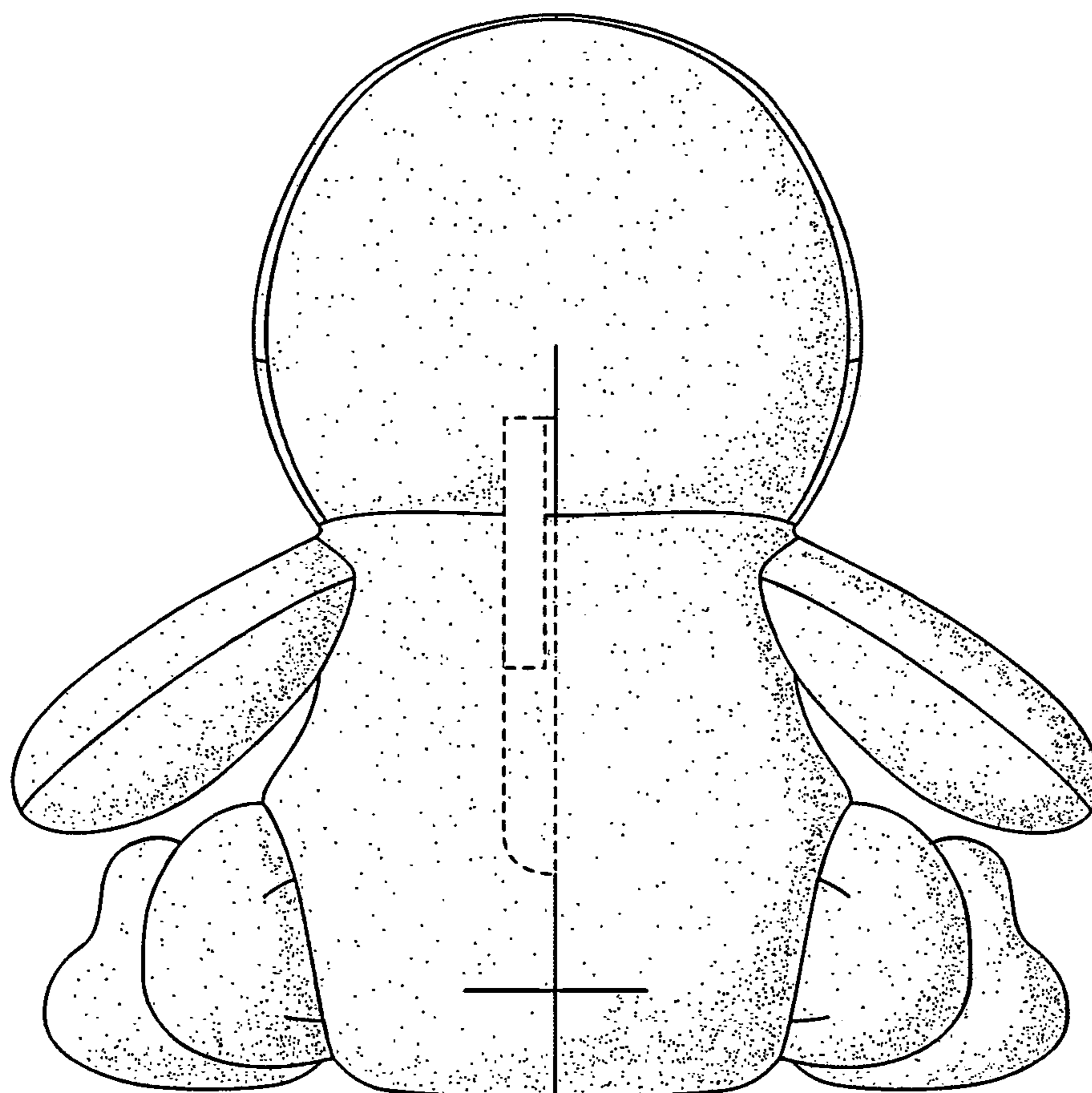

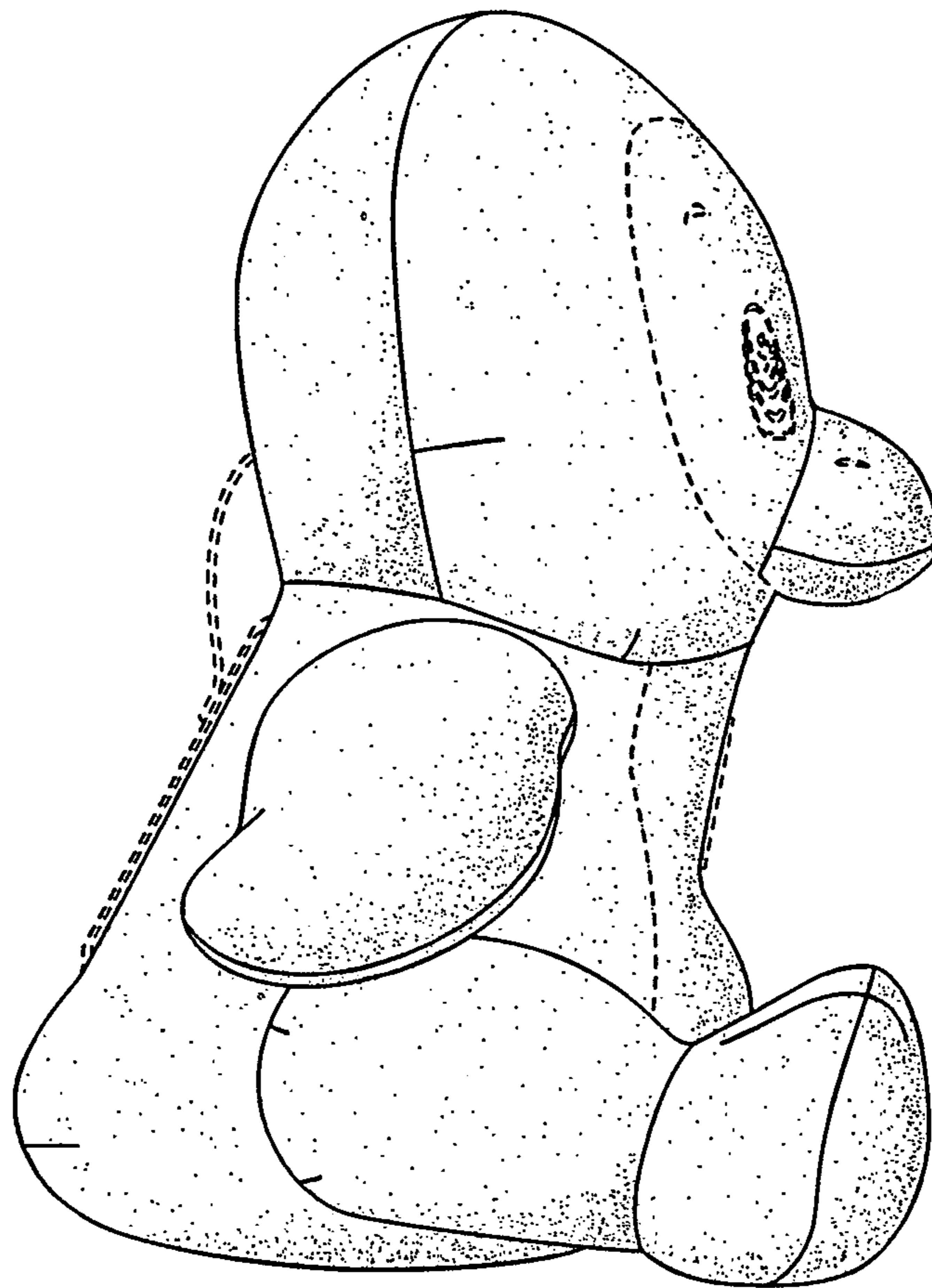

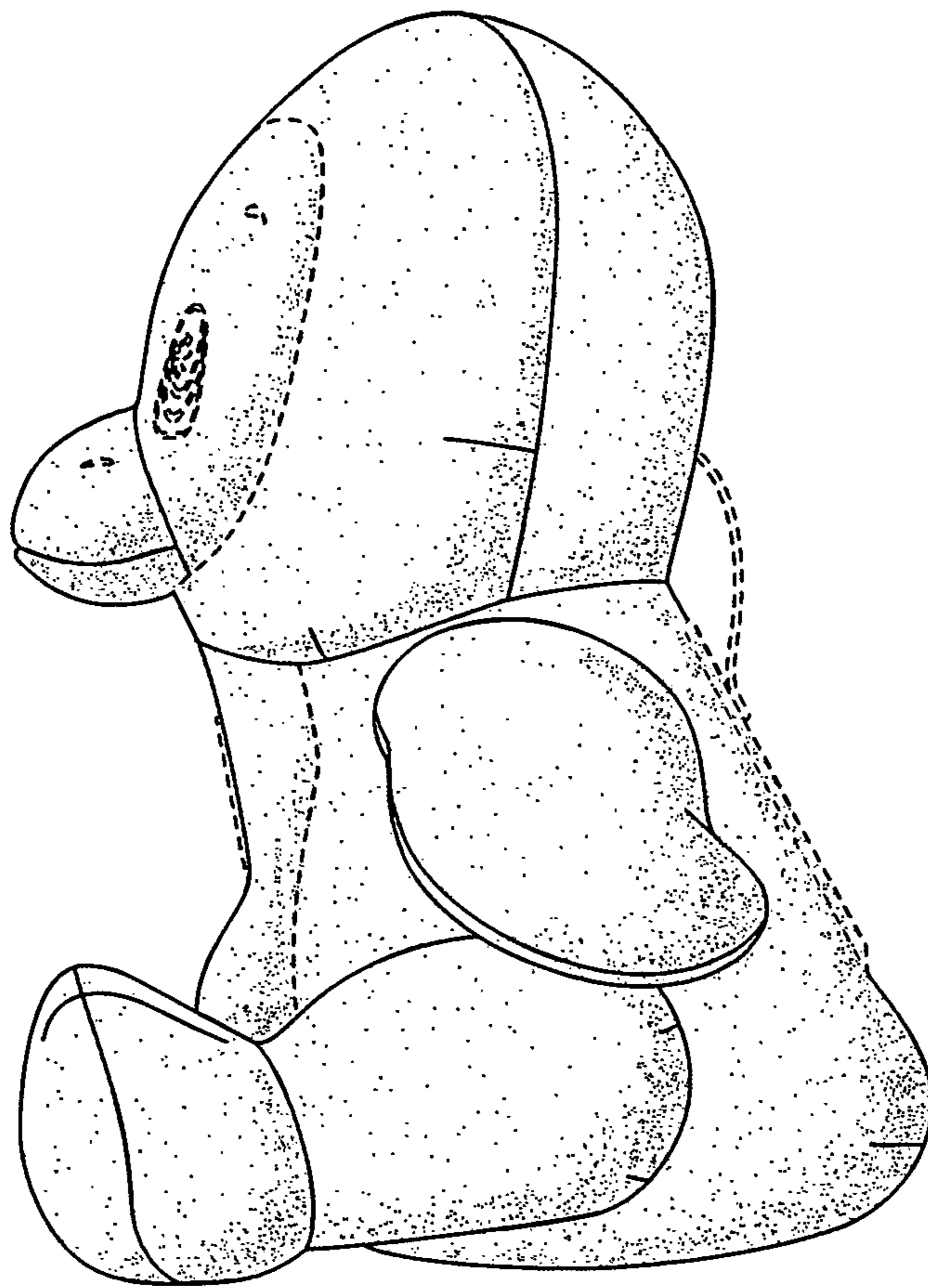

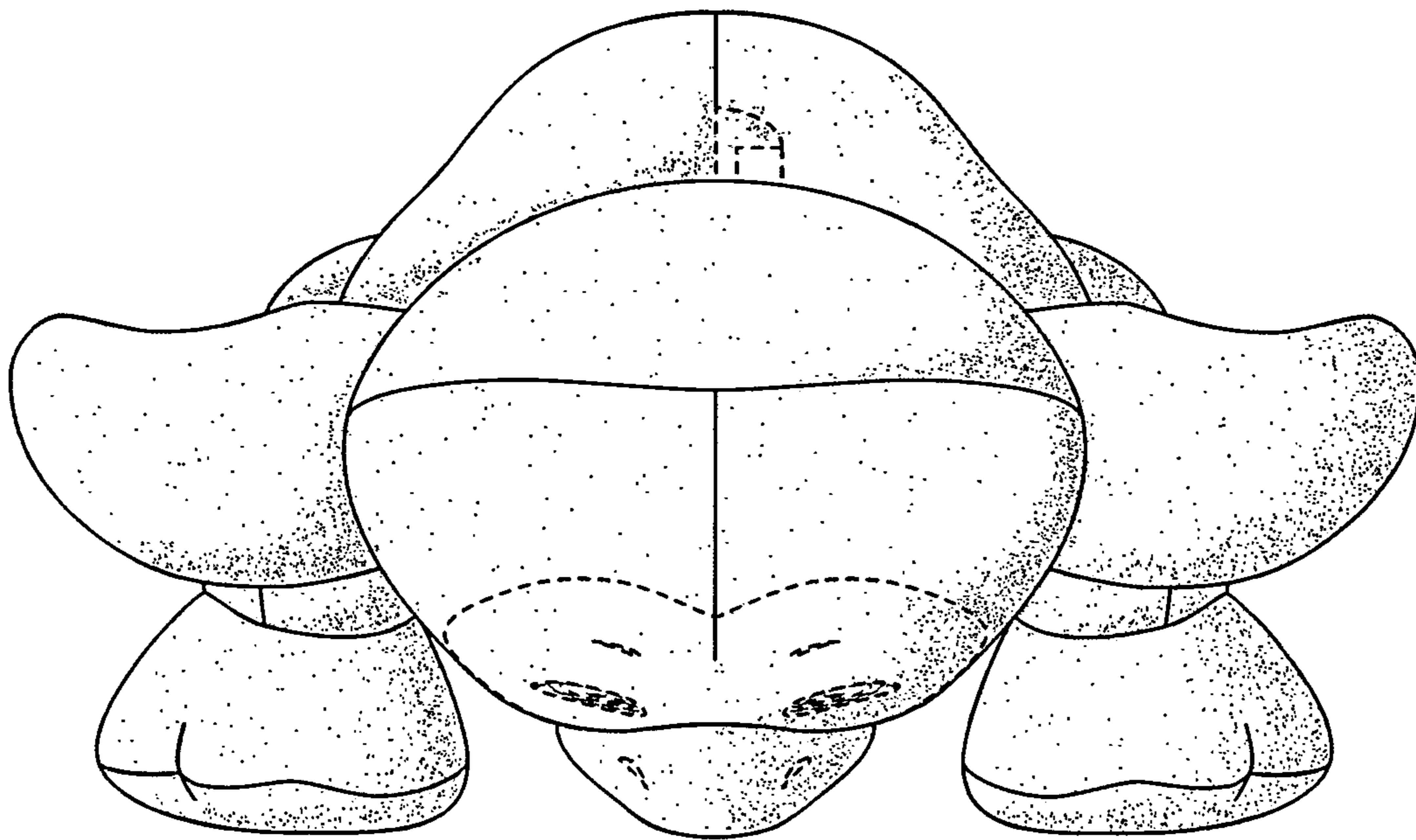

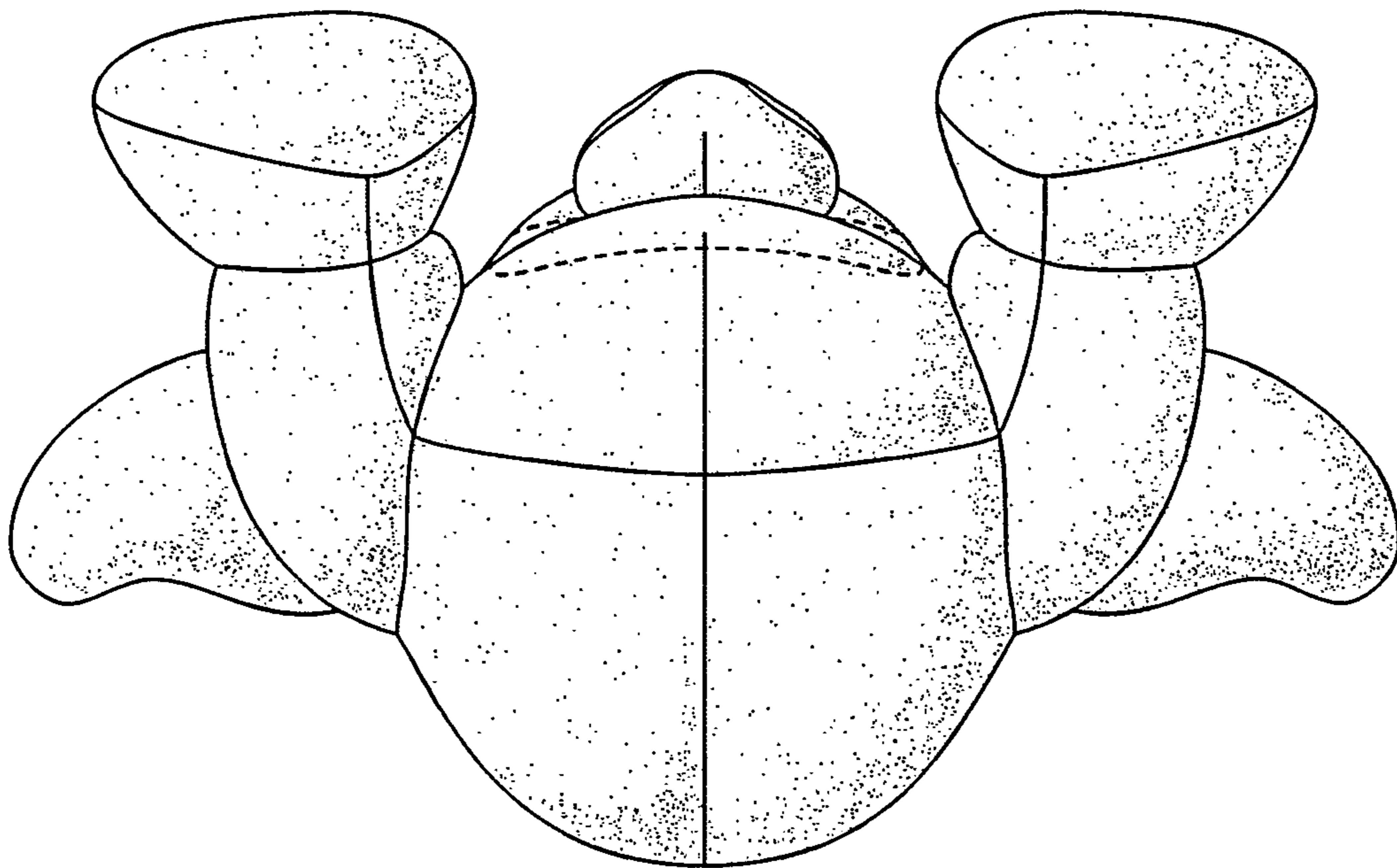
