(57) **CLAIM**

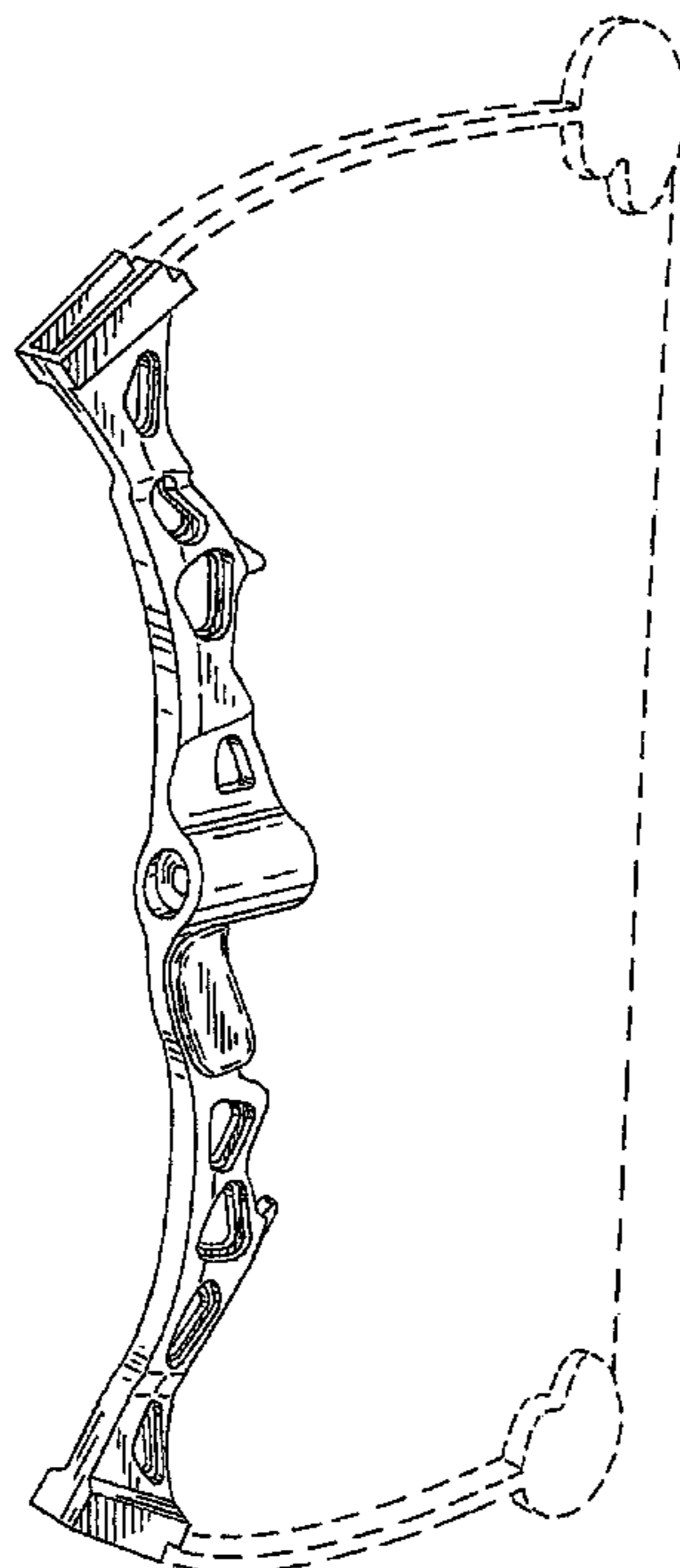
The ornamental design for a new bow riser for an archery bow, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a bow riser for an archery bow in accordance with the present invention; FIG. 2 is a rear right perspective view of the bow riser for an archery bow shown in FIG. 1; FIG. 3 is a left side elevational view of the bow riser for an archery bow shown in FIG. 1; FIG. 4 is a front elevational view of the bow riser for an archery bow shown in FIG. 1; FIG. 5 is a rear elevational view of the bow riser for an archery bow shown in FIG. 1; FIG. 6 is a right side elevational view of the bow riser for an archery bow shown in FIG. 1; FIG. 7 is a top view of the bow riser for an archery bow shown in FIG. 3; and, FIG. 8 is a bottom view of the bow riser for an archery bow shown in FIG. 3.

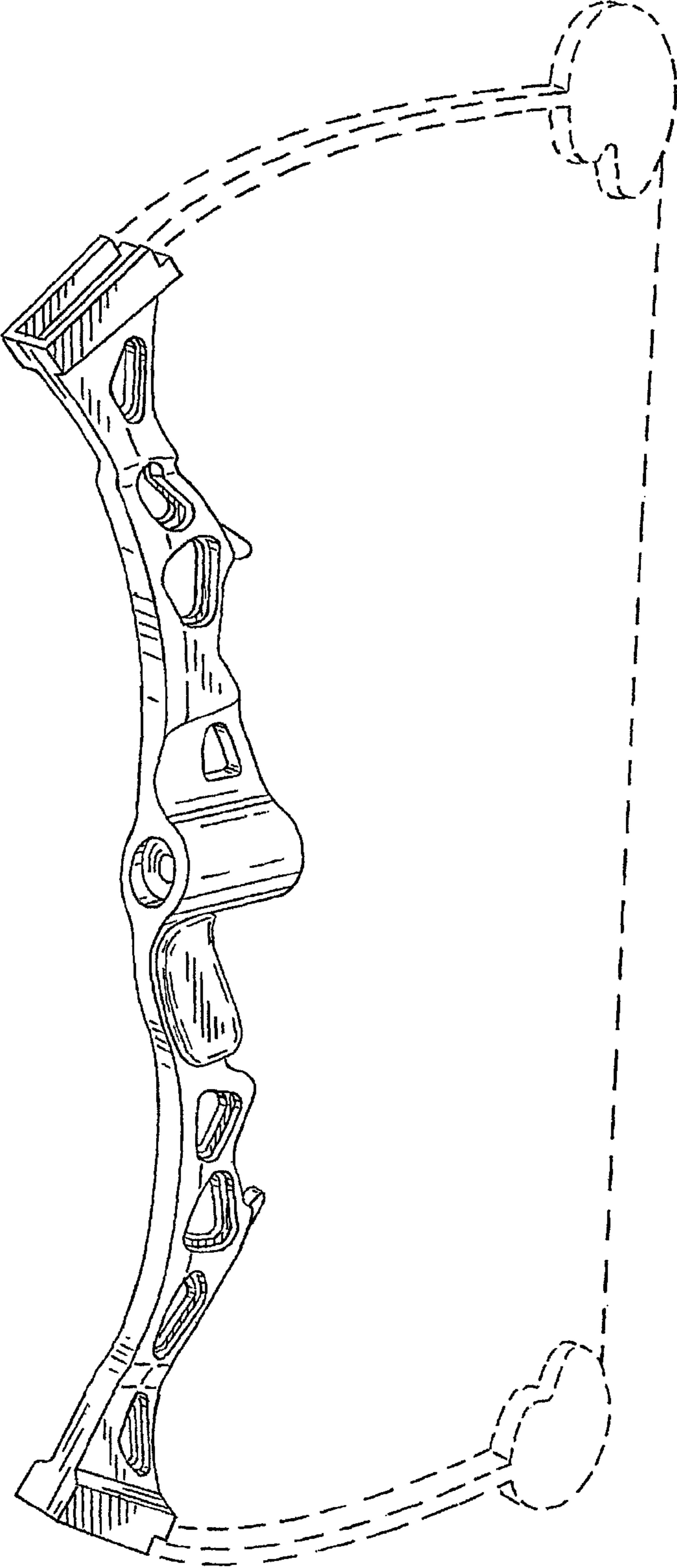

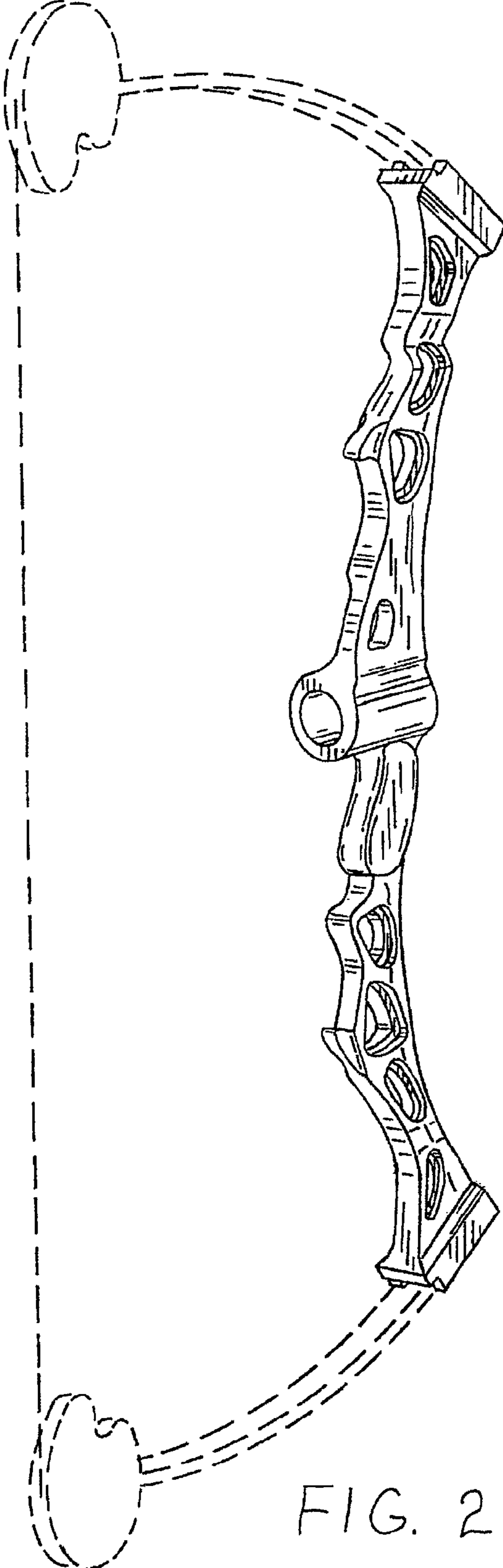

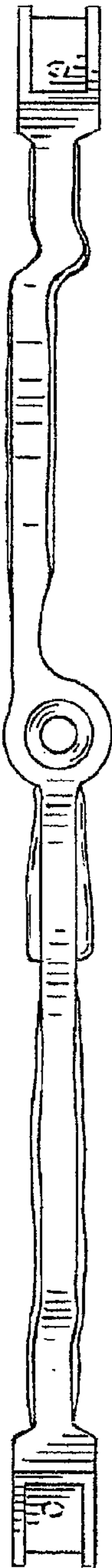

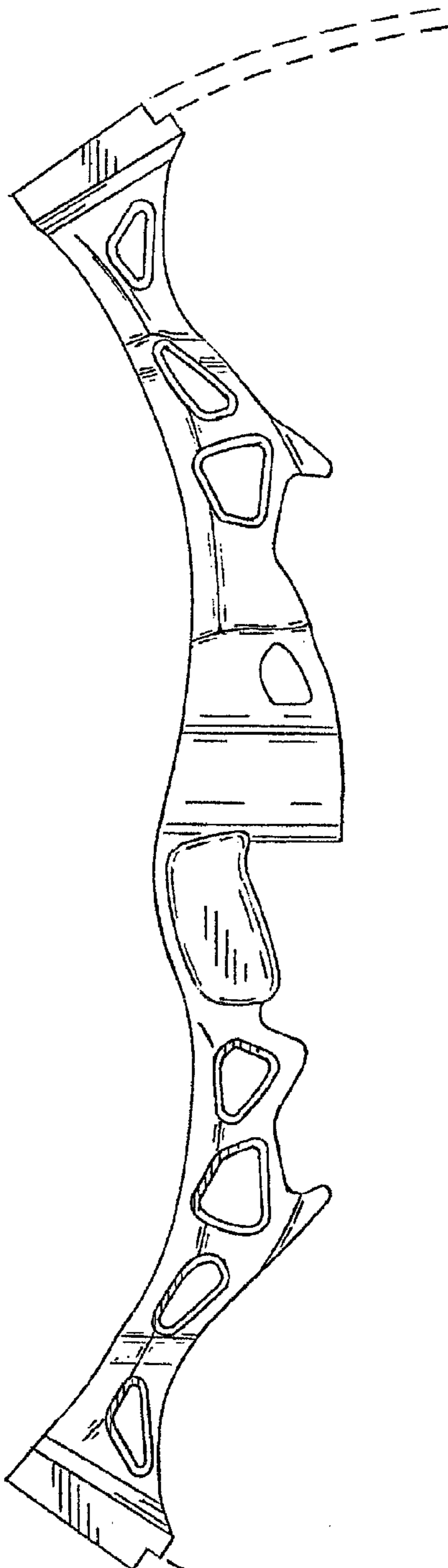

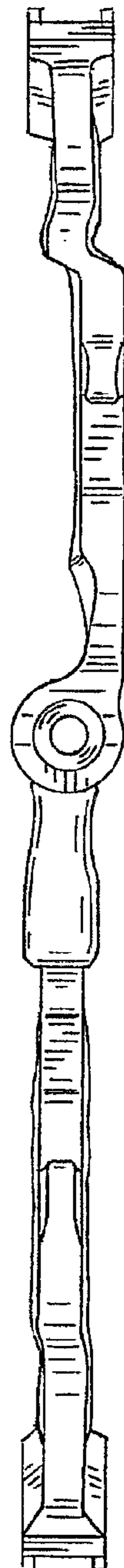

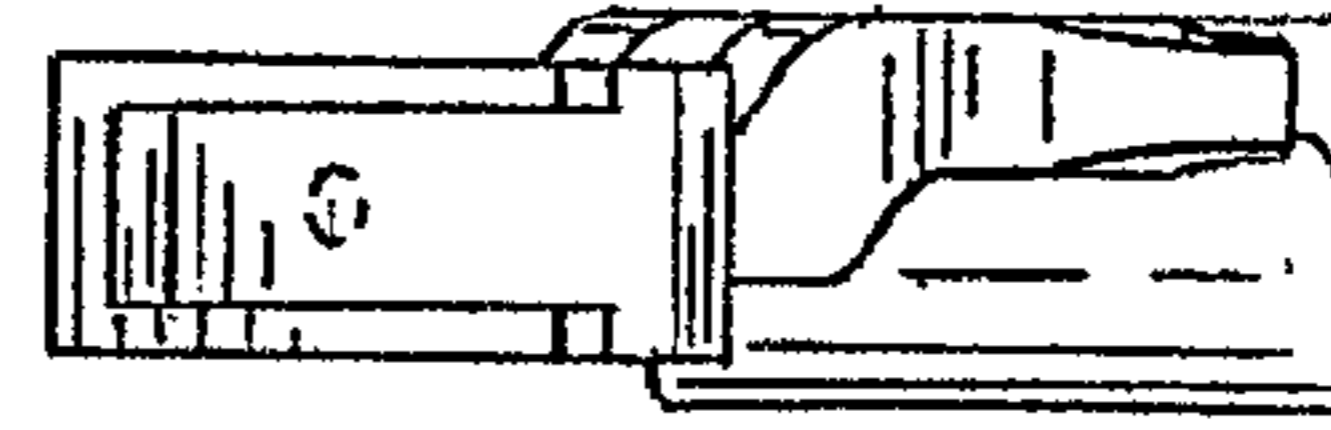
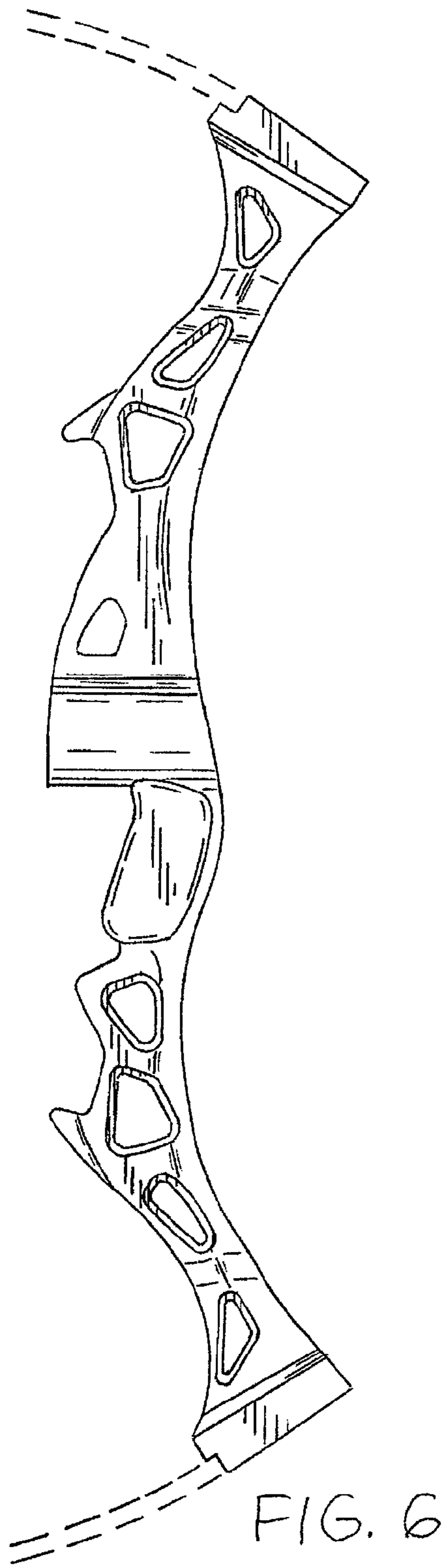

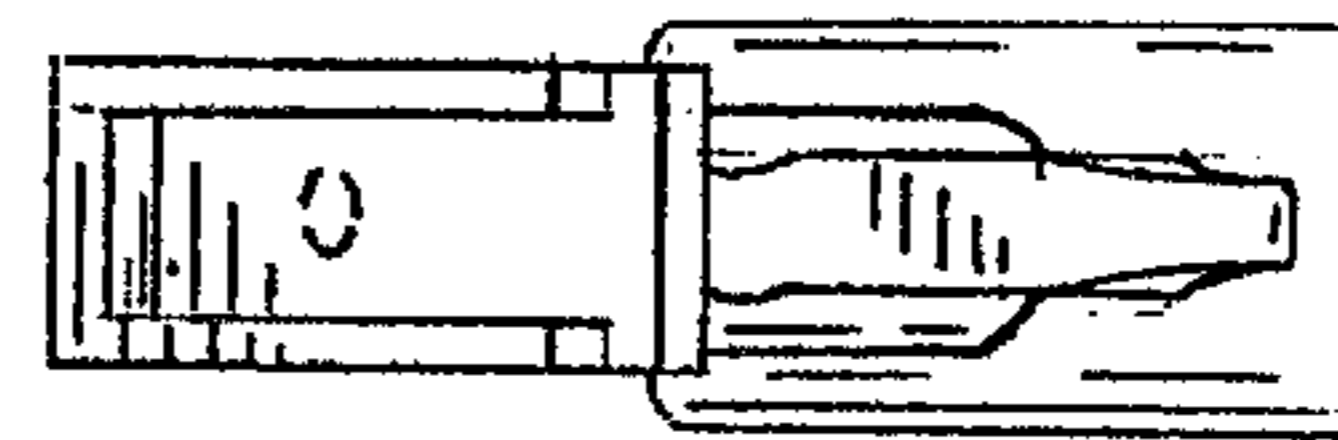
