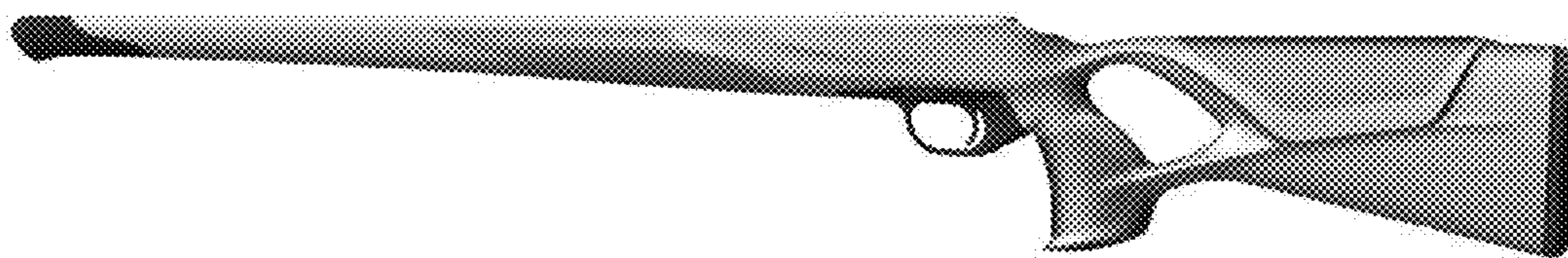
(57) **CLAIM**

The ornamental design for a gunstock, as shown and described.

DESCRIPTION

FIG. 1 is a first side view of a first embodiment of a gunstock according to the present invention.
FIG. 2 is a second side view of the gunstock of FIG. 1.
FIG. 3 is a top view of the gunstock of FIG. 1.
FIG. 4 is a bottom view of the gunstock of FIG. 1.
FIG. 5 is a front view of the gunstock of FIG. 1.
FIG. 6 is a rear view of the gunstock of FIG. 1.
FIG. 7 is a first side view of a second embodiment of a gunstock according to the present invention.
FIG. 8 is a second side view of the gunstock of FIG. 7.
FIG. 9 is a top view of the gunstock of FIG. 7.
FIG. 10 is a bottom view of the gunstock of FIG. 7.
FIG. 11 is a front view of the gunstock of FIG. 7; and, FIG. 12 is a rear view of the gunstock of FIG. 7.

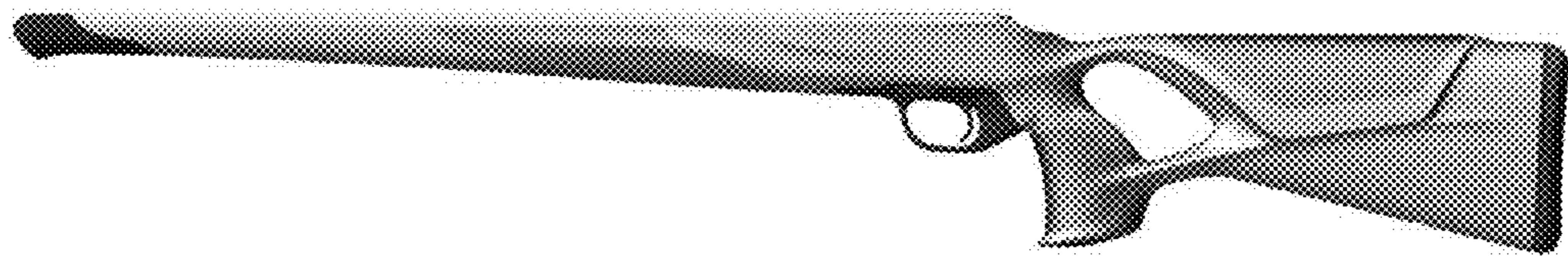

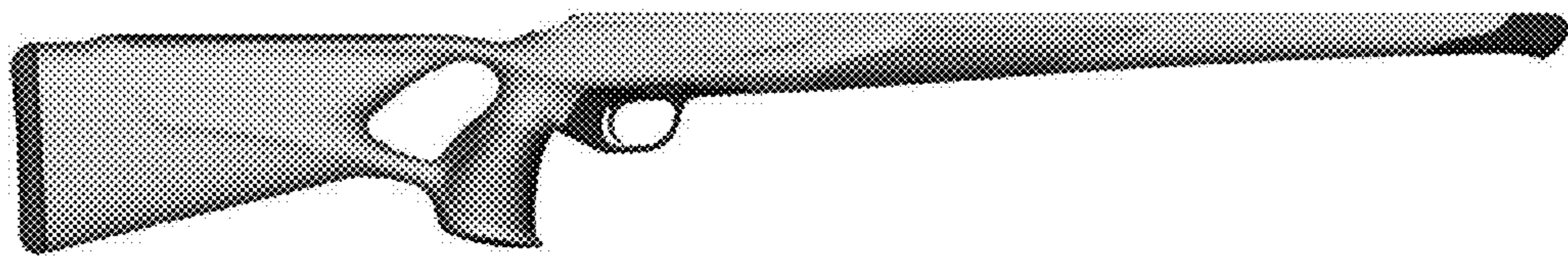

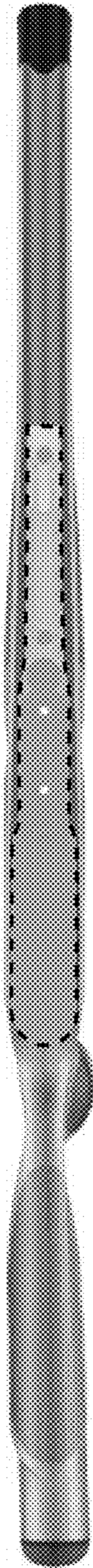

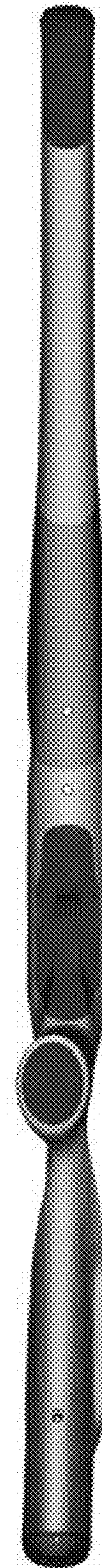

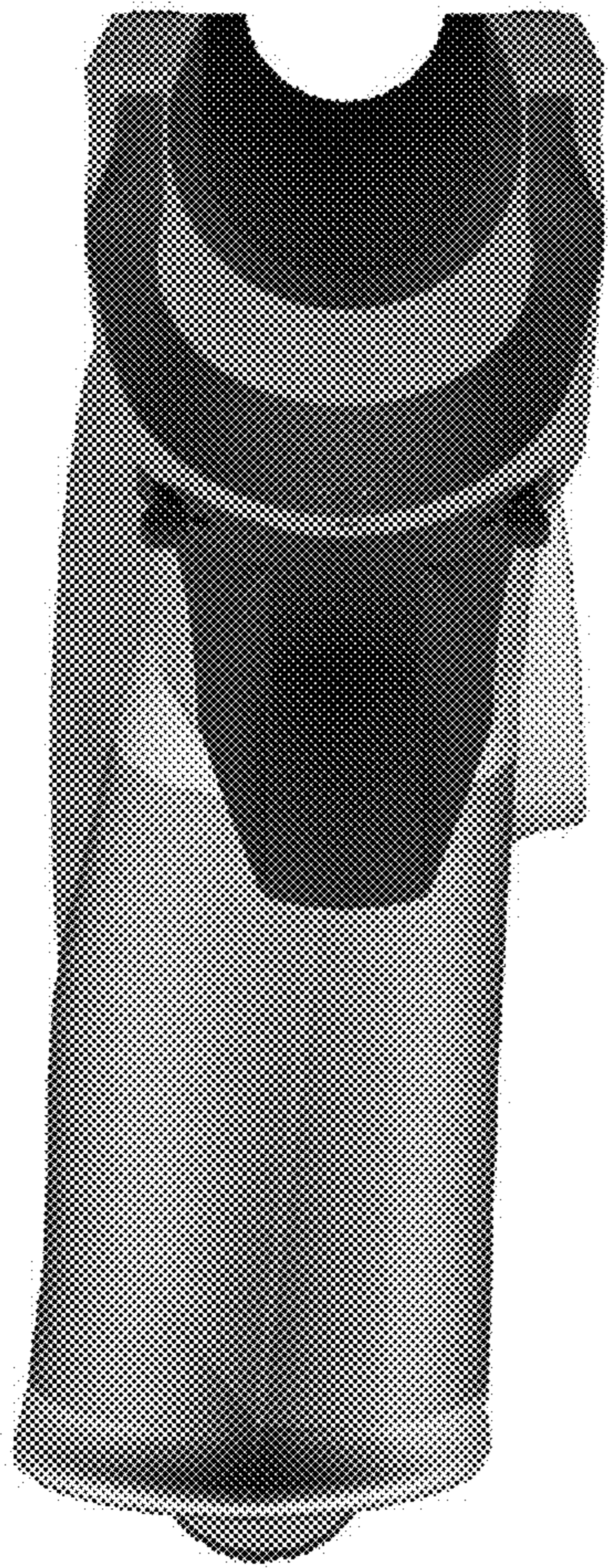

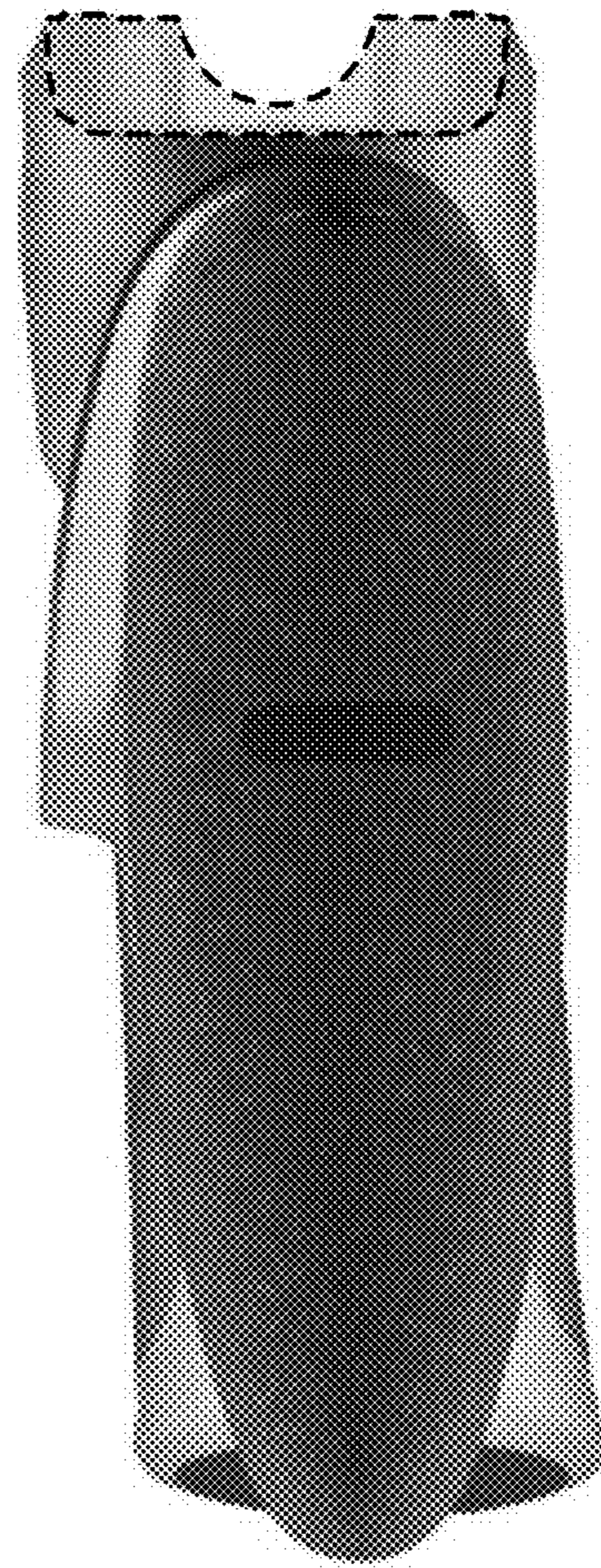

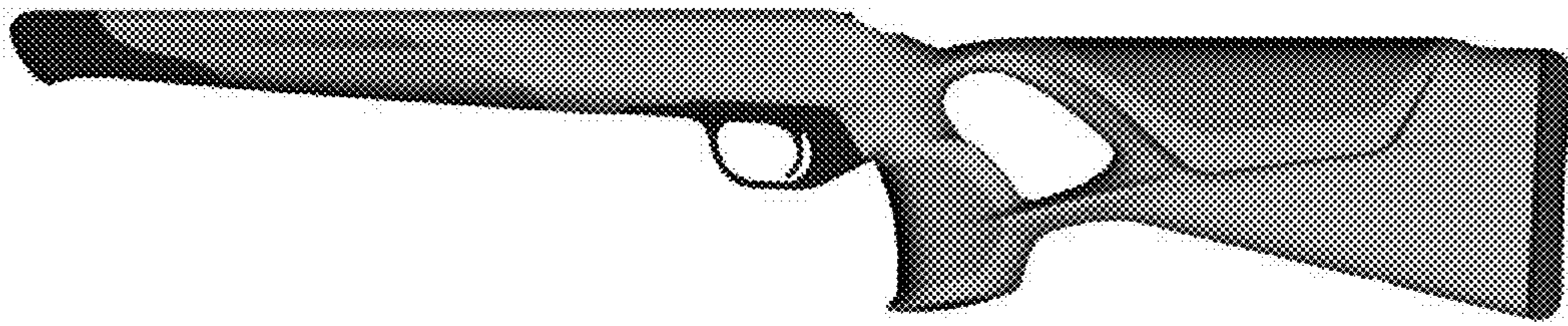

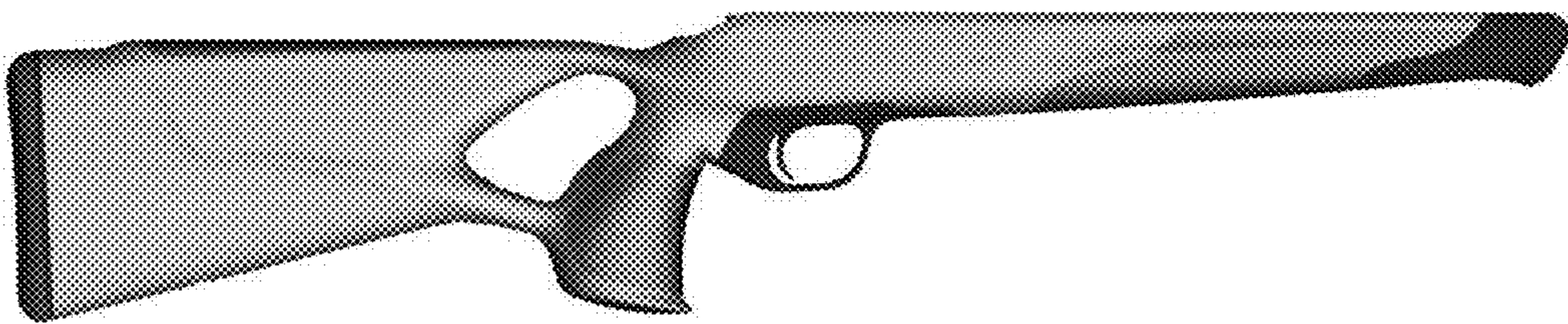

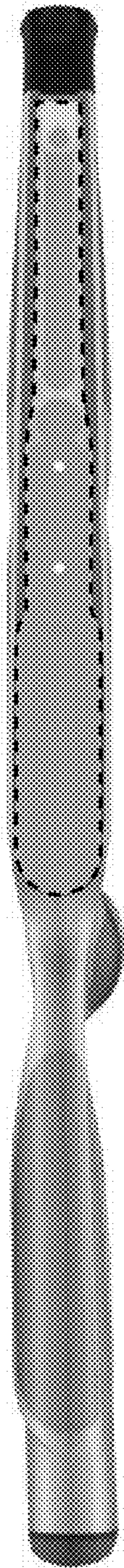

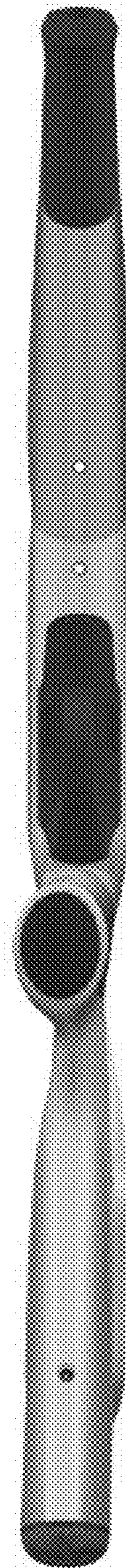

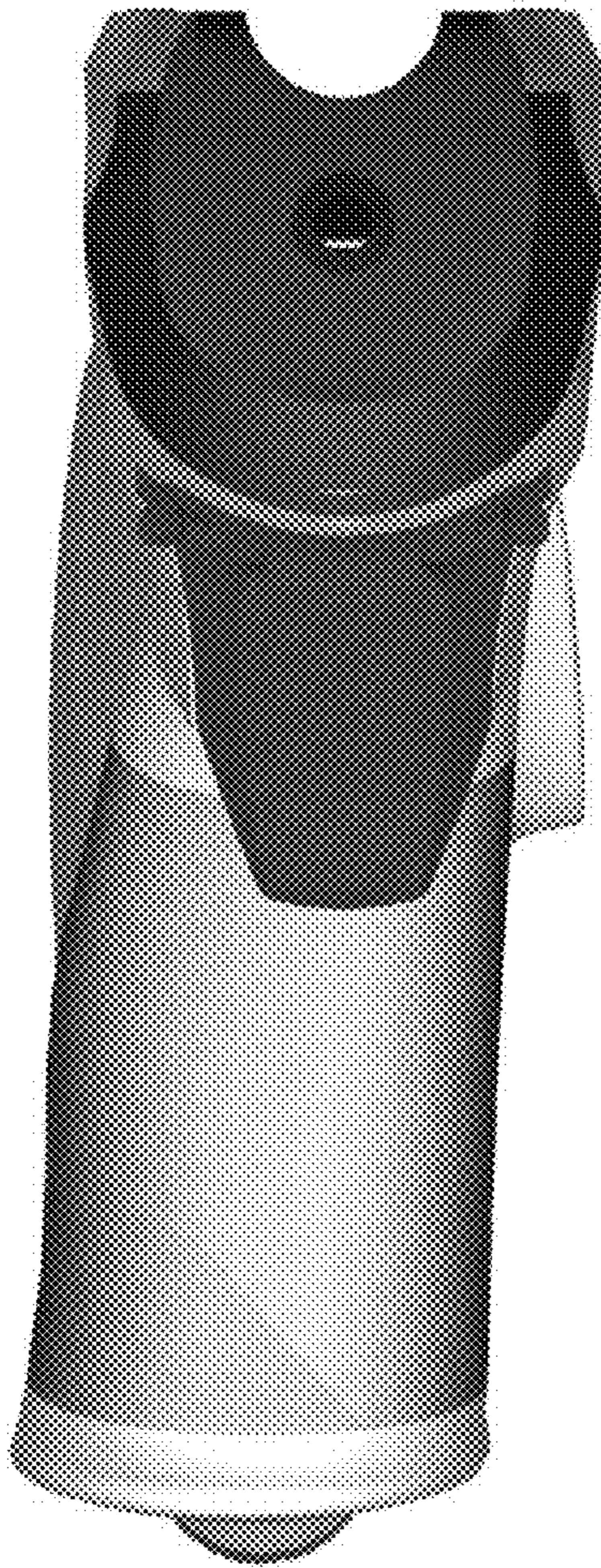
