(57)CLAIM

The ornamental design for a fishing reel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fishing reel constructed in accordance with an embodiment of the present invention, shown with a flange in an open position;

FIG. 2 is a rear perspective view of the fishing reel shown in FIG. 1, shown with the flange in an open position;

FIG. 3 is a top view of the fishing reel shown in FIGS. 1 and 2, shown with the flange in an open position;

FIG. 4 is a bottom view of the fishing reel shown in FIGS. 1-3, shown with the flange in an open position;

FIG. 5 is a left side view of the fishing reel shown in FIGS.

1-4, shown with the flange in an open position; FIG. 6 is a right side view of the fishing reel shown in FIGS.

1-12, shown with the flange in a closed position;


FIG. 14 is a right side view of the fishing reel shown in FIGS.































