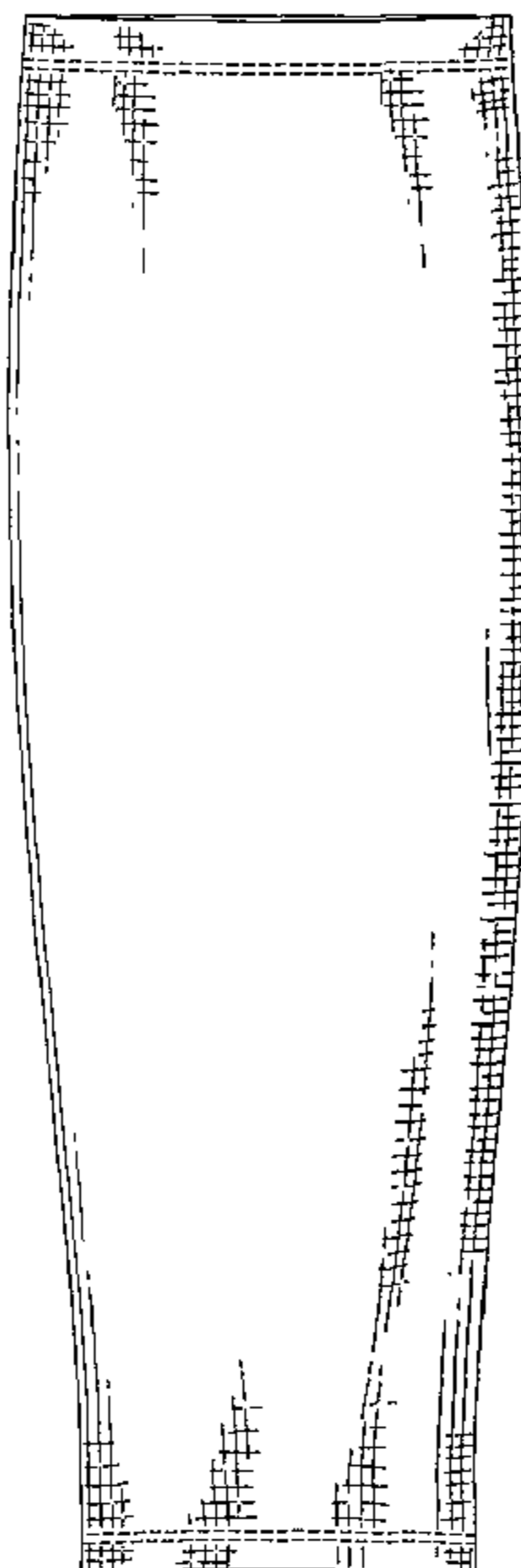
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of one embodiment of my new design for a knee pillow;

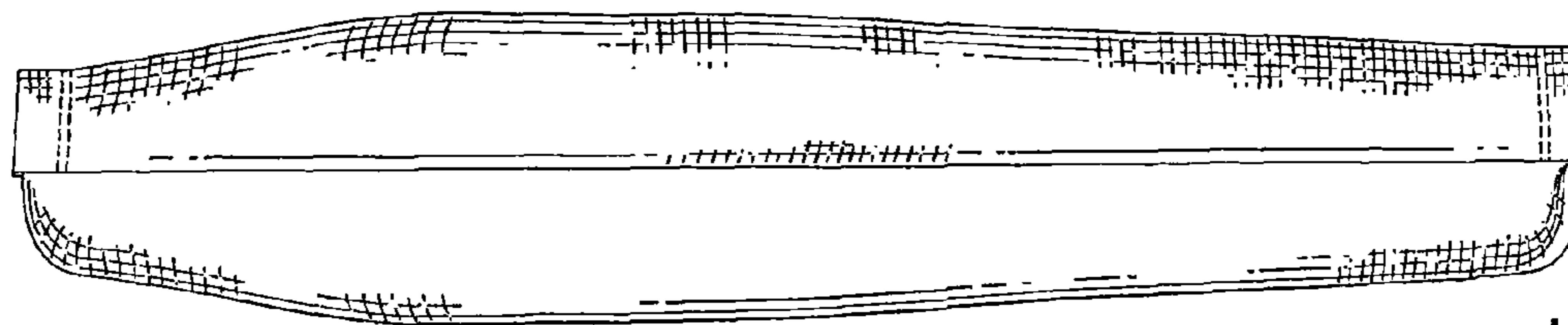

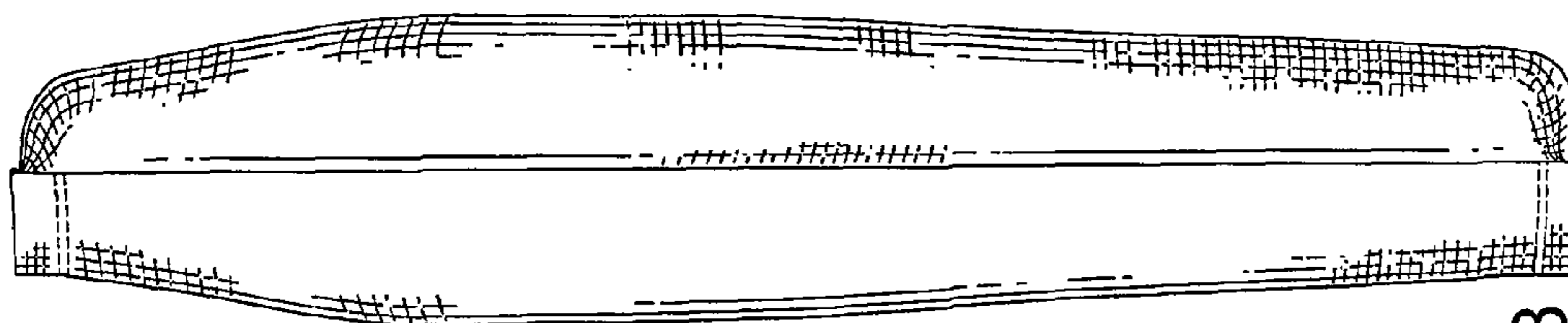

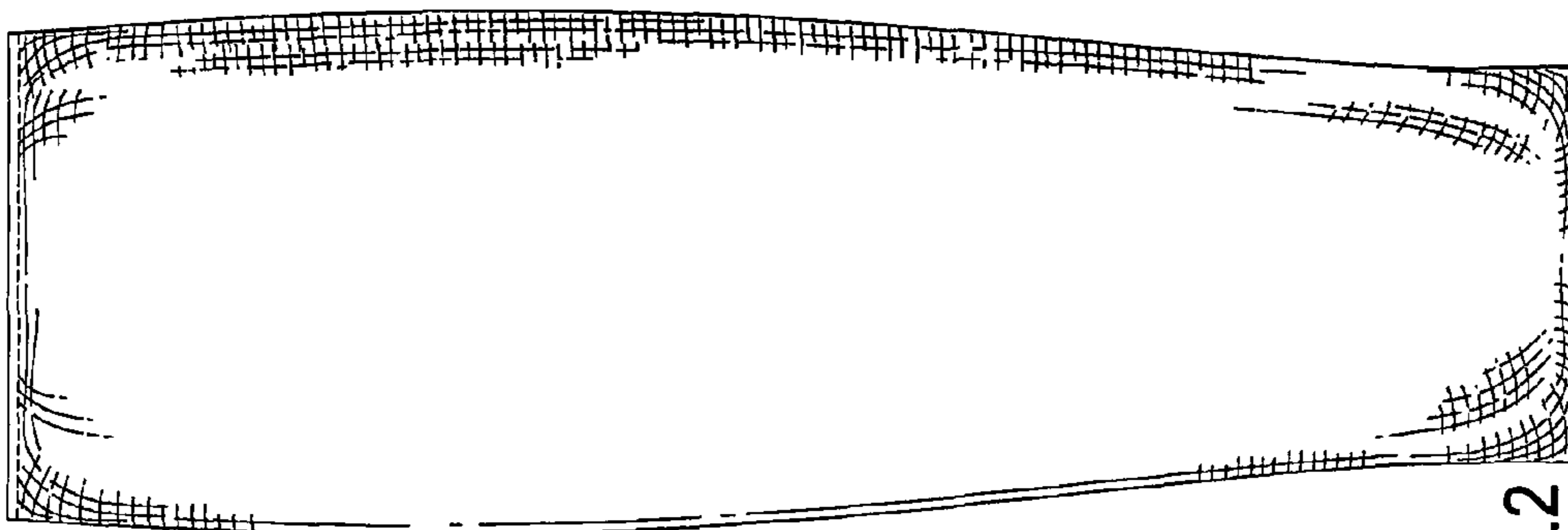

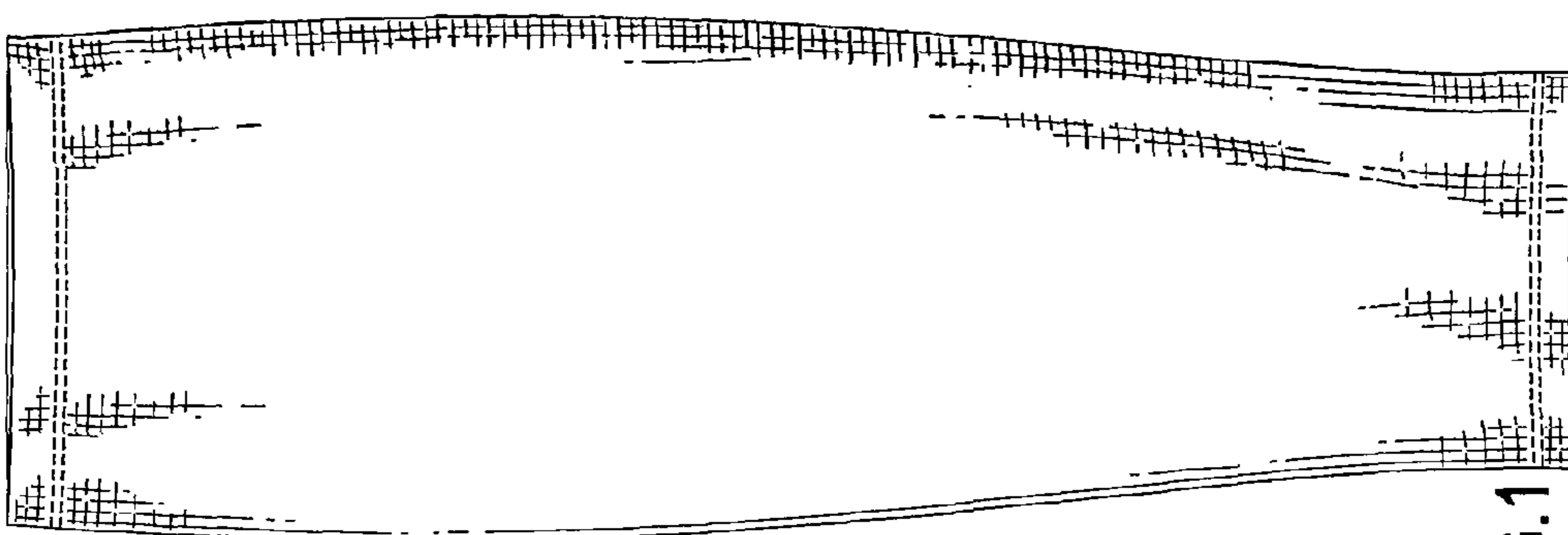

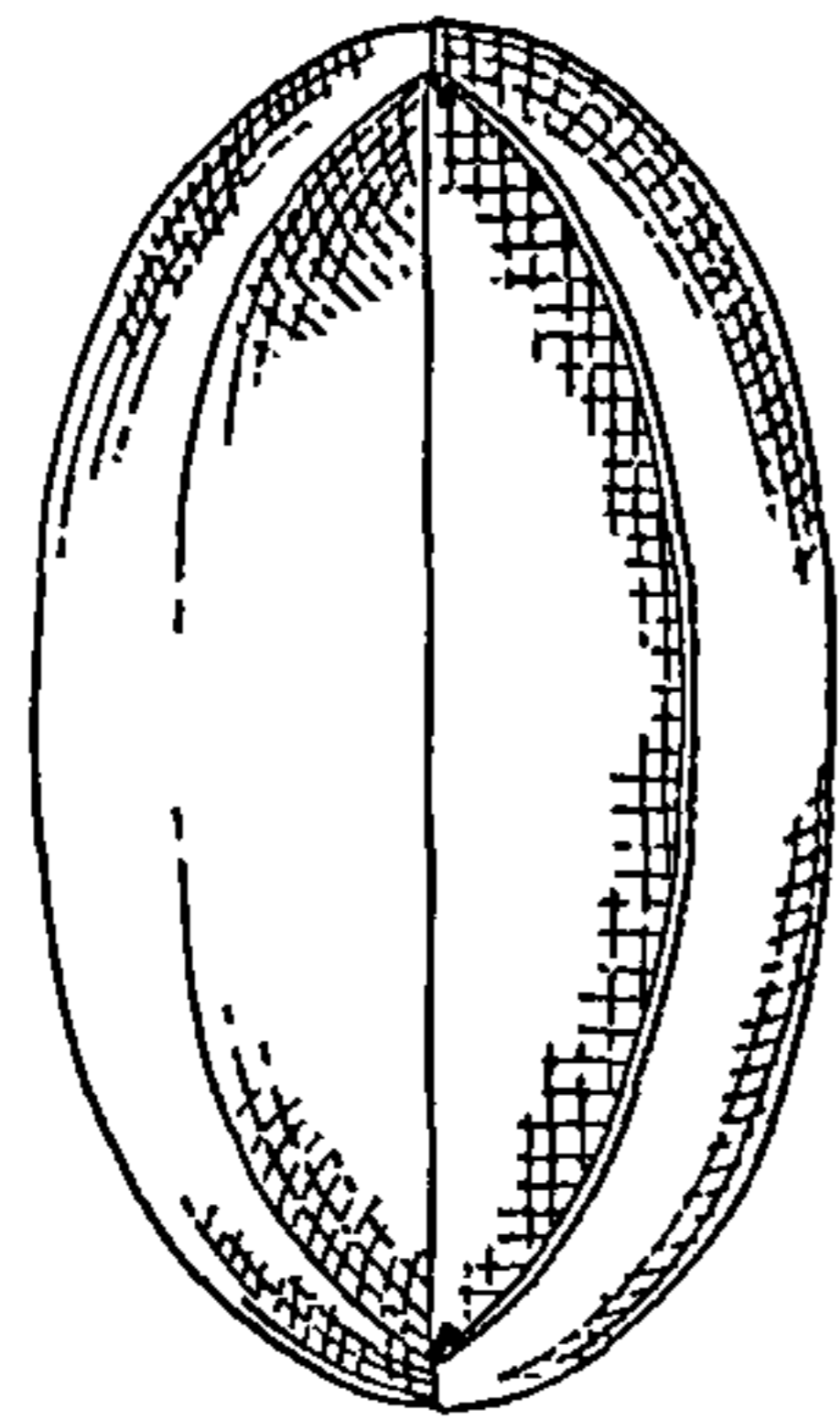

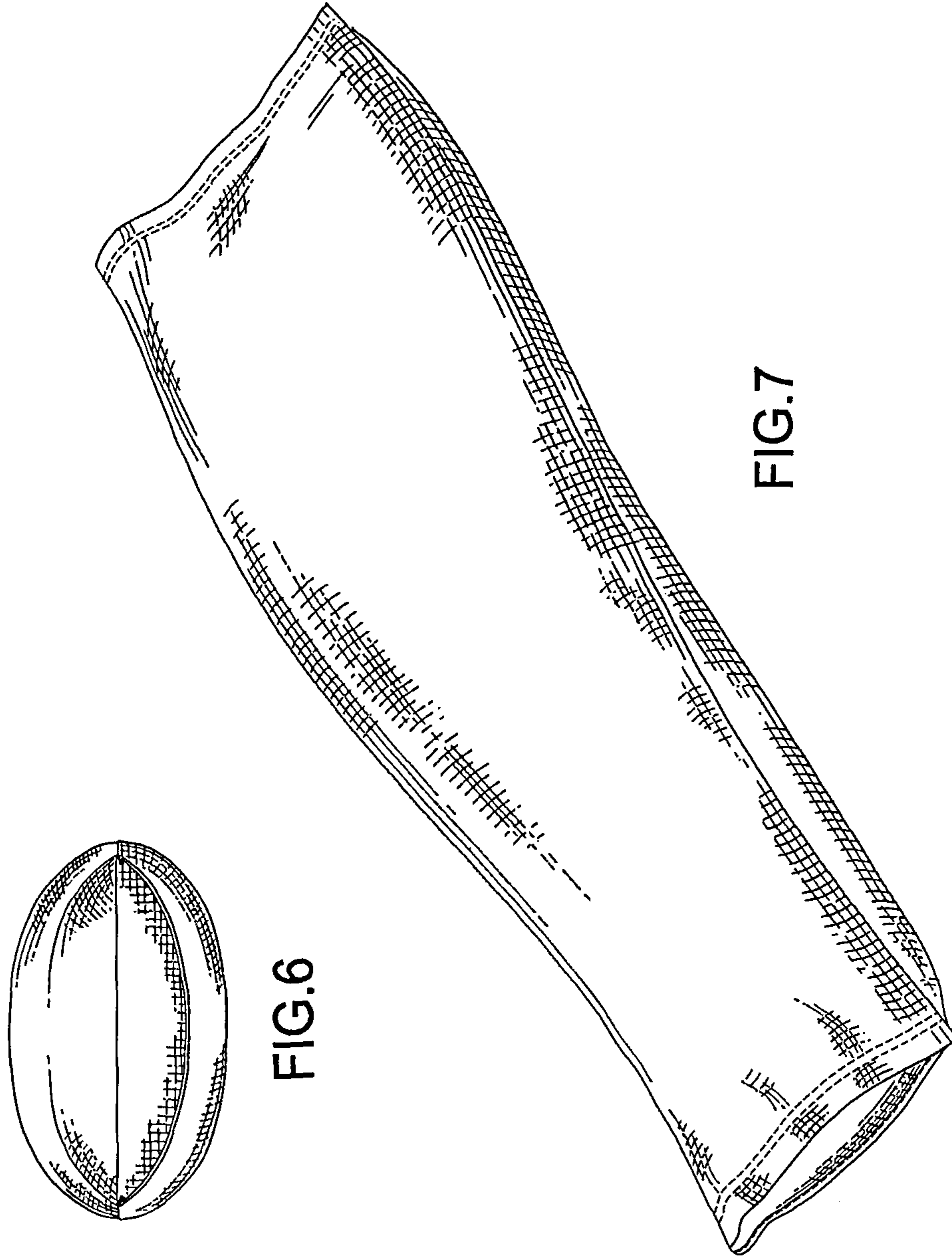

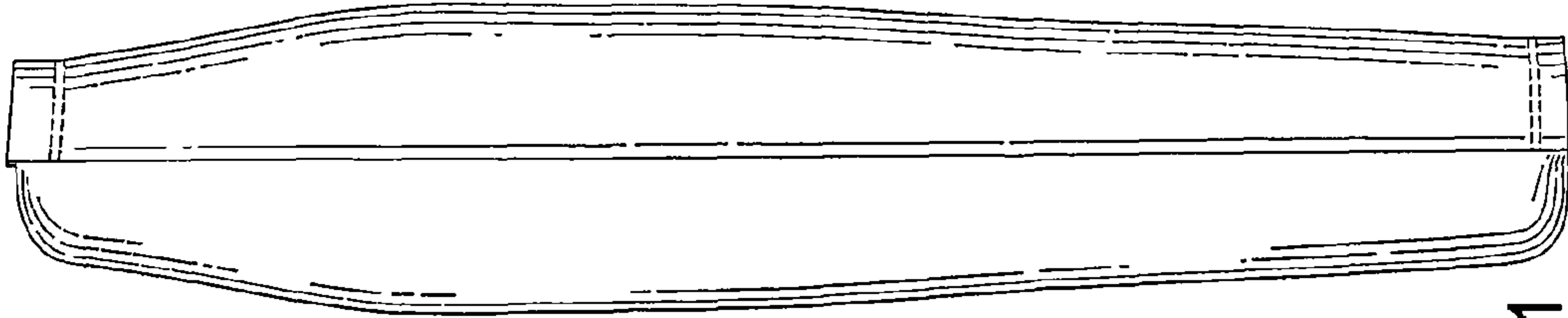

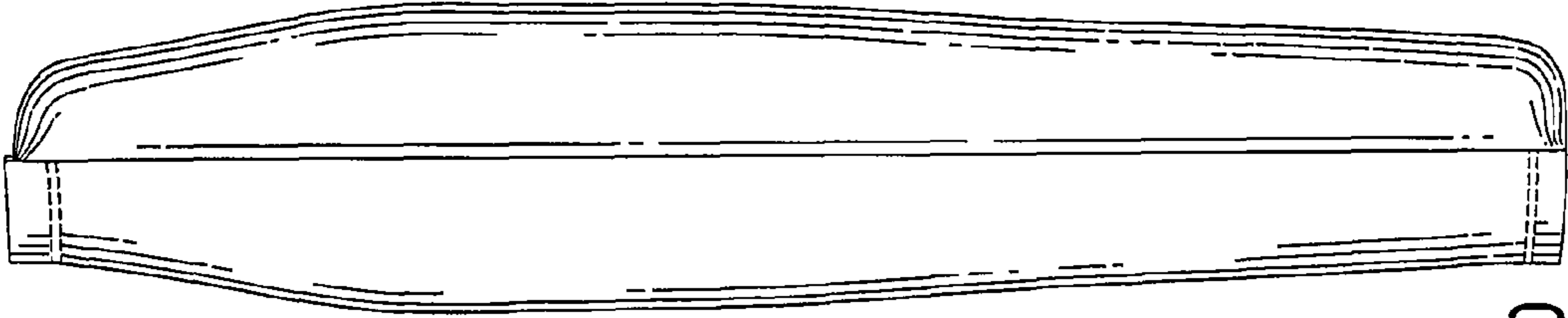

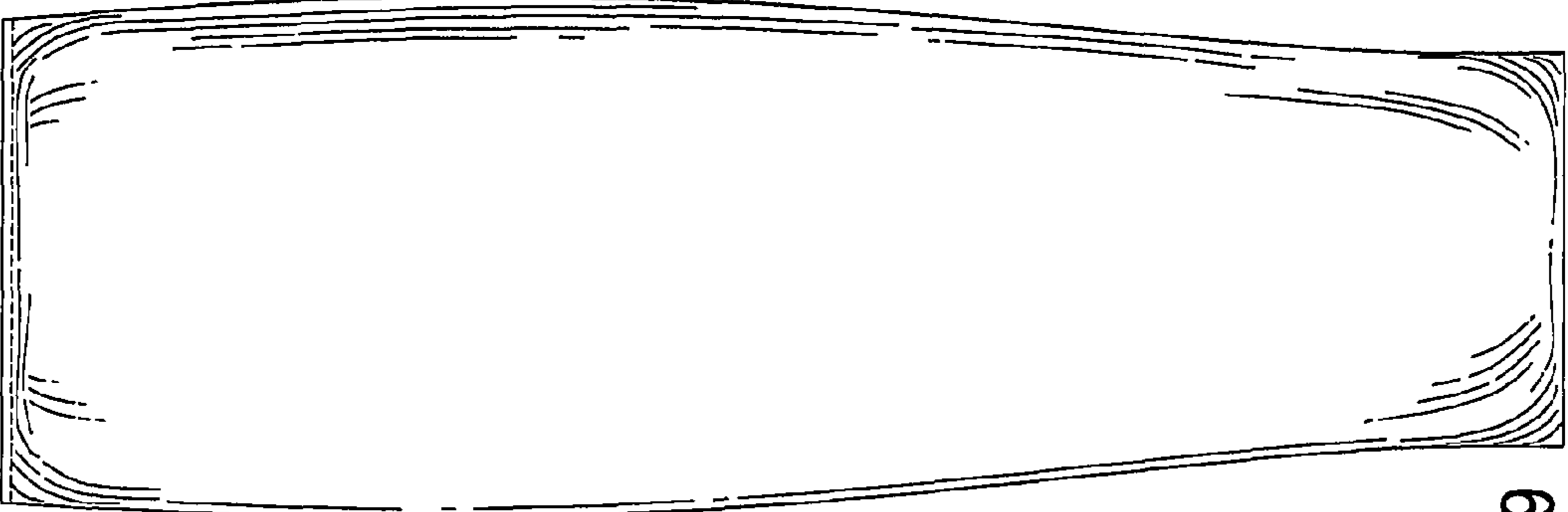

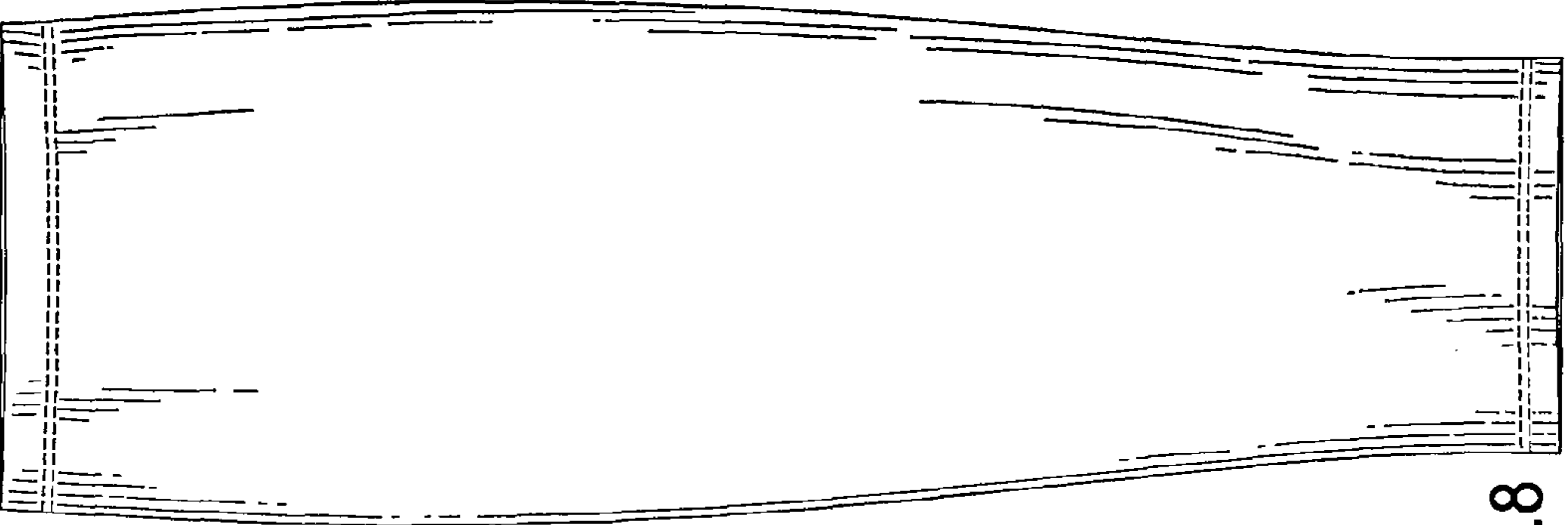

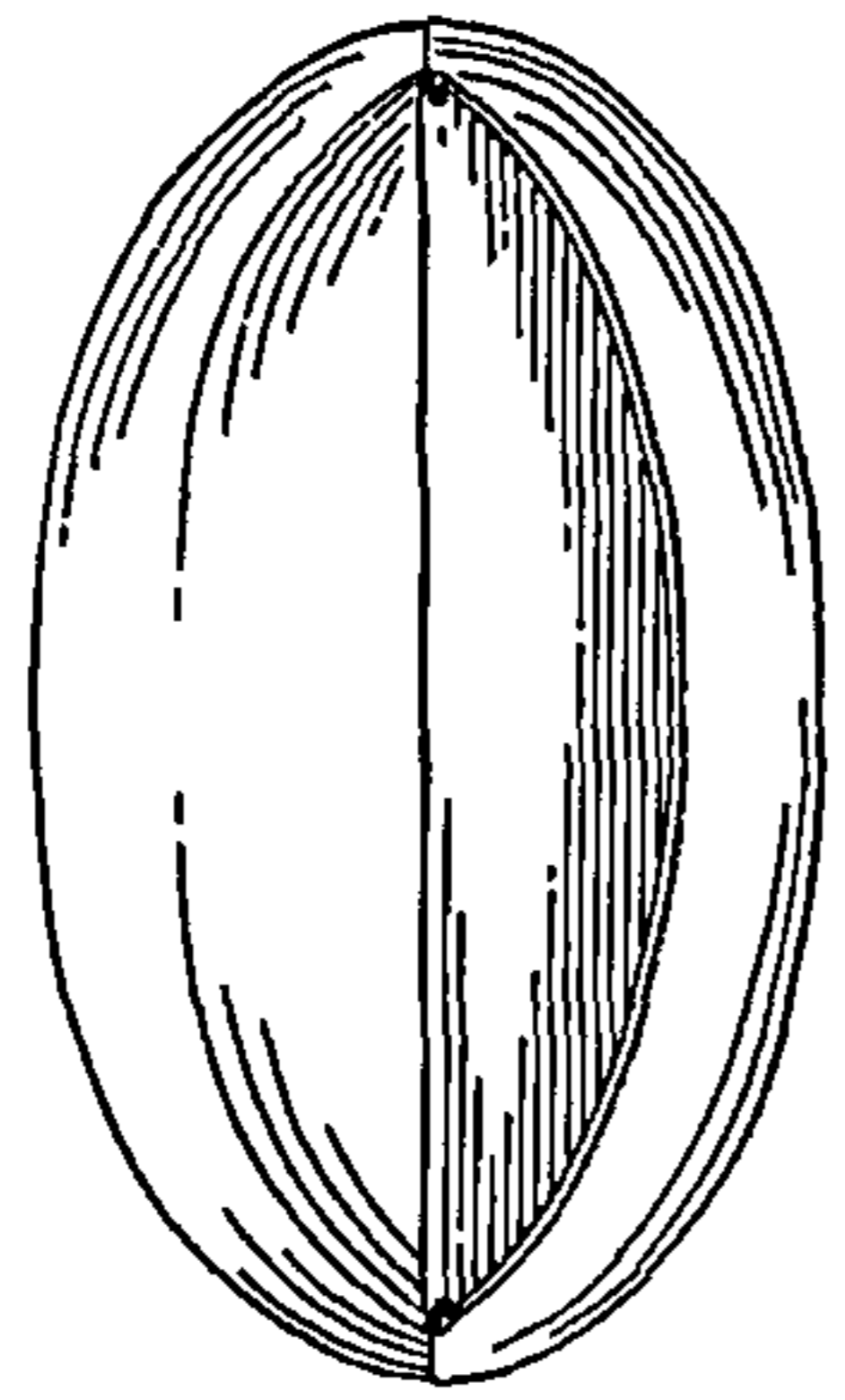

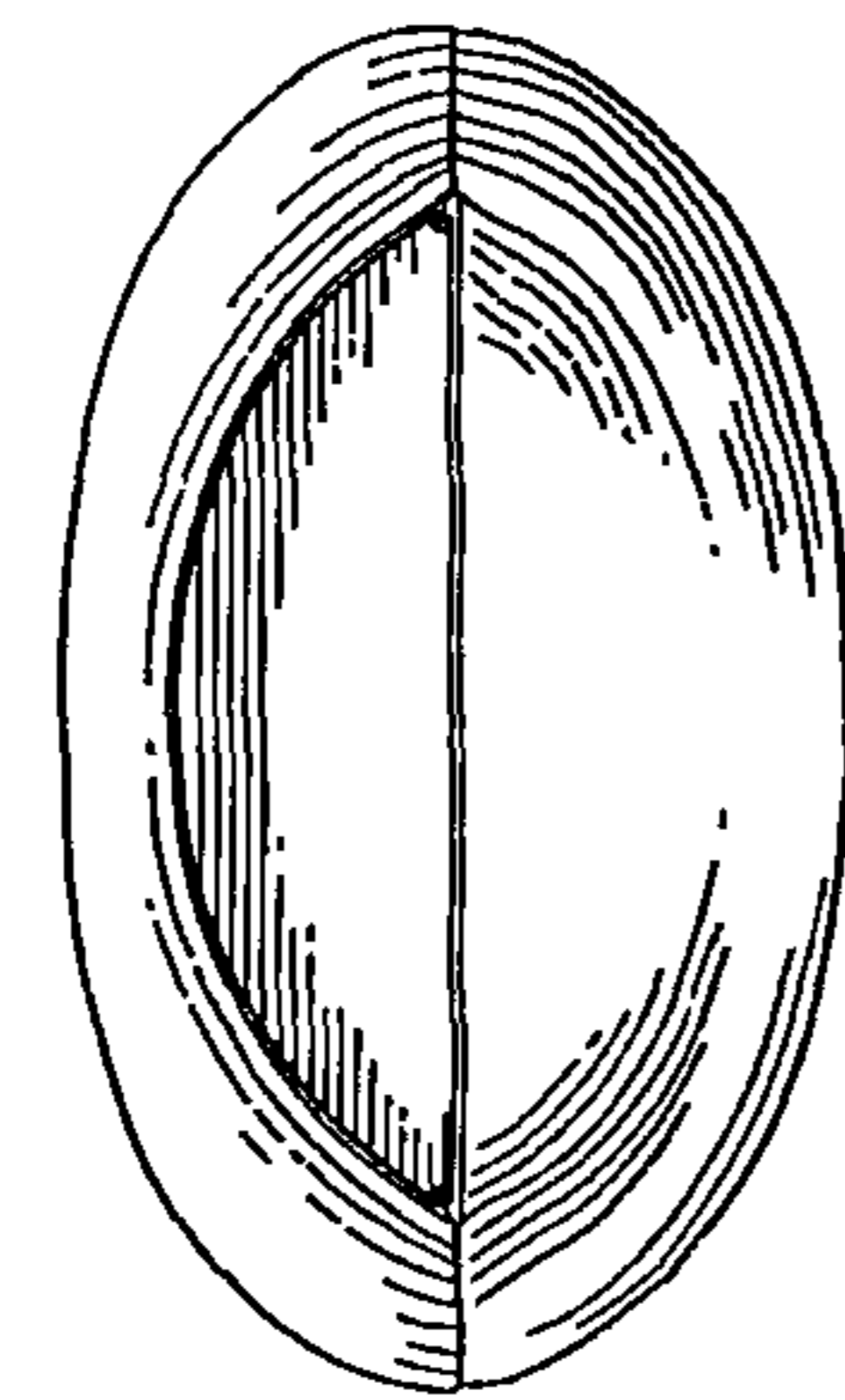

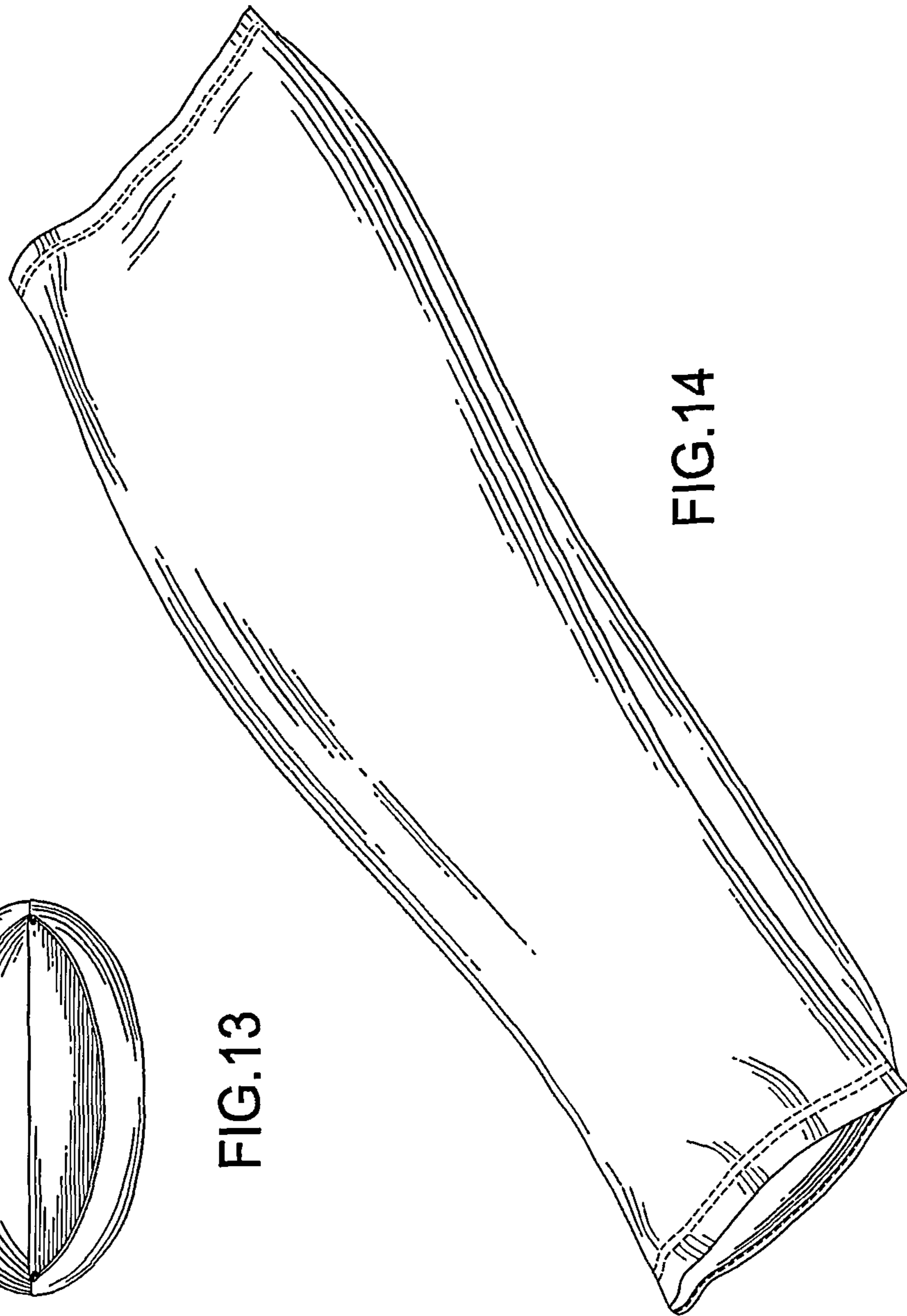

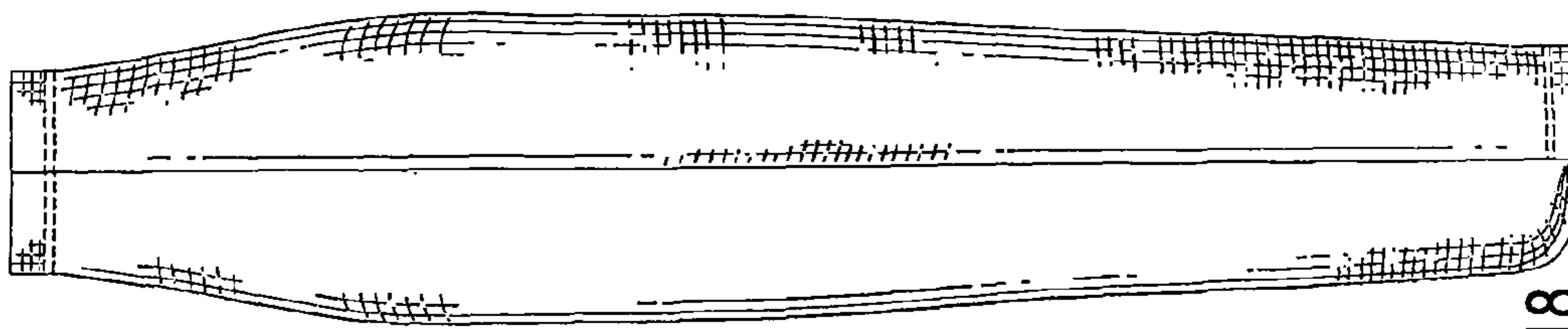

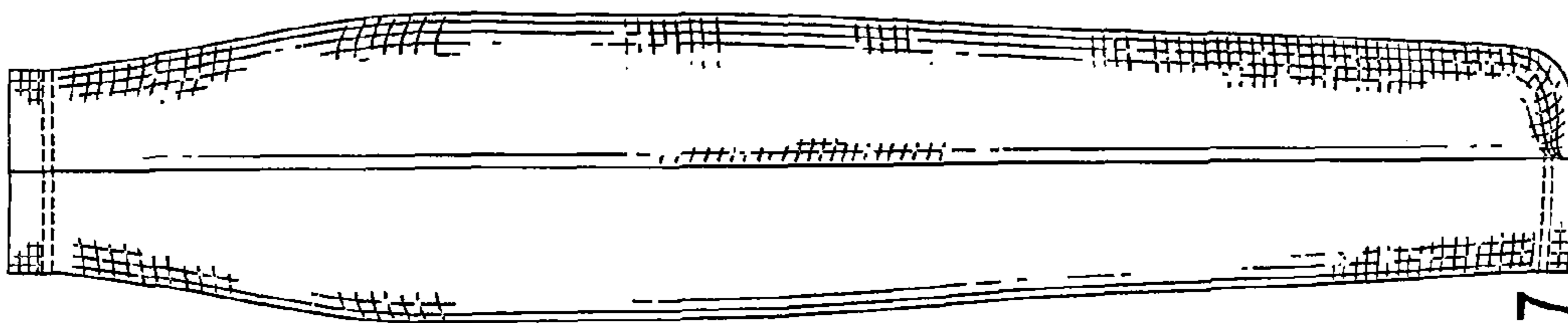

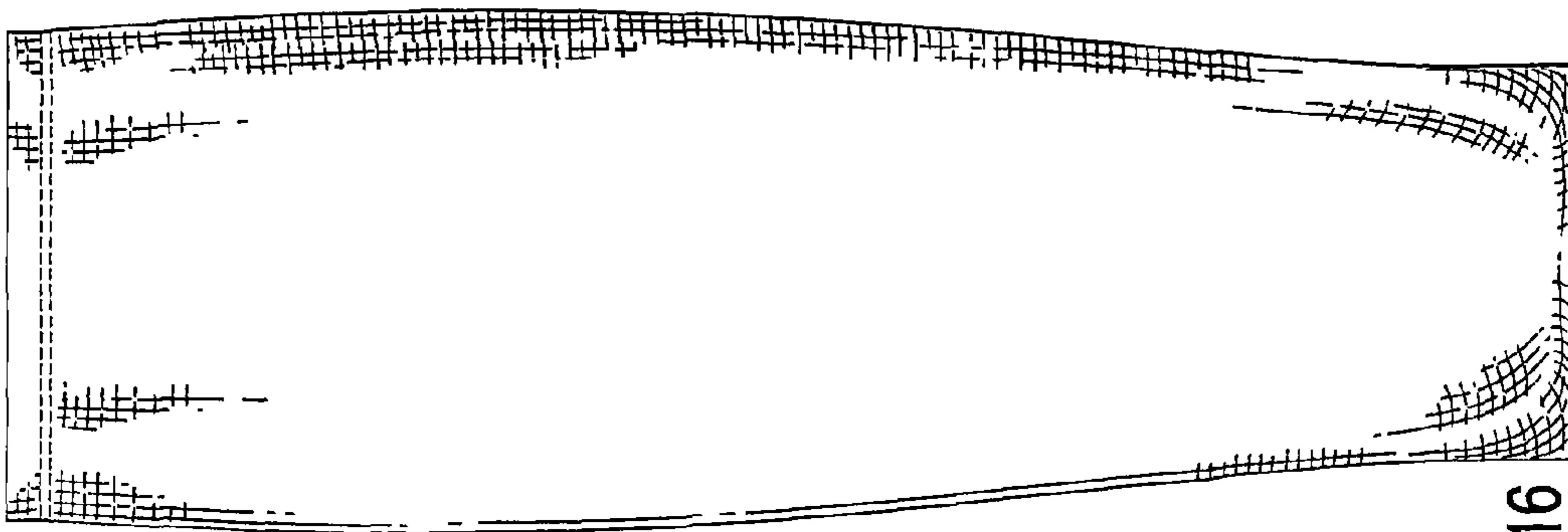

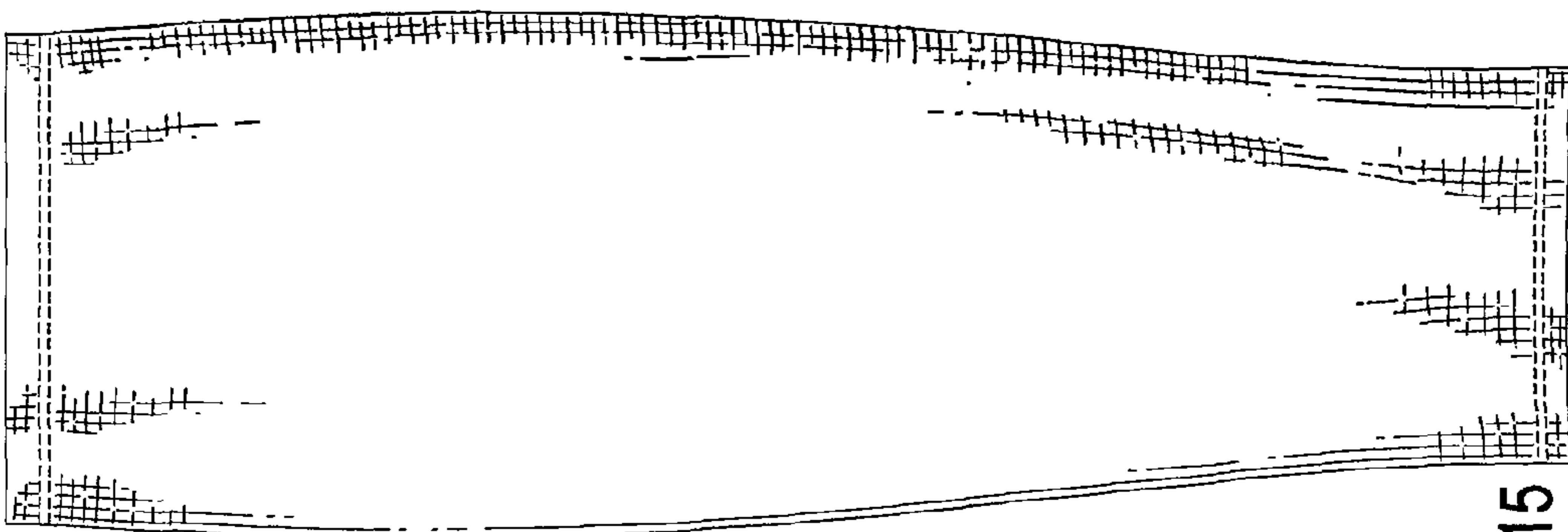

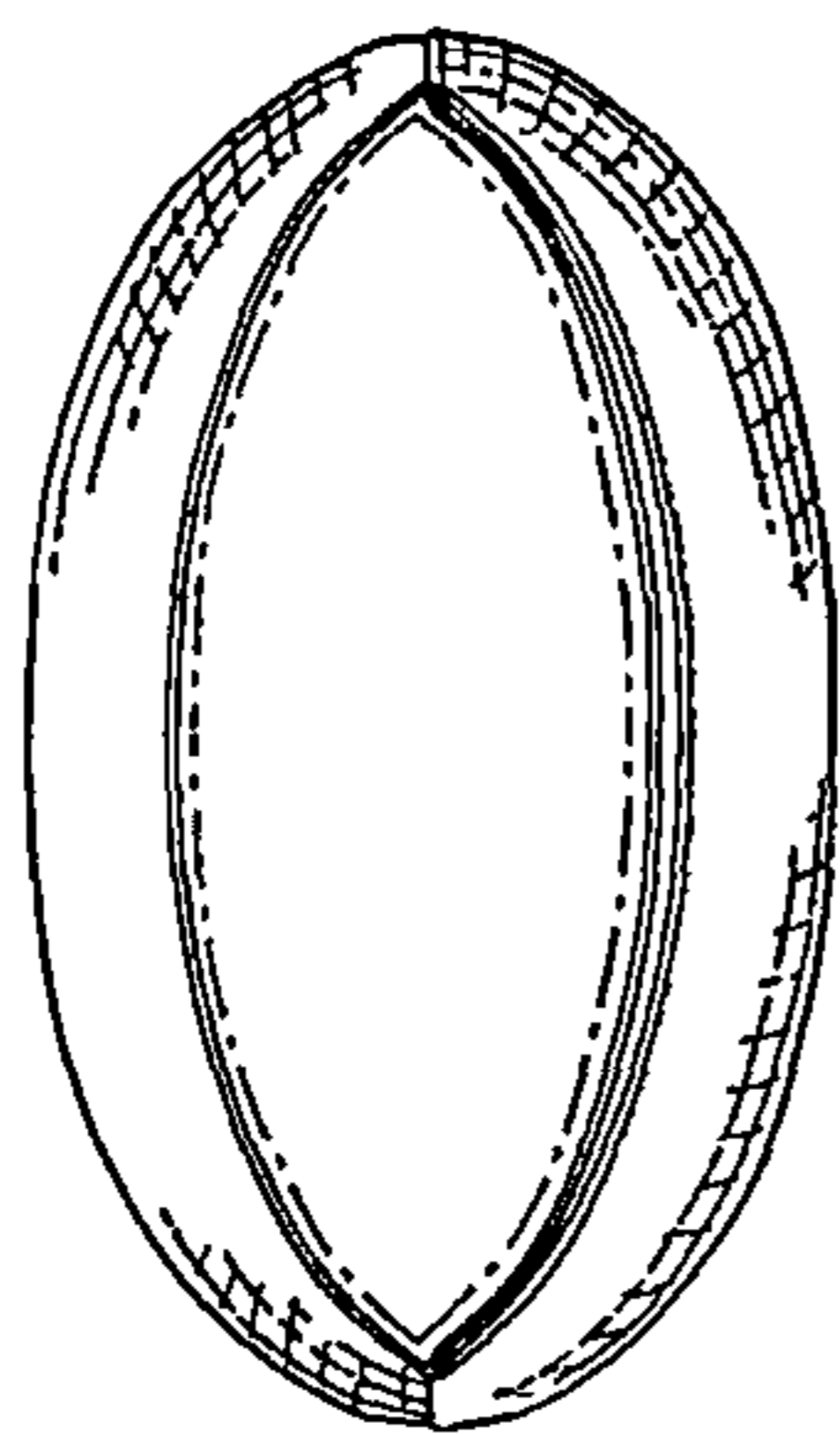

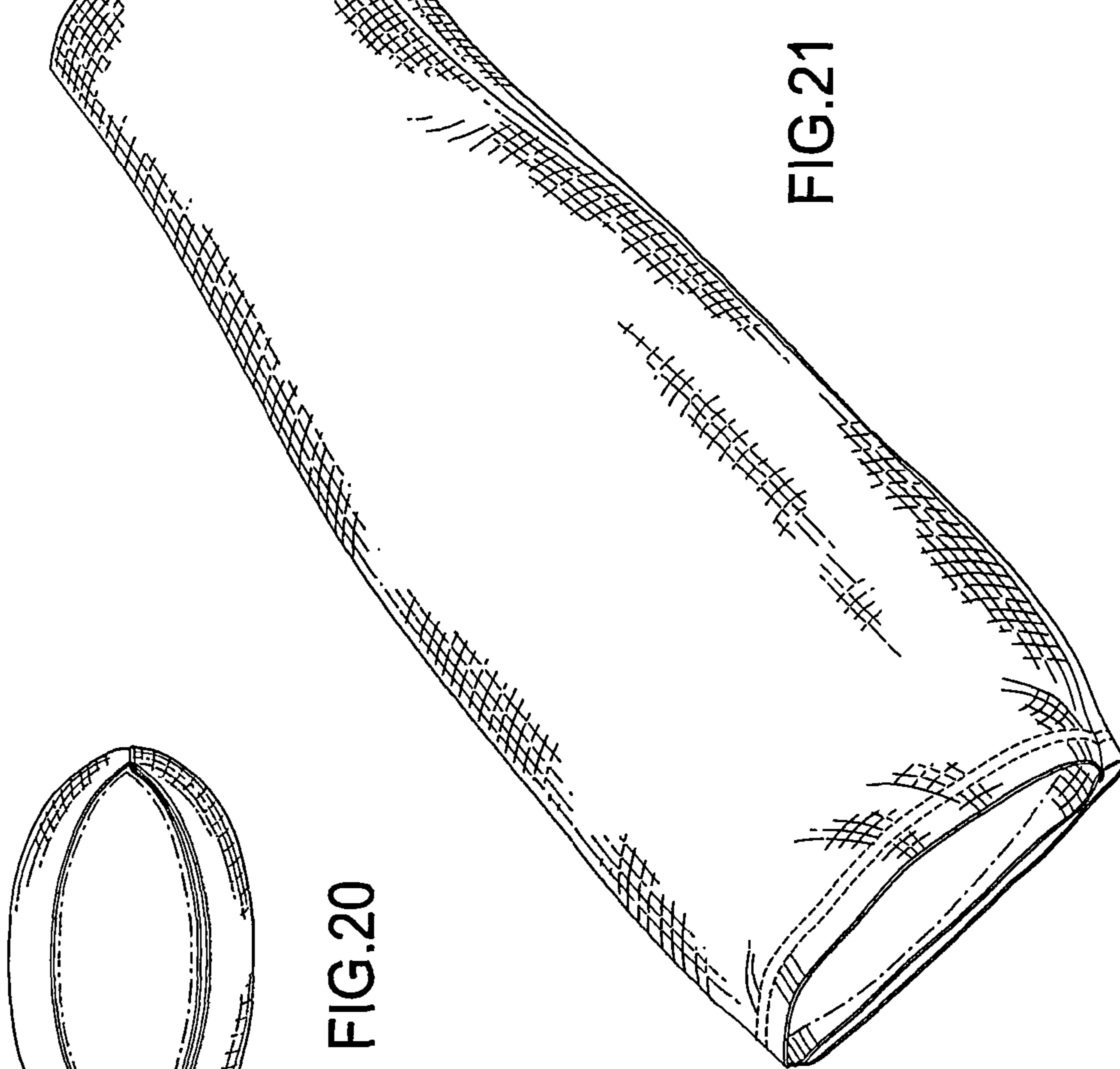

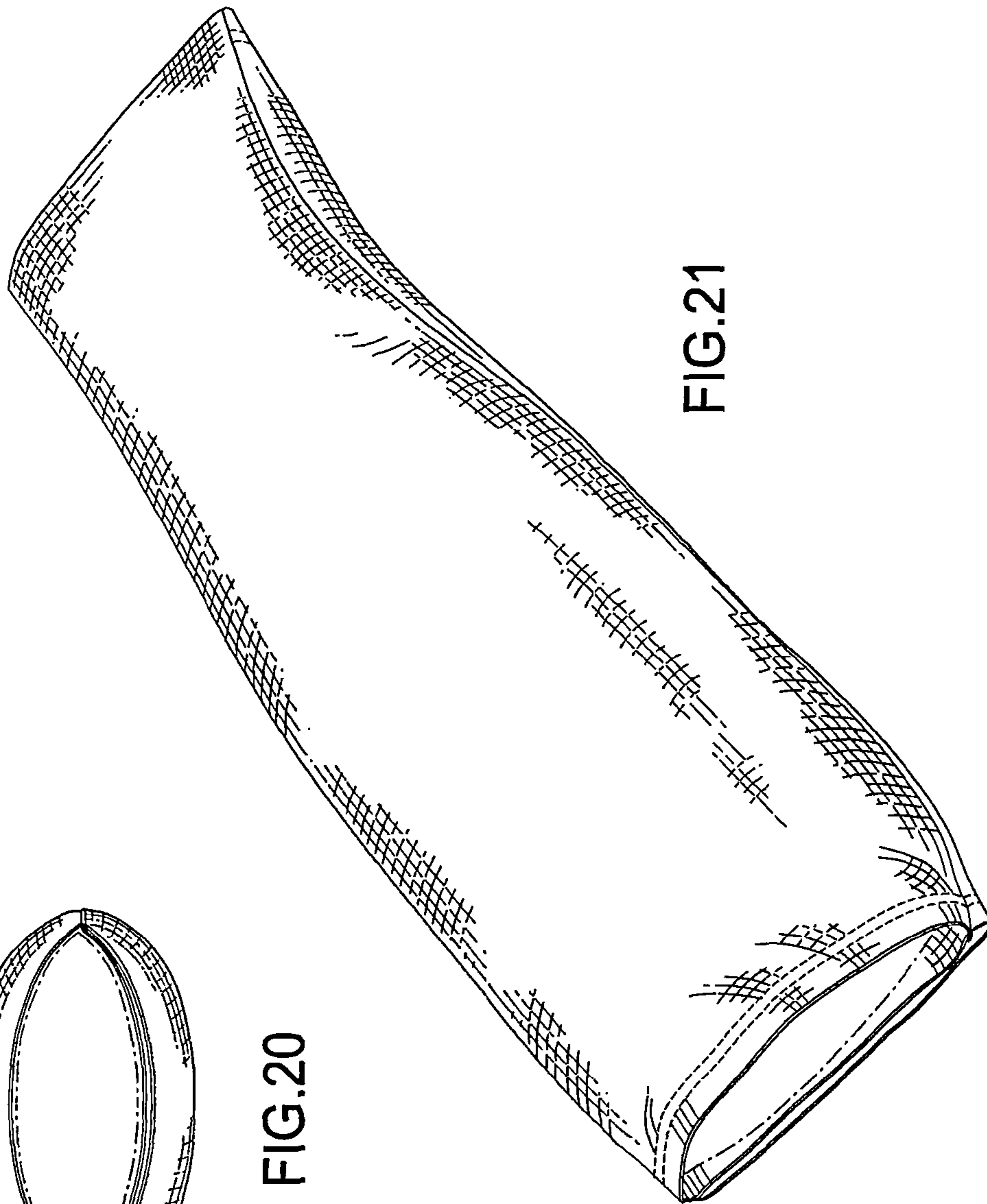
