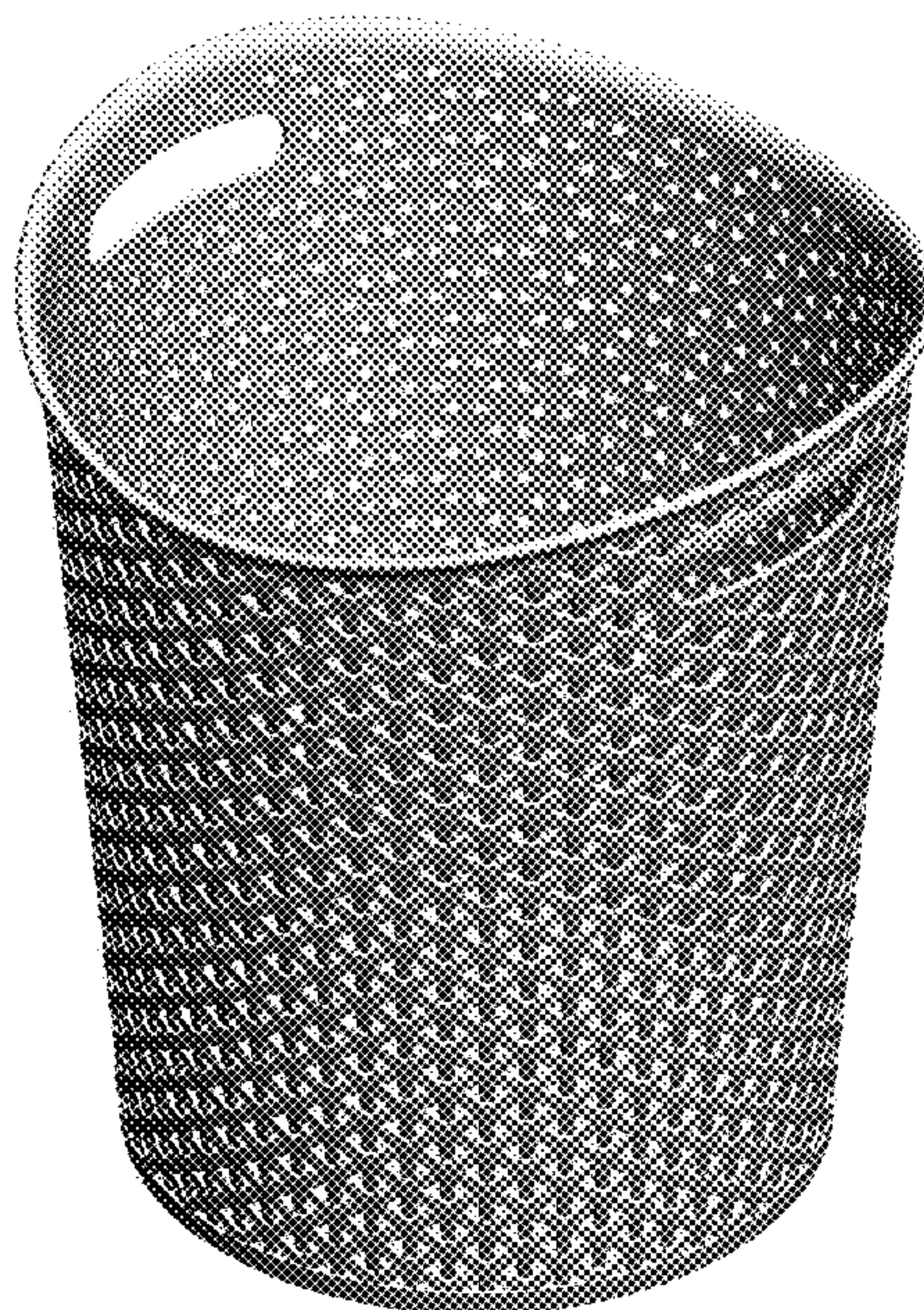

The ornamental design for a hamper, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a hamper;
FIG. 2 is a bottom perspective view thereof,
FIG. 3 is a front elevational view thereof, the rear view being identical thereof,
FIG. 4 is a left-side elevational view thereof, the right-side being a identical thereof,
FIG. 5 is a top planar view thereof,
FIG. 6 is a top perspective view of a second embodiment of a hamper.
FIG. 7 is a bottom perspective view thereof,
FIG. 8 is a front elevational view thereof, the rear view being identical thereof,
FIG. 9 is a left-side elevational view thereof, the right-side being a identical thereof; and,
FIG. 10 is a top planar view thereof.

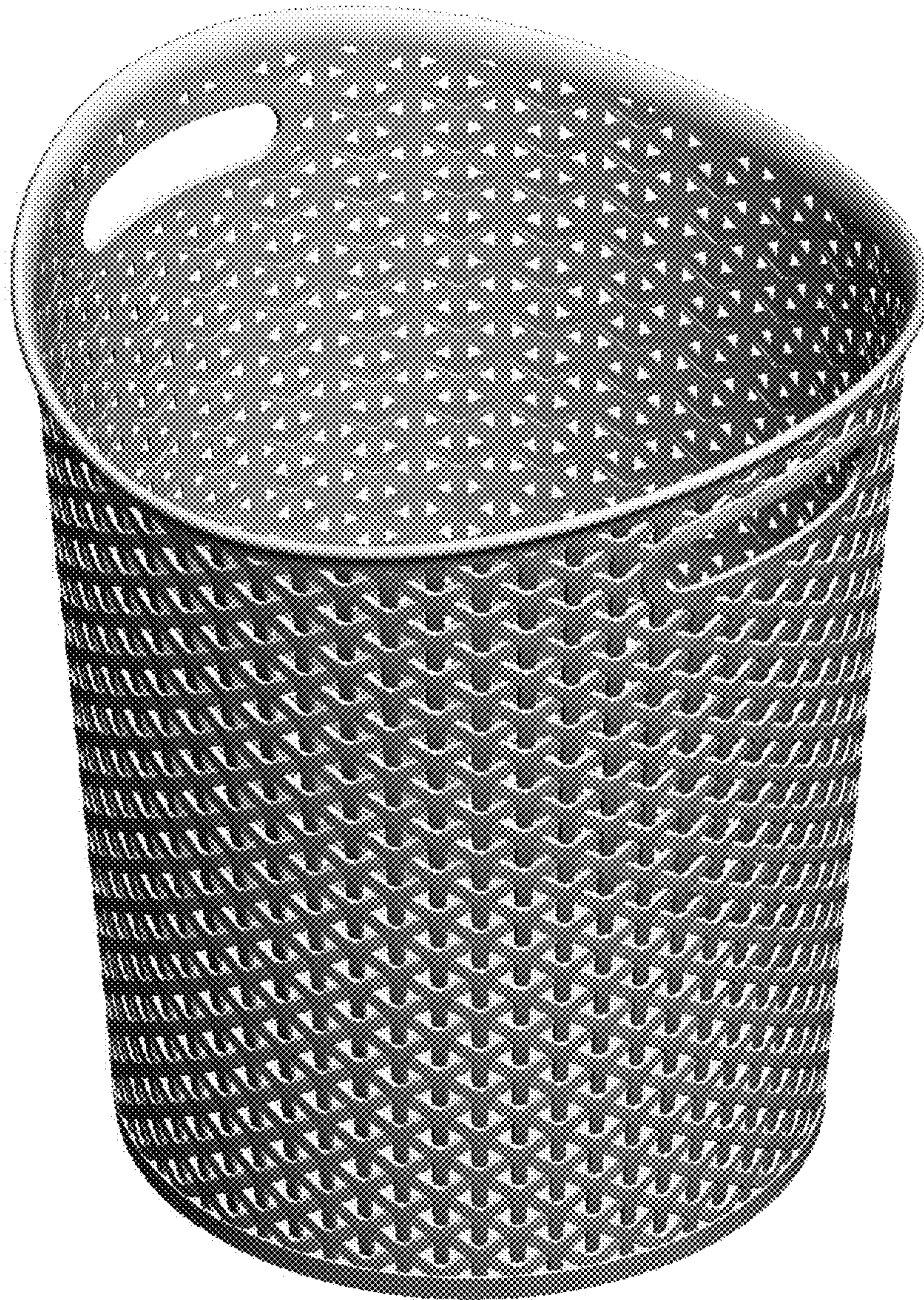

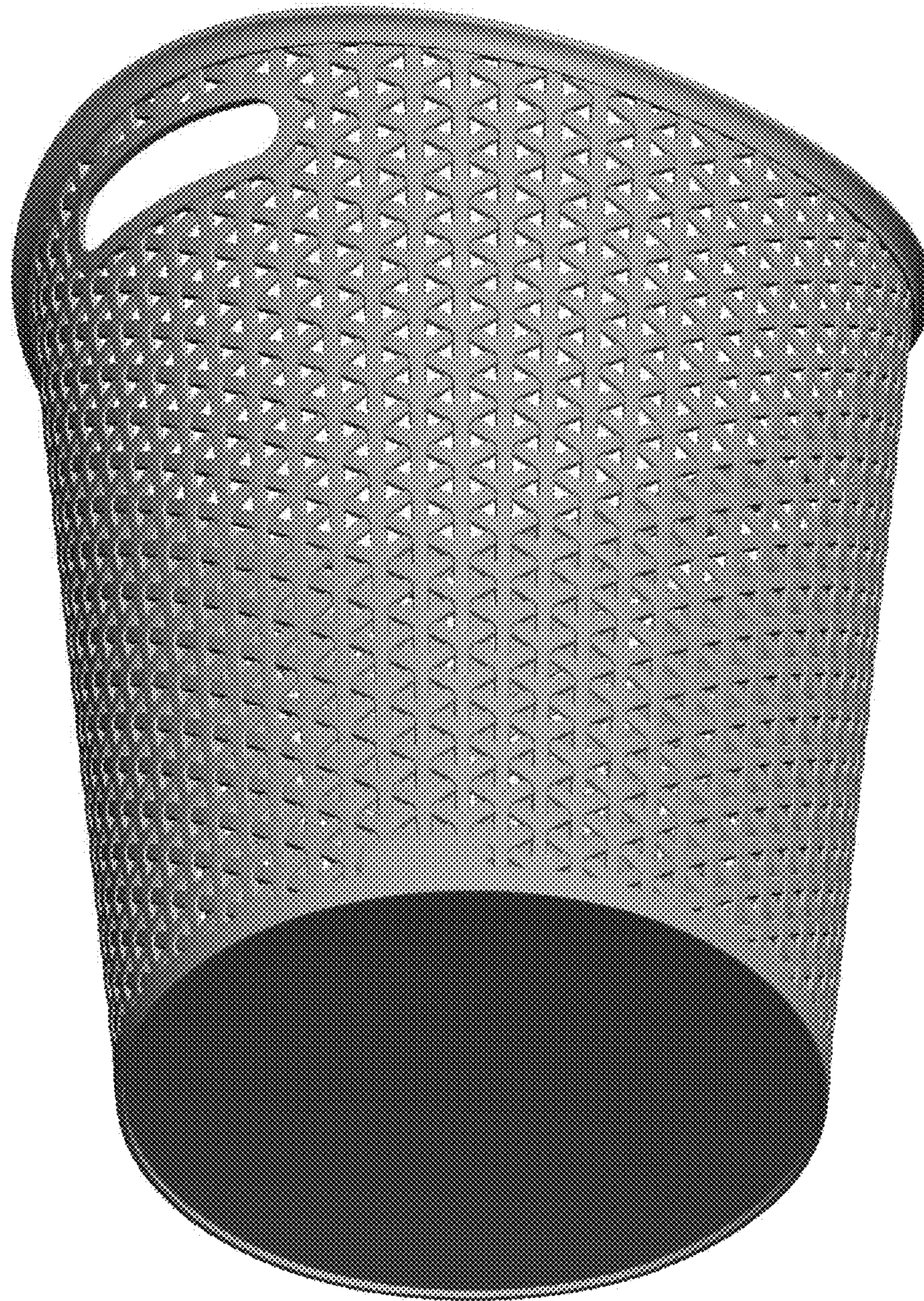

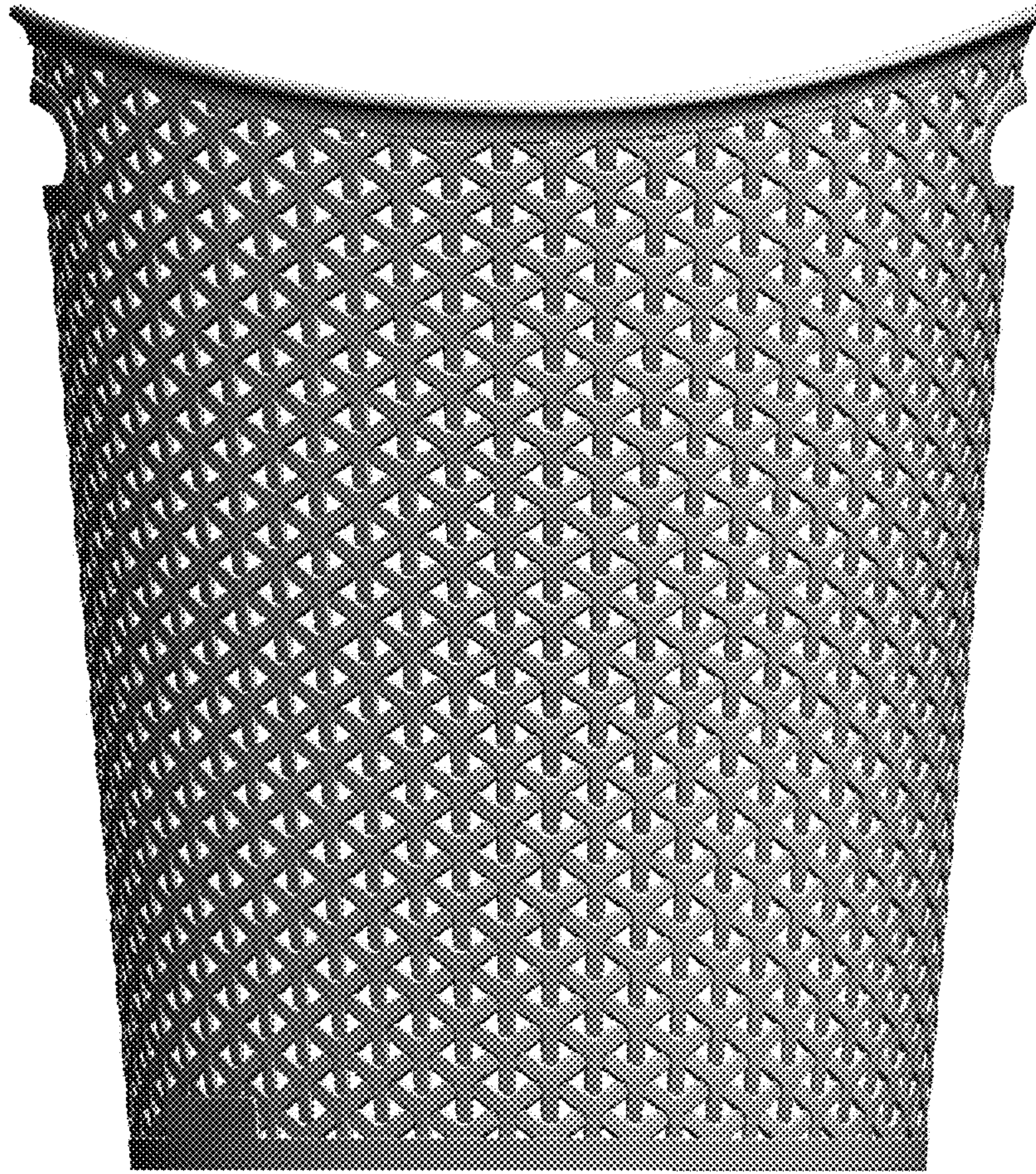

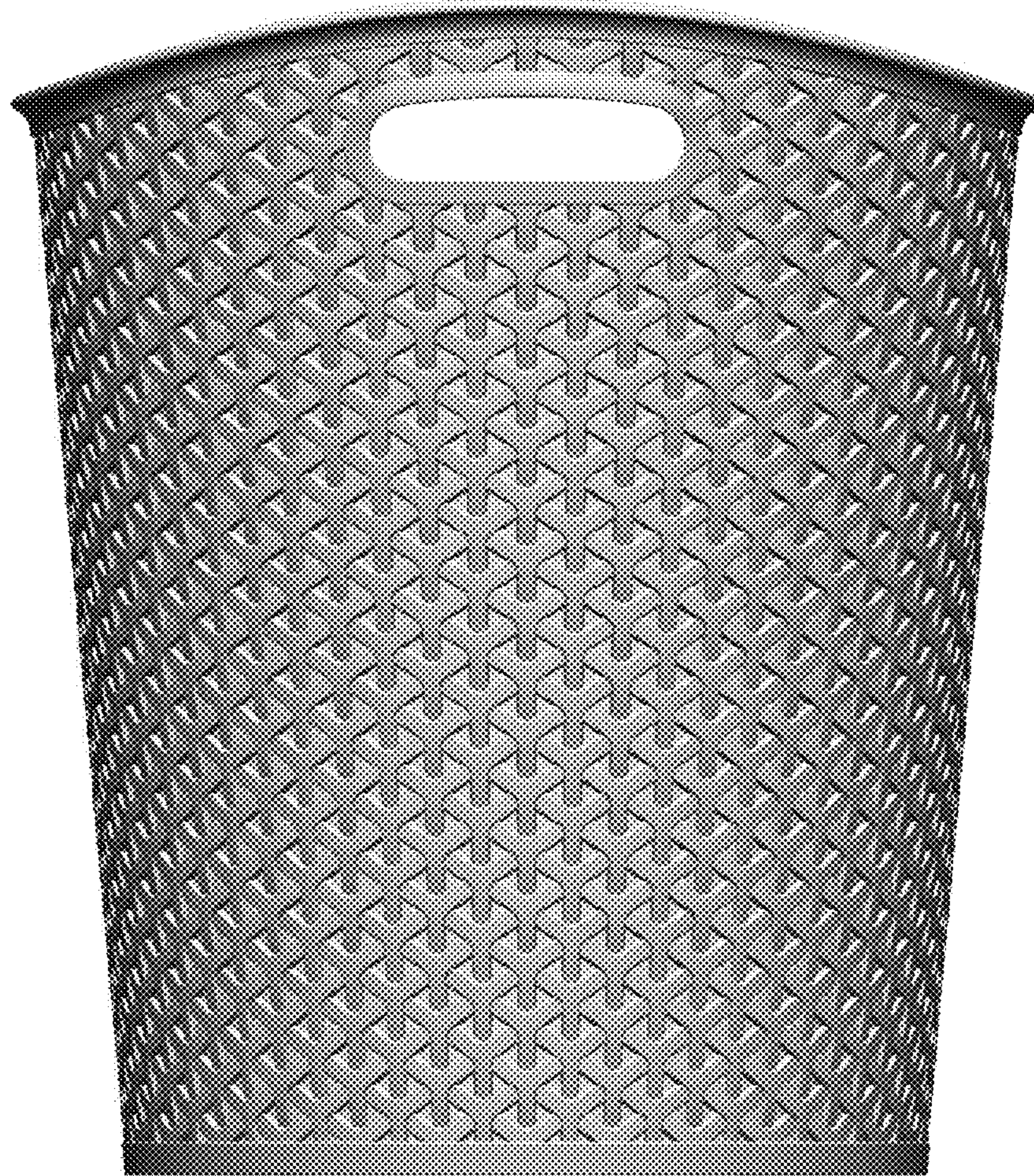

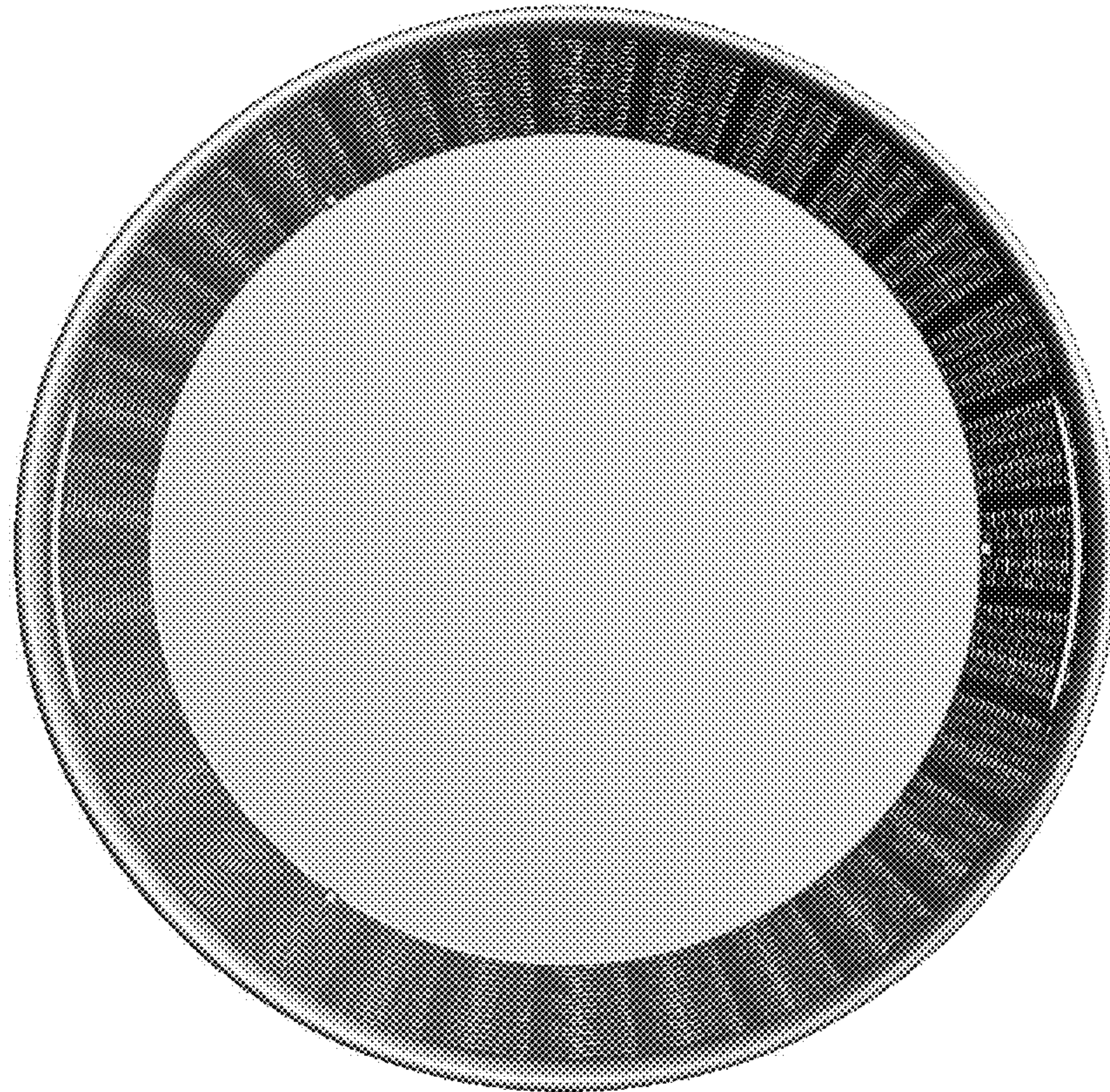

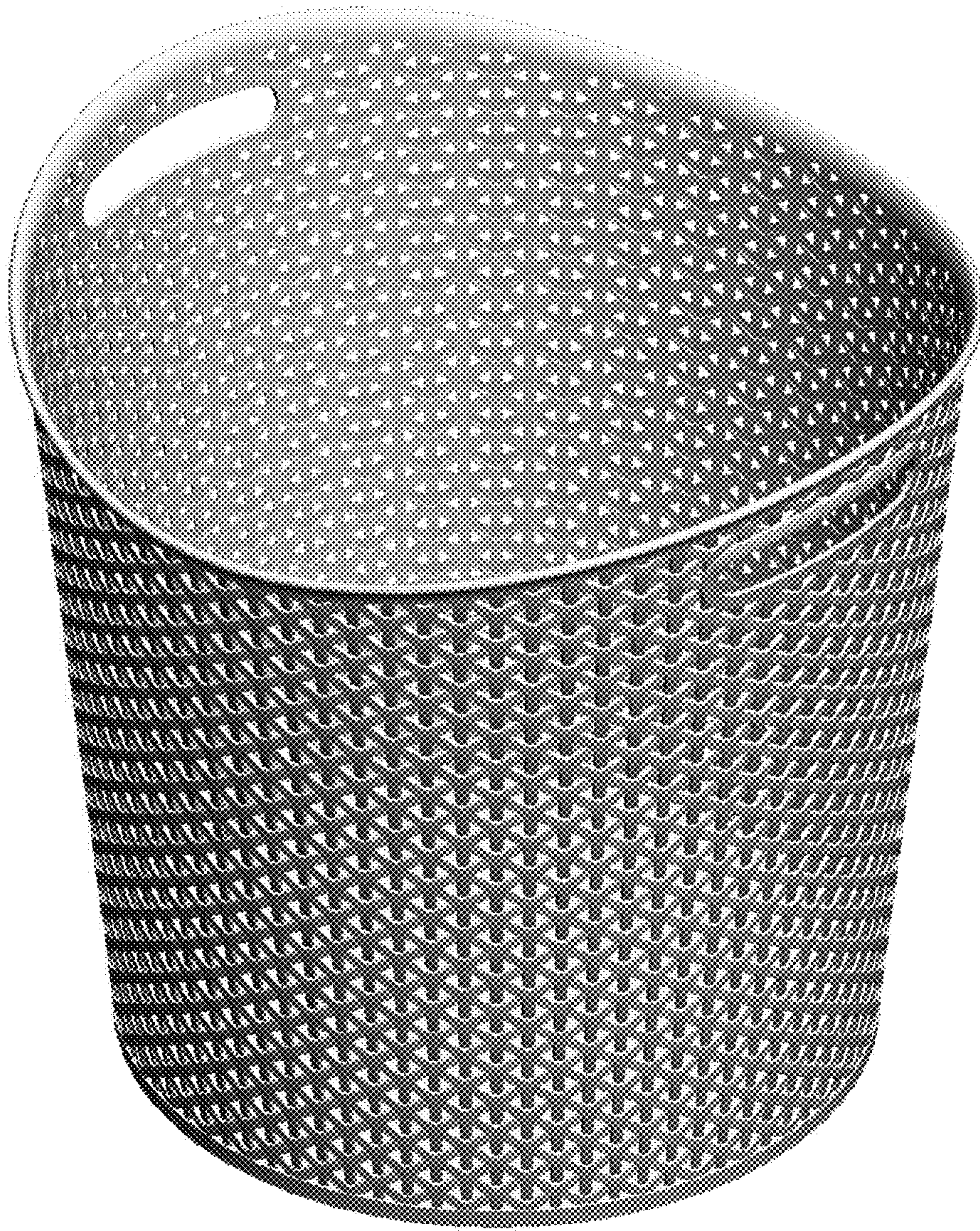

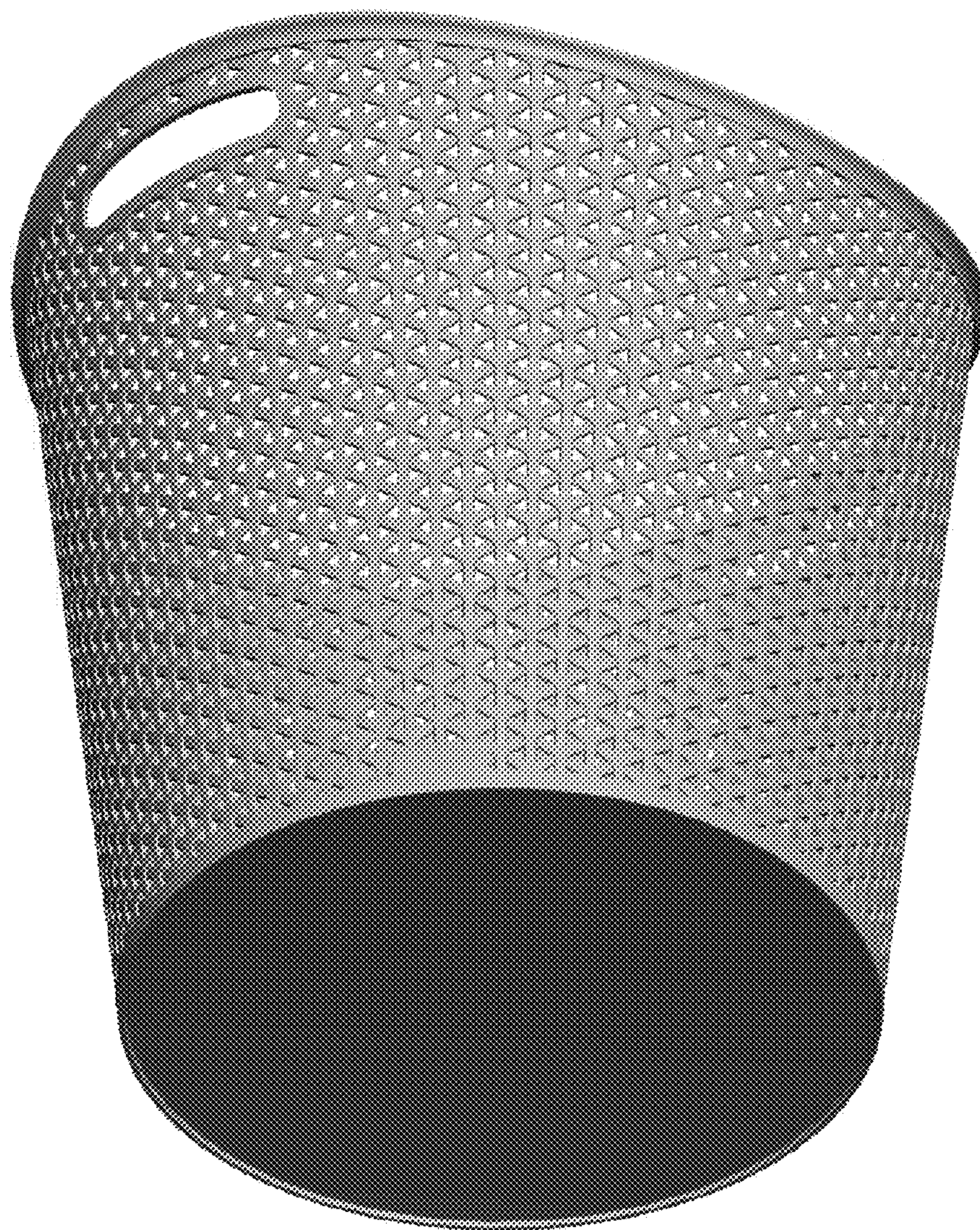

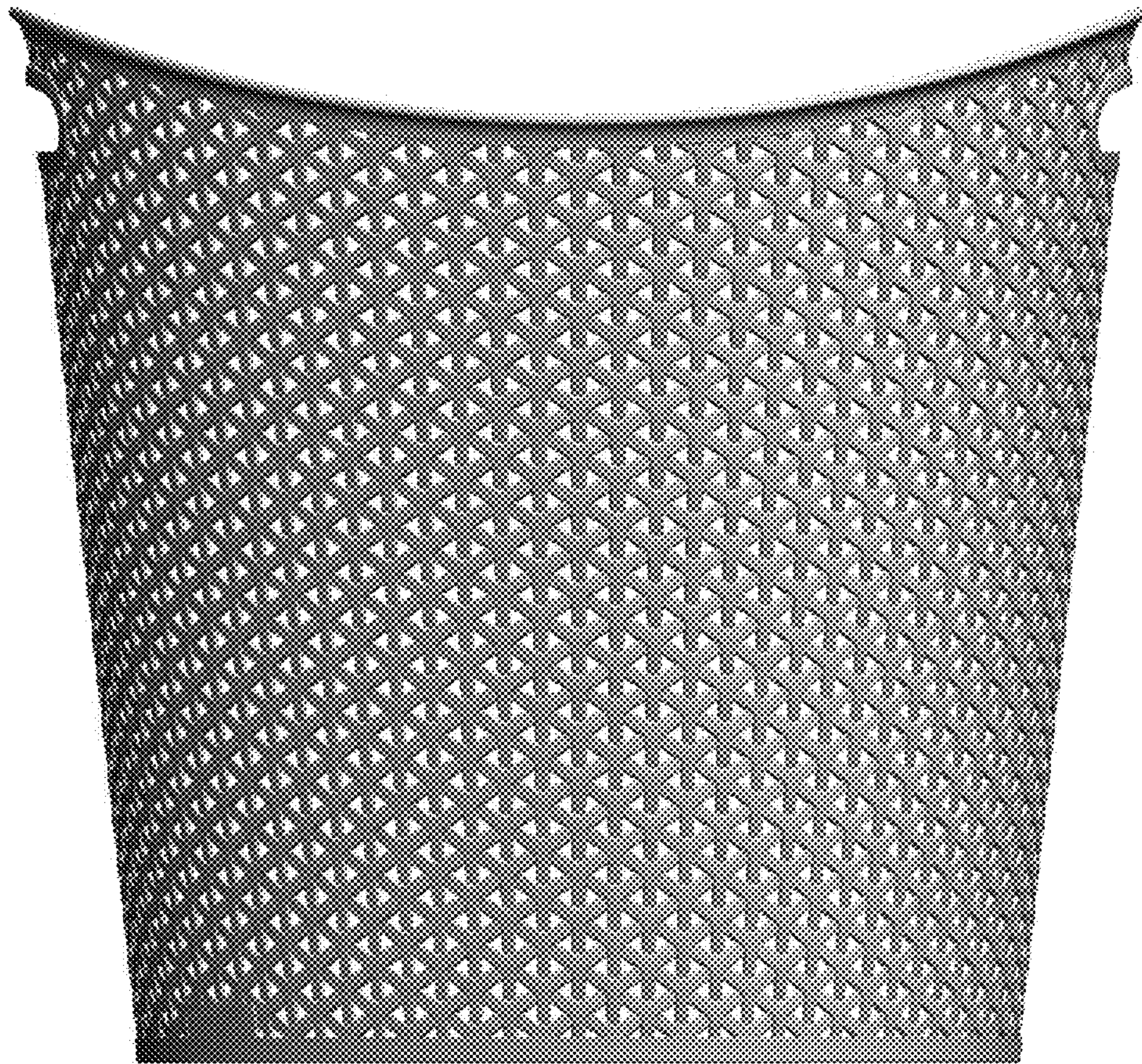

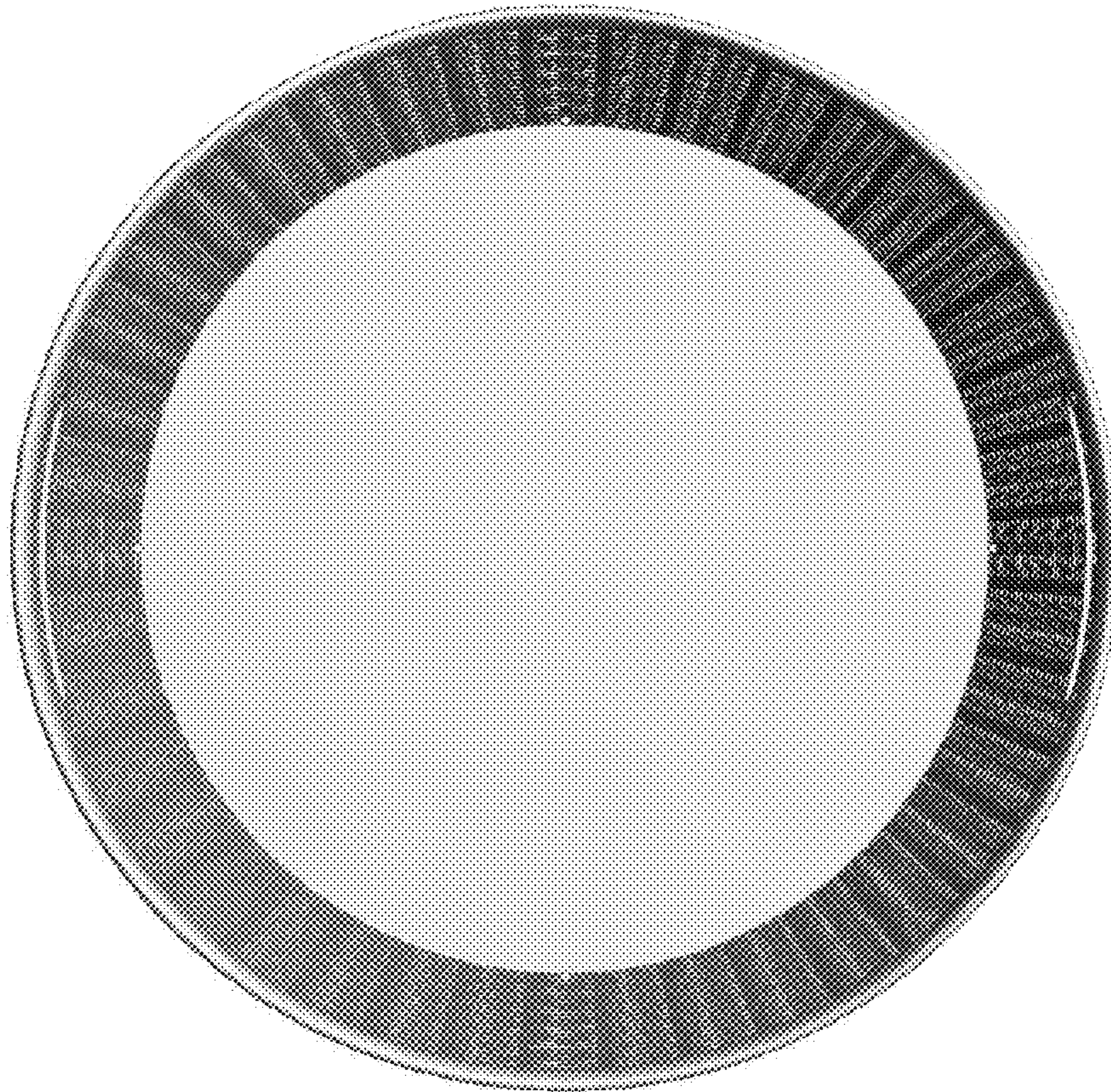
