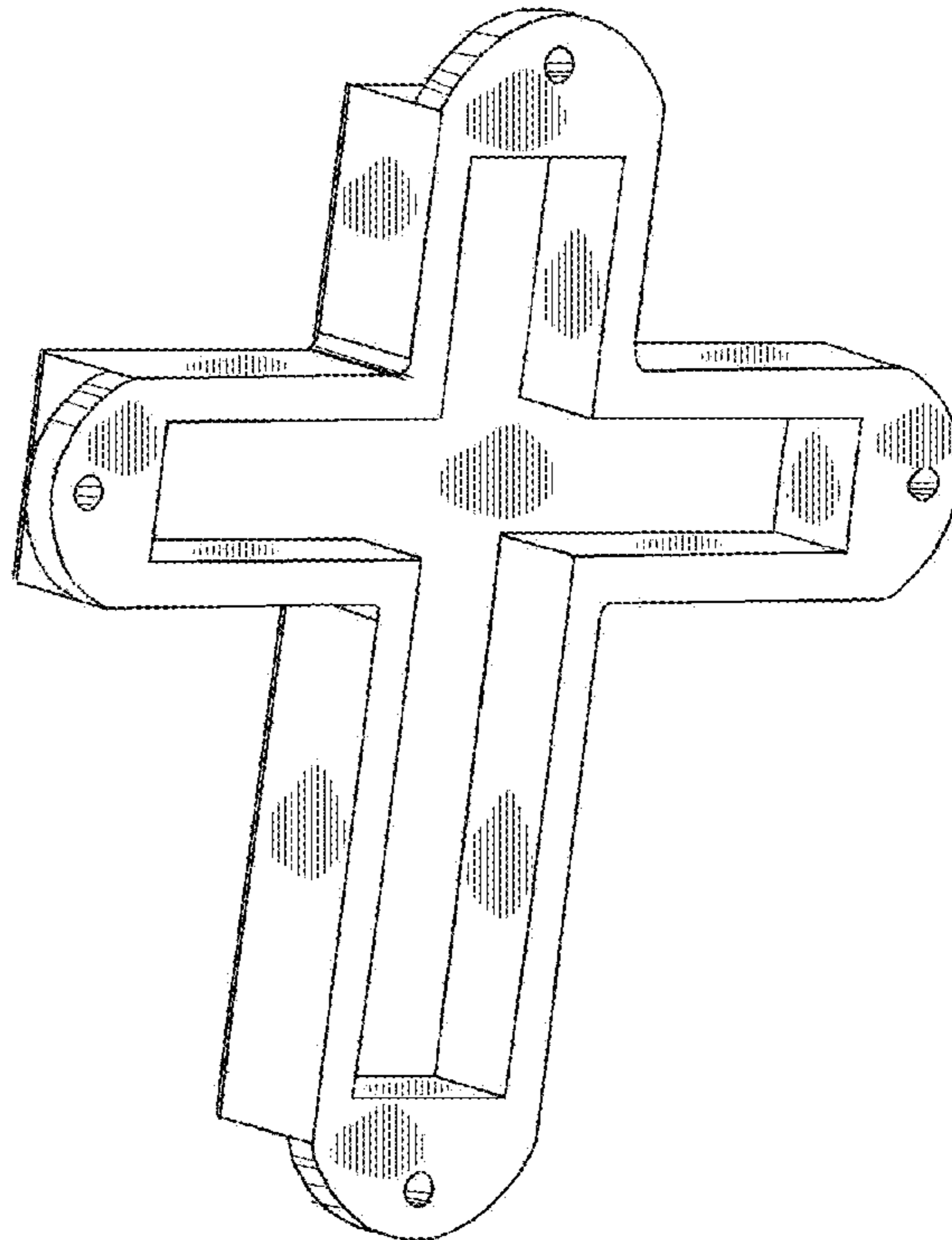
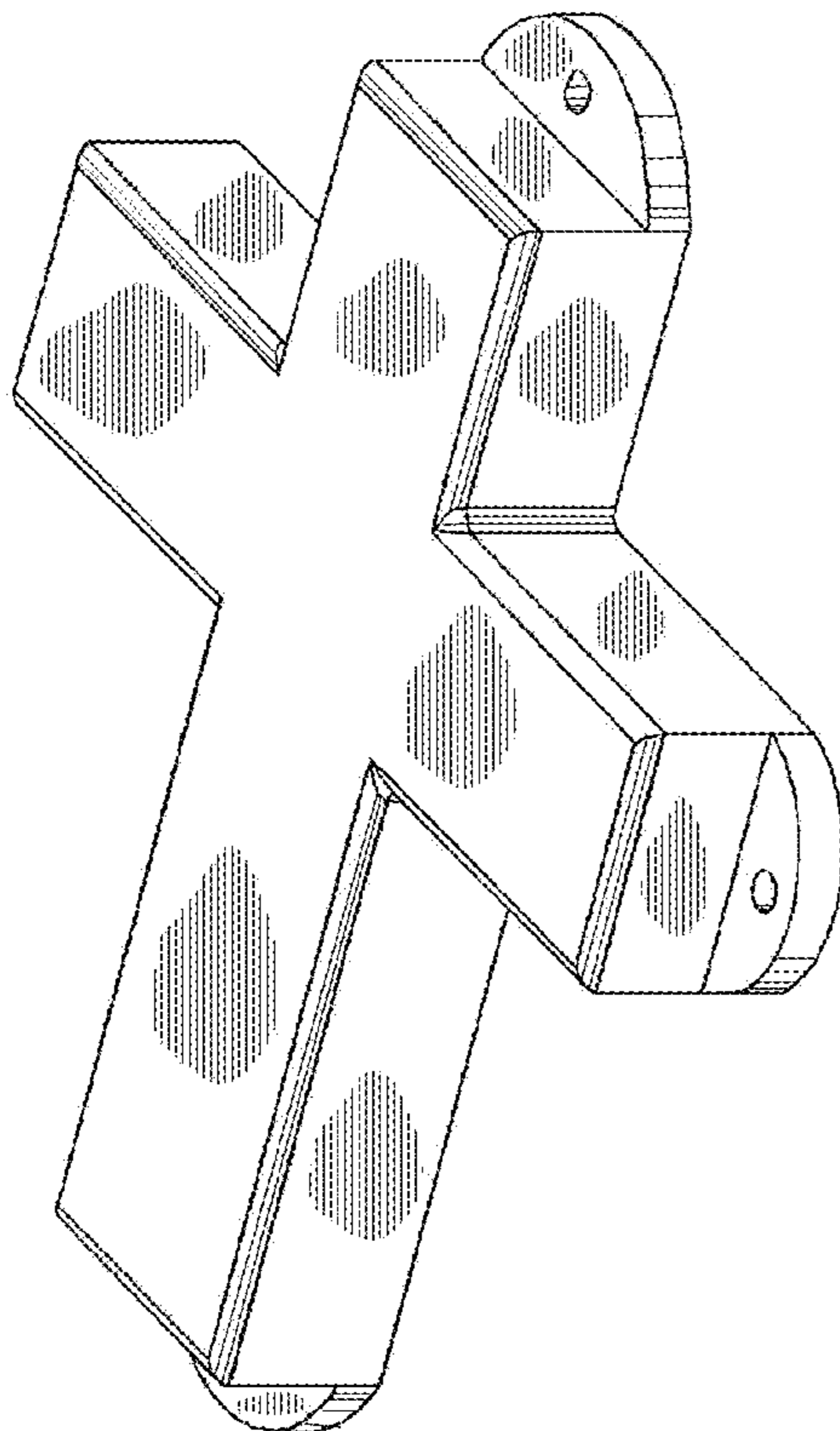

(57) **CLAIM**
The ornamental design for a container for printed Christian prayers, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container for printed Christian prayers showing my new design;

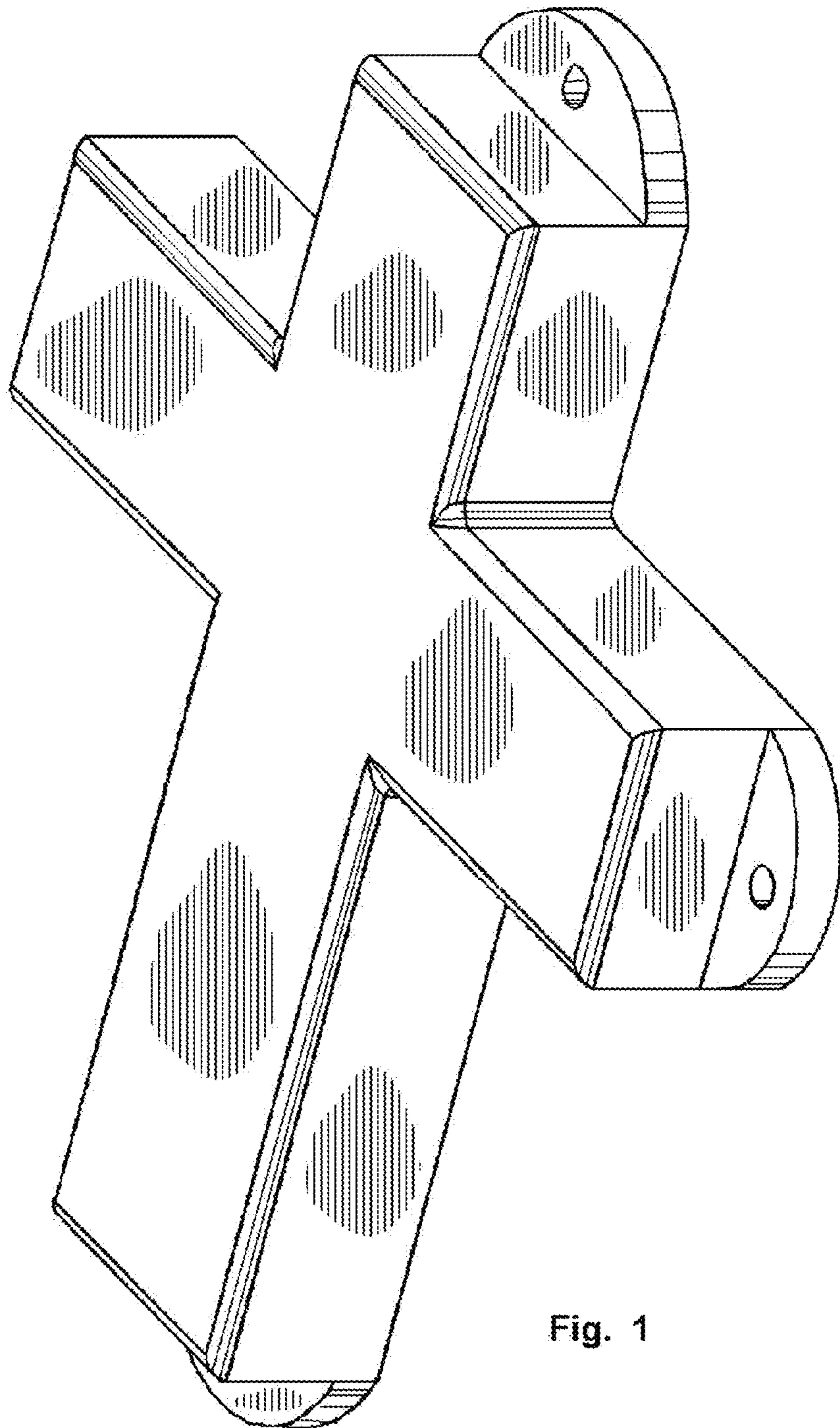

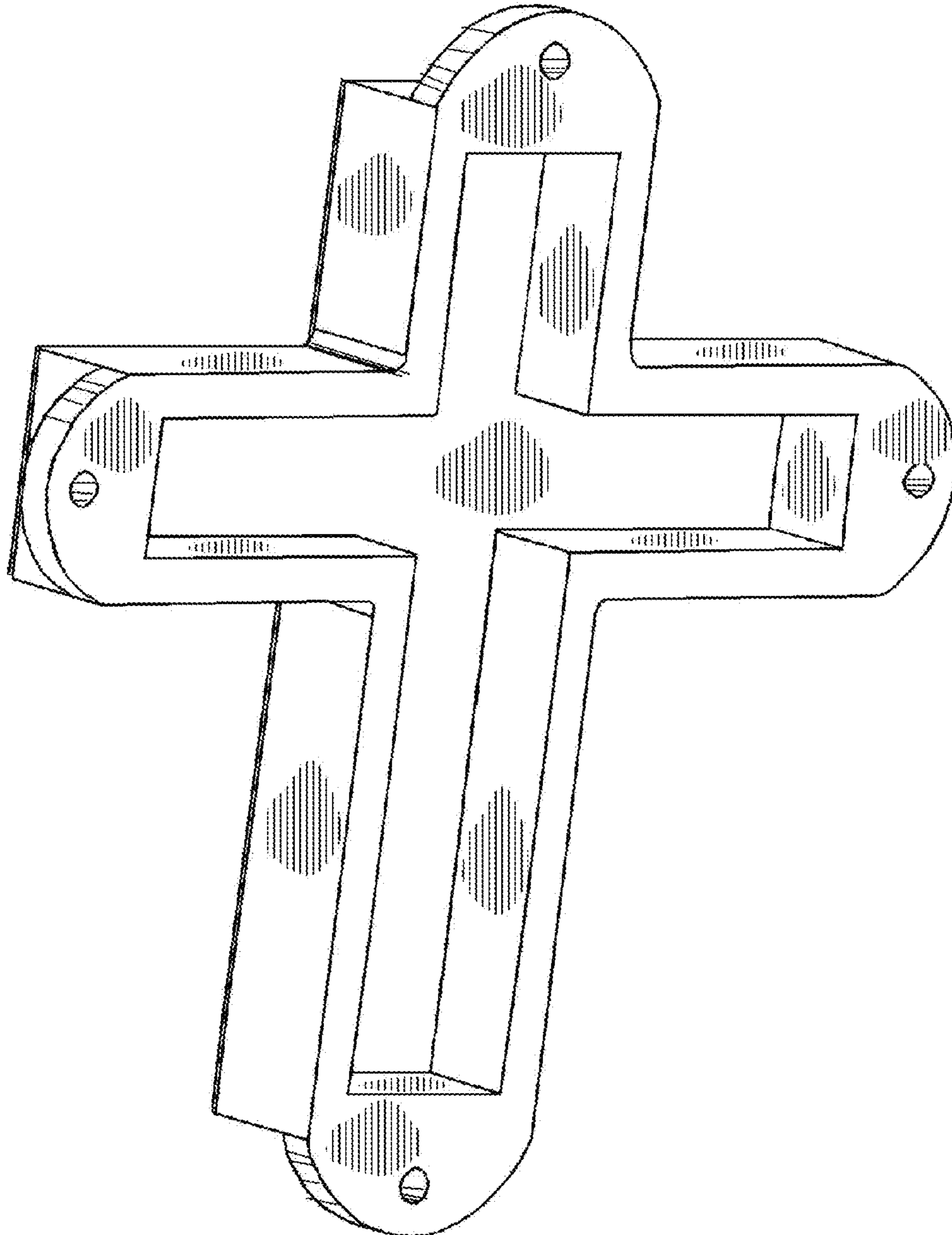

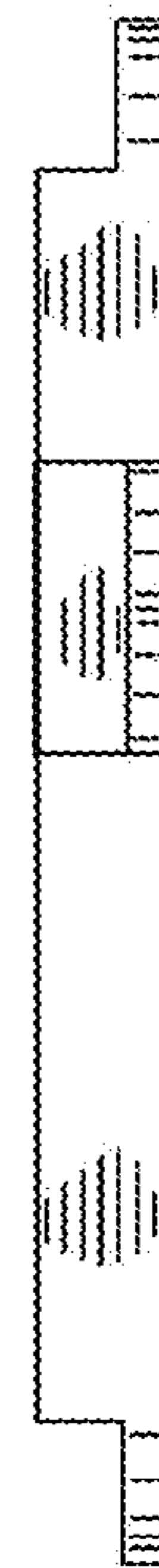
