(57) **CLAIM**

The ornamental design for an edible pet treat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, right, and top sides of our new design for an edible pet treat.

FIG. 2 is a front view of our new design for an edible pet treat, the rear view being a mirror image thereof.

FIG. 3 is a right view of our new design for an edible pet treat.

FIG. 4 is a left view of our new design for an edible pet treat.

FIG. 5 is a top view of our new design for an edible pet treat.

FIG. 6 is a bottom view of our new design for an edible pet treat; and,

FIG. 7 is a perspective view showing the front, left and top sides of our new design for an edible pet treat.

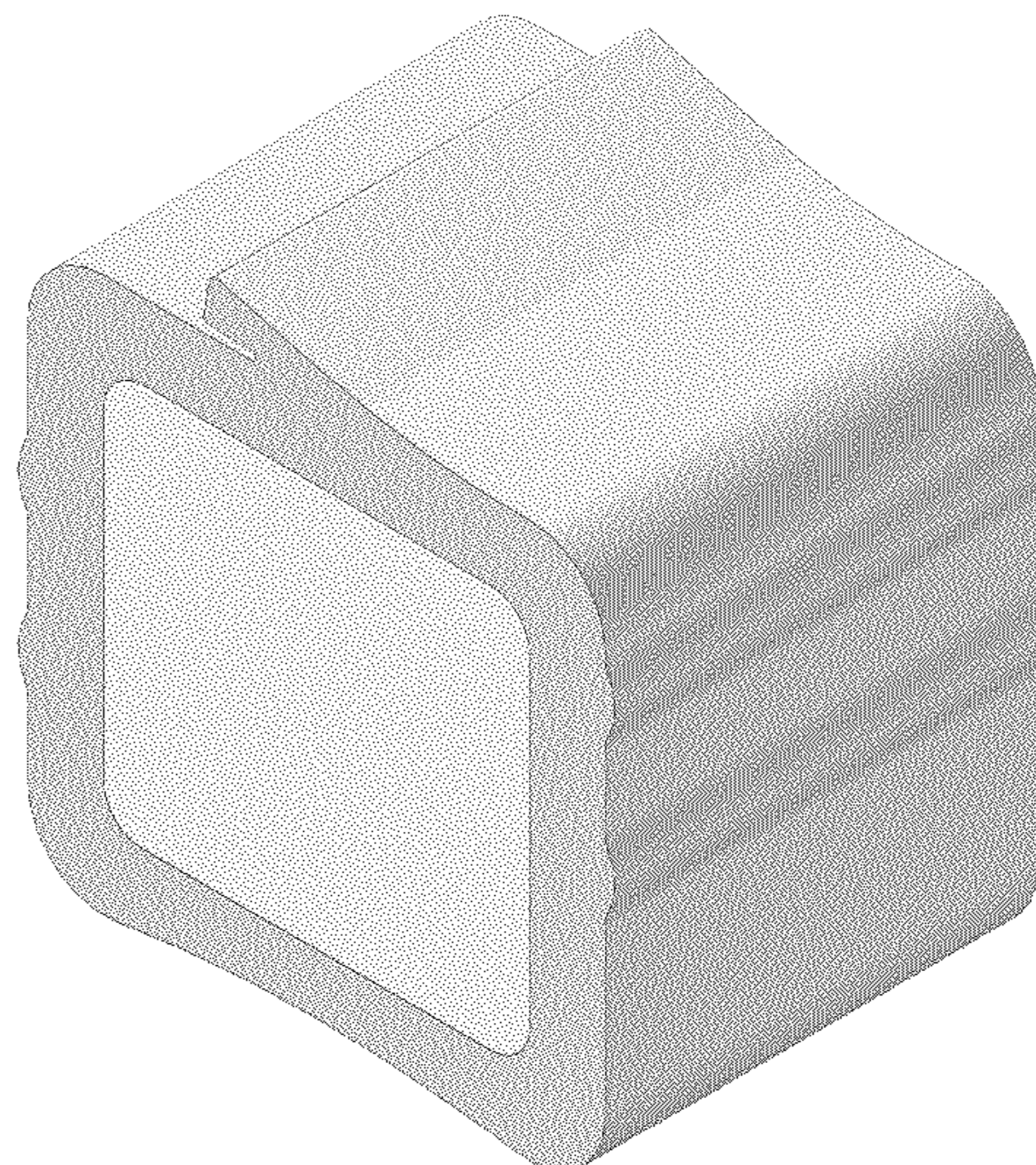

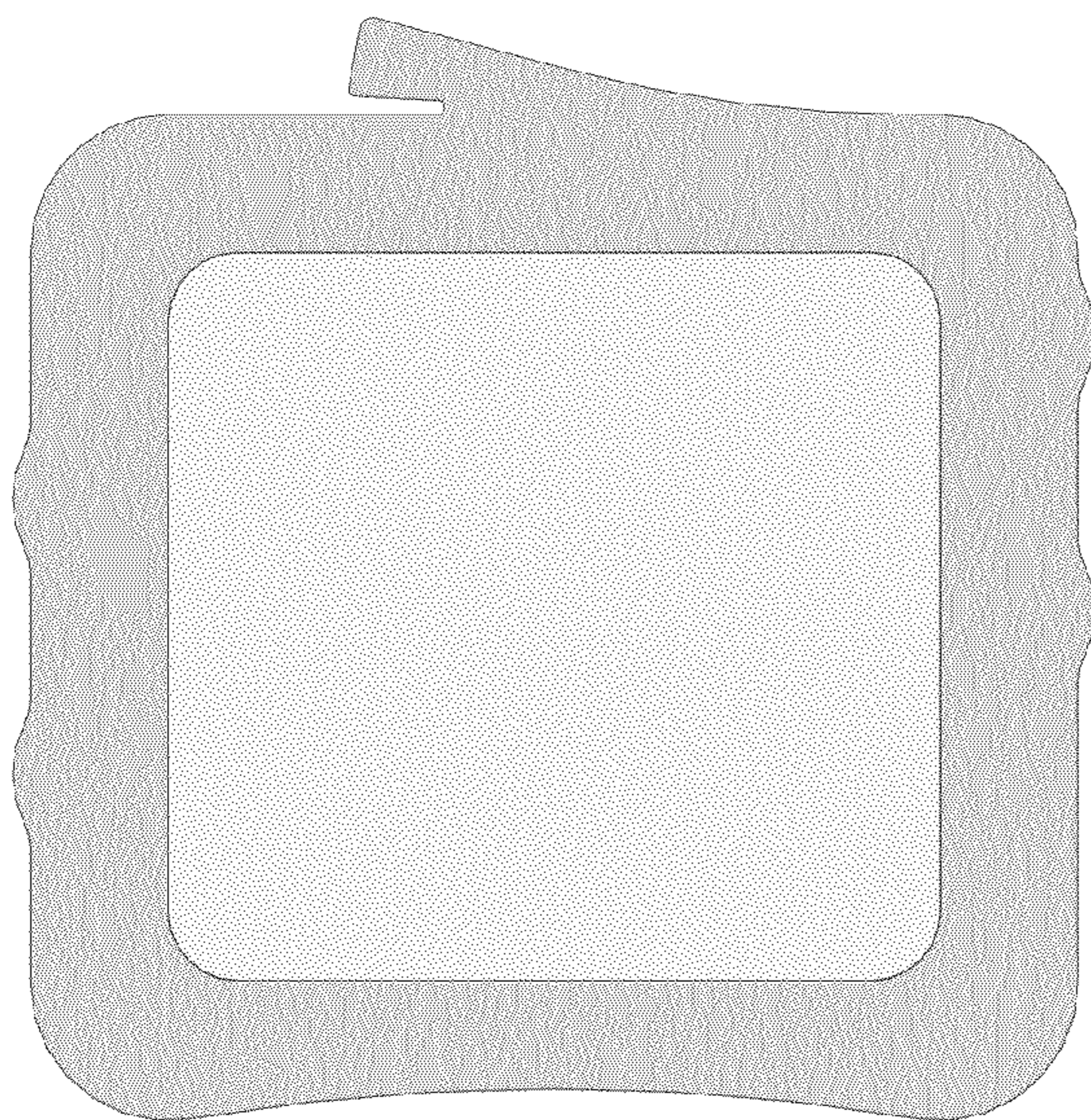
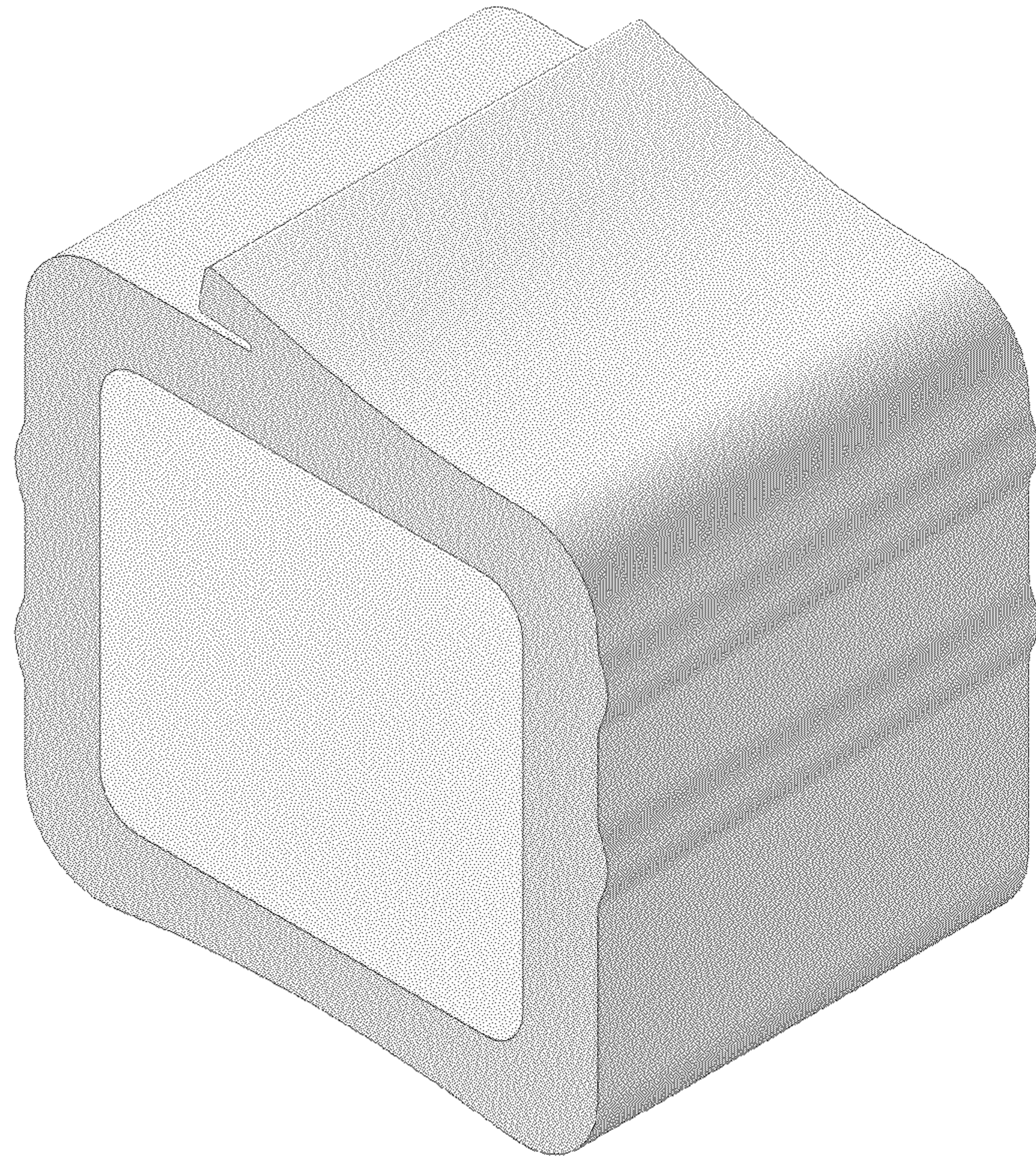

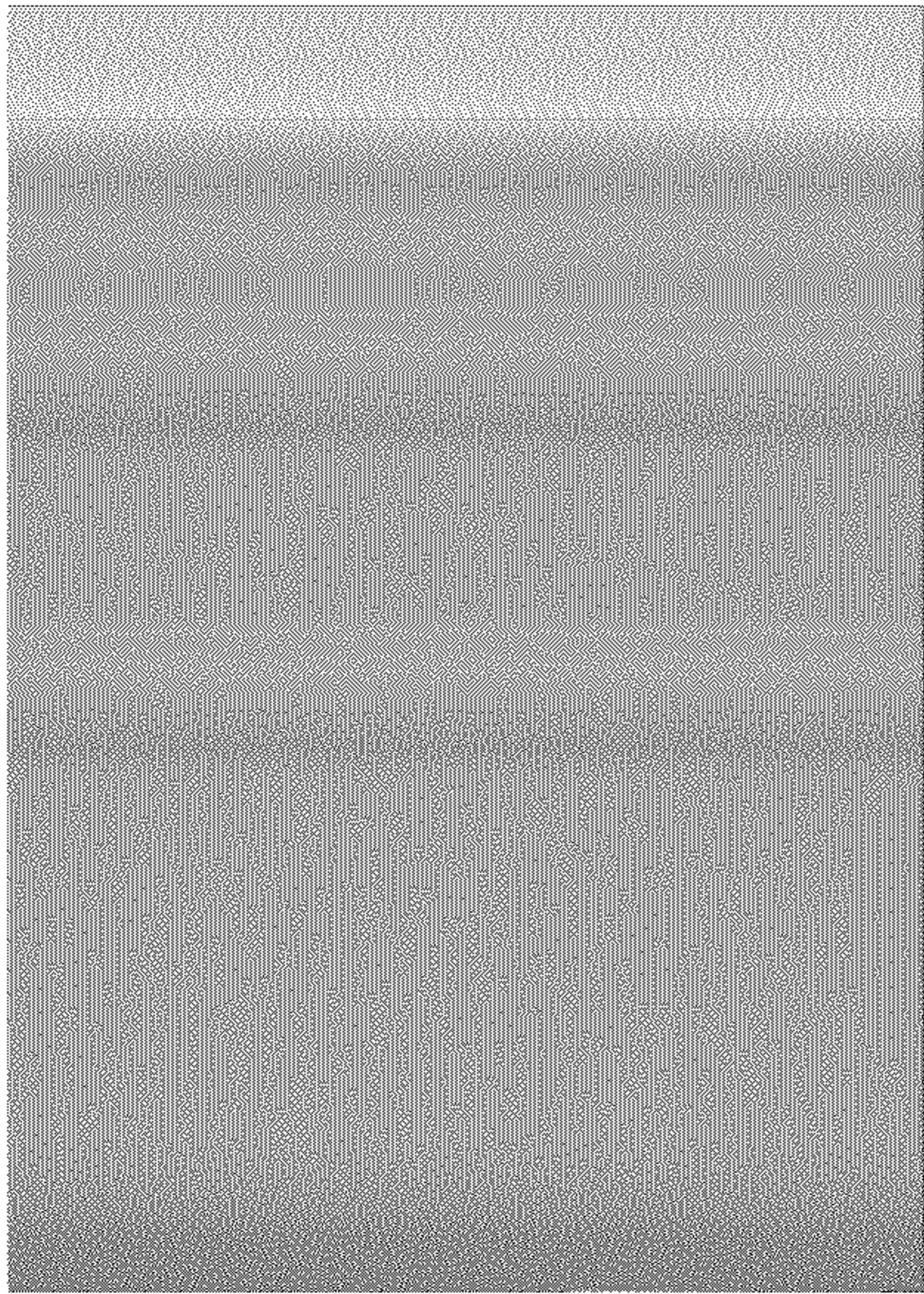

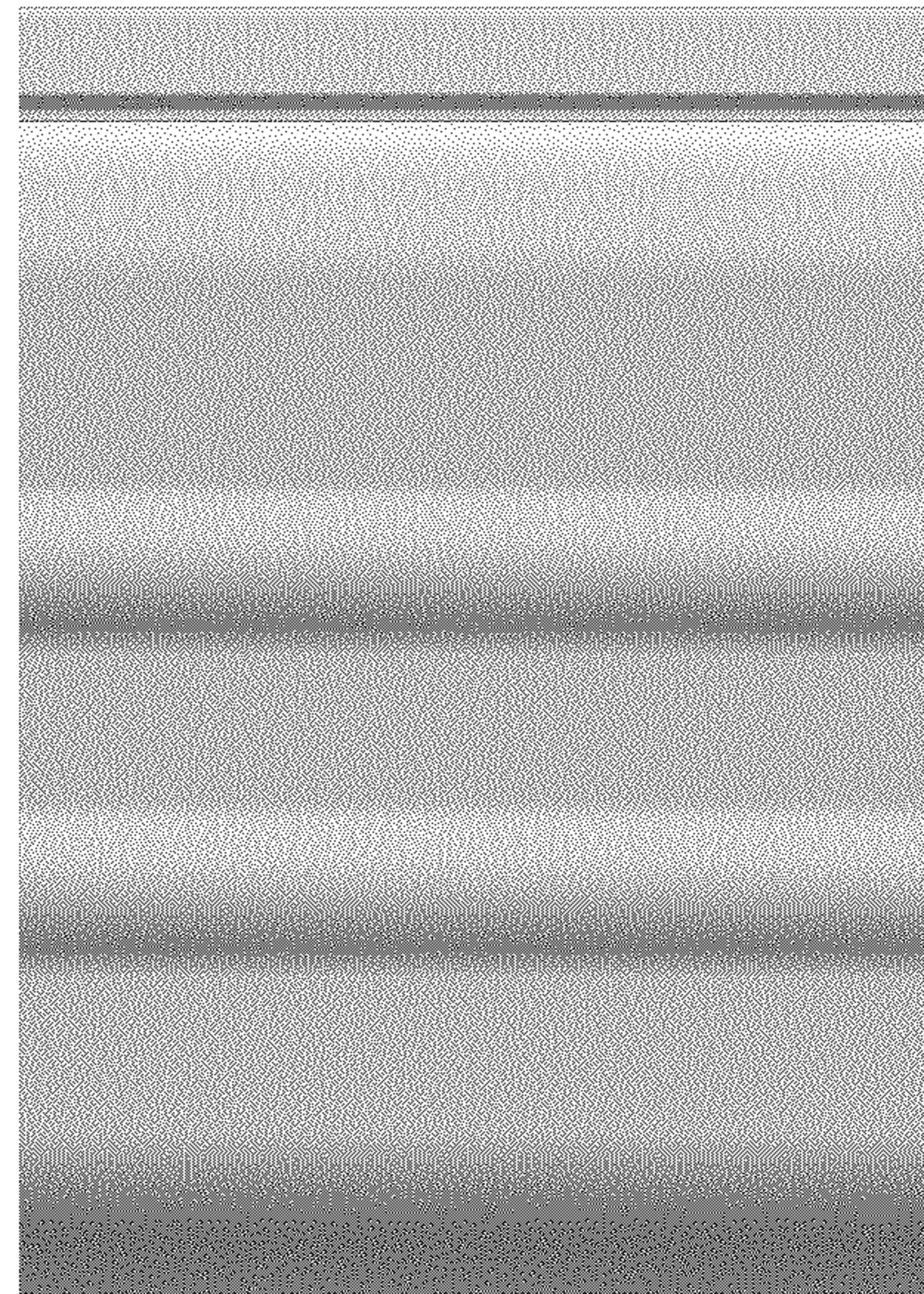

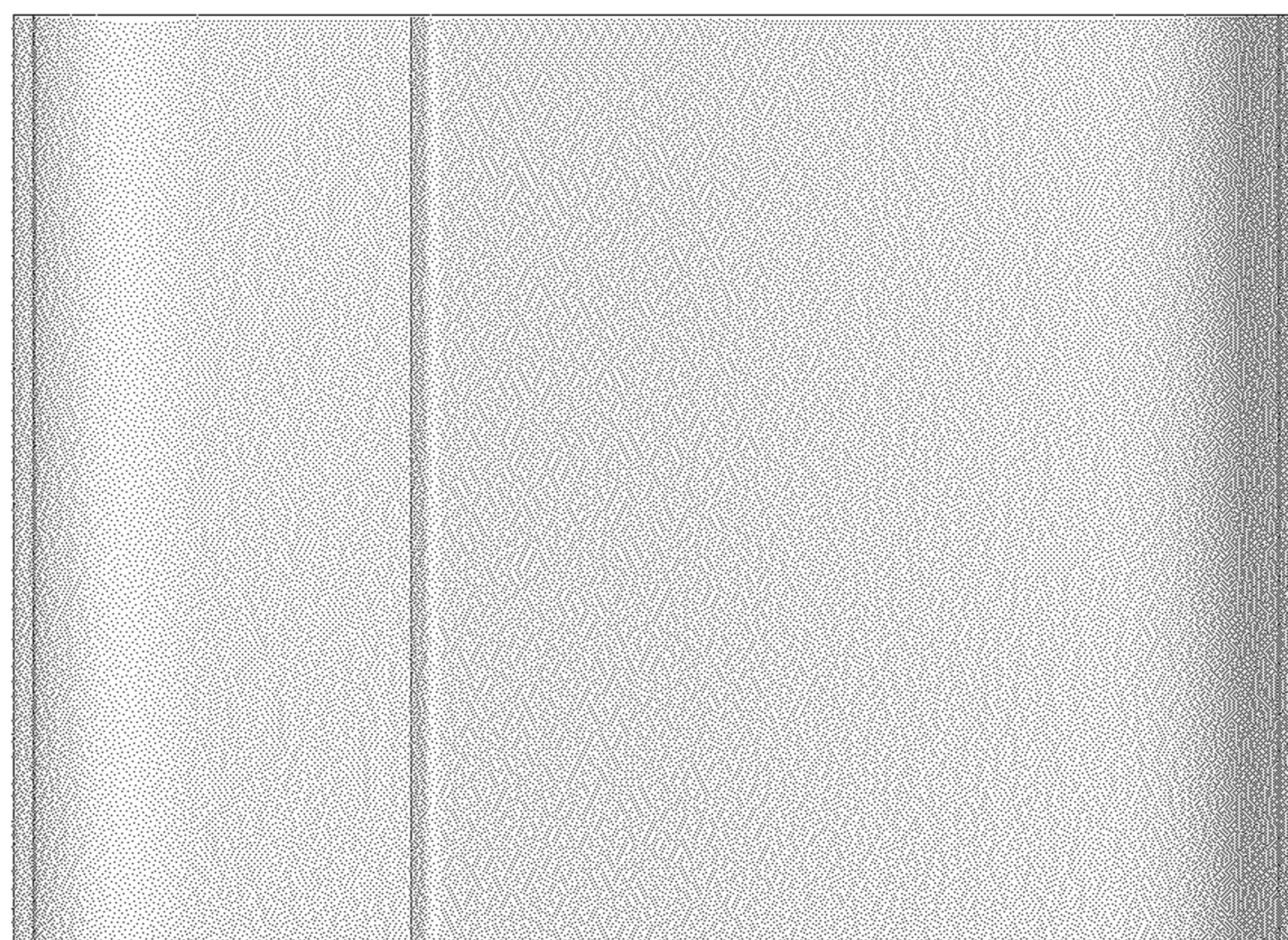

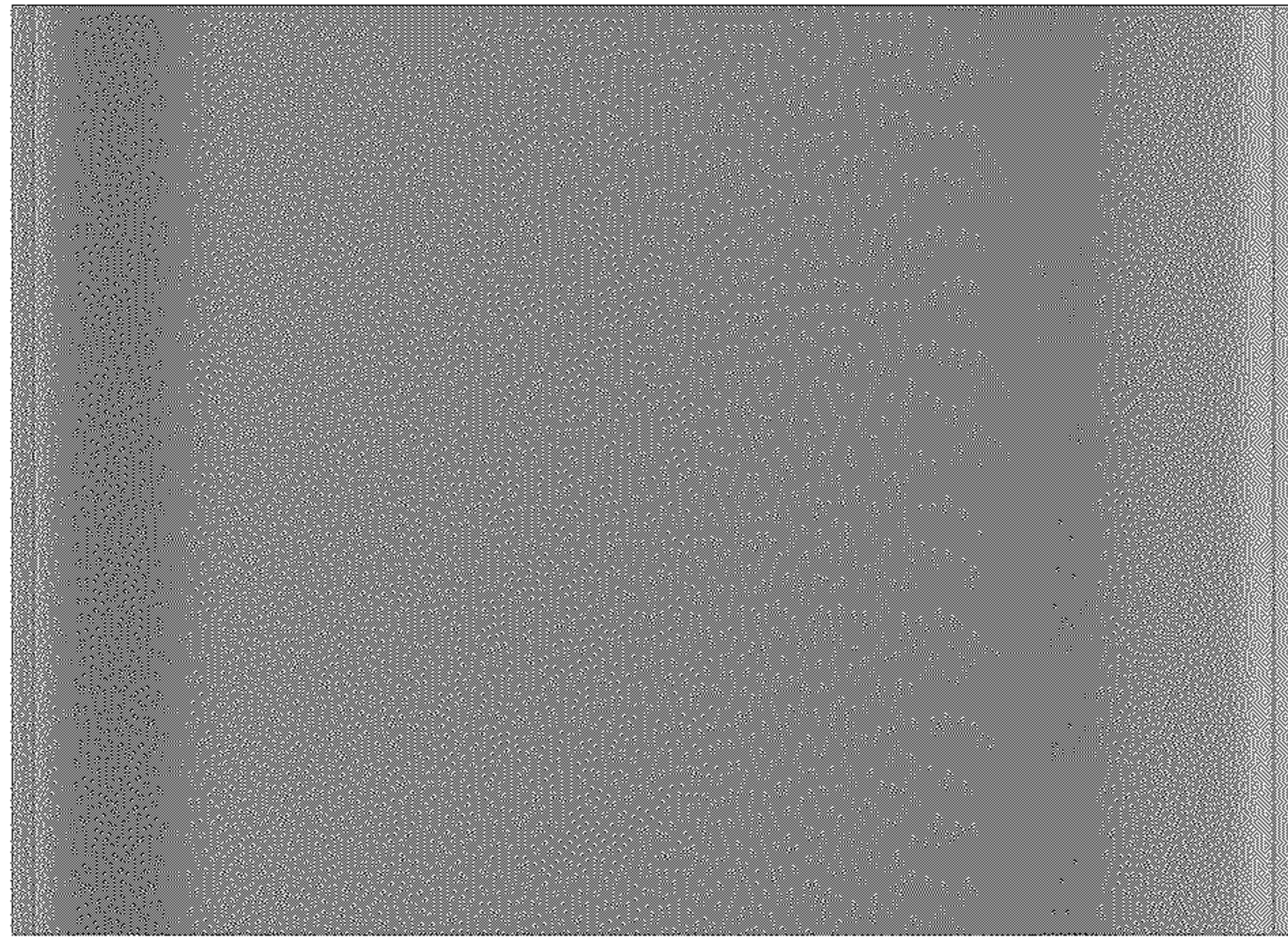

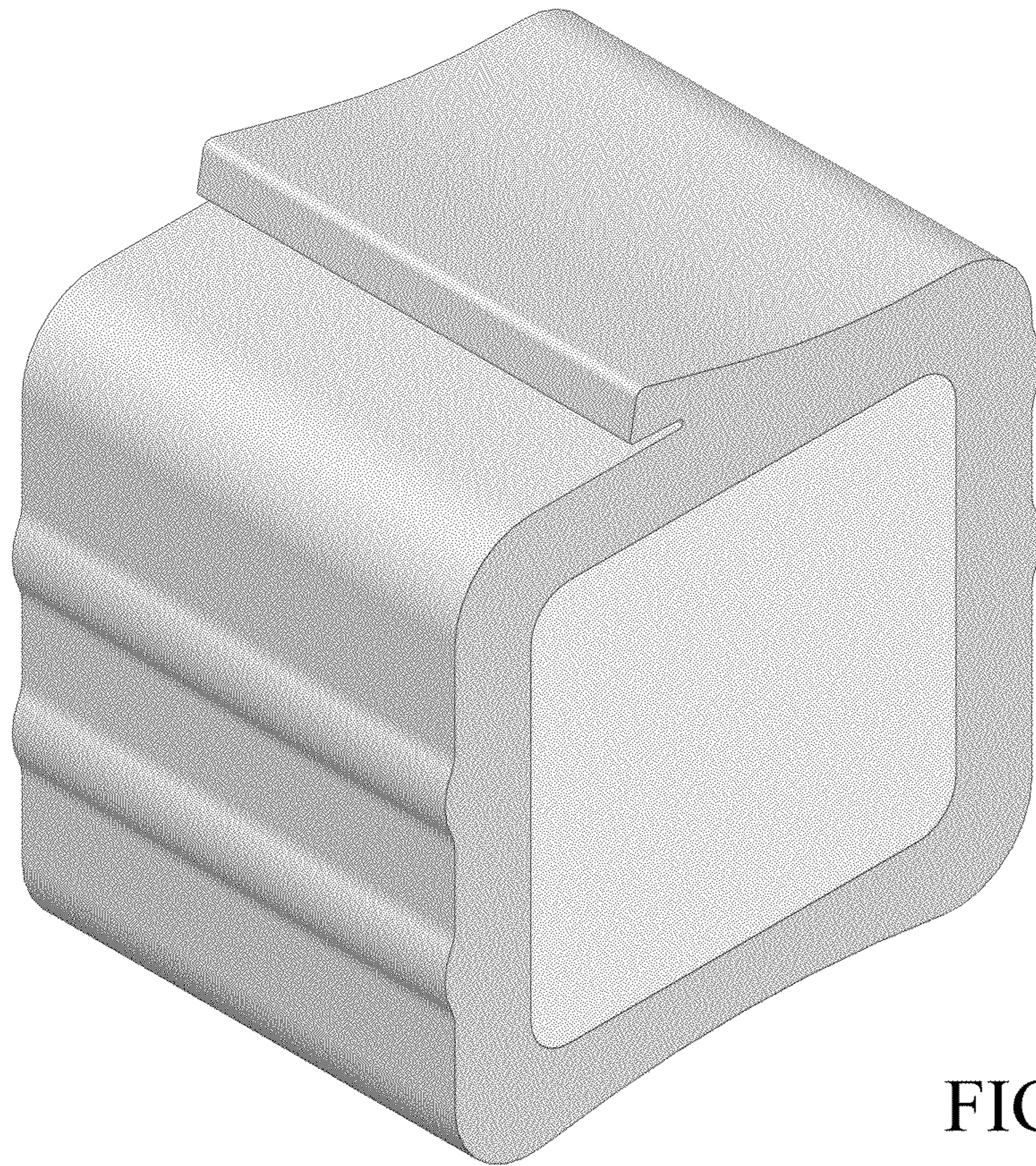
