The ornamental design for a carpet underlayment, as shown and described.

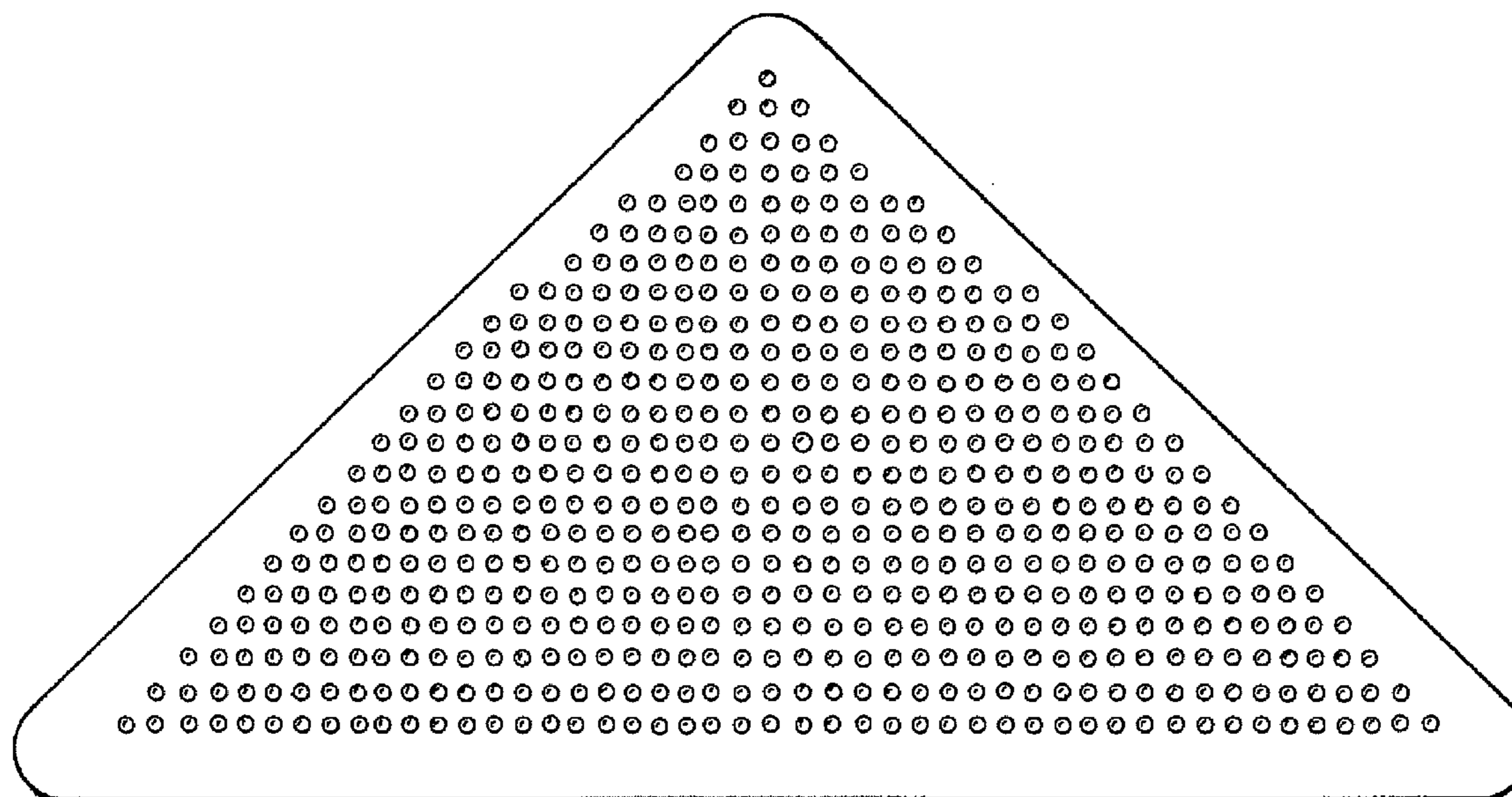
**DESCRIPTION**

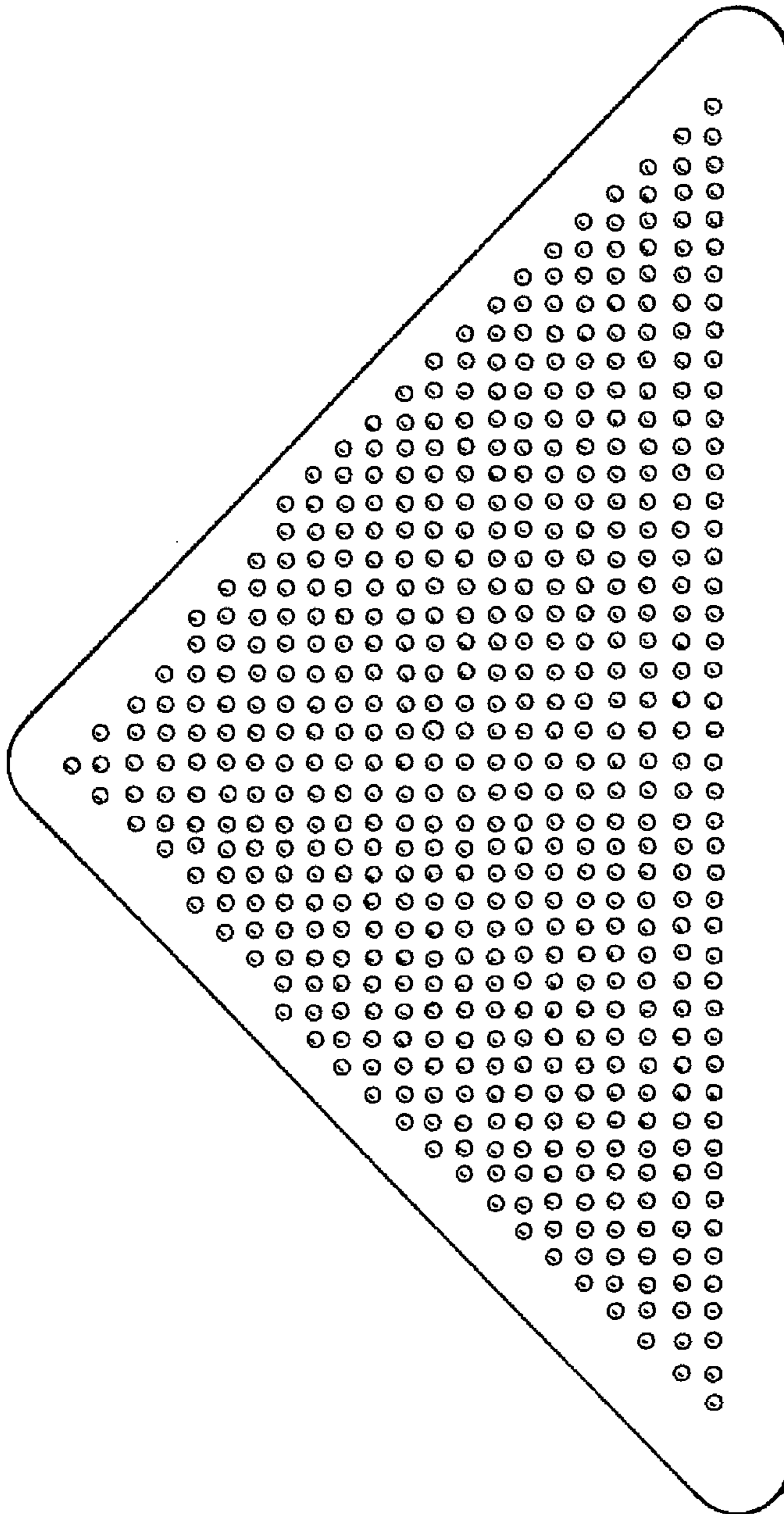
FIG. 1 is a top plan view of the proposed design.

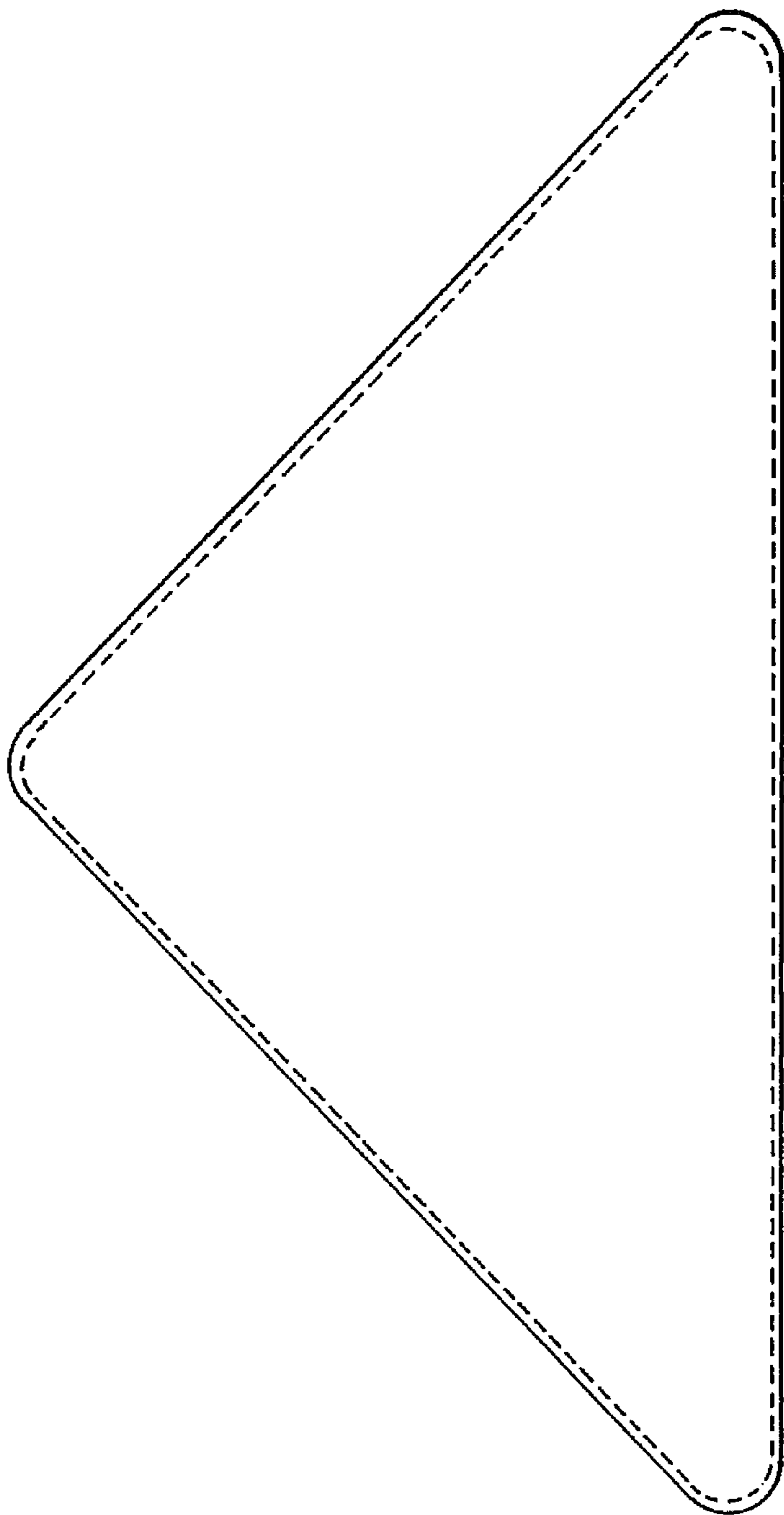

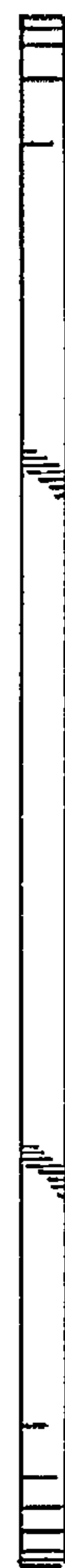
