FIG. 7 is a top view of the corkscrew.

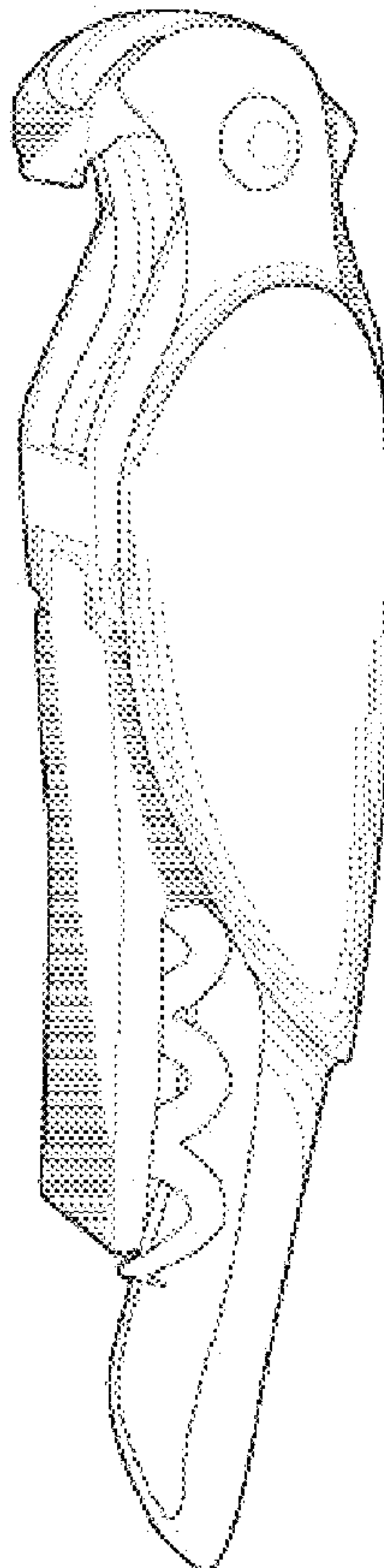

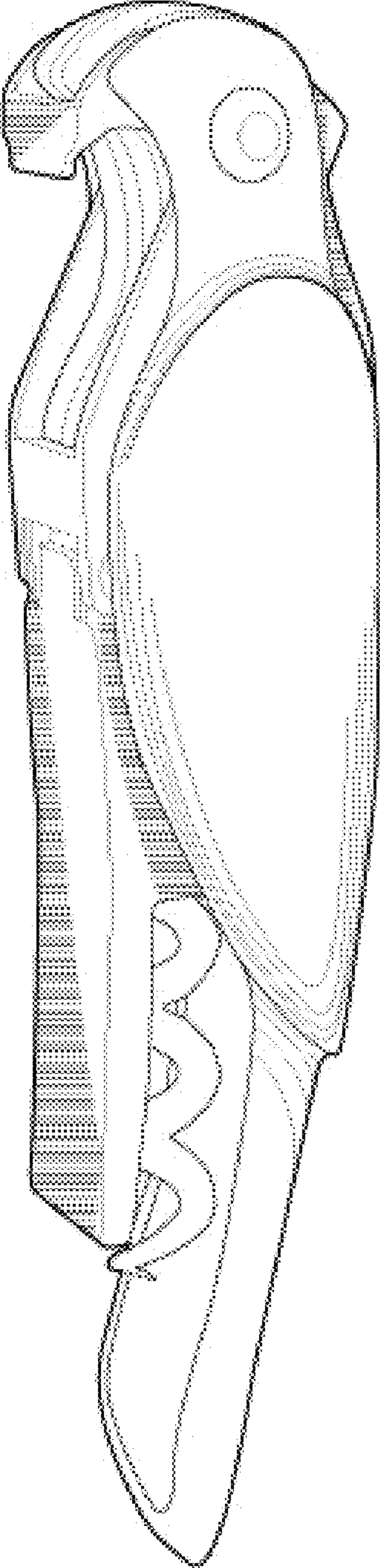

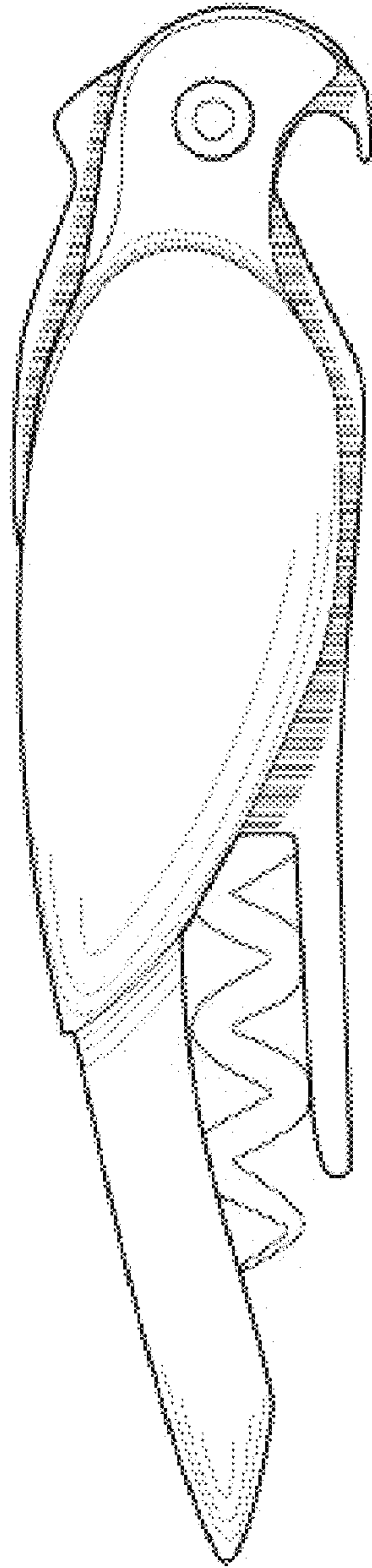

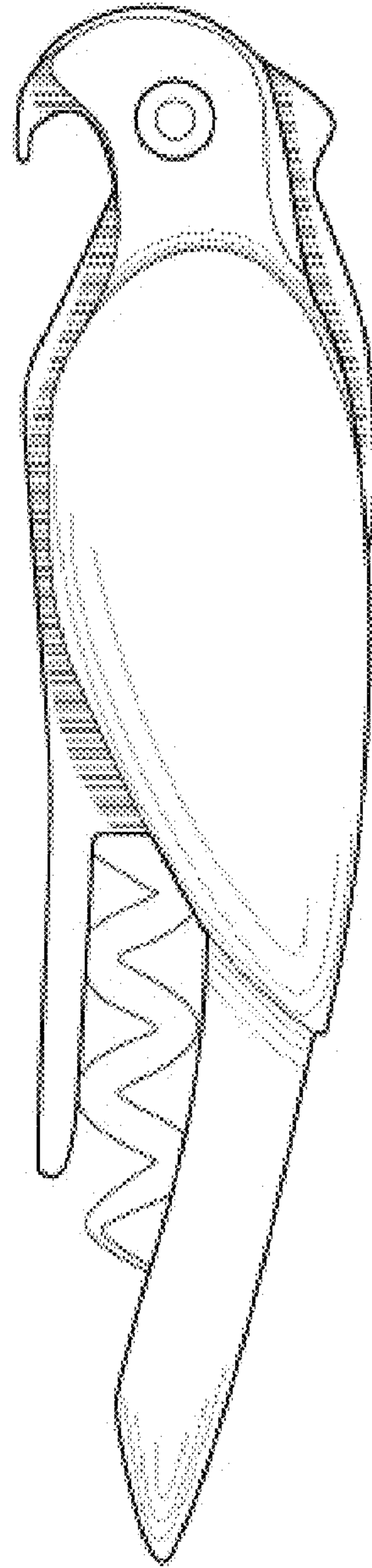

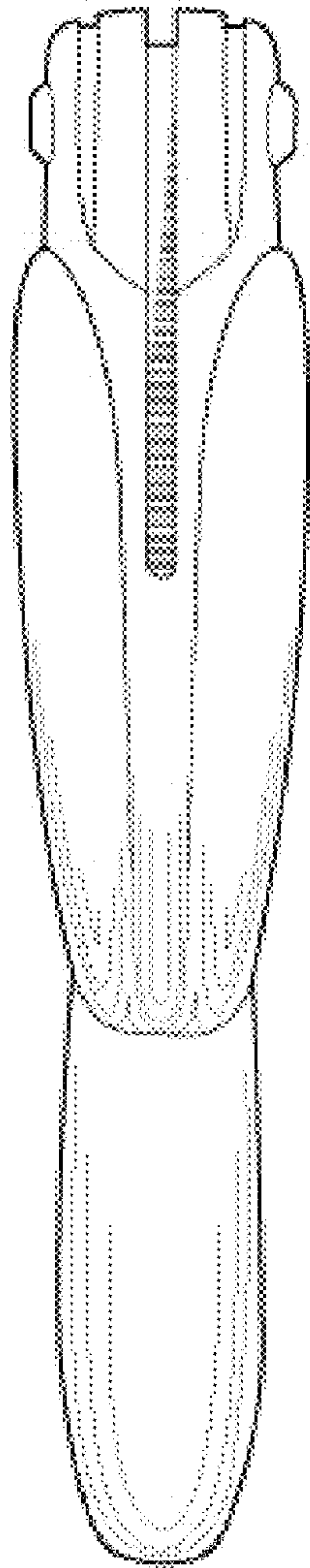

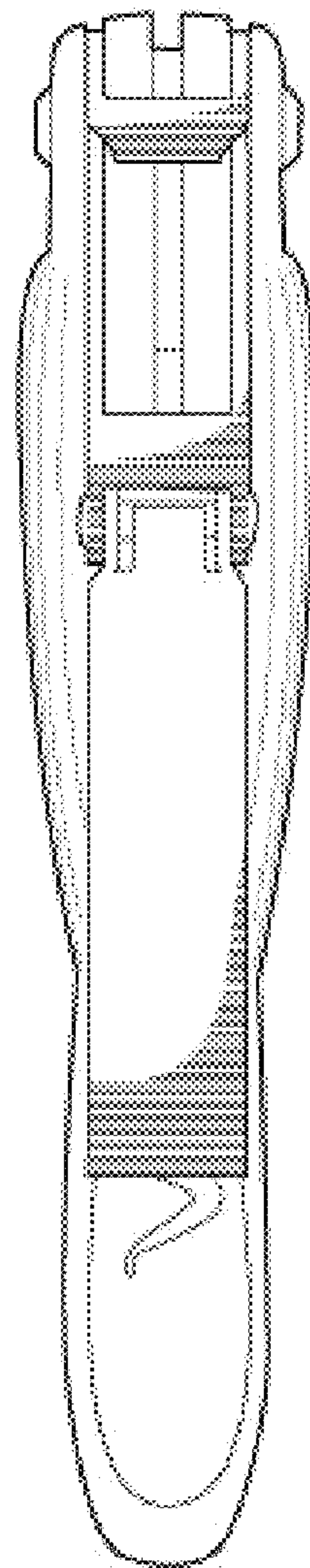

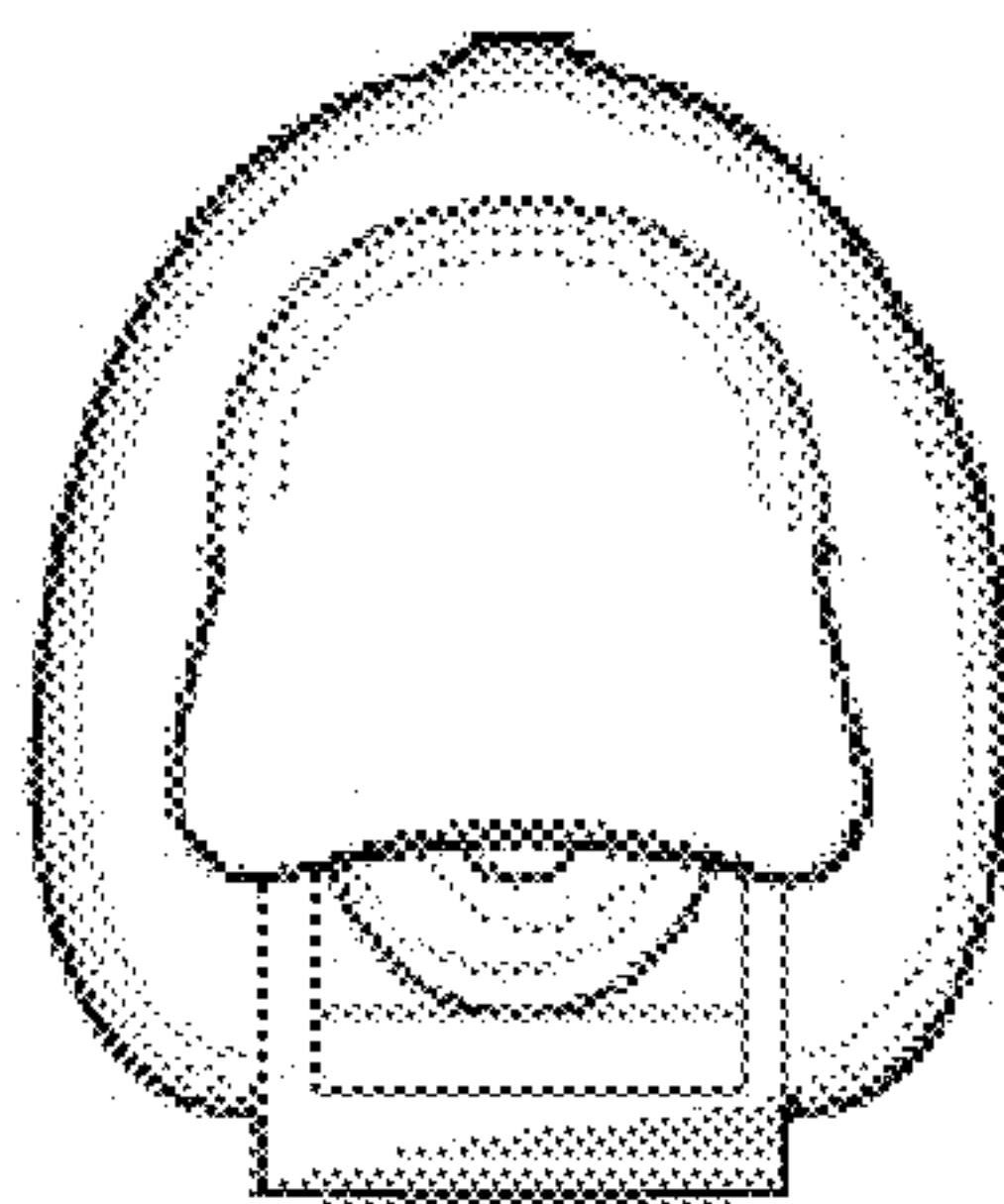

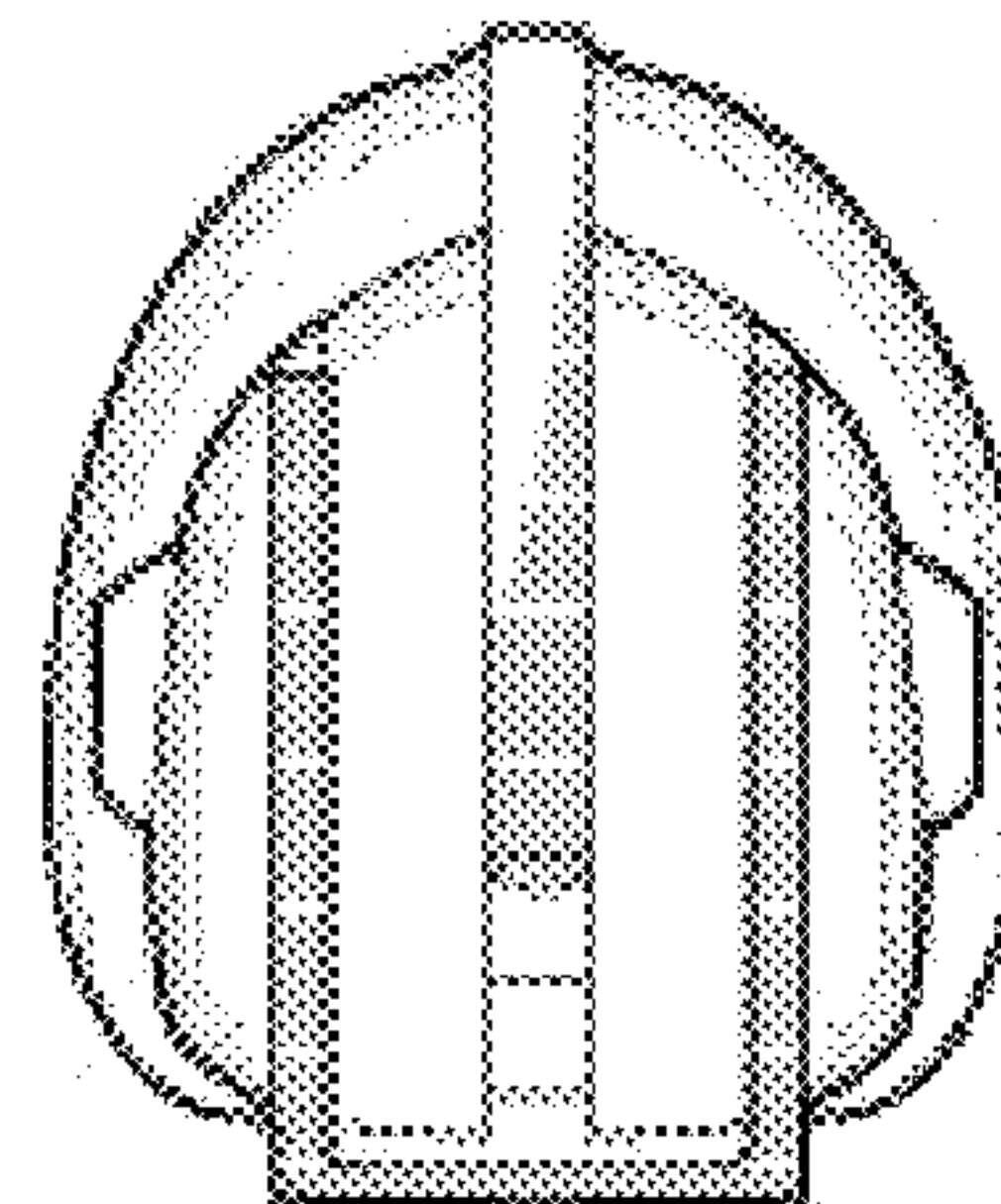
