DESCRIPTION

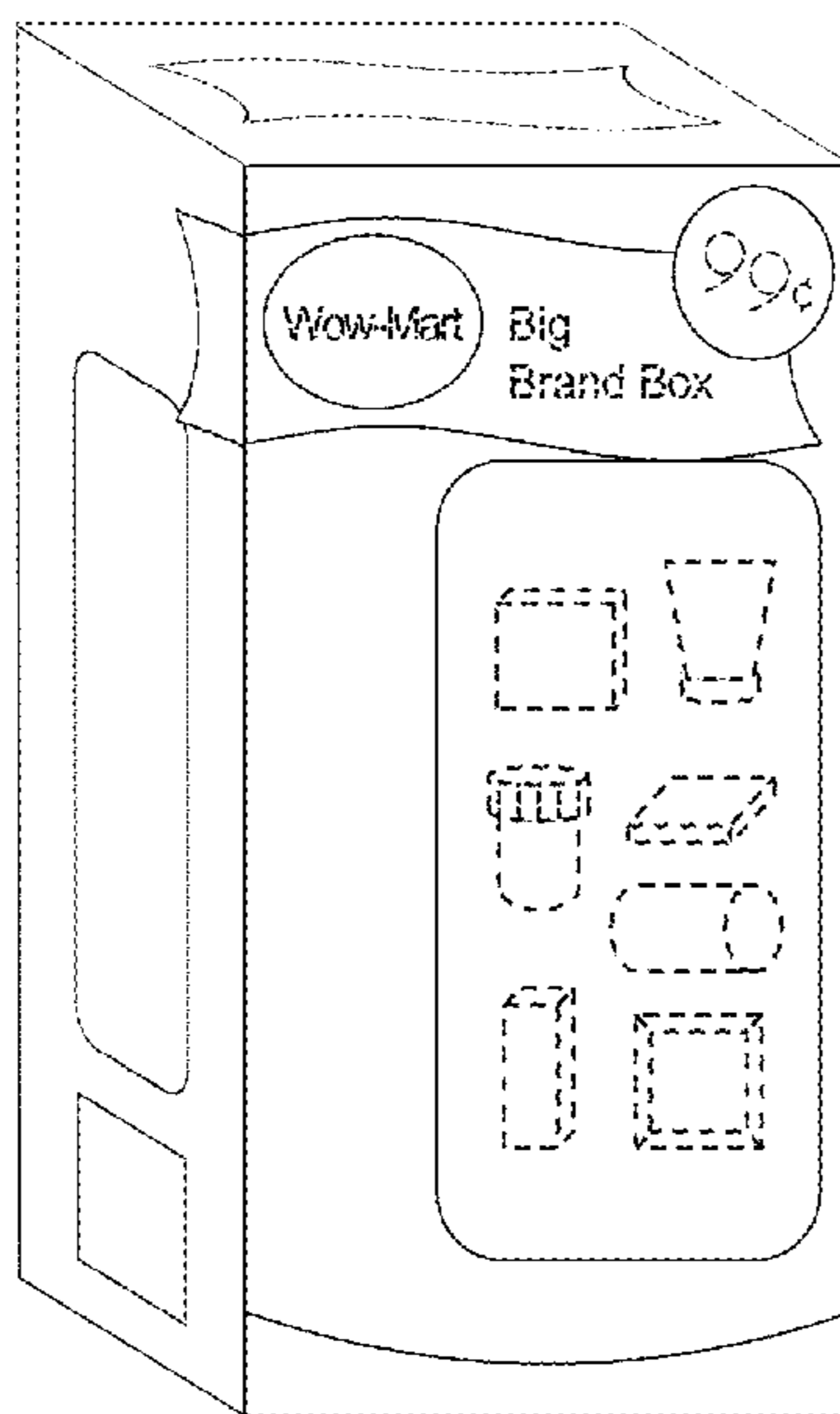
FIG. 1 is a frontal view of a box.

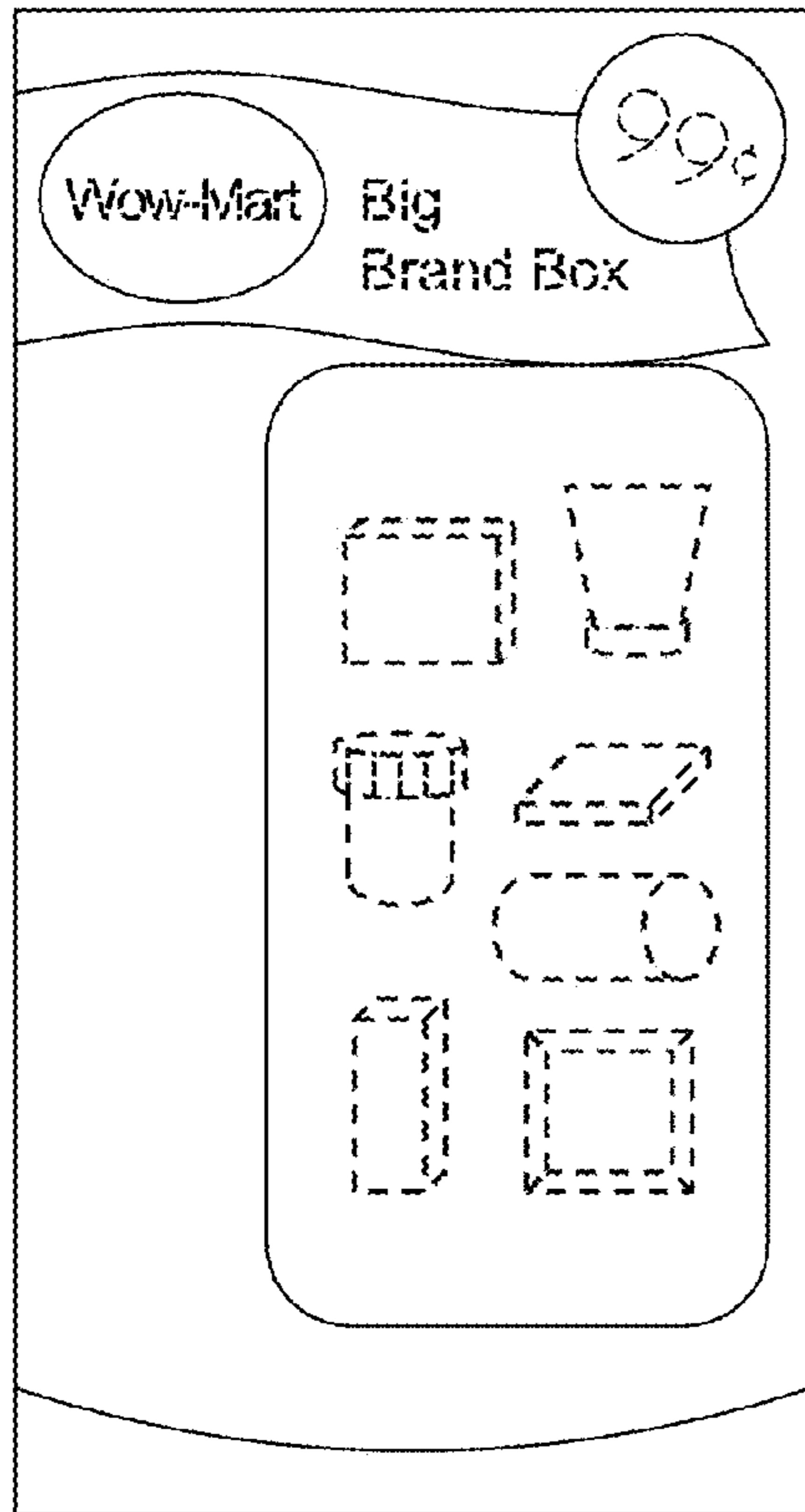

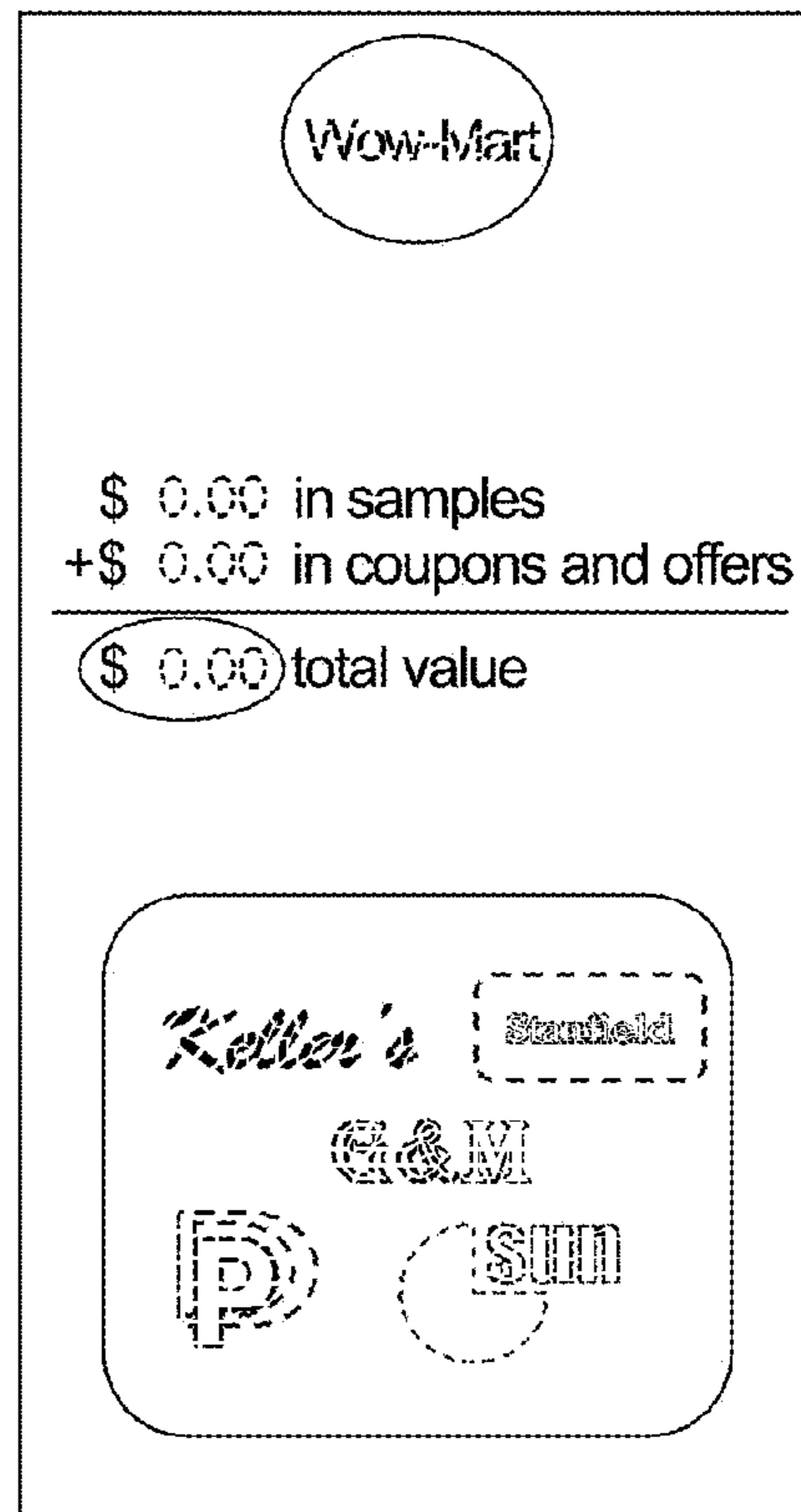

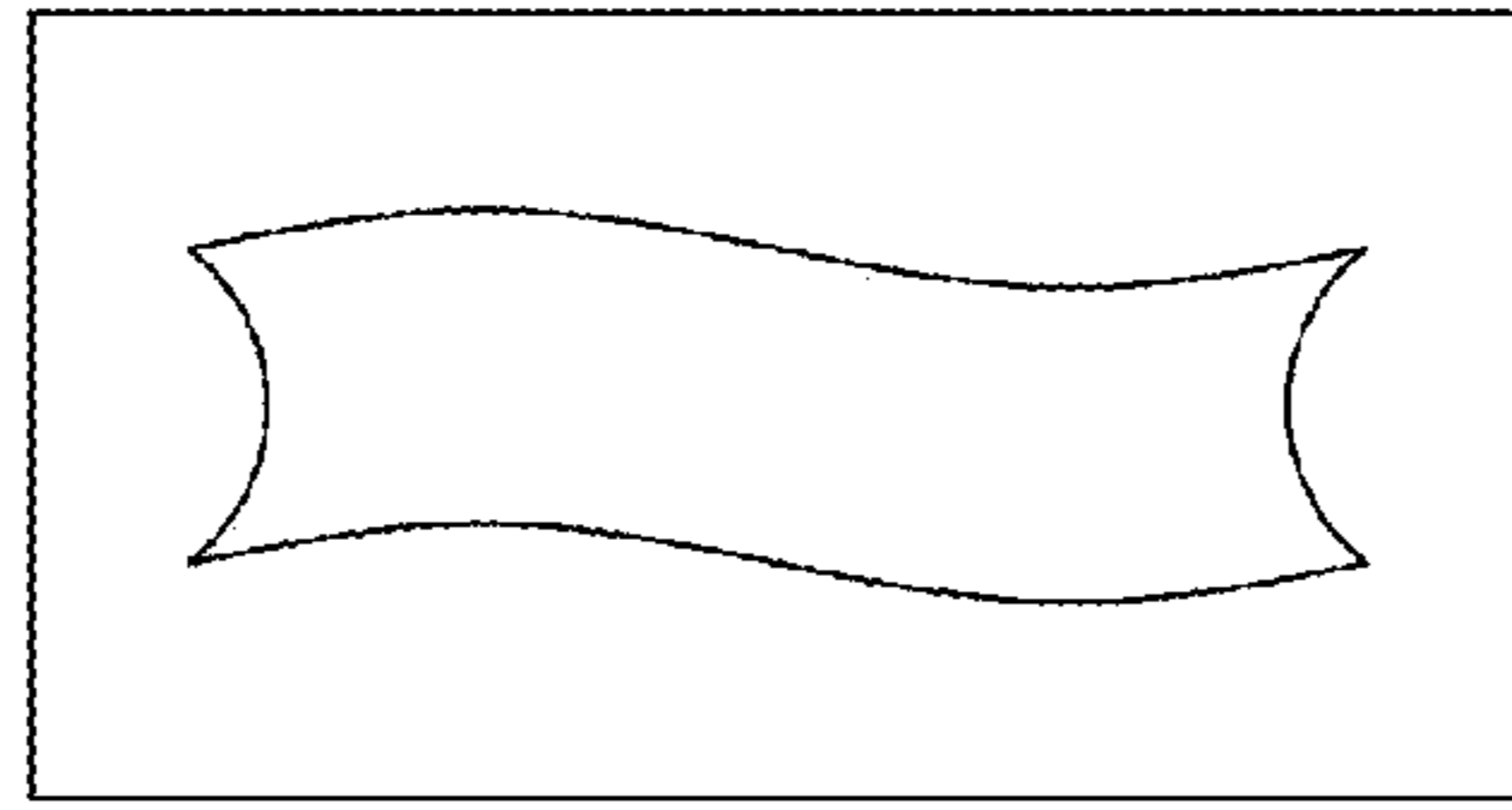

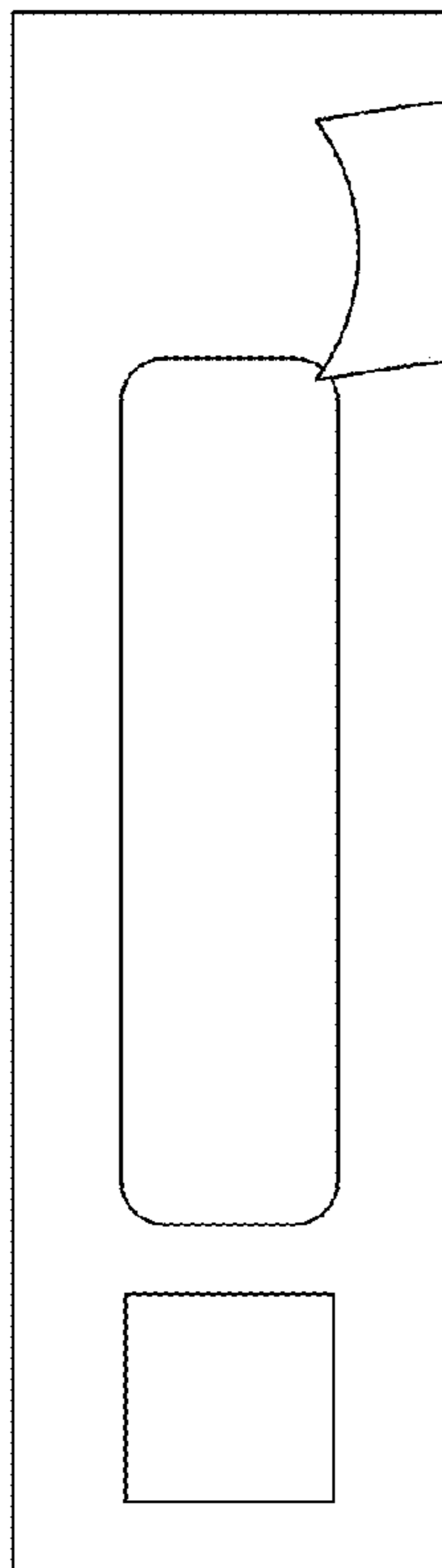

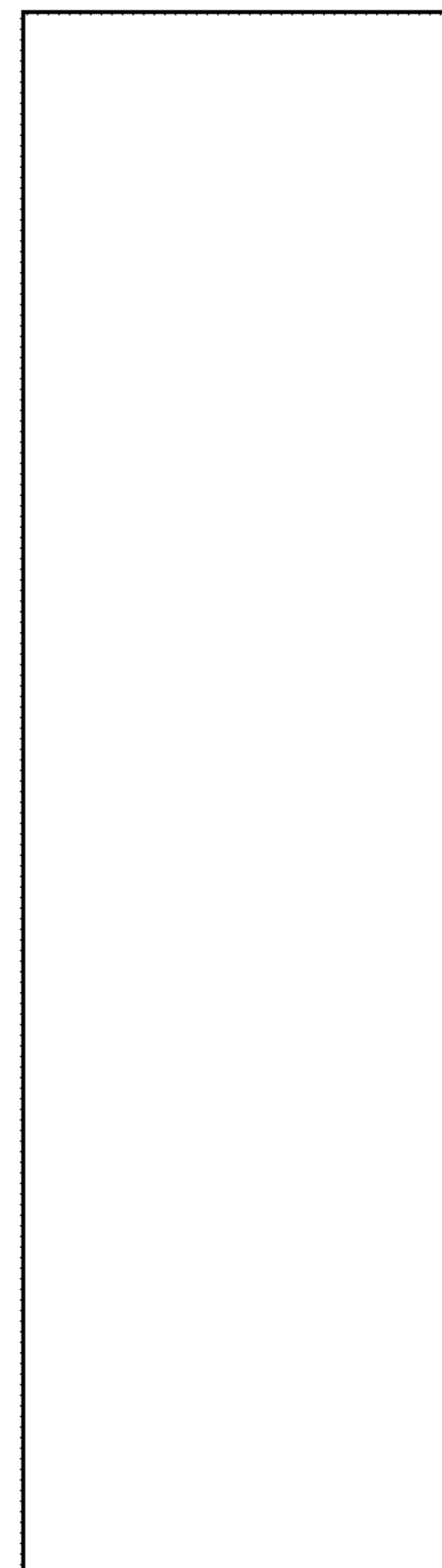

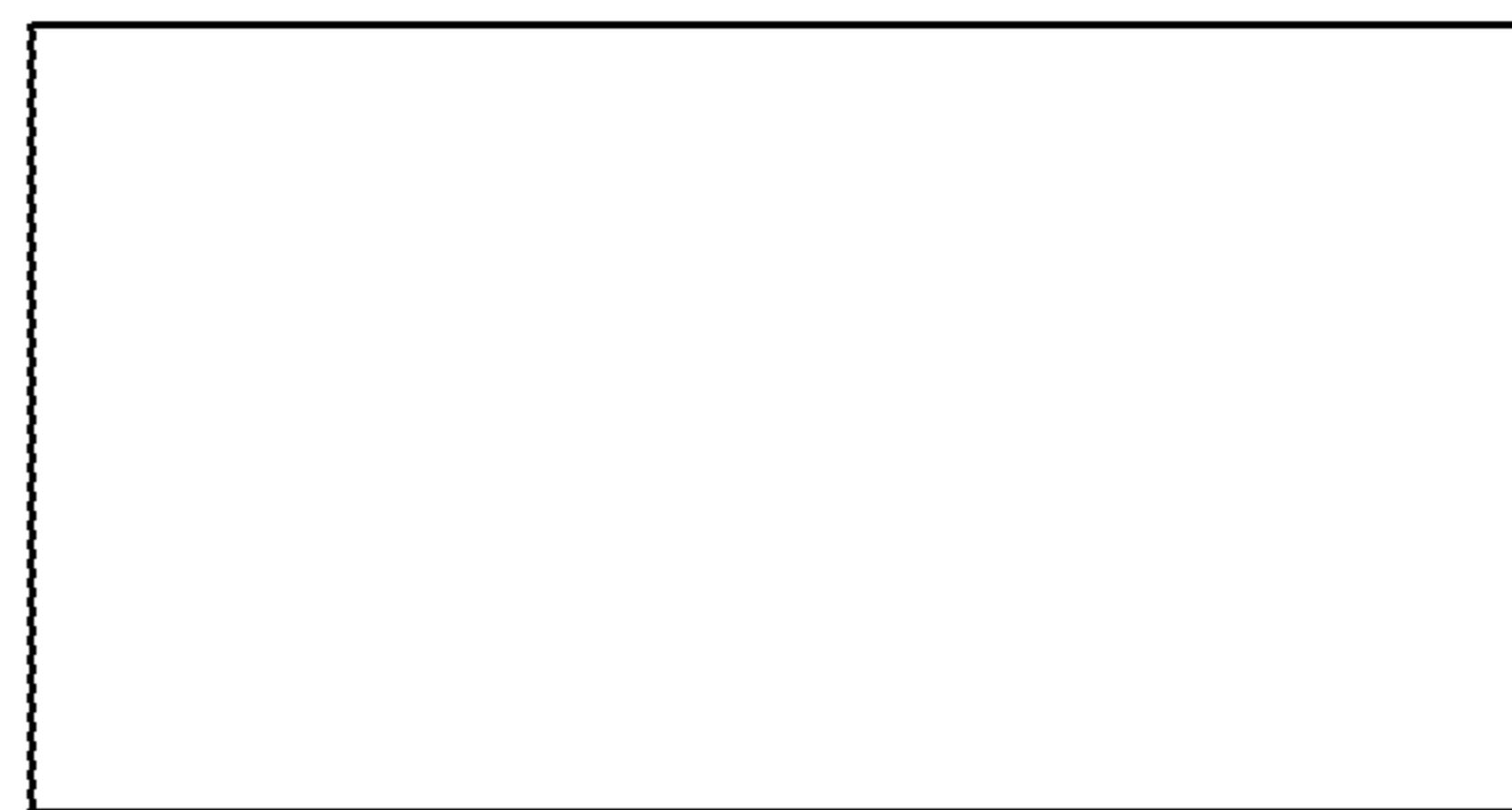

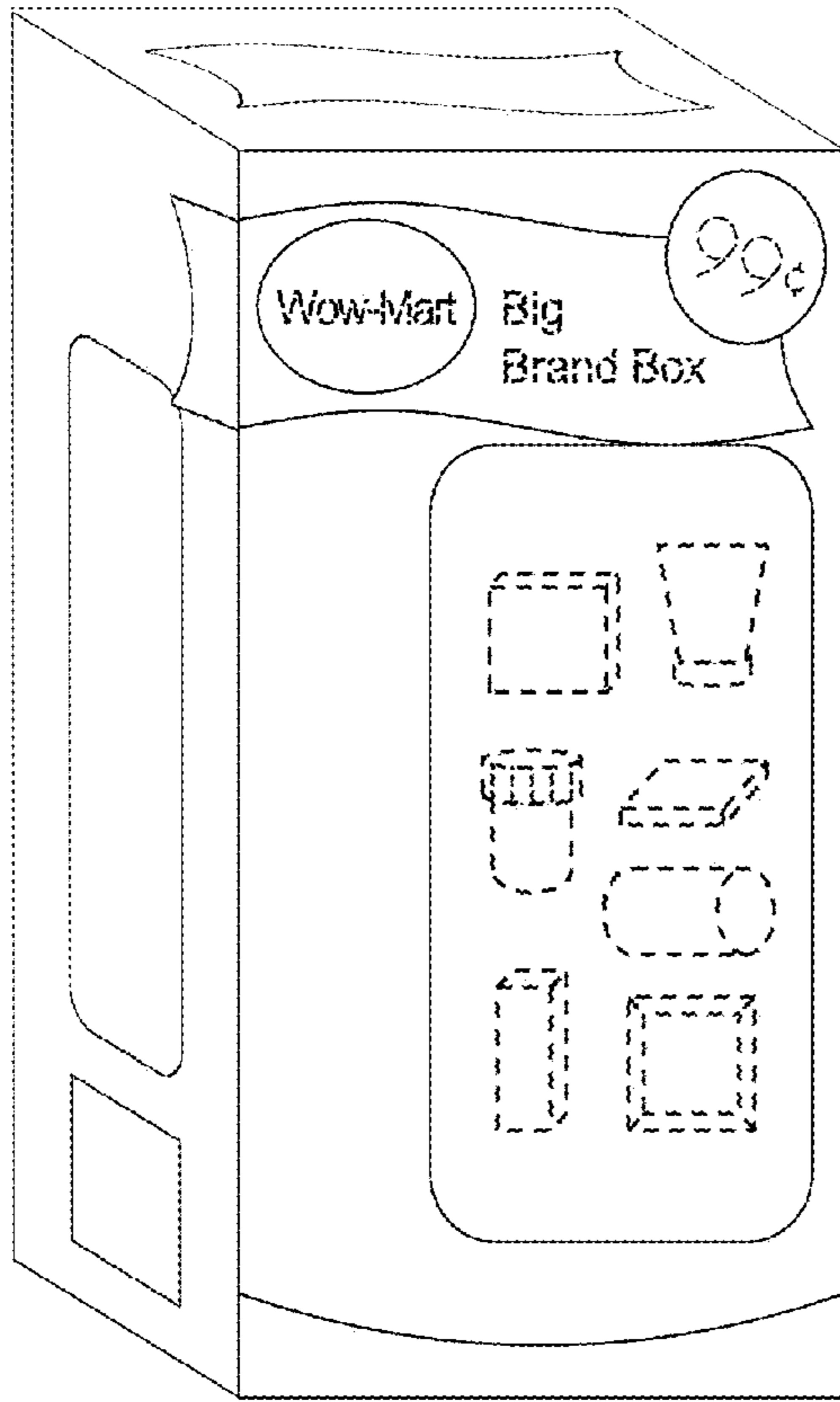

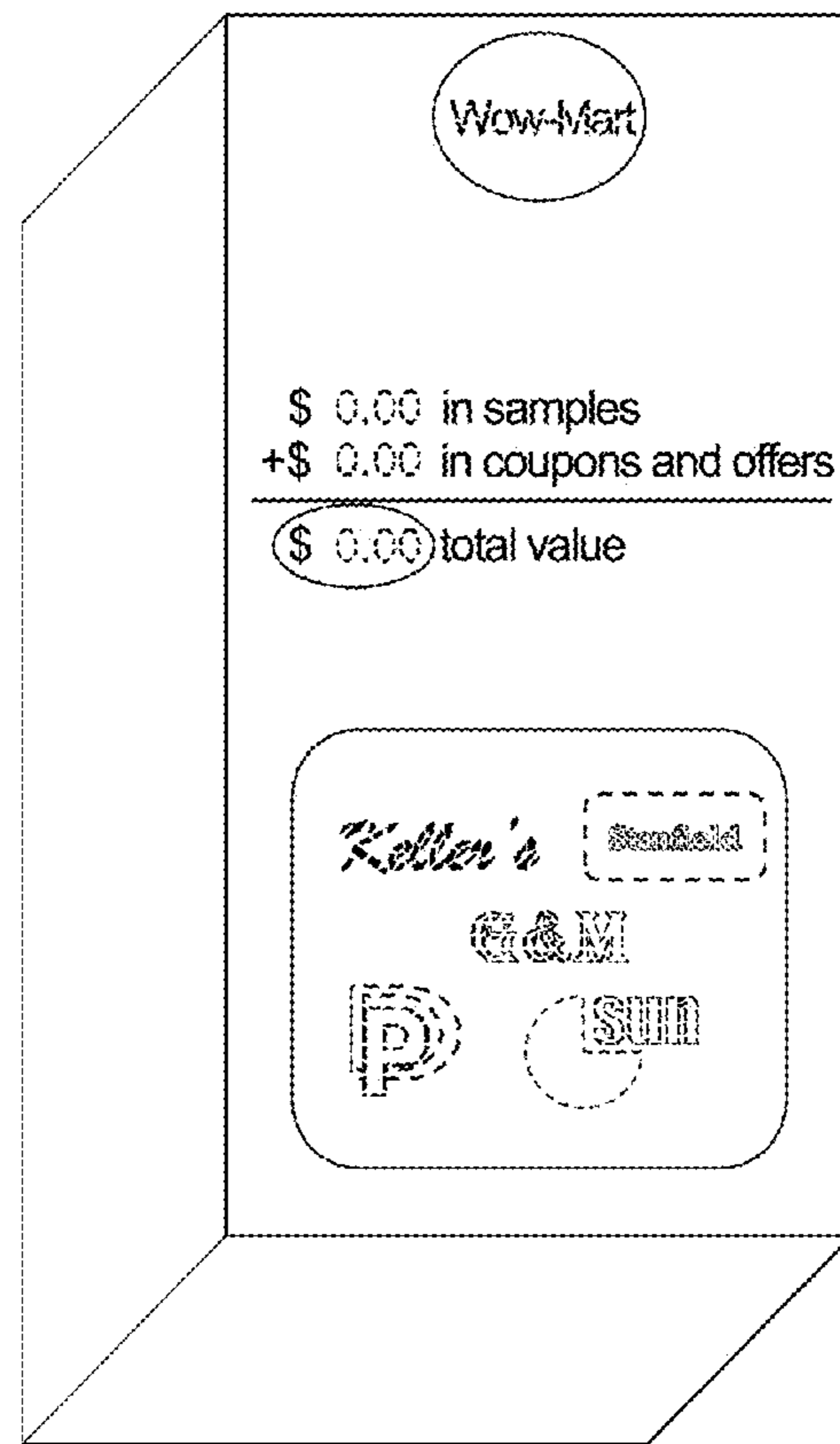
