**DESCRIPTION**

FIG. 1 is a perspective view of a turkey hunter's trophy showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image of the left side;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a top plan view thereof.  
The rear of the turkey hunter's trophy is flat and unornamented.

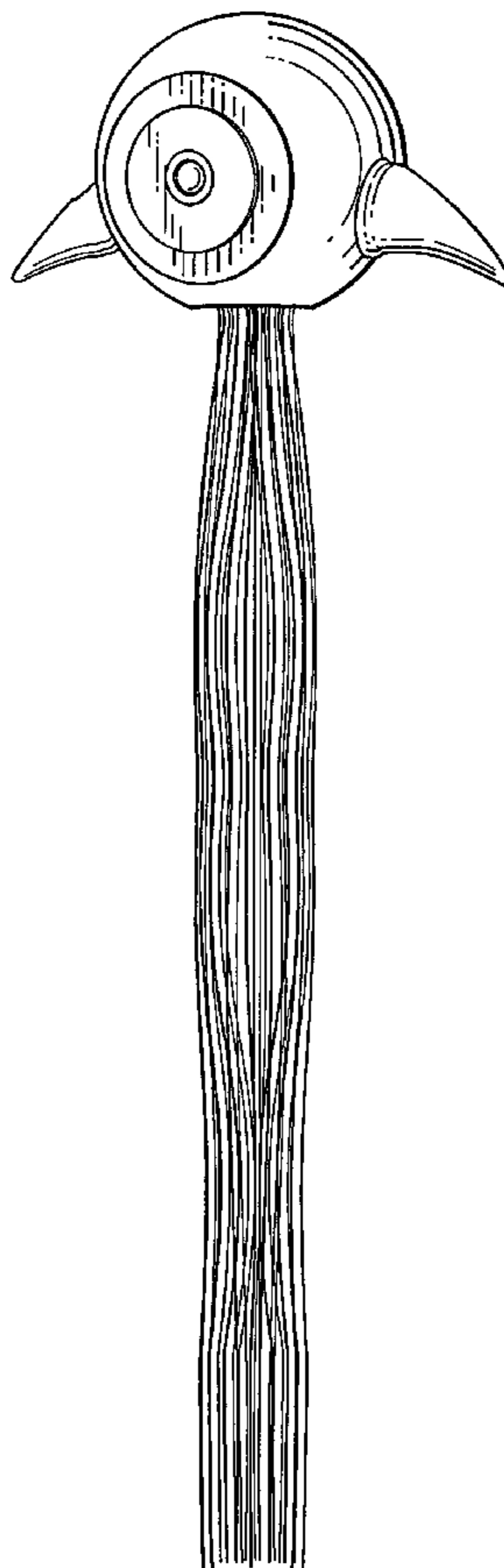
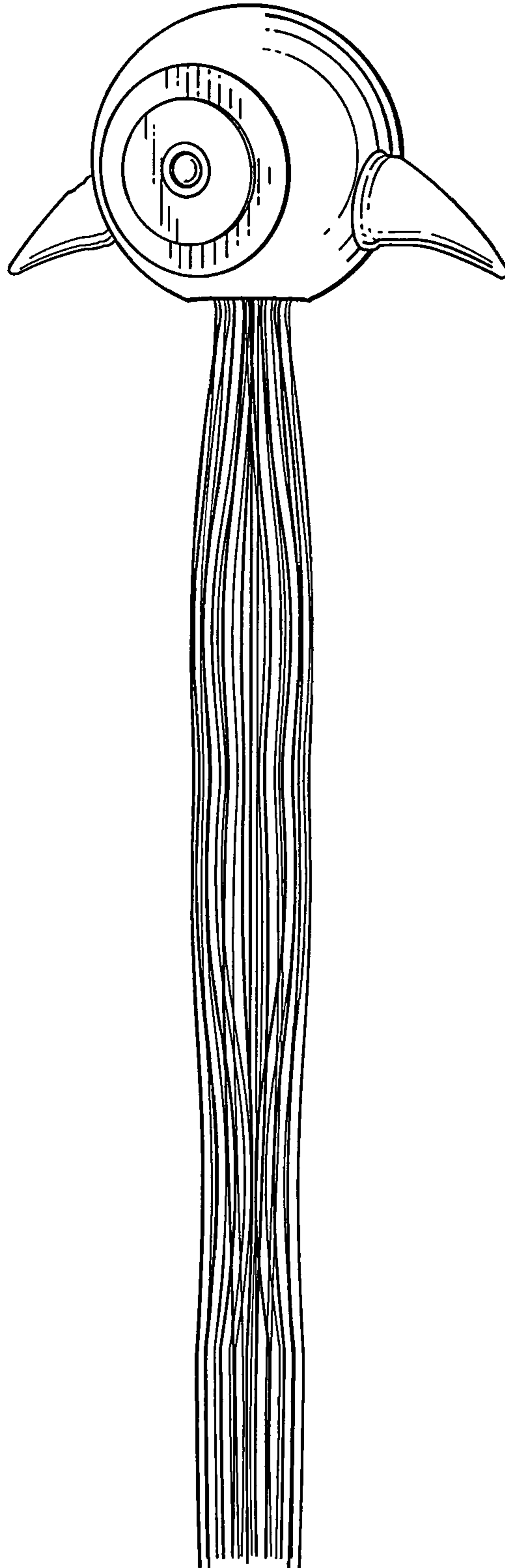
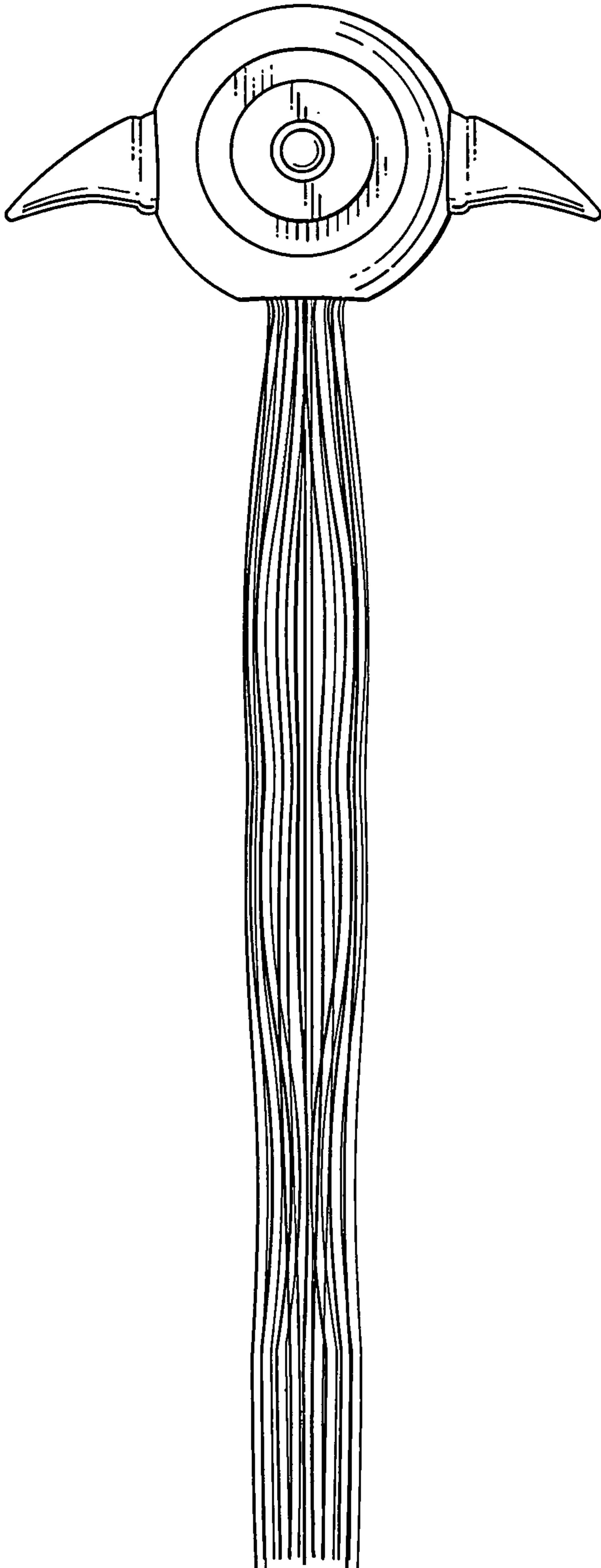


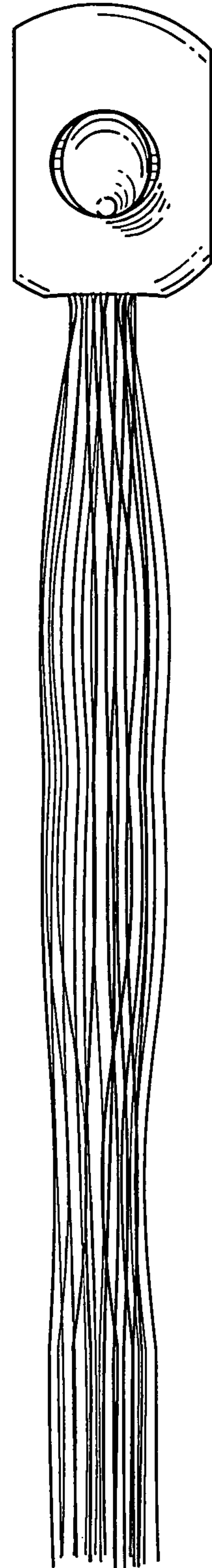

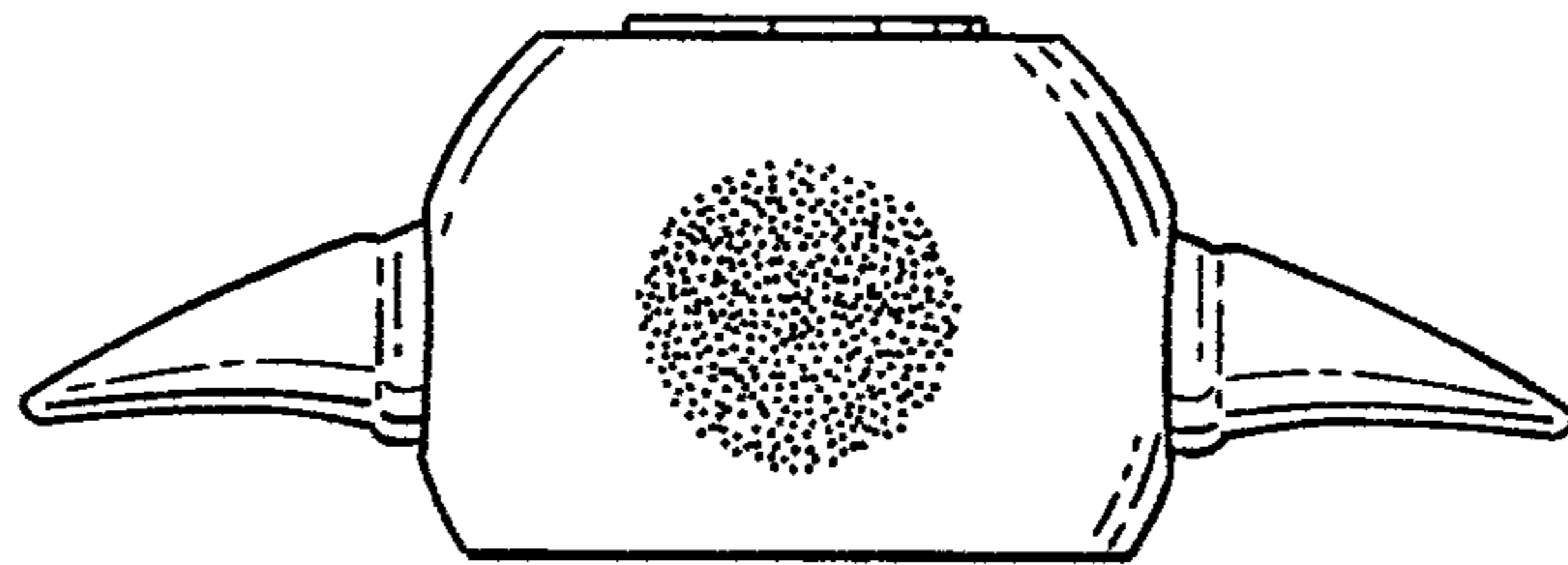
