The ornamental design for a piping slider, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the front, bottom and right side of a piping slider showing my new design;
FIG. 2 is a second perspective view of the front, bottom and left side thereof;
FIG. 3 is a third perspective view of the rear, top and right side thereof;
FIG. 4 is a front view thereof, the rear view being mirror image thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom view thereof.

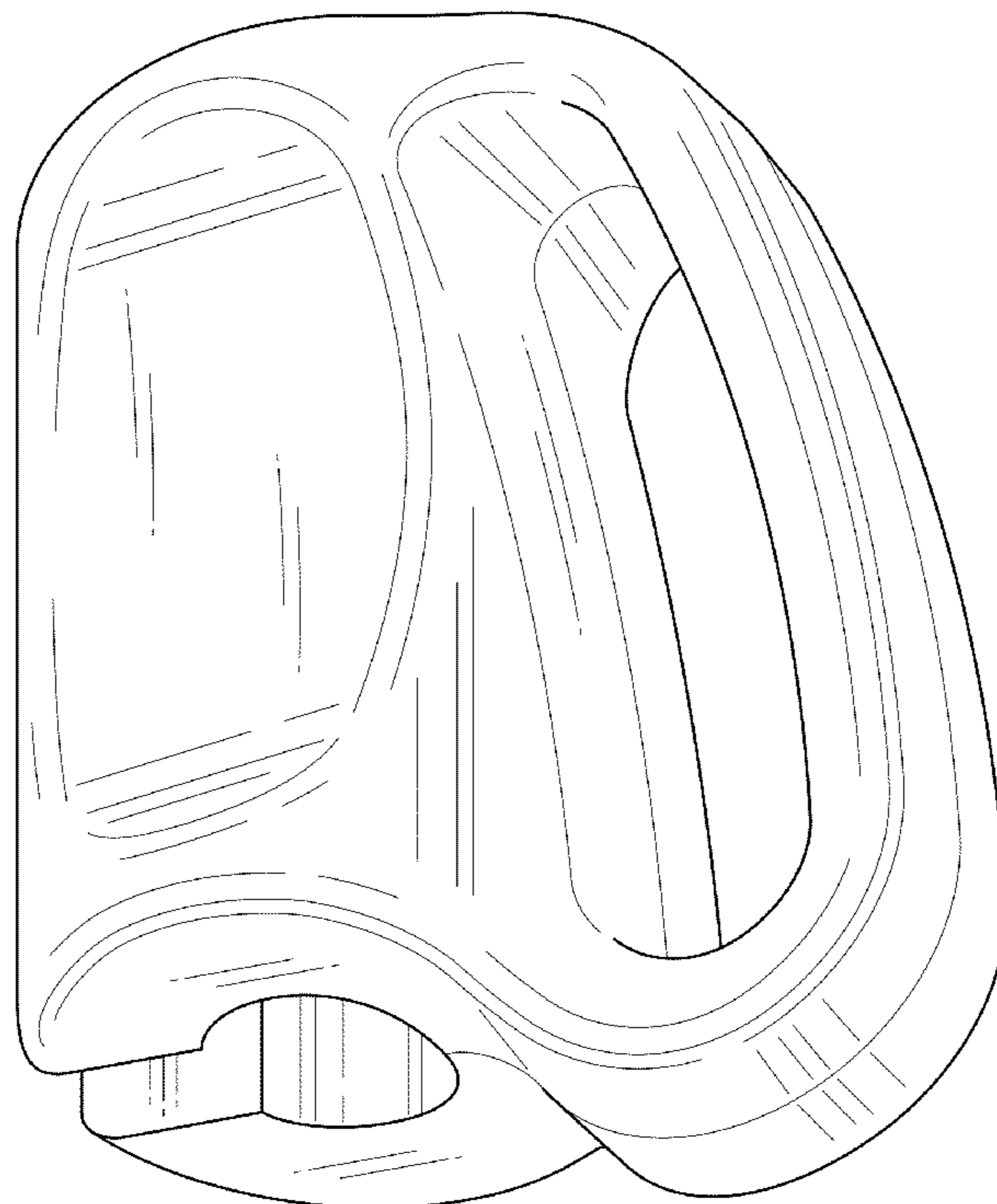

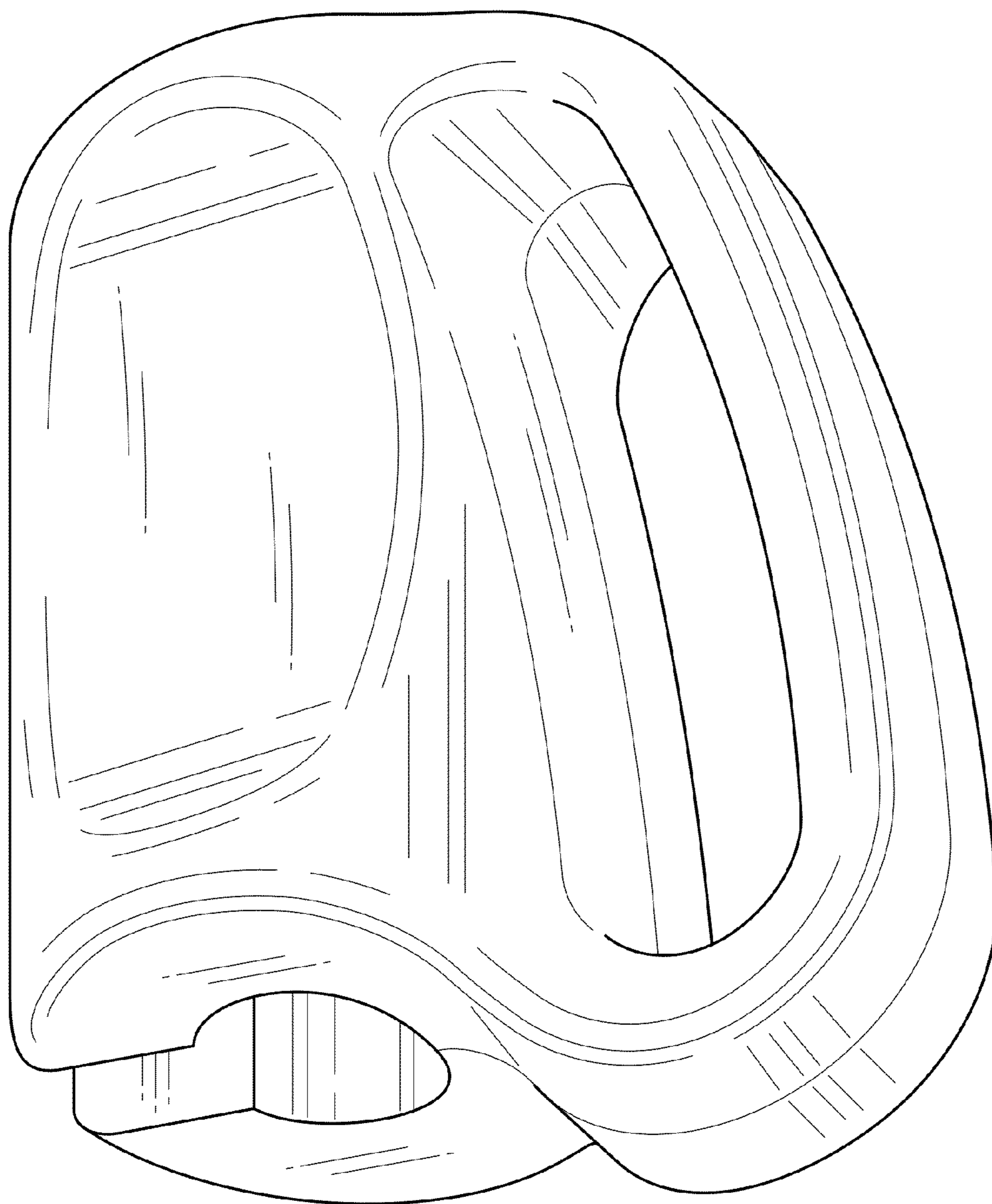

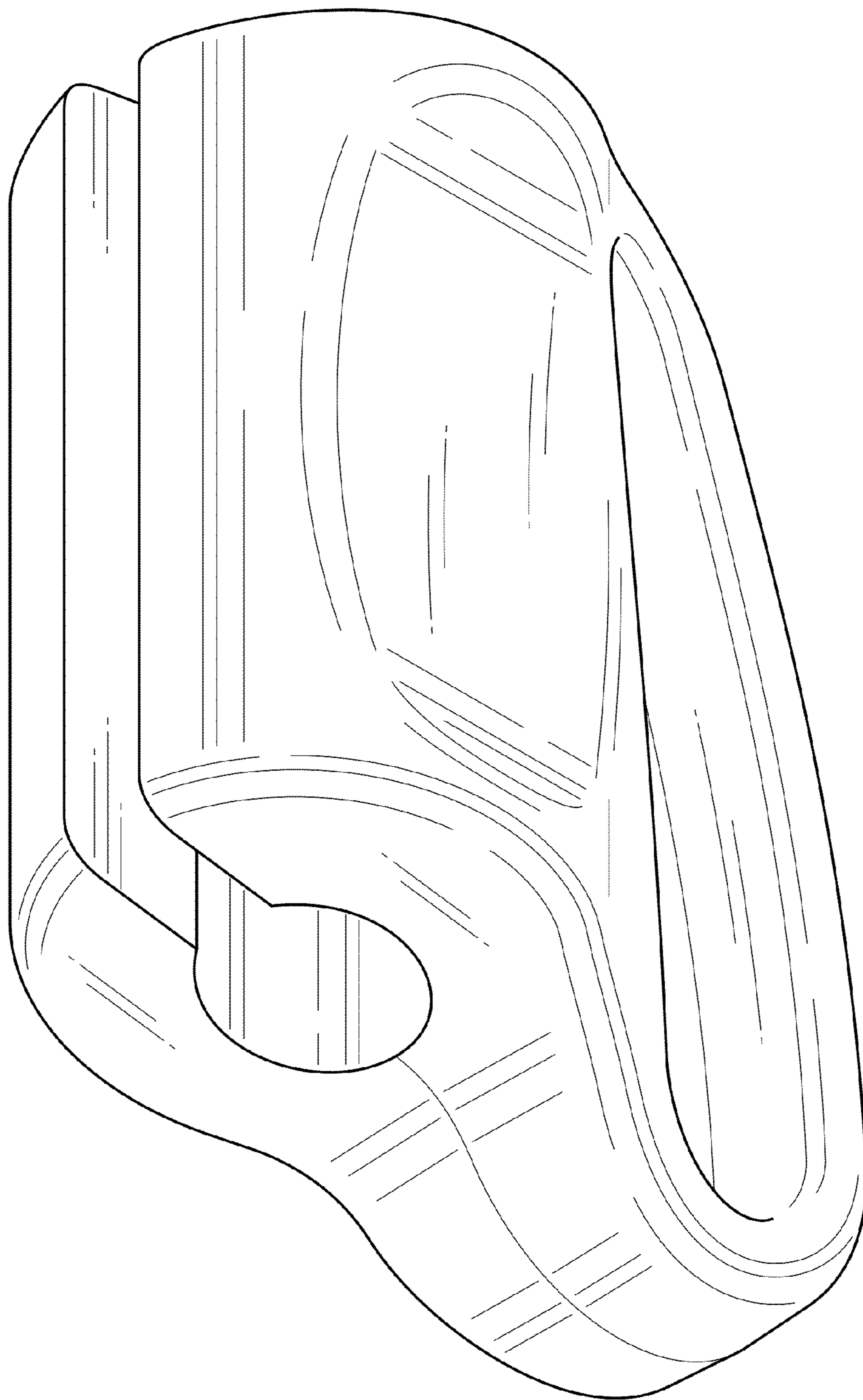

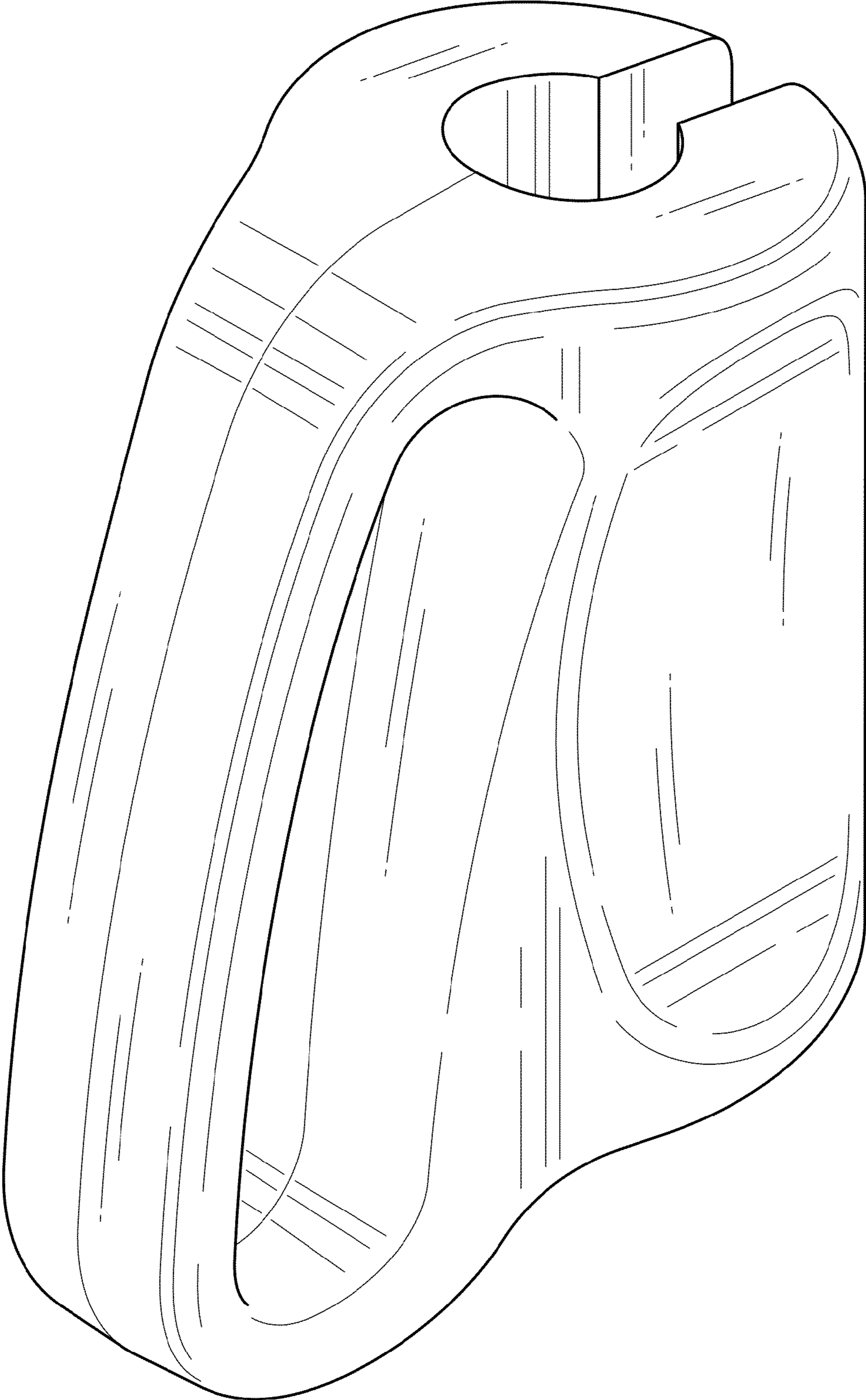

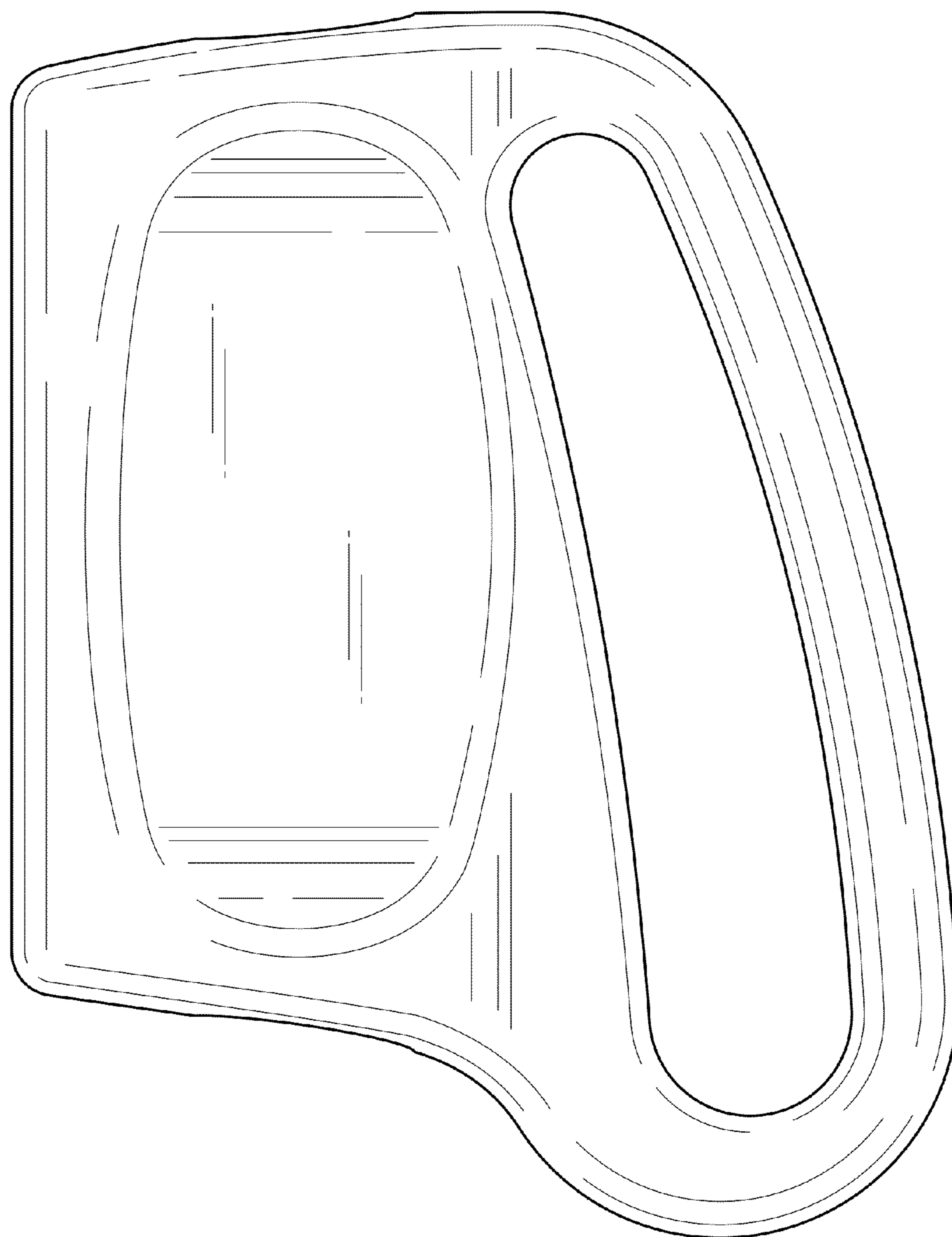

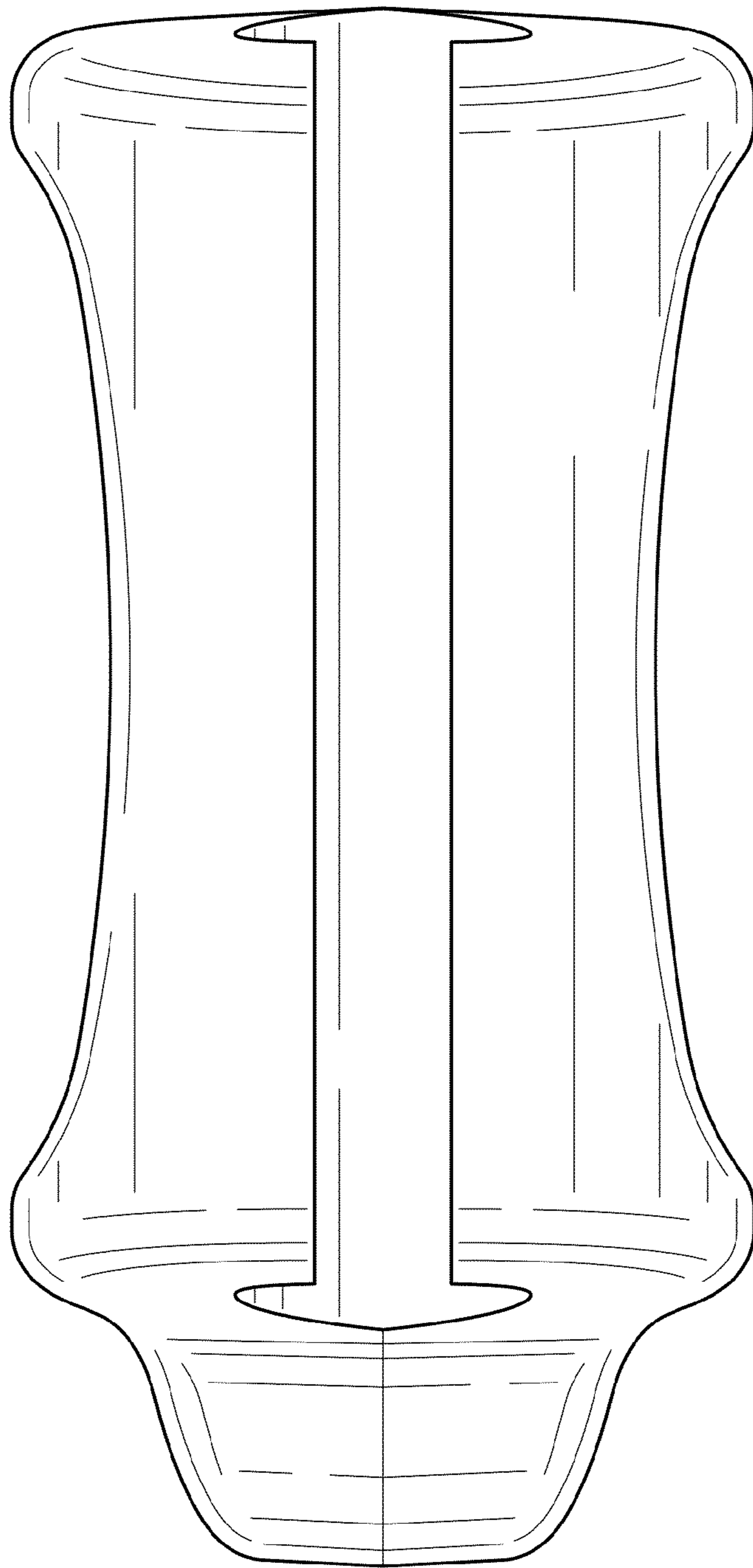

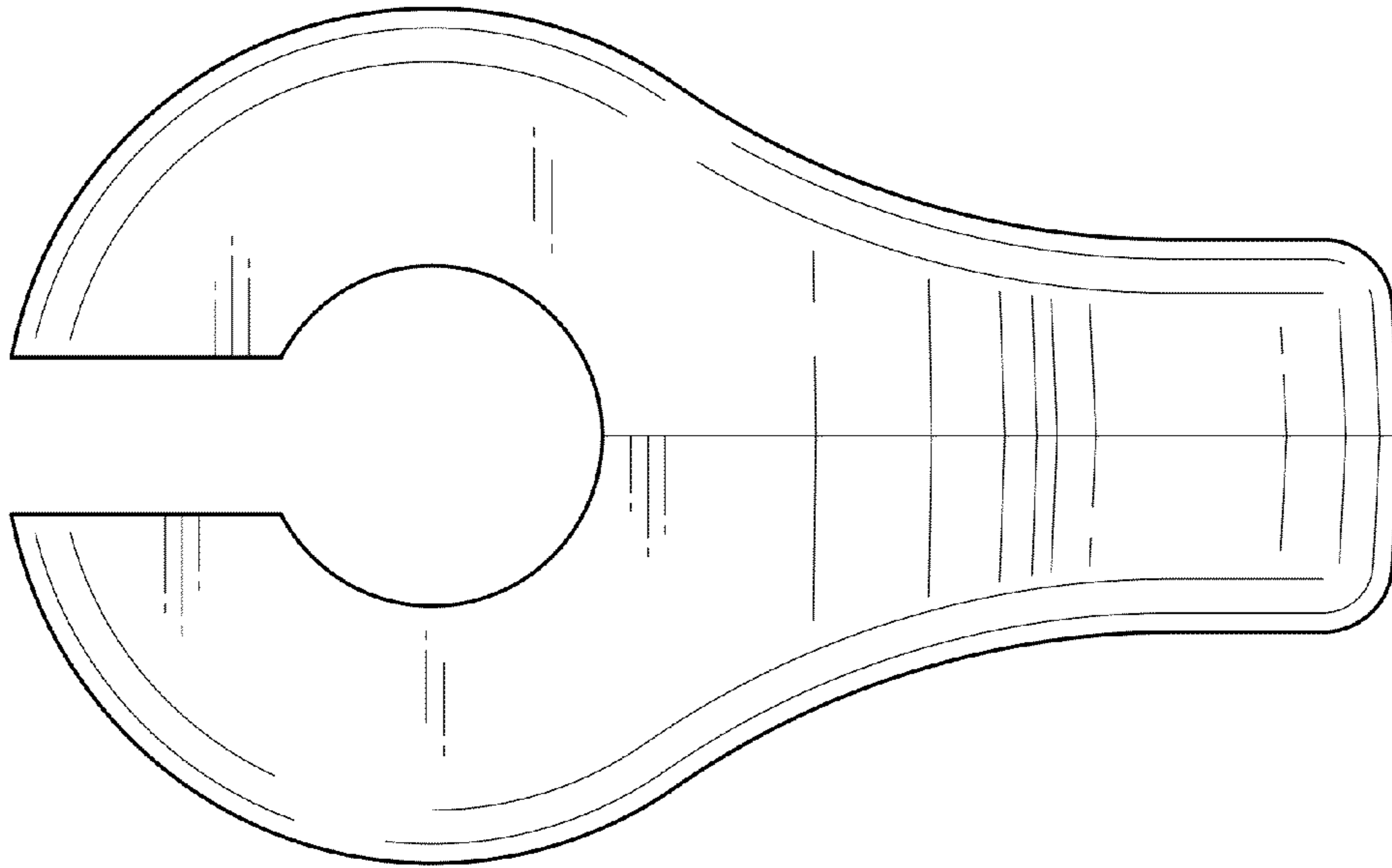
