The ornamental design for a personal service unit, as shown and described.

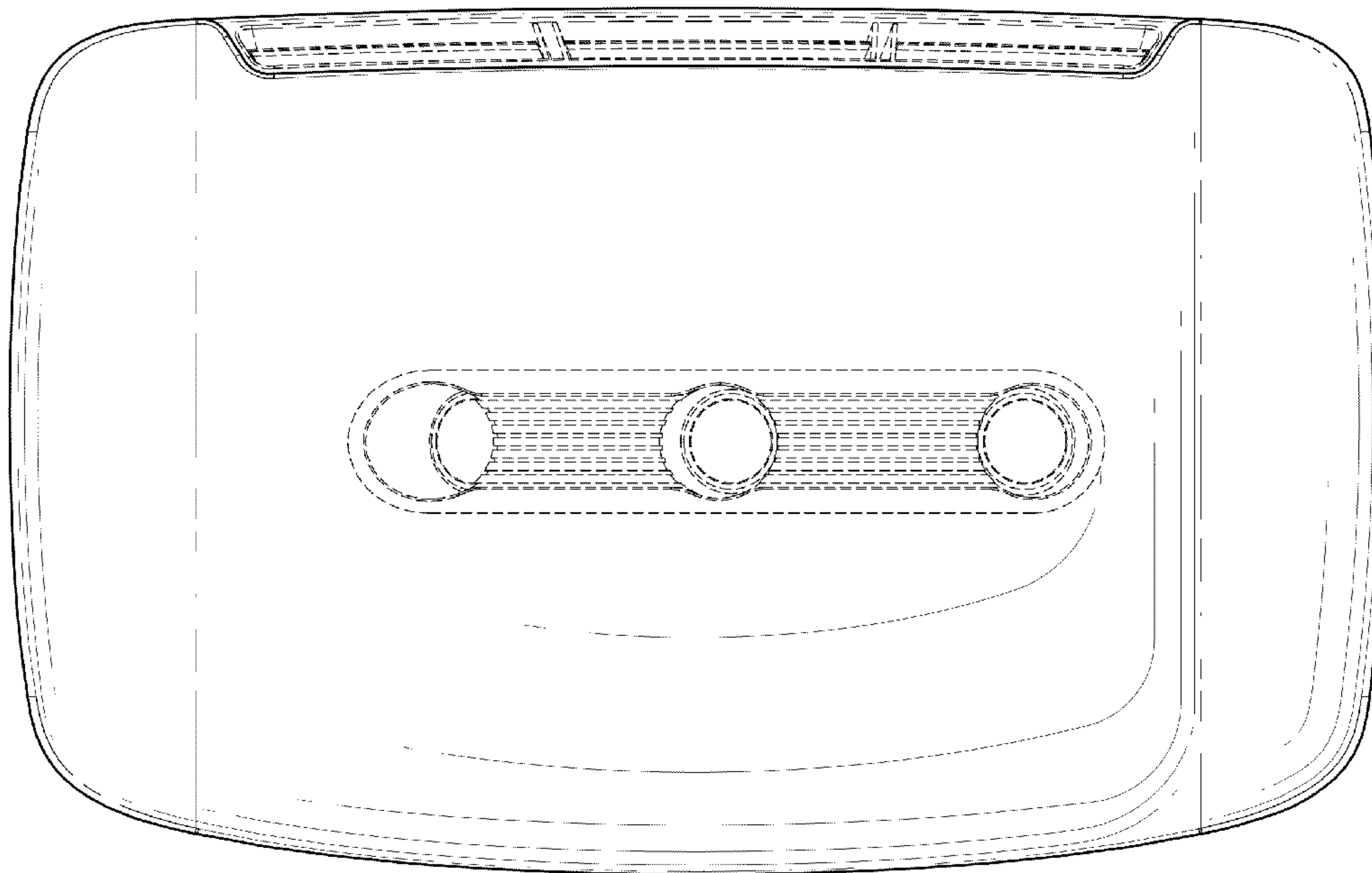
**DESCRIPTION**

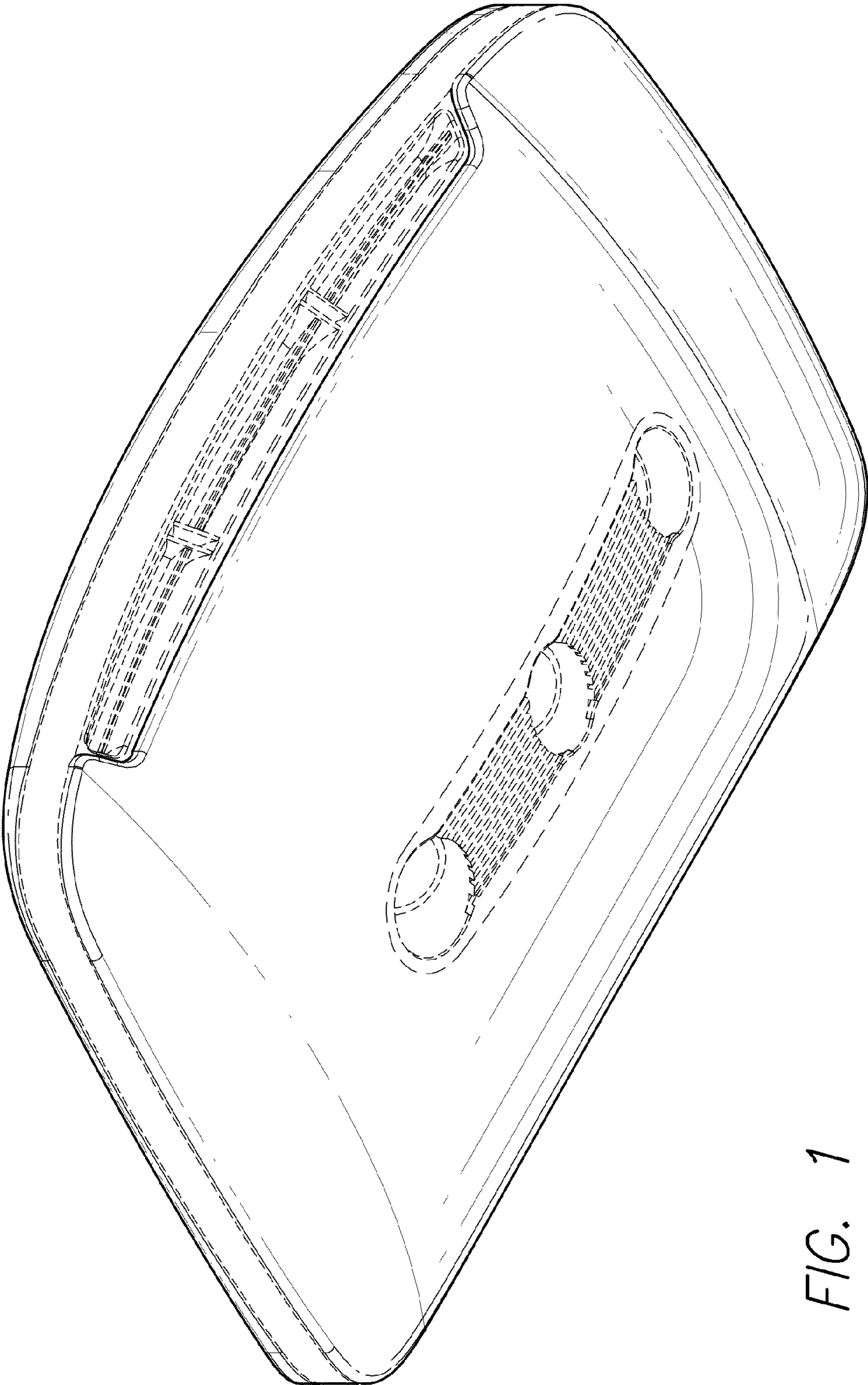

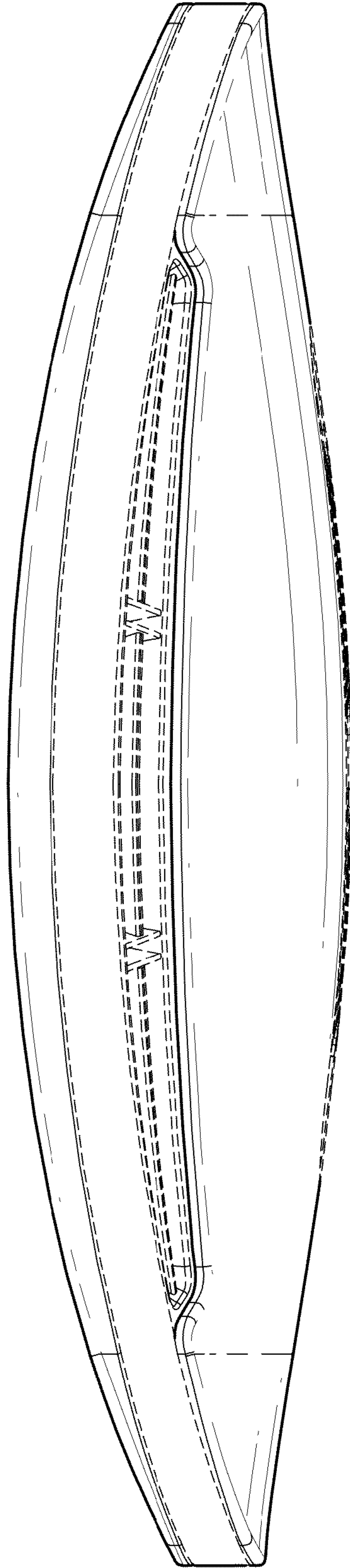

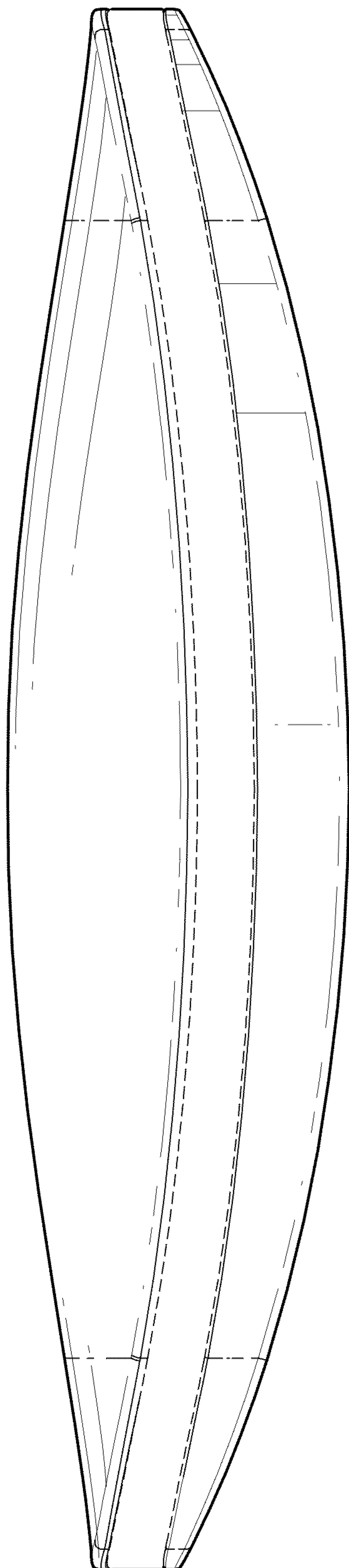

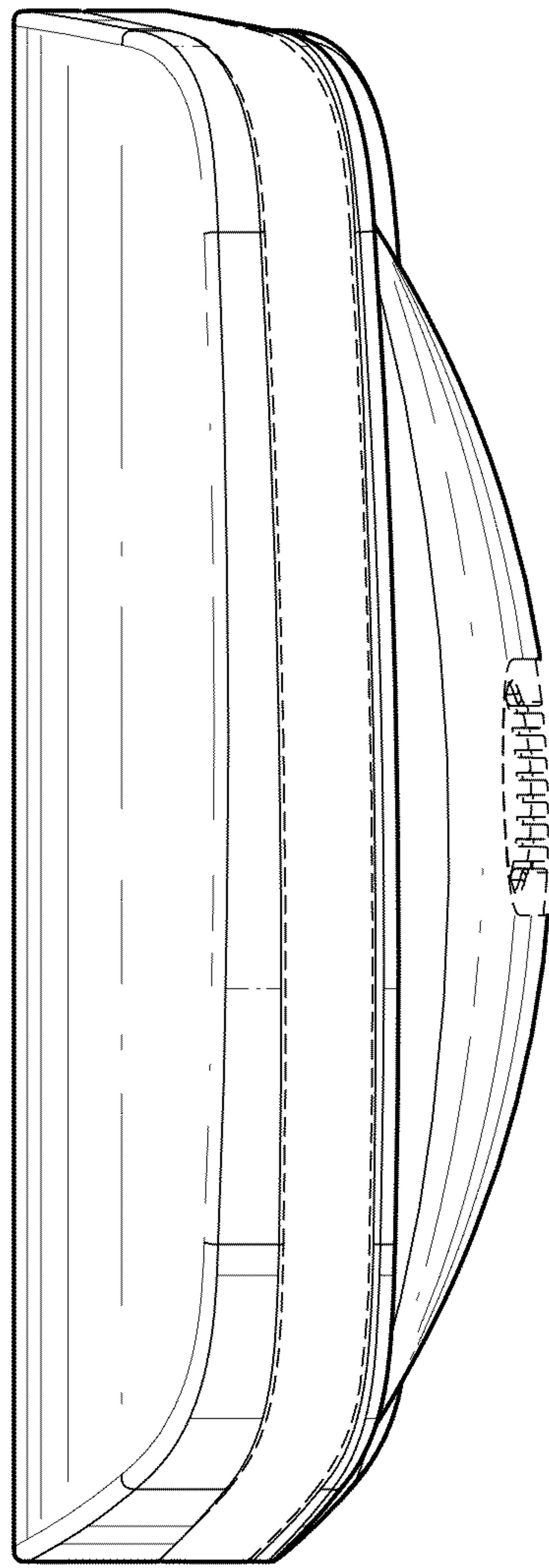

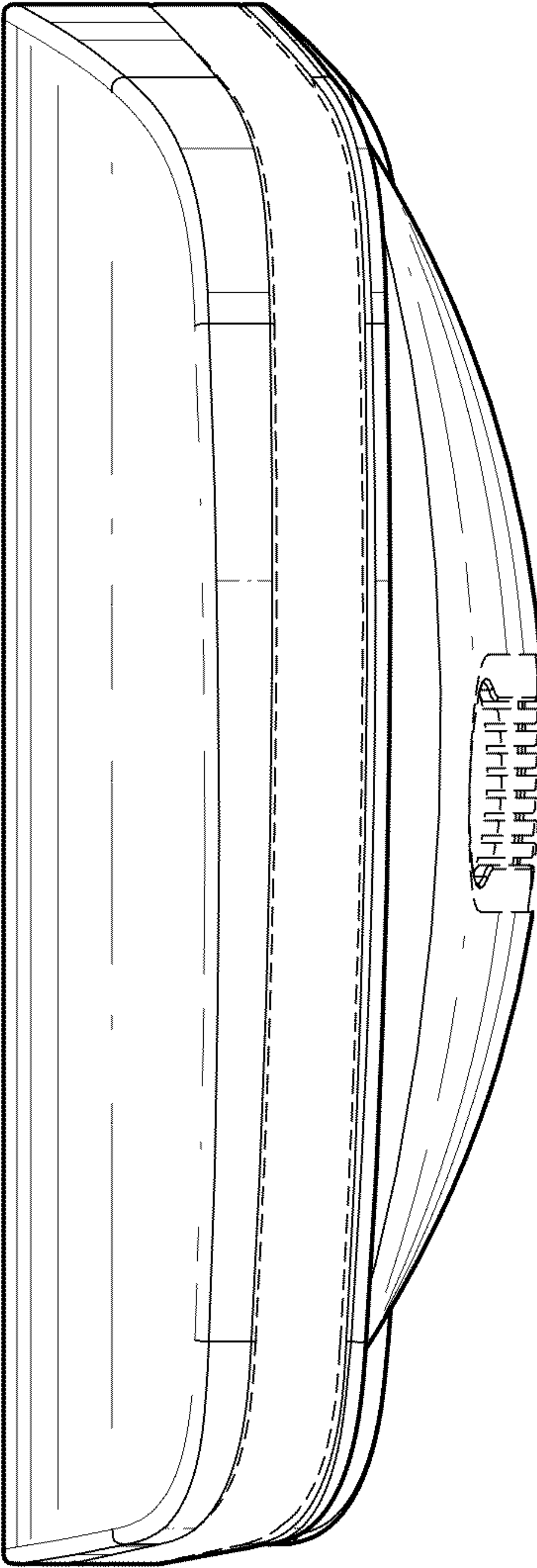

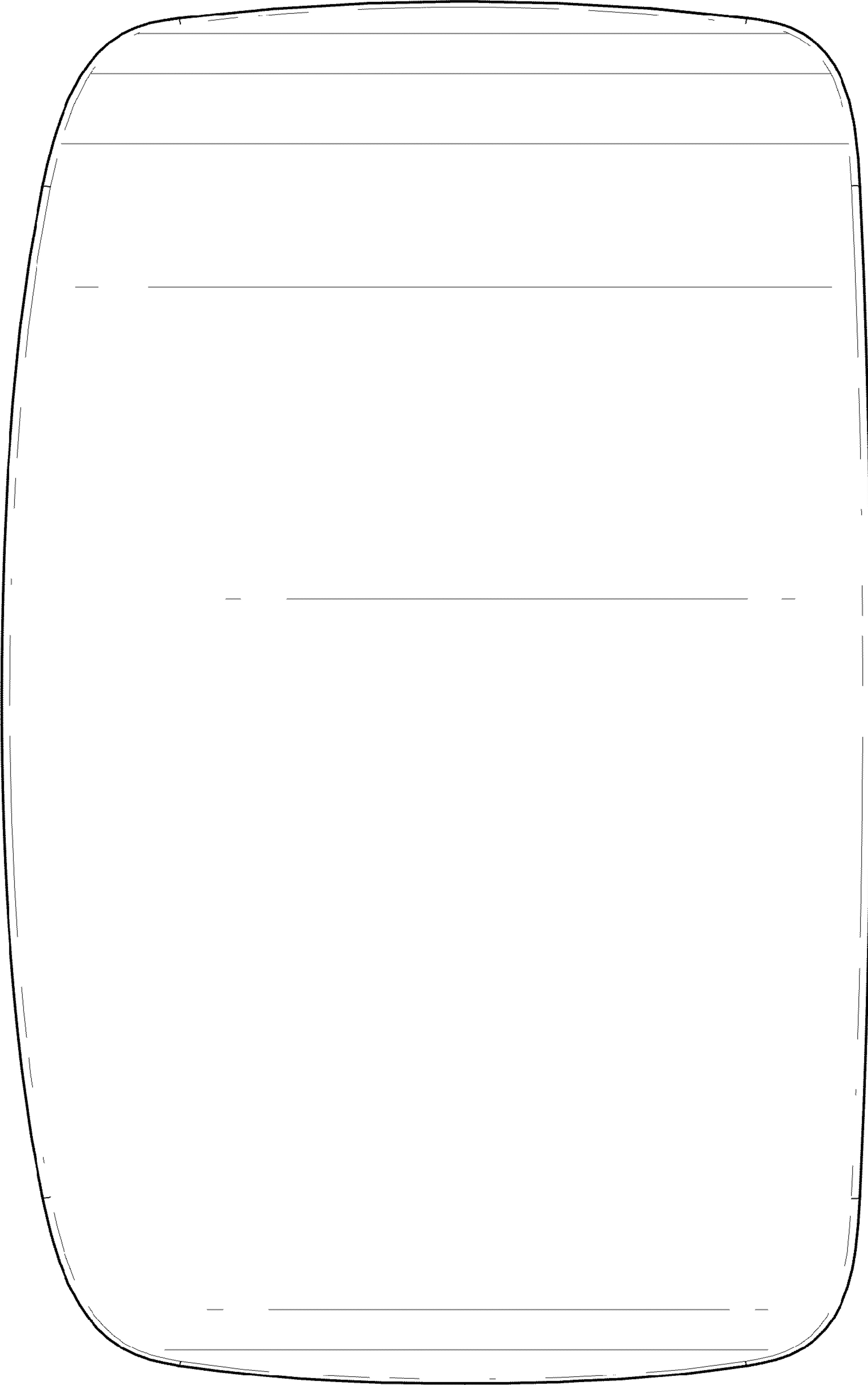

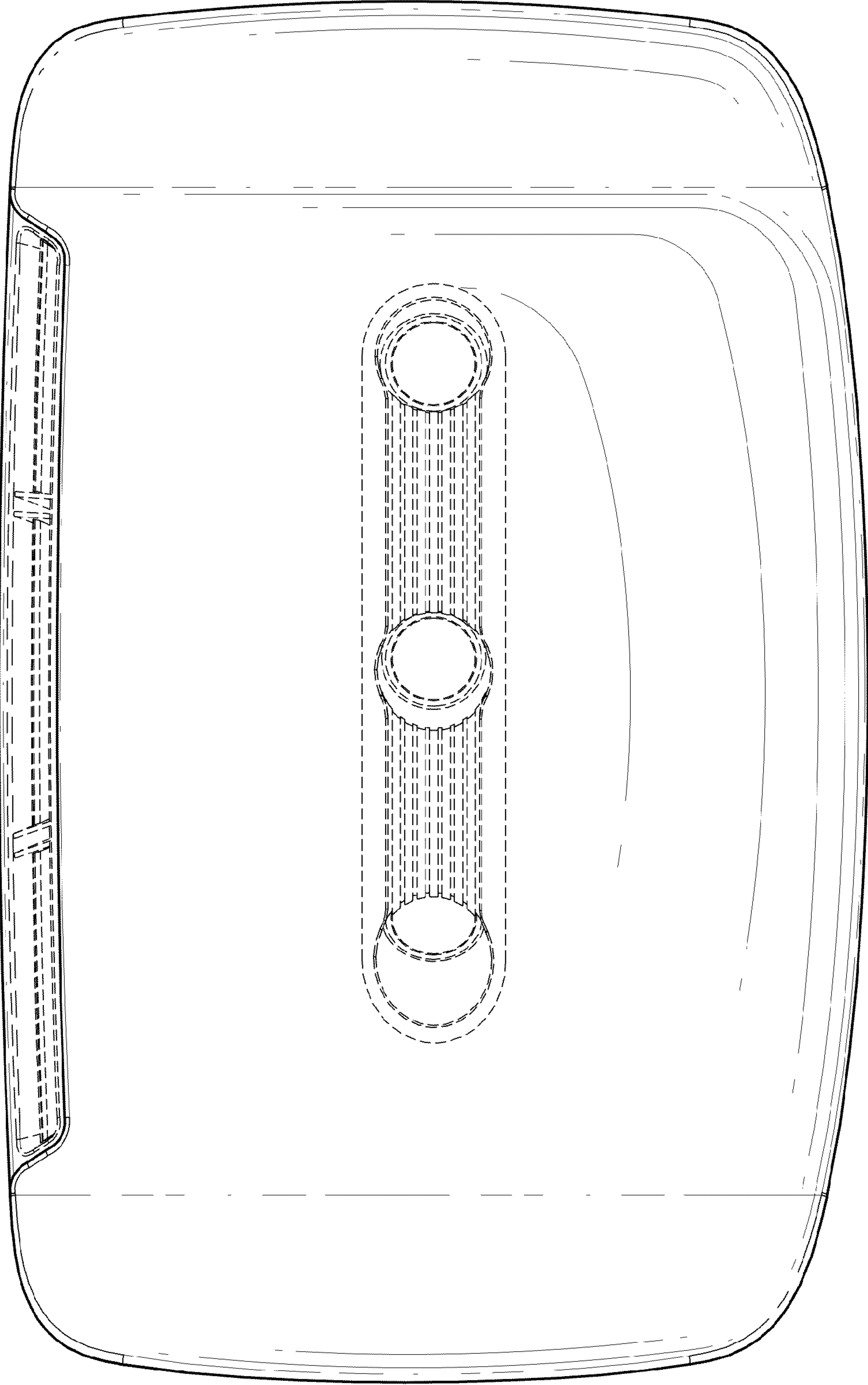
