(57) **CLAIM**

The ornamental design for a notebook computer, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a notebook computer; FIG. 2 is a front view of the notebook computer of FIG. 1; FIG. 3 is a rear view of the notebook computer of FIG. 1; FIG. 4 is a left-side view of the notebook computer of FIG. 1; FIG. 5 is a right-side view of the notebook computer of FIG. 1; FIG. 6 is a top plan view of the notebook computer of FIG. 1; FIG. 7 is a bottom plan view of the notebook computer of FIG. 1; FIG. 8 is an open perspective view of the notebook computer of FIG. 1; and, FIG. 9 is a partial enlarged view of FIG. 8 that is included to more clearly depict the design feature on the top of the bottom portion of the notebook computer, as viewed from the open perspective view (a-a', b-b', c-c', d-d') of FIG. 8. Features shown in broken lines in FIGS. 1, 2, 4, 5, 7, and 8, form no part of the claimed design.

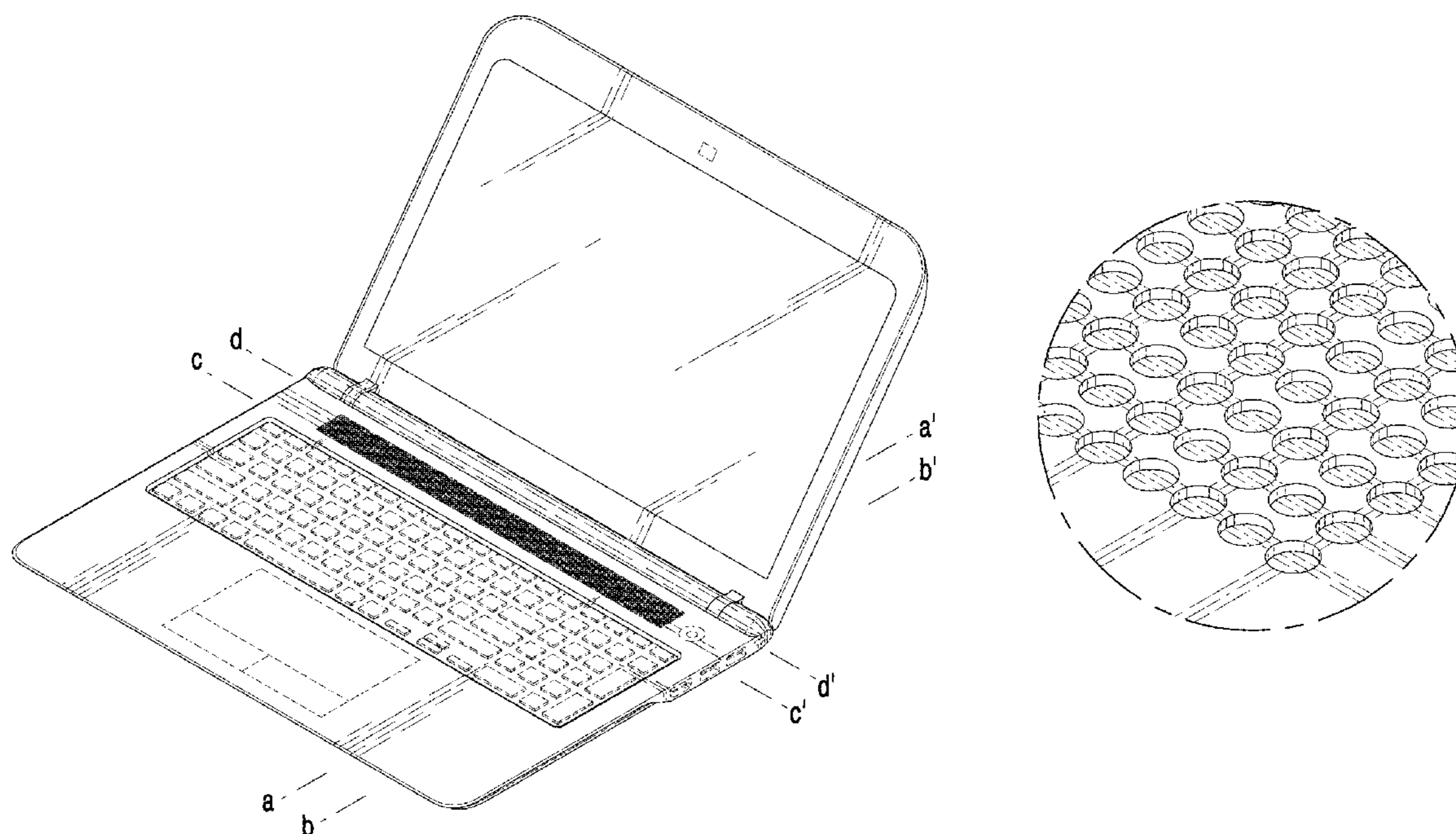

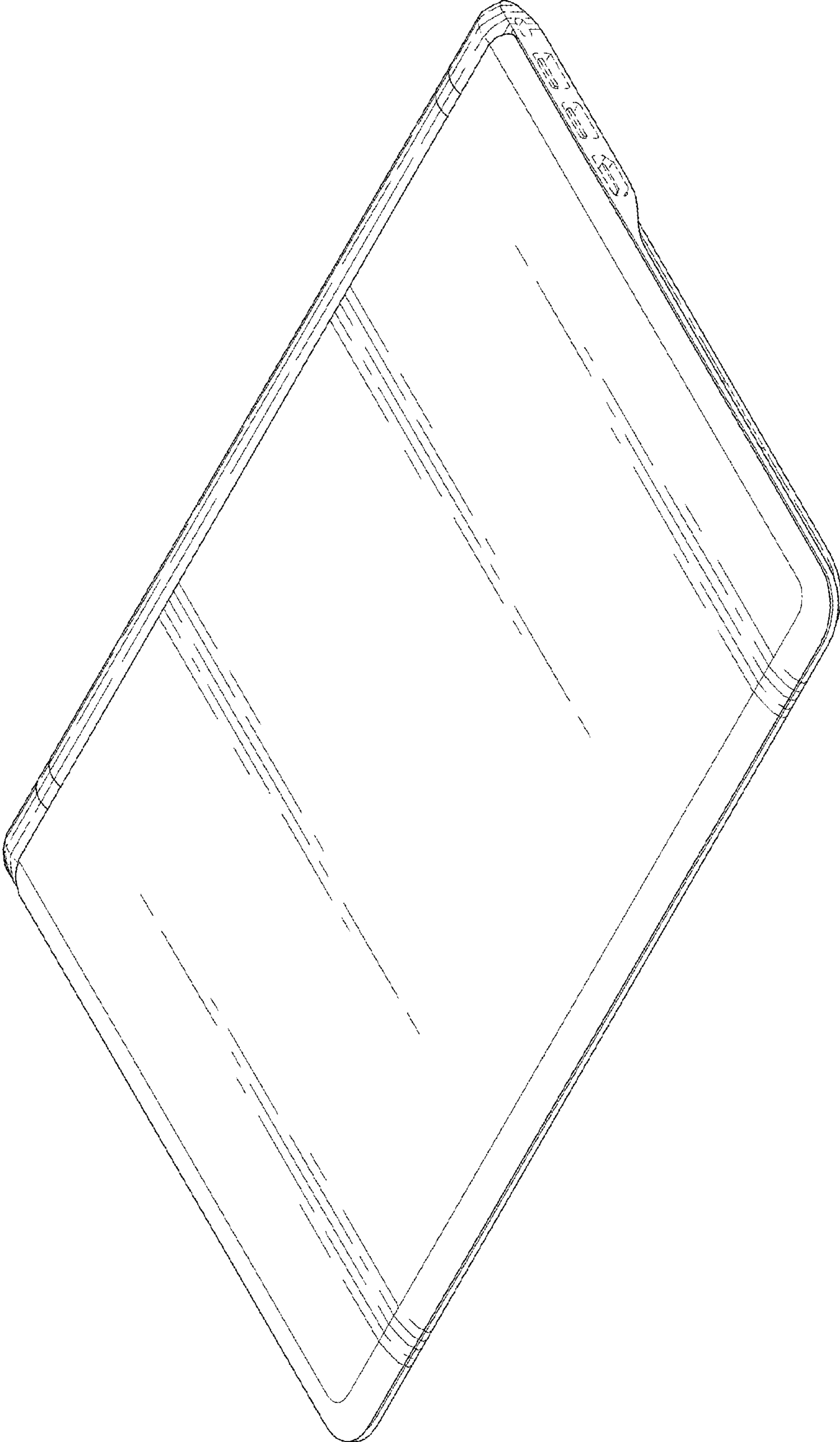

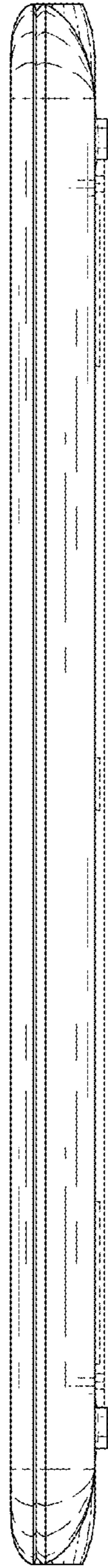

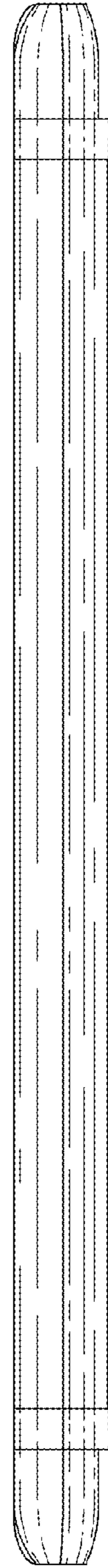

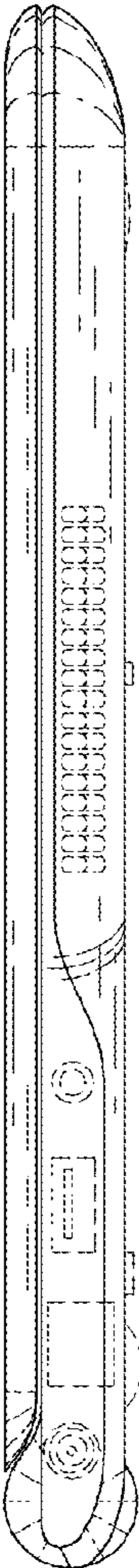

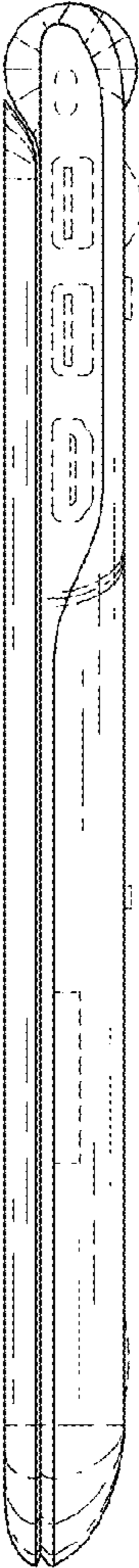

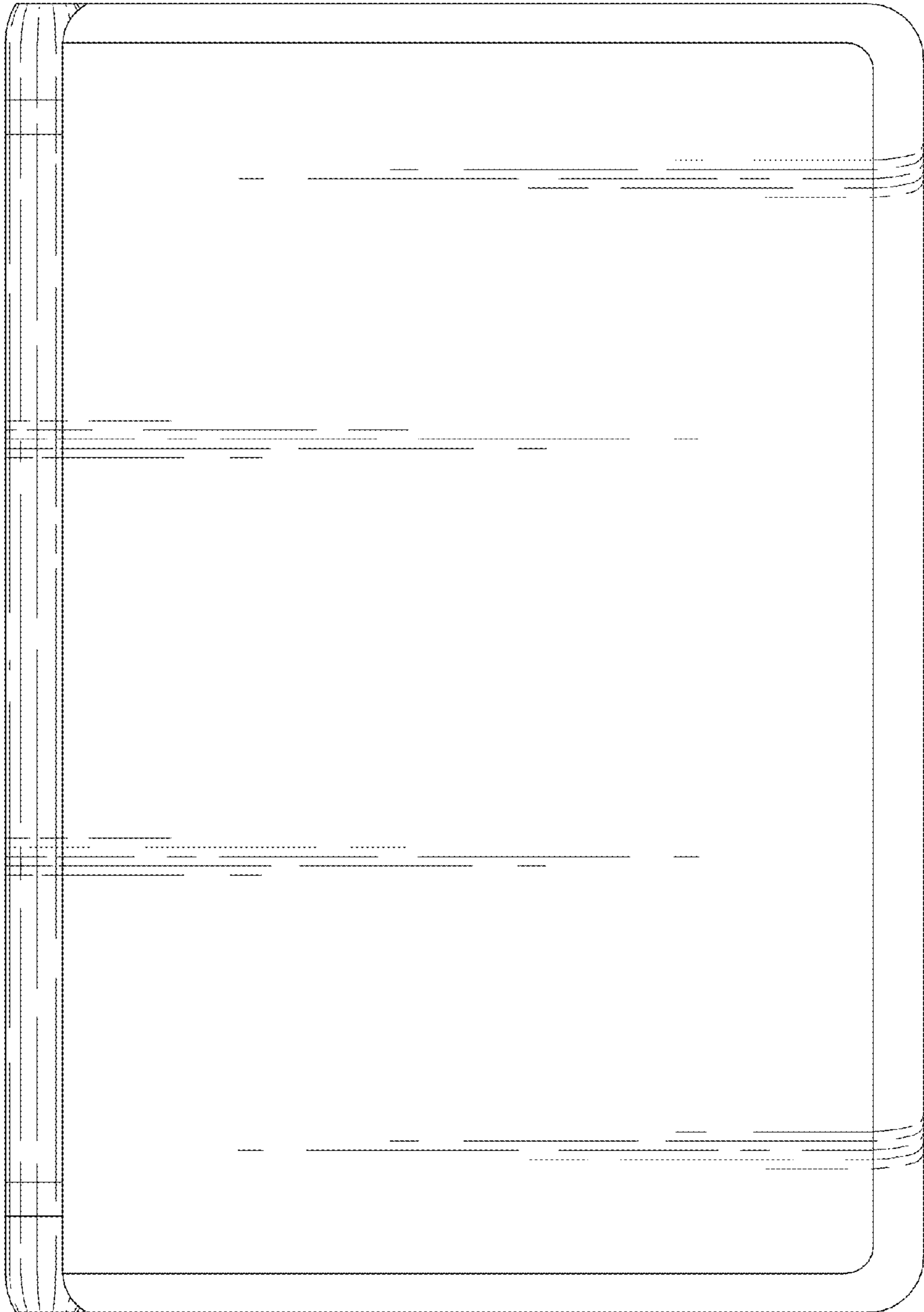

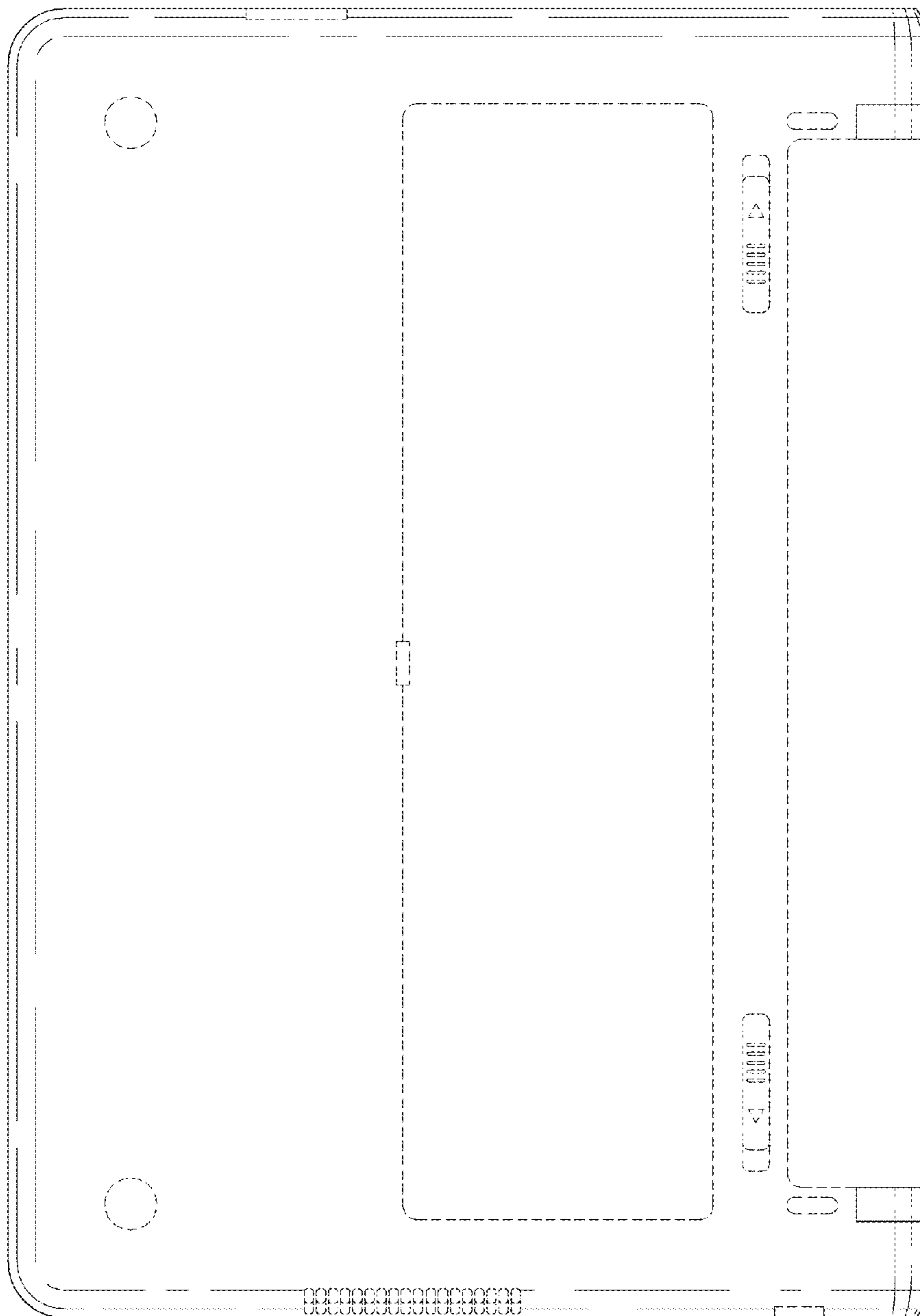

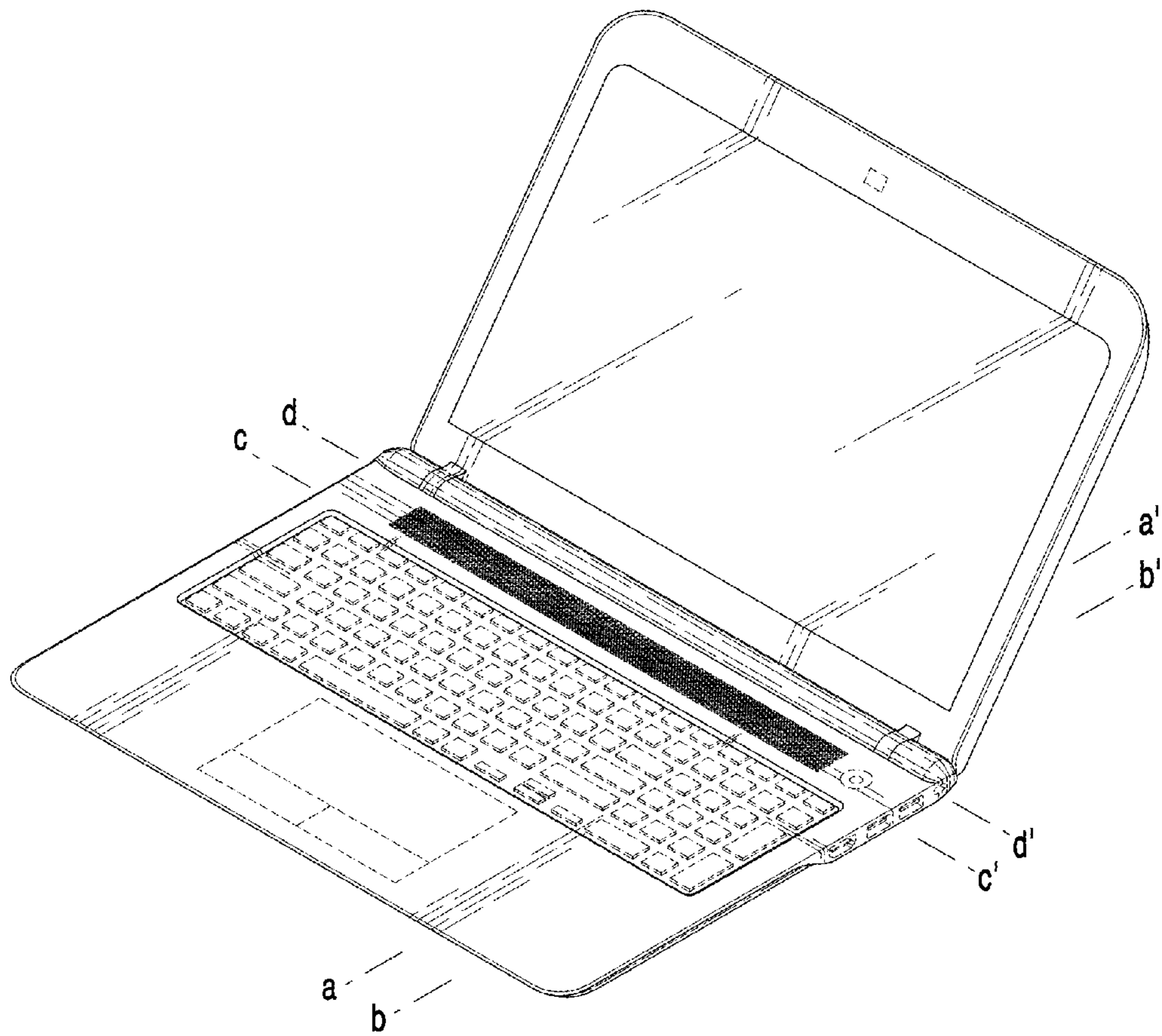
