DESCRIPTION

FIG. 1 is a right side elevational view of a percussion drill showing our new design;

FIG. 2 is a perspective view showing the design for the percussion drill of FIG. 1;

FIG. 3 is another right side elevational view showing the design for the percussion drill of FIG. 1;

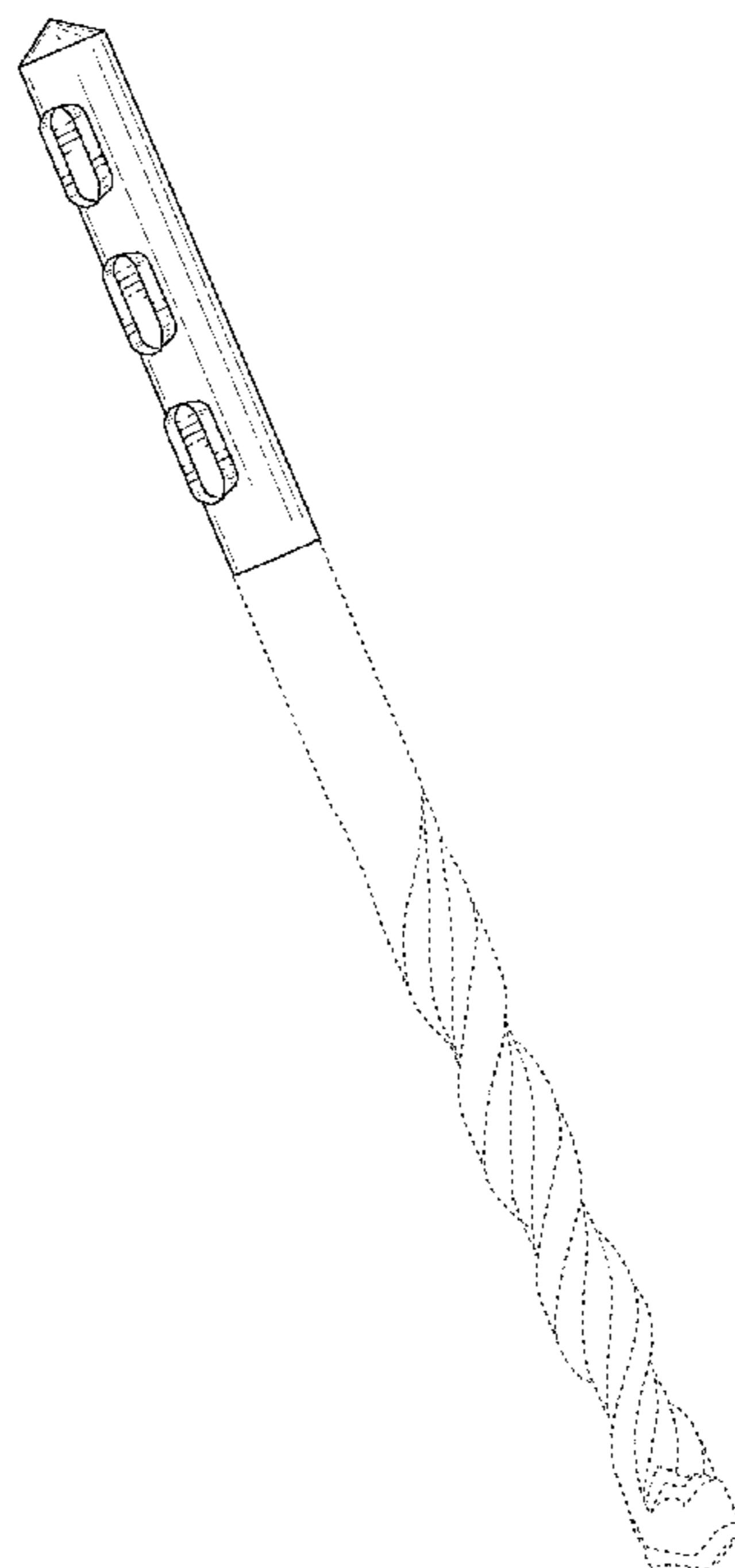
FIG. 4 is a front elevational view showing the design for the percussion drill of FIG. 1;

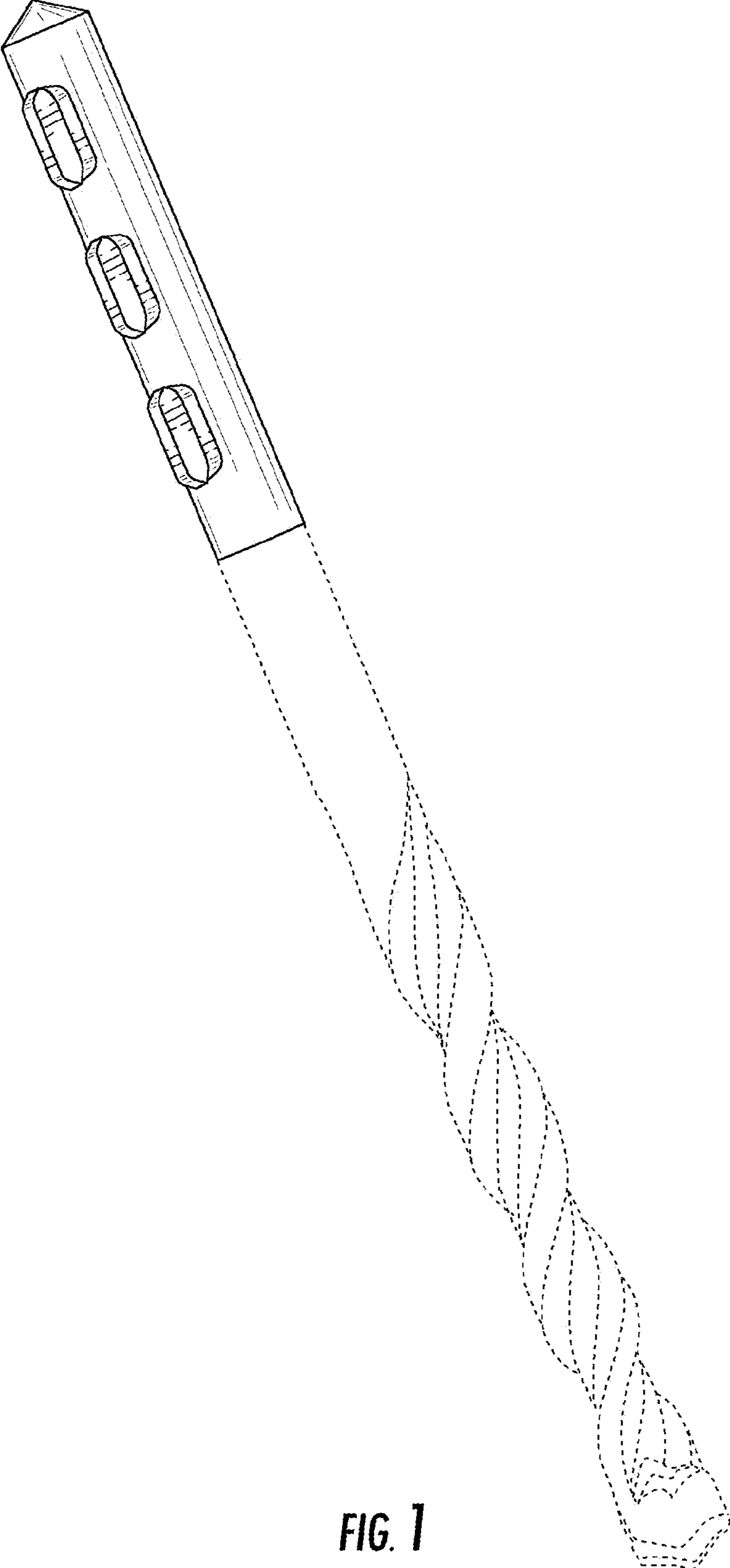

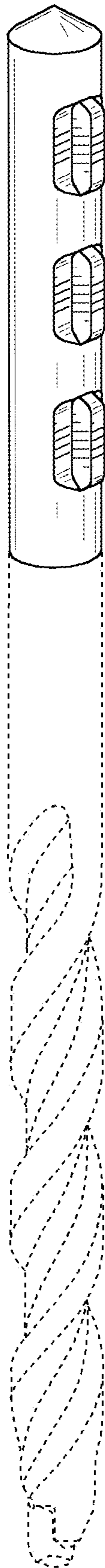

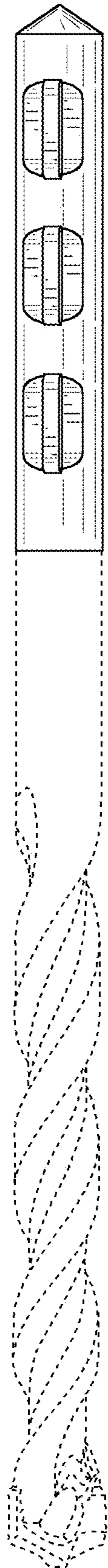

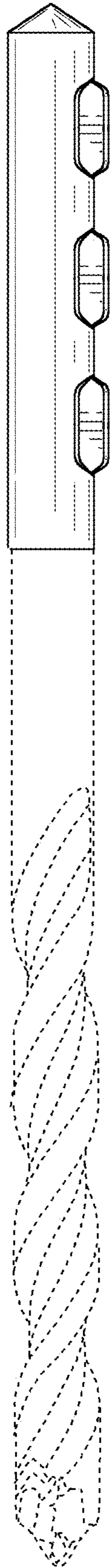

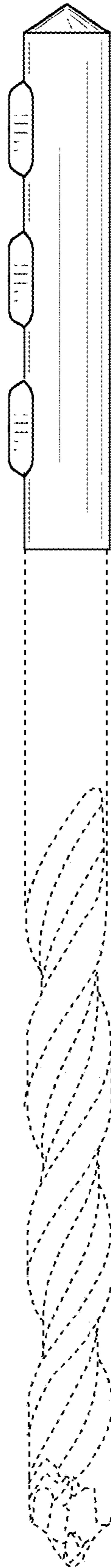

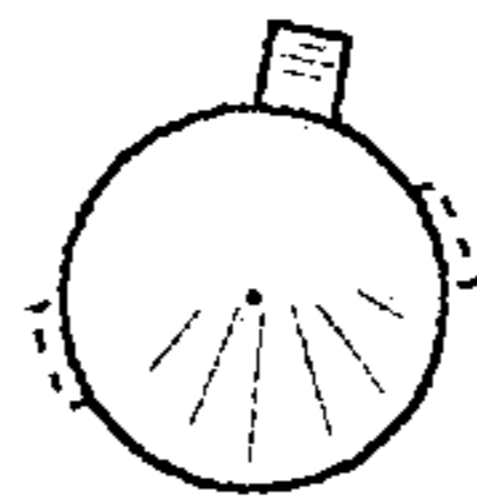
