DESCRIPTION

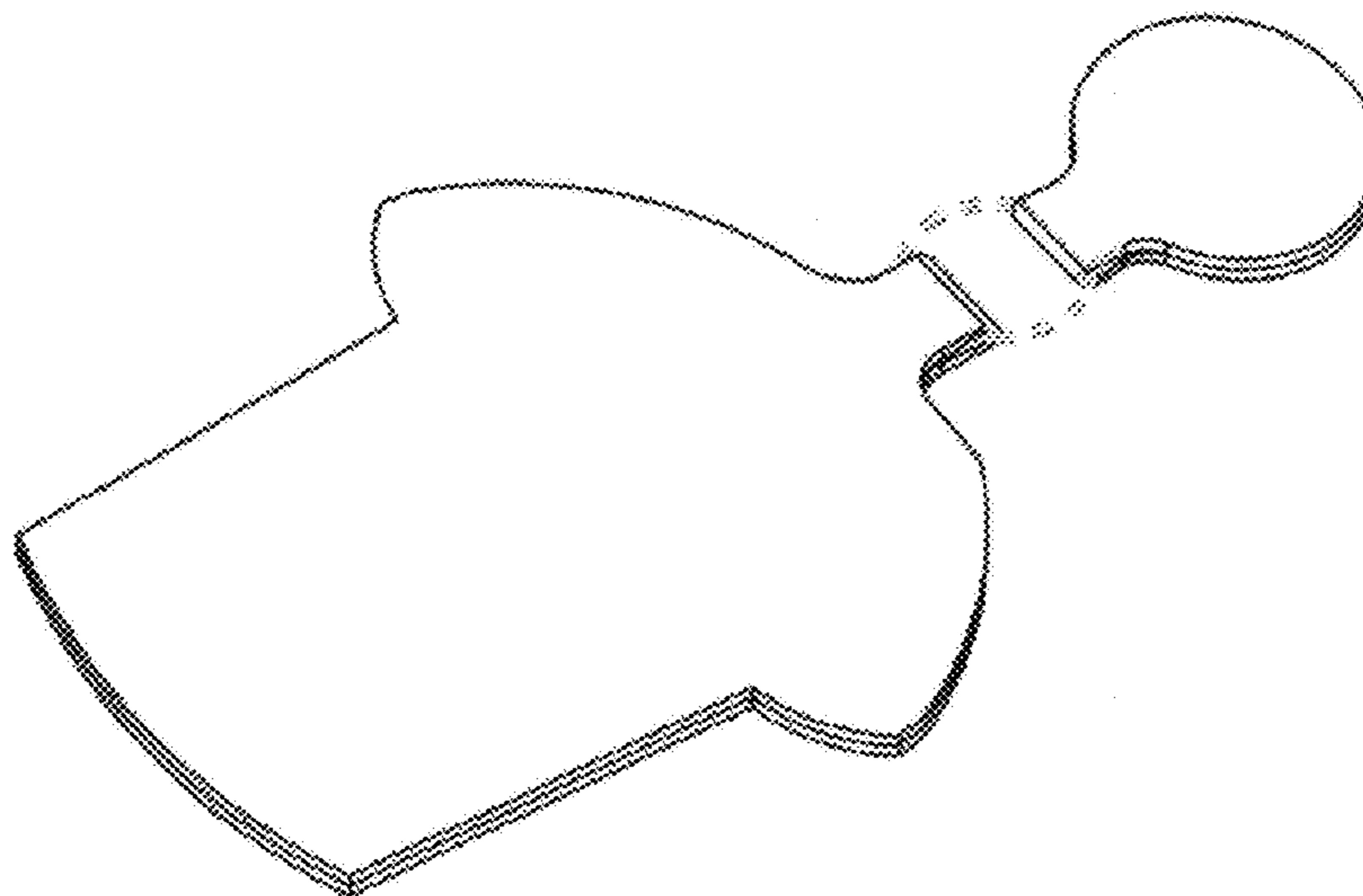

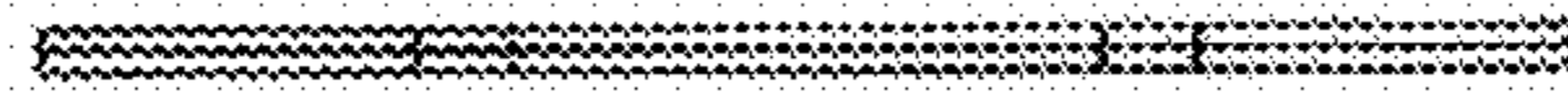

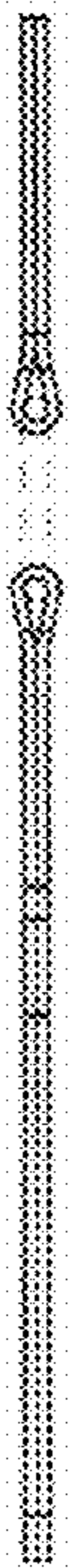

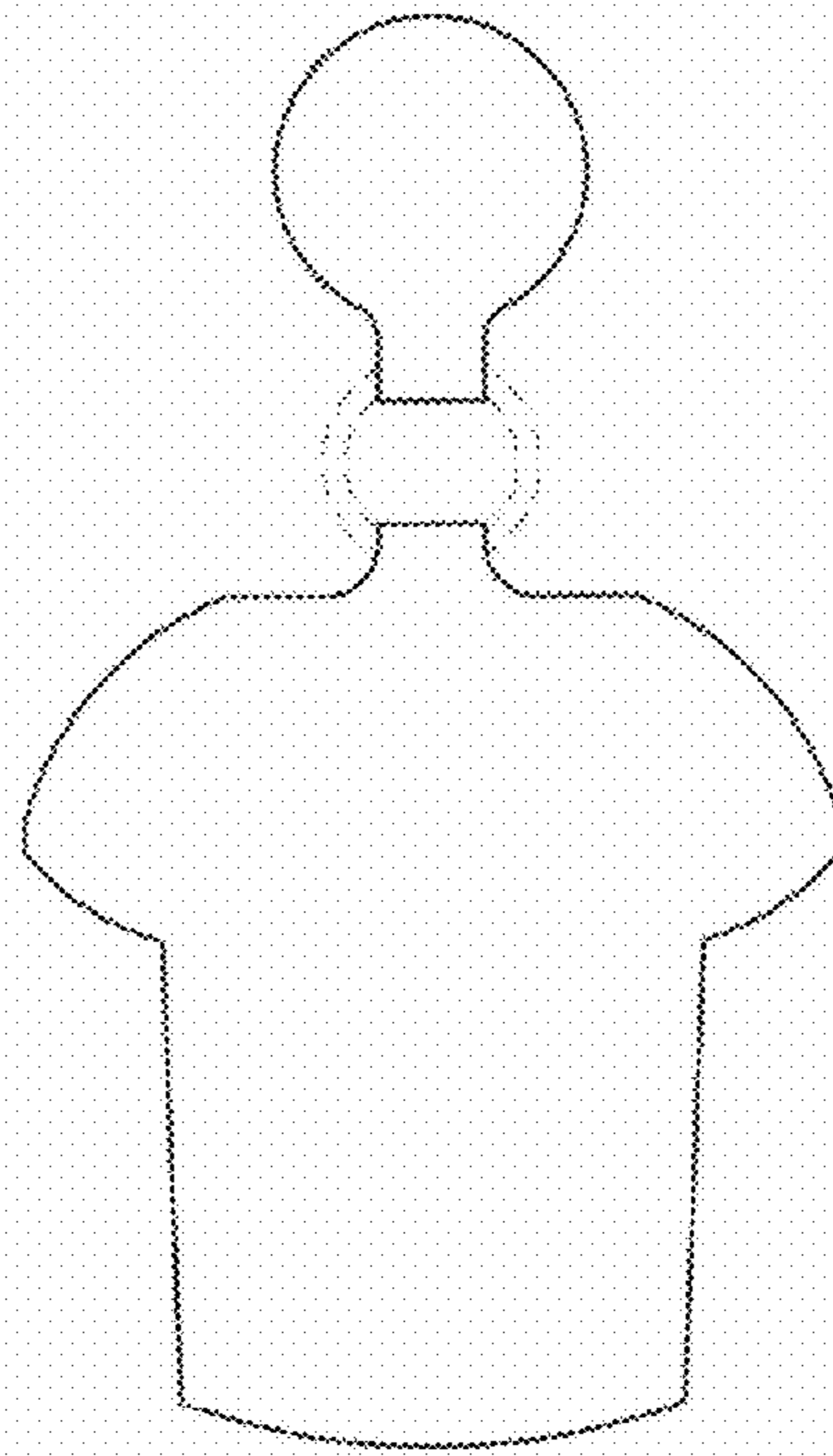

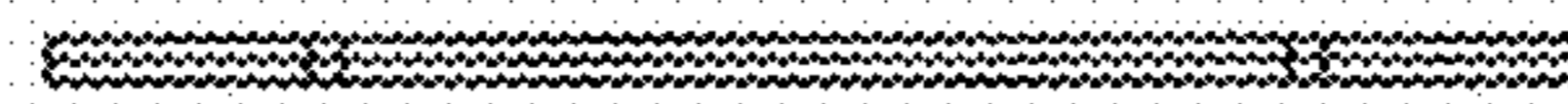

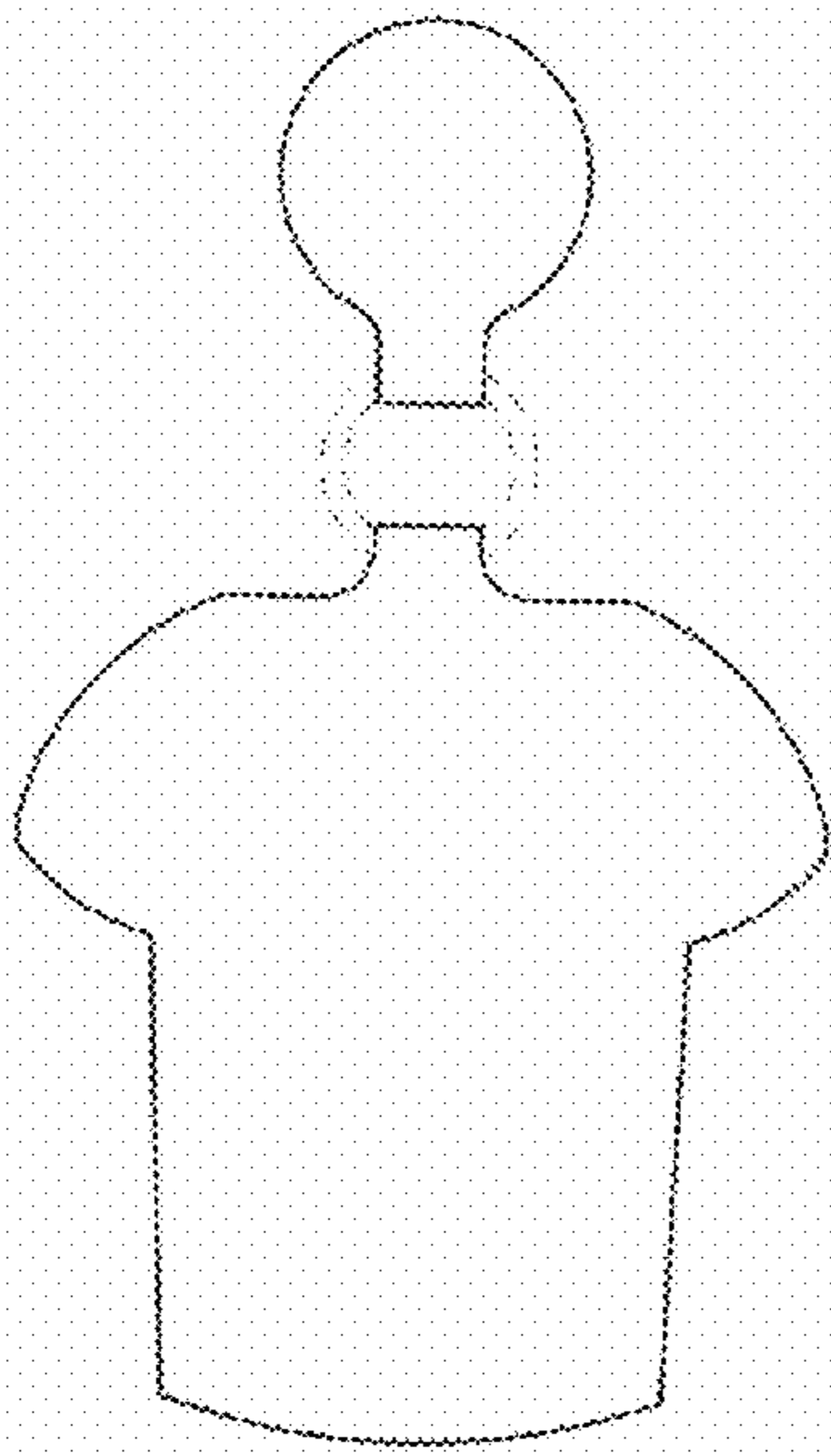

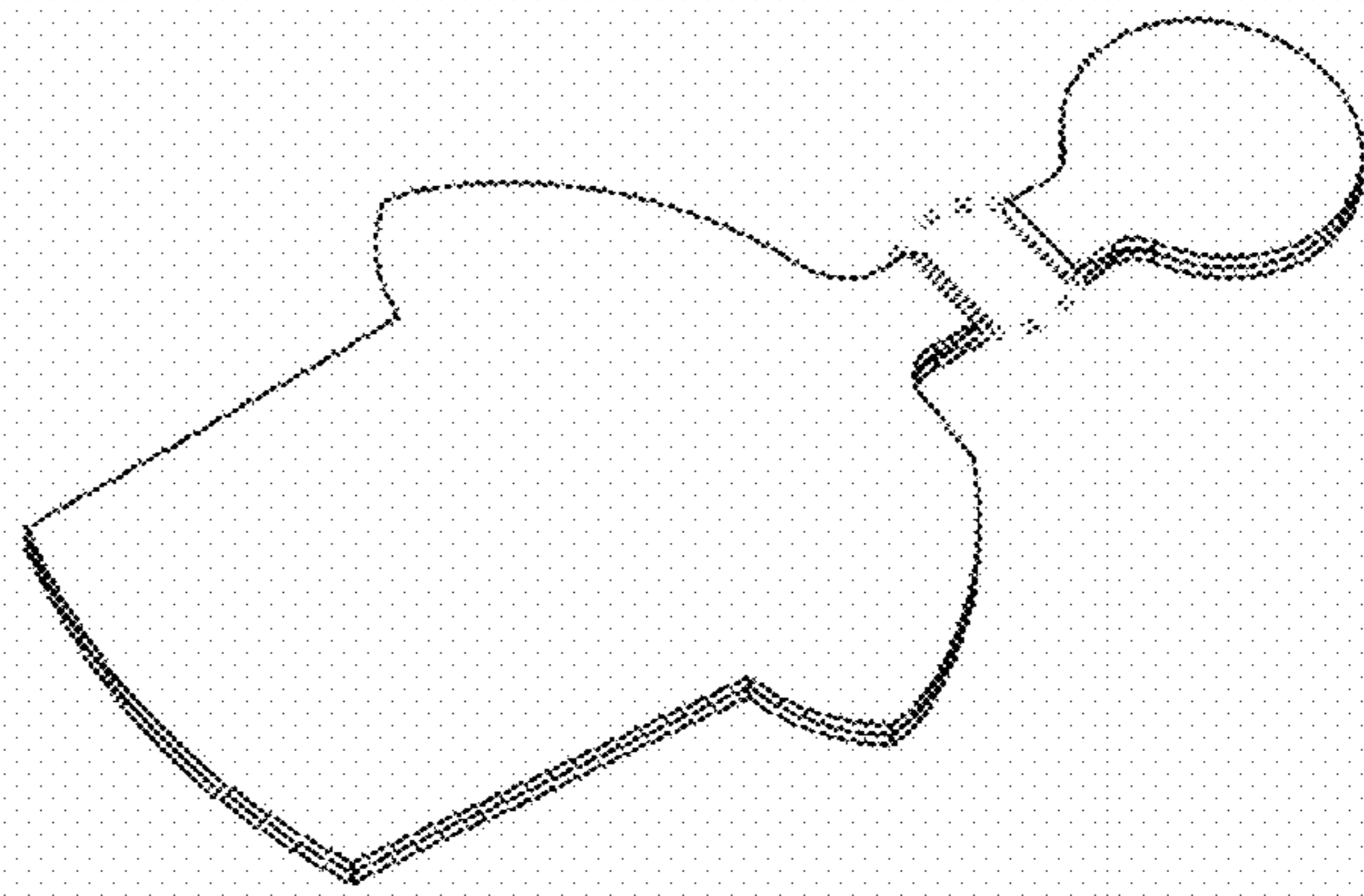
