The ornamental design for an electronic cigarette case, as shown and described.

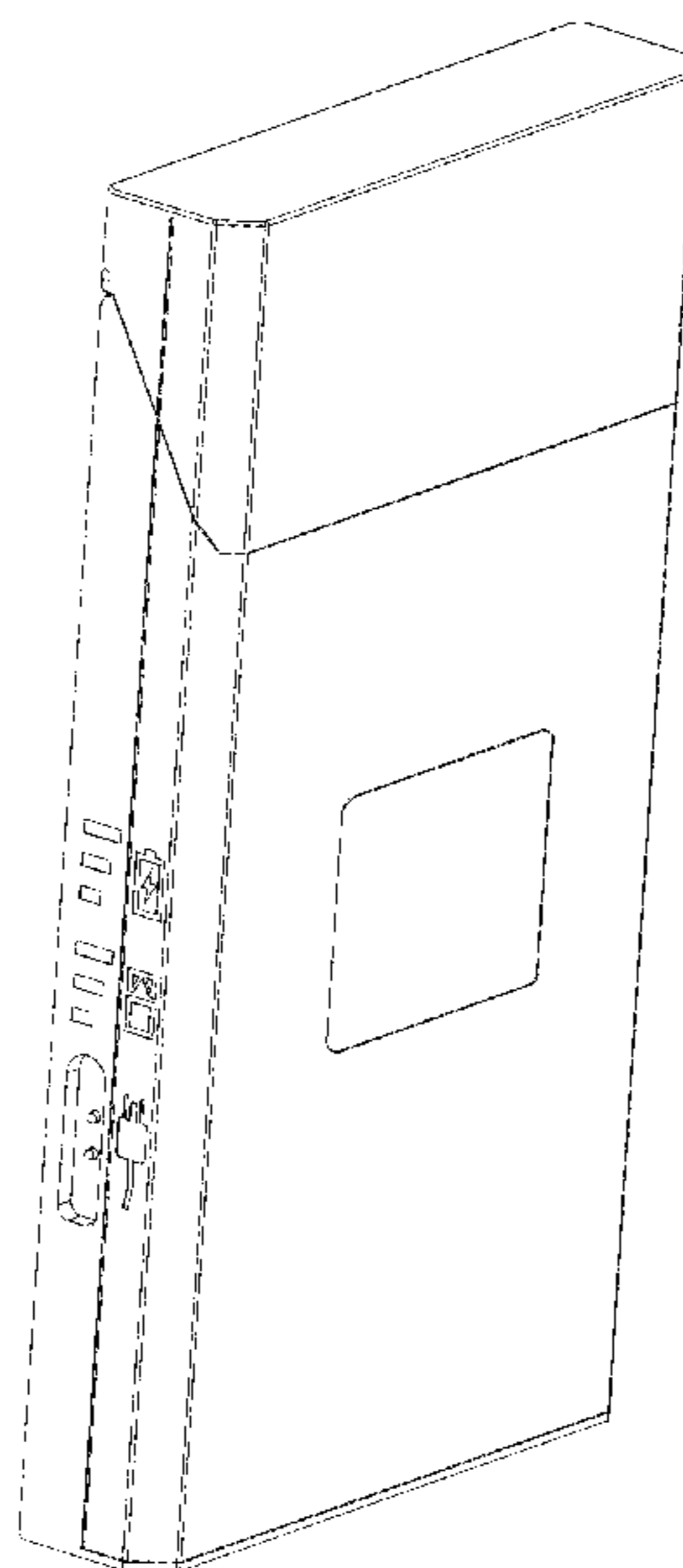
**DESCRIPTION**

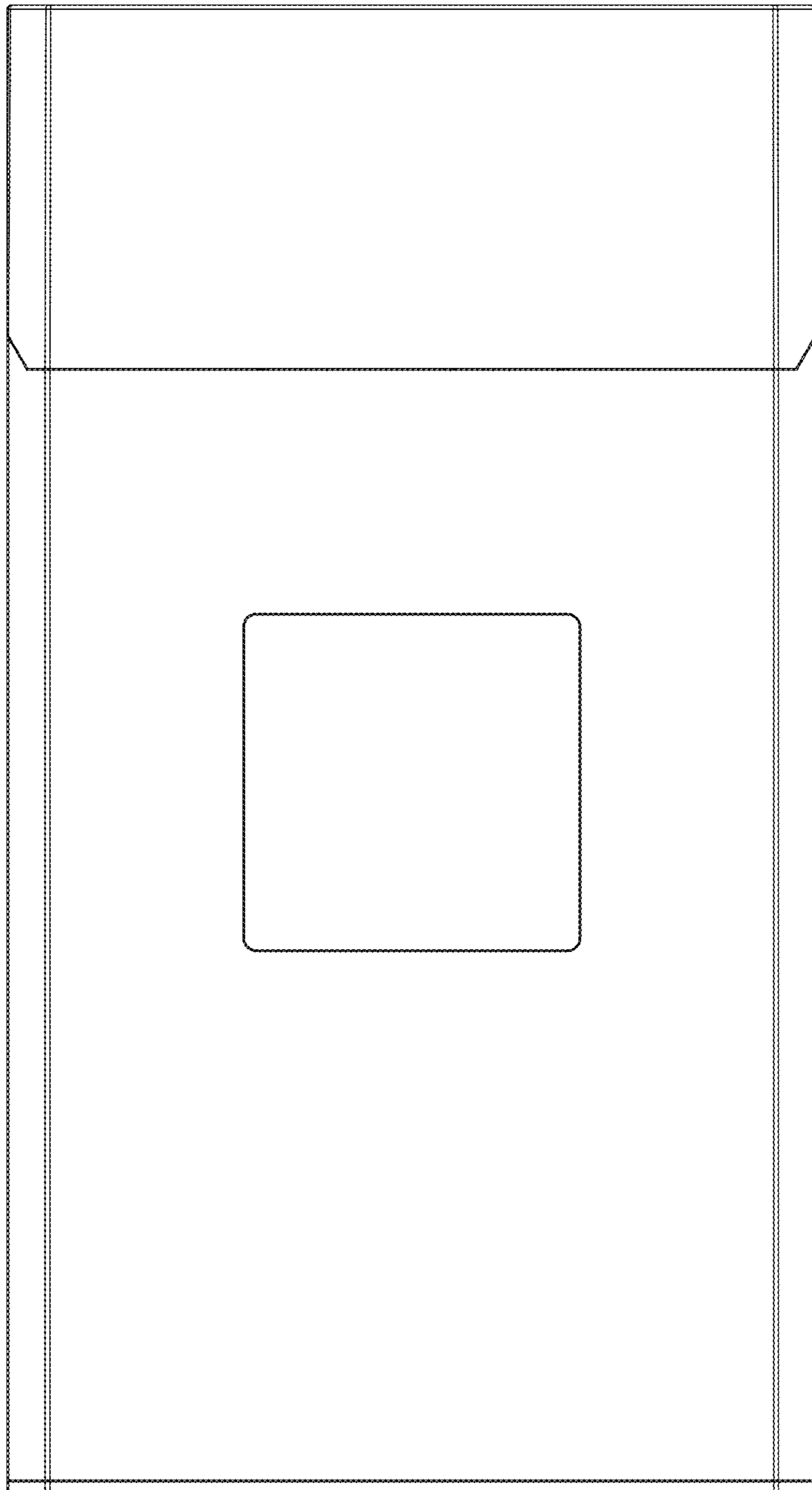

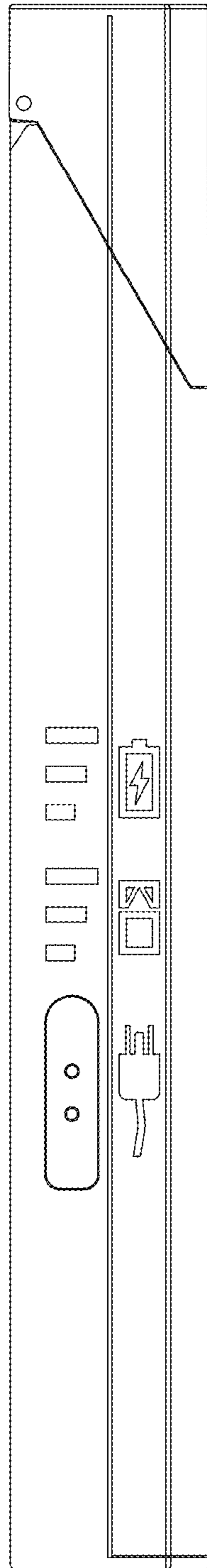

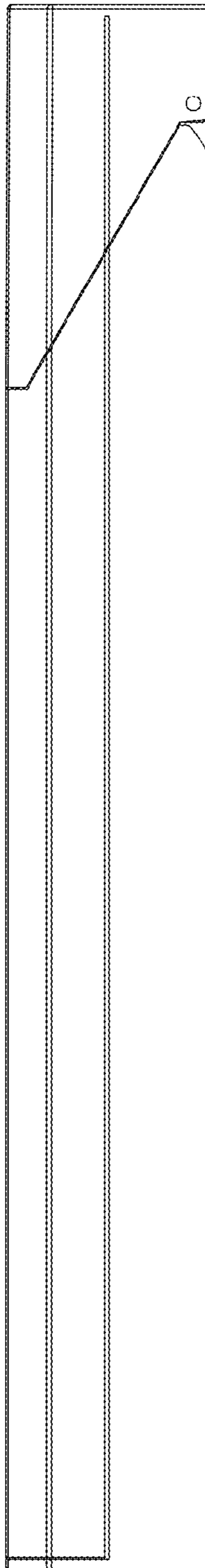

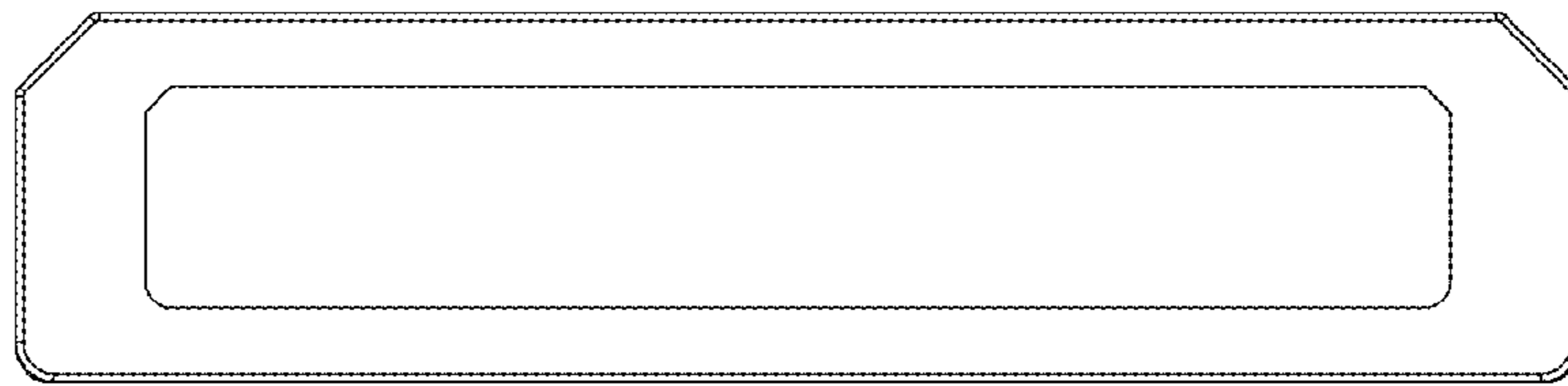

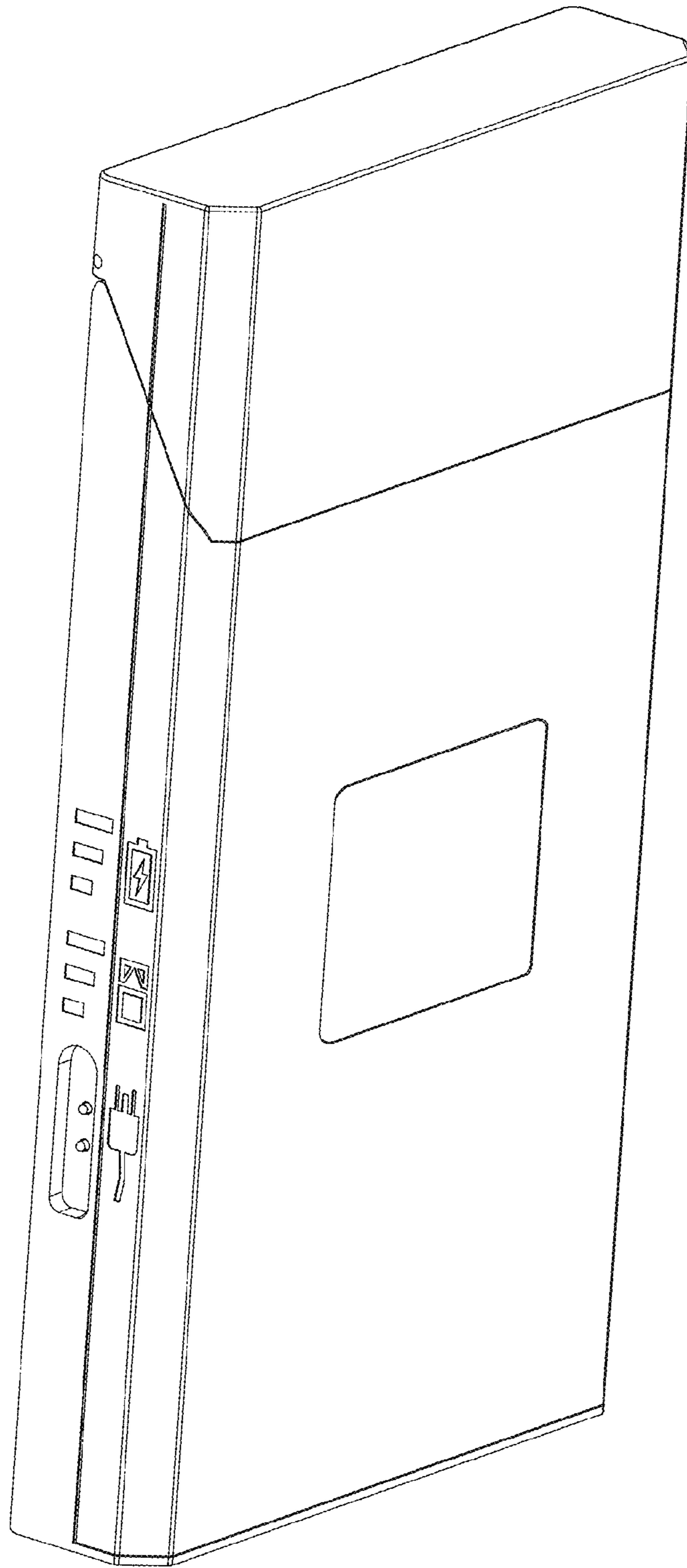

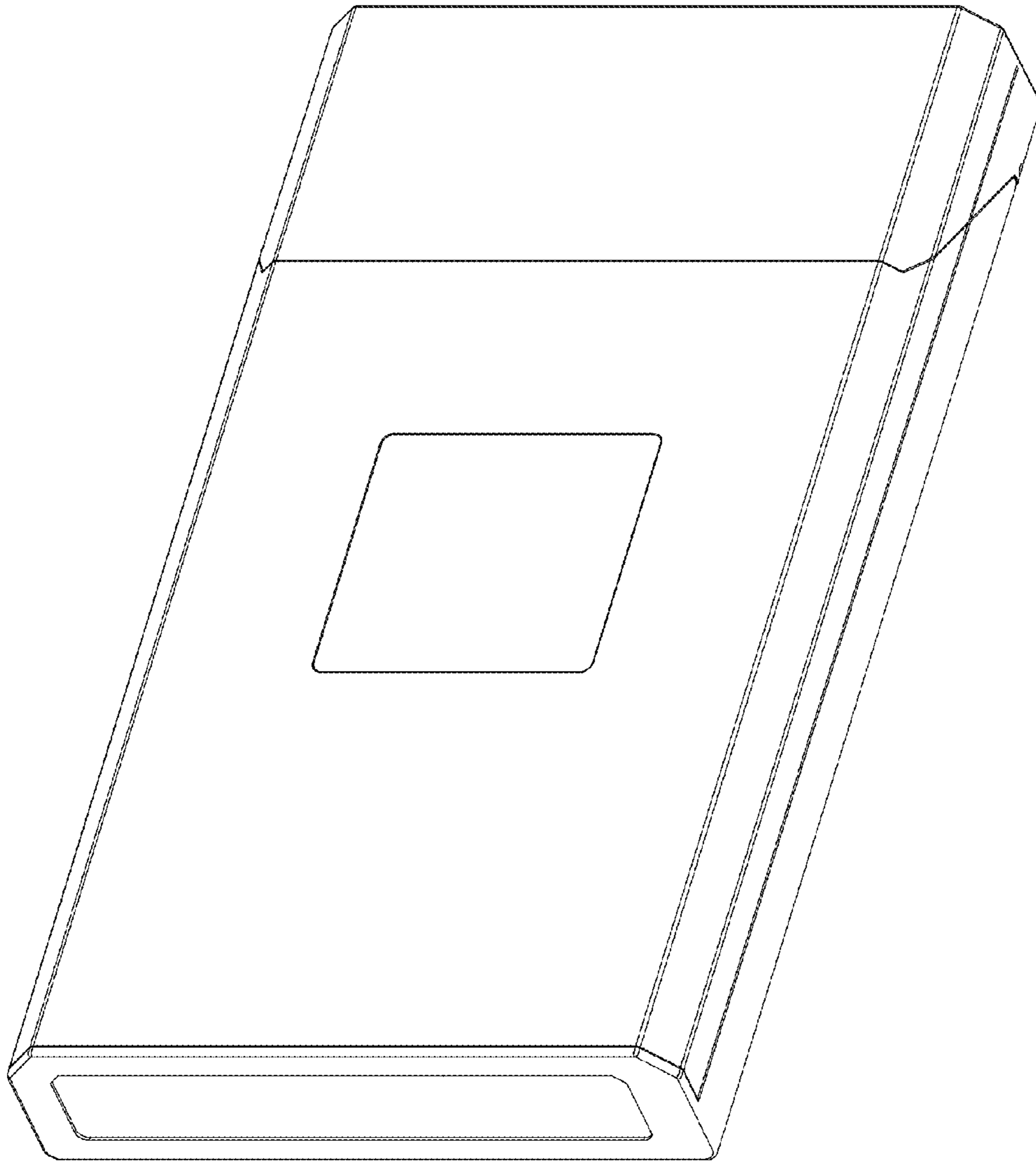
