FIG. 4 is a left-side view view thereof;

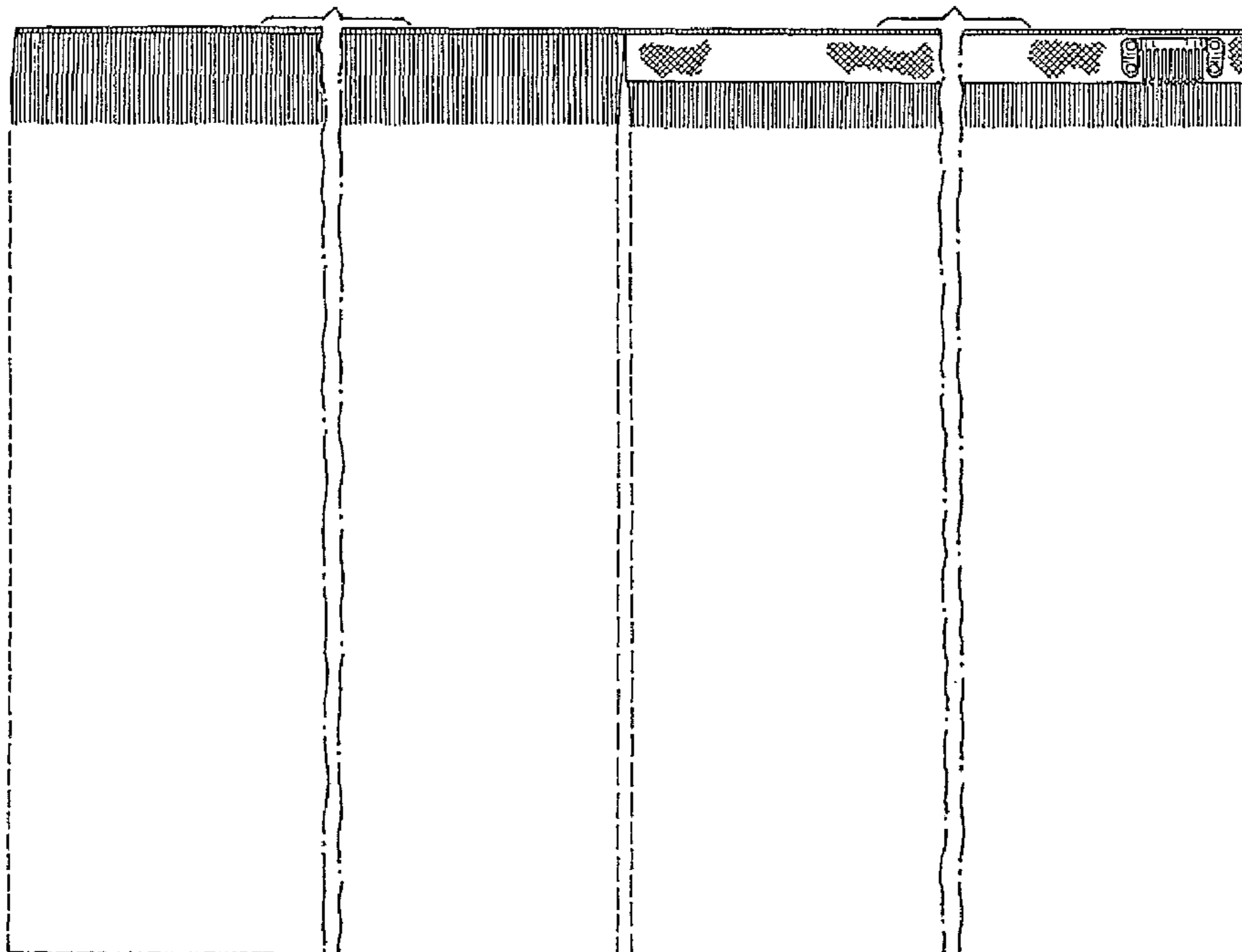
FIG. 5 is a rear-view thereof; and,

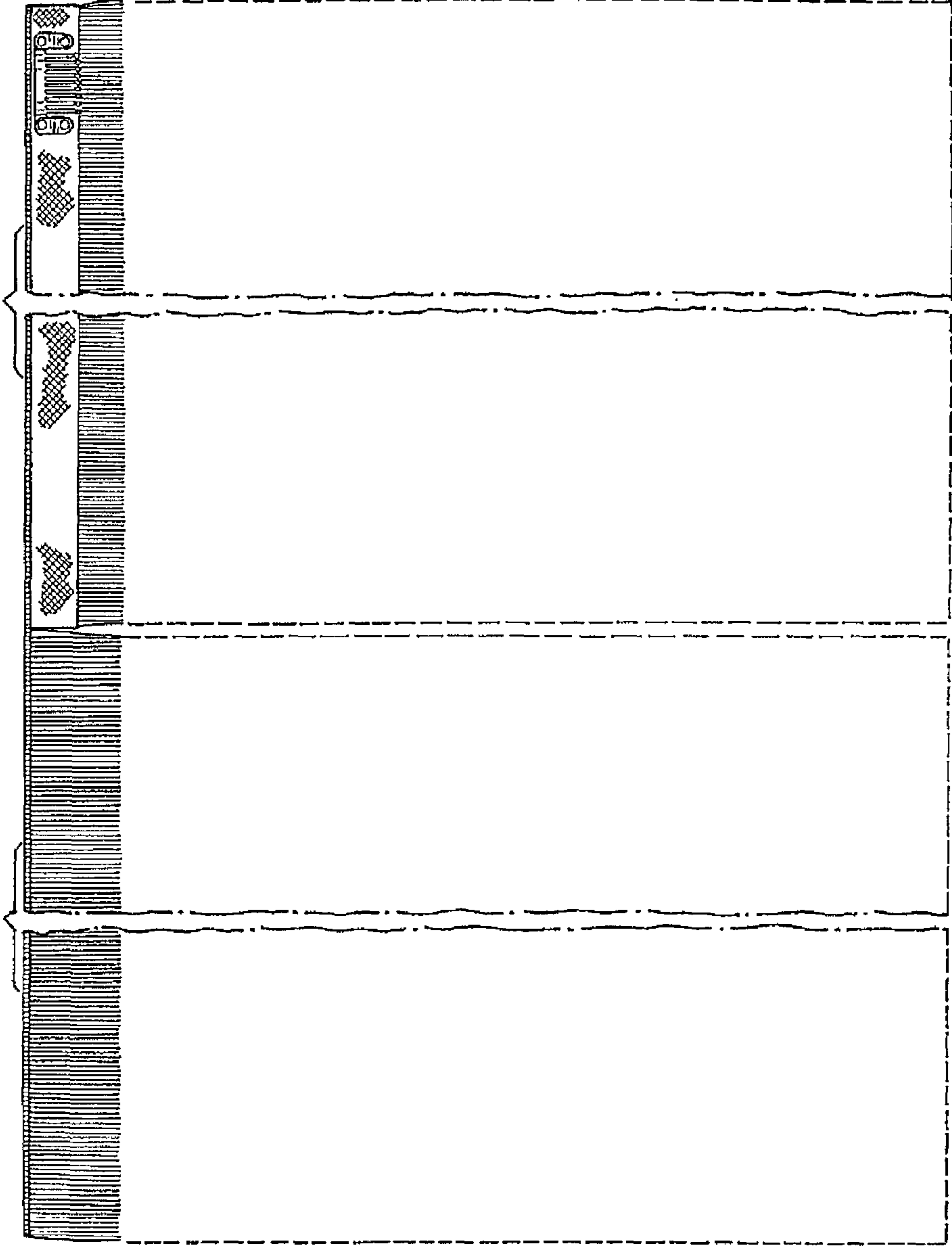

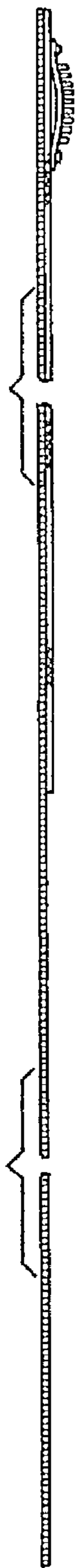

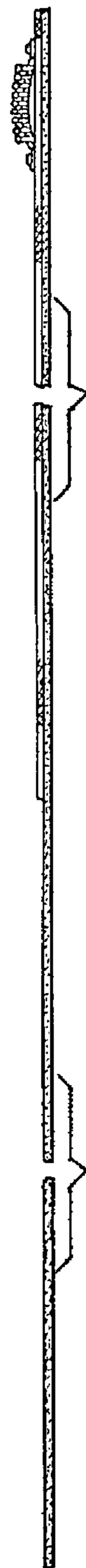
