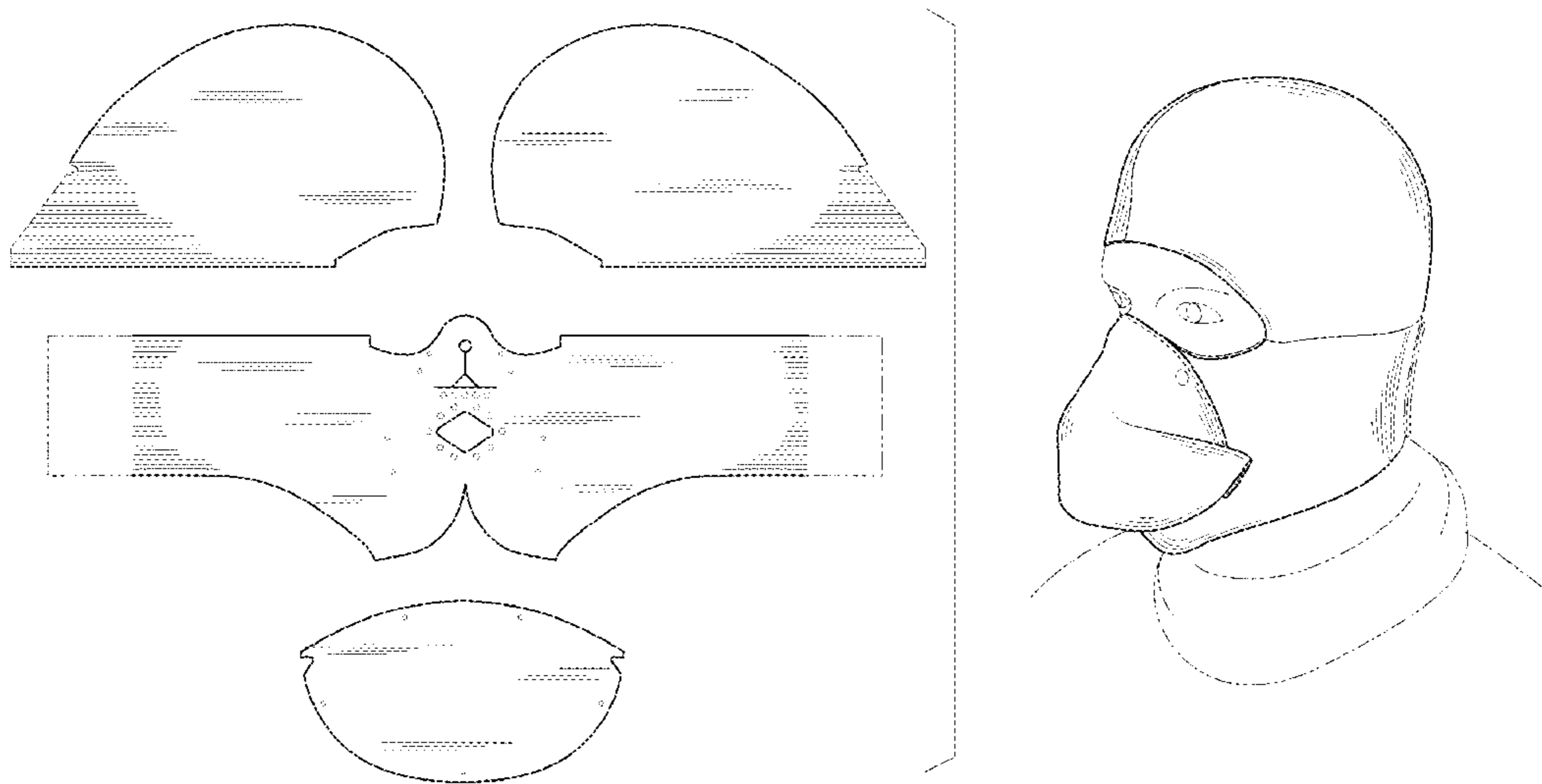
(57) **CLAIM**

The ornamental design for a face mask, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front elevation view of a face mask showing my new design, the rear view being identical; FIG. 2 is an exploded front perspective view thereof showing the article in use; FIG. 3 is a front perspective view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a rear elevation view thereof; and, FIG. 8 is a top plan view thereof. The broken lines are for illustrative purposes only and form no part of the claimed design.

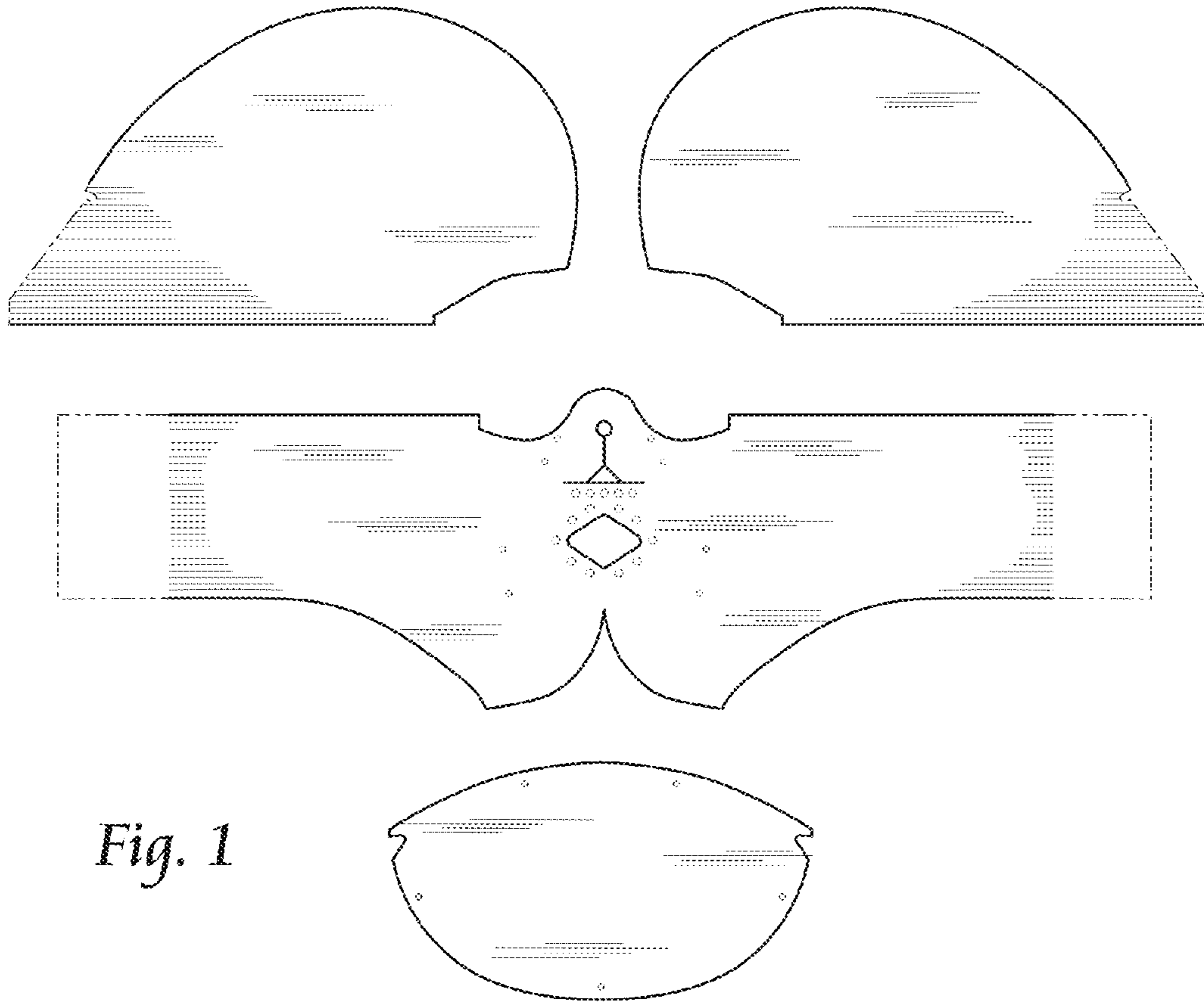

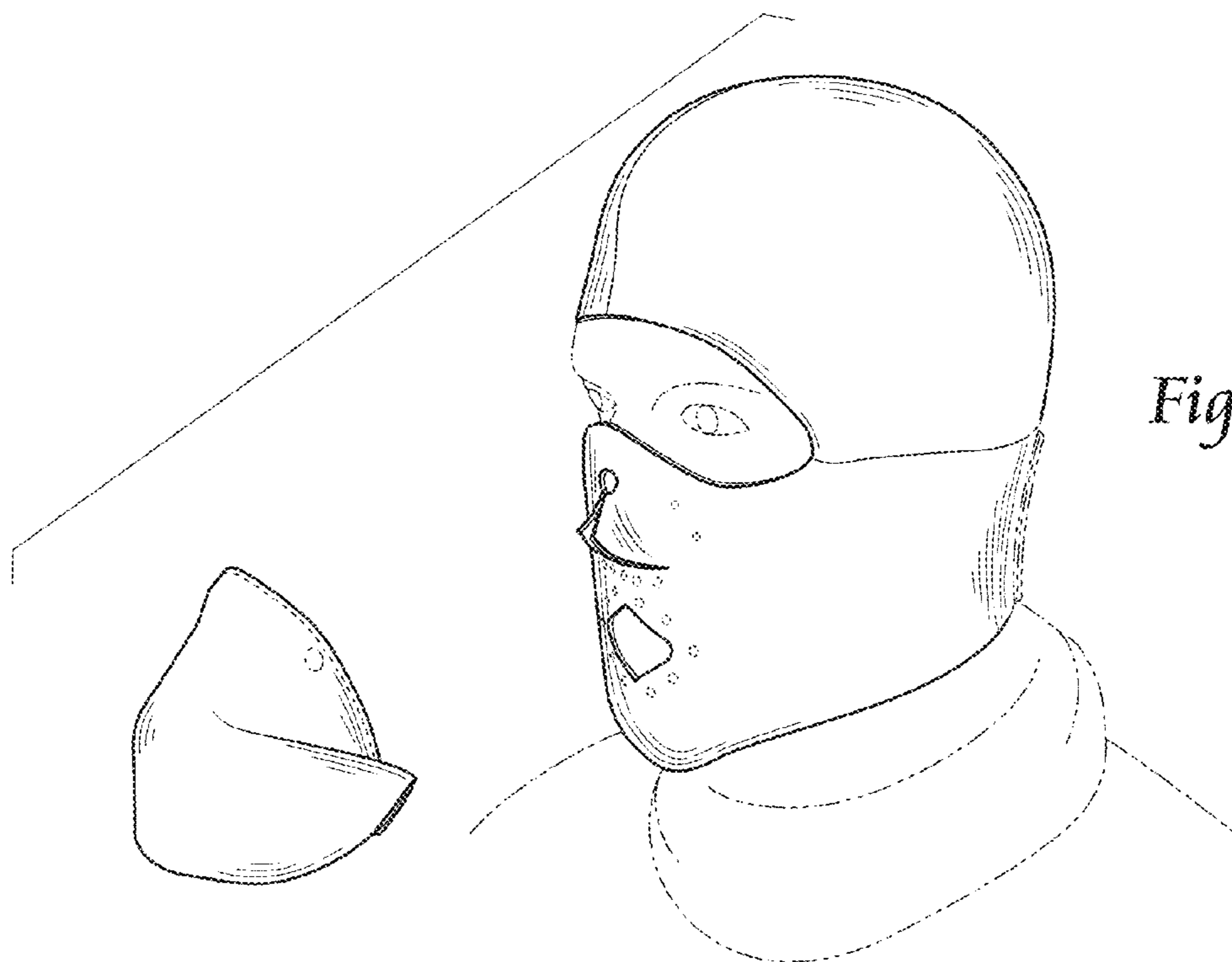

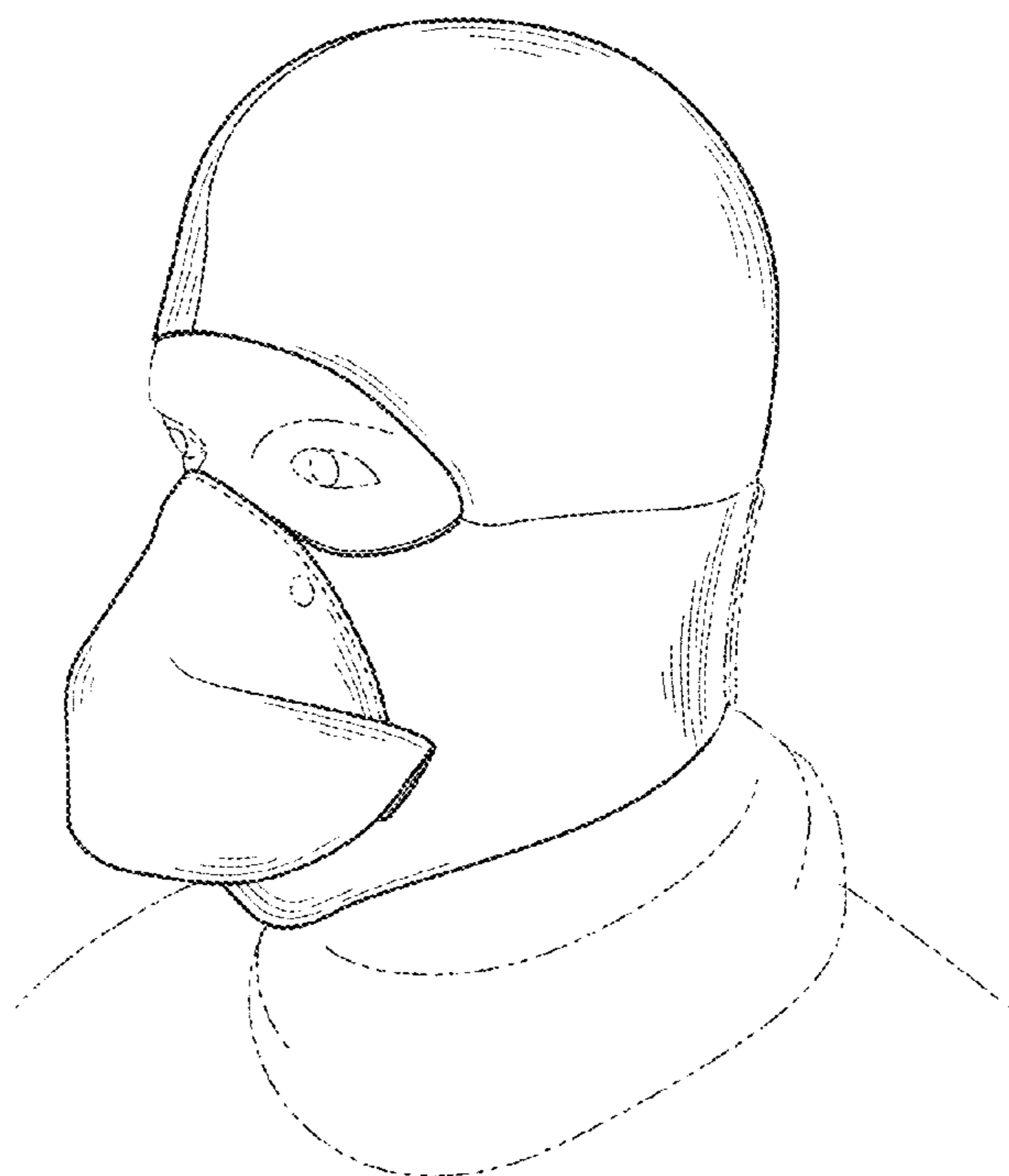

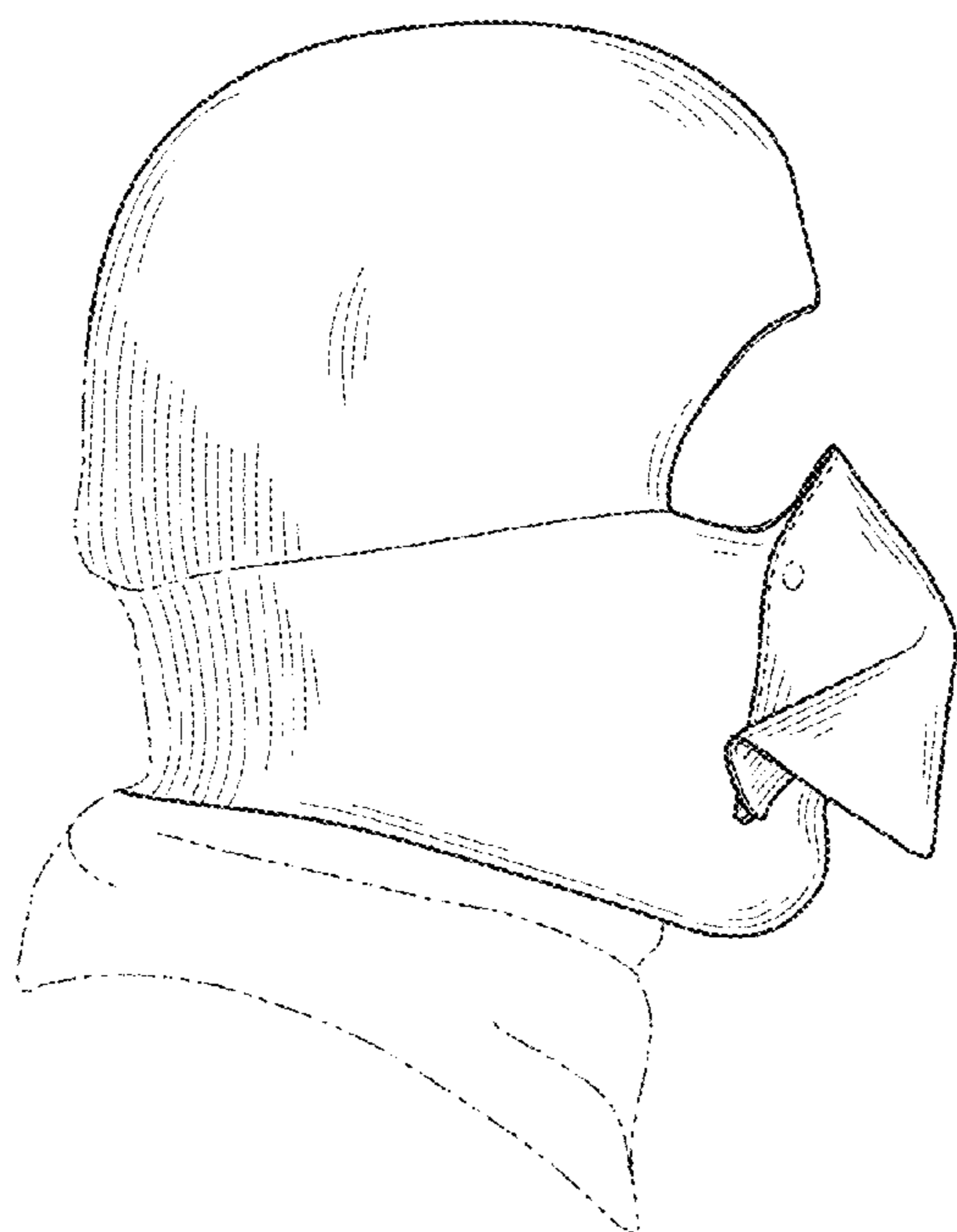

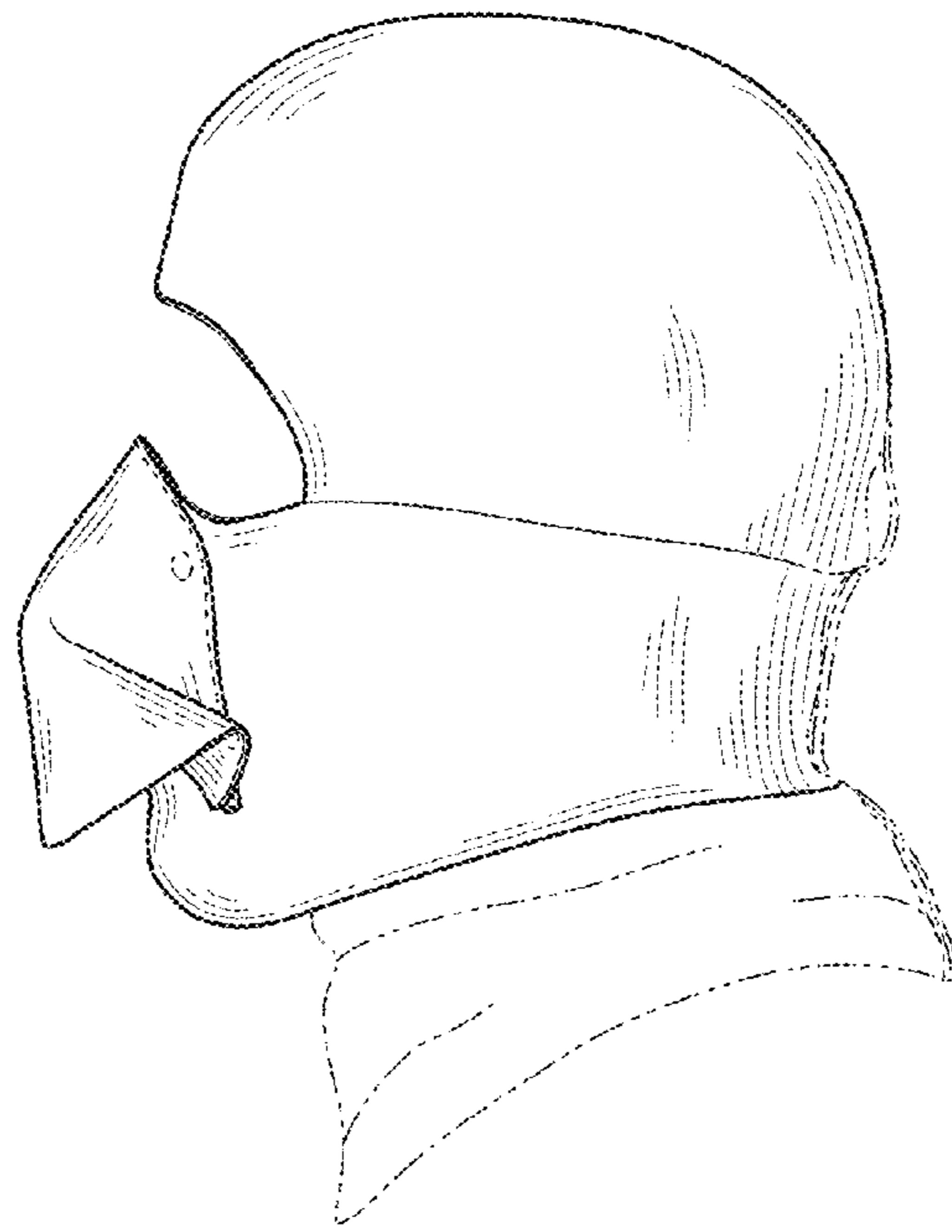

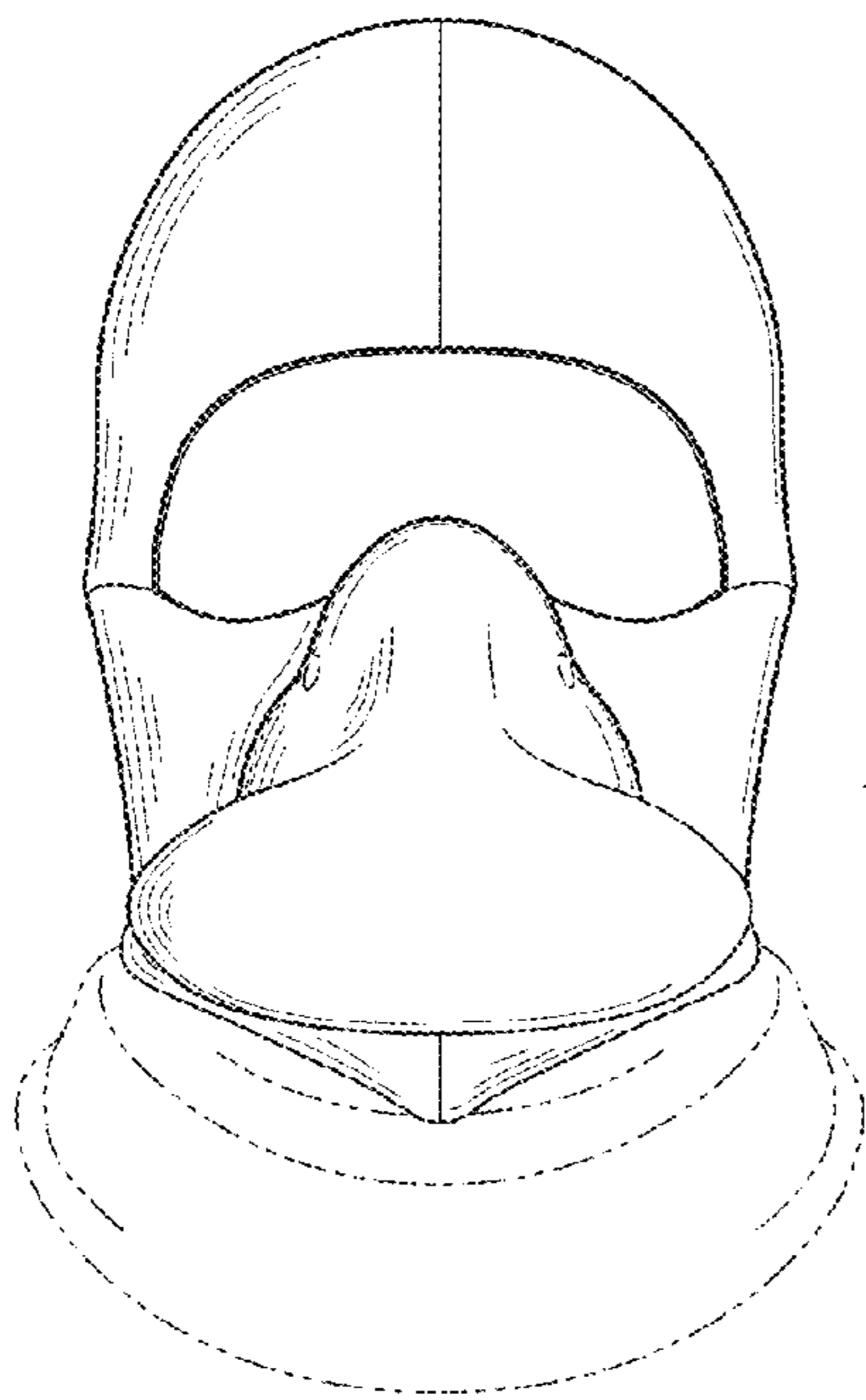

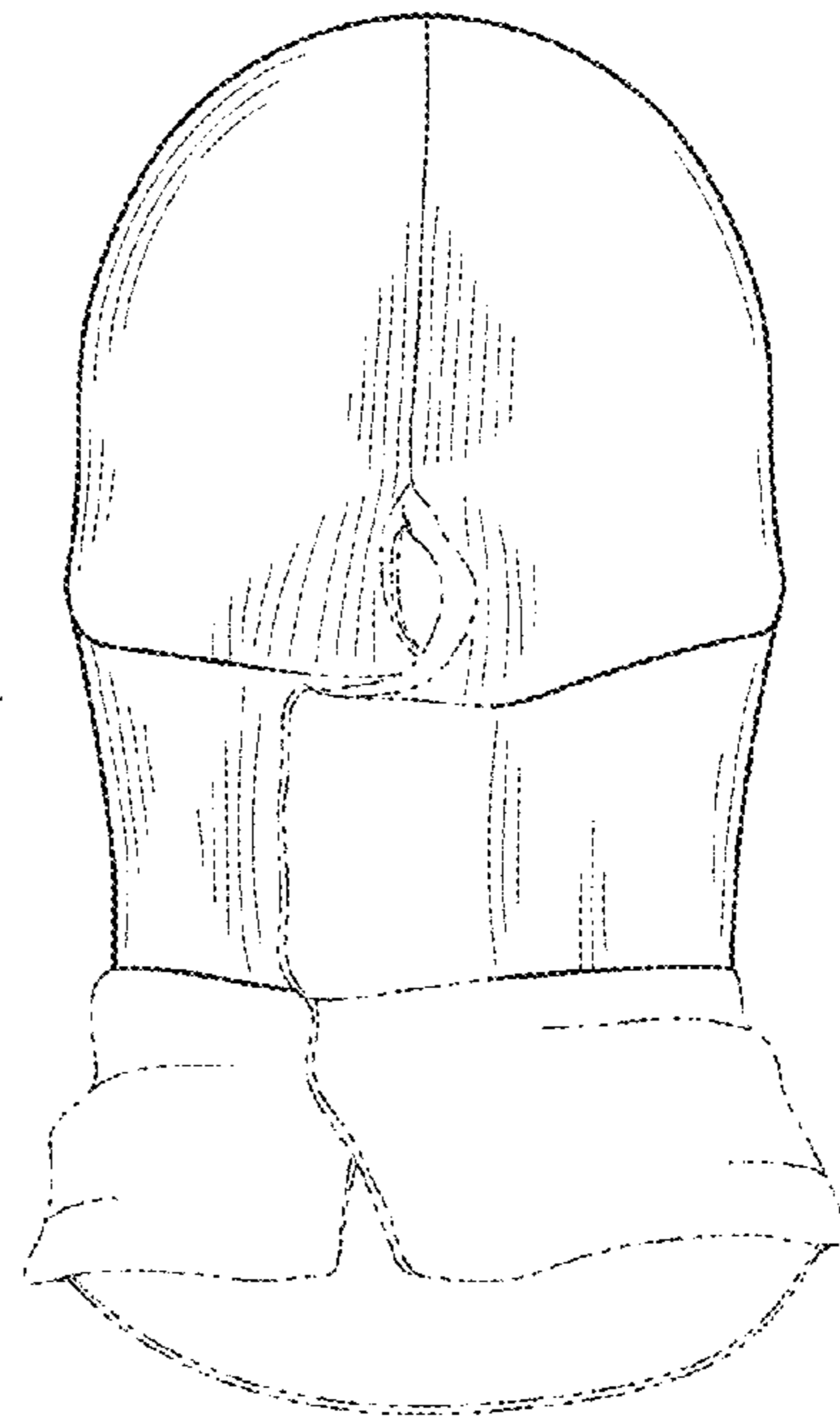
