and described.

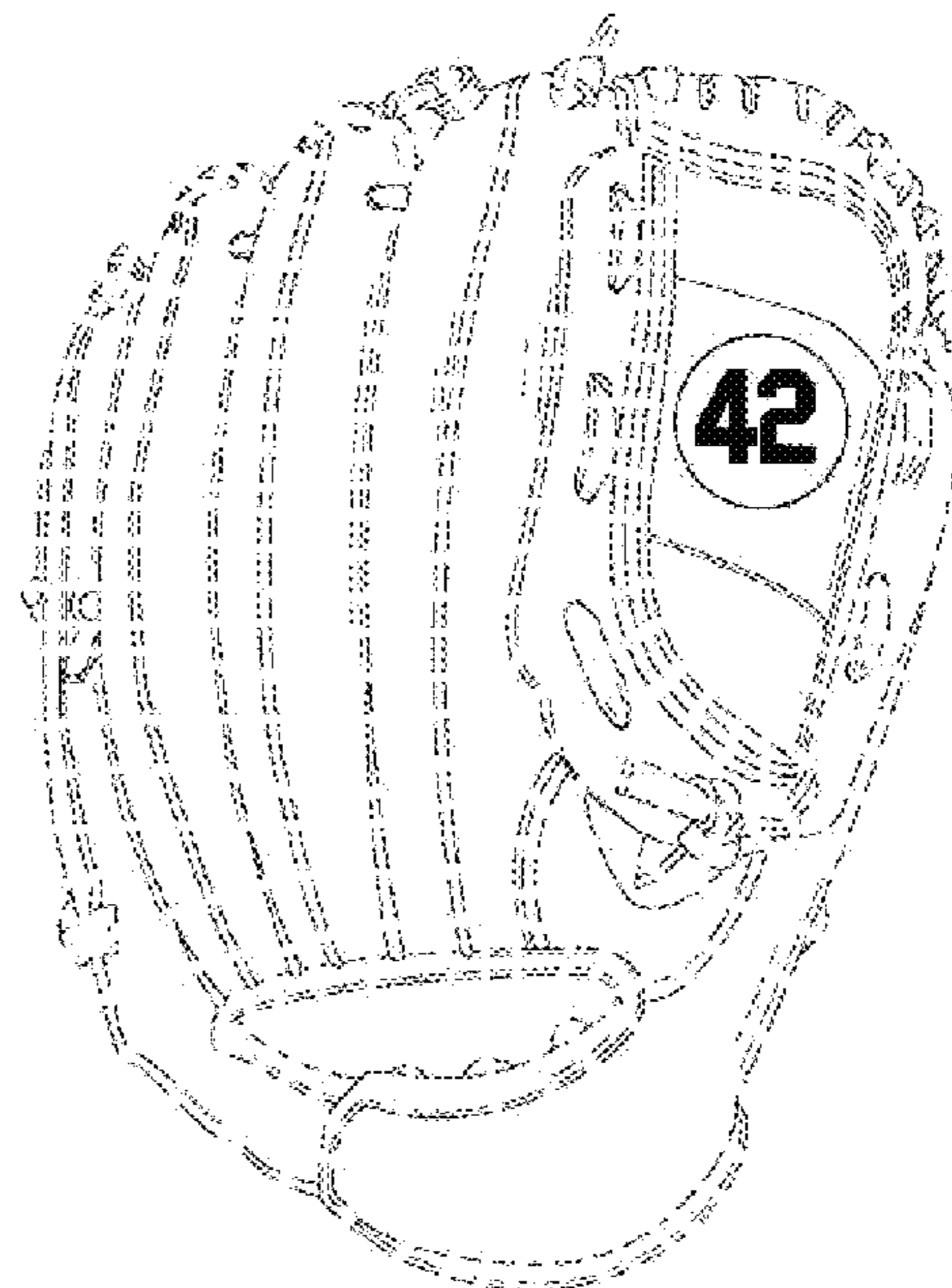
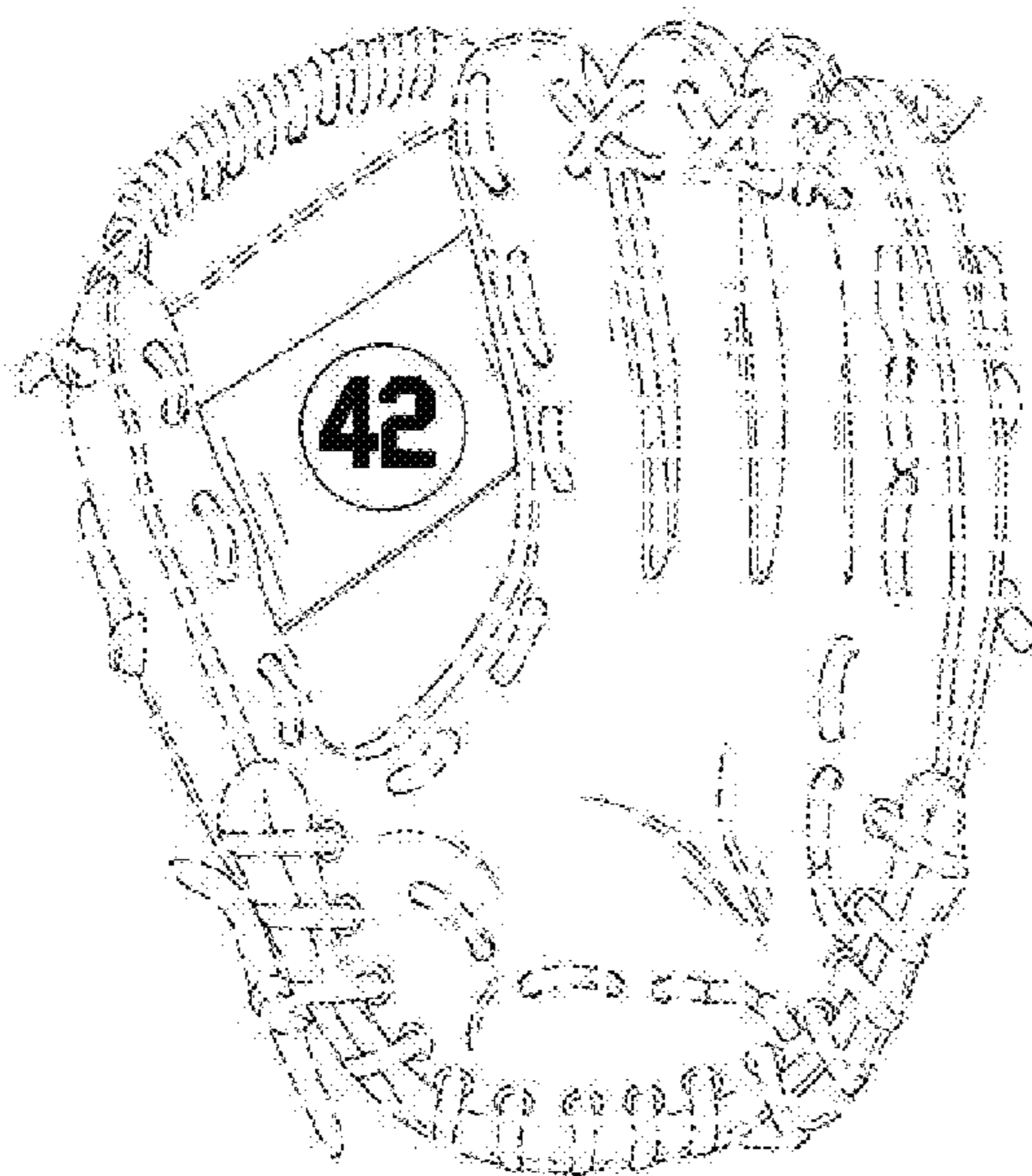
DESCRIPTION

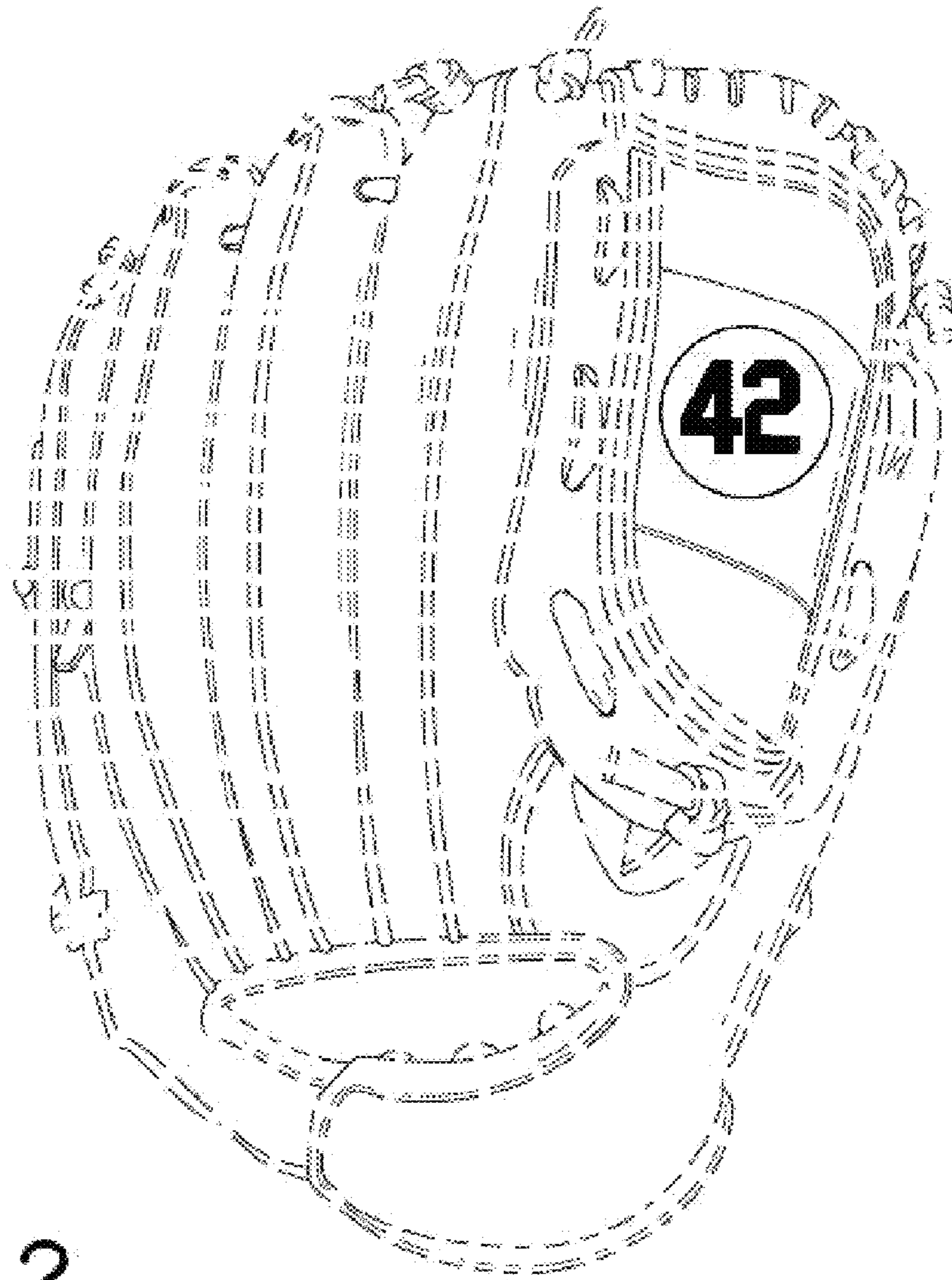
