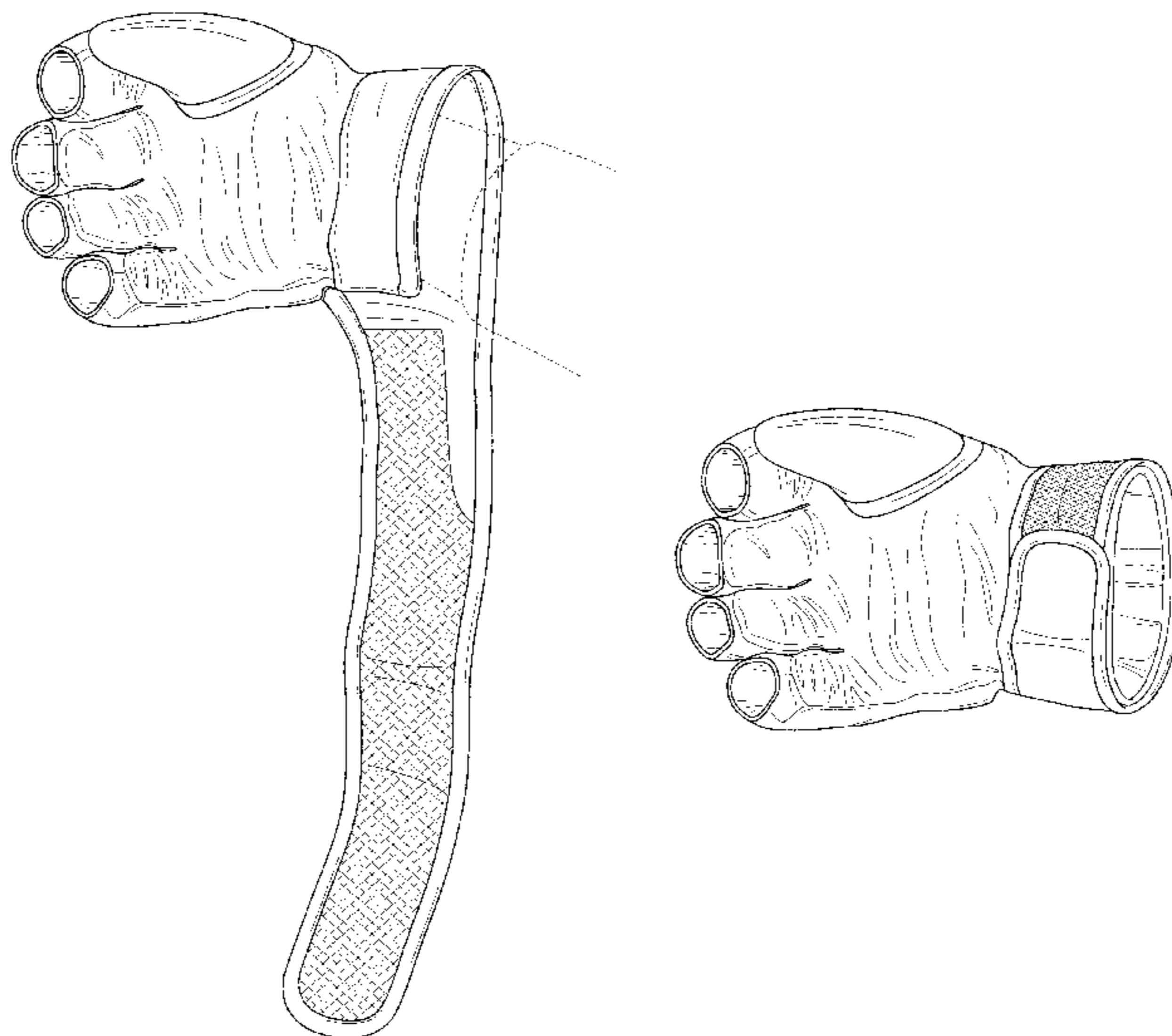
(57) **CLAIM**

I claim the ornamental design for a fighting glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fighting glove, showing my new design with a fastening strap in an extended position; FIG. 2 is a perspective view thereof, illustrated with the fastening strap in a fastened position; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a right-side elevational view thereof; FIG. 7 is a front elevational view thereof; and, FIG. 8 is a rear elevational view thereof. The broken lines showing an arm in the figures depict environmental matter, and form no part of the claimed design.

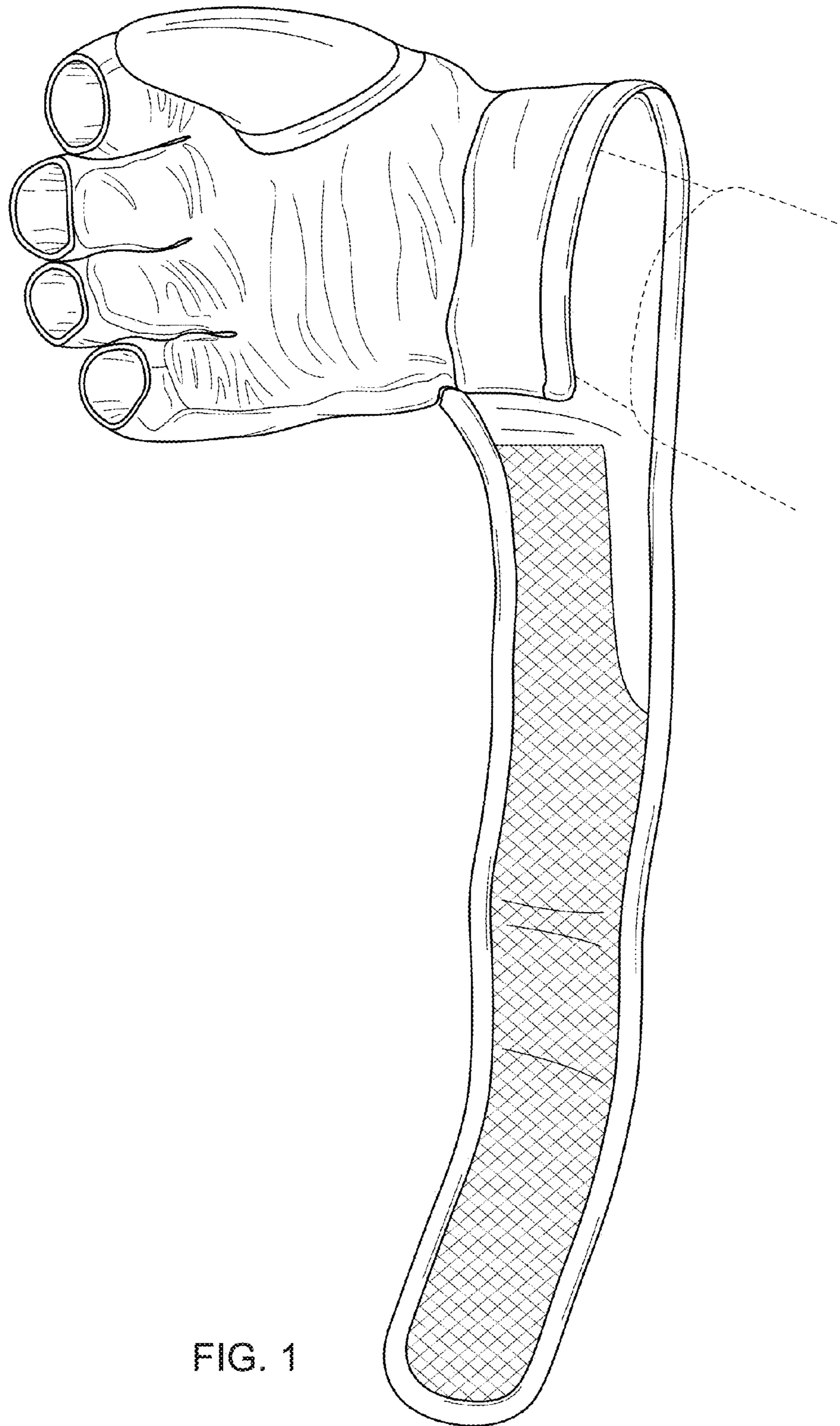

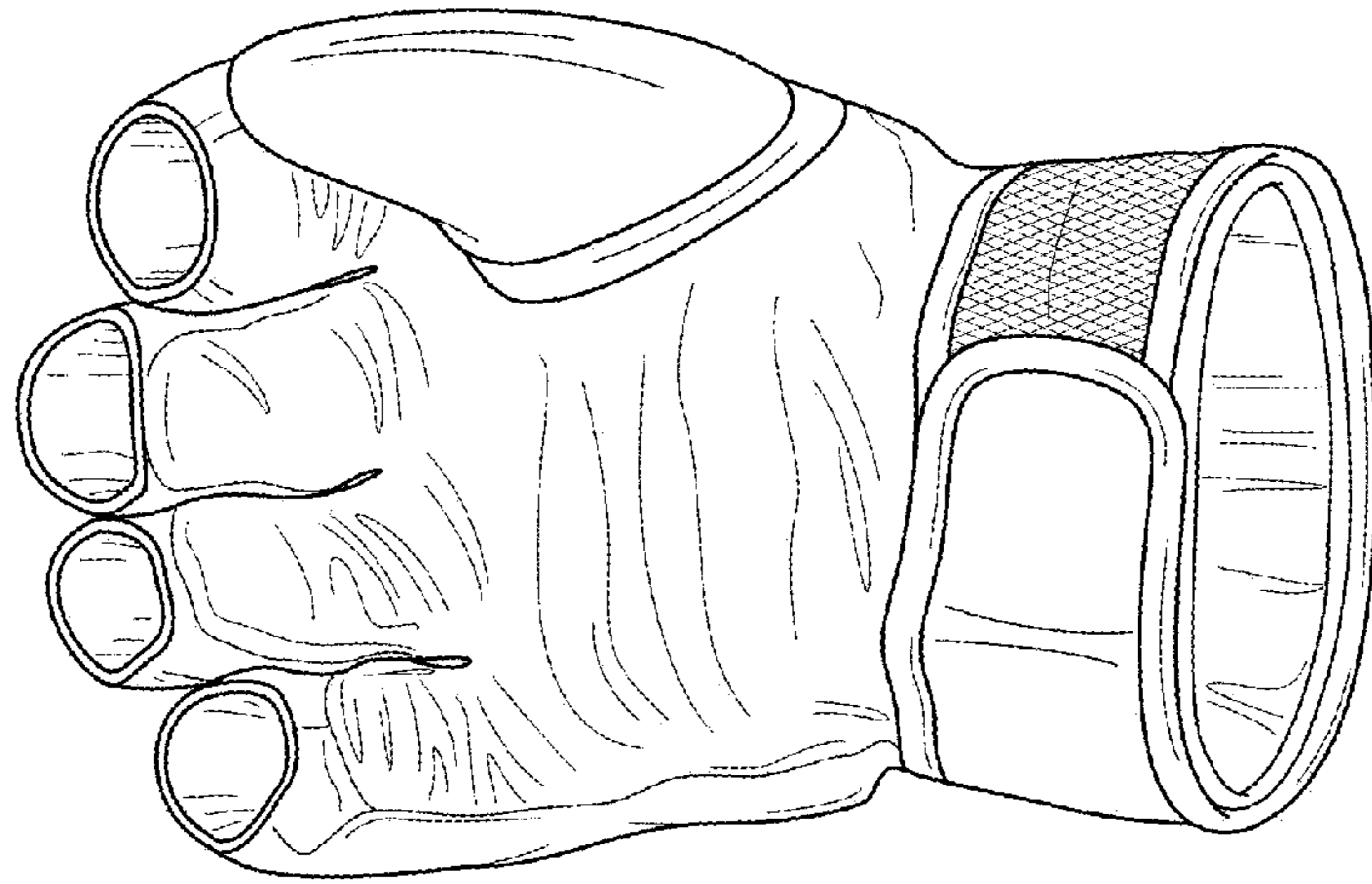

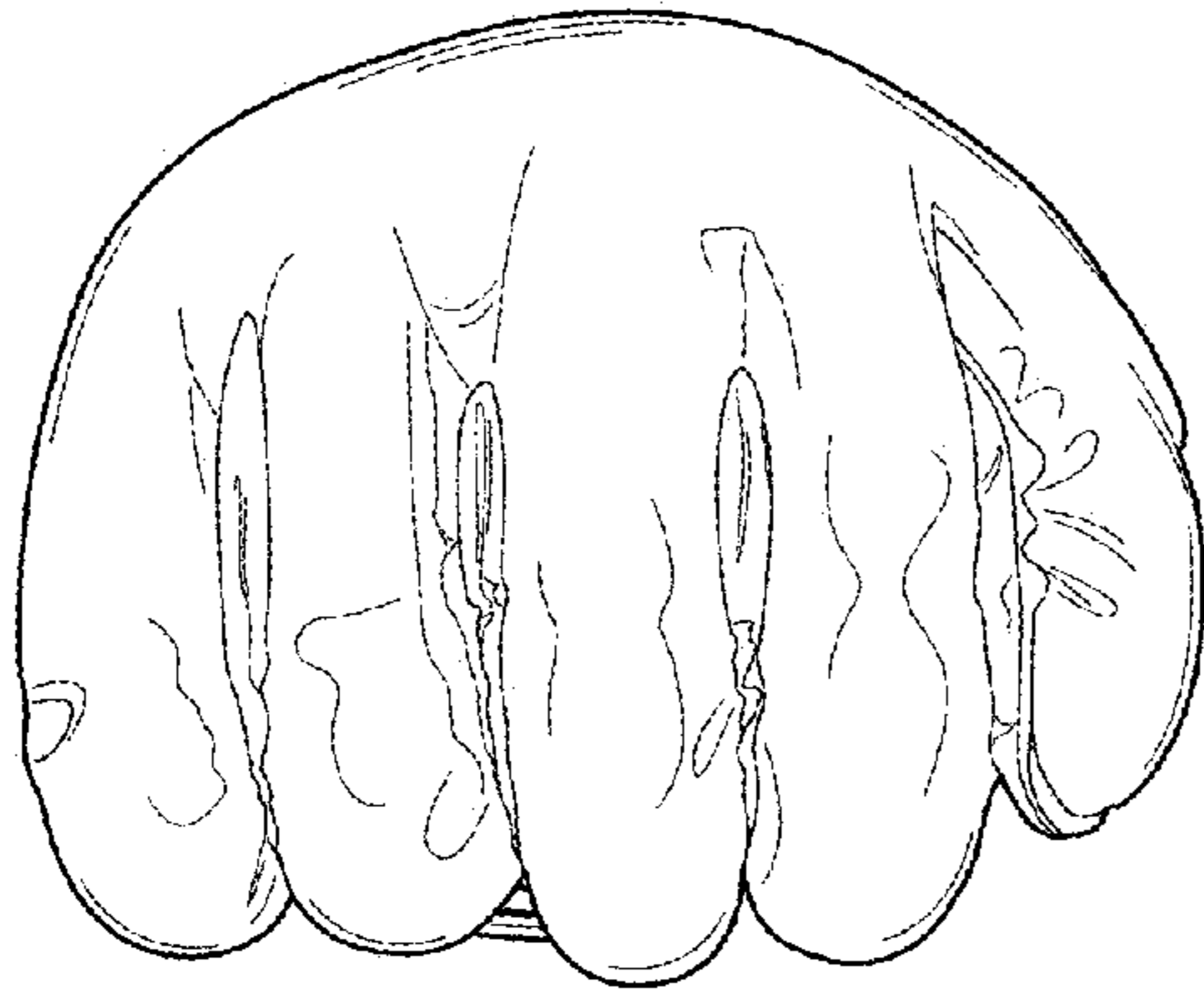

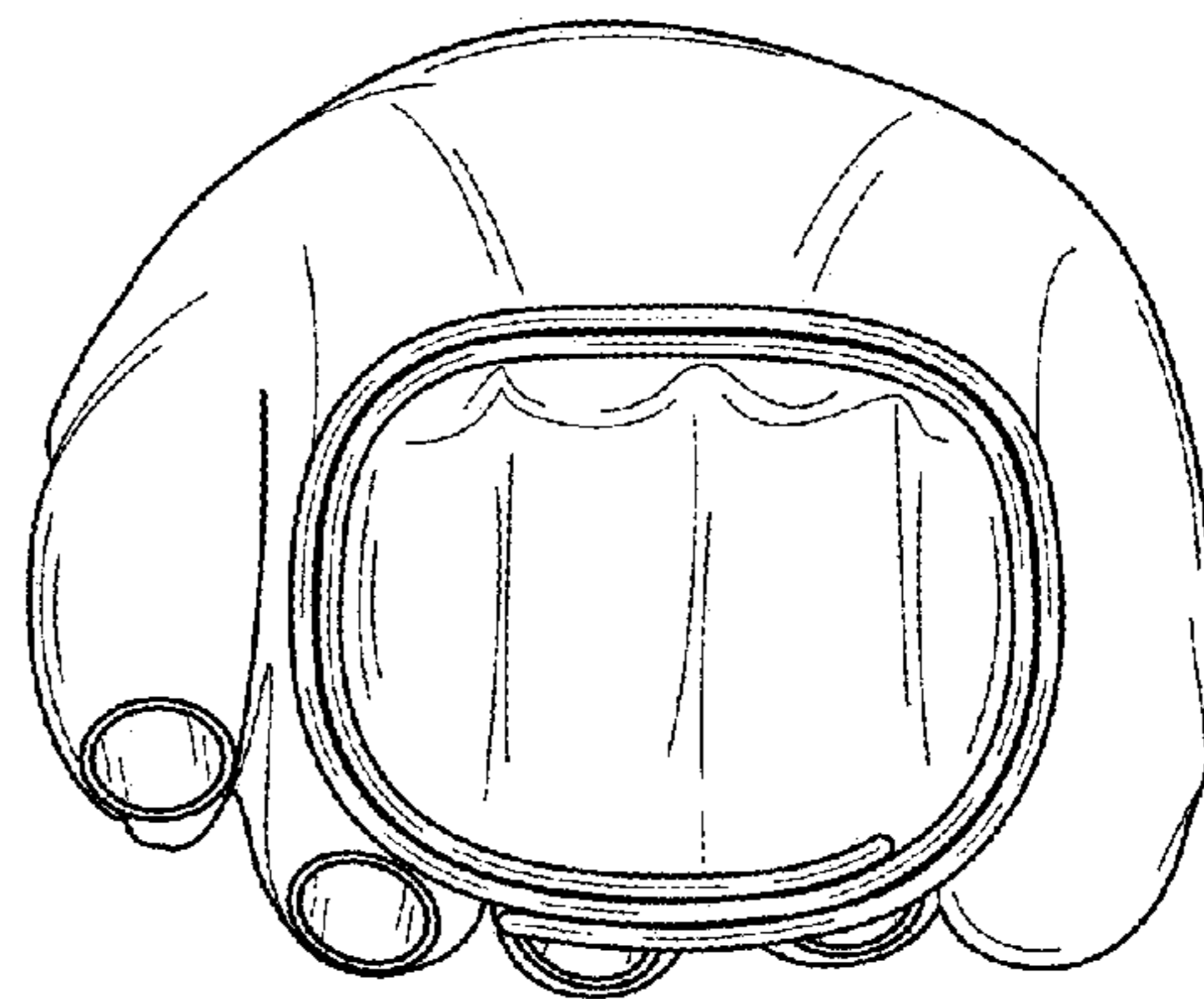

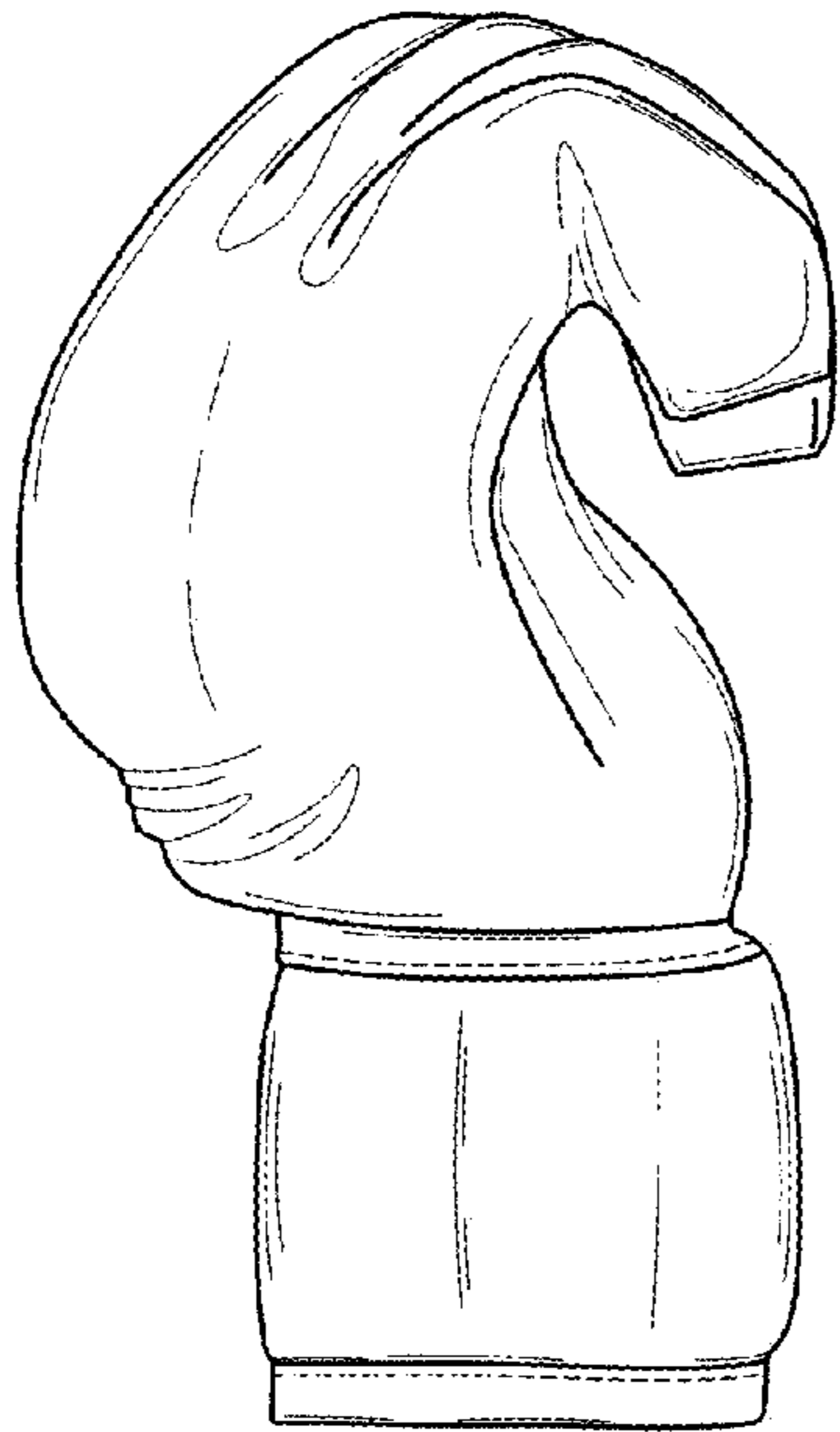

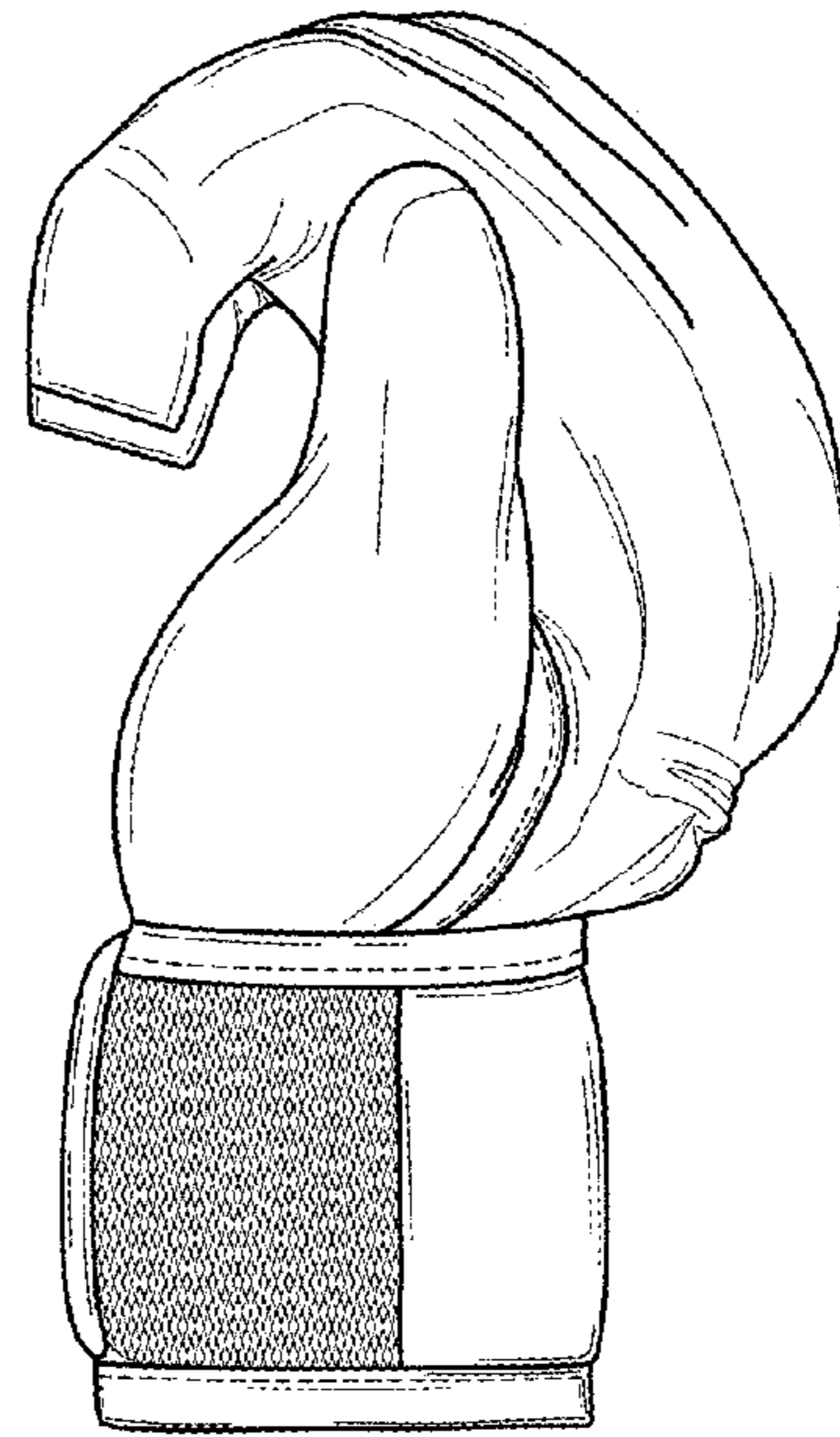

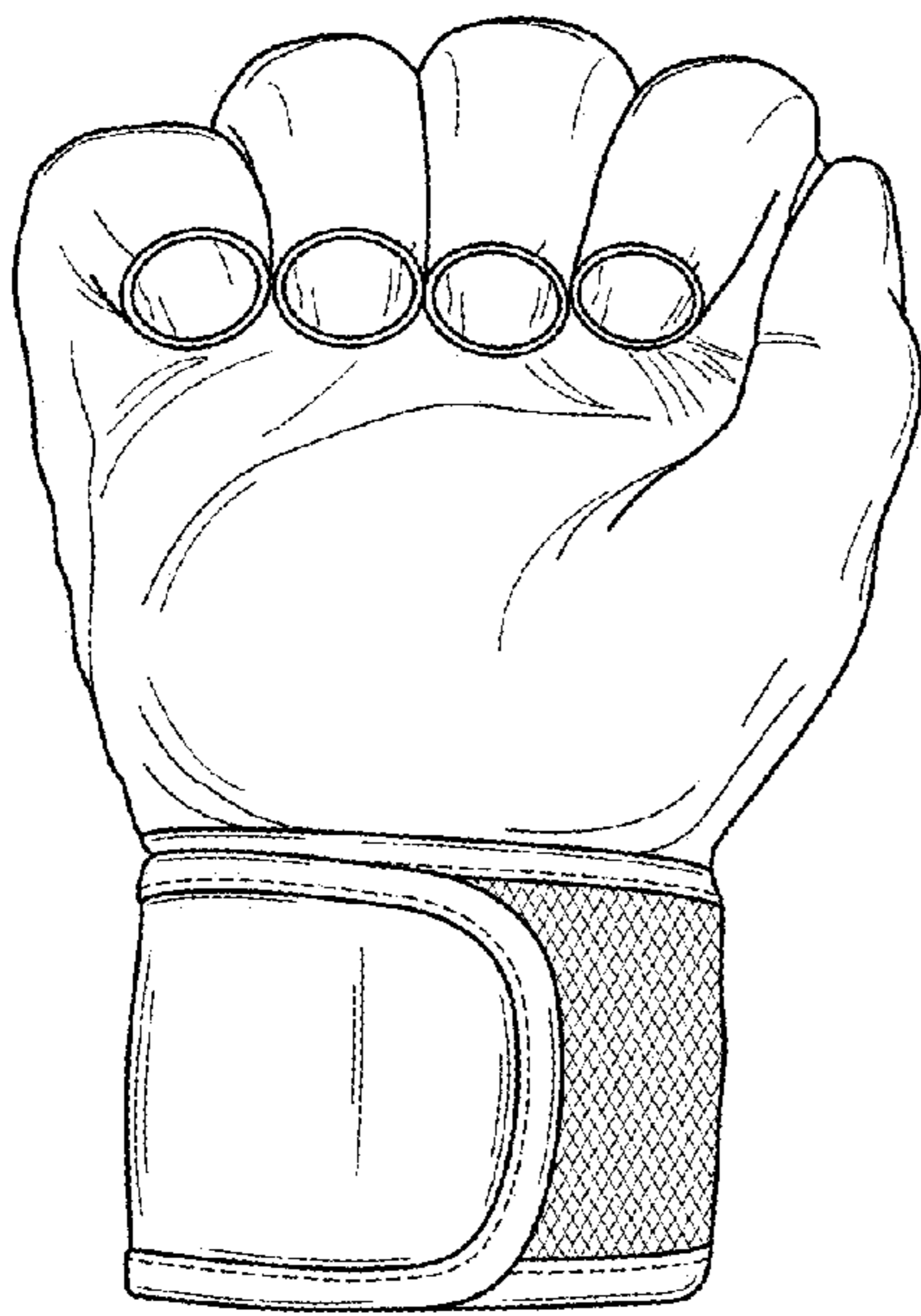

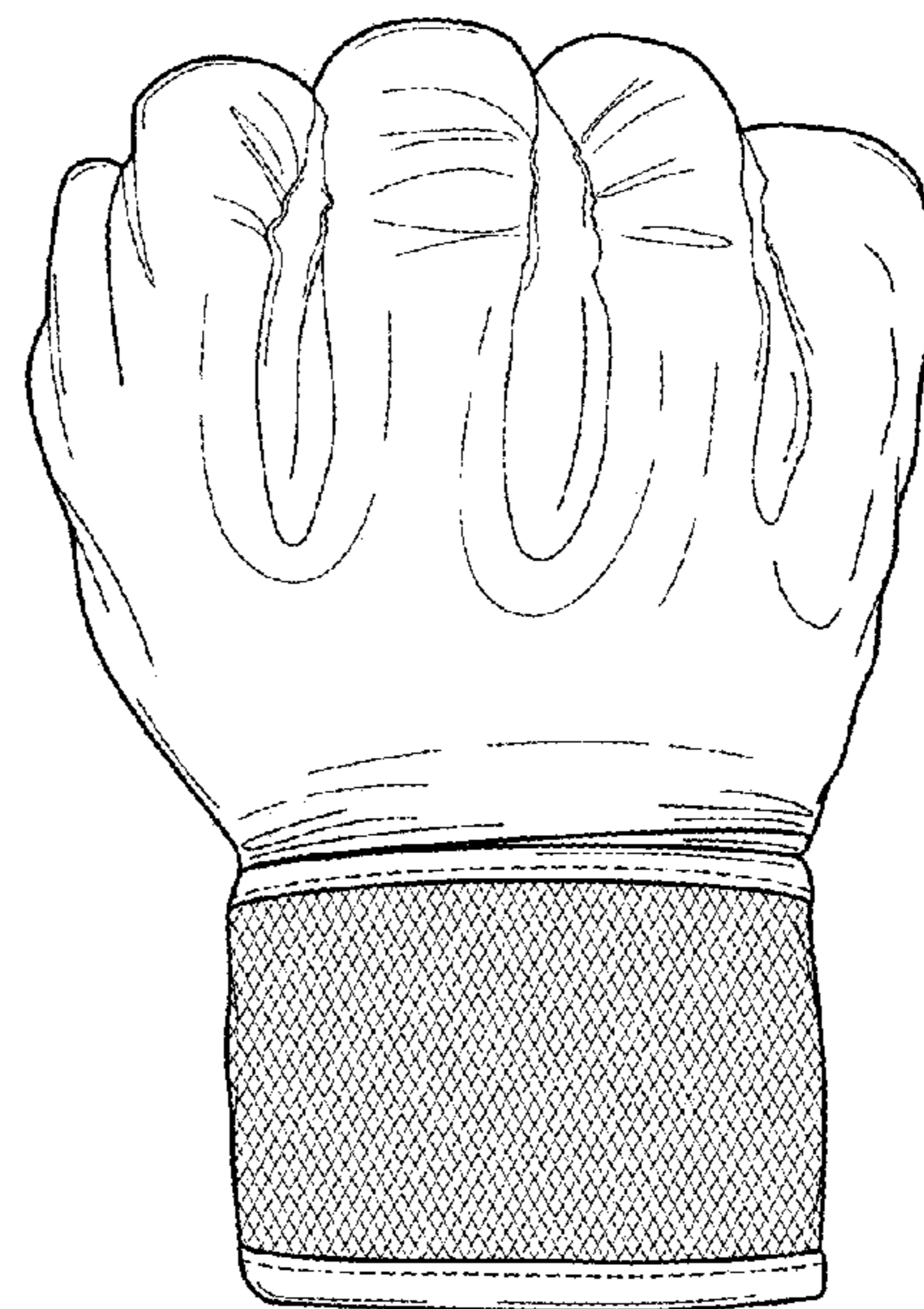
