(57) **CLAIM**

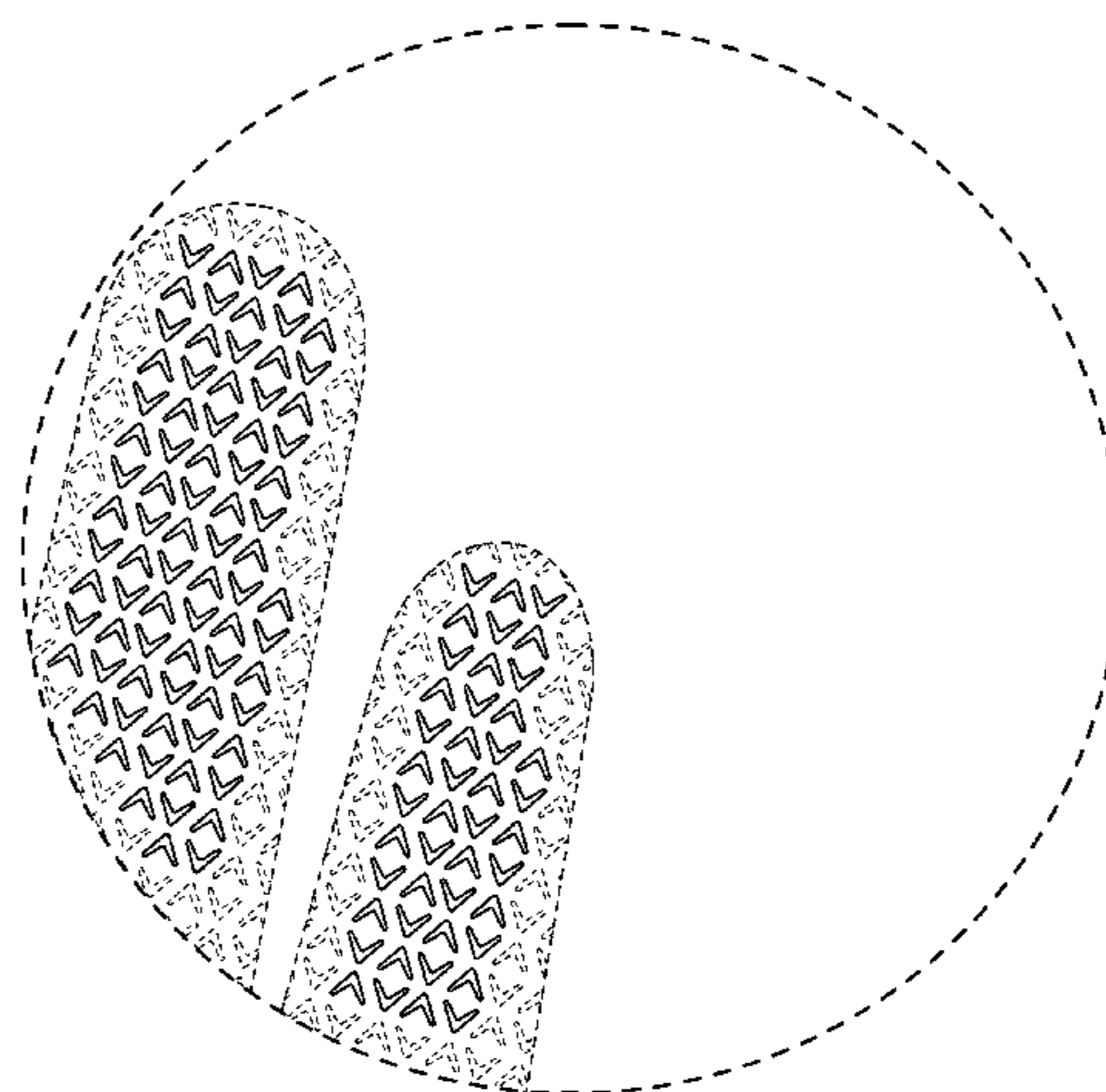
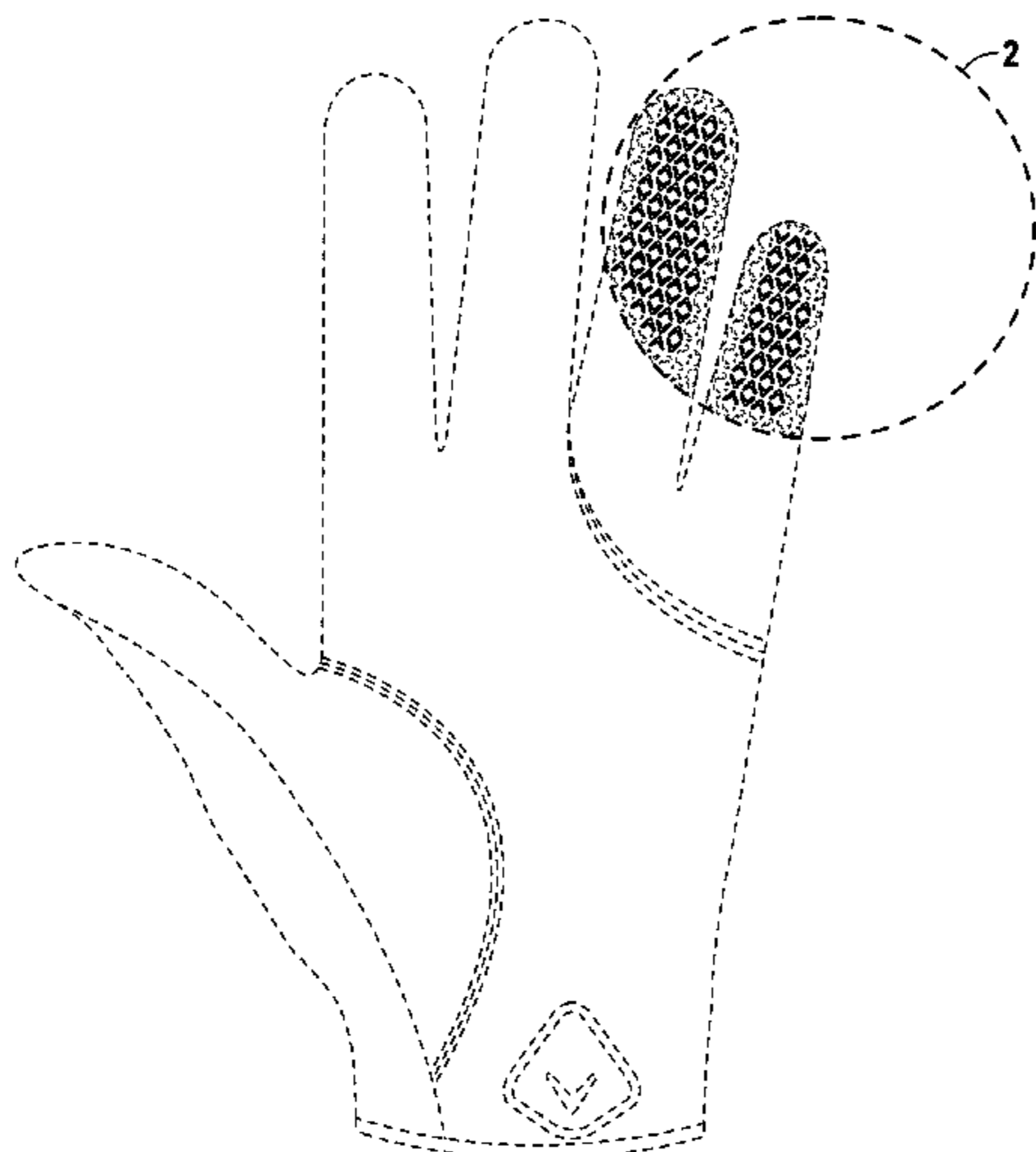
The ornamental design for a golf glove, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of a golf glove; and, FIG. 2 is an enlarged detail view of the circled portion of the golf glove shown in FIG. 1.

The larger-segmented broken lines showing a glove in the drawings and the finely-incremented dotted lines in the surface ornamentation illustrate unclaimed features of the golf glove.

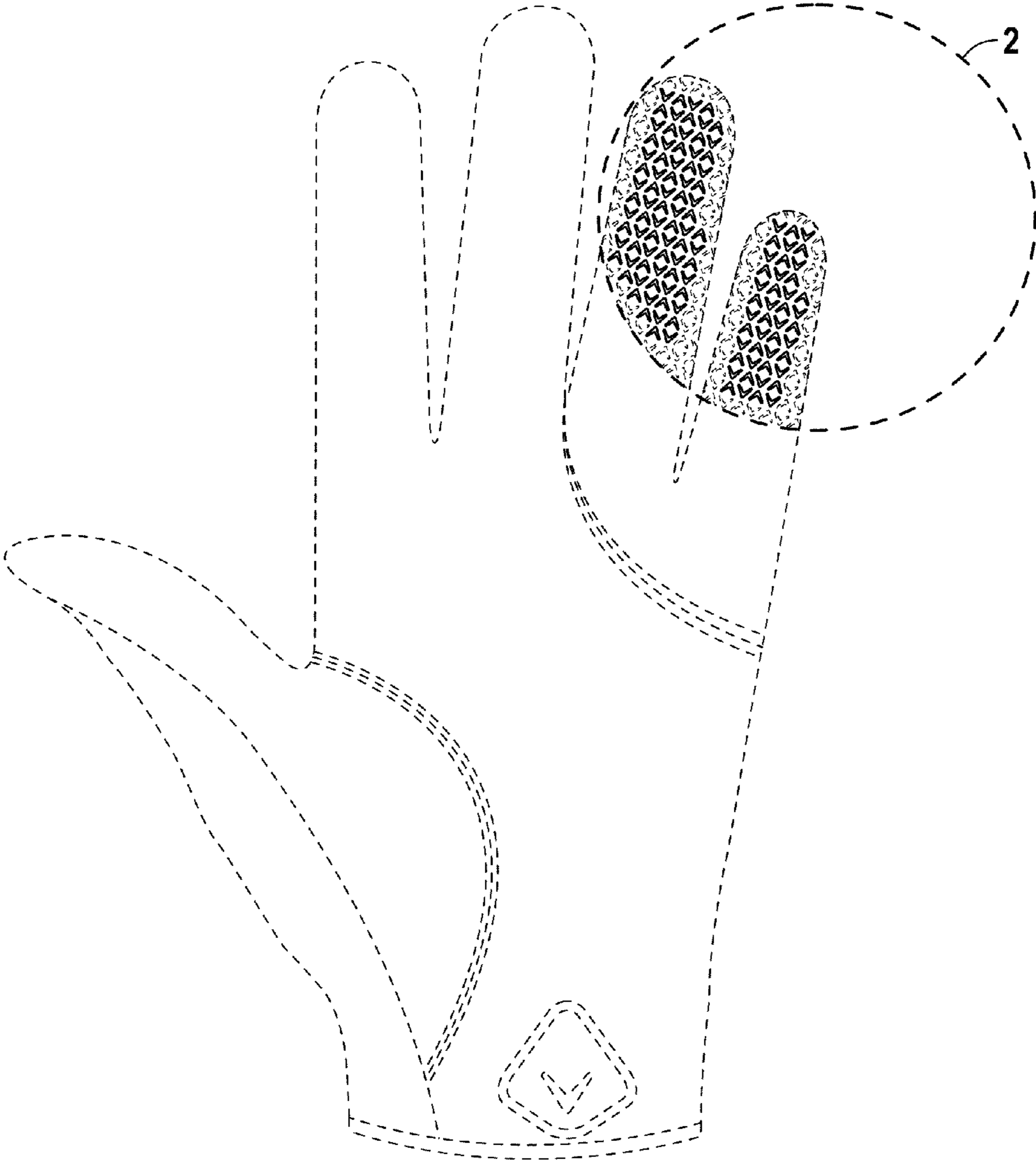

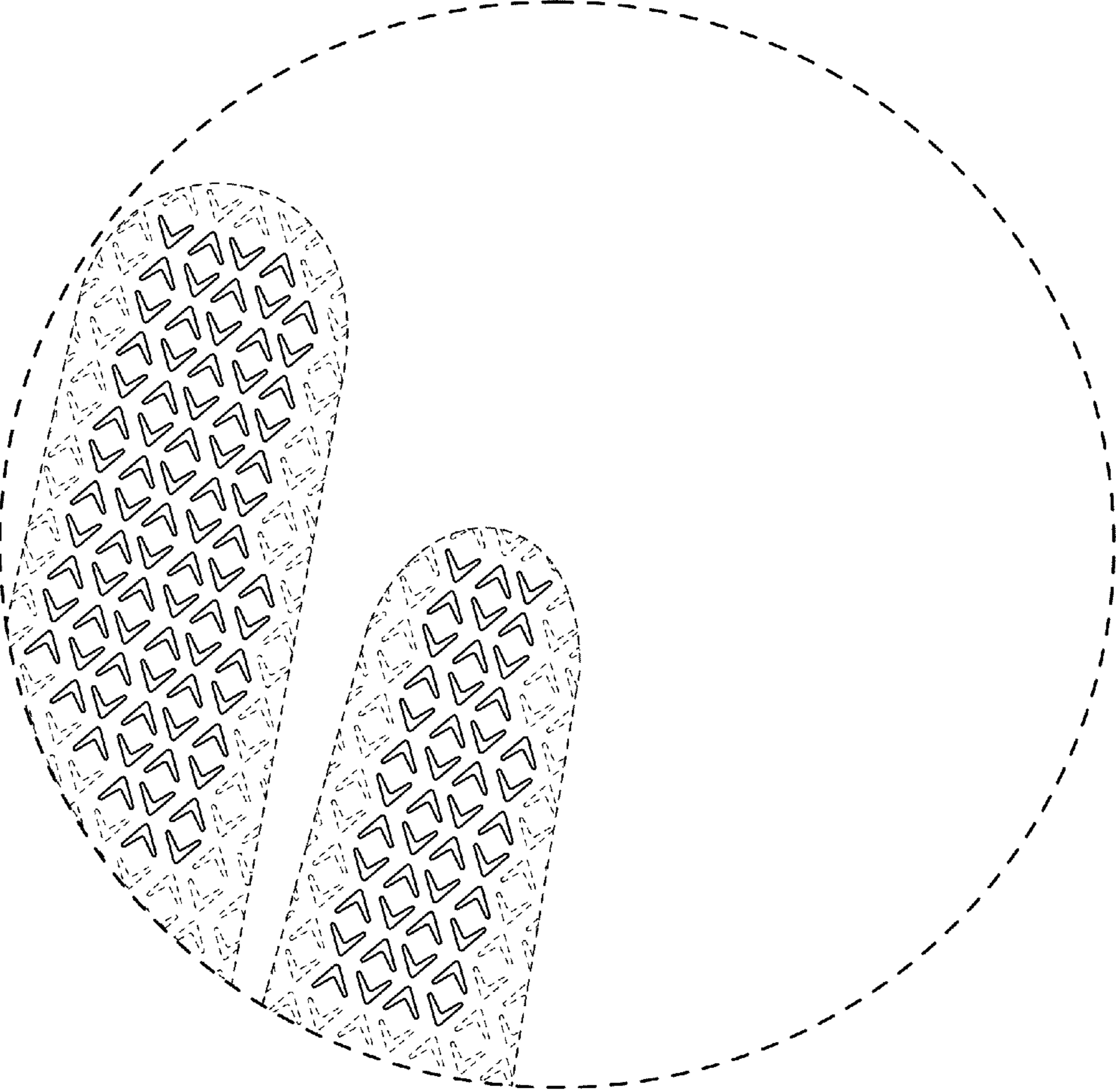
