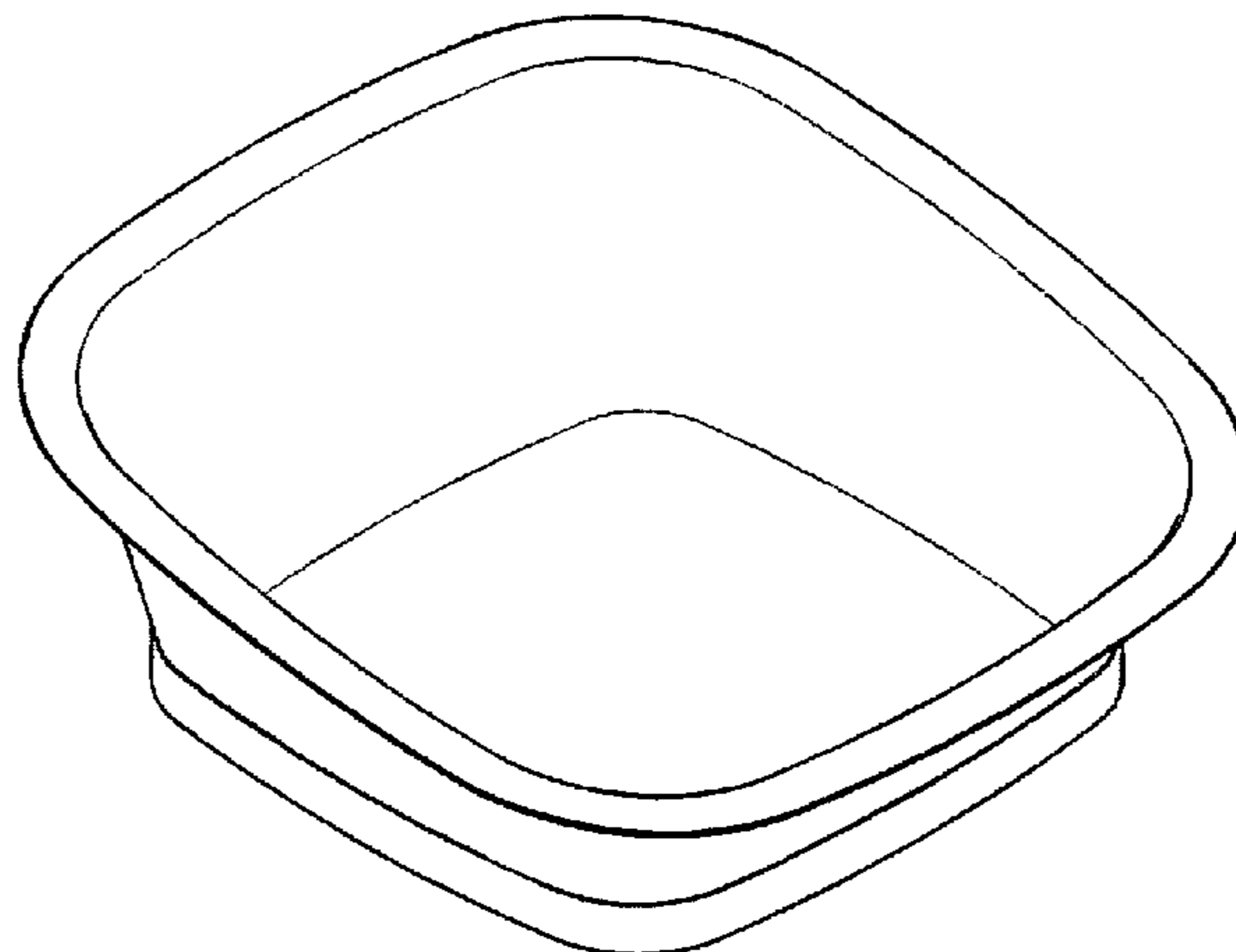
(57) **CLAIM**

The ornamental design for a slanted pet feeder with non-skid lower surface, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slanted pet feeder with non-skid lower surface showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a back elevational view; and, FIG. 6 is a right side elevational view, opposite side being a mirror image thereof. The broken lines and portions contained within broken lines in FIG. 3 are not claimed.

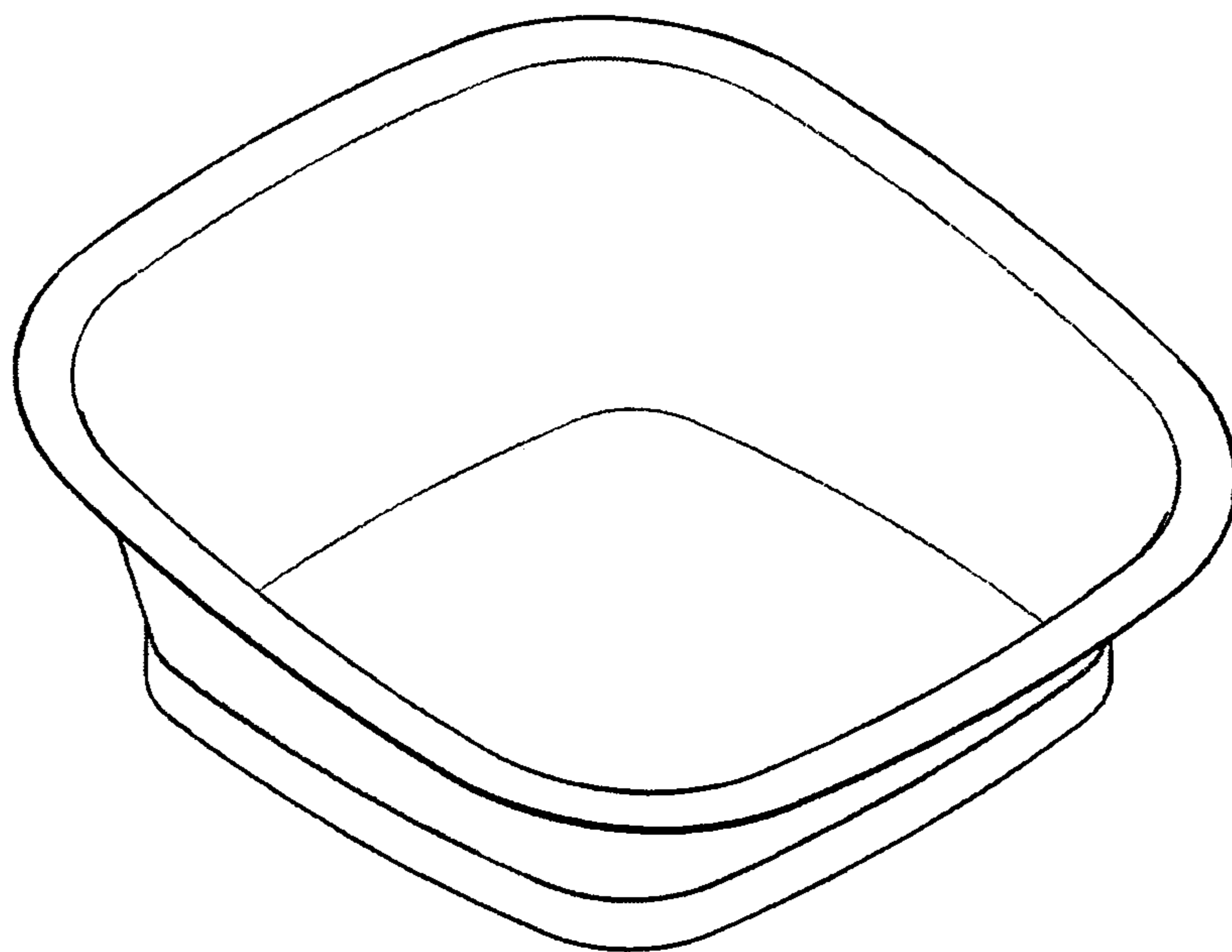

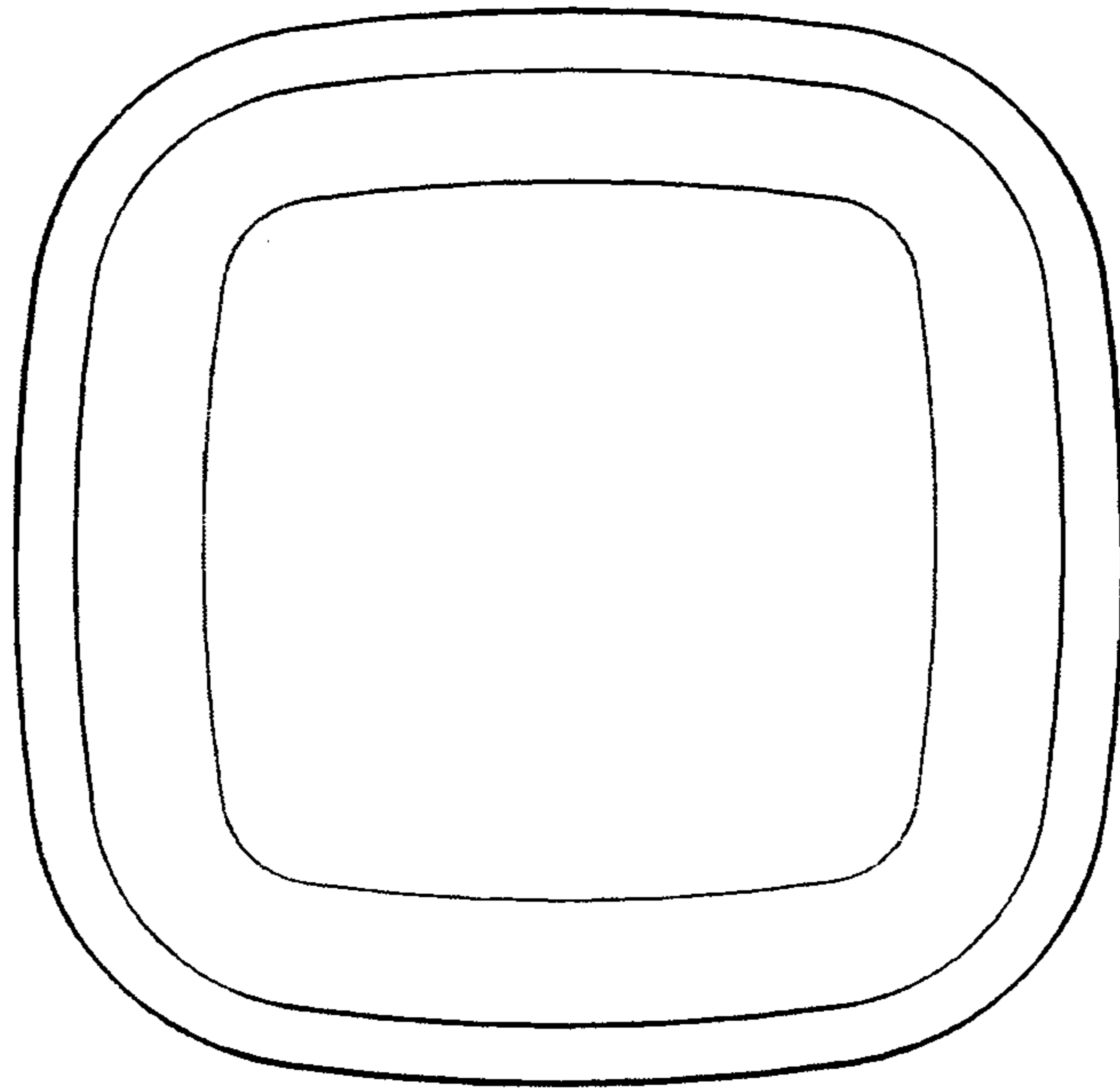

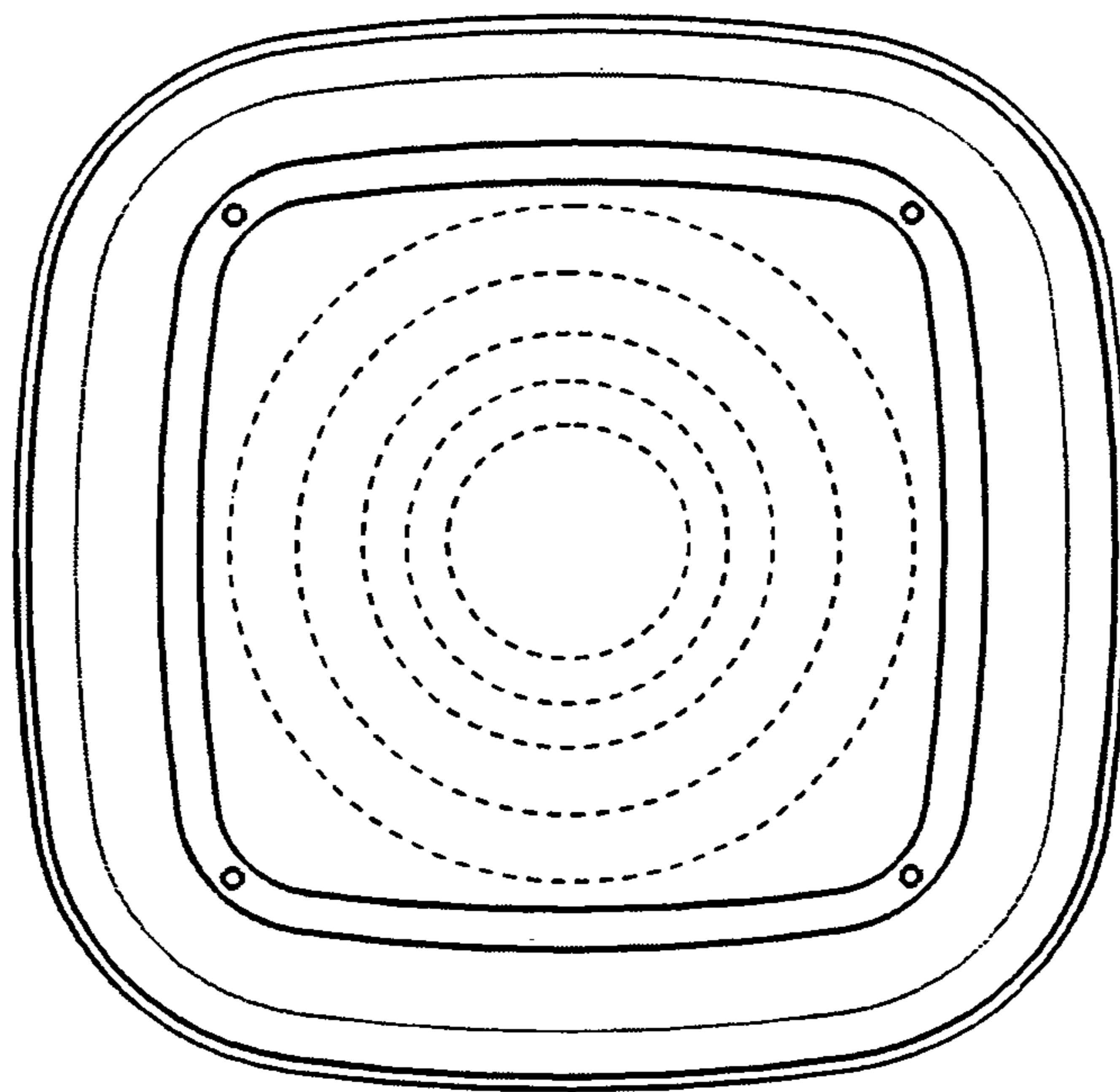

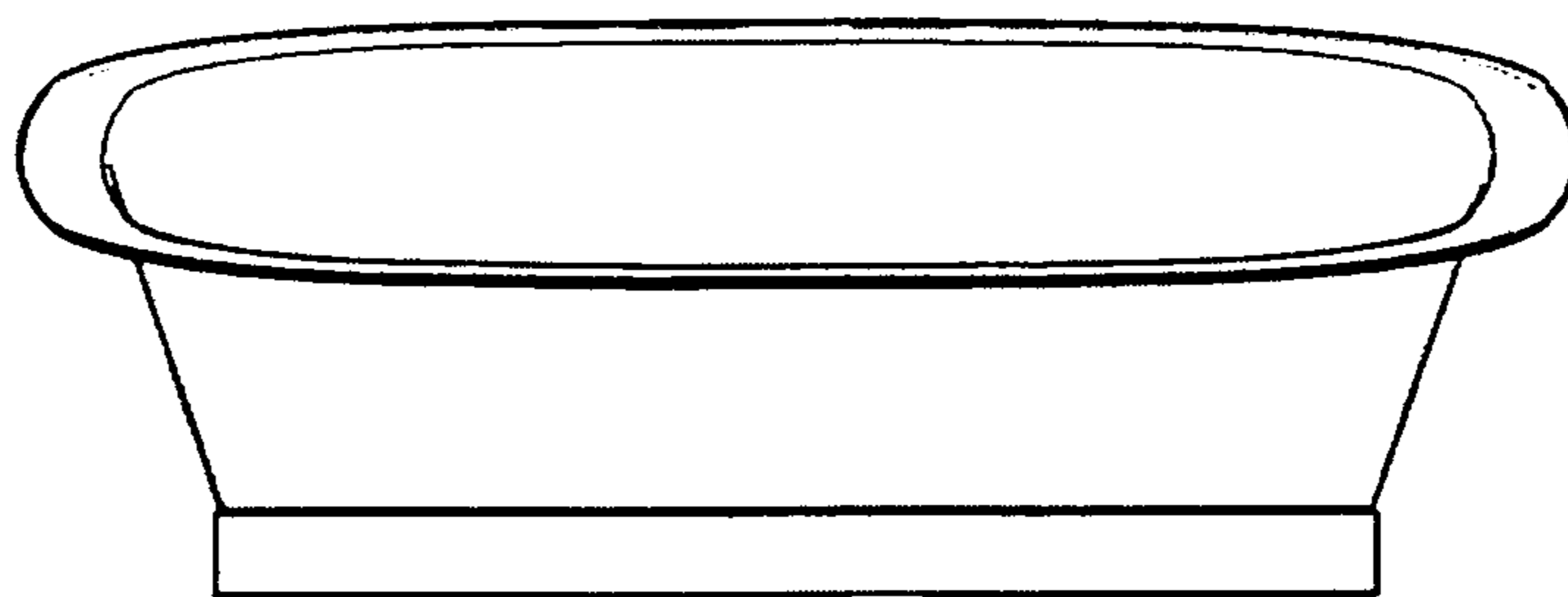

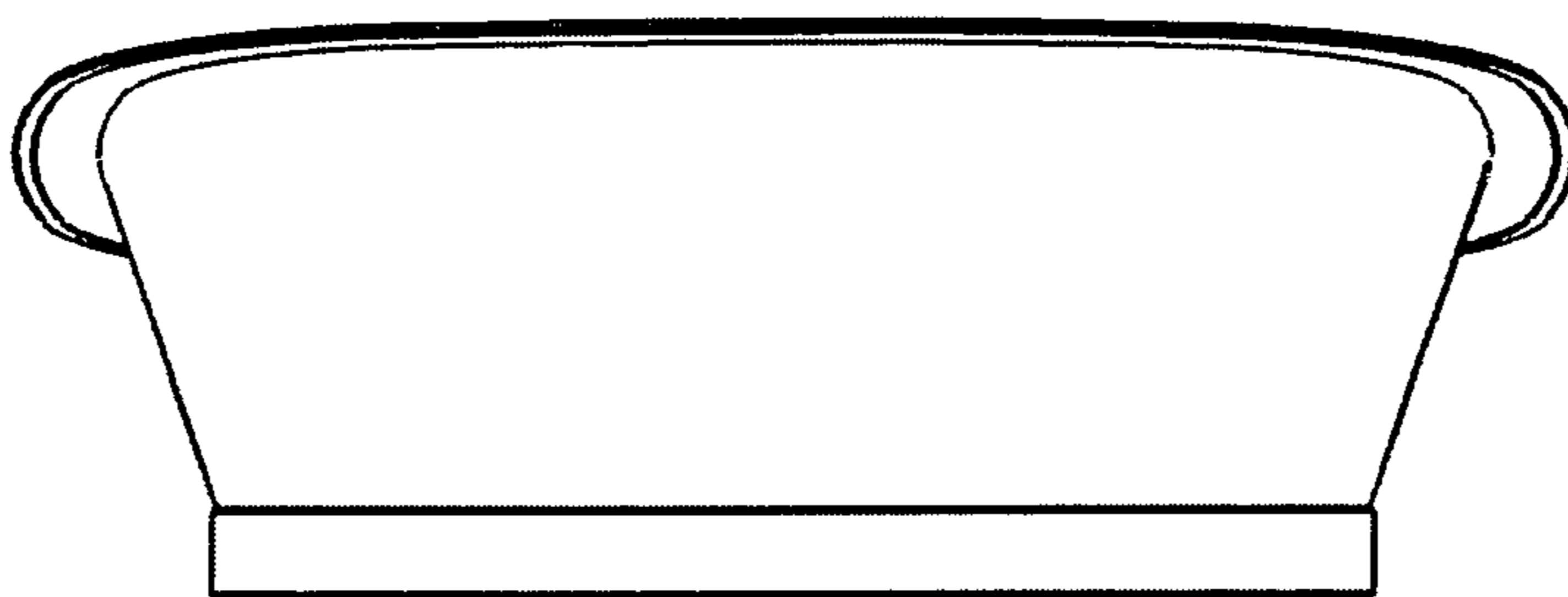

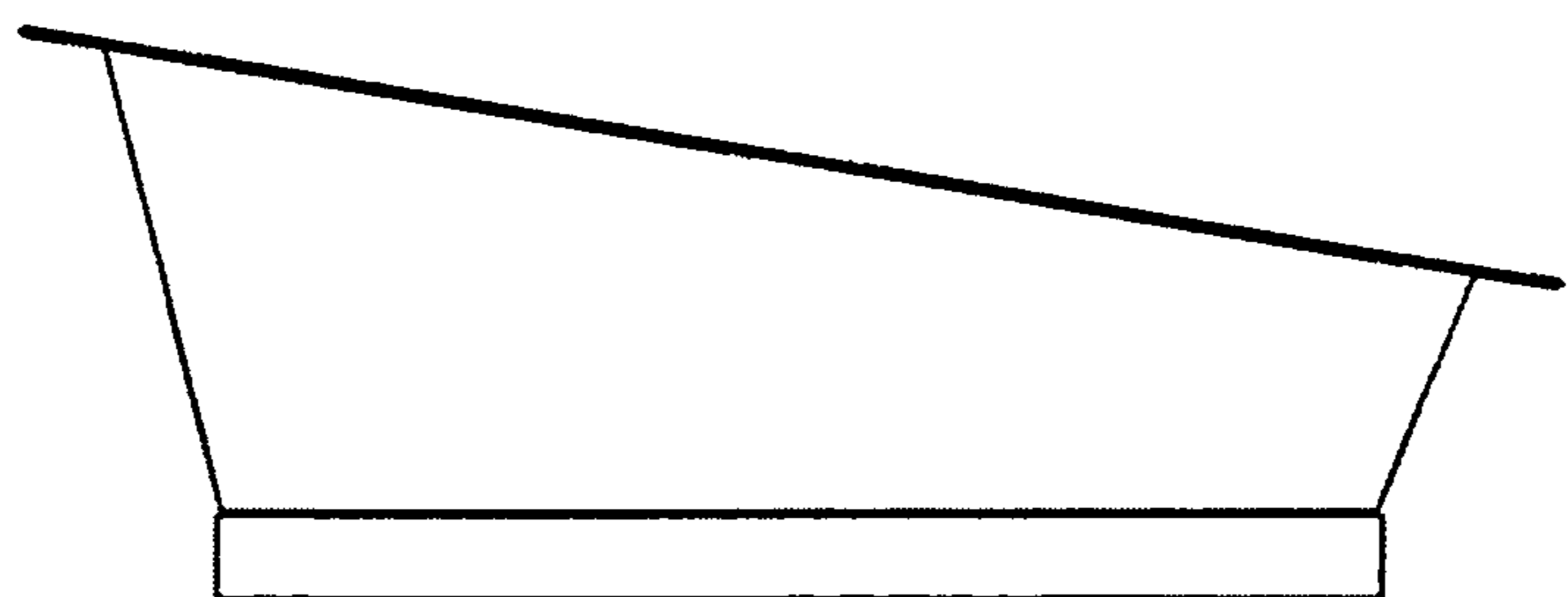
