**DESCRIPTION**

FIG. 1 is a perspective view of a shoe showing my new design; FIG. 2 is a left side view of the shoe of FIG. 1. FIG. 3 is a right side view of the shoe of FIG. 1. 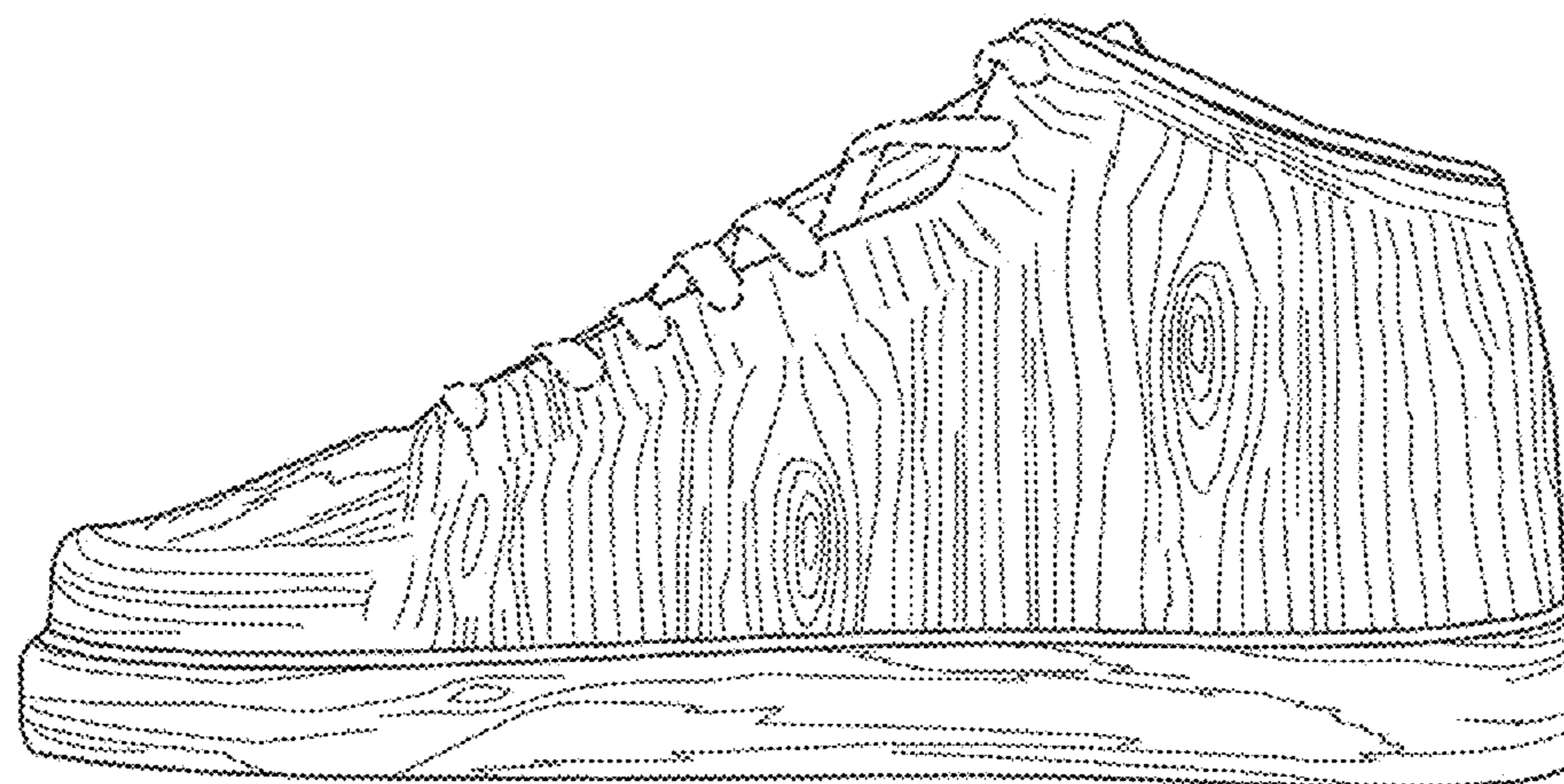

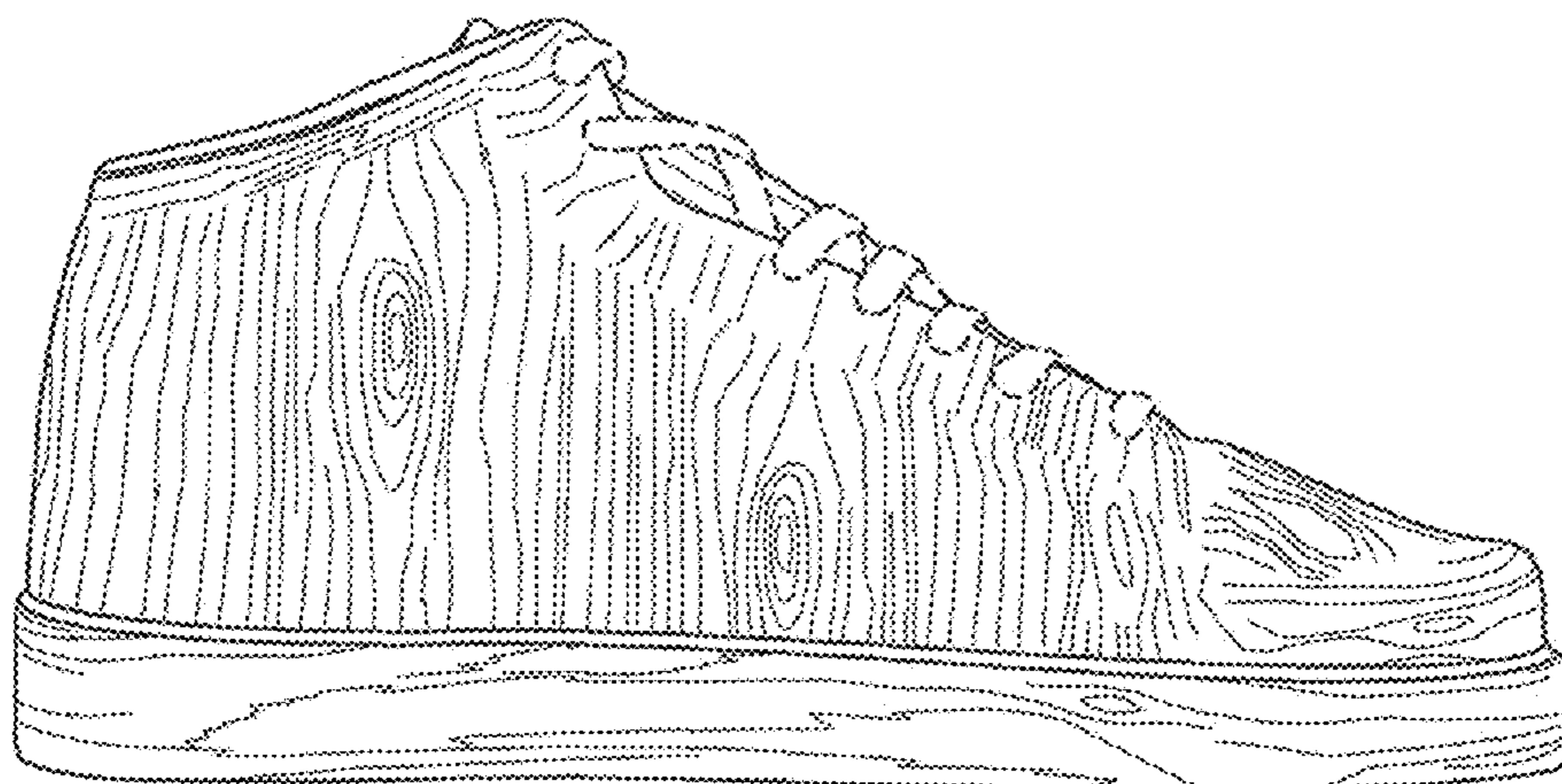

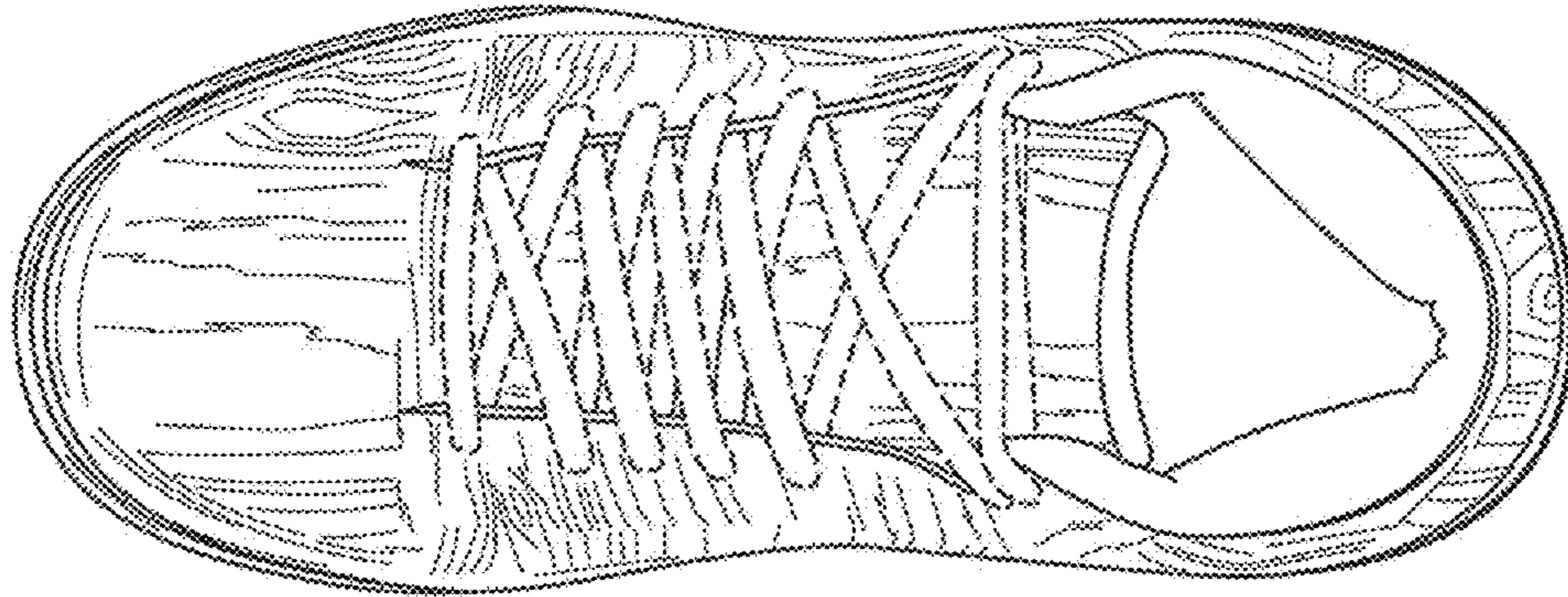

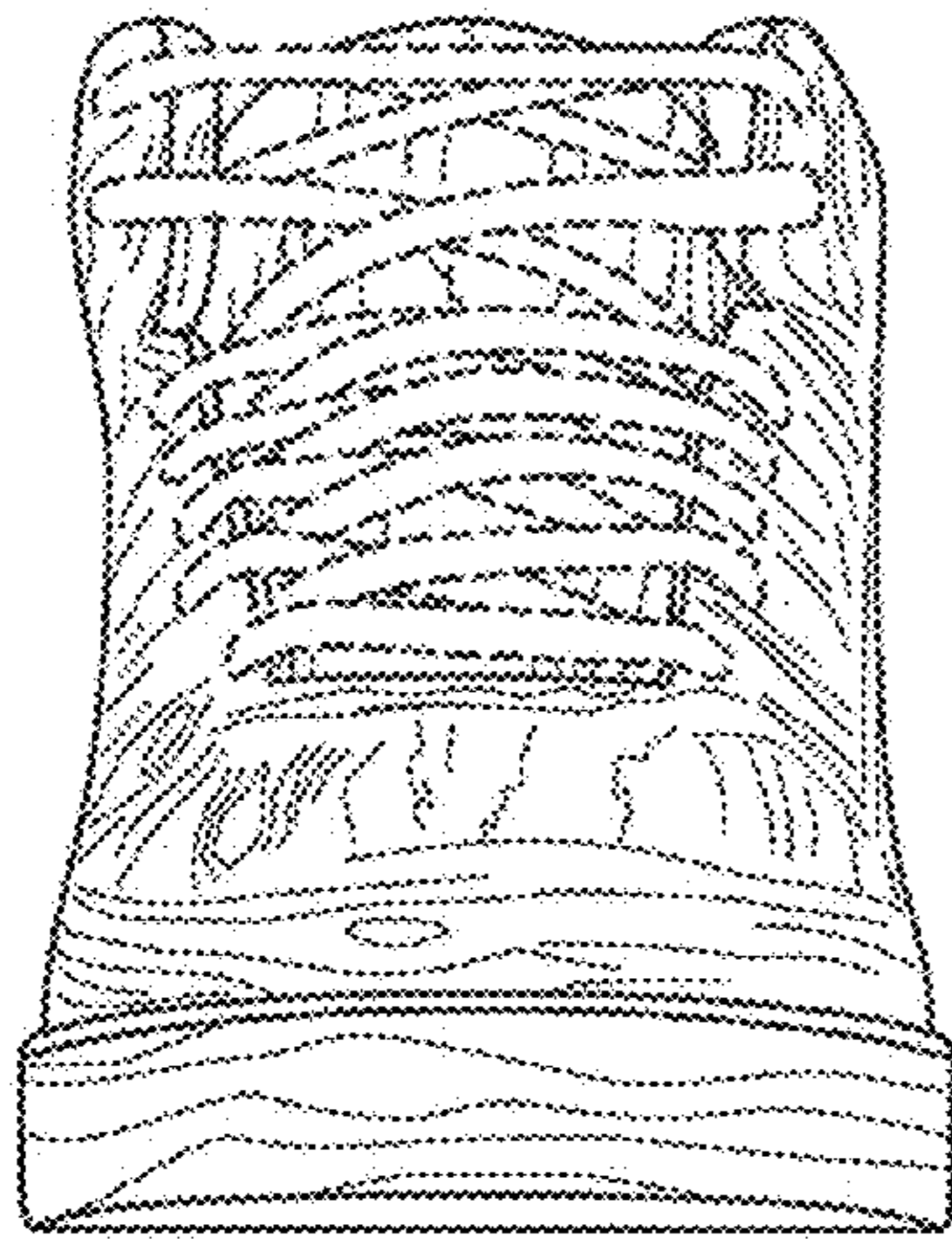

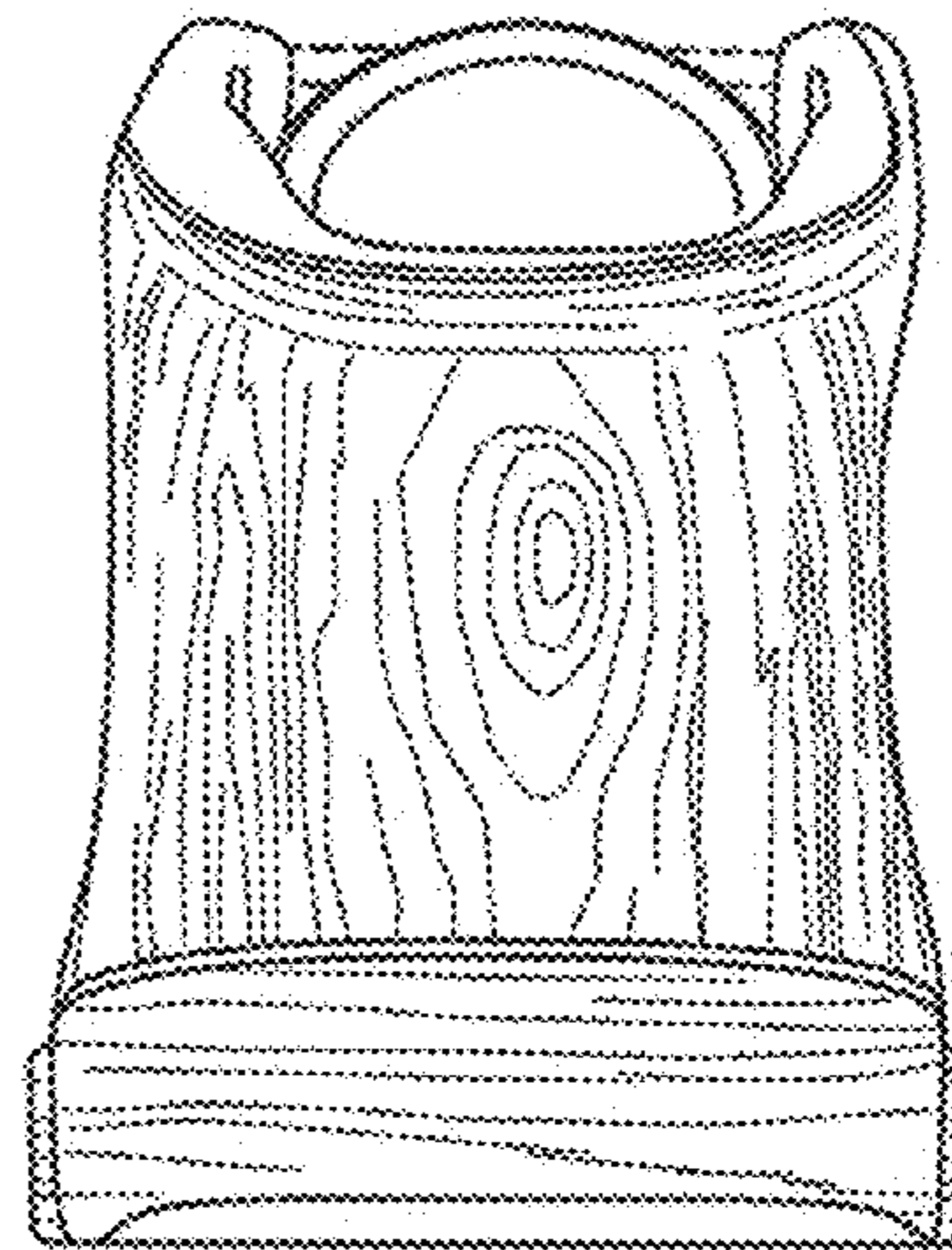
